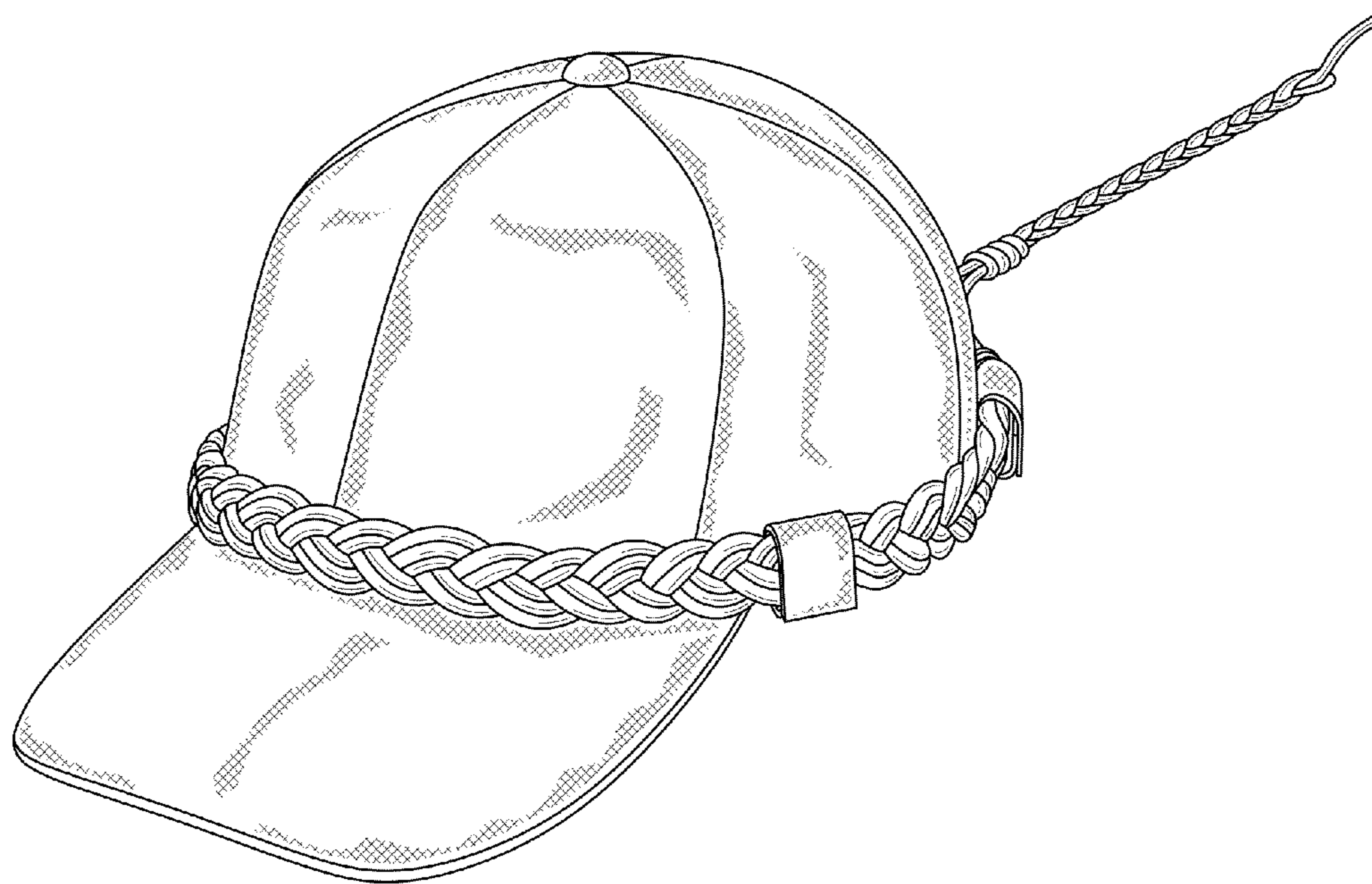
(57) **CLAIM**
The ornamental design for a bill cap, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a bill cap illustrating the claimed design.
FIG. 2 is a front elevation view thereof.
FIG. 3 is a rear elevation view thereof.
FIG. 4 is a first side elevation view thereof.
FIG. 5 is a second side elevation thereof.
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The claimed bill cap is intended for use as a personal head covering.

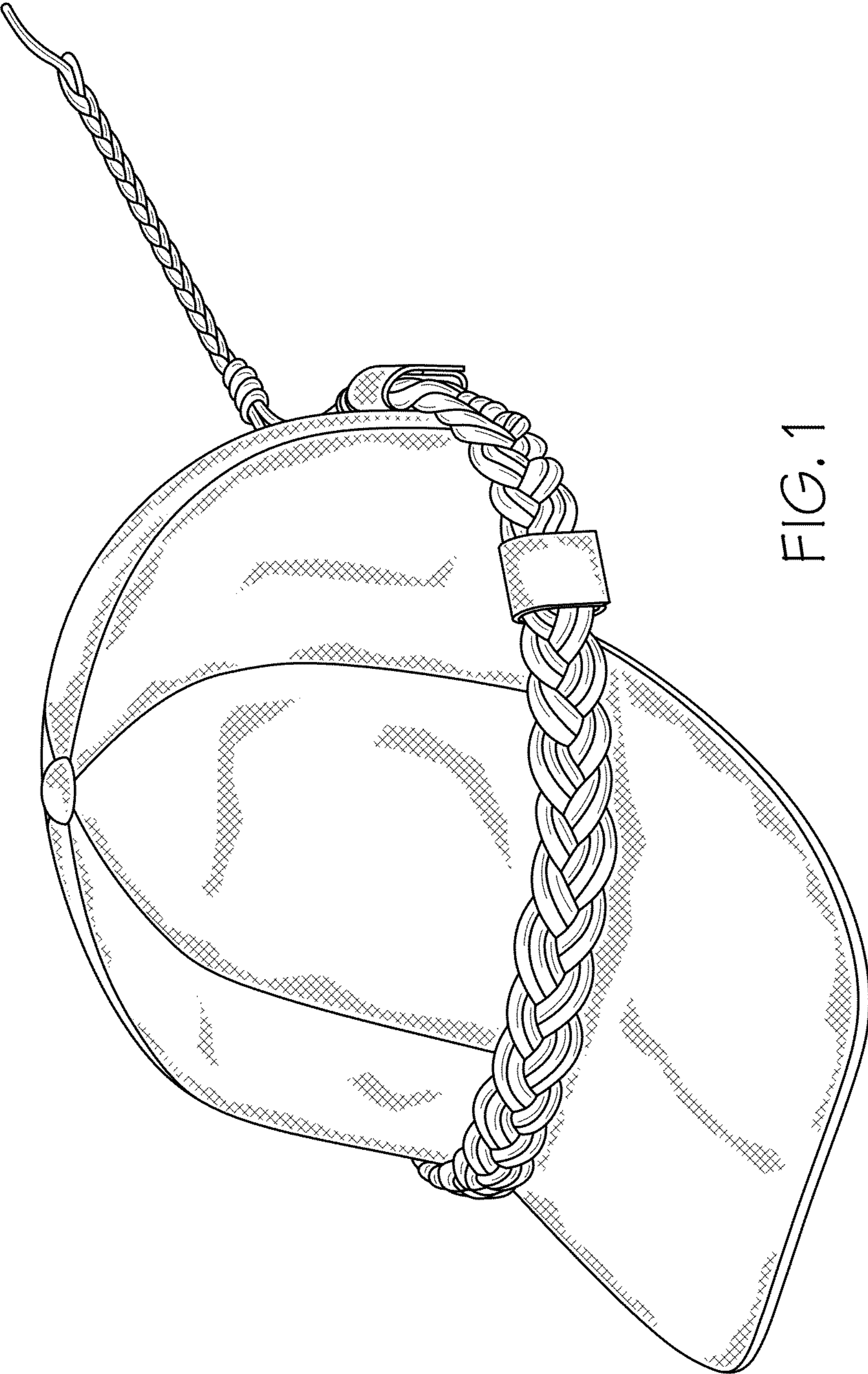

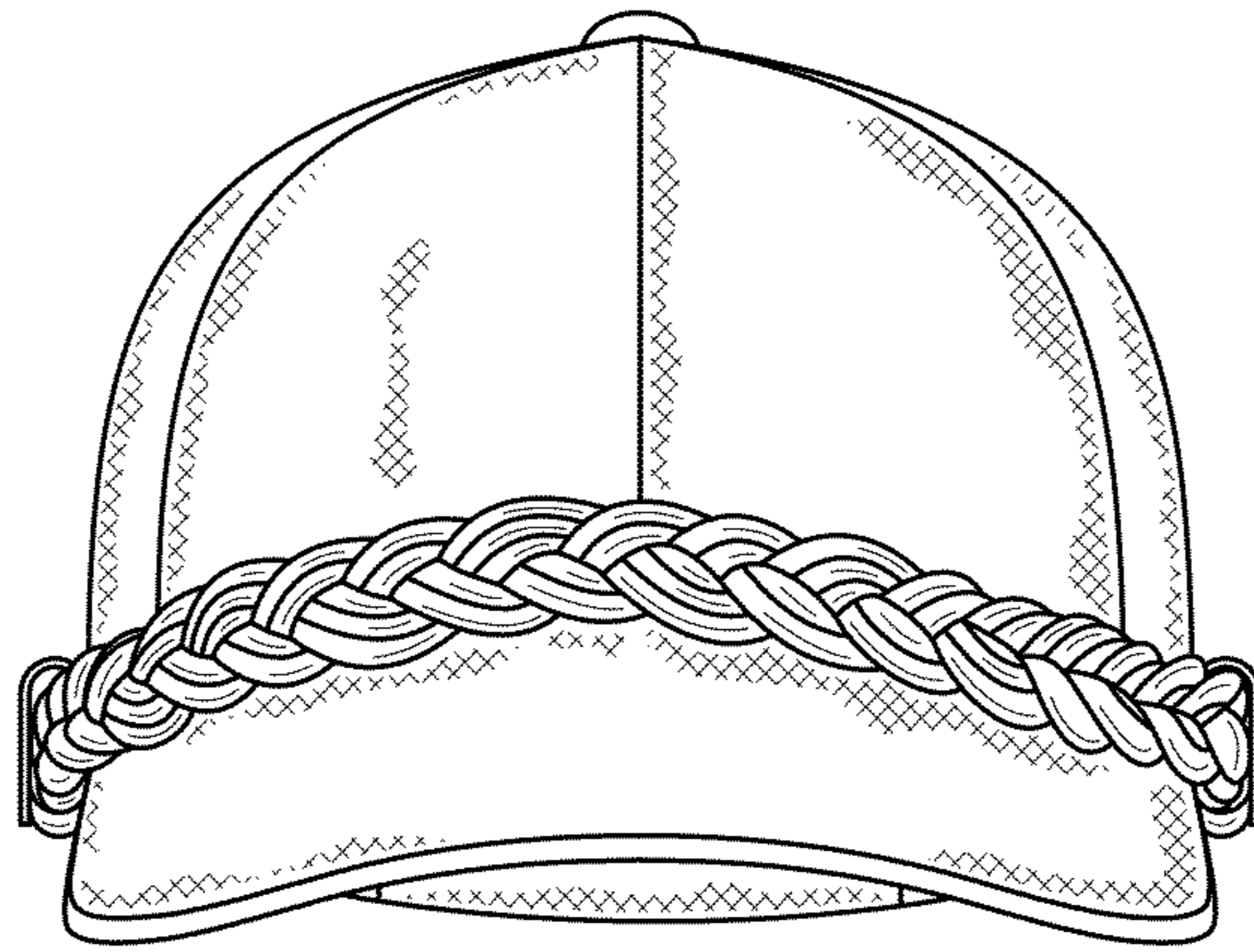

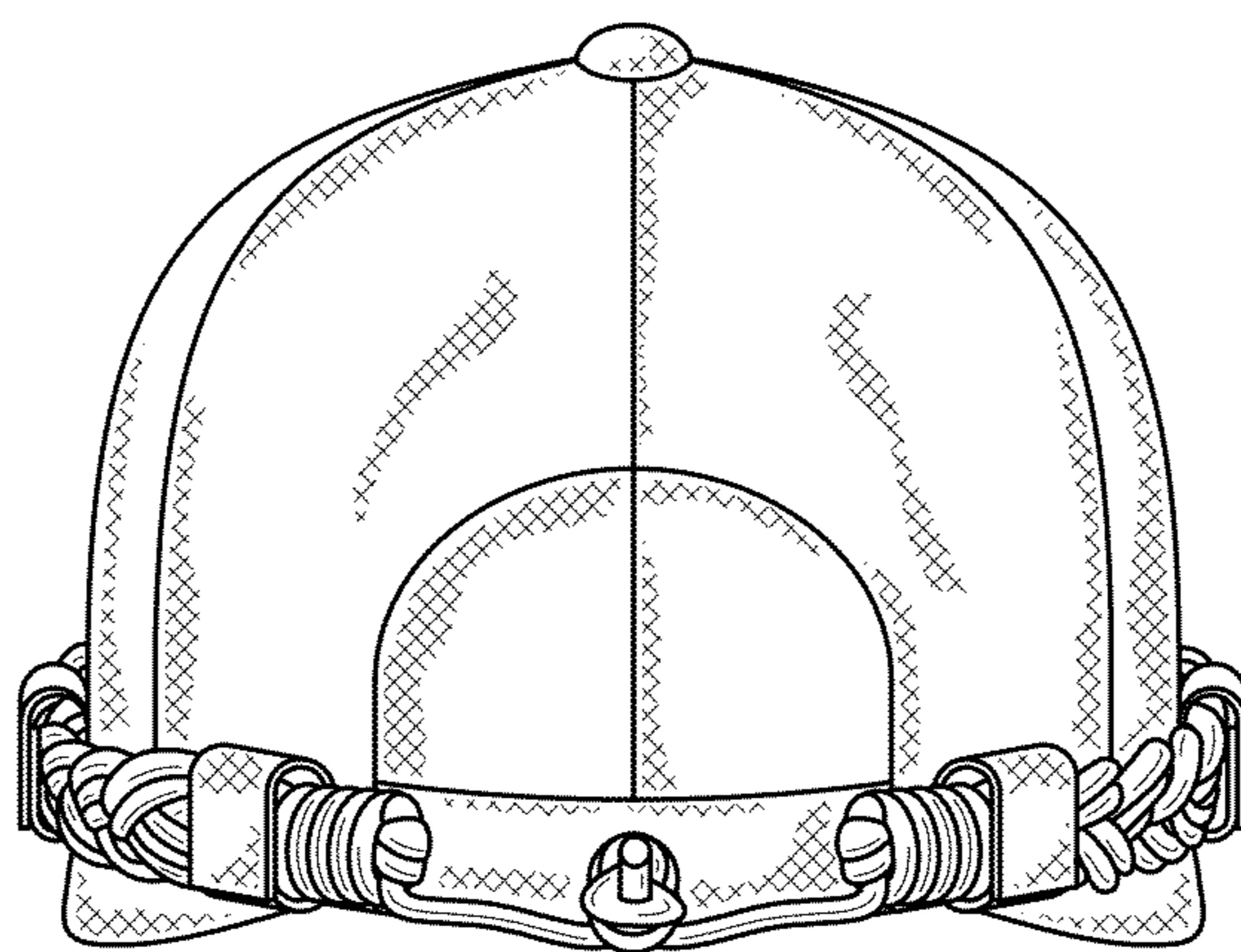

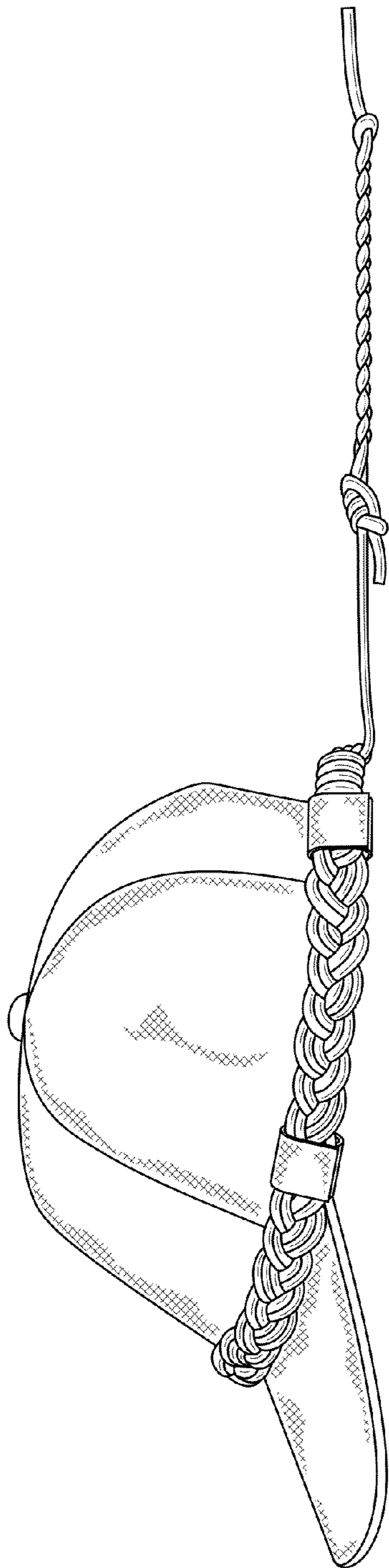

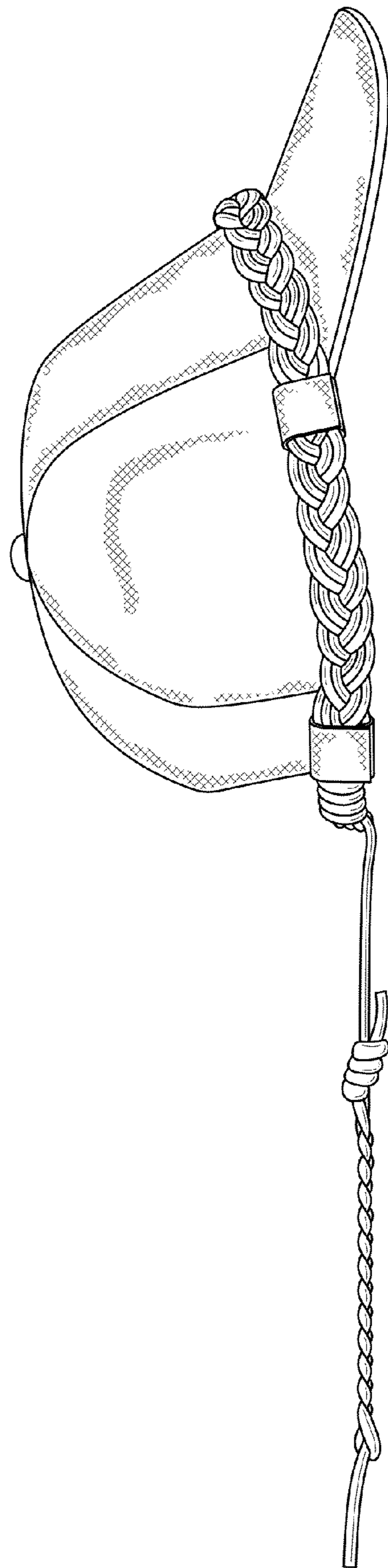

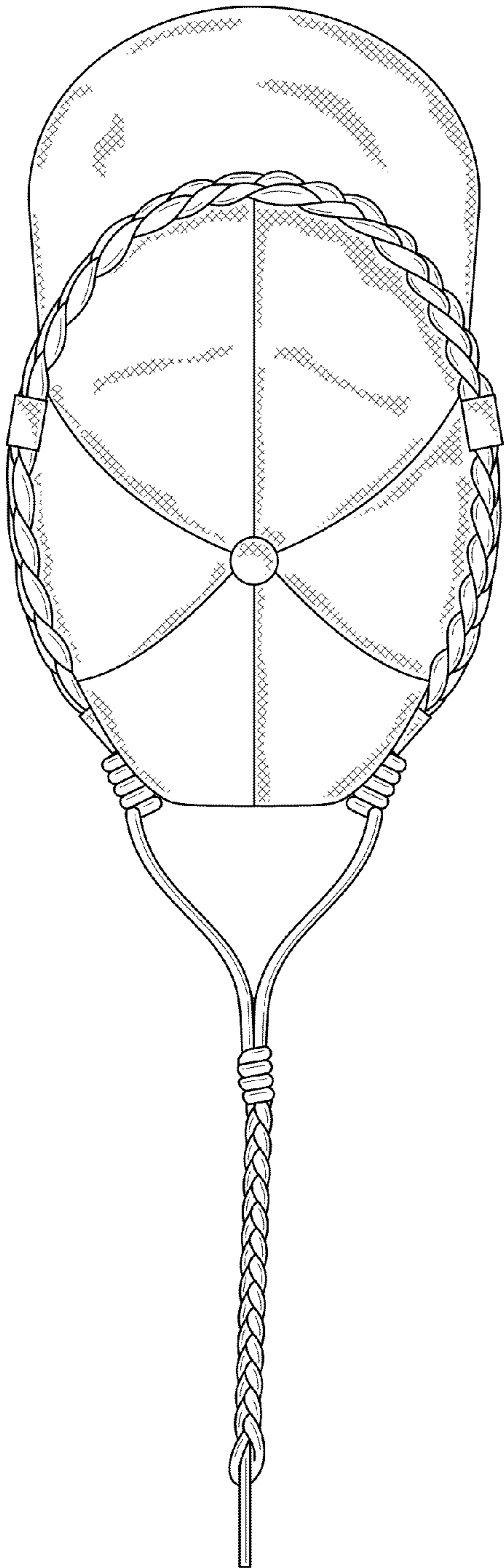

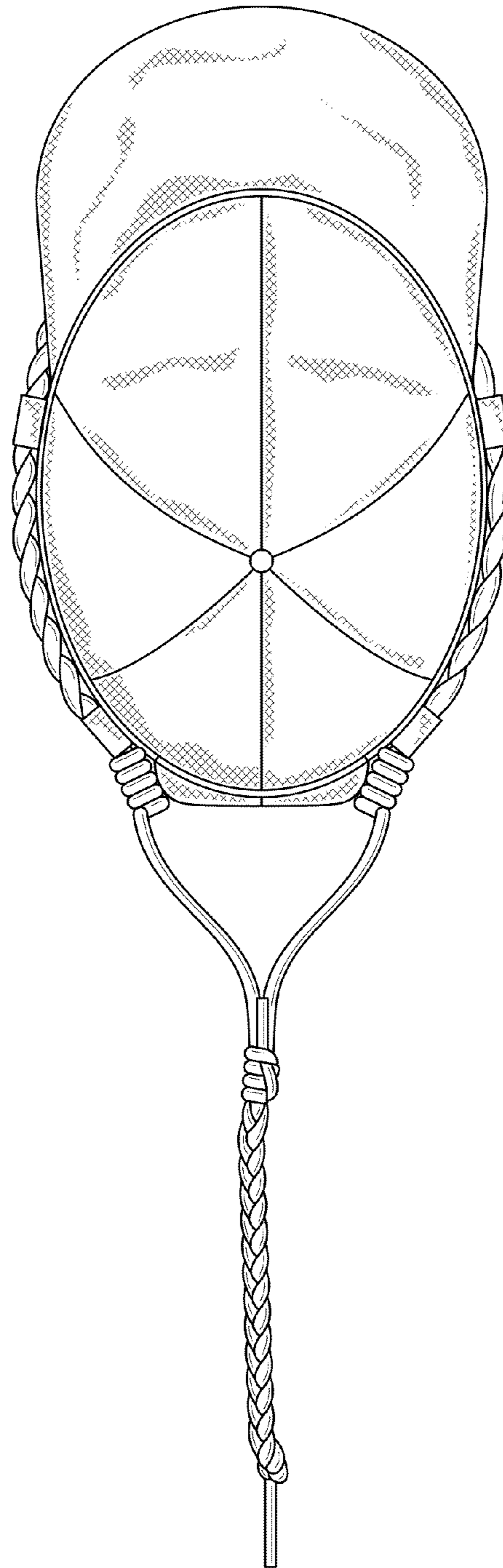
