DESCRIPTION

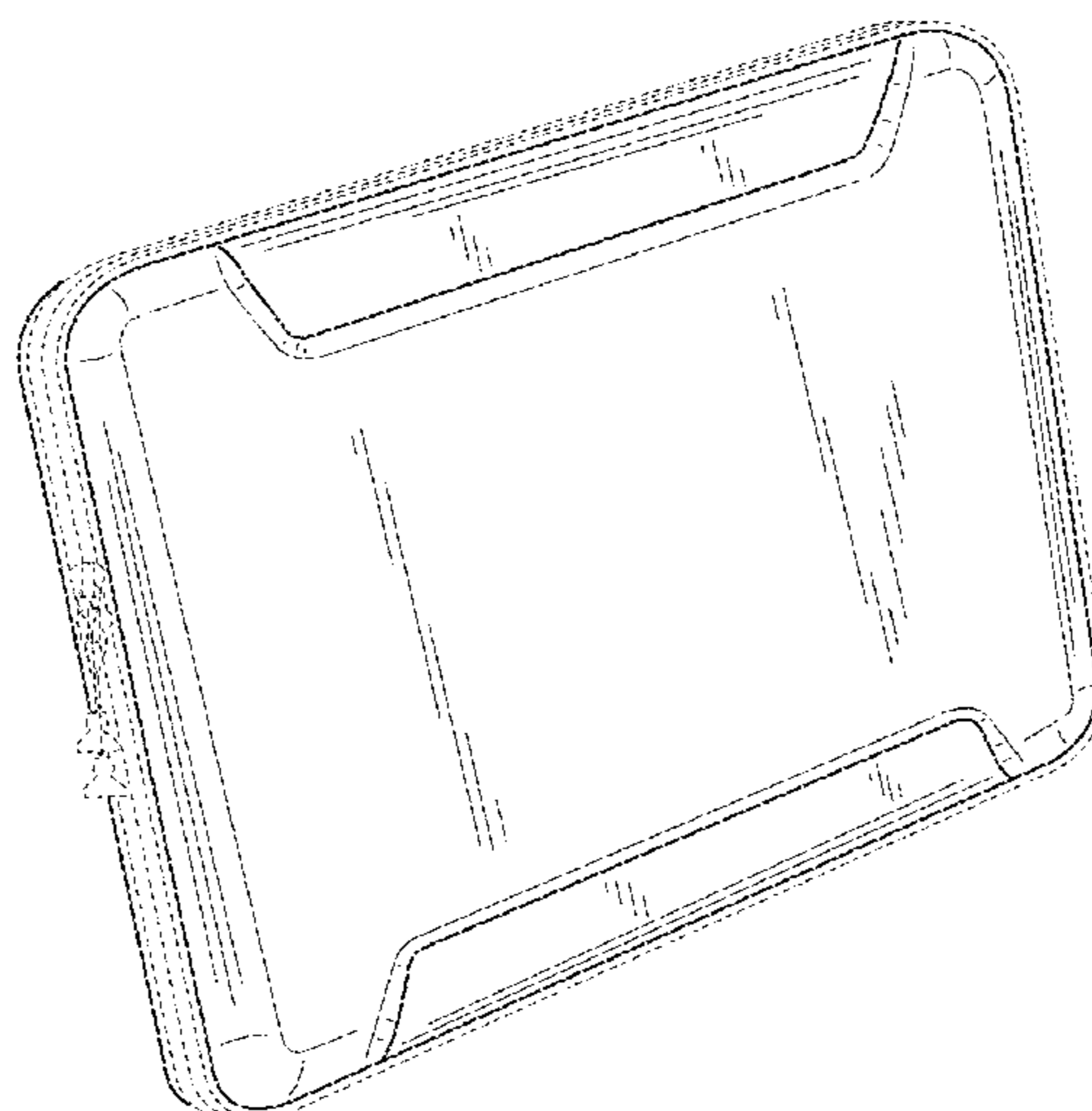
FIG. 1 is a front perspective view of a protective sleeve showing my new design;

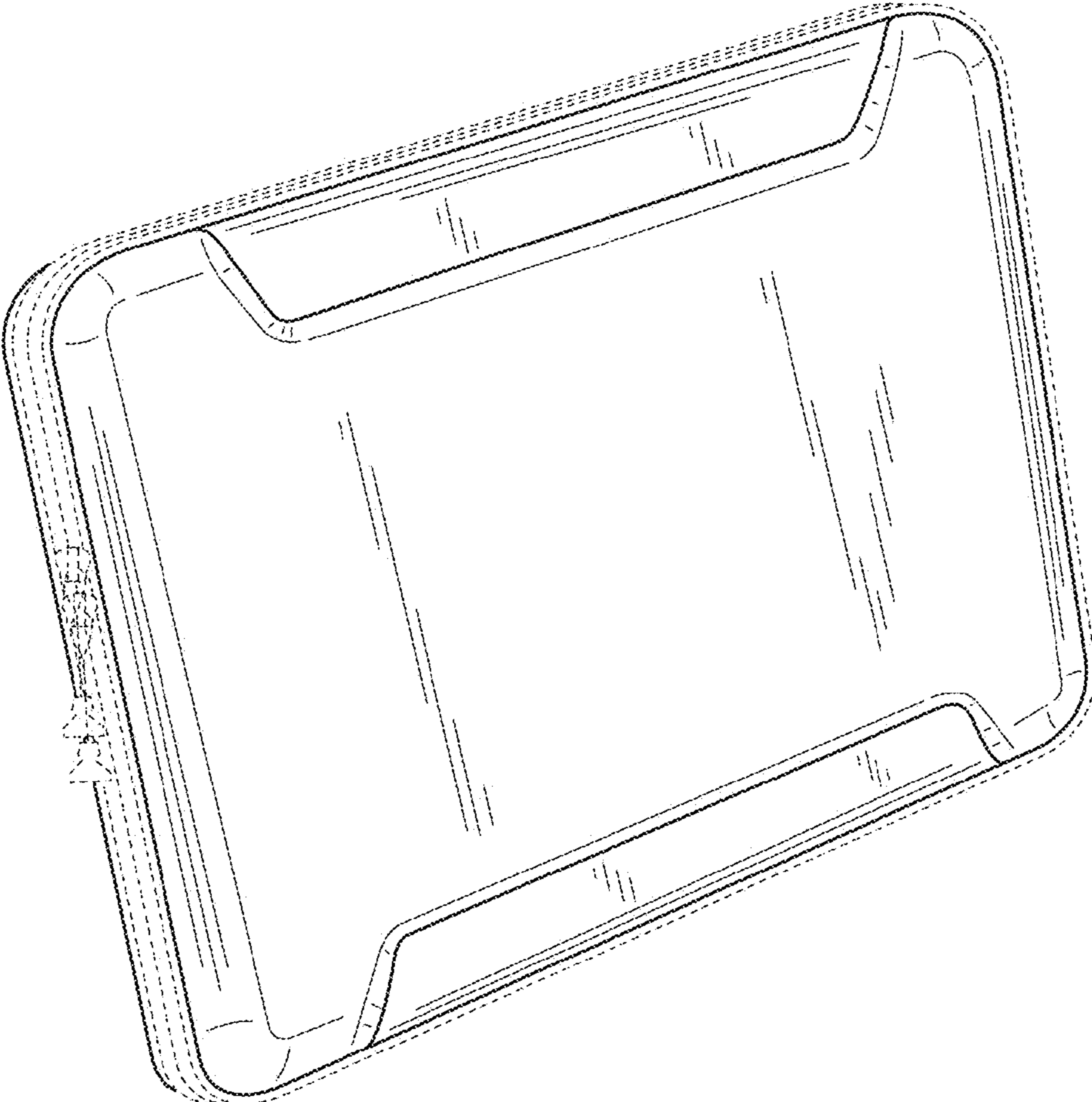

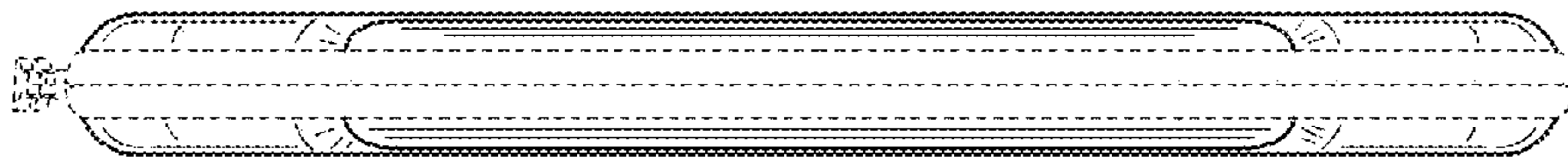

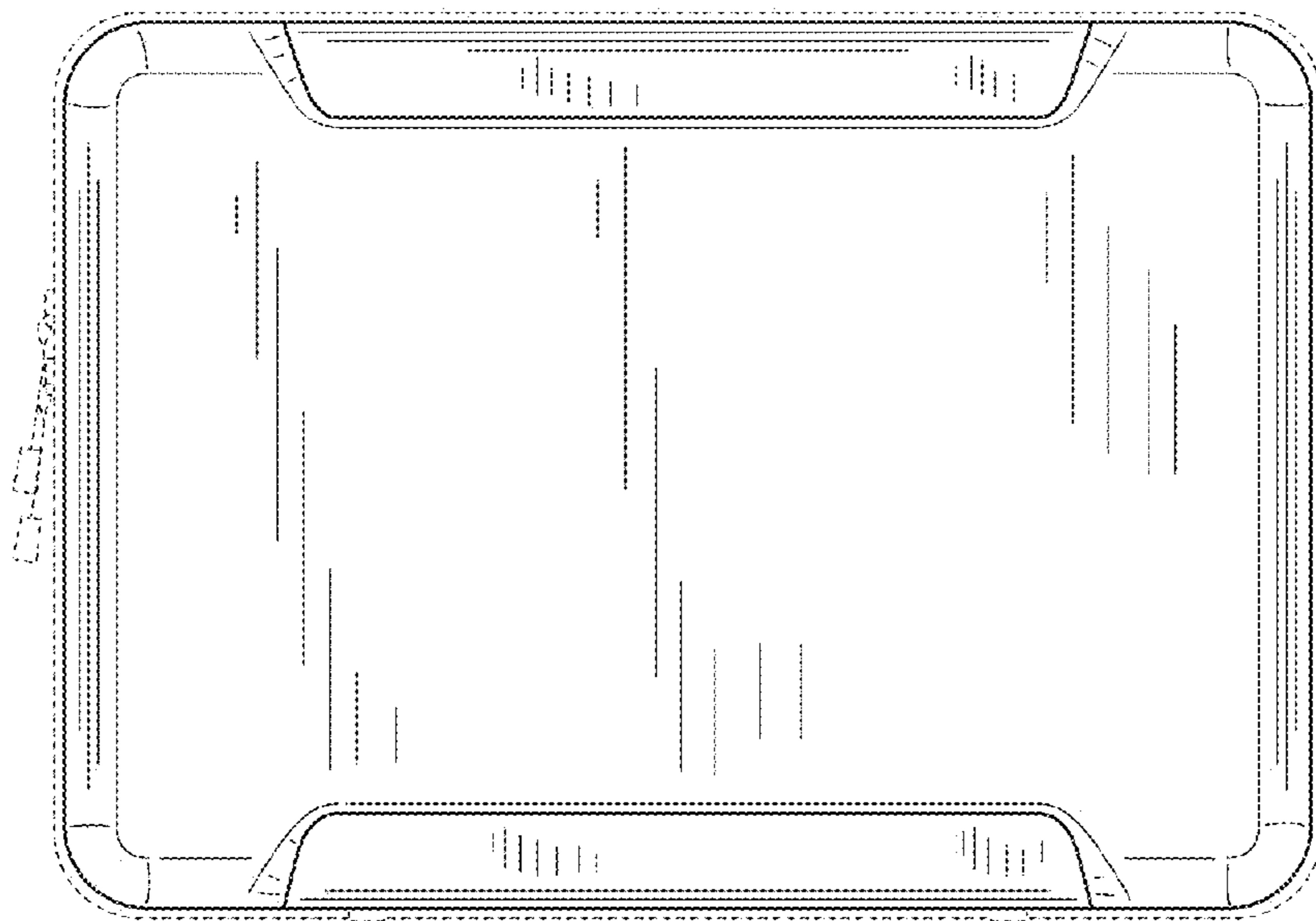

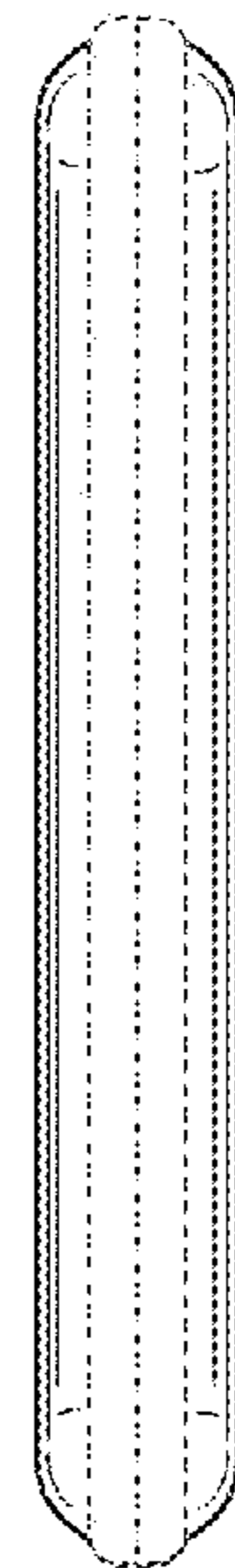

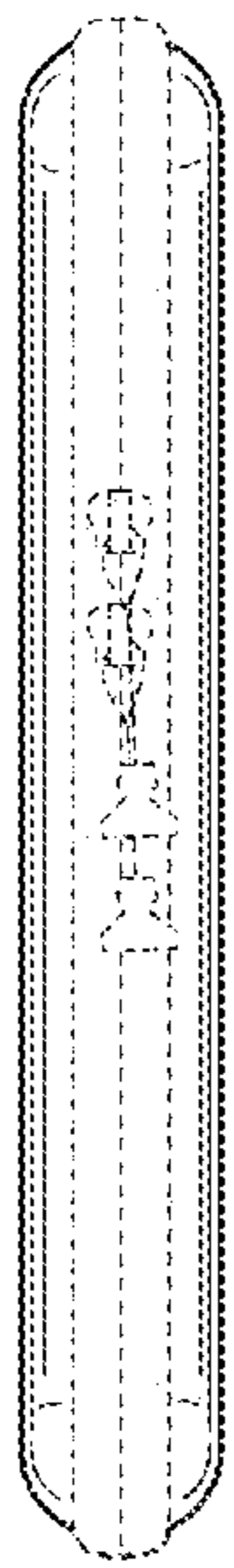

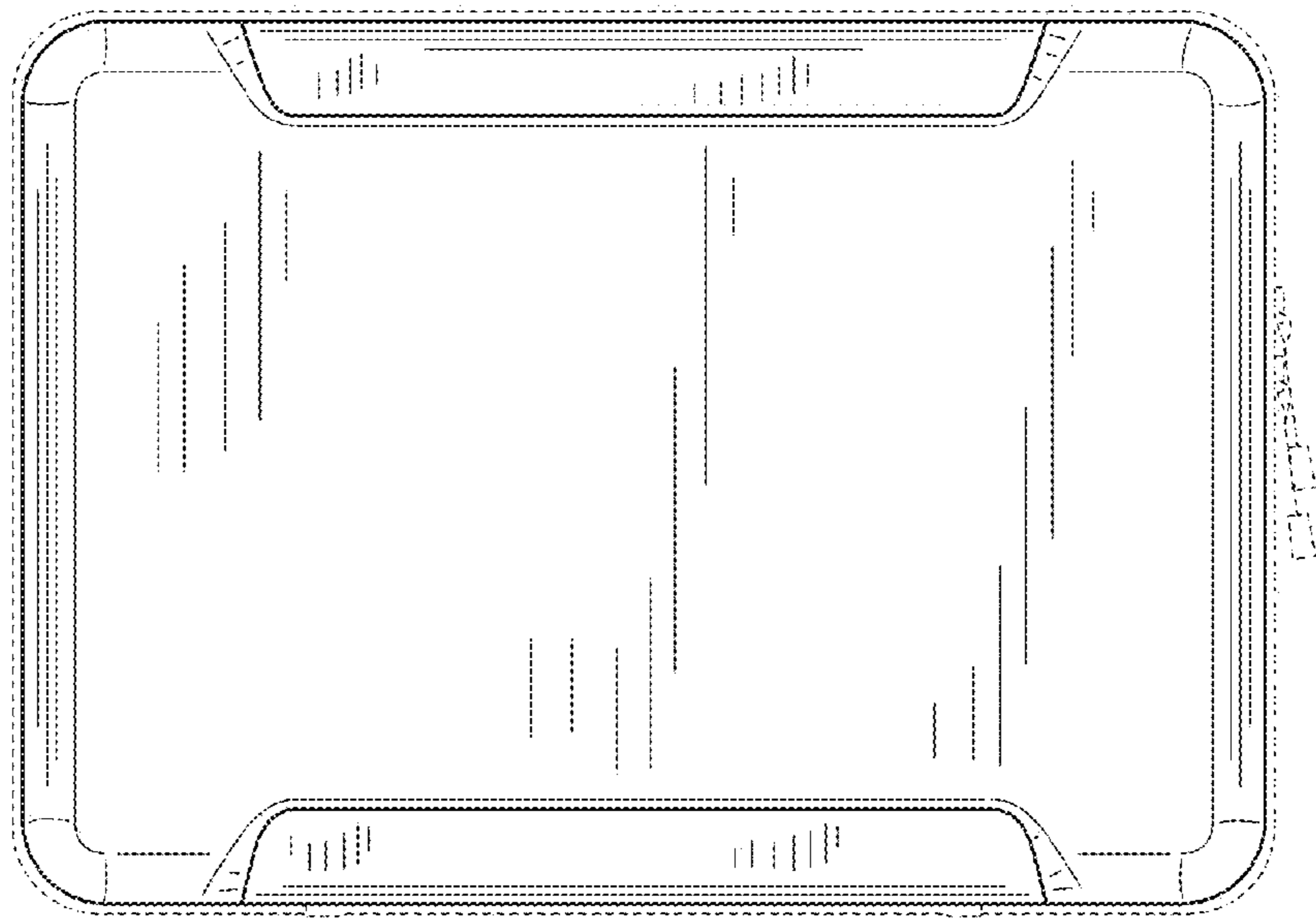

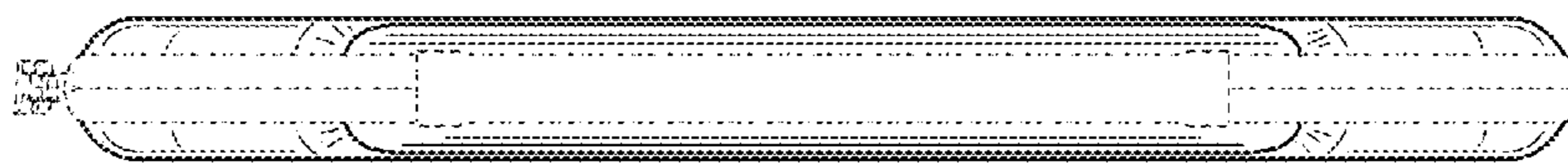
