(57) **CLAIM**

The ornamental design for a lace fabric, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a portion of a lace fabric in accordance with the present invention;
 FIG. 2 is a back side view of FIG. 1;
 FIG. 3 is a front perspective view of FIG. 1; and,
 FIG. 4 is an enlarged front view of the area of the lace fabric circumscribed by broken lines within FIG. 1.
 The broken lines in FIG. 1 represent the boundaries of the detail area shown in FIG. 4 and form no part of the lace fabric. For clarity, the lace fabric is shown within an unclaimed black environment.

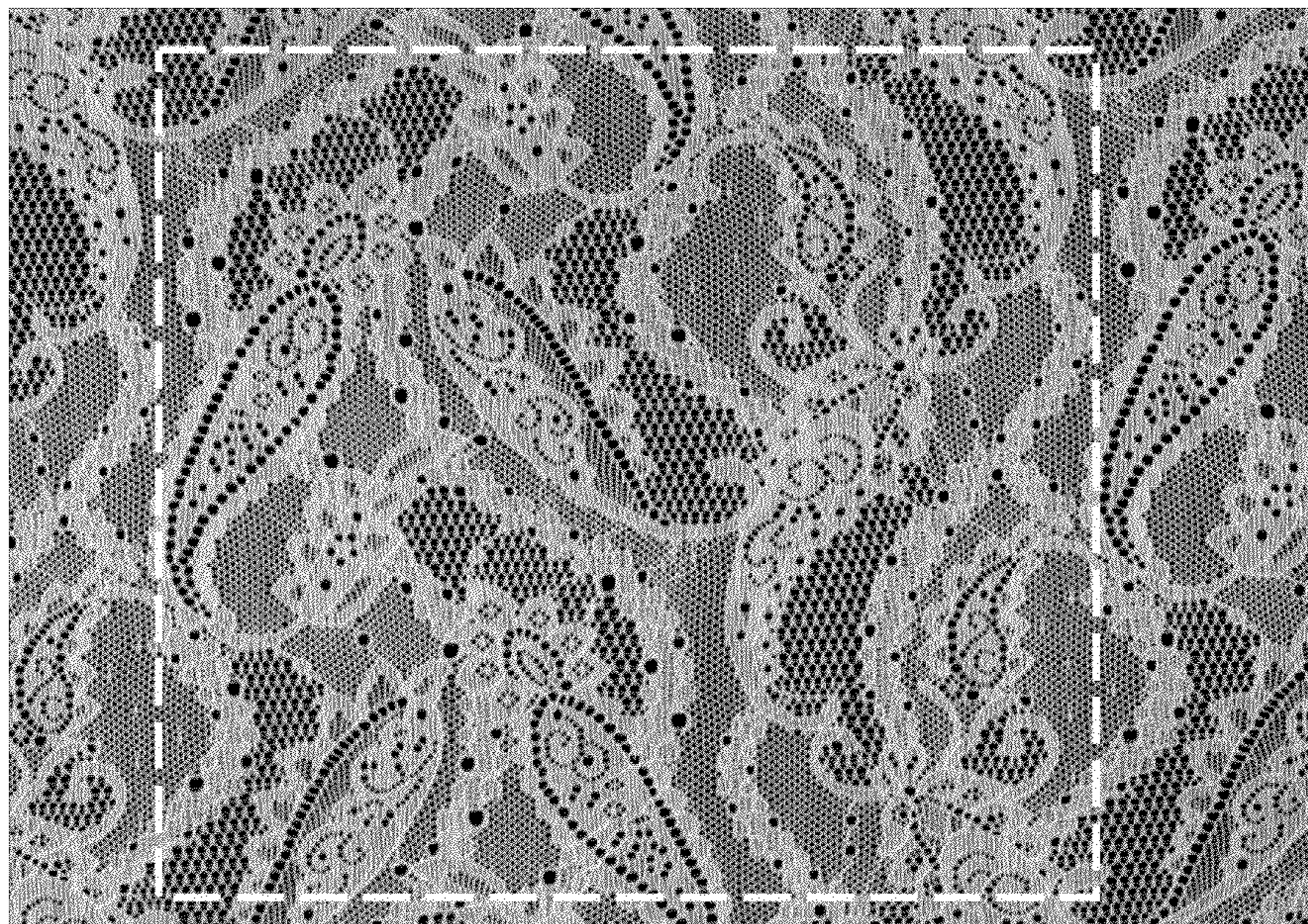

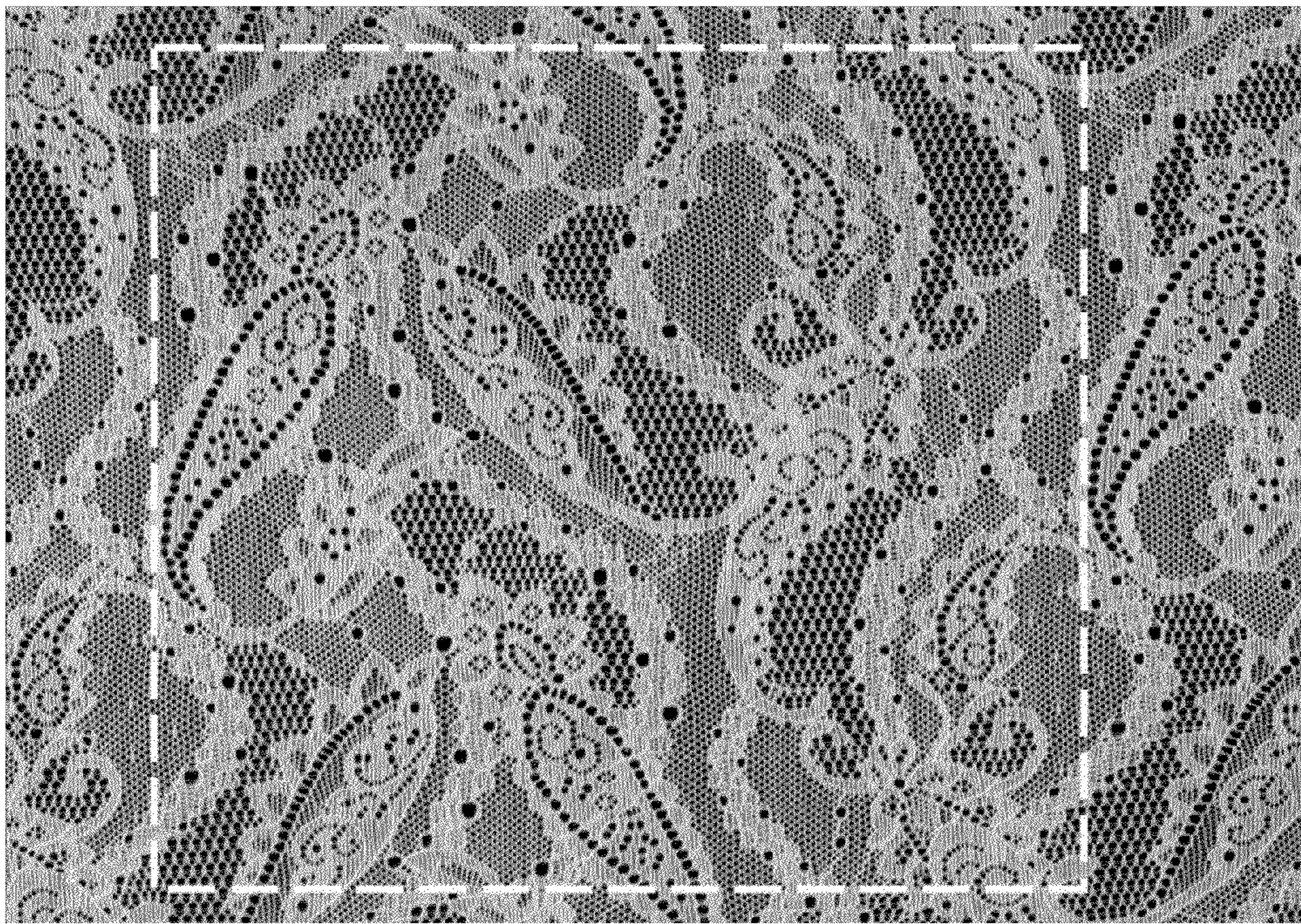

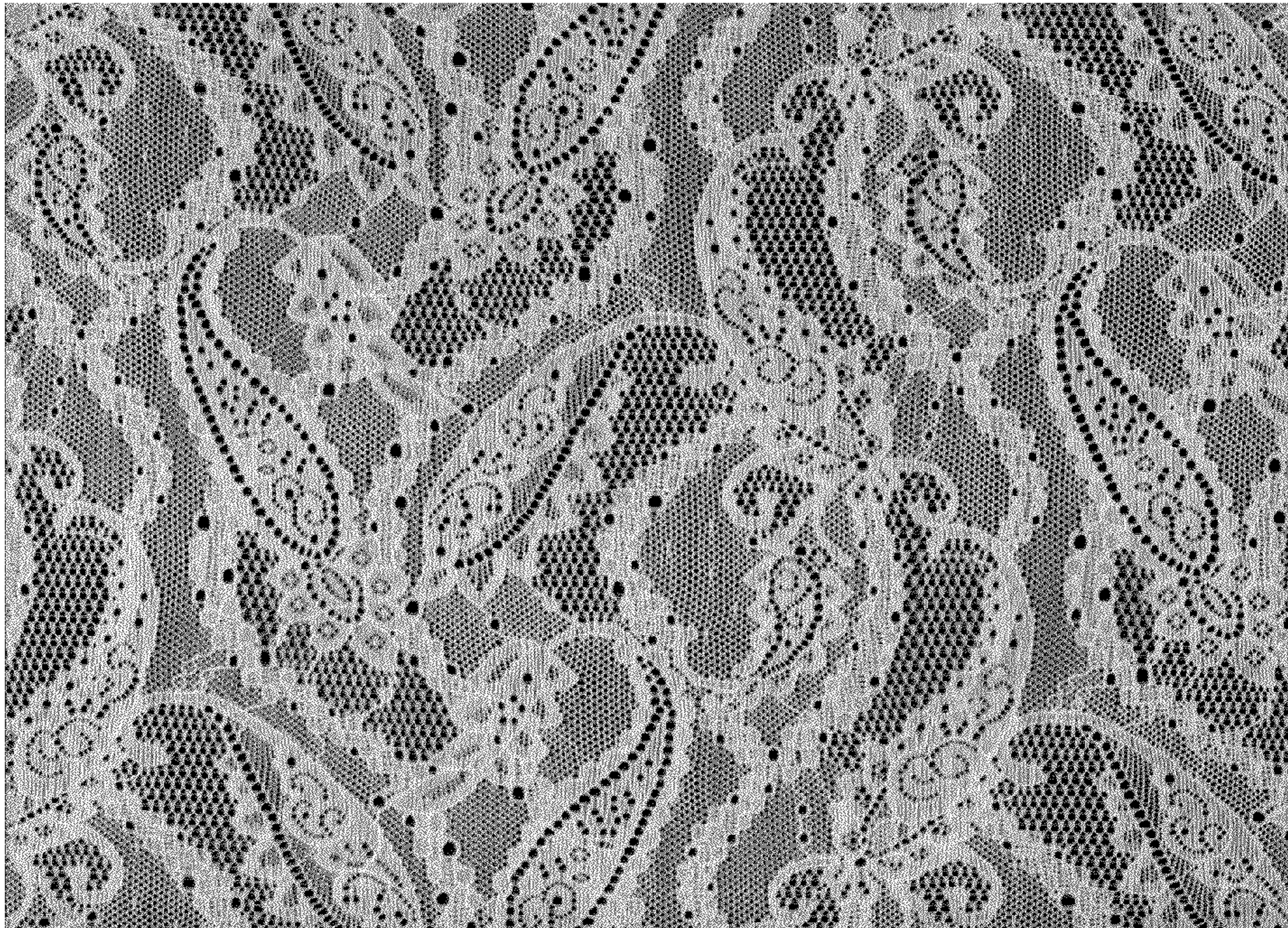

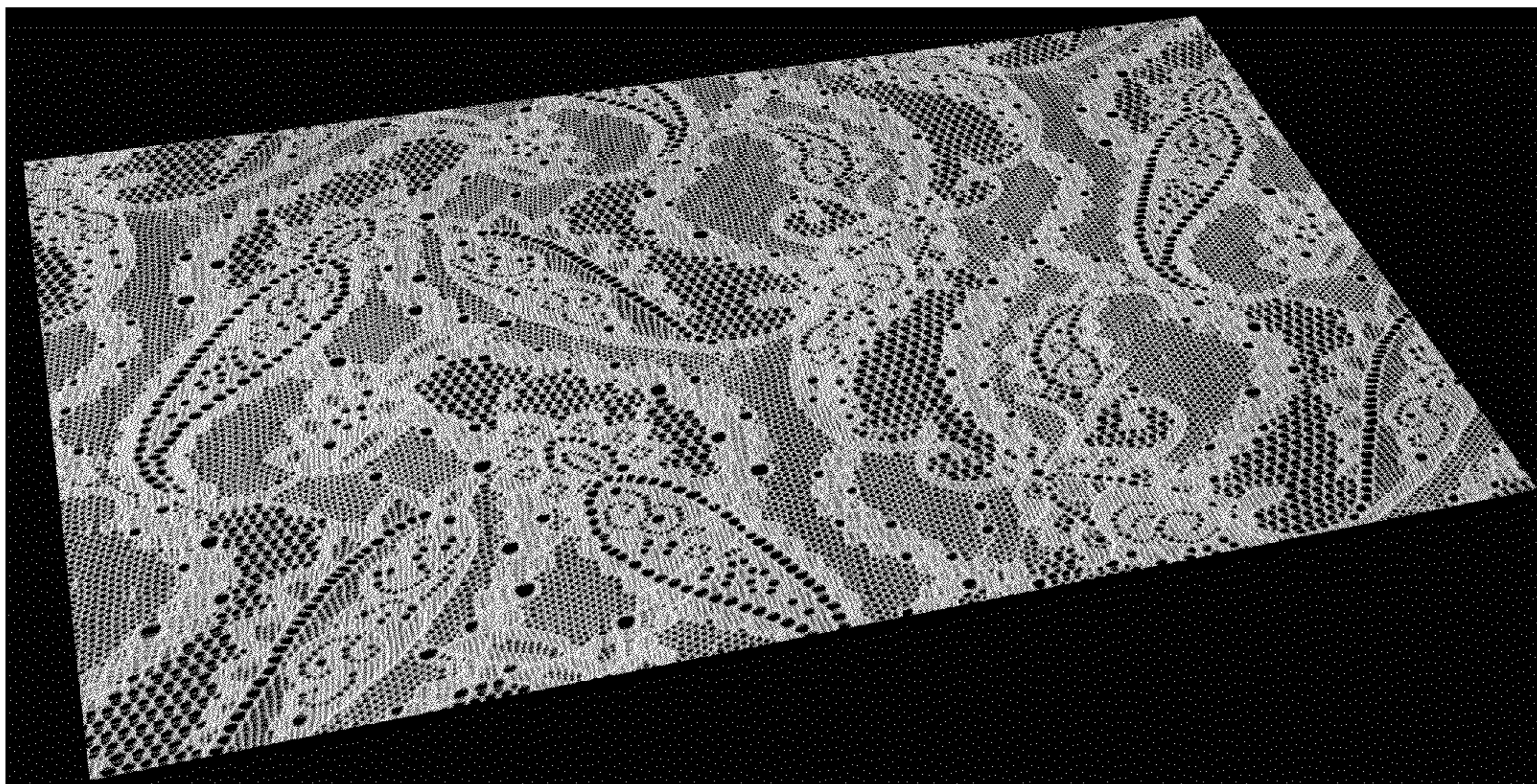
