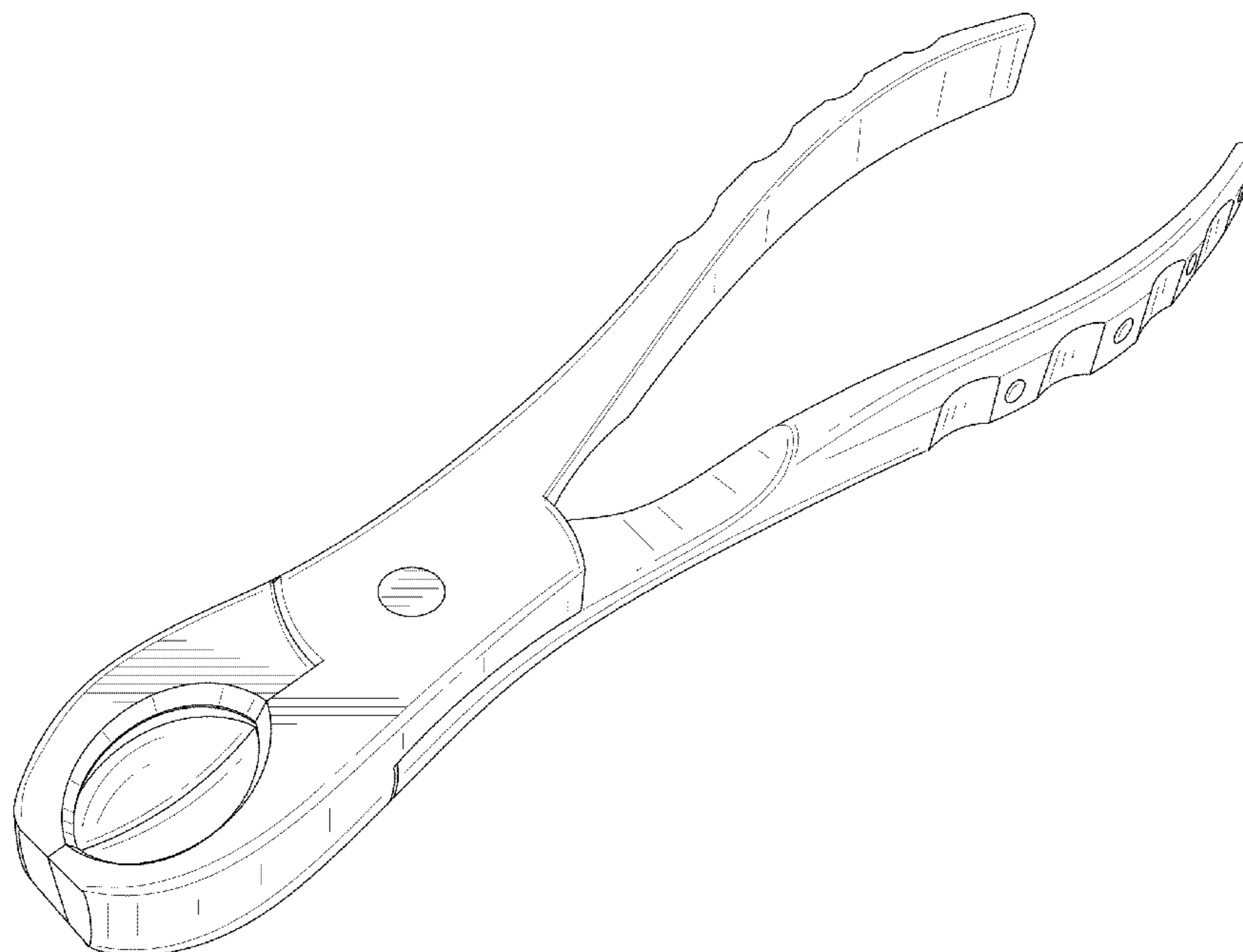
(57) **CLAIM**  
The ornamental design for a twin action decapping pliers, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a twin action decapping pliers showing my new design;  
FIG. 2 is a top plan view of the twin action decapping pliers shown in FIG. 1;  
FIG. 3 is a bottom perspective view of the twin action decapping pliers shown in FIG. 1;  
FIG. 4 is a bottom plan view of the twin action decapping pliers shown in FIG. 1;  
FIG. 5 is an end view of the twin action decapping pliers shown in FIG. 1;  
FIG. 6 is a side view of the twin action decapping pliers shown in FIG. 1;  
FIG. 7 is an end view of the end opposite that shown in FIG. 5;  
FIG. 8 is a side view of the side opposite that shown in FIG. 6; and,  
FIG. 9 is a top perspective view of the twin action decapping pliers shown in FIG. 1, in an “open” state.

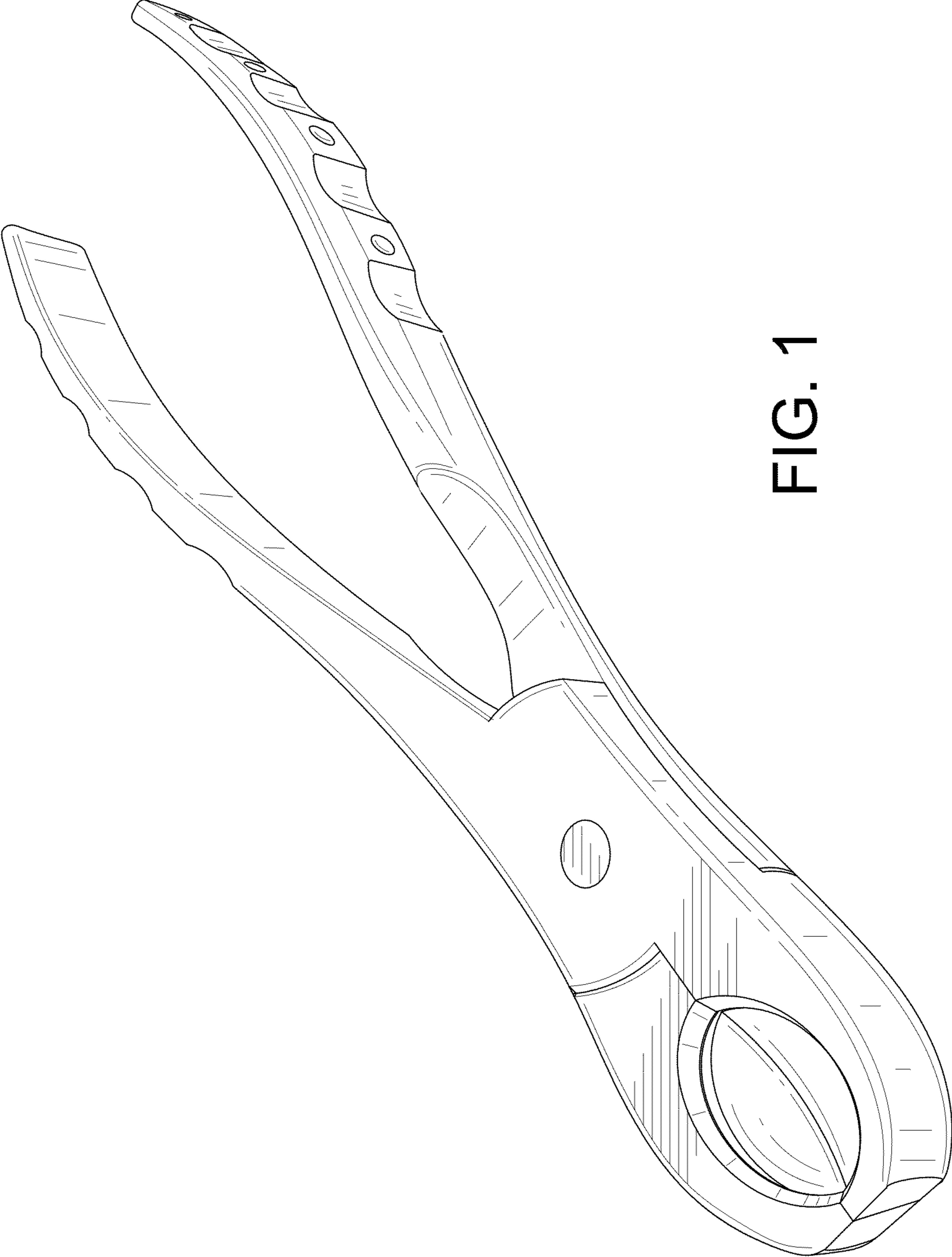

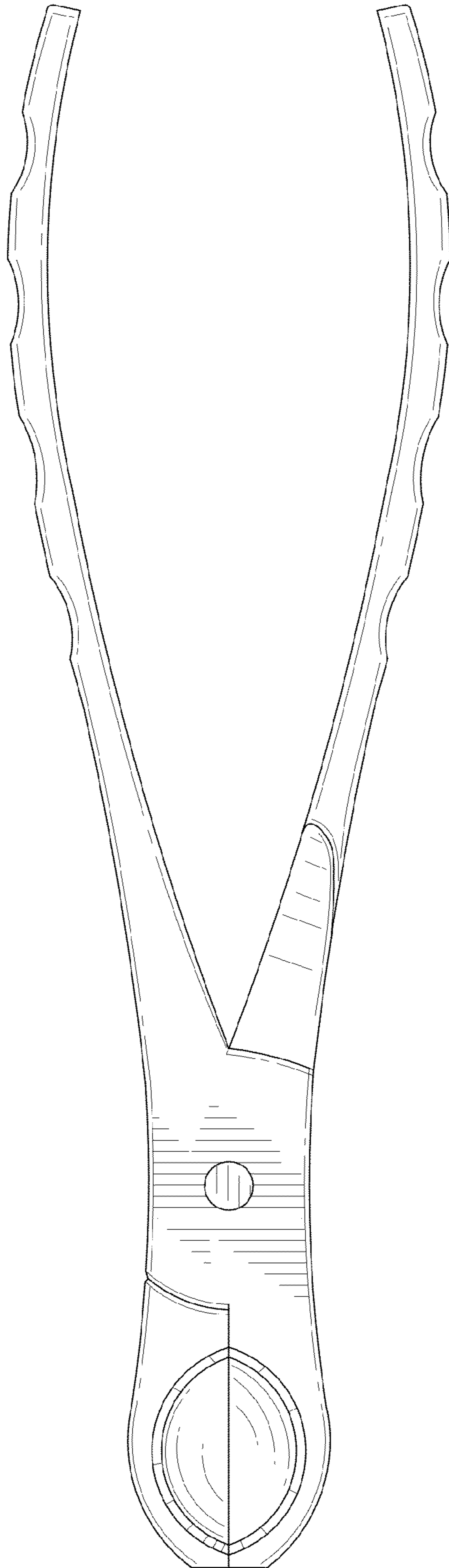

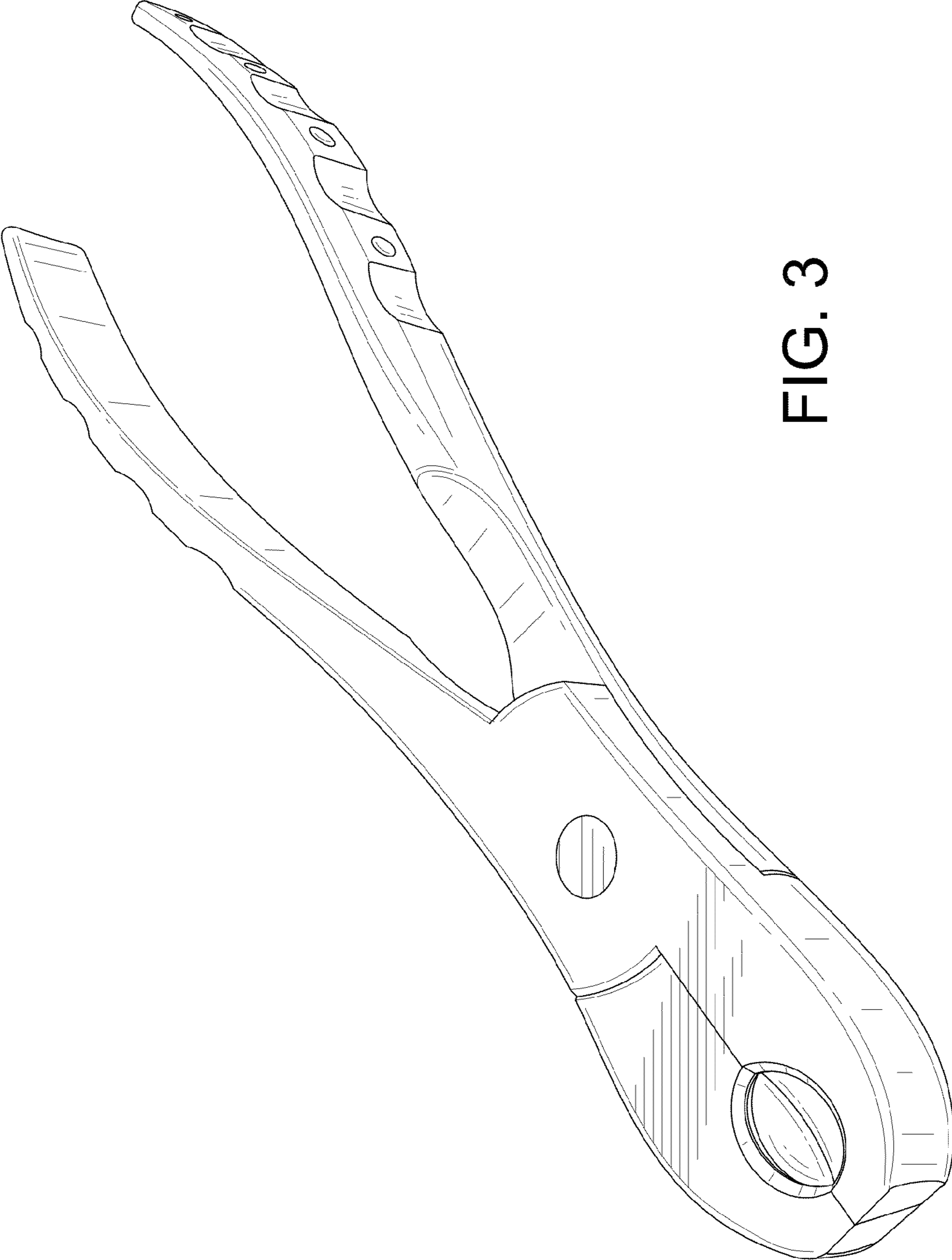

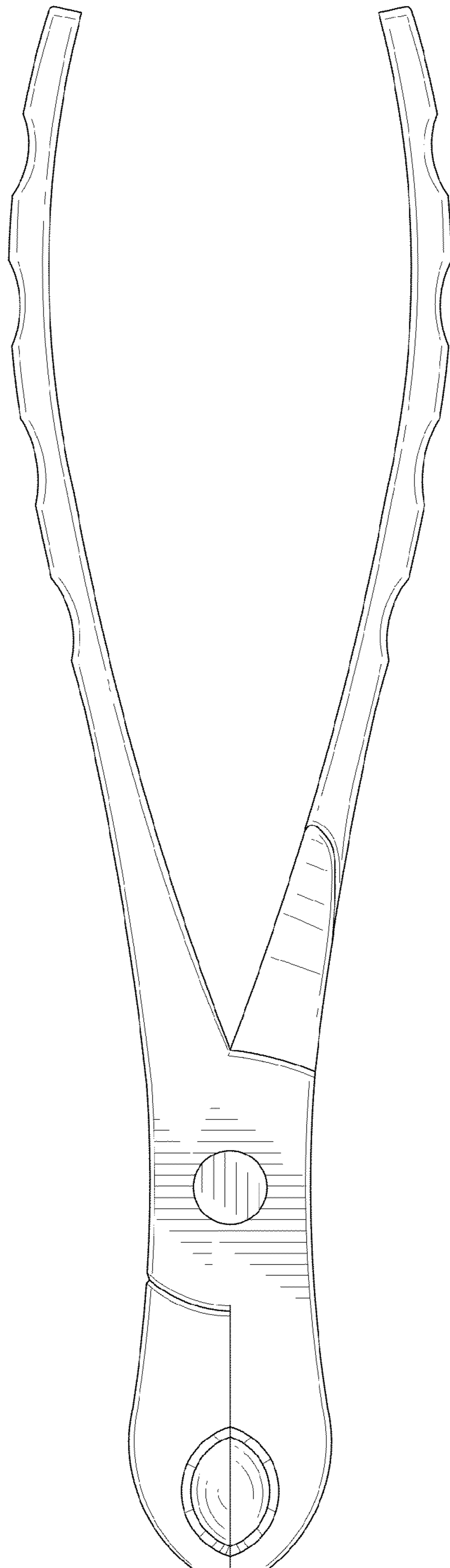

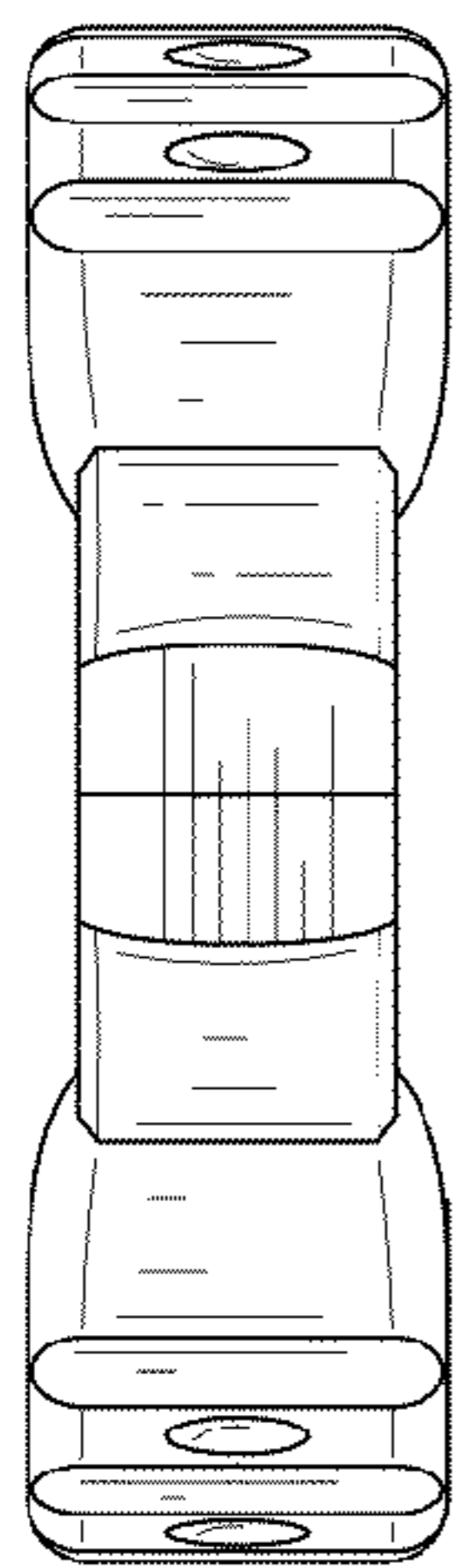

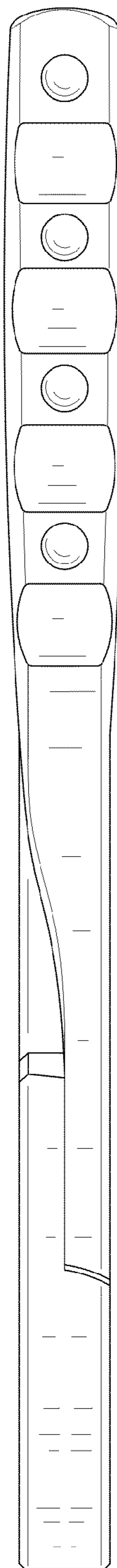

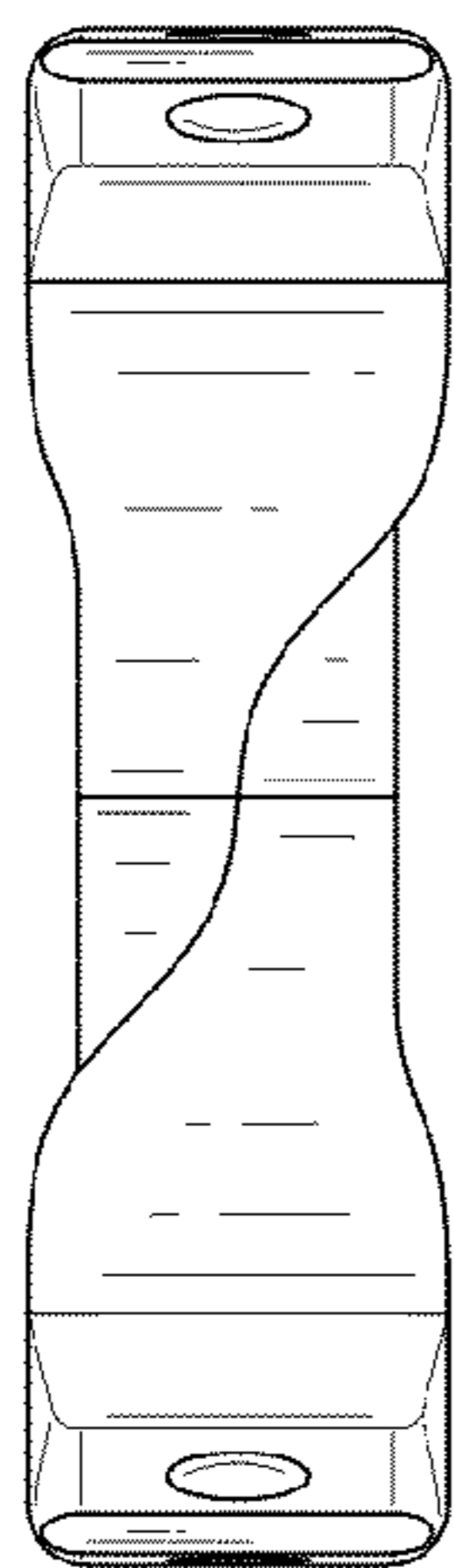

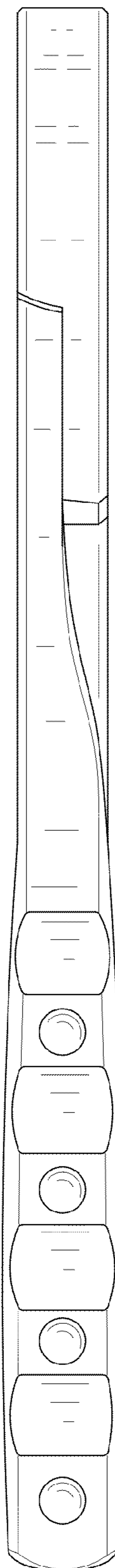

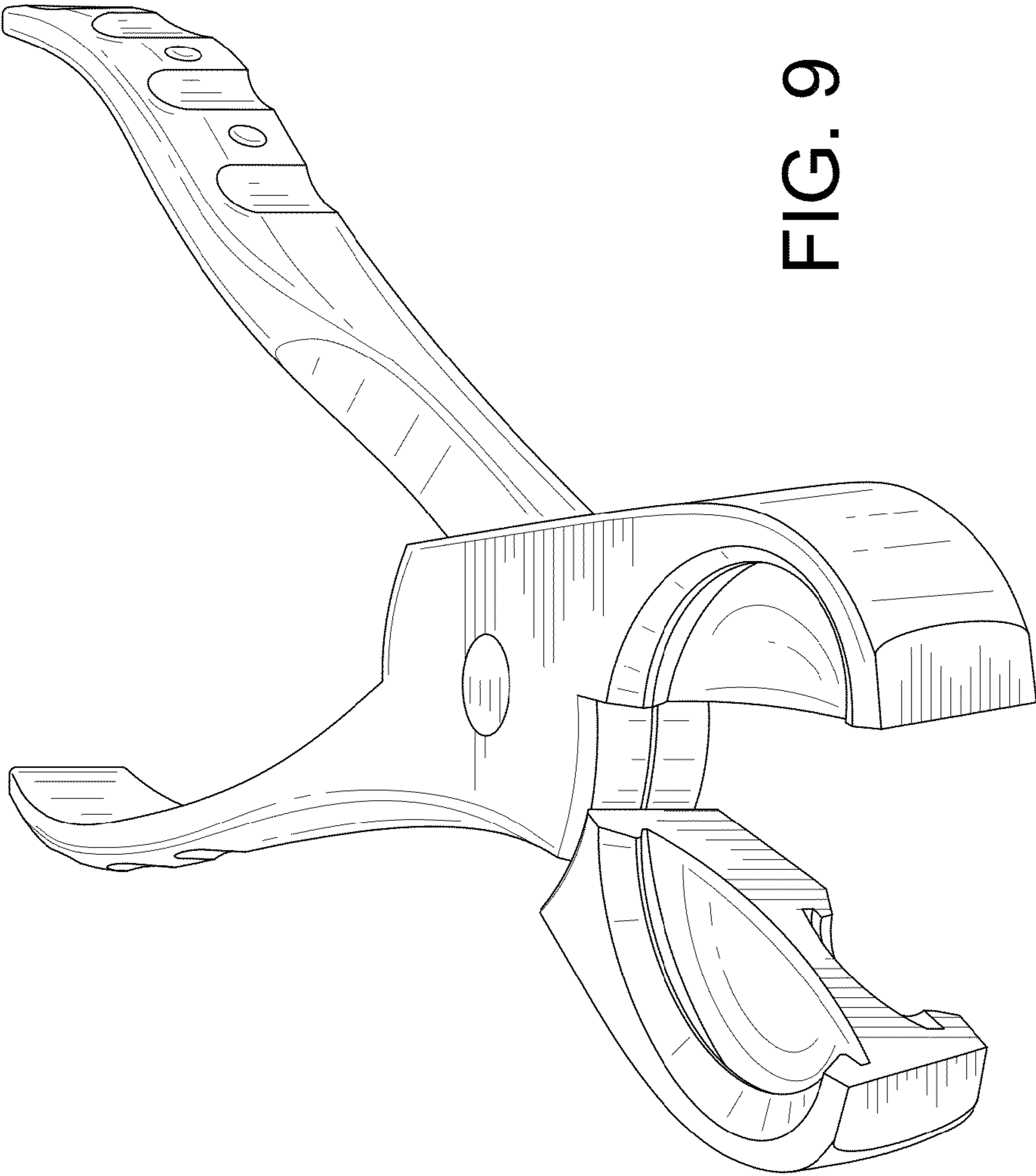
