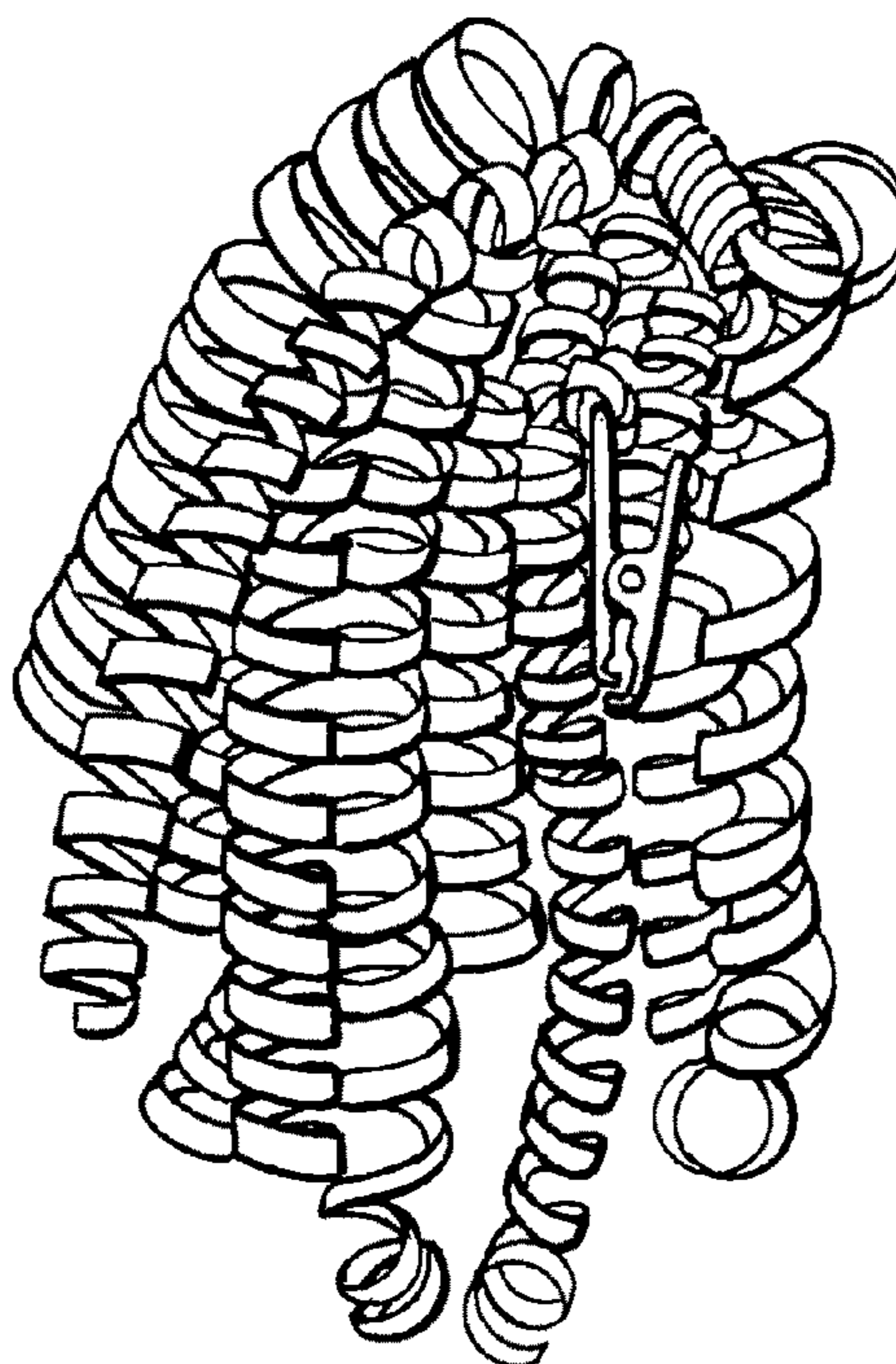
(57) **CLAIM**

The ornamental design for a gift bow with clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of the gift bow with clip; FIG. 2 is a side elevation view of a first variant thereof; FIG. 3 is a rear elevation view of a first variant thereof; FIG. 4 is a side elevation view of a second variant thereof; and, FIG. 5 is a rear elevation view of a second variant thereof.

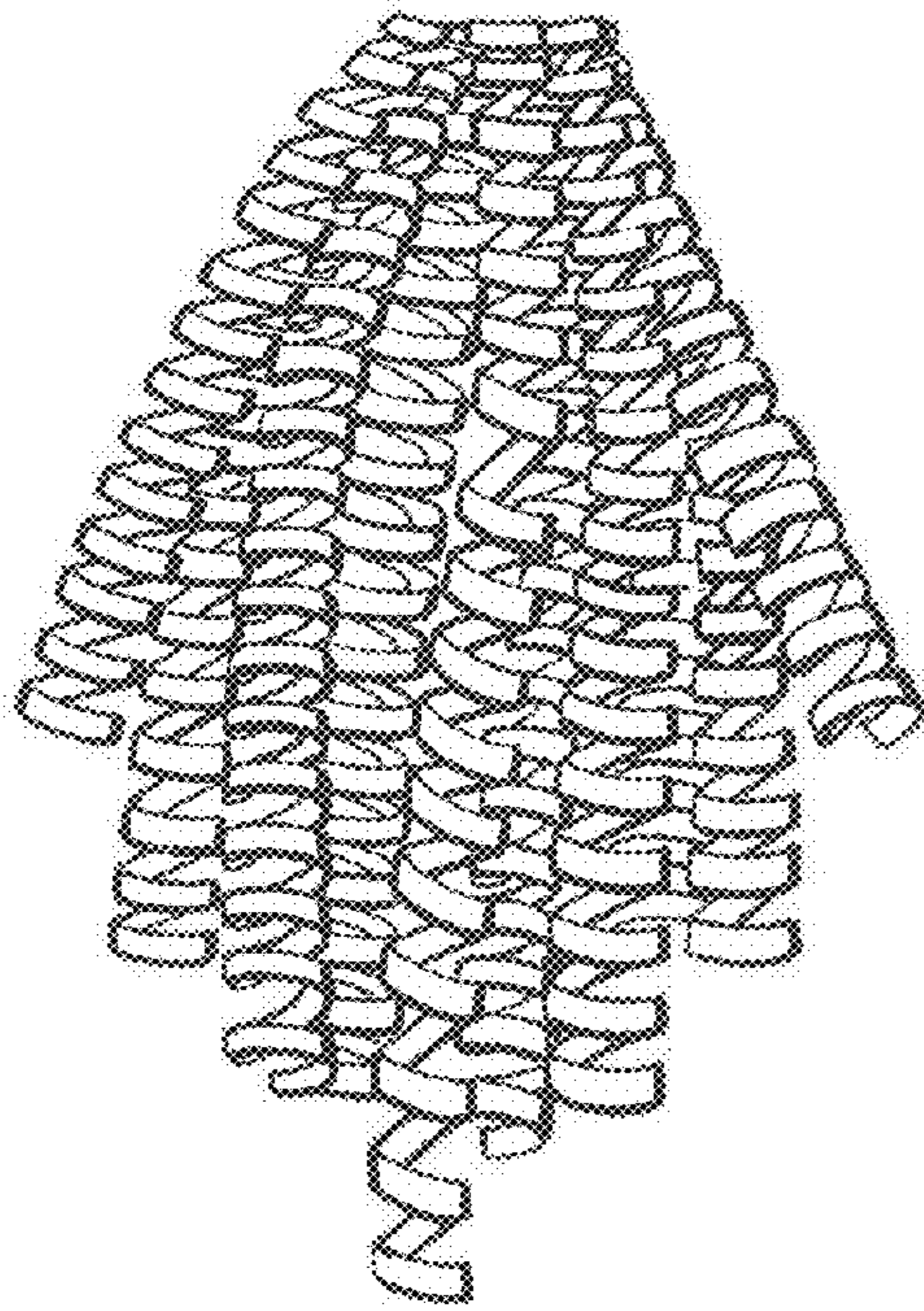

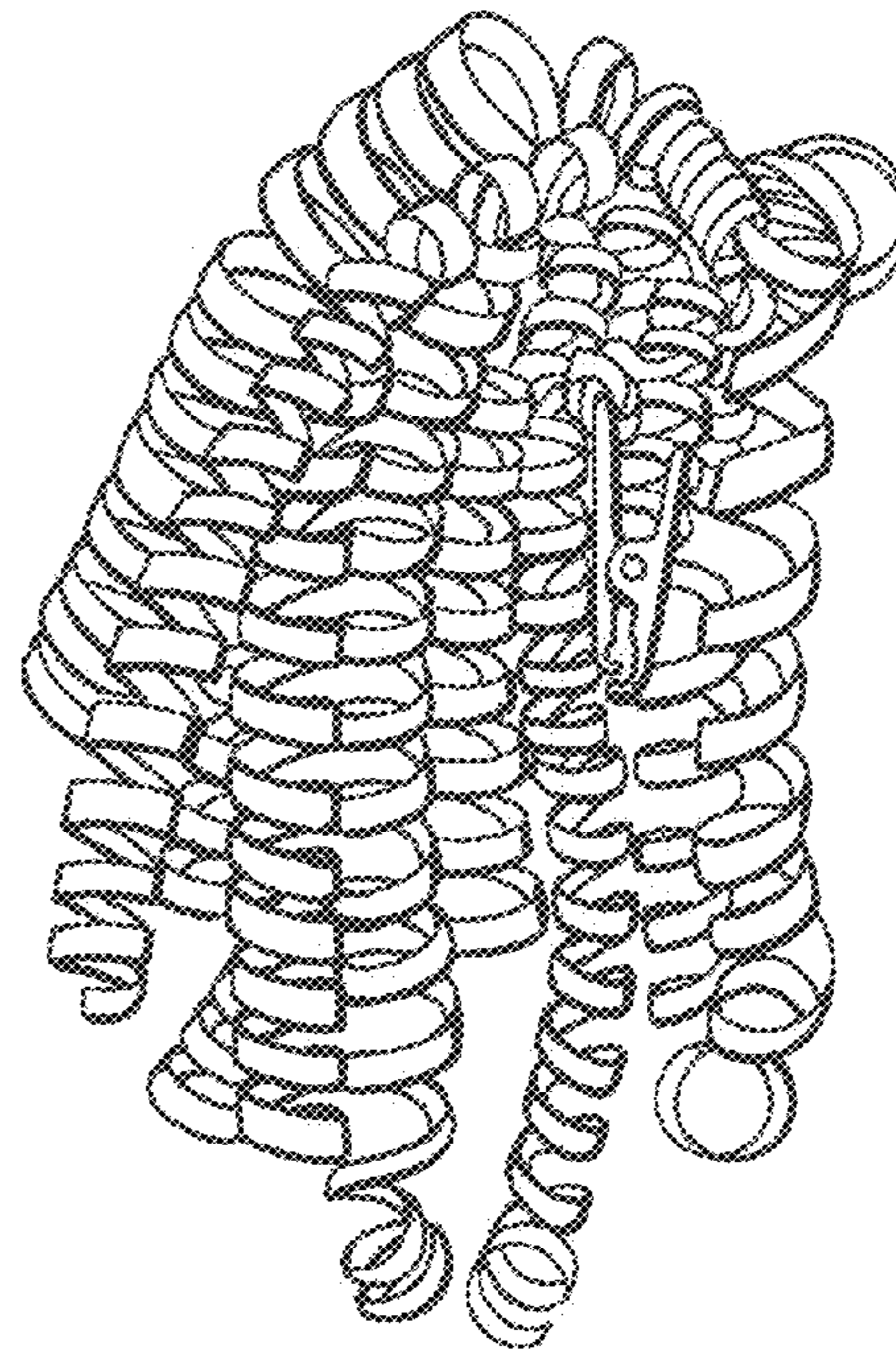

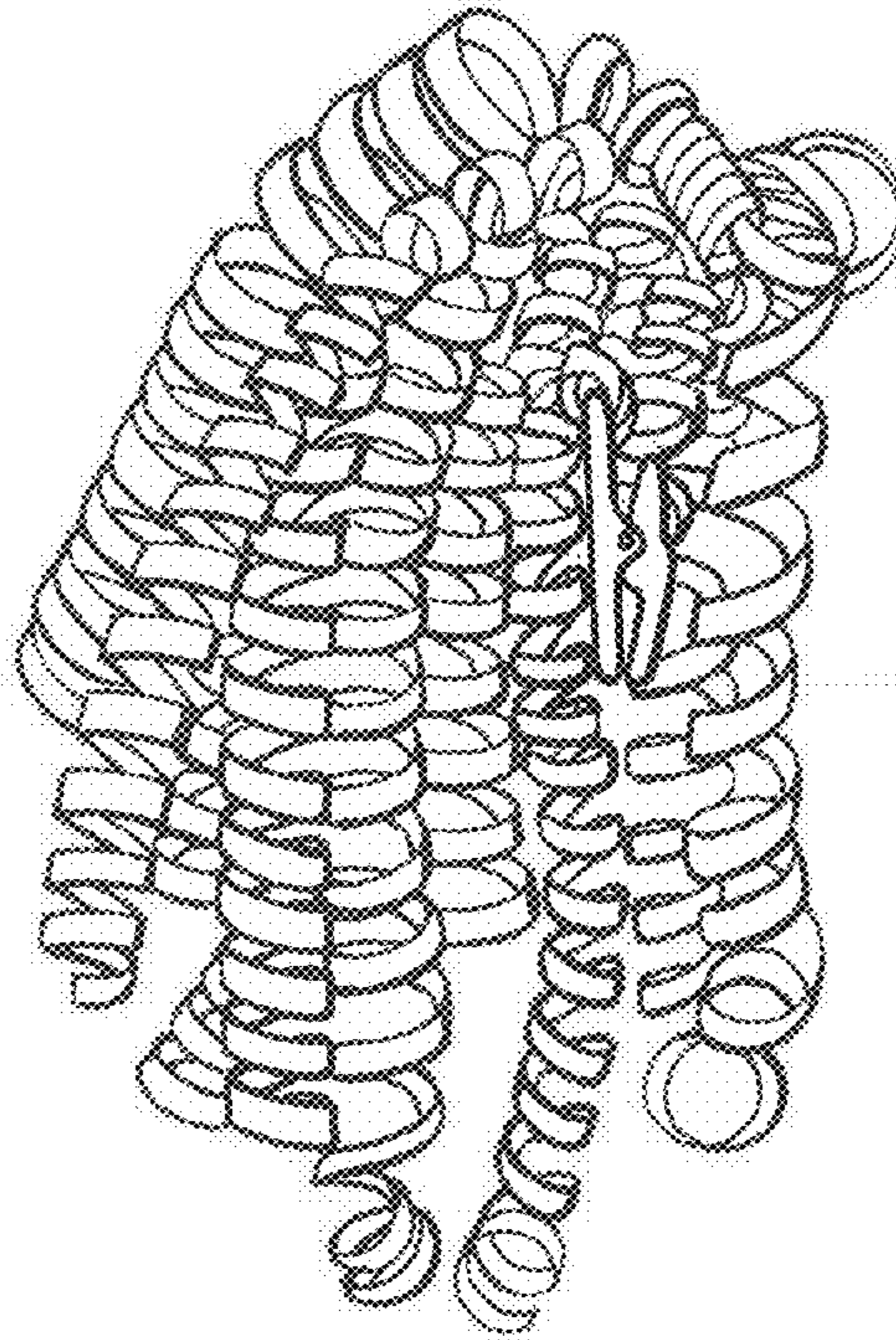

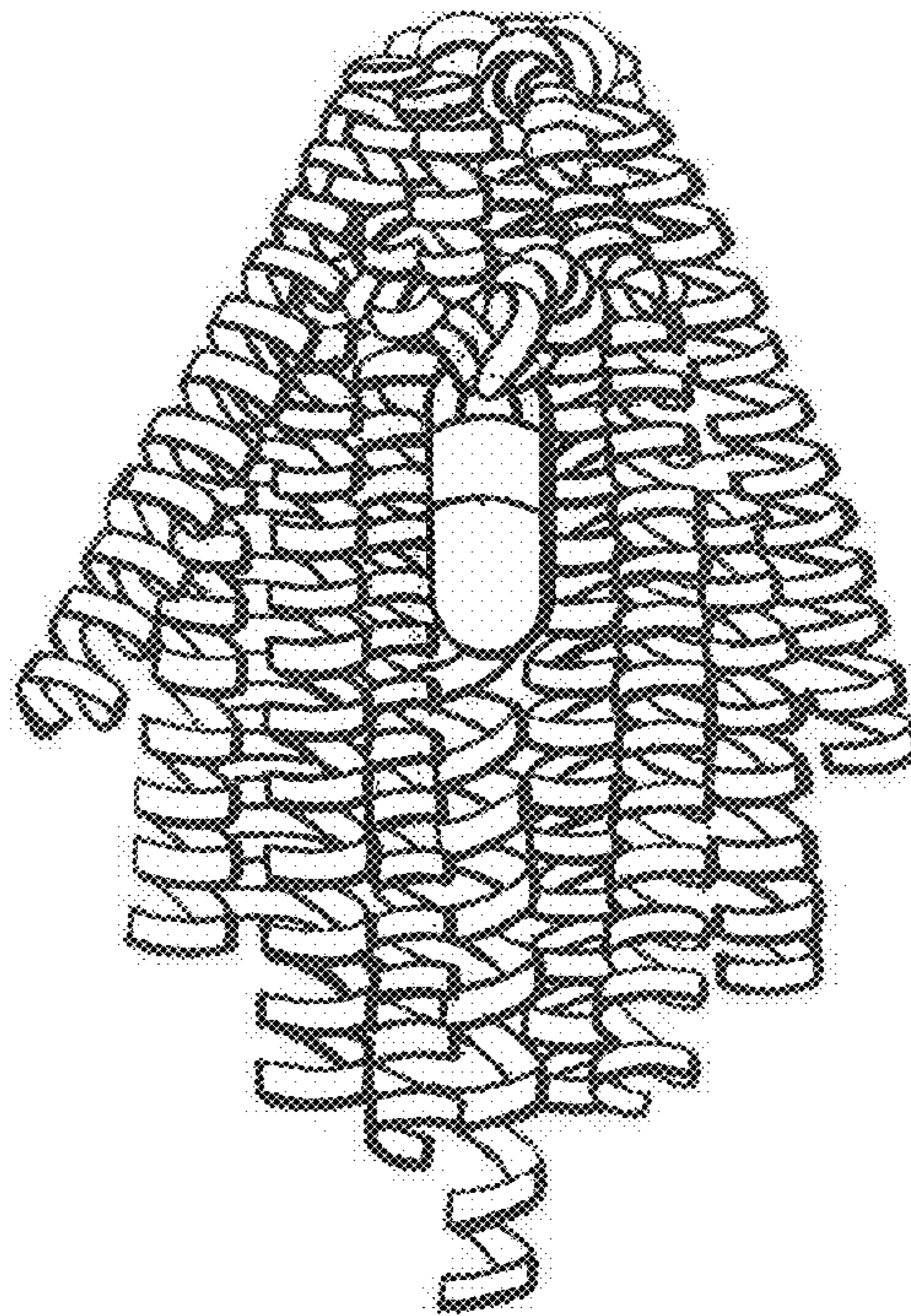
