**DESCRIPTION**

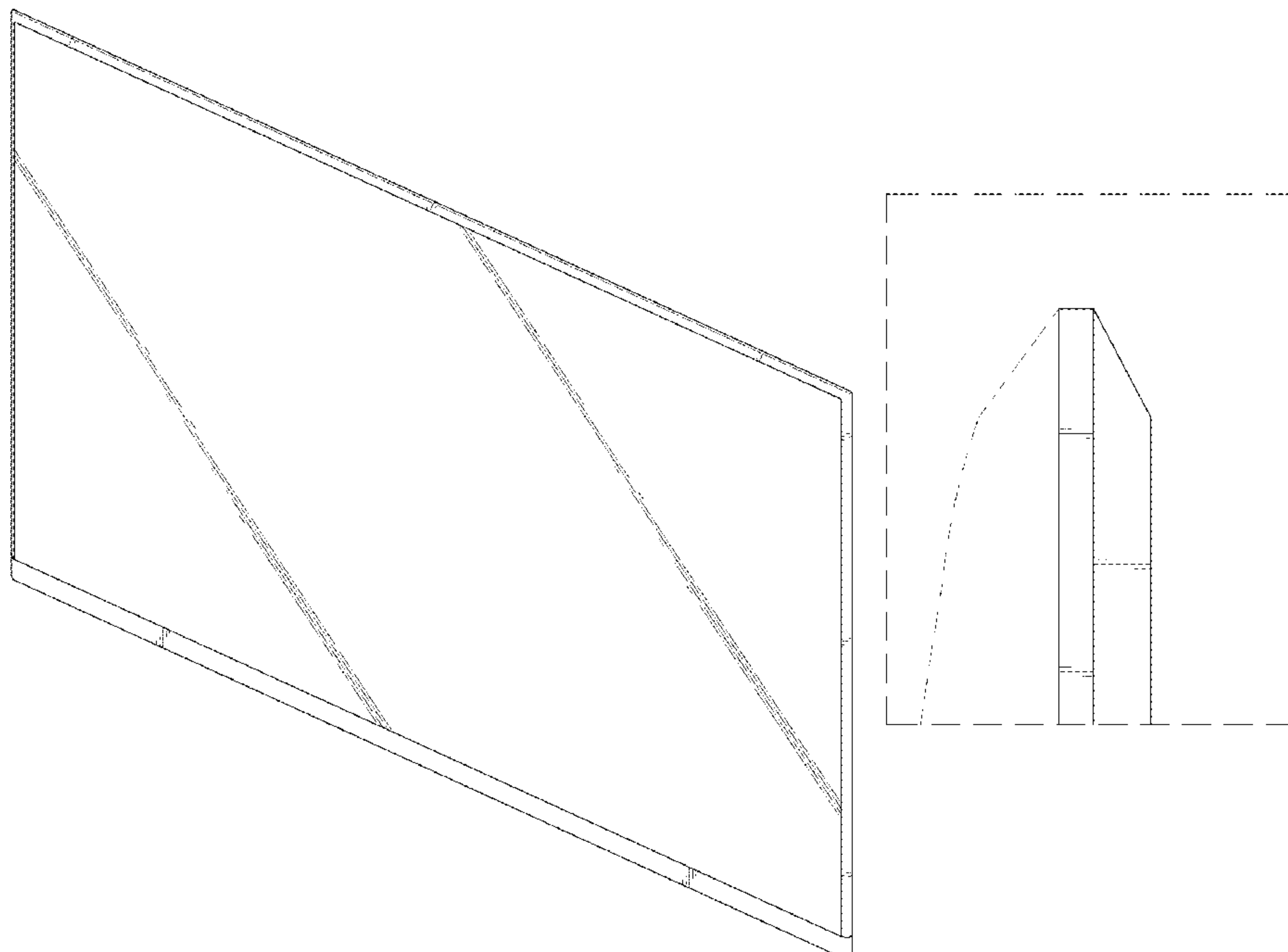

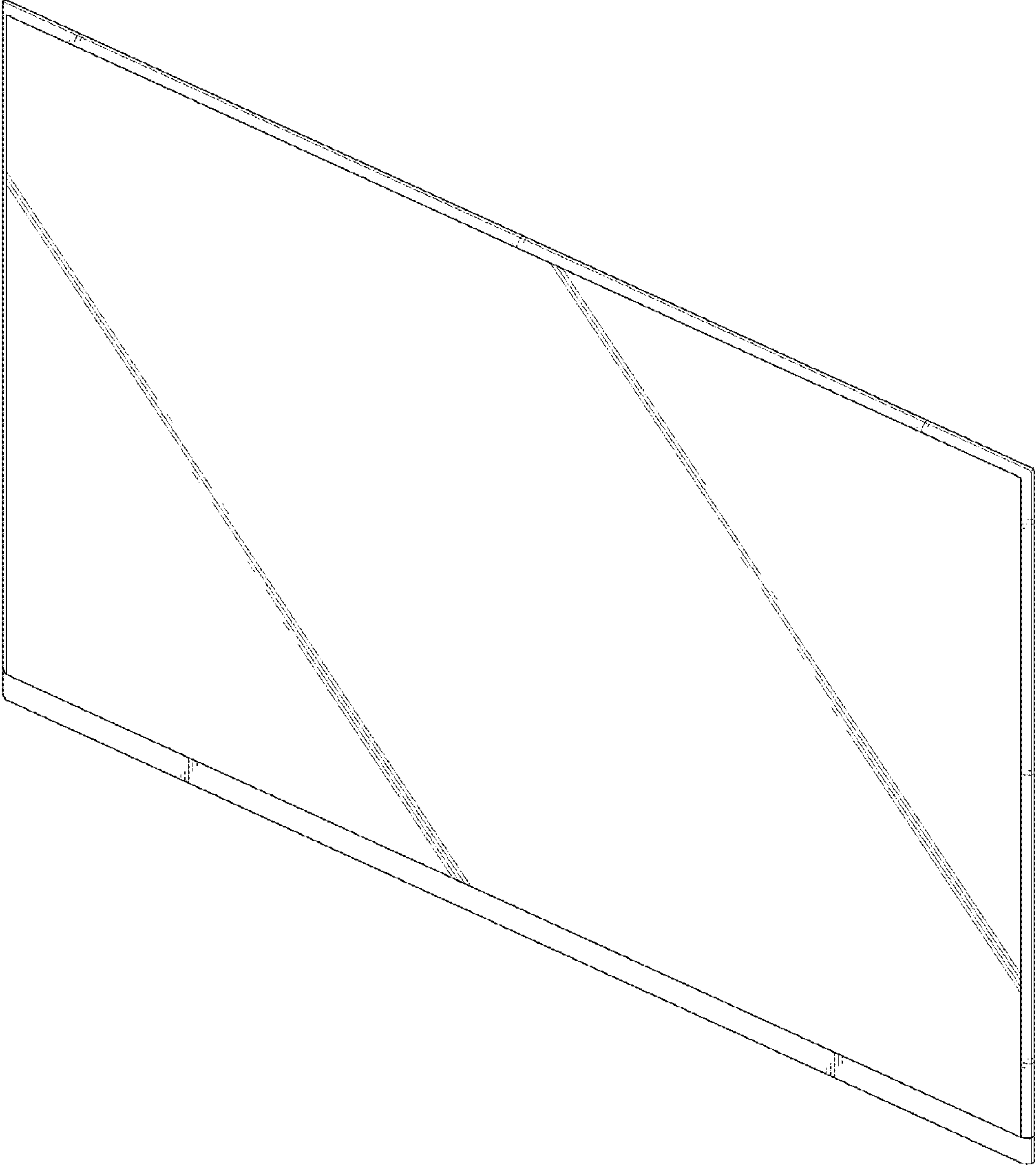

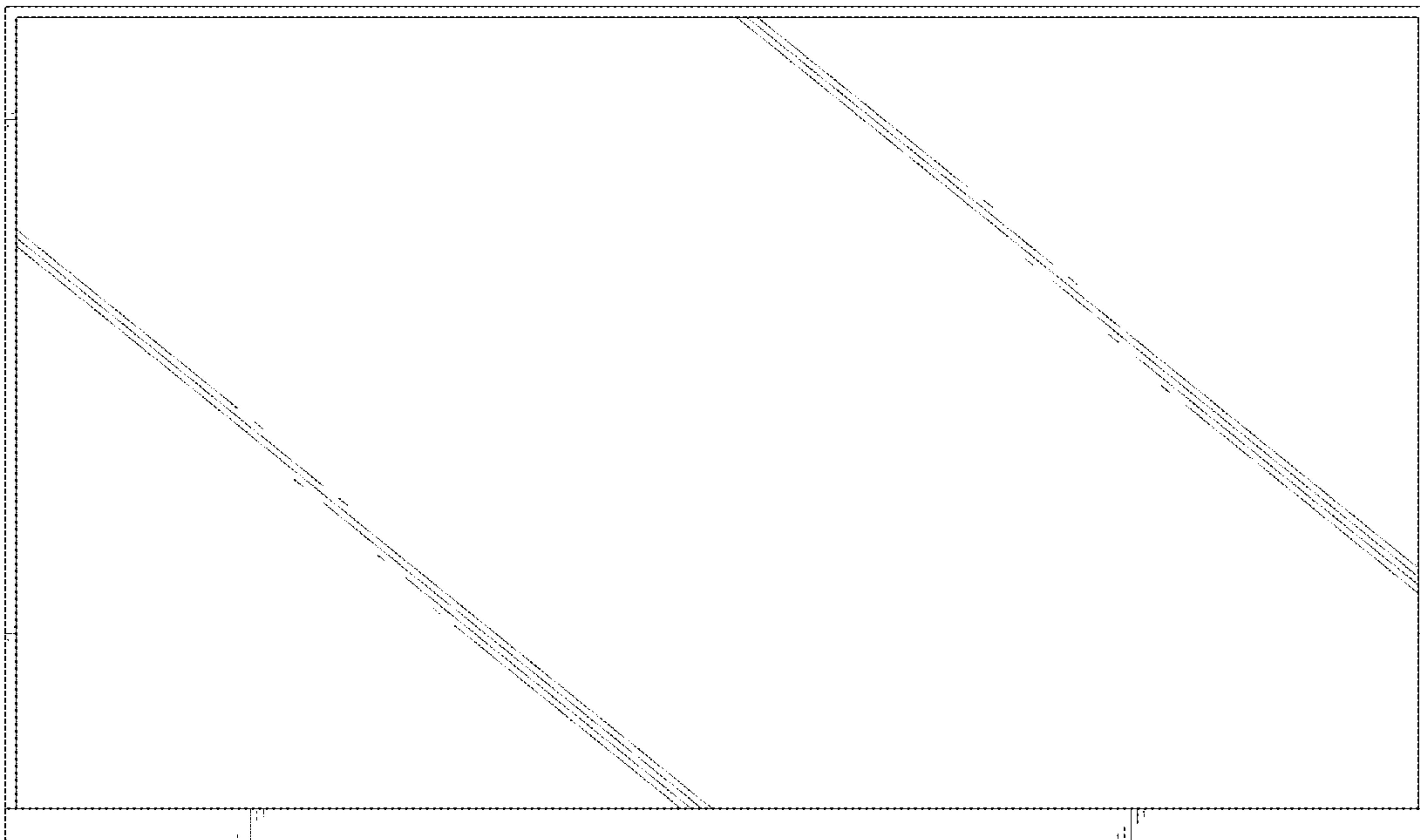

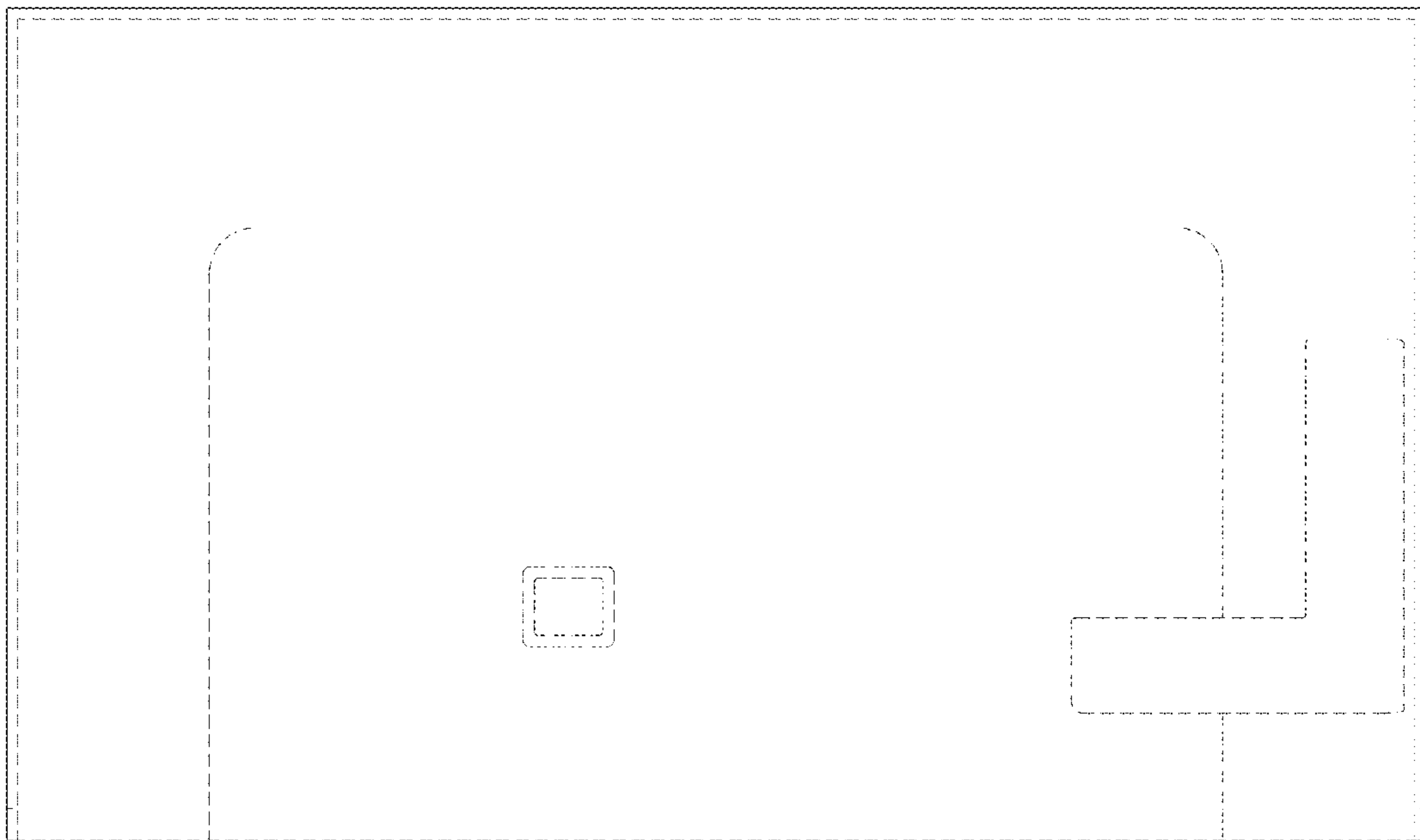

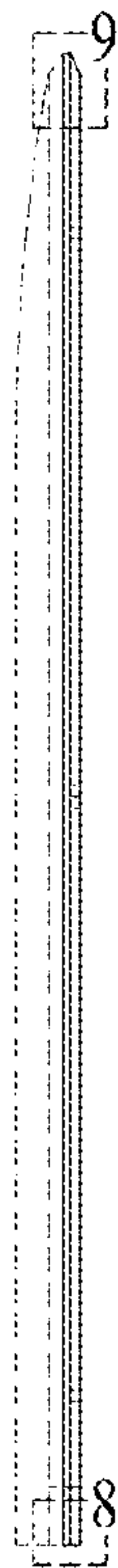

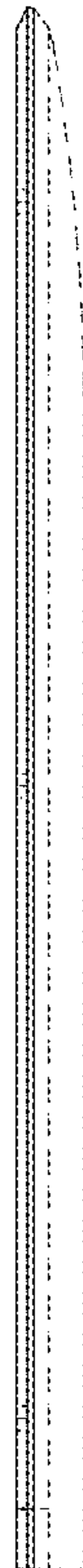

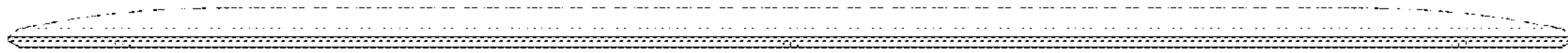

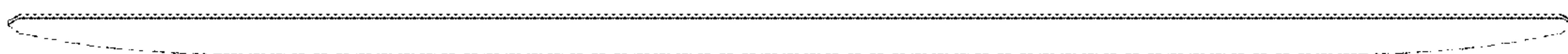

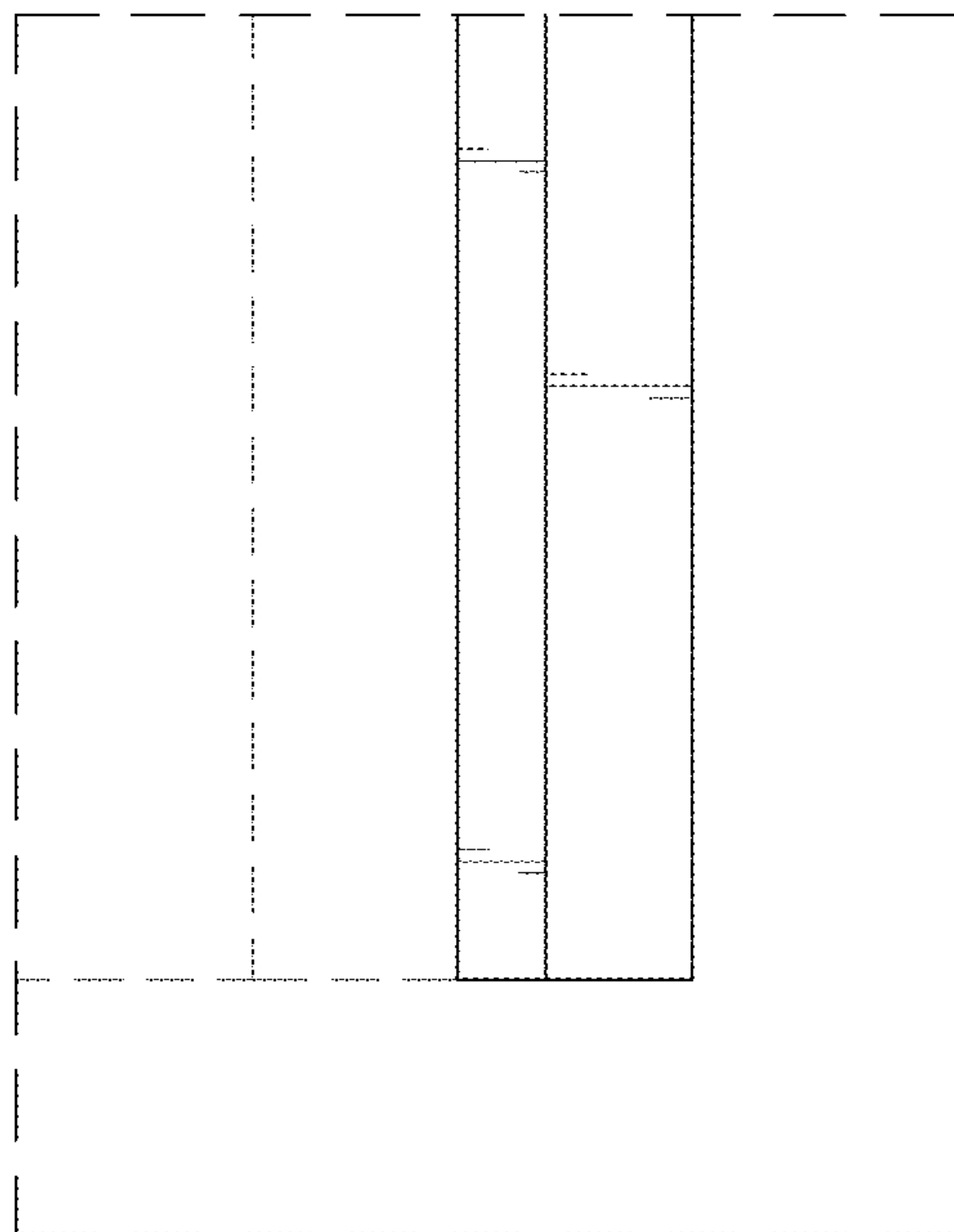
