FIG. 4 is a front elevational view thereof; and,

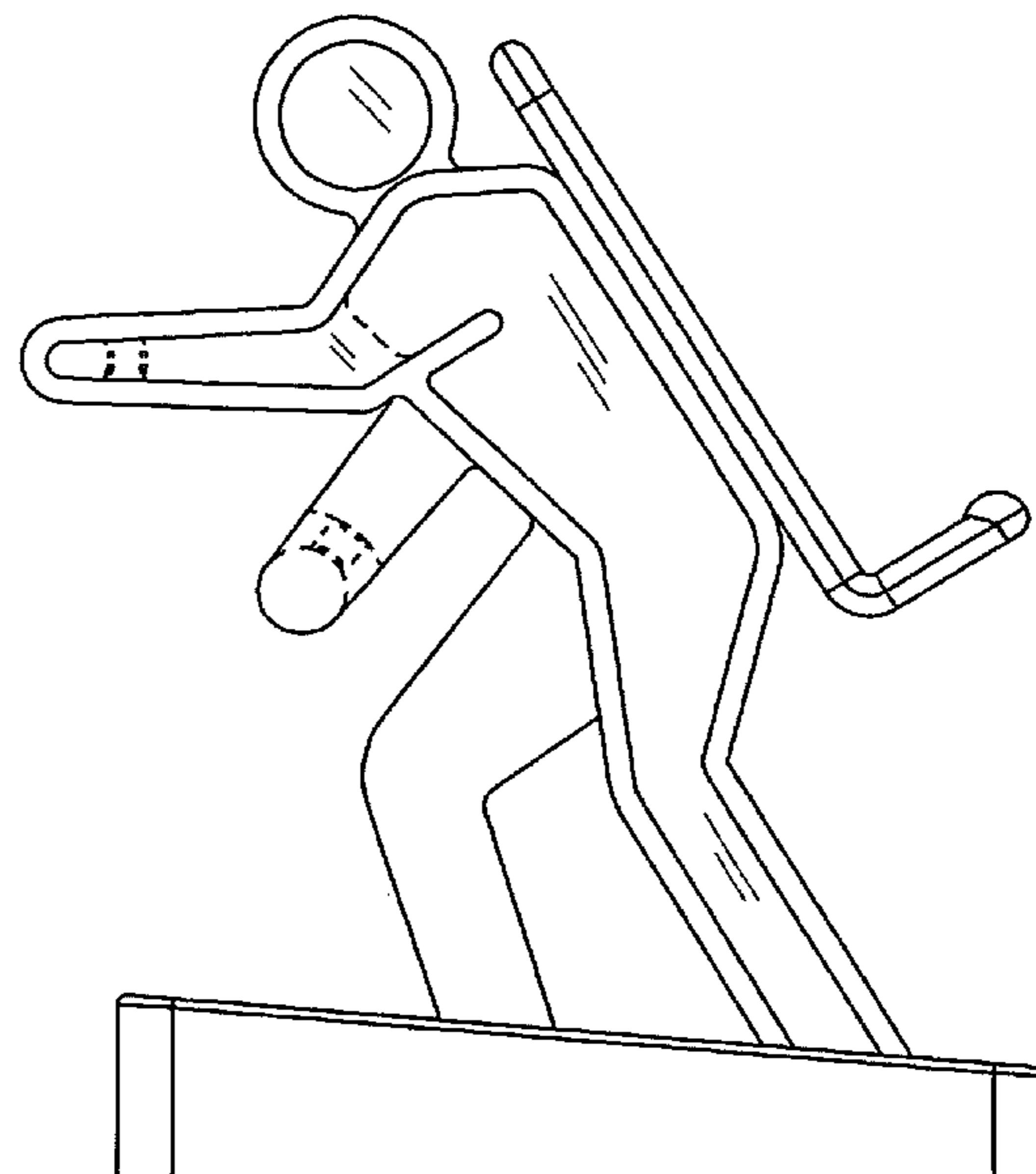
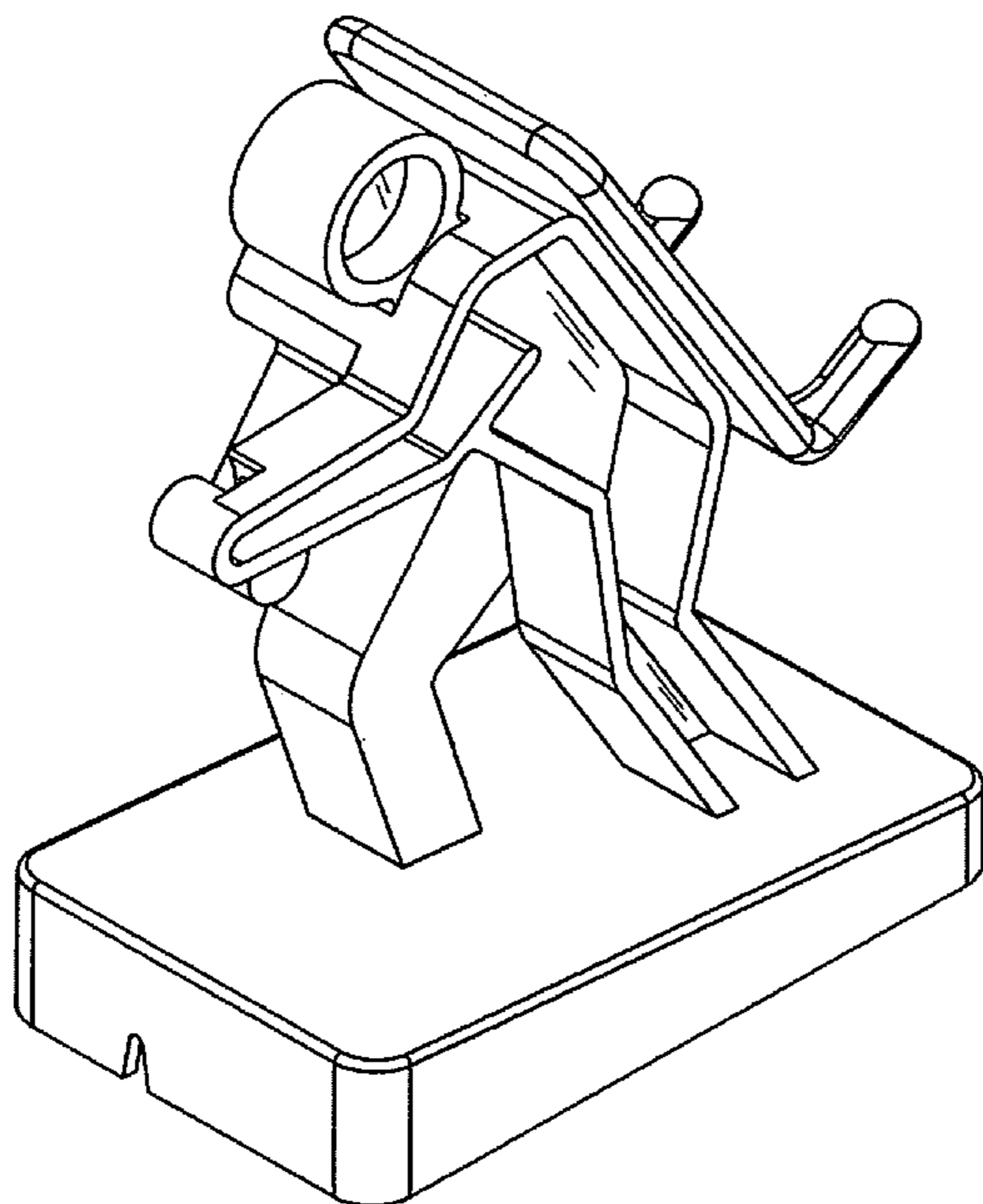
FIG. 5 is a top plan elevational view thereof.

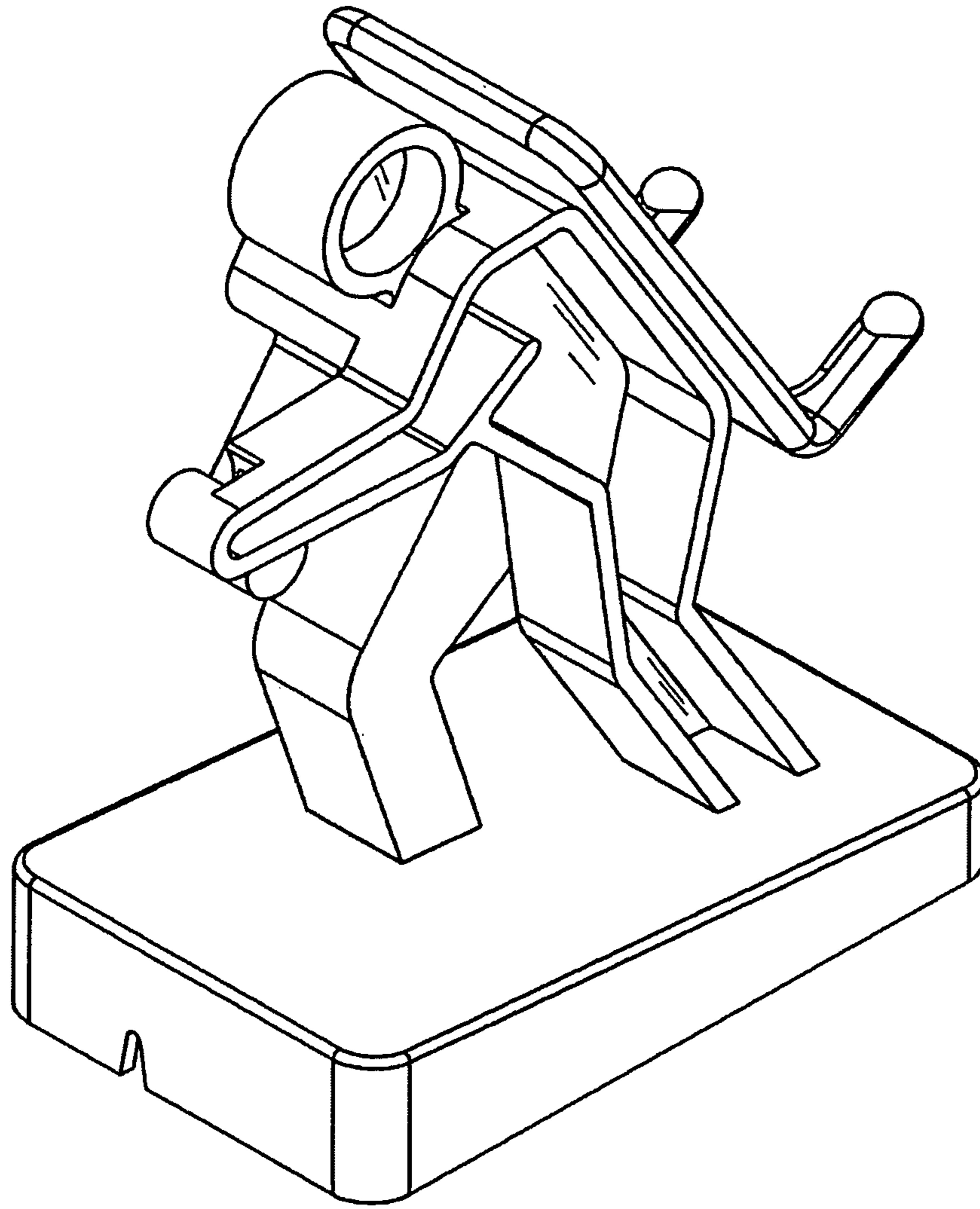

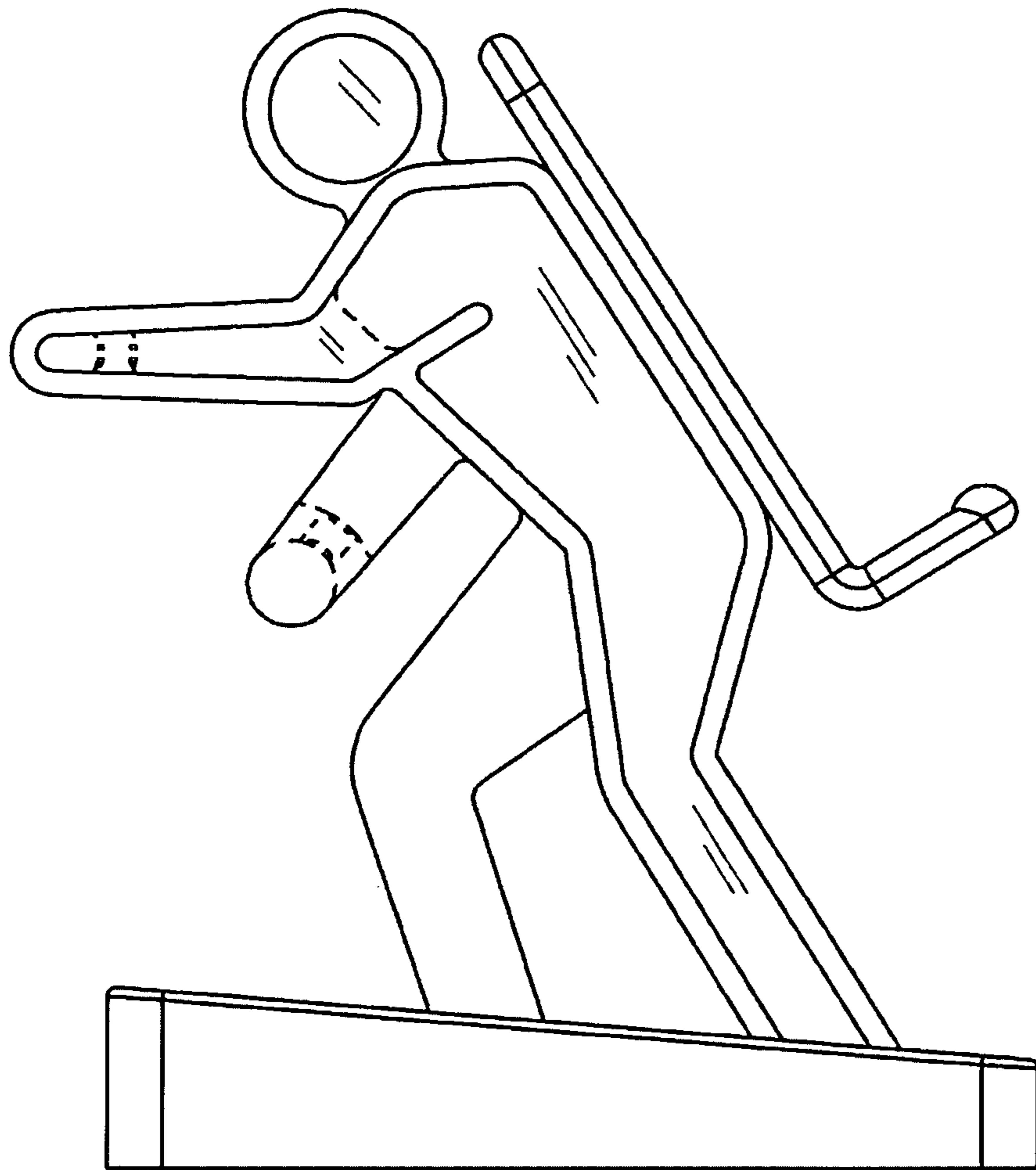

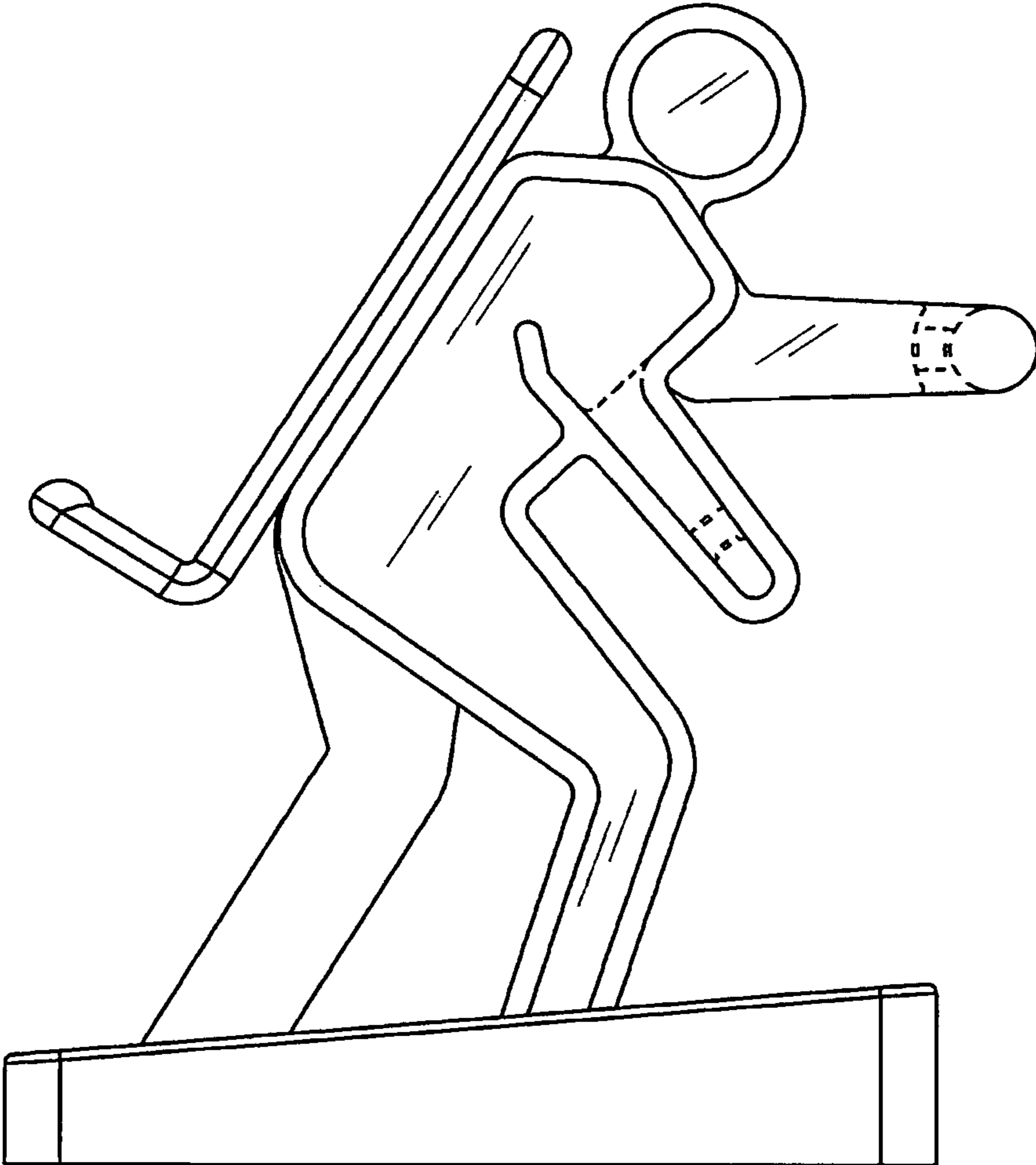

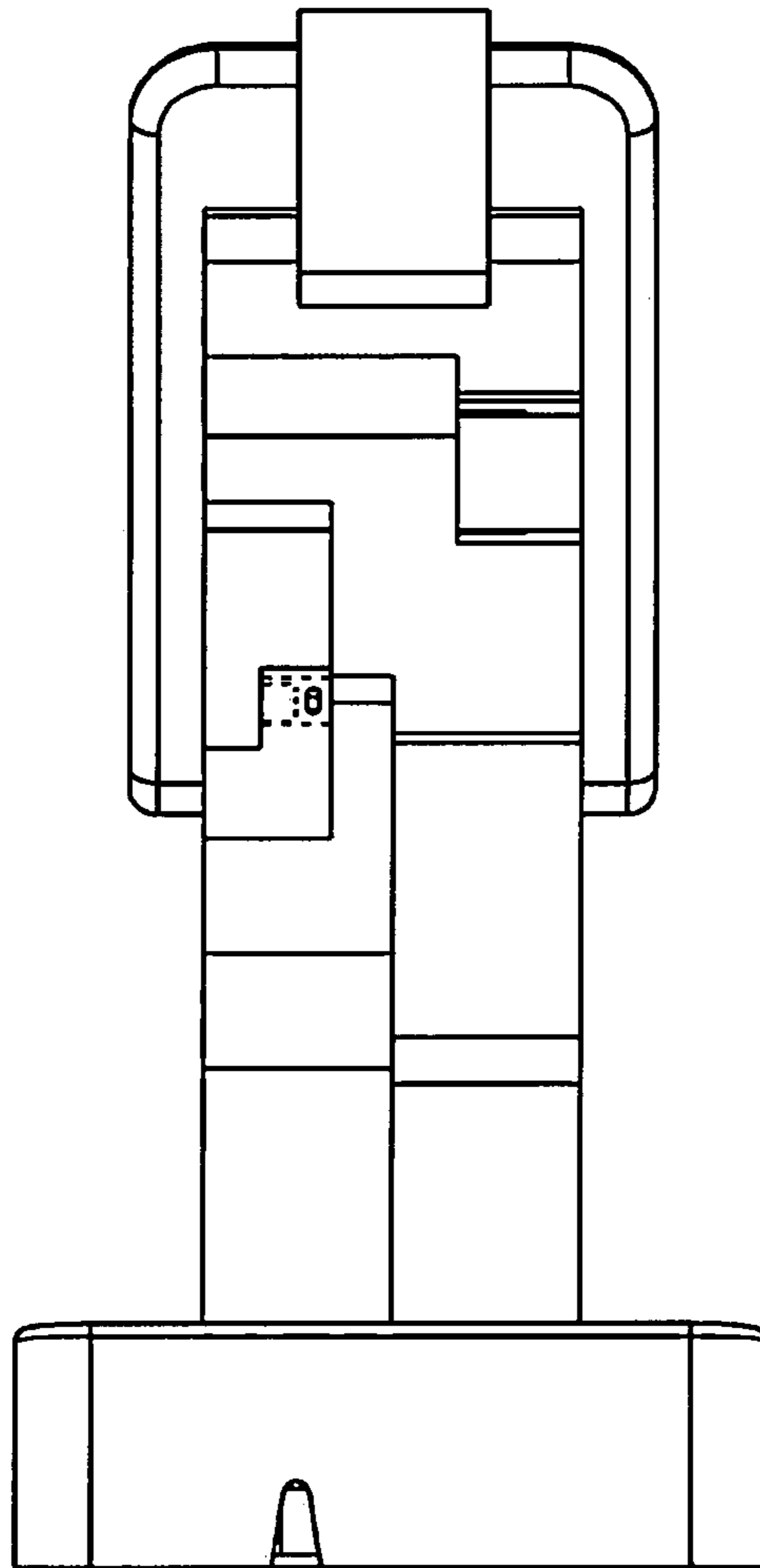

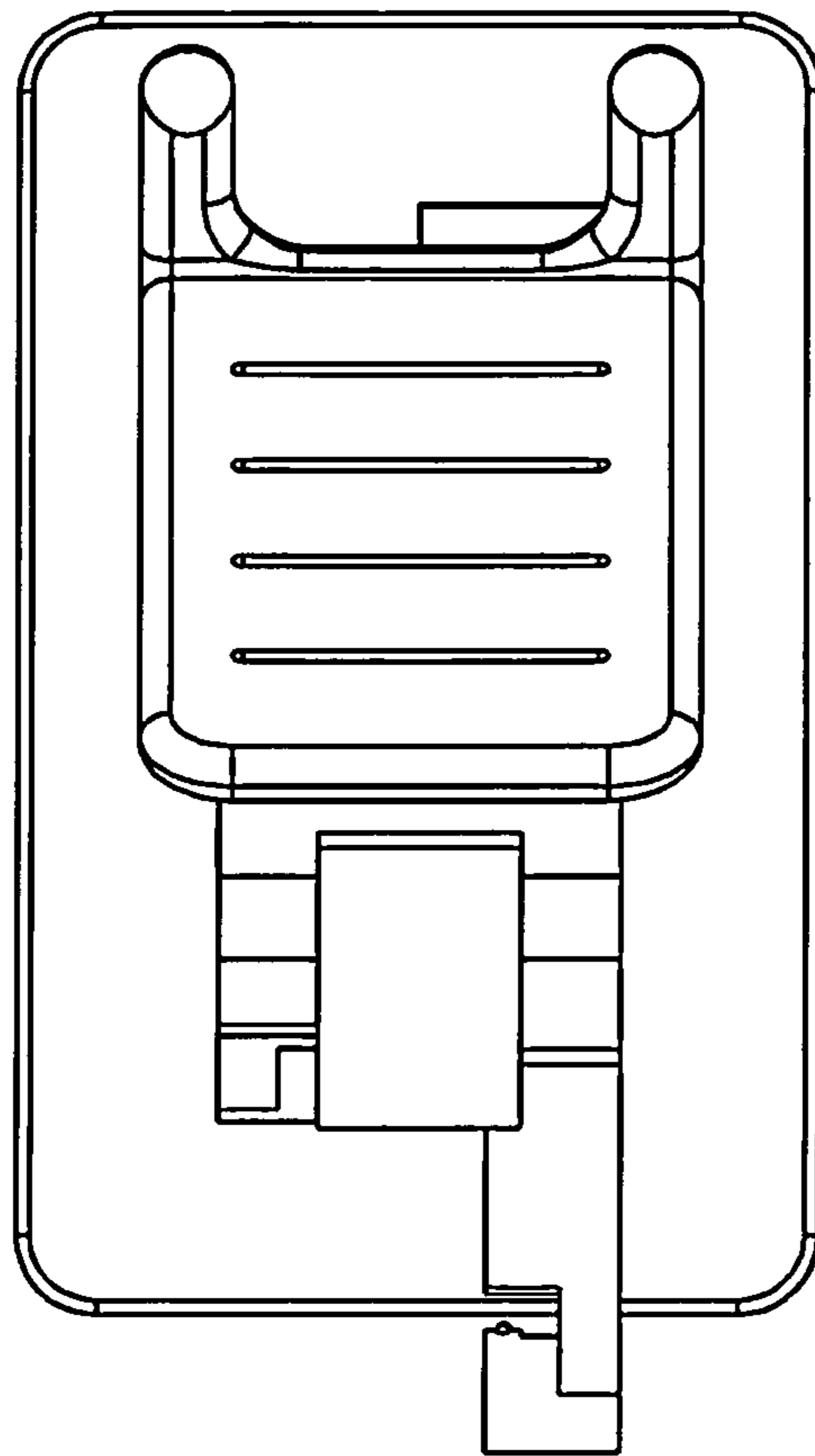
