The ornamental design for a personal computer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of front, bottom and right side of a personal computer showing our new design;

FIG. 2 is a perspective view of rear, bottom and left side thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is a top view thereof;

FIG. 8 is a bottom view thereof;

FIG. 9 is a perspective view of front, bottom and right side thereof, with lid open;

FIG. 10 is a perspective view of rear, bottom and left side thereof, with lid open;

FIG. 11 is a front view thereof, with lid open;

FIG. 12 is a rear view thereof, with lid open;

FIG. 13 is a left side view thereof, with lid open;

FIG. 14 is a right side view thereof, with lid open;

FIG. 15 is a top view thereof, with lid open;

FIG. 16 is a bottom view thereof, with lid open;

FIG. 17 is a cross-sectional view taken along line 17-17' in FIG. 15 thereof, omitting the interior mechanism;

FIG. 18 is a cross-sectional view taken along line 18-18' in FIG. 15 thereof, omitting the interior mechanism;

FIG. 19 is a partial enlarged view taken along line 19-19' in FIG. 17 thereof; and,

FIG. 20 is a cross-sectional view taken along line 20-20' in FIG. 15 thereof, omitting the interior mechanism.

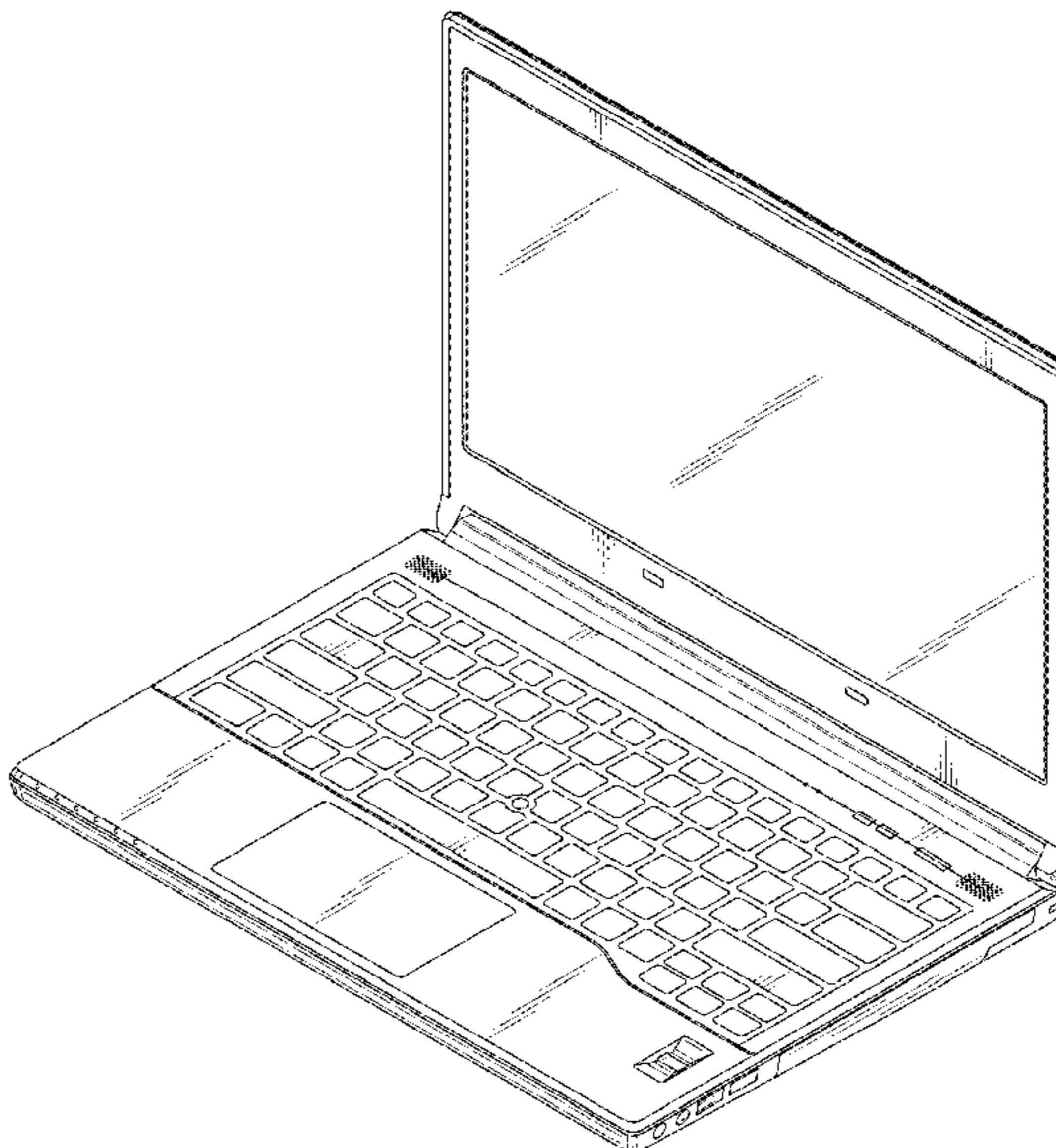
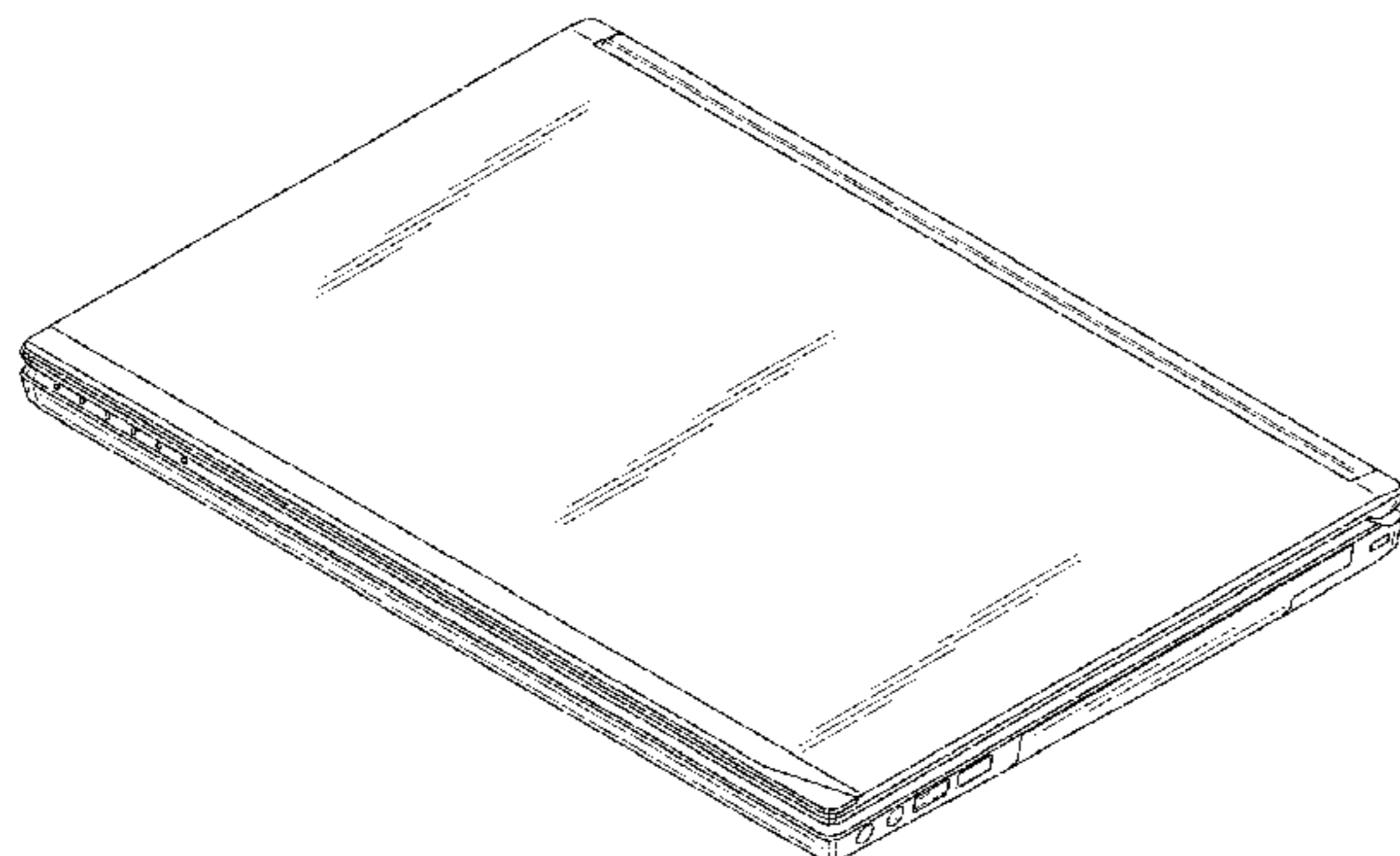

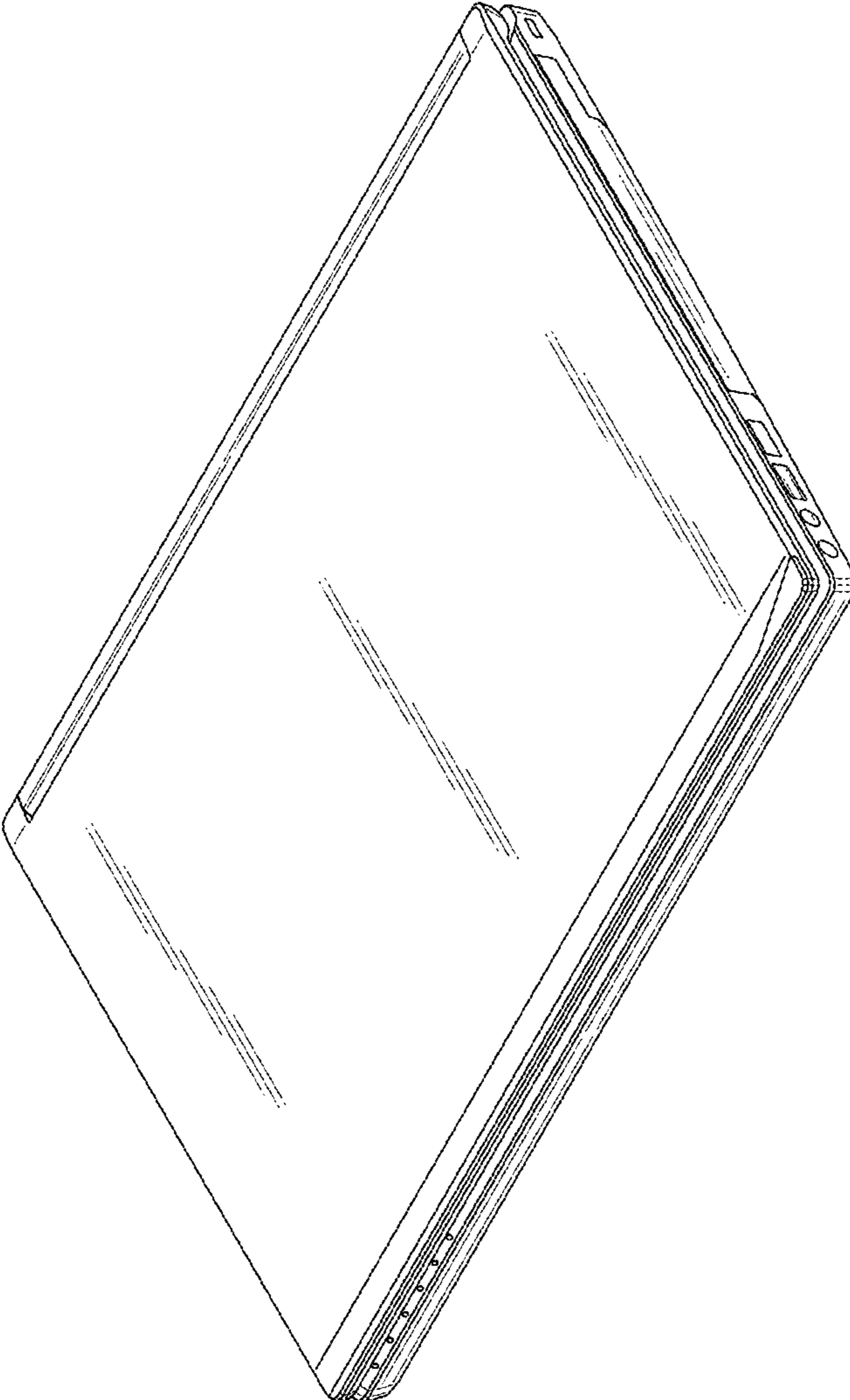

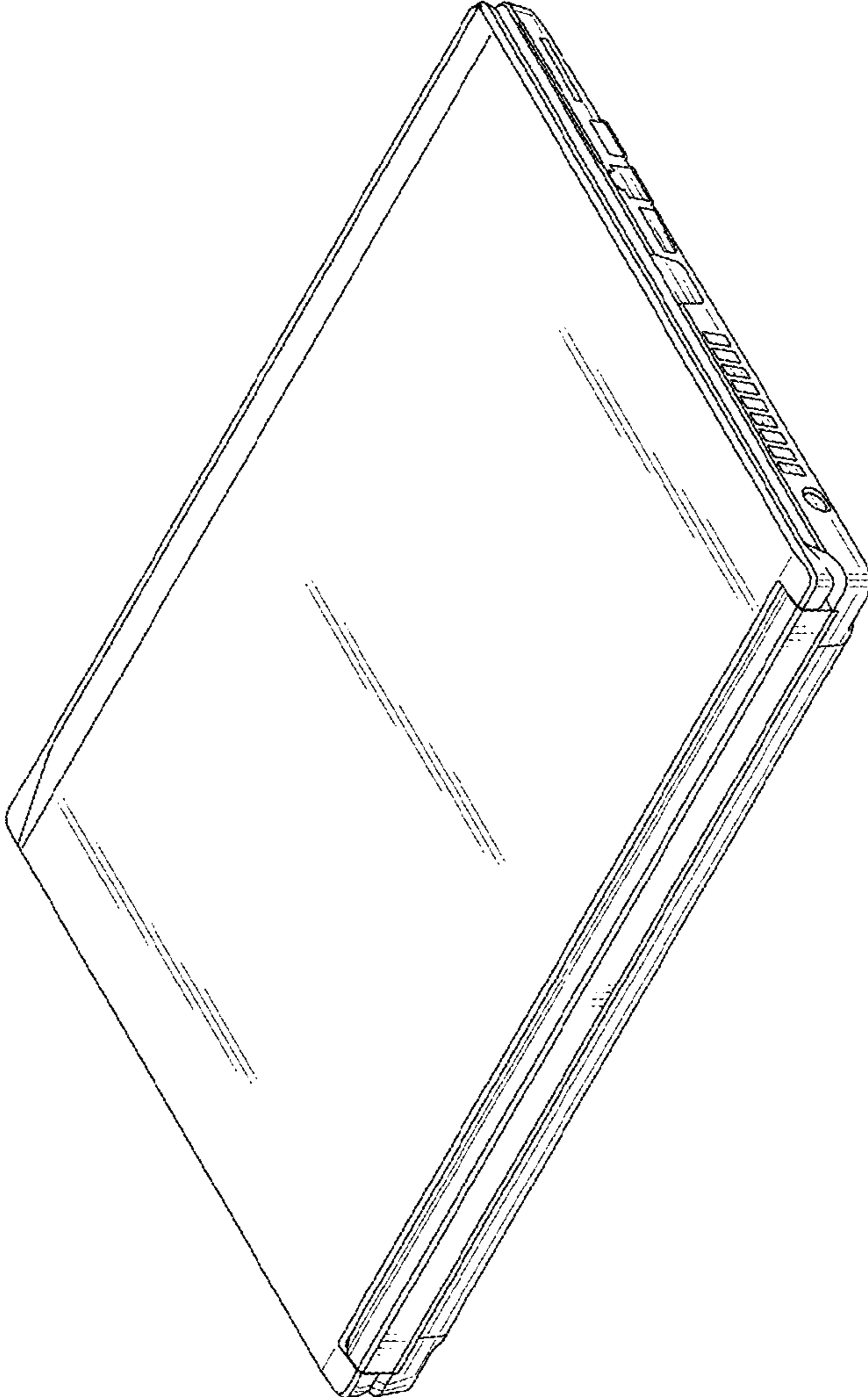

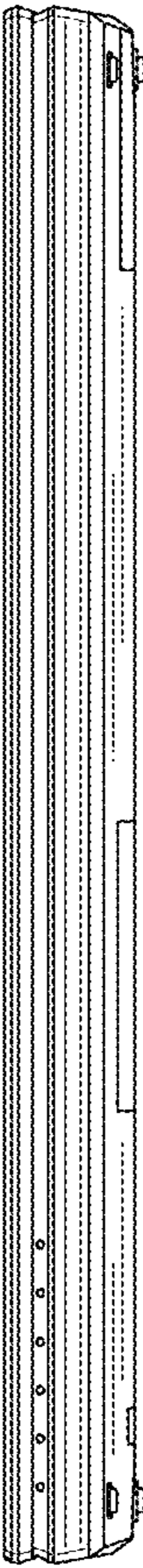

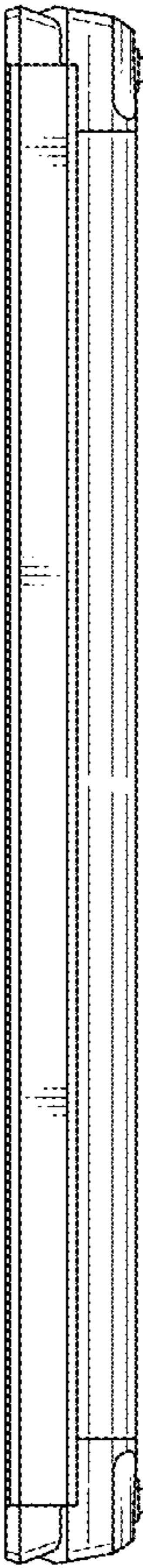

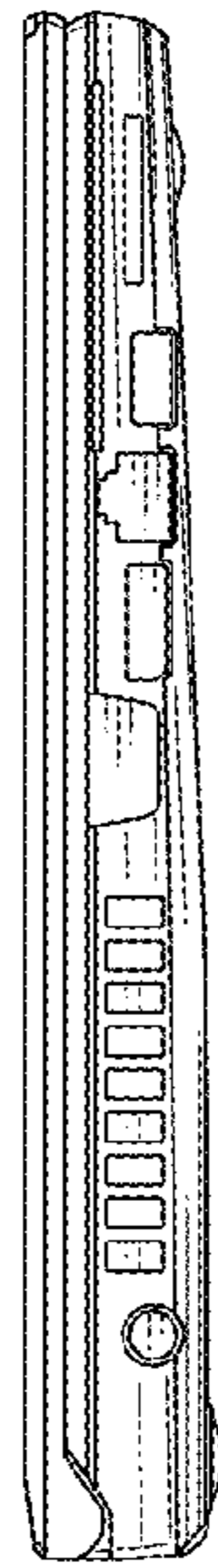

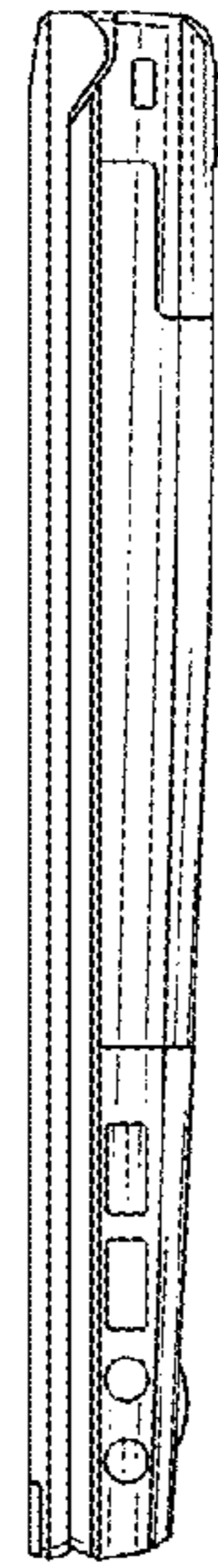

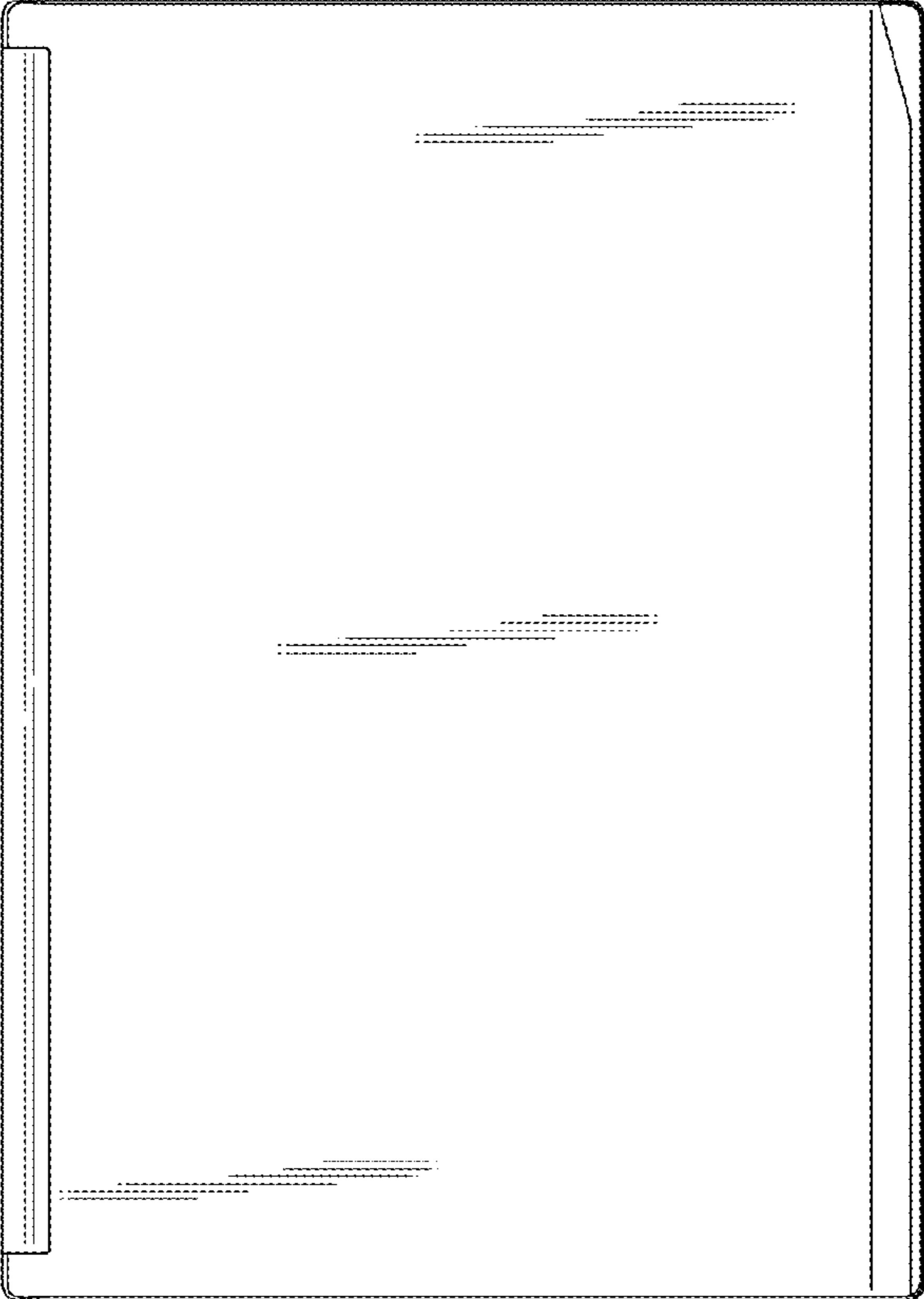
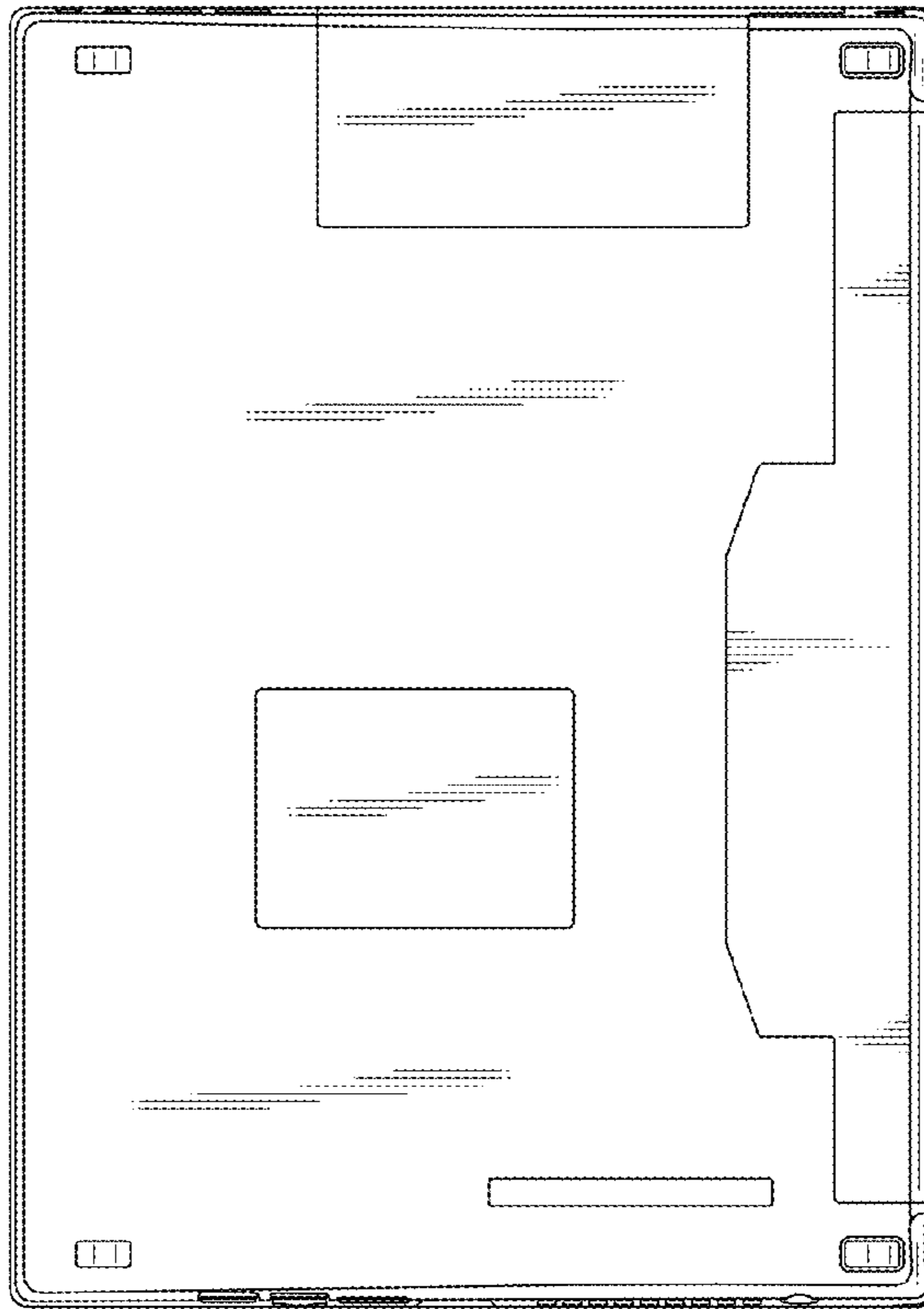

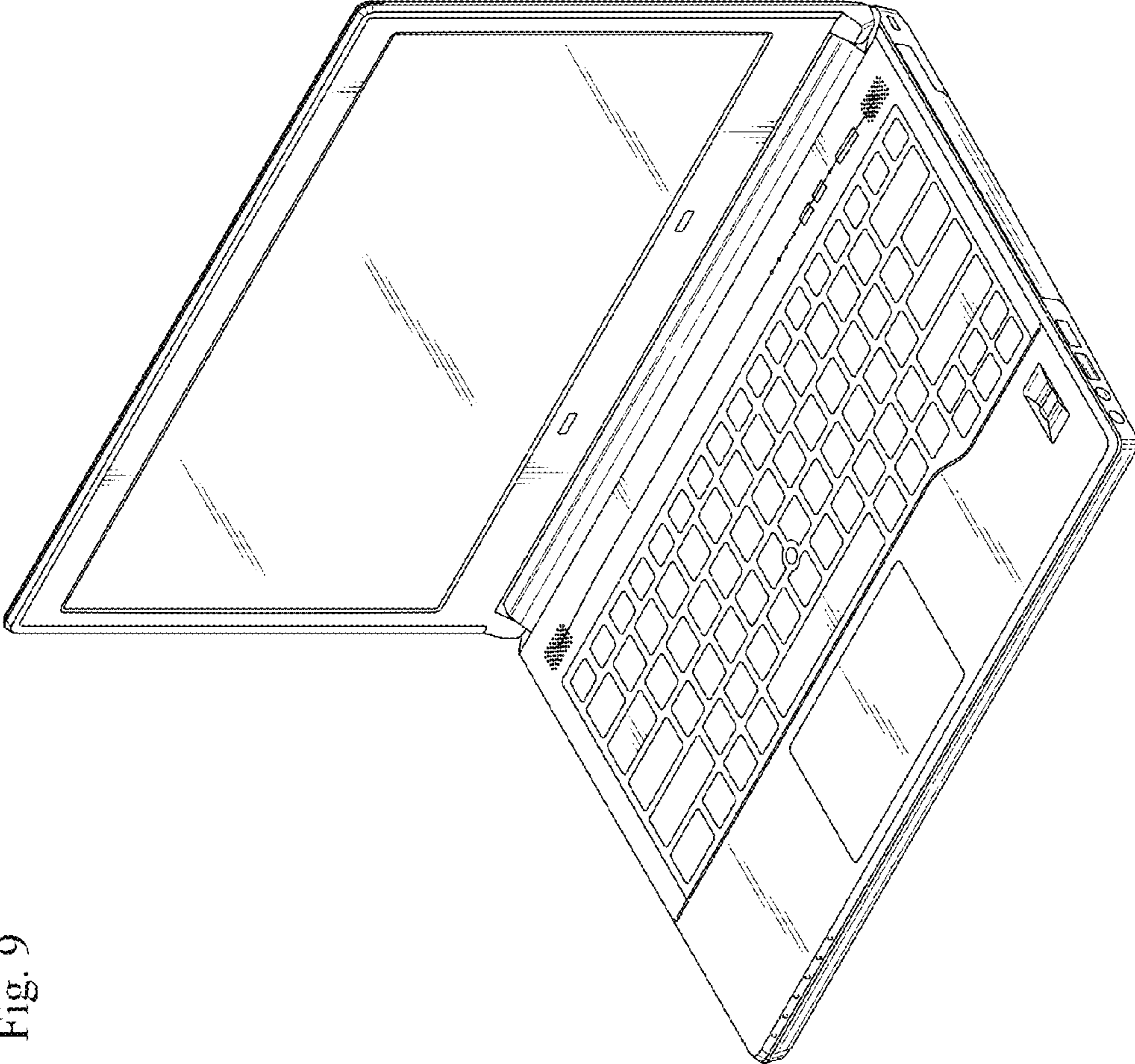

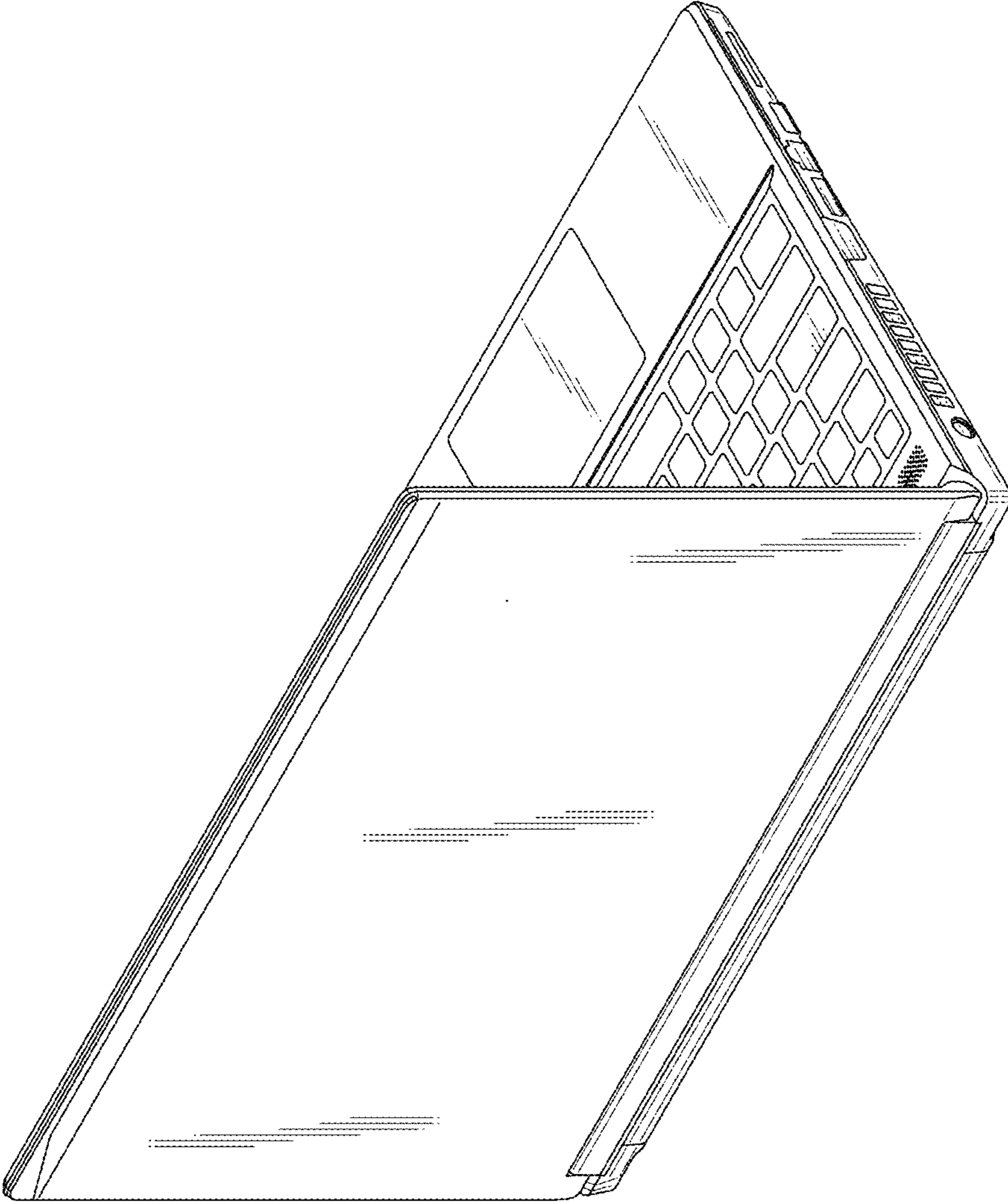

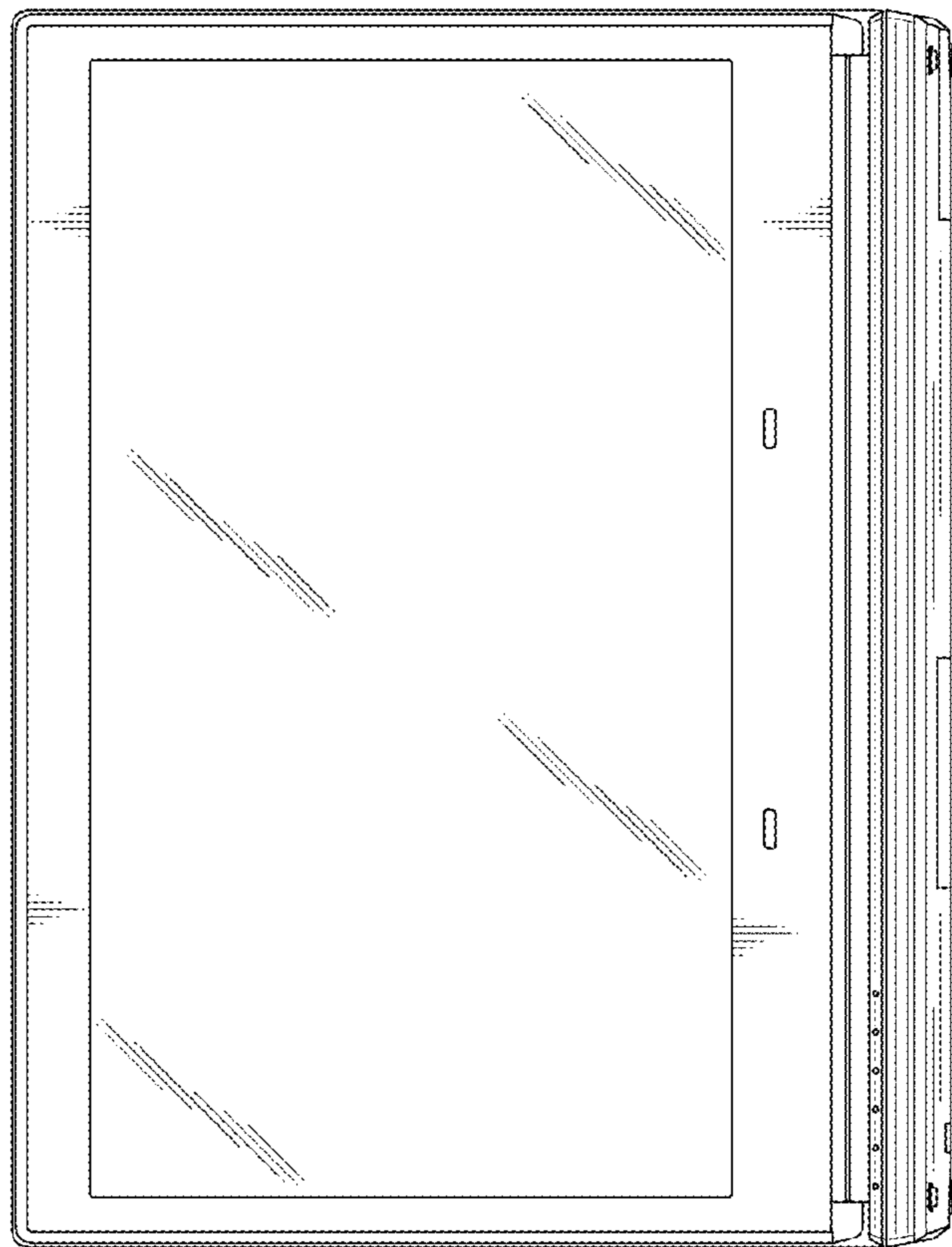

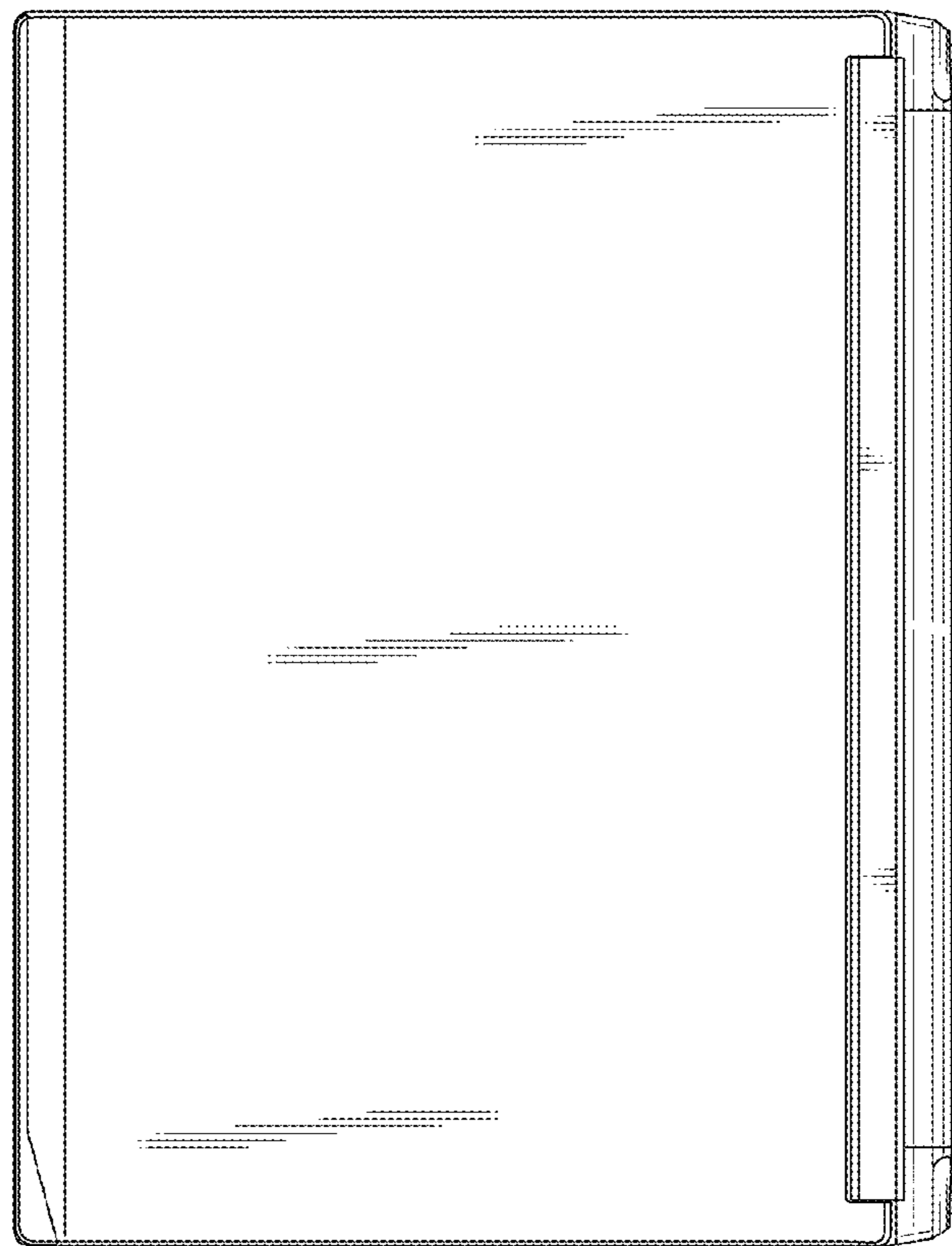

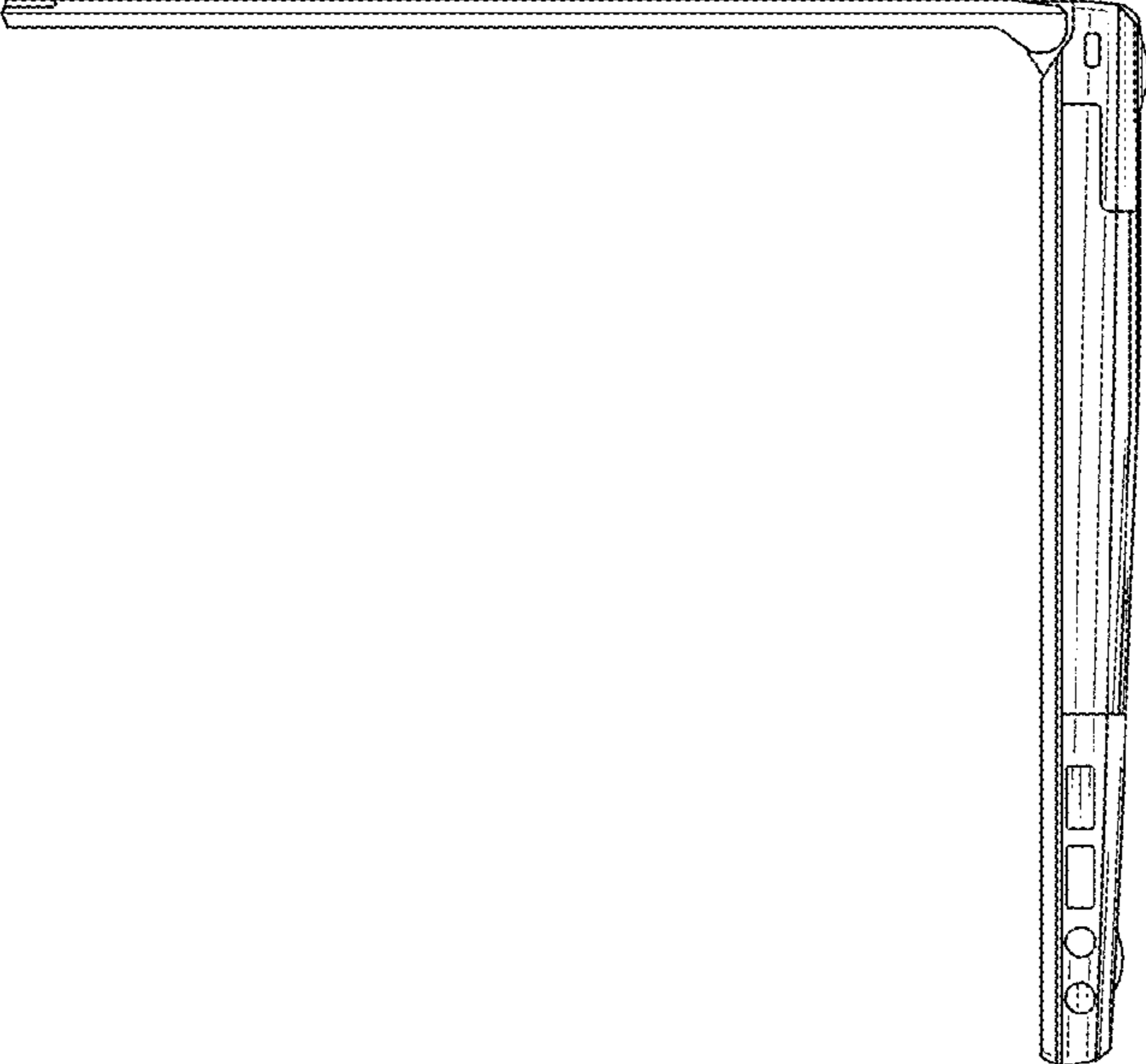

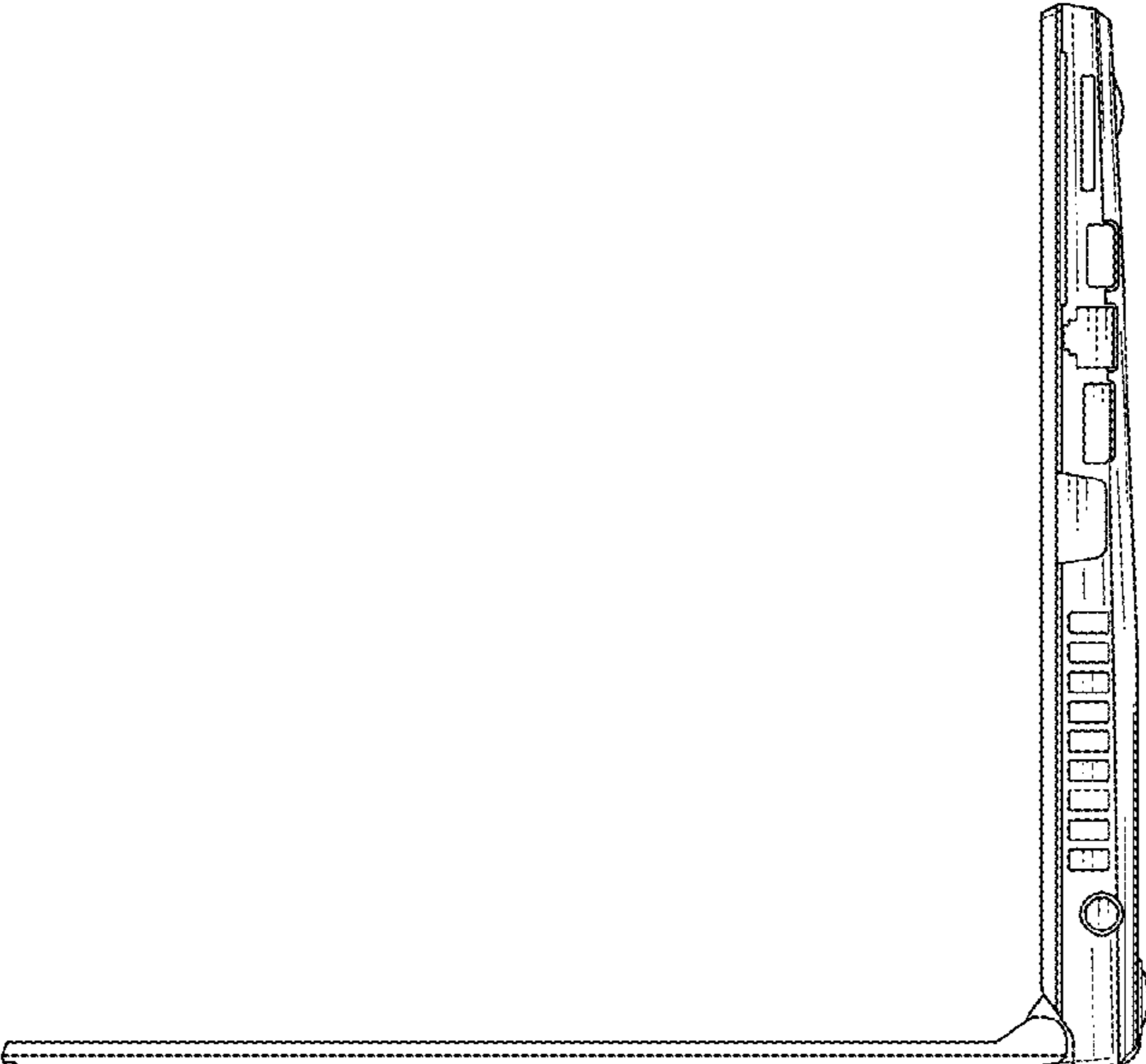

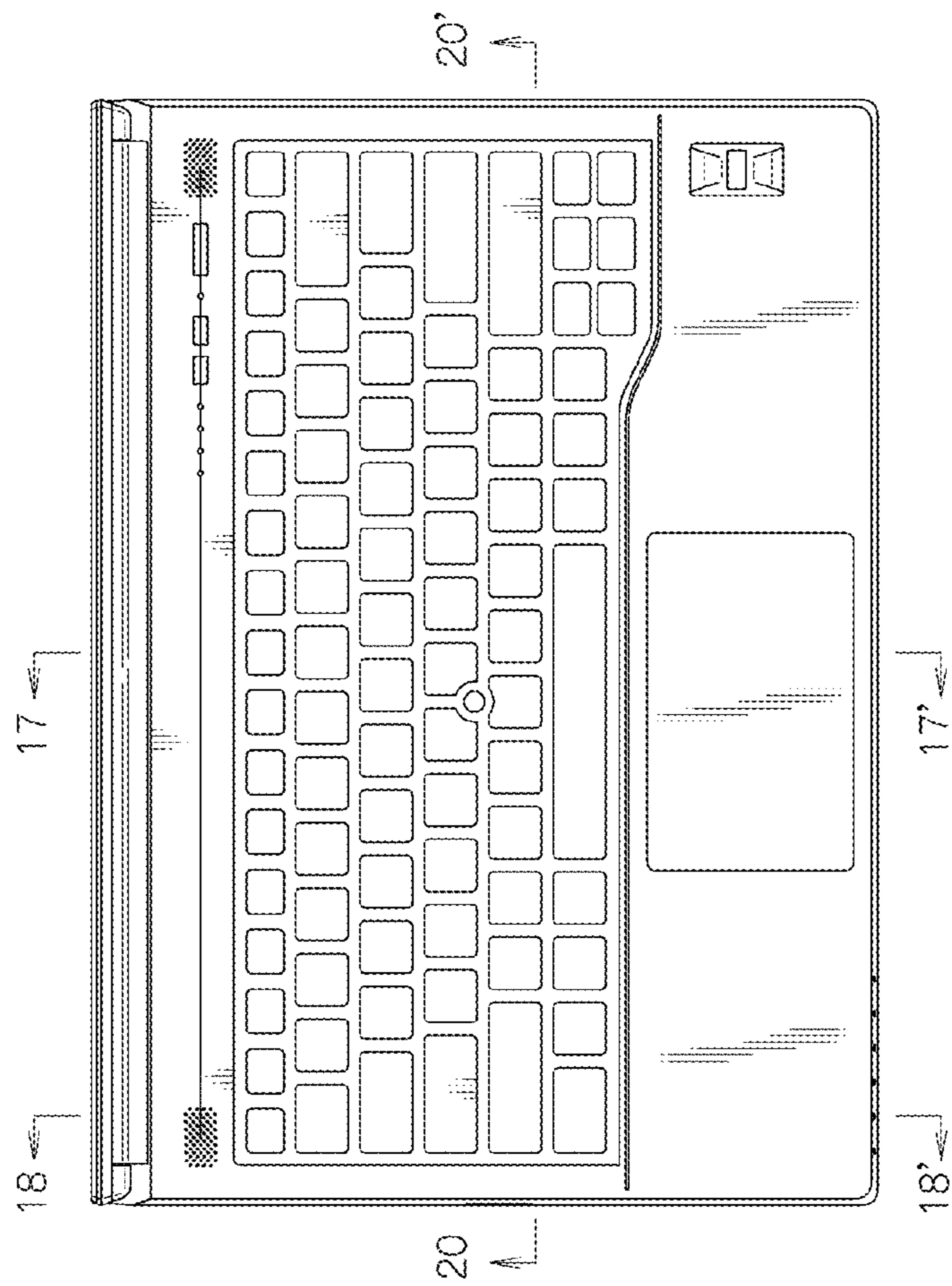

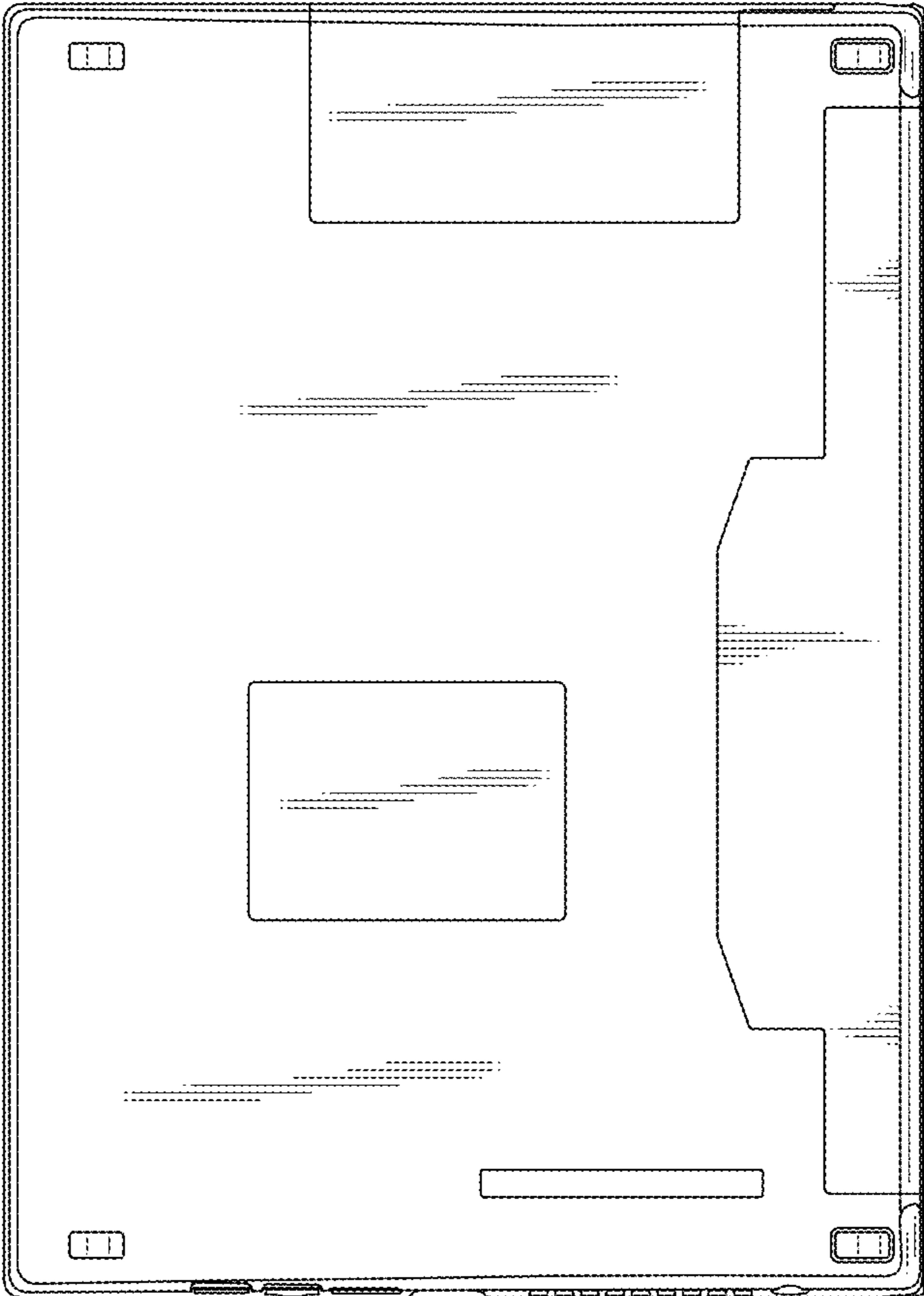

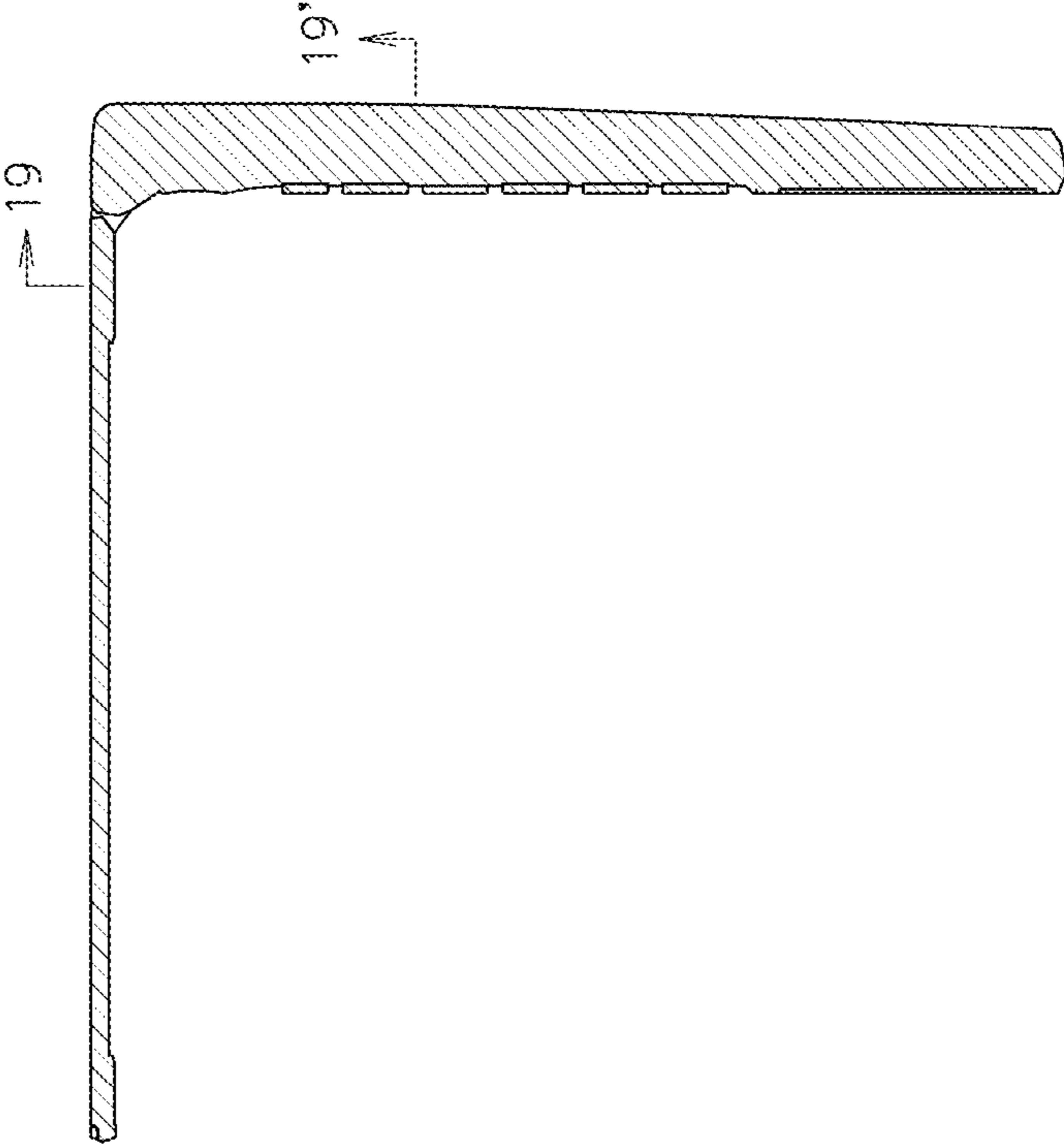

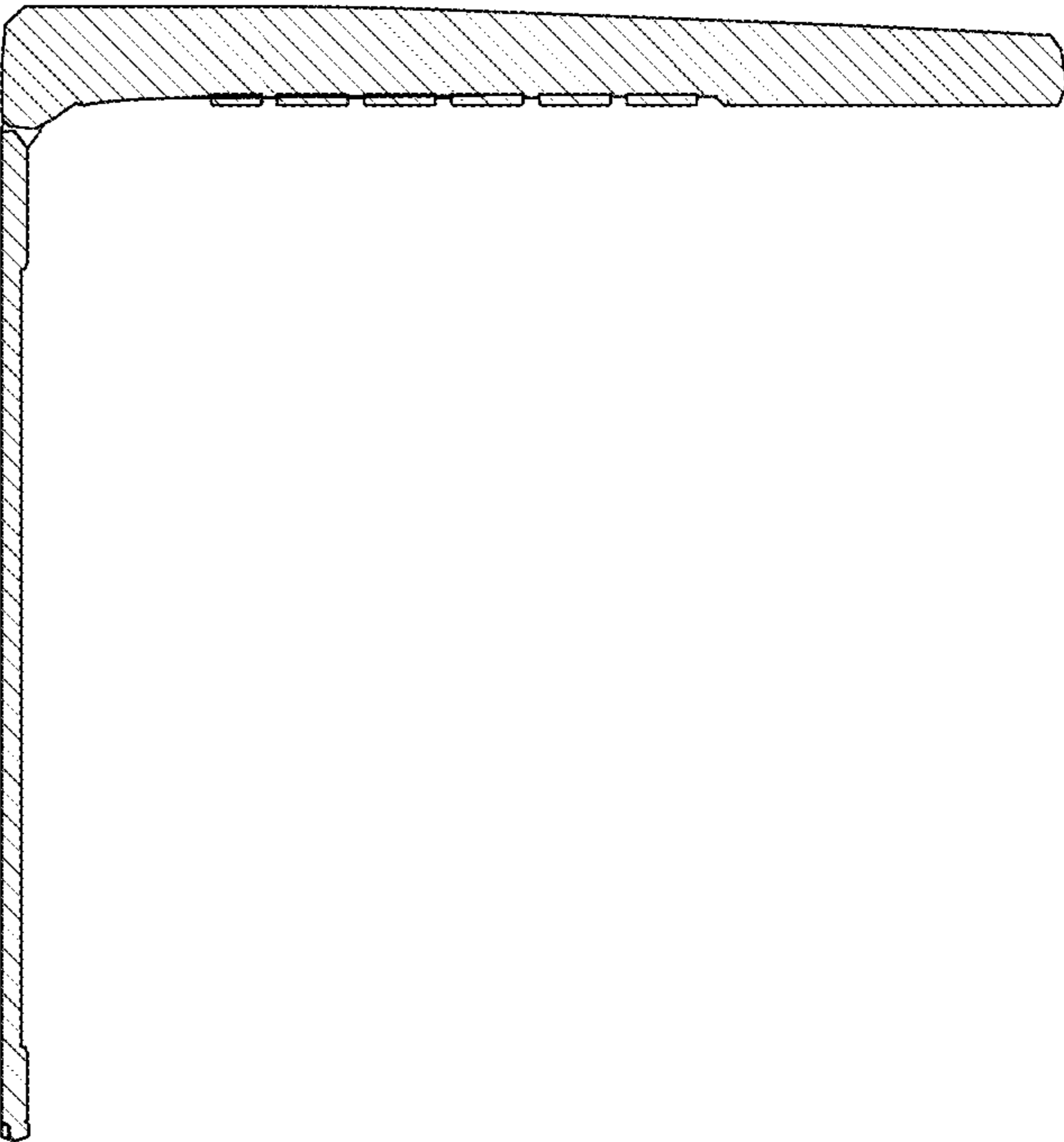

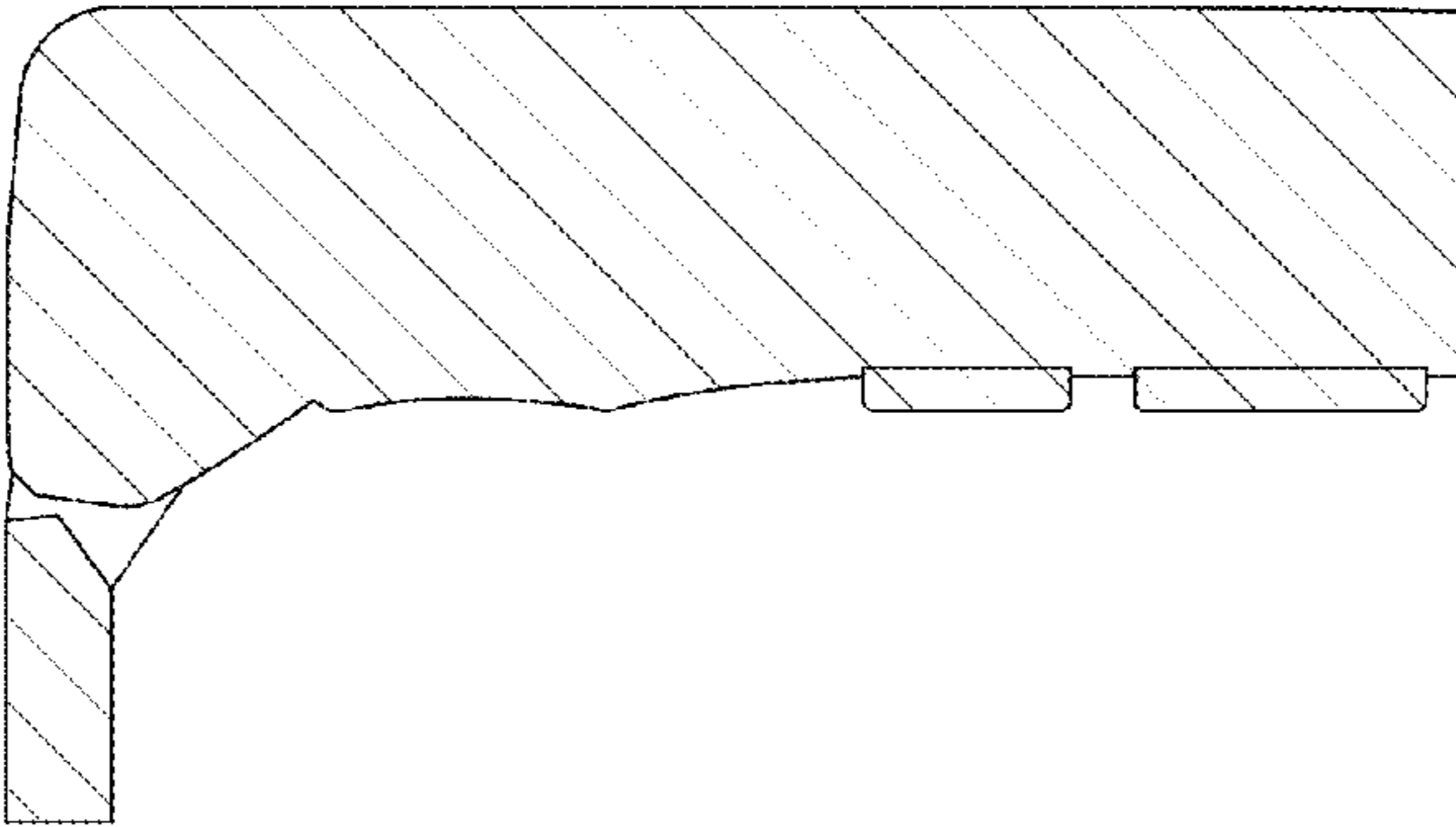
