The ornamental design for a tablet stand, as shown and described.

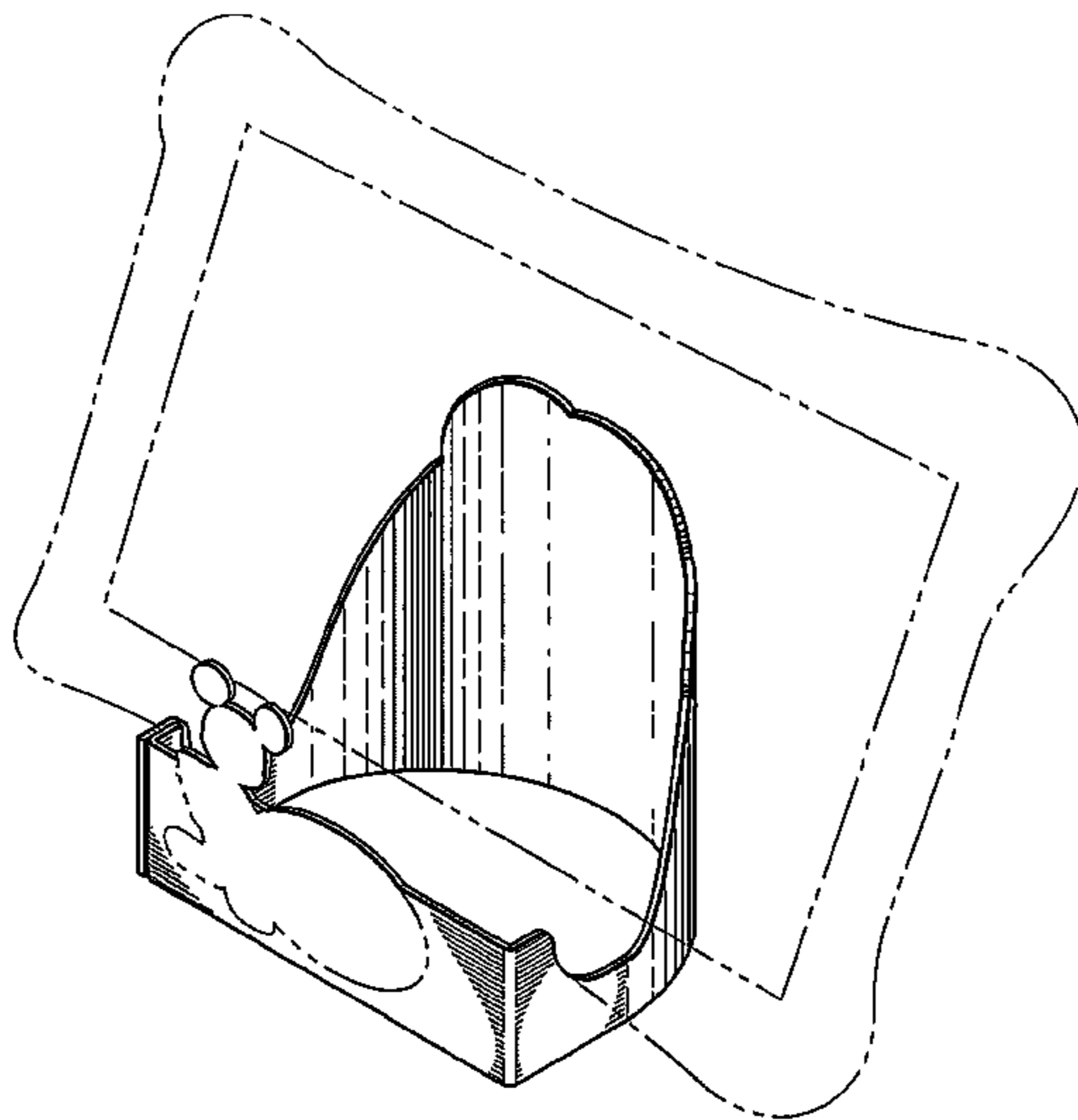
DESCRIPTION

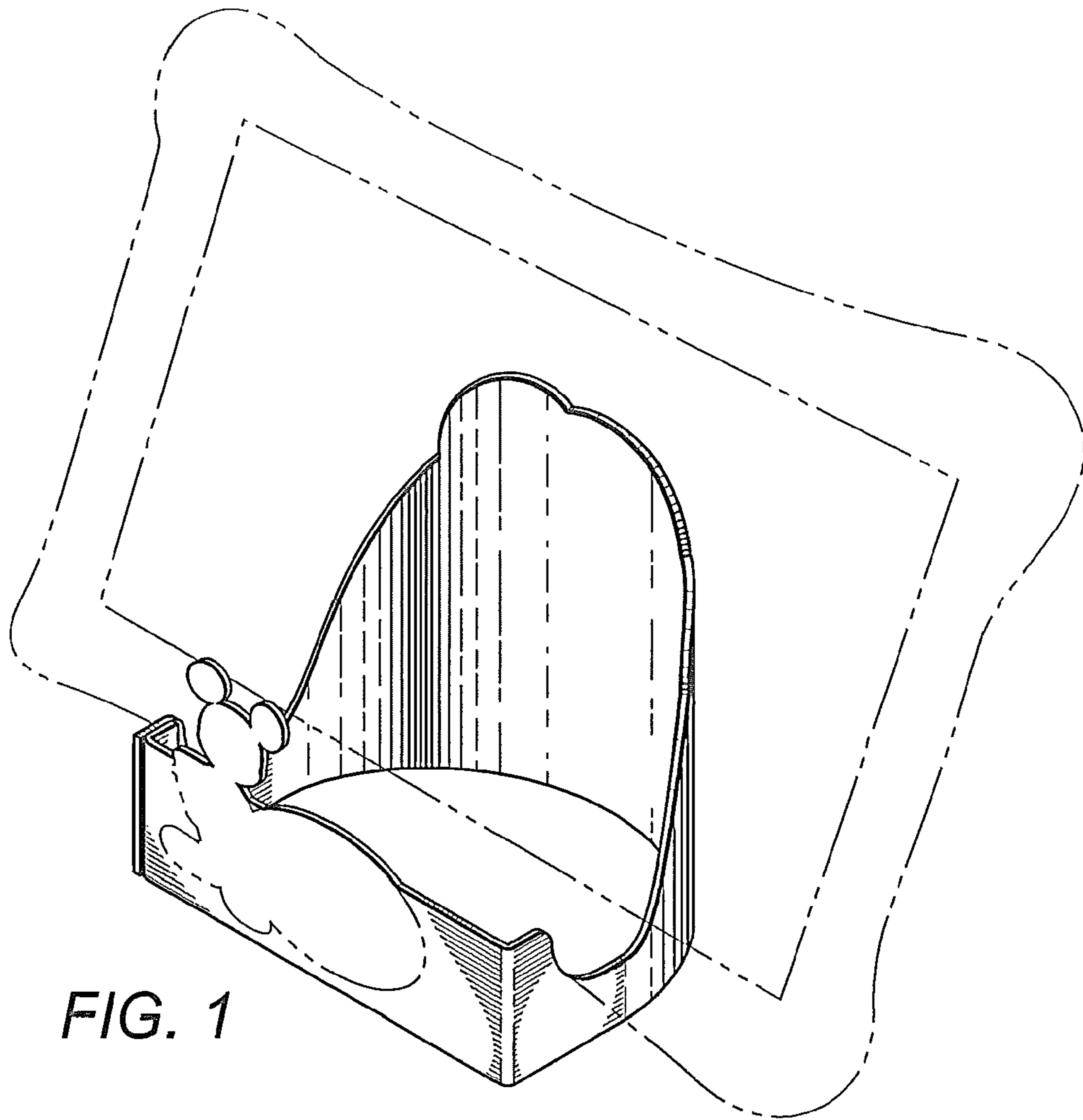

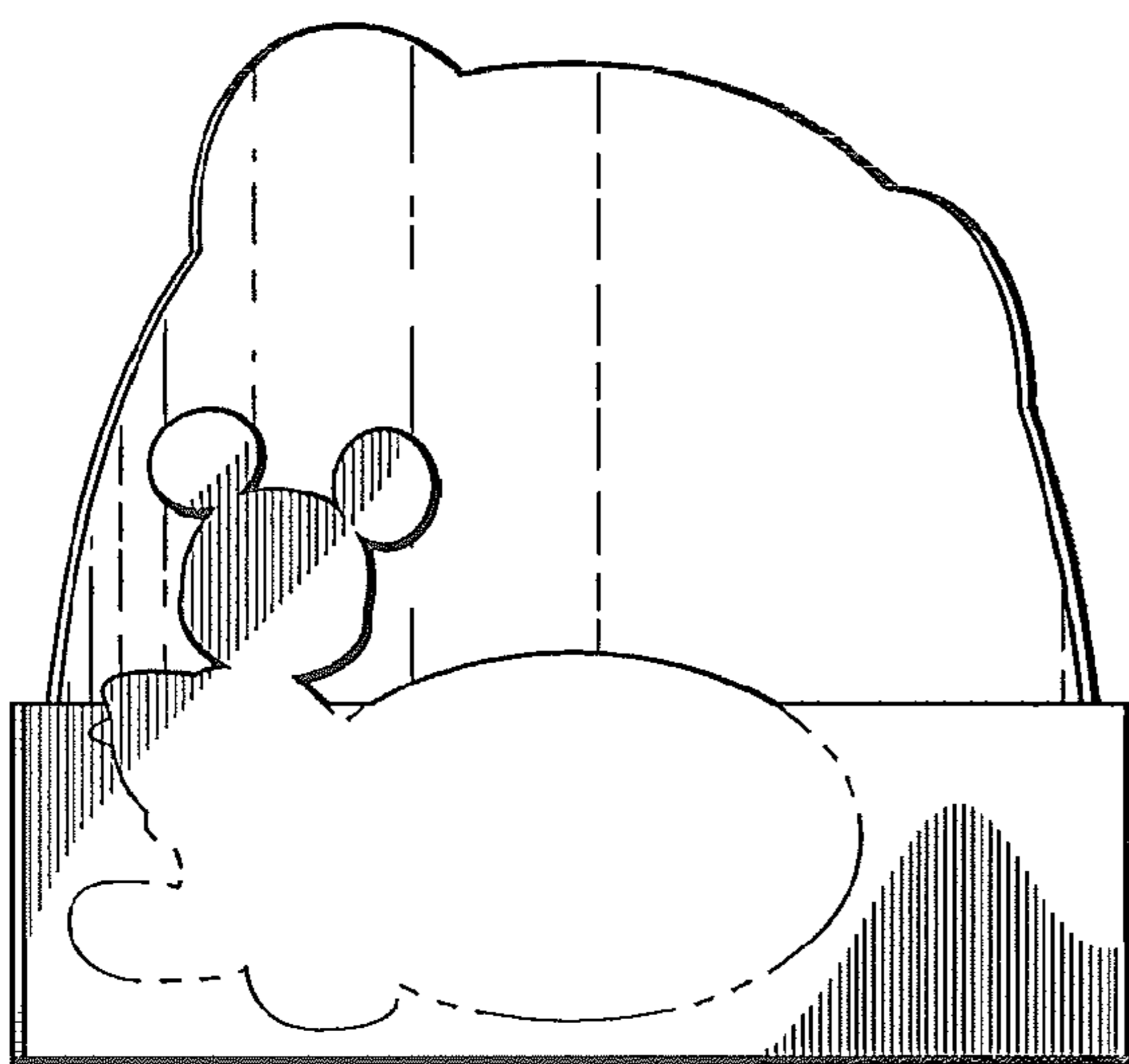

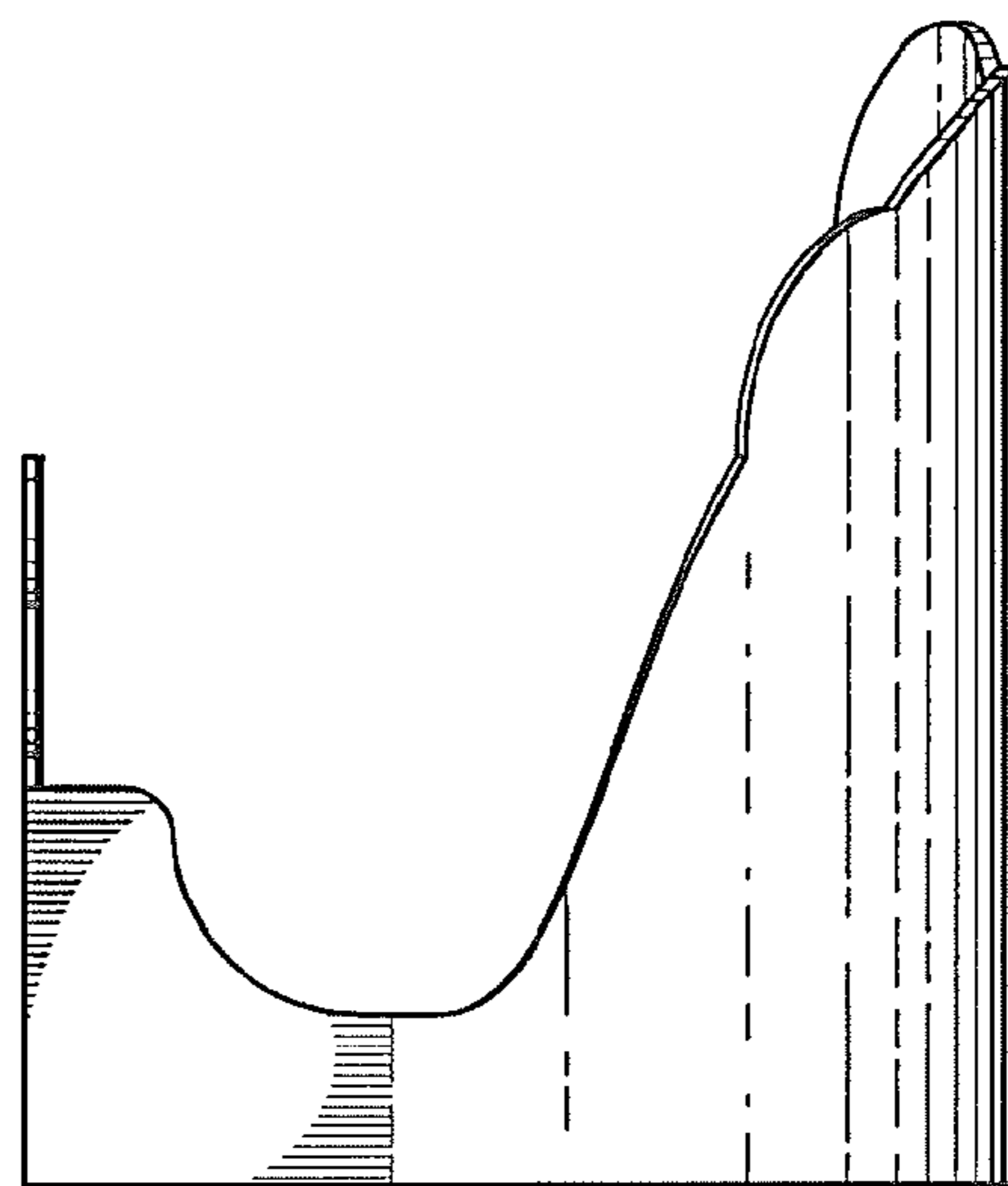

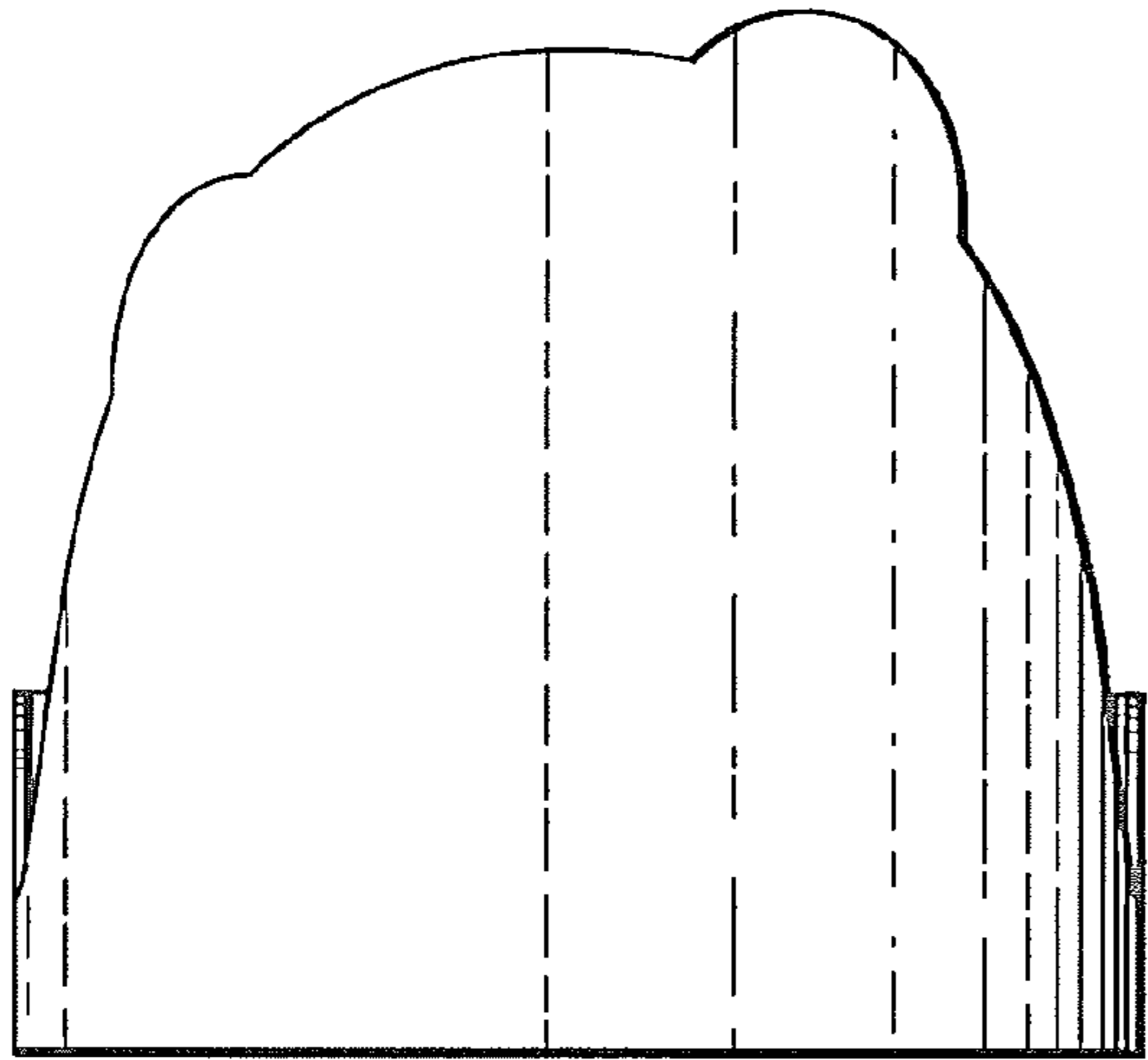

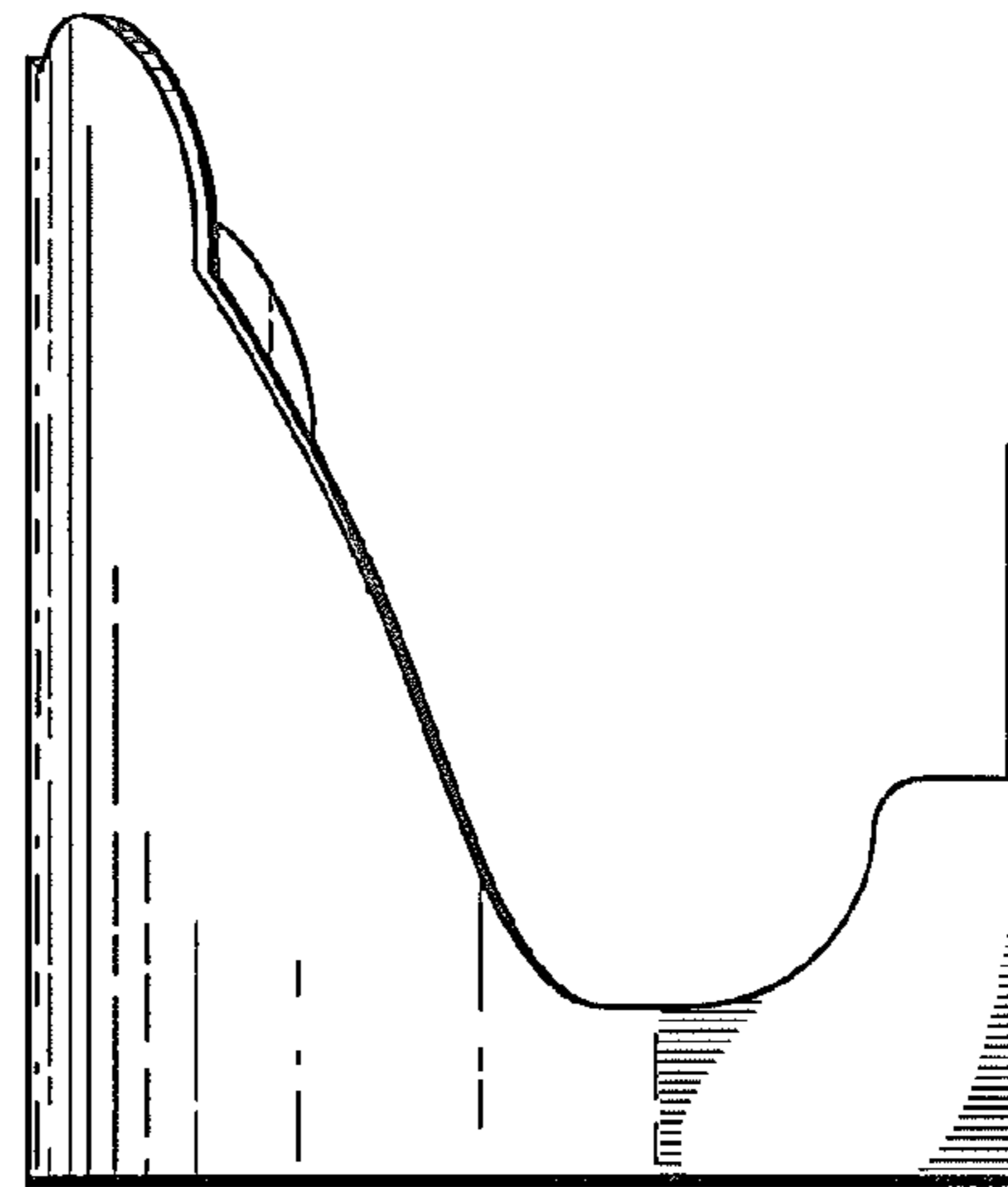

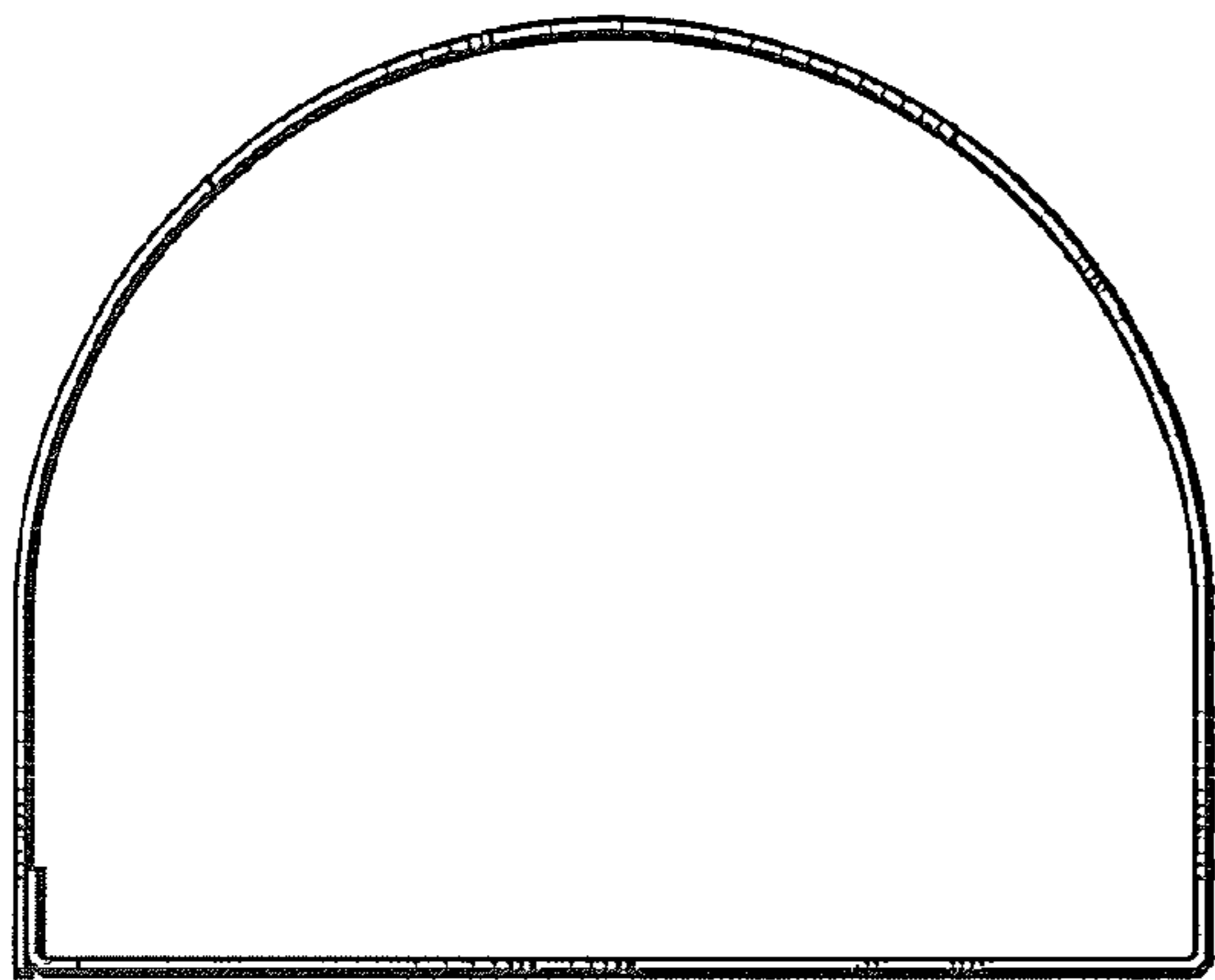

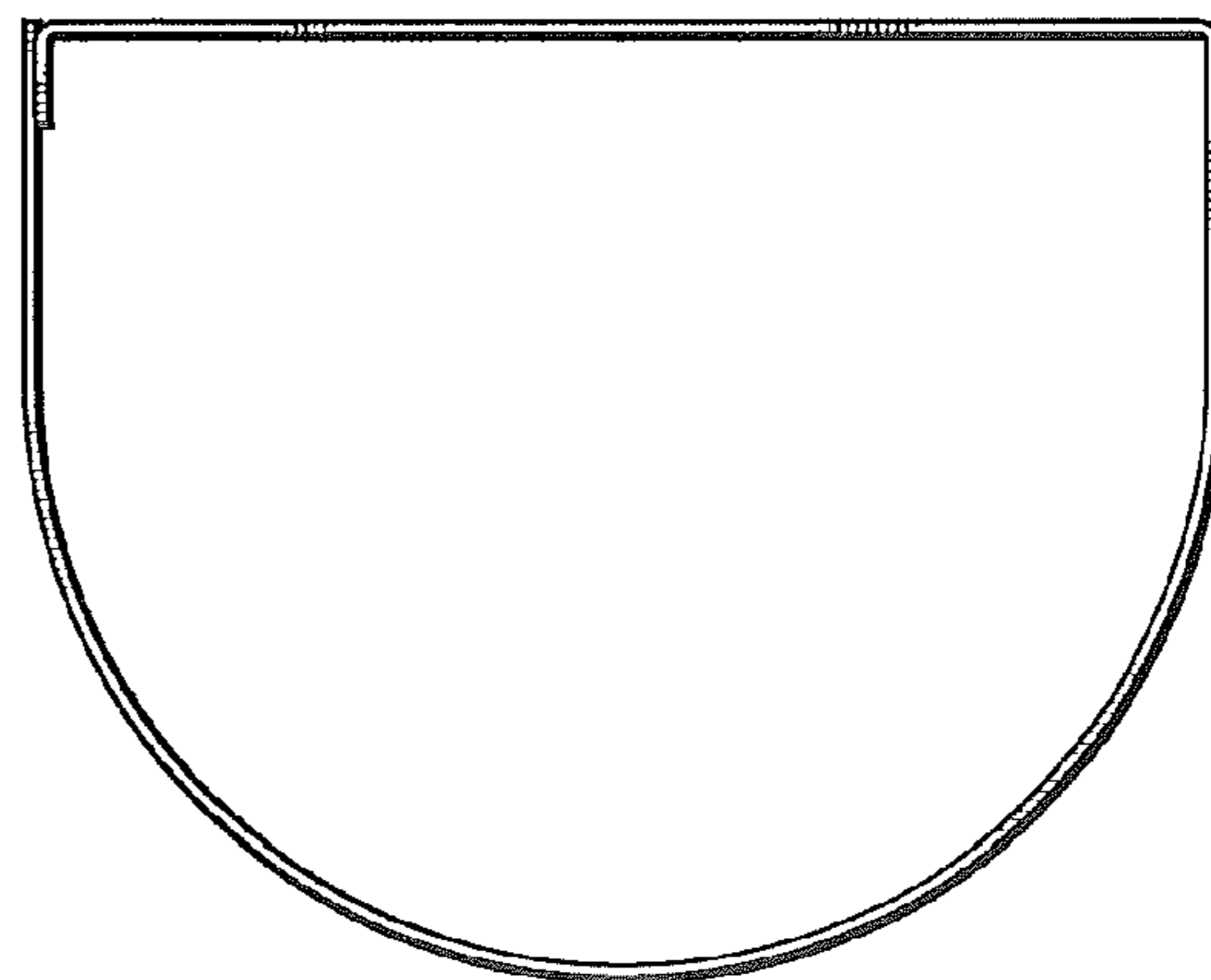

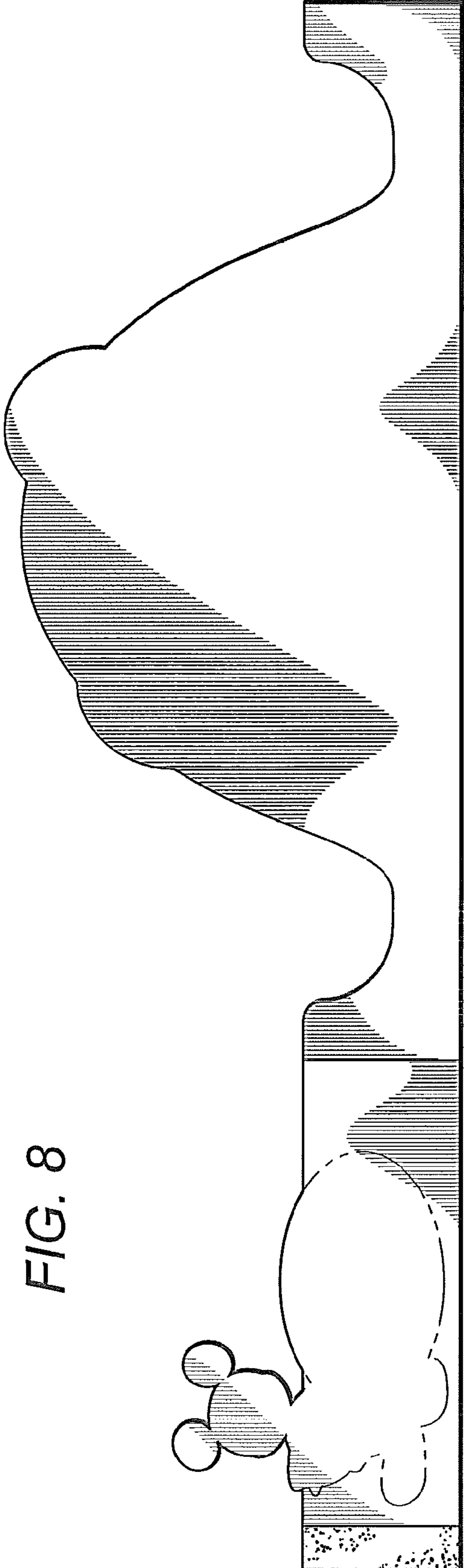
