(57) **CLAIM**

We claim the ornamental design for a washing machine displaying graphical user interface, as shown and described.

**DESCRIPTION**

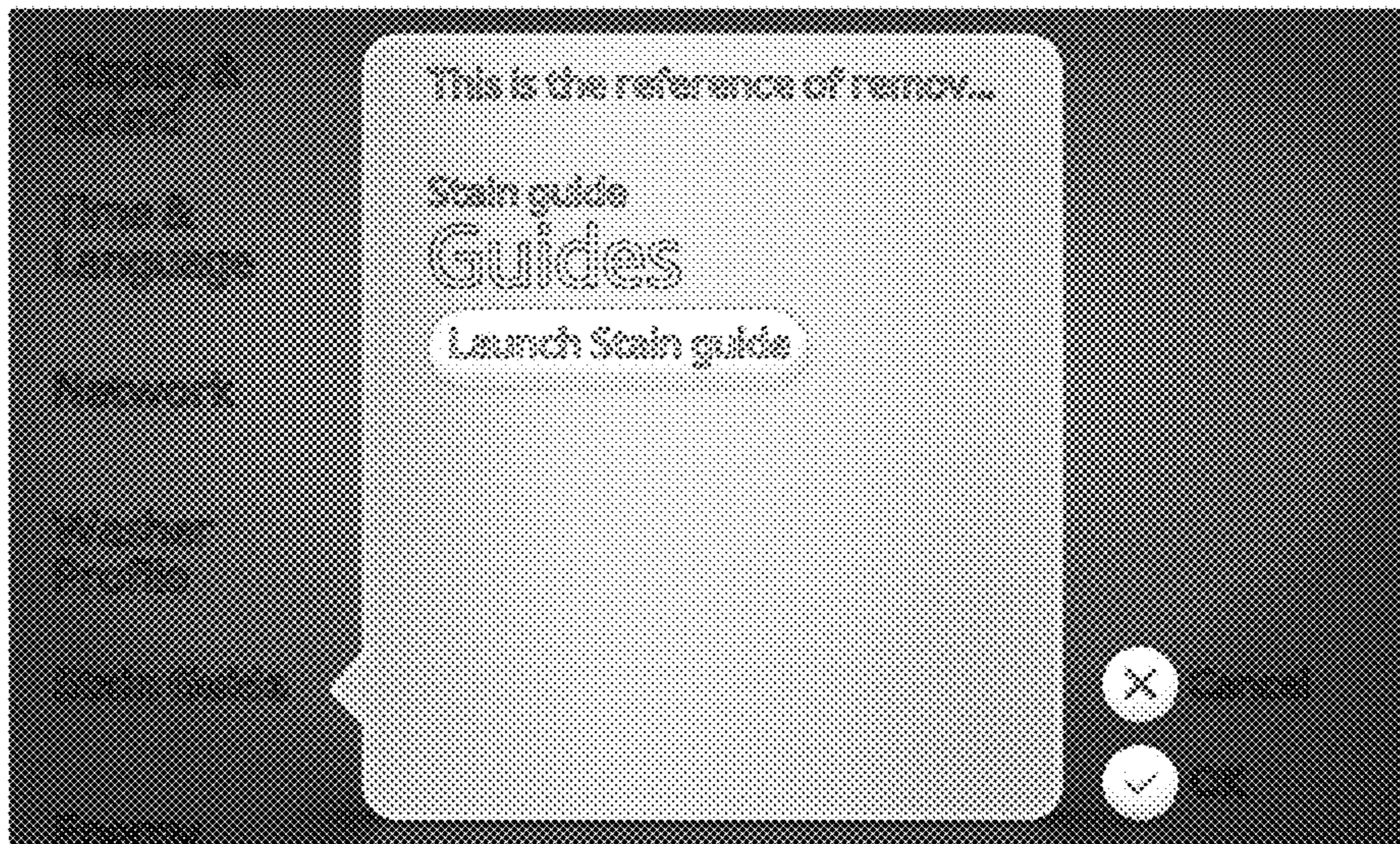

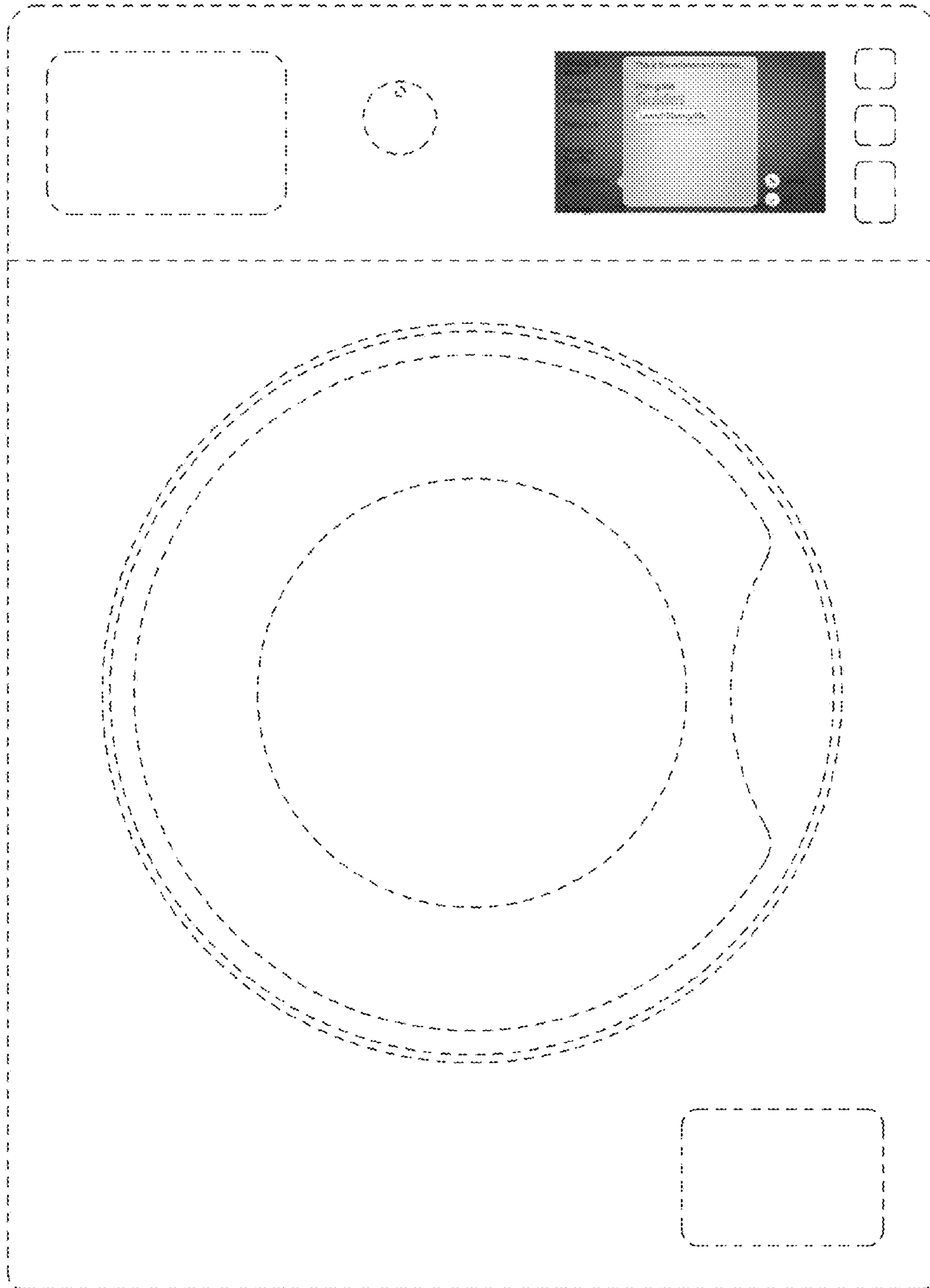
