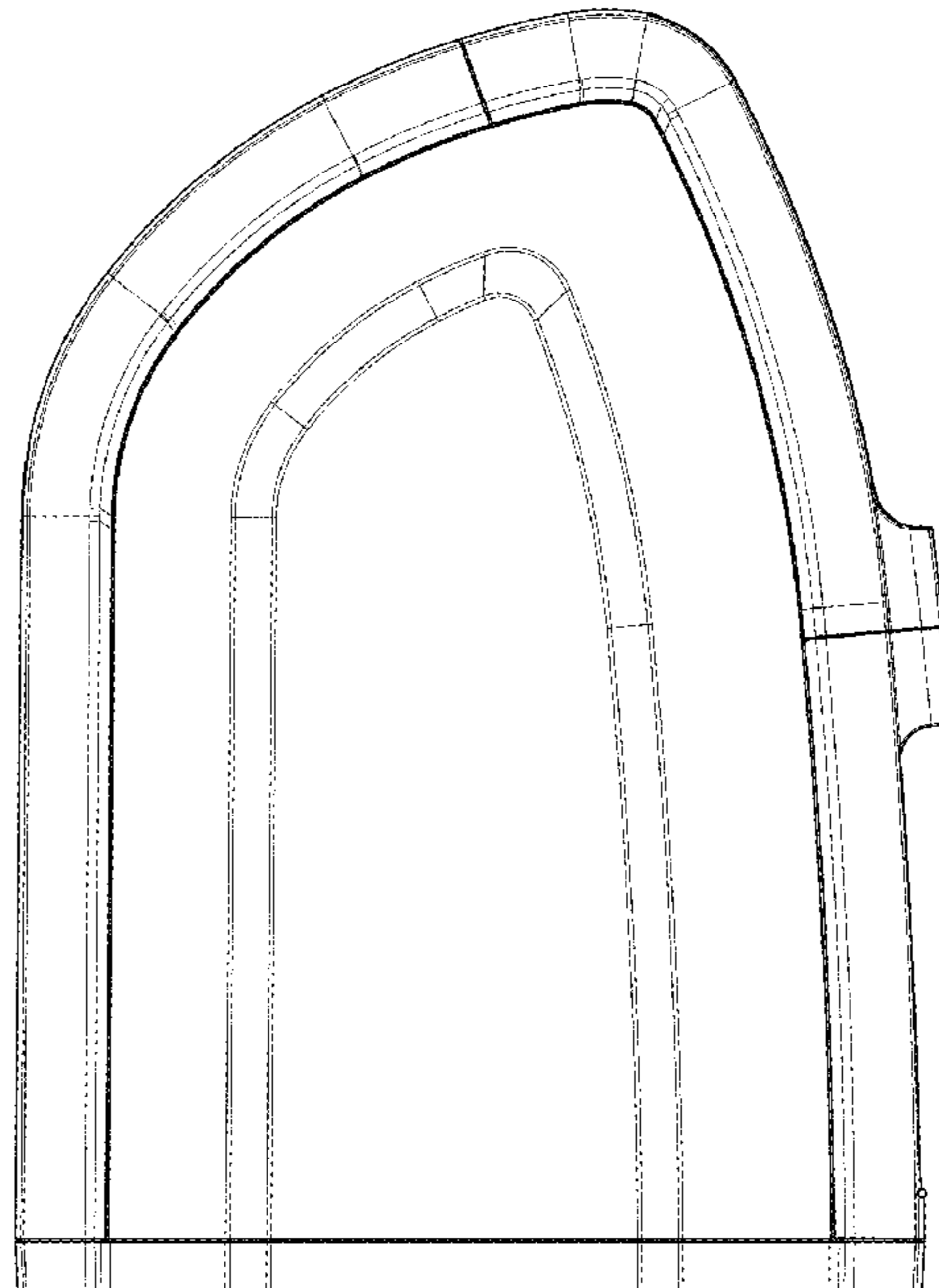
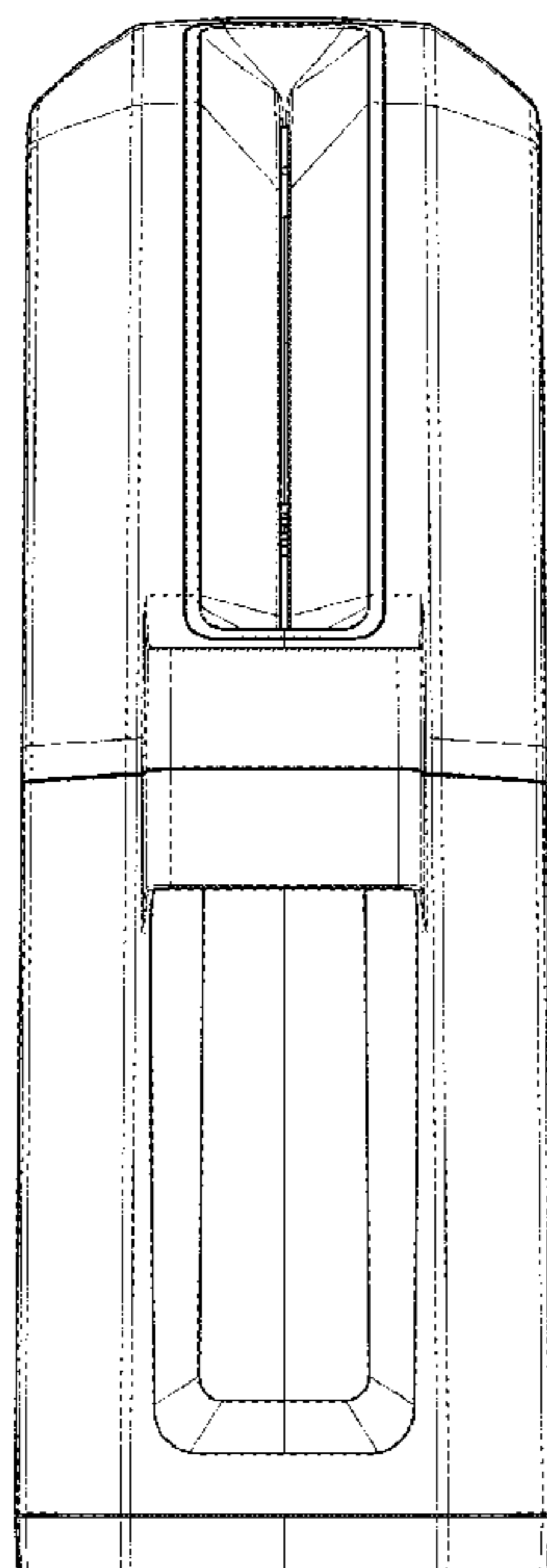
(57) **CLAIM**

The ornamental design for a media shredder, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a media shredder; FIG. 2 is a rear elevational view of the media shredder of FIG. 1; FIG. 3 is a right front perspective view of the media shredder of FIG. 1; FIG. 4 is a left front perspective view of the media shredder of FIG. 1; FIG. 5 is a left elevational view of the media shredder of FIG. 1, with the right side elevational view being a mirror image thereof; FIG. 6 is a top view of the media shredder of FIG. 1; and, FIG. 7 is a bottom view of the media shredder of FIG. 1.

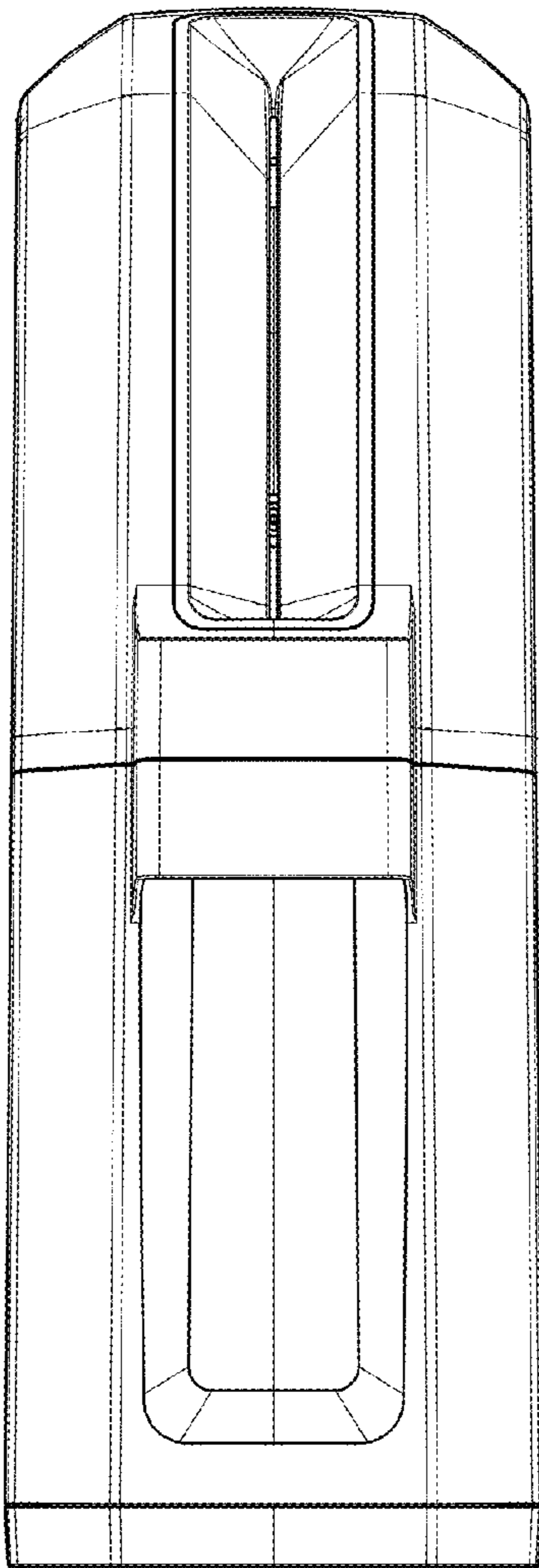

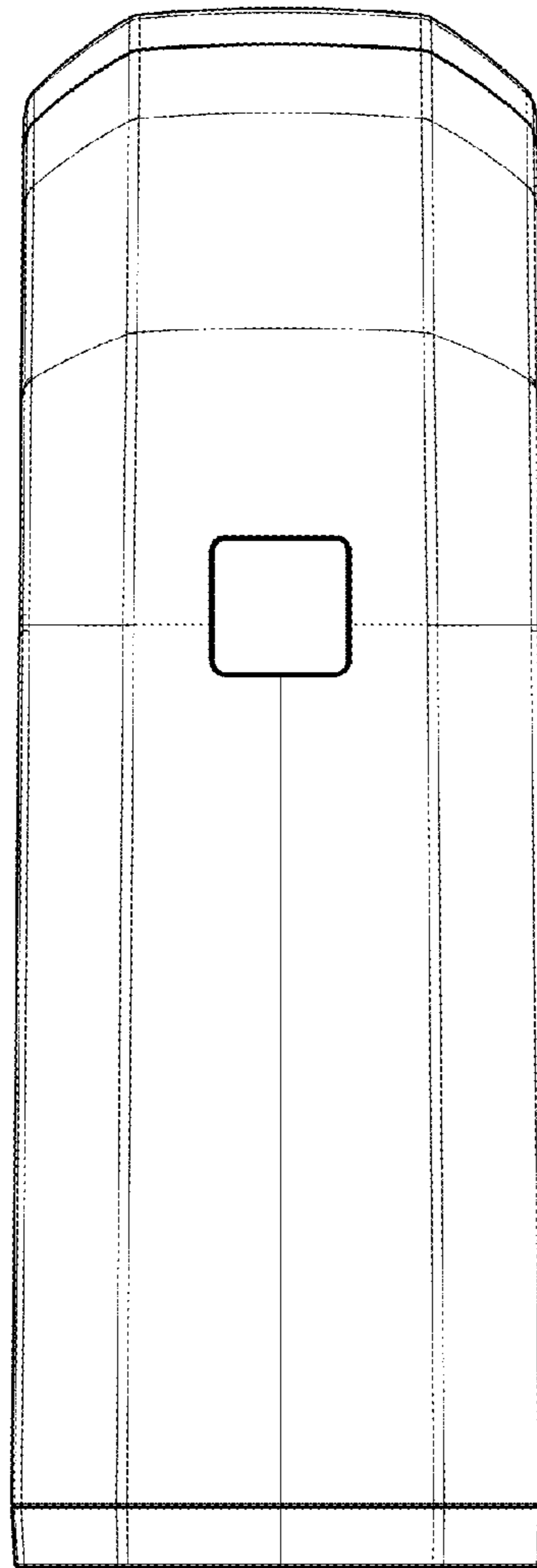

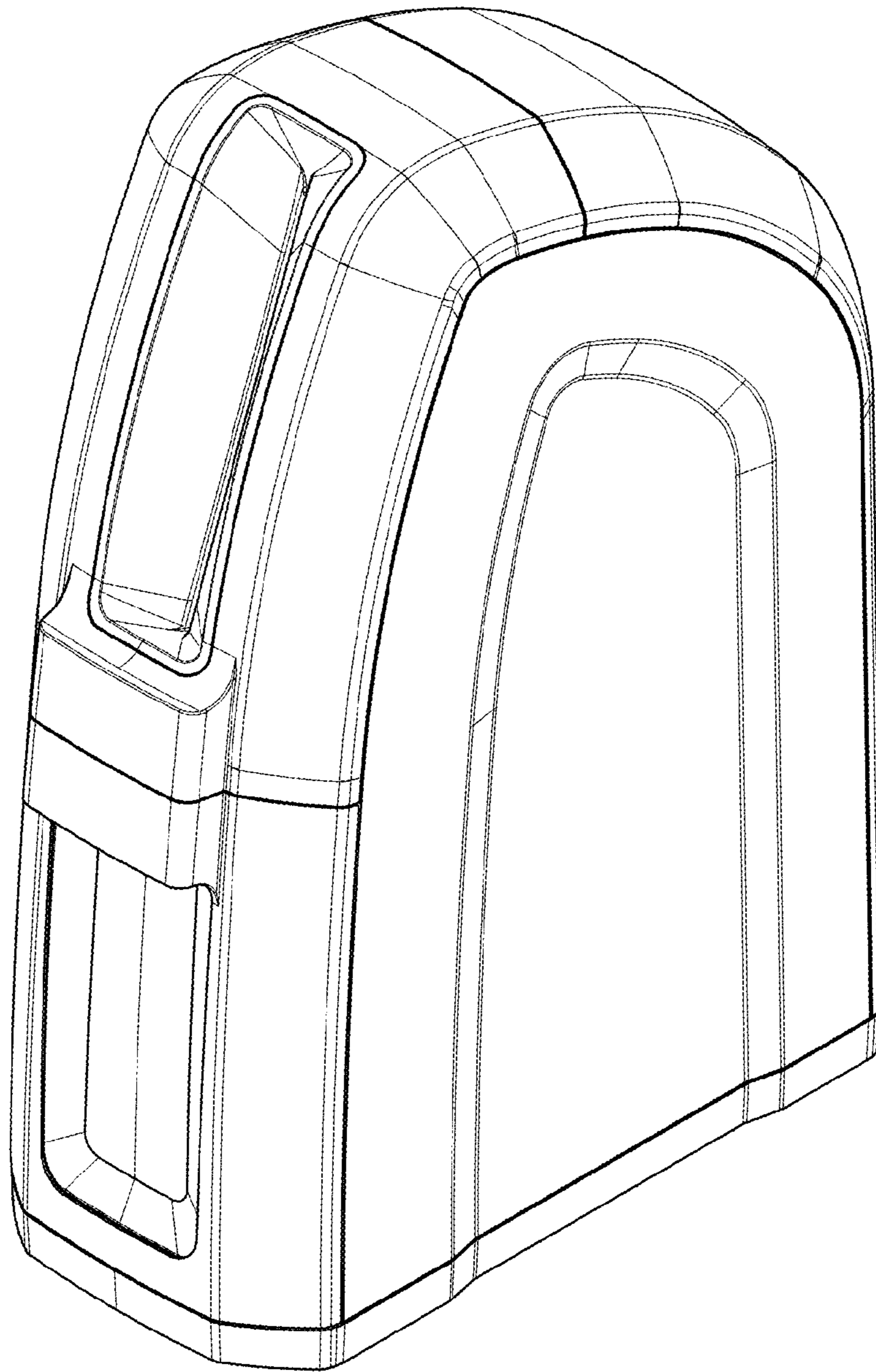

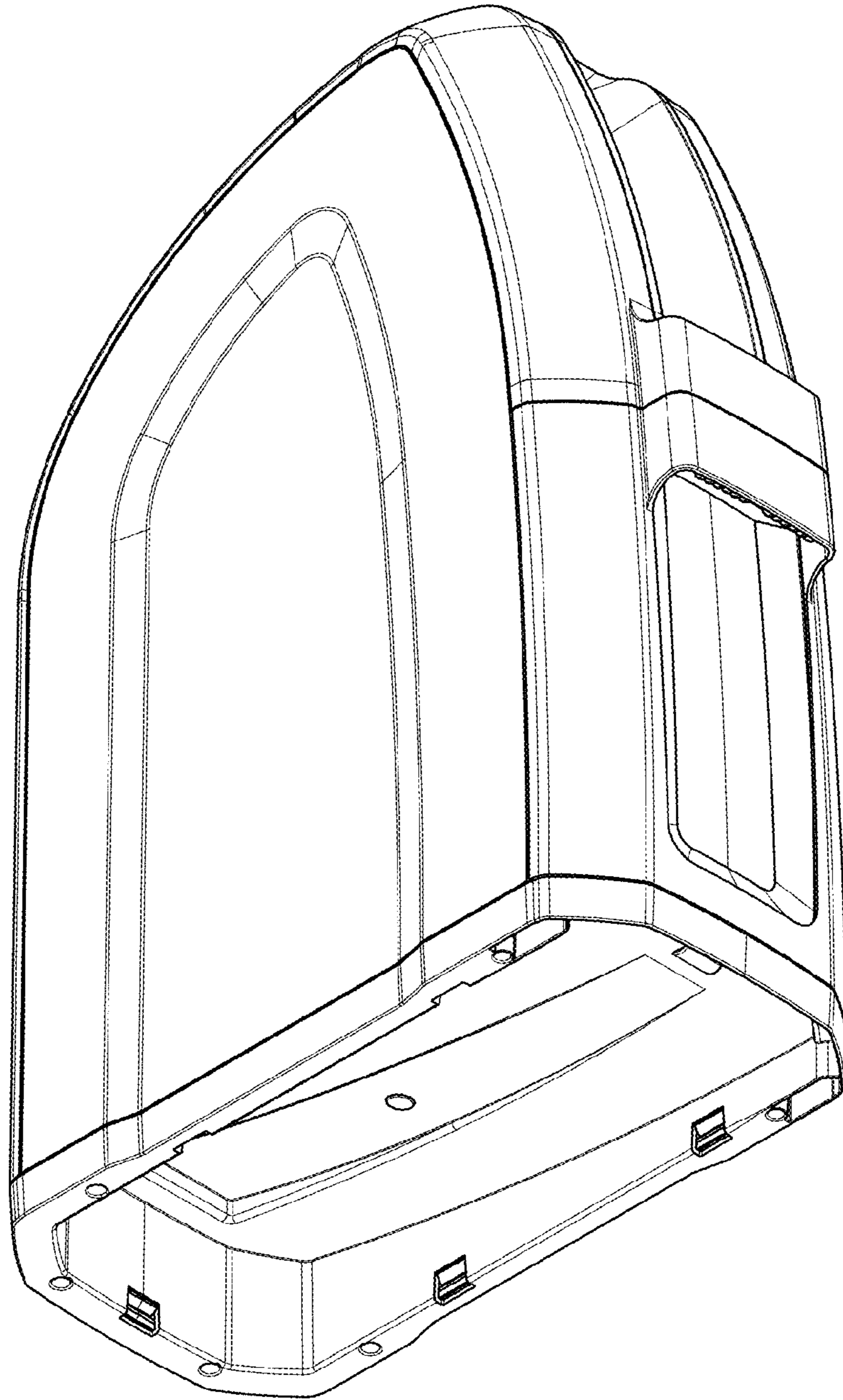

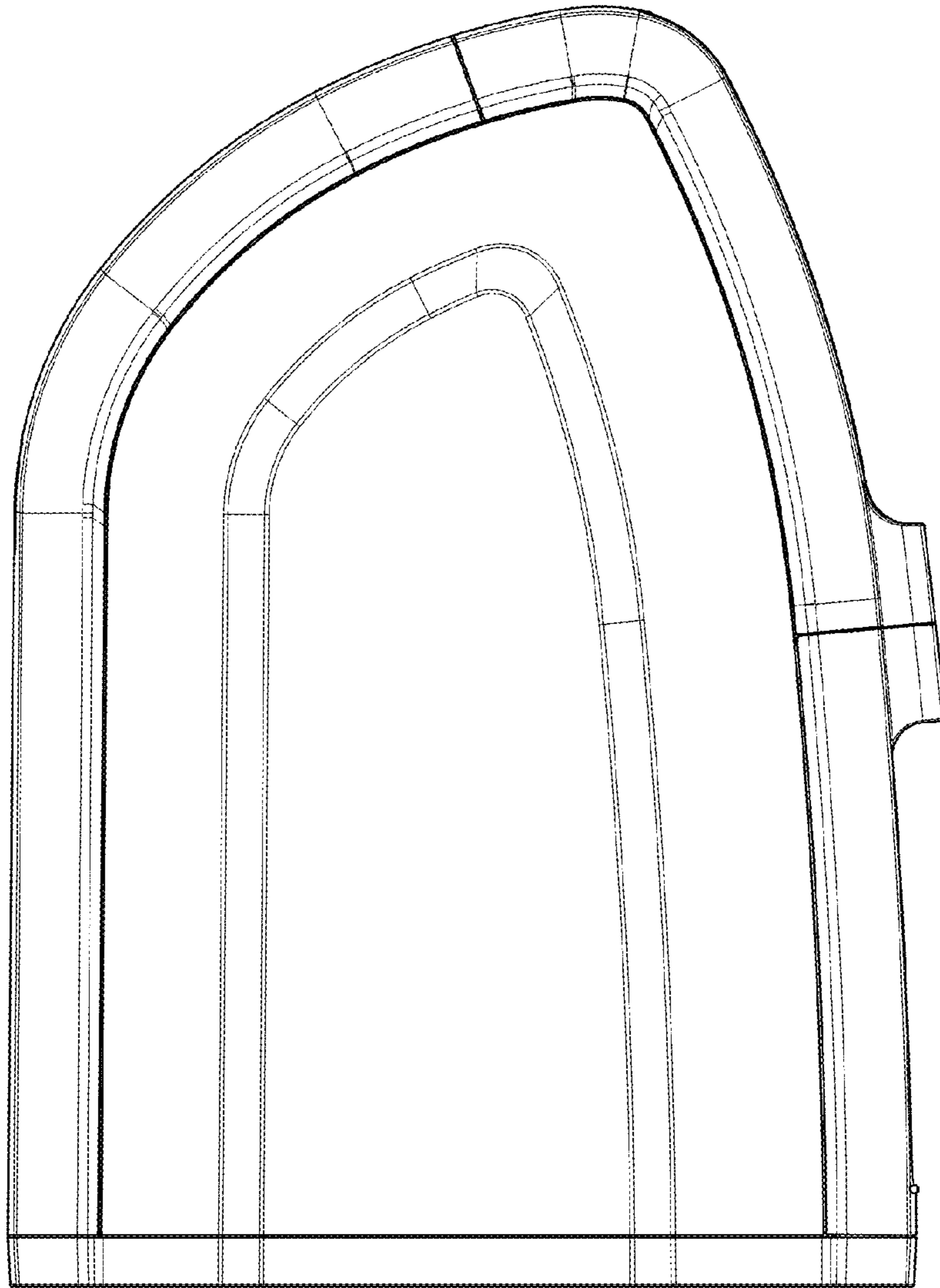

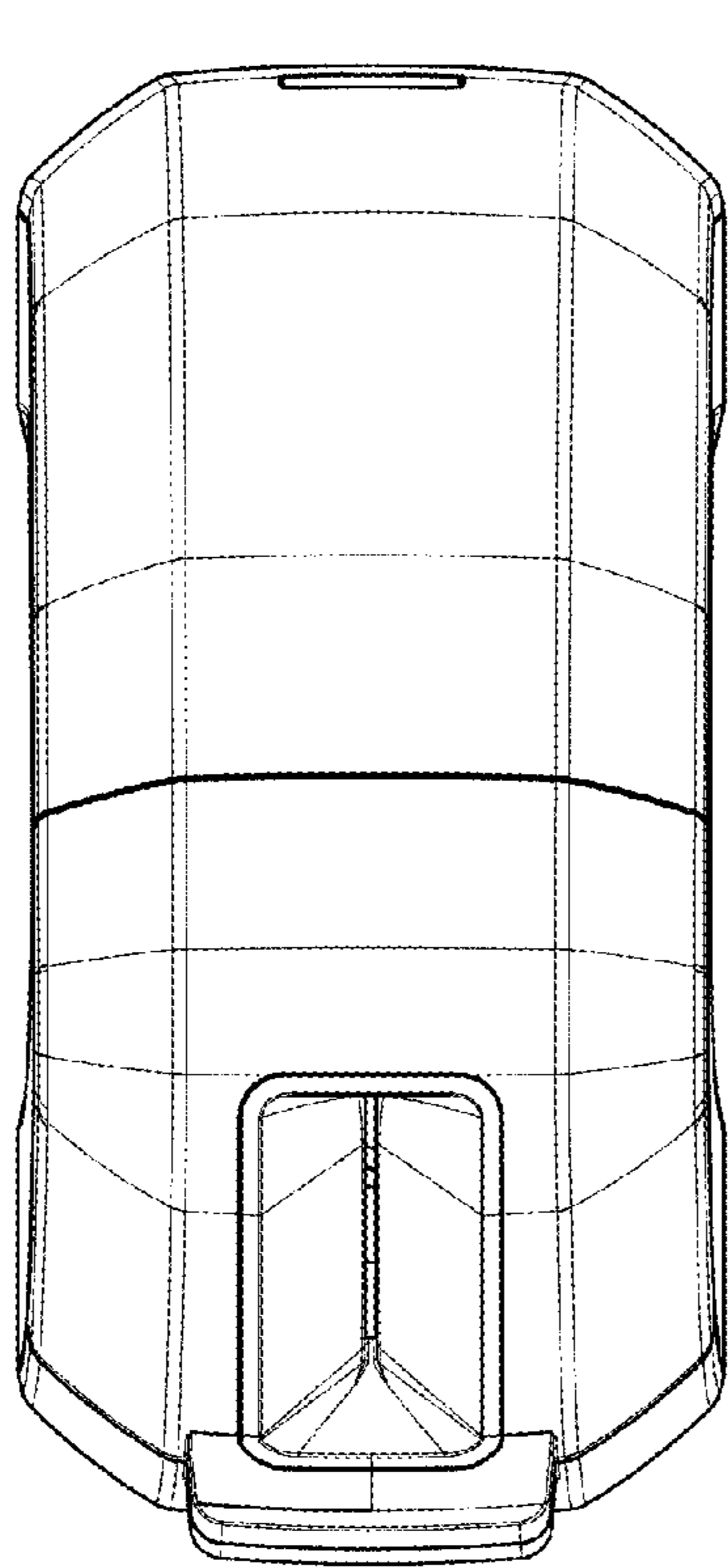

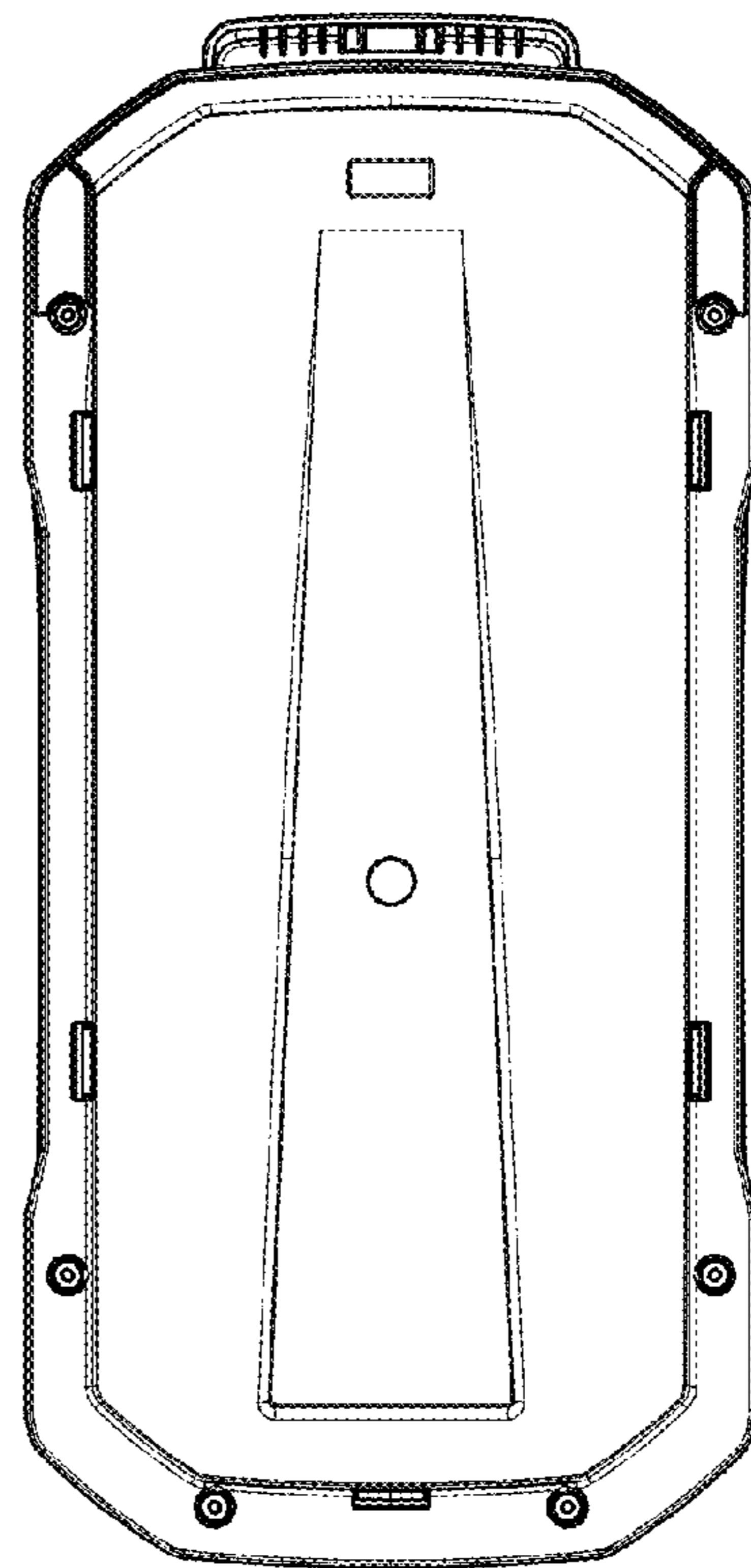
