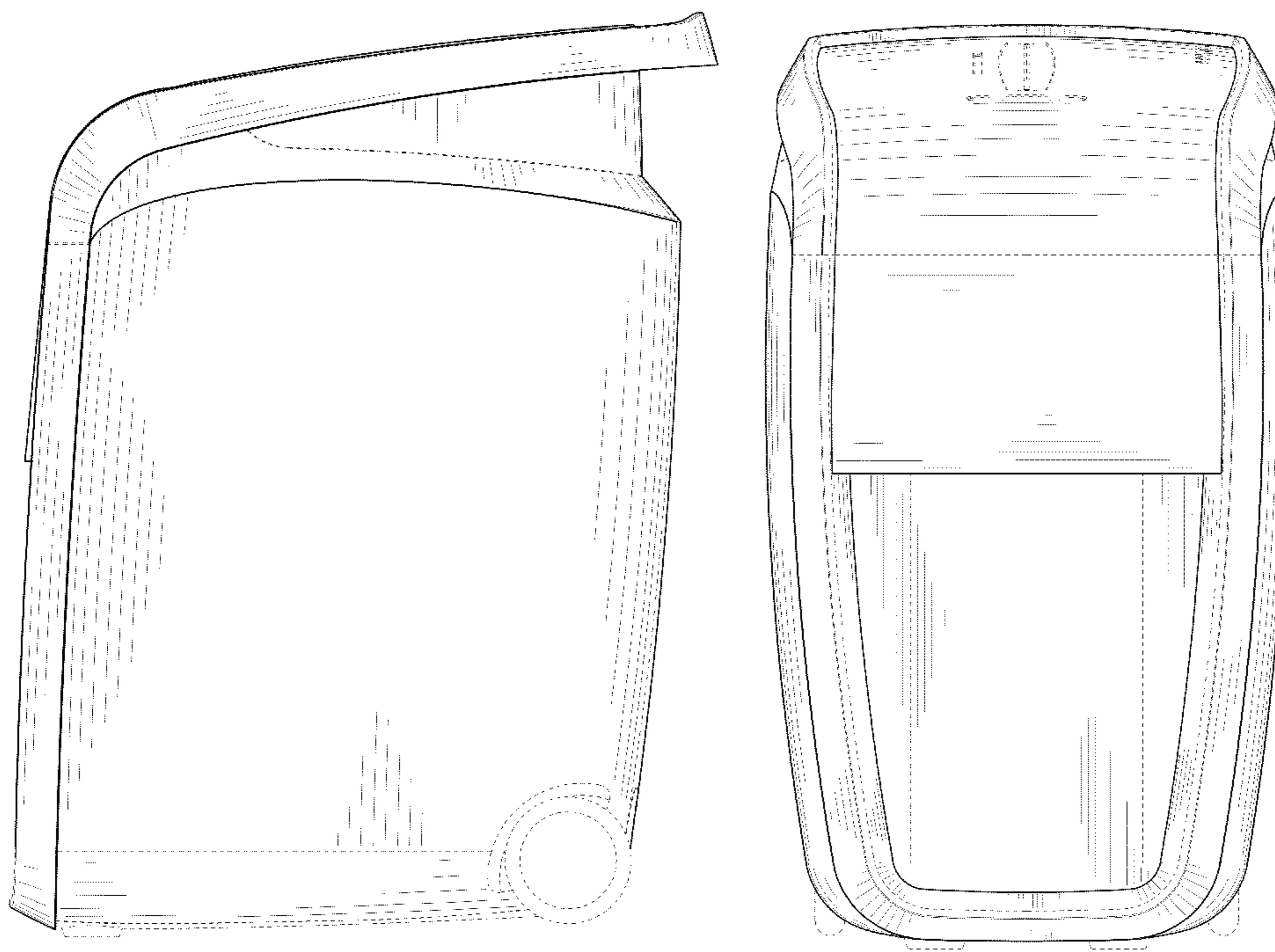
(57) **CLAIM**

The ornamental design for a shredder, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a shredder showing our new design, with portions of the shredder being shown in phantom as environmental structure;
FIG. 2 is a second perspective view of the shredder shown in FIG. 1;
FIG. 3 is a right side view of the shredder shown in FIG. 1;
FIG. 4 is a left side view of the shredder shown in FIG. 1;
FIG. 5 is a front view of the shredder shown in FIG. 1;
FIG. 6 is a rear side view of the shredder shown in FIG. 1;
FIG. 7 is a top view of the shredder shown in FIG. 1; and, FIG. 8 is a bottom view of the shredder shown in FIG. 1.
The broken lines shown in the views are included for the purpose of illustrating portions of the shredder that form no part of the claimed design.

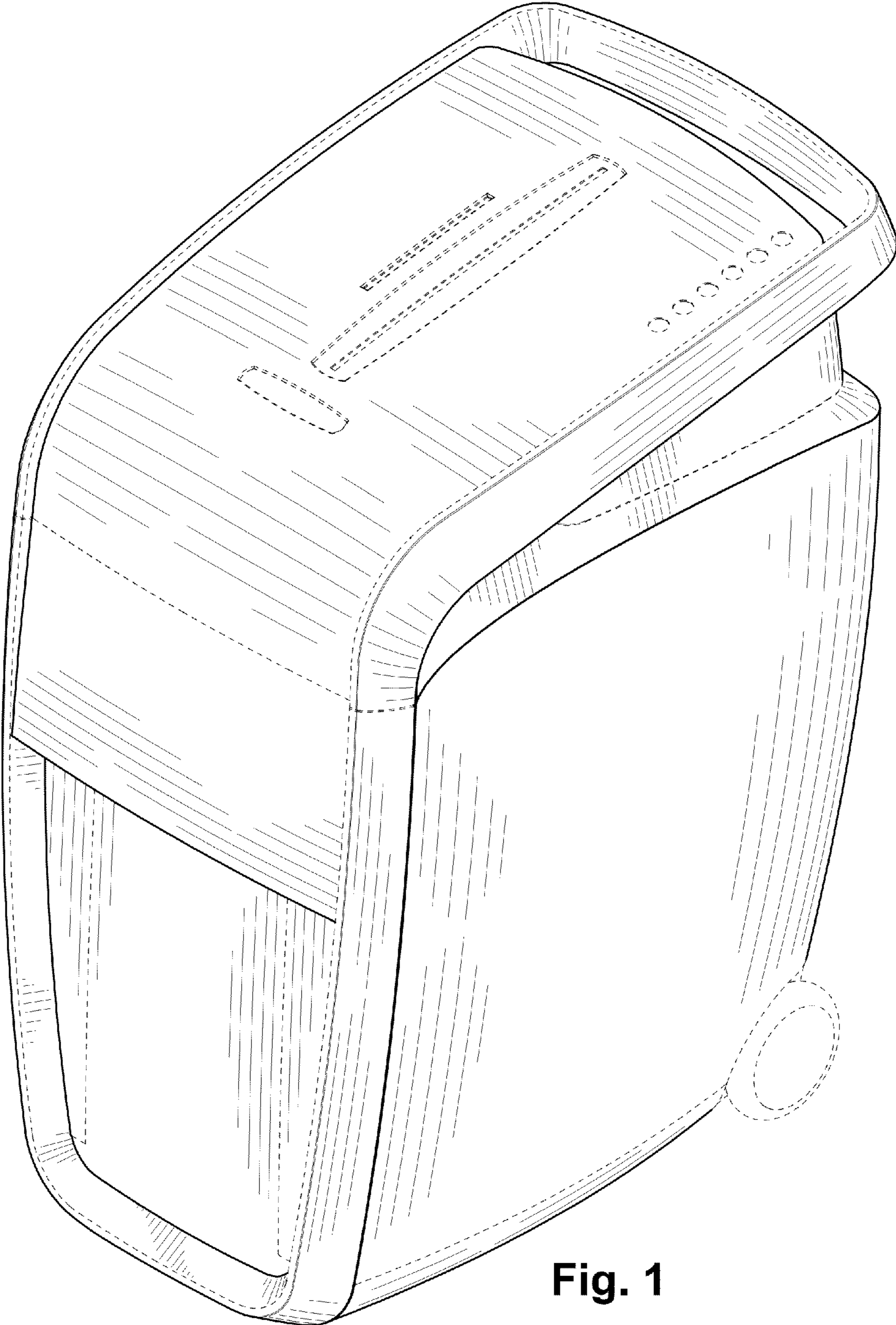

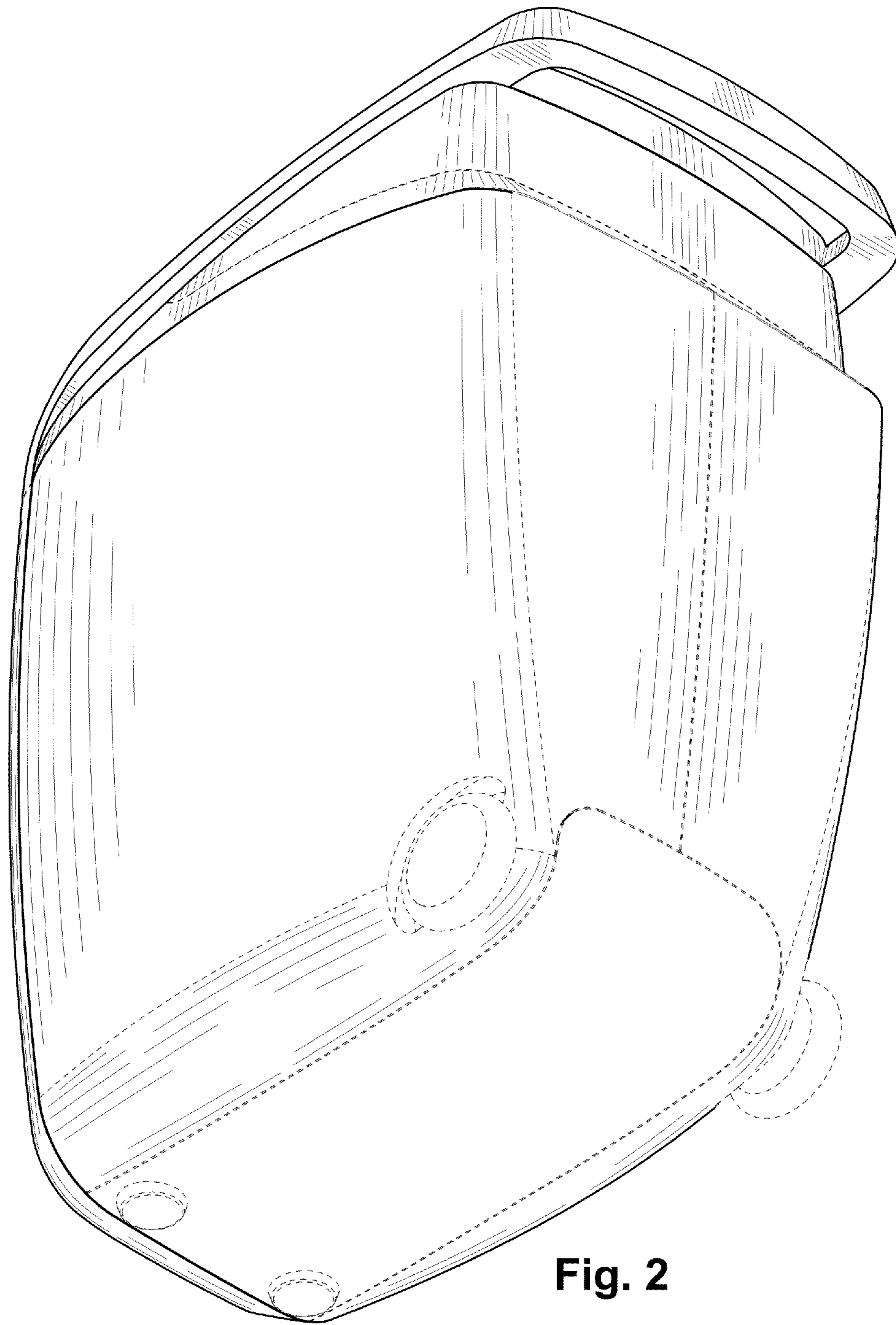

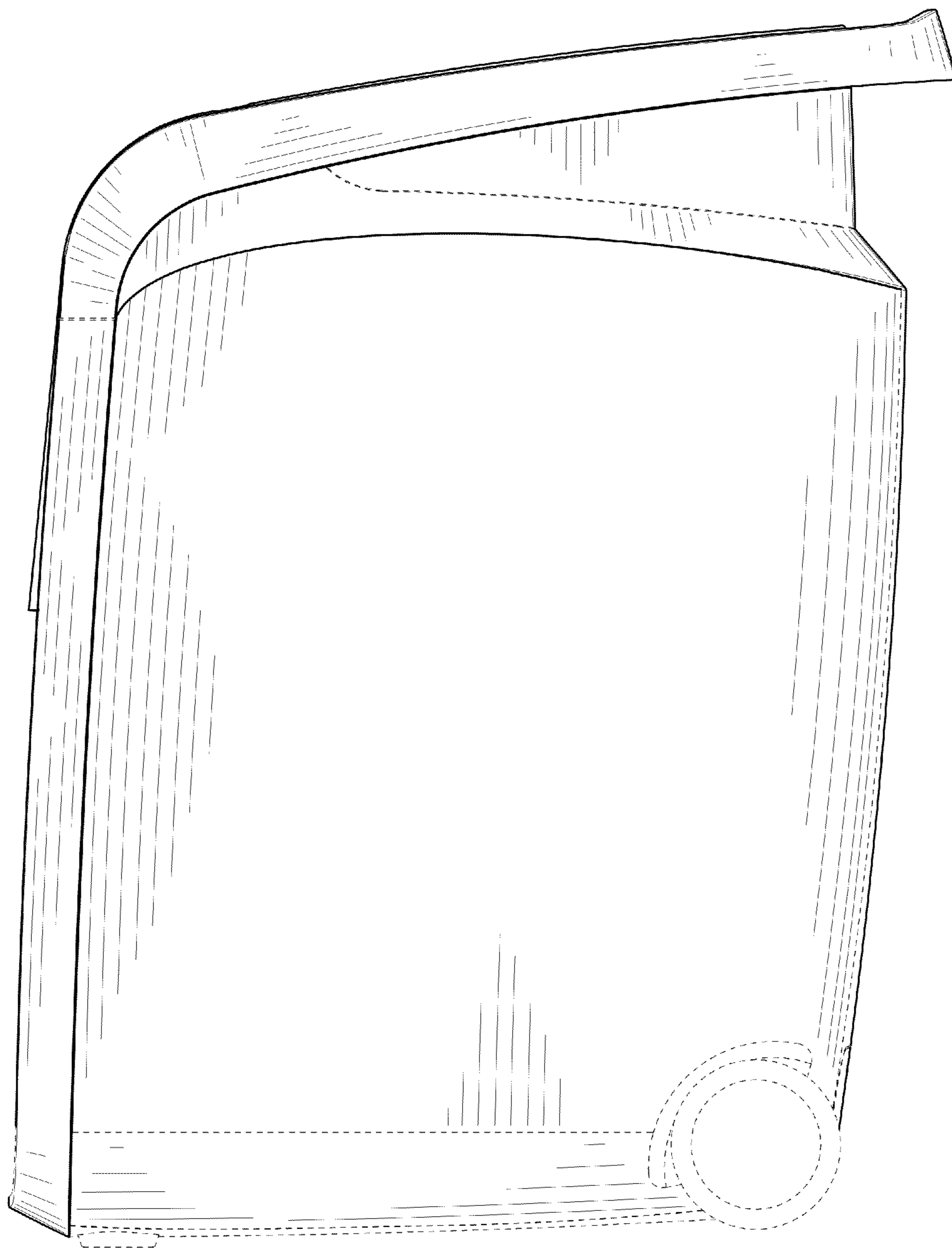

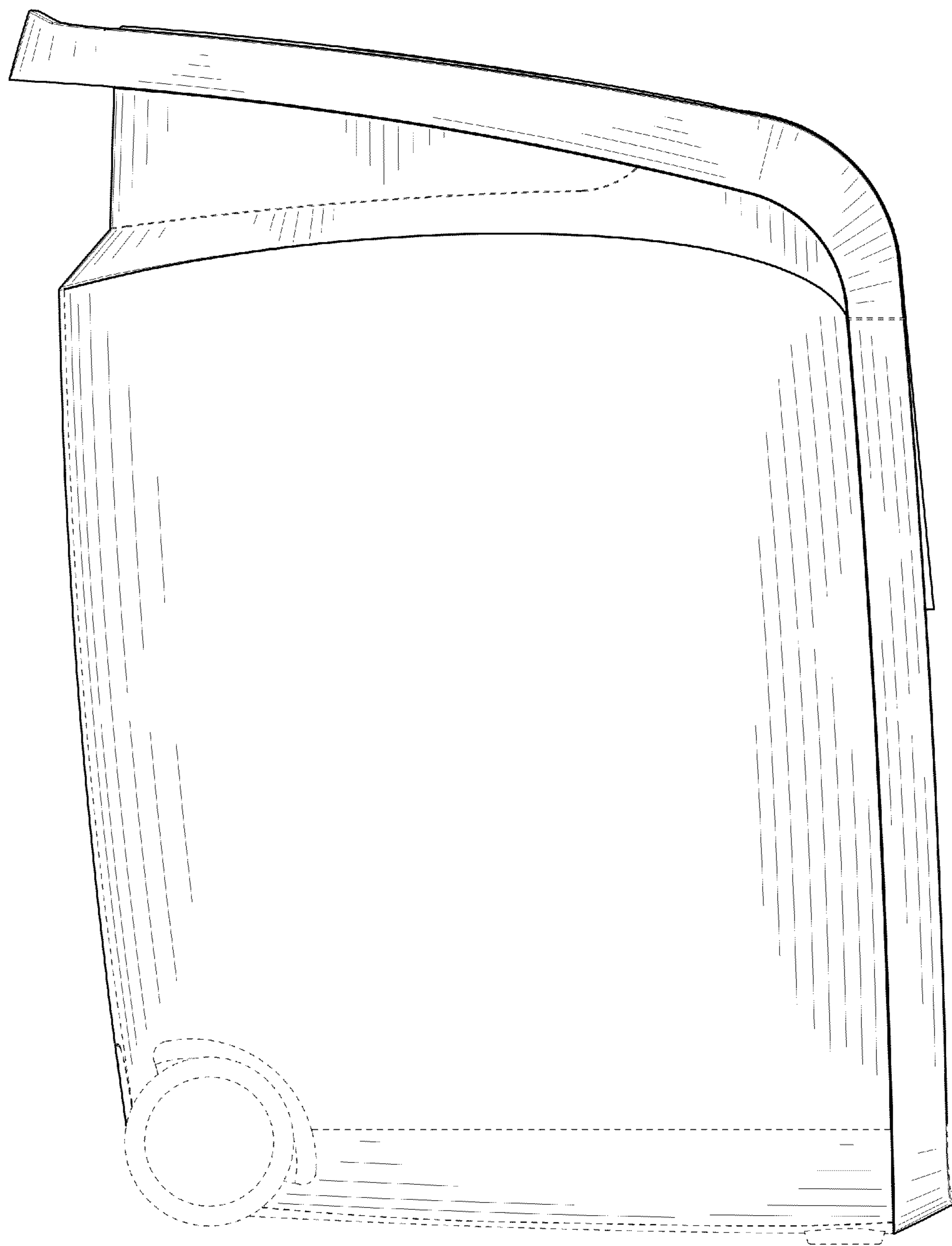

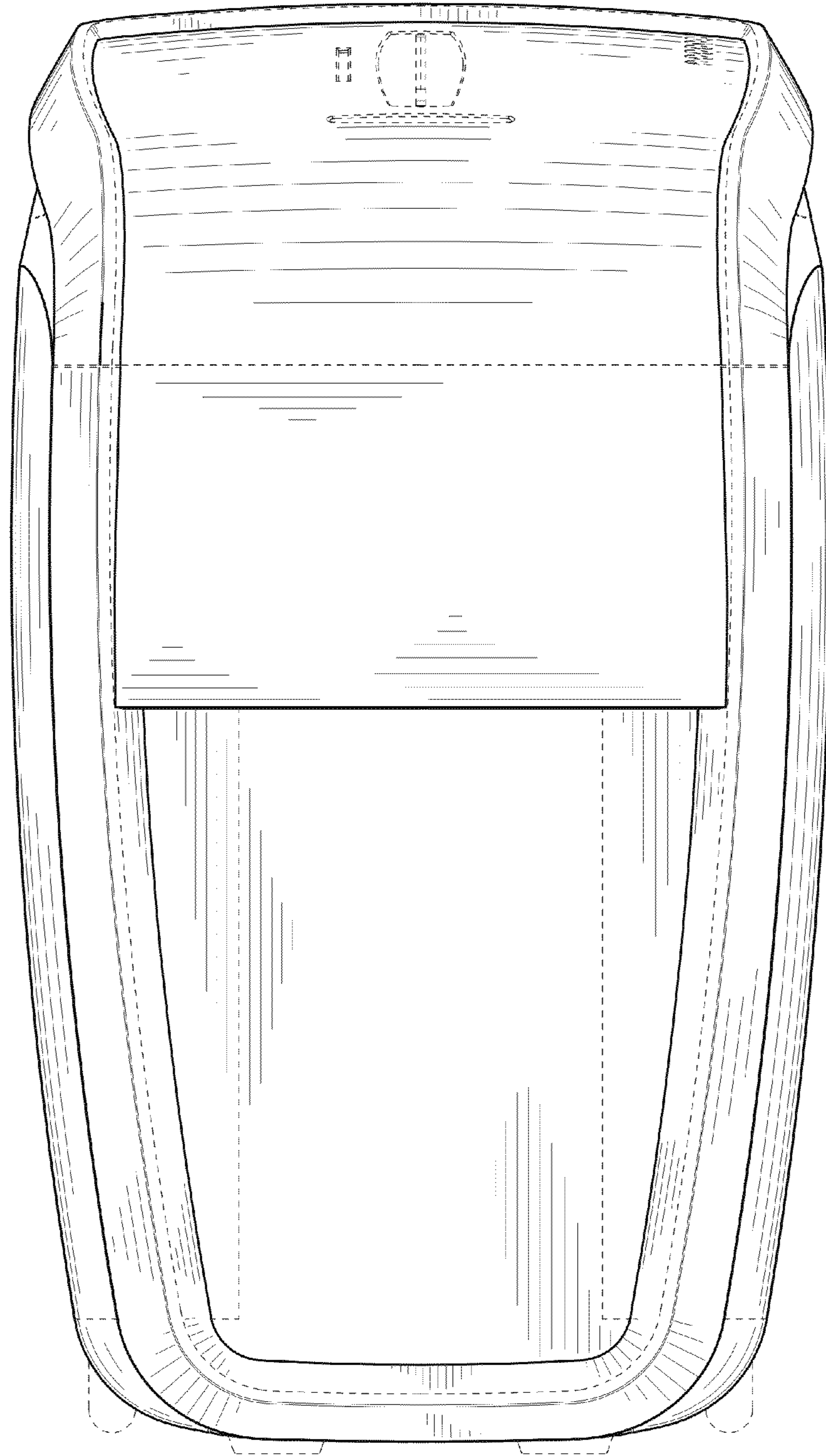

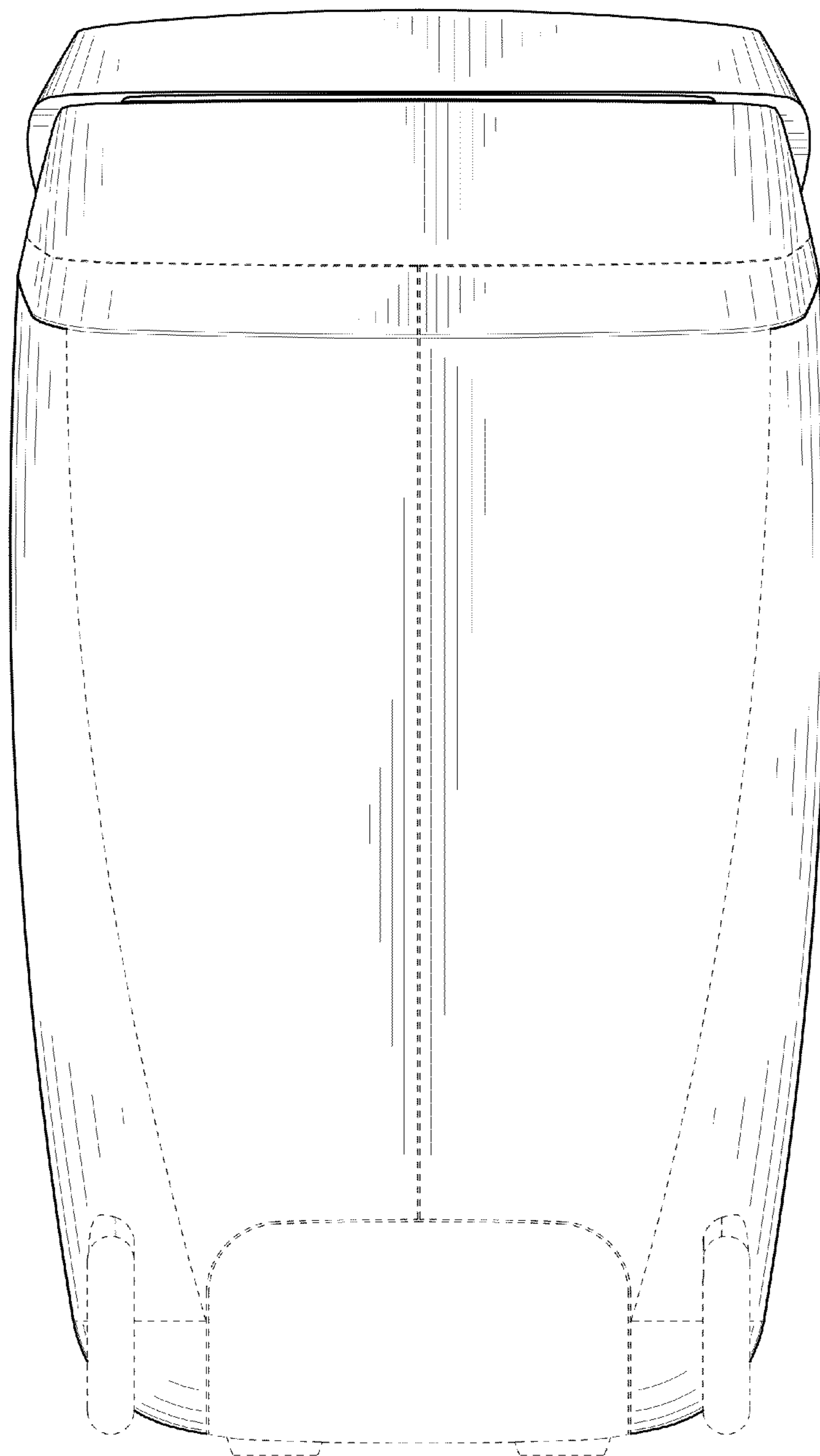

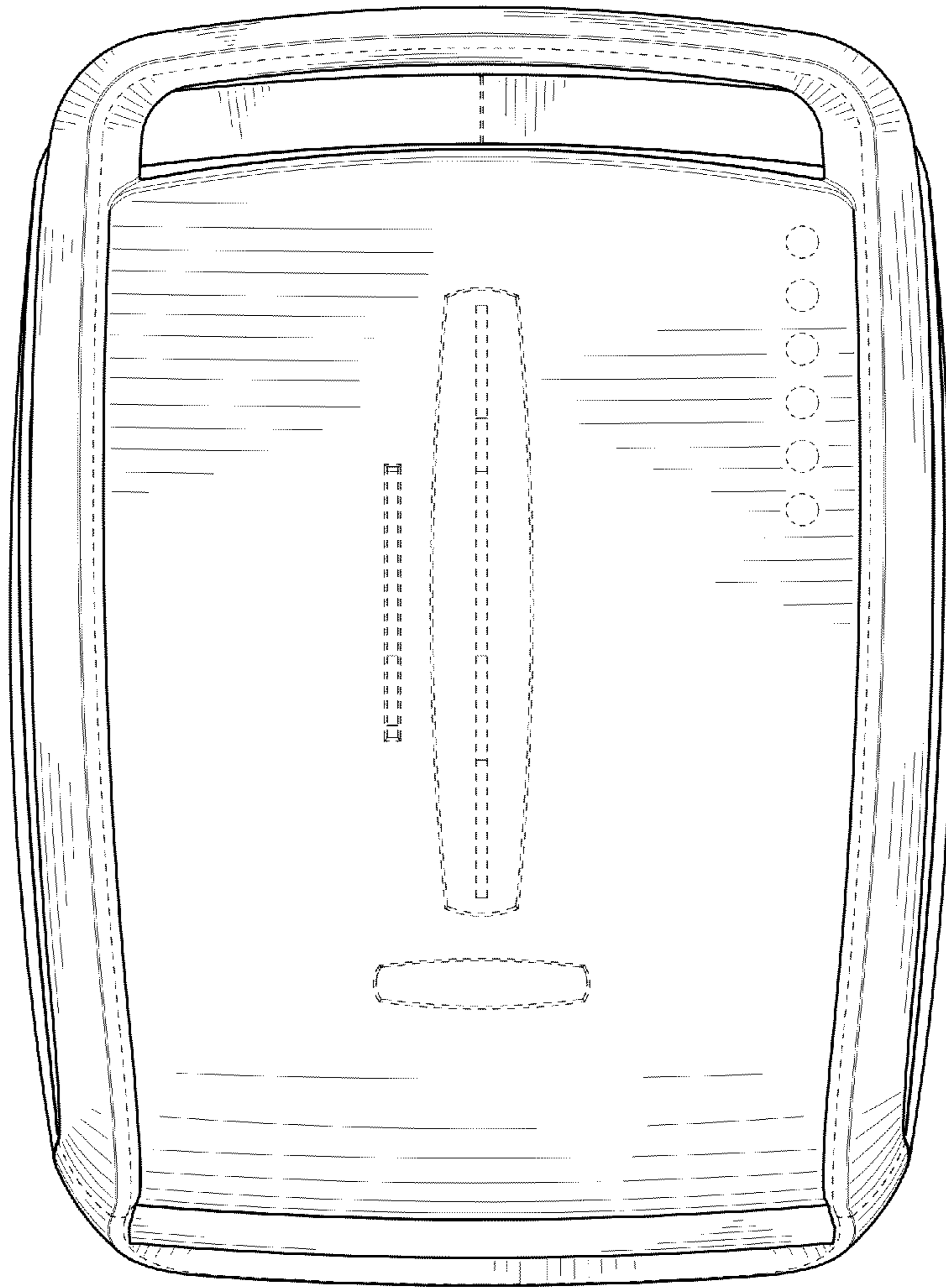

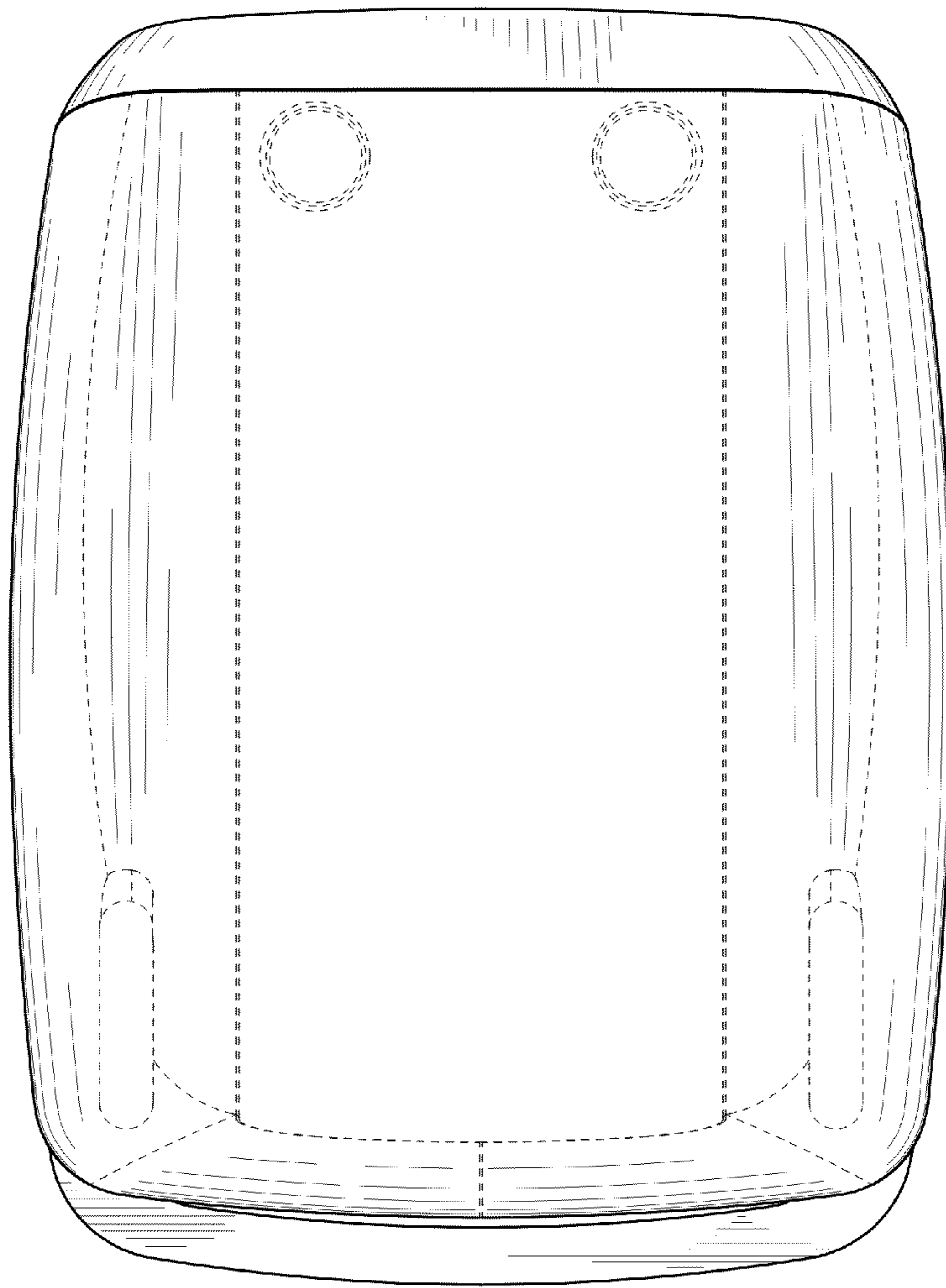
