(57) **CLAIM**

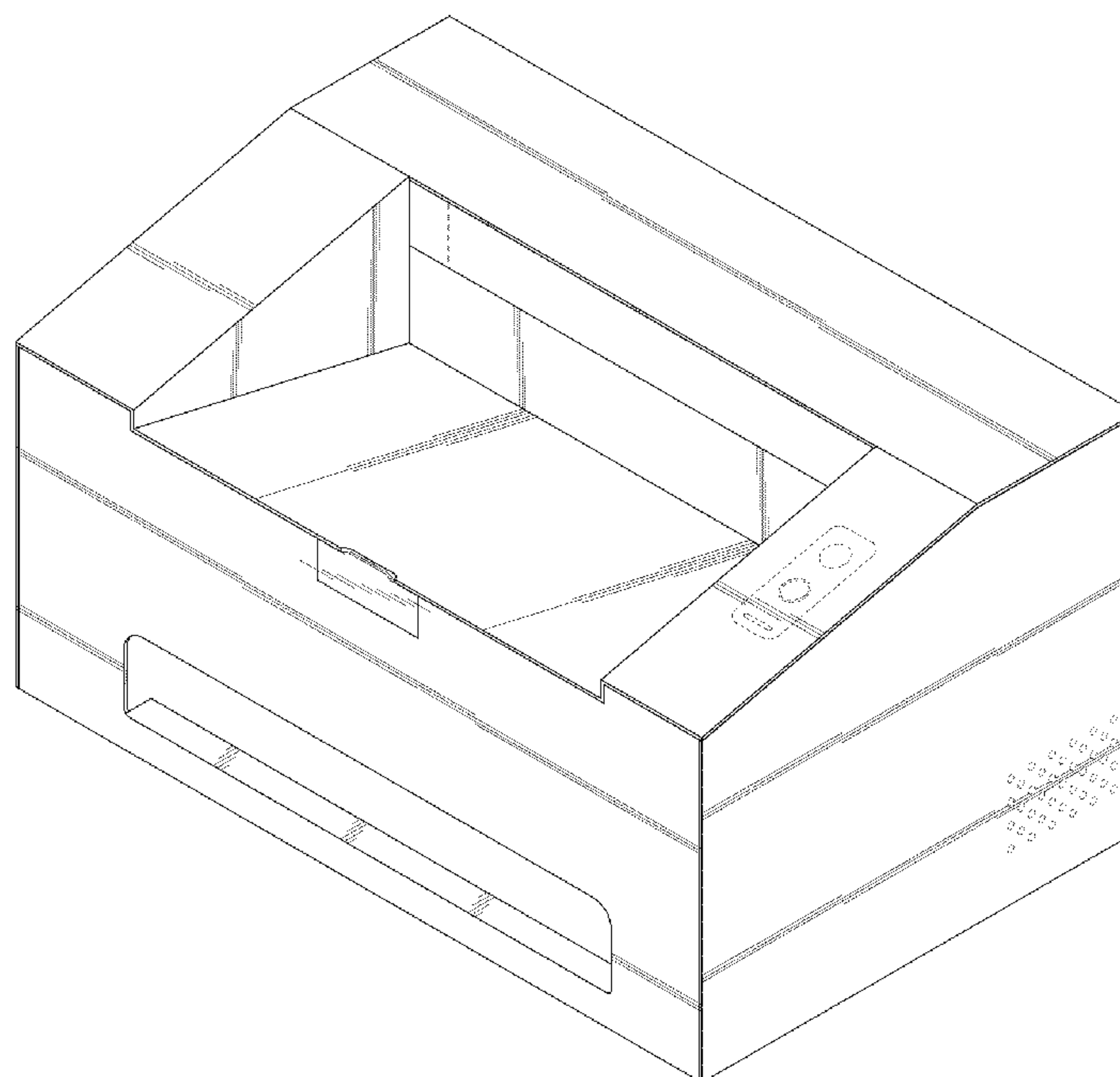
The ornamental design for a case for a printer, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a case for a printer showing our new design;
FIG. 2 is a front view thereof

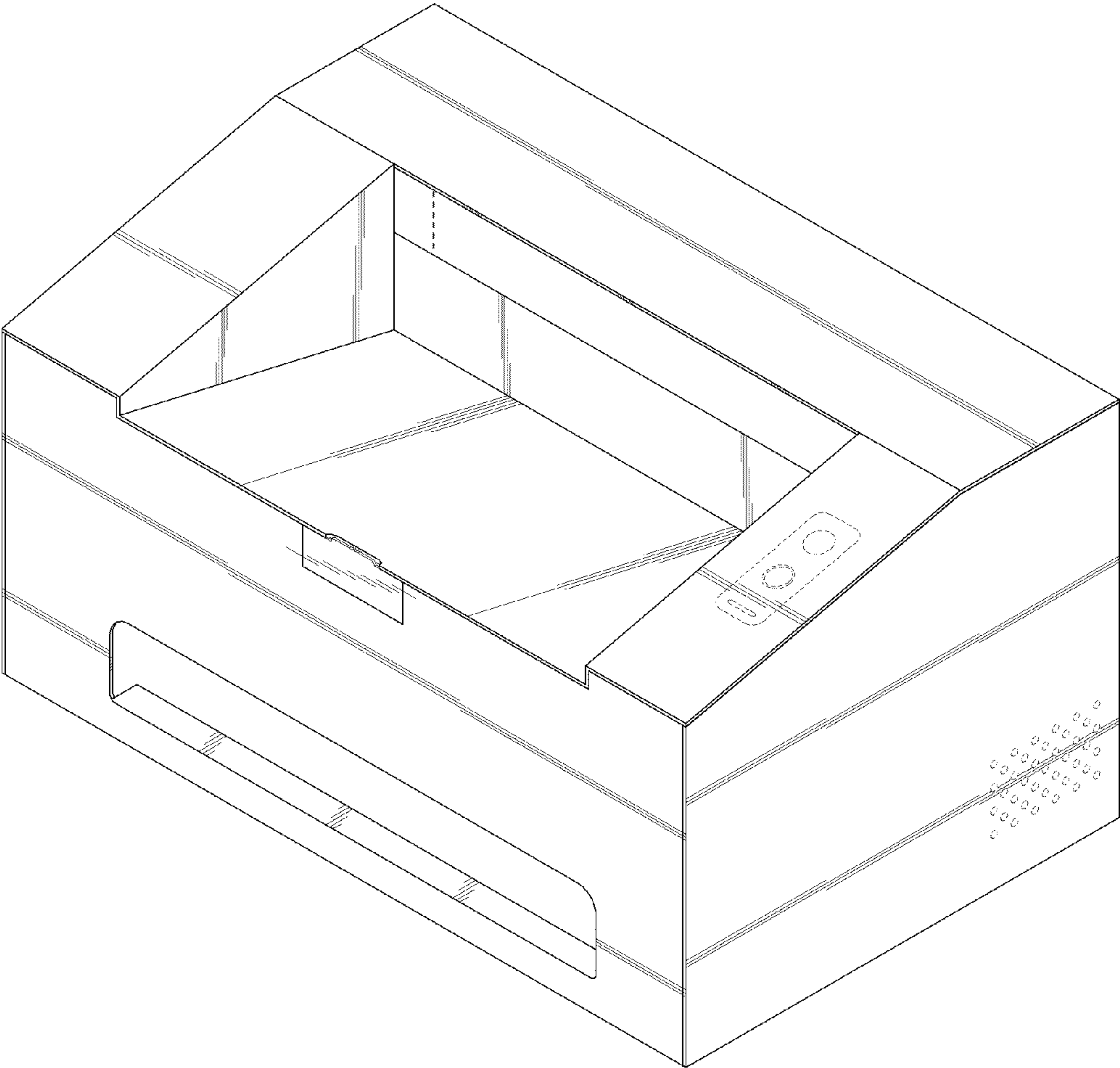

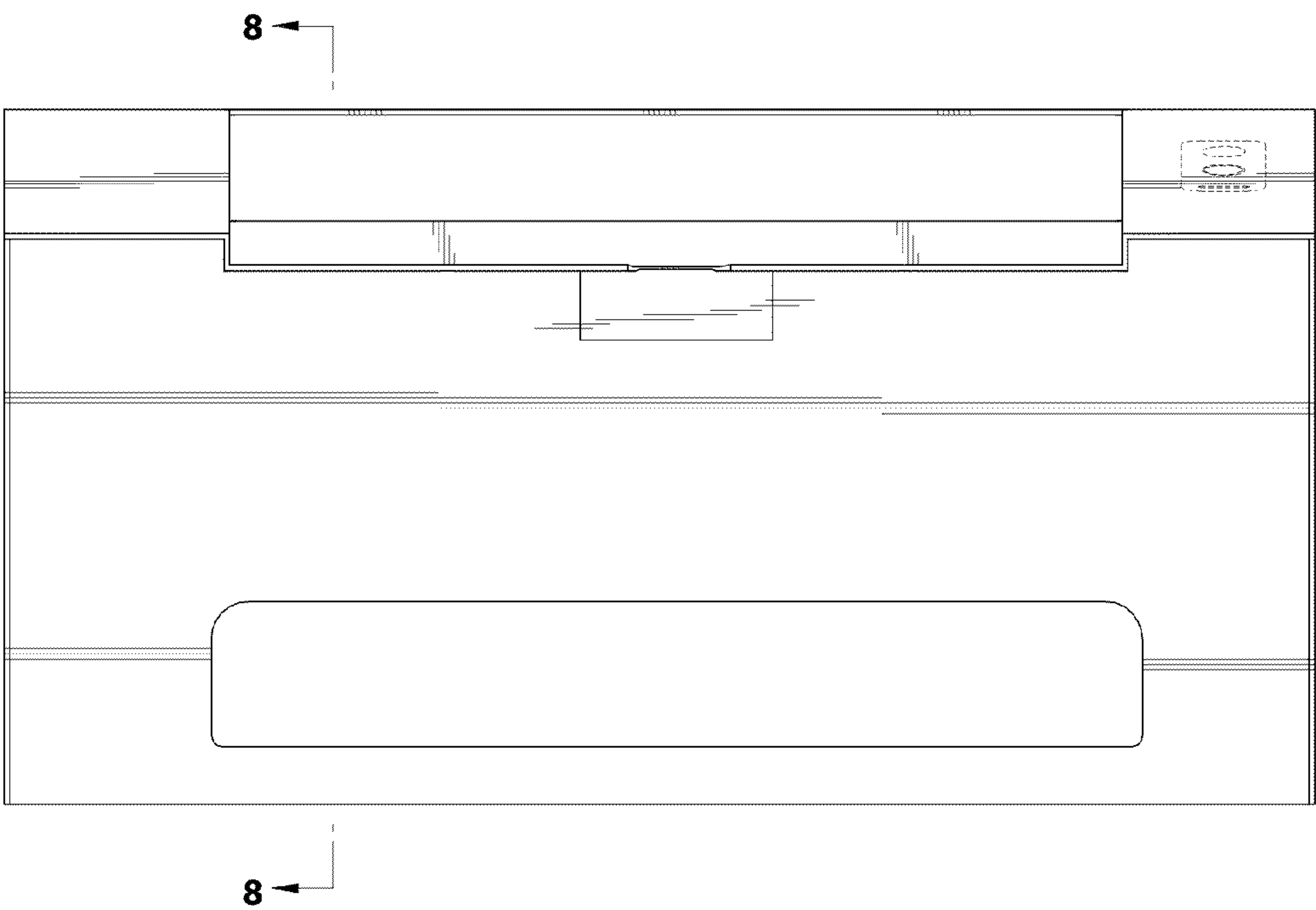

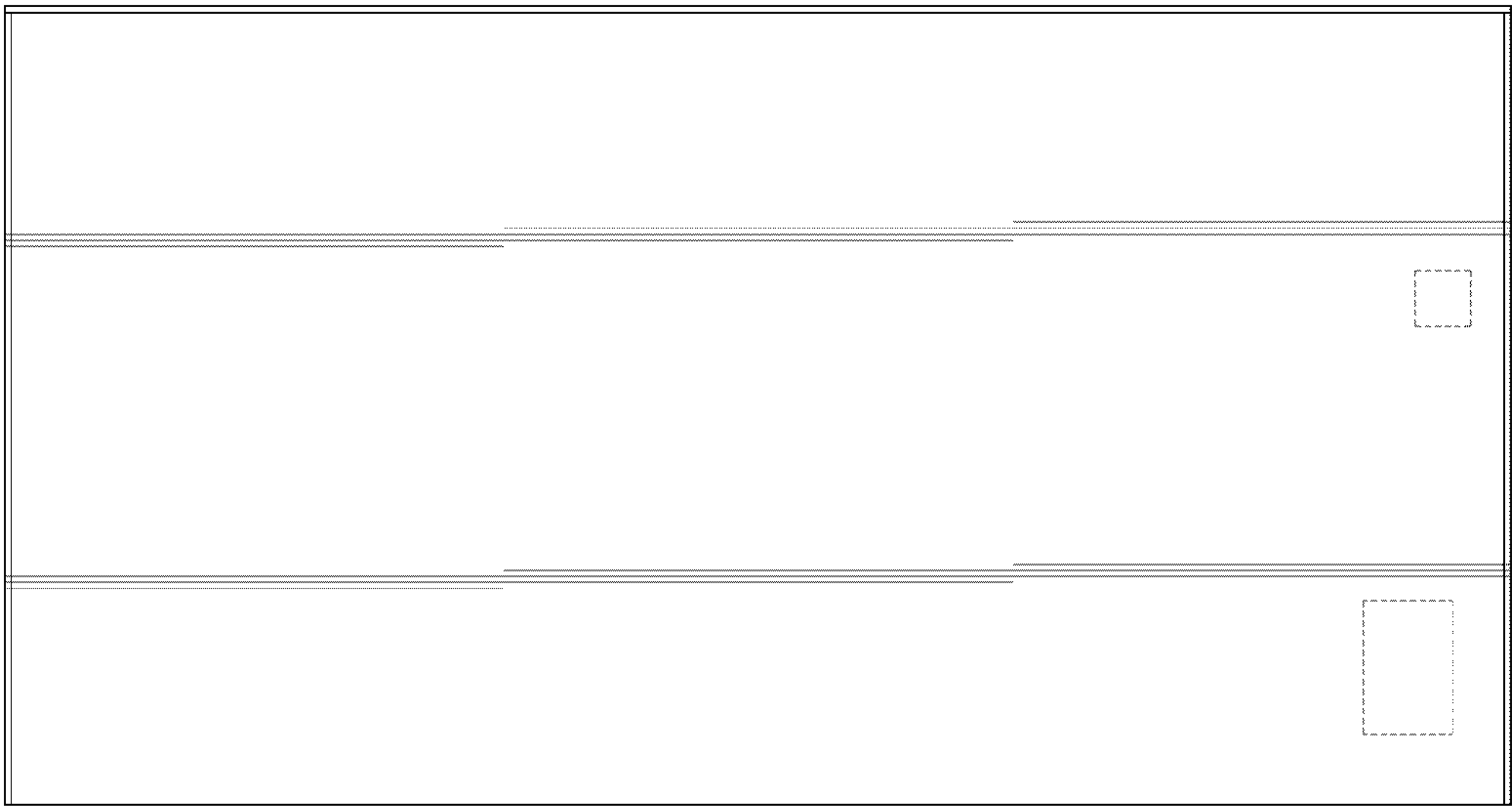

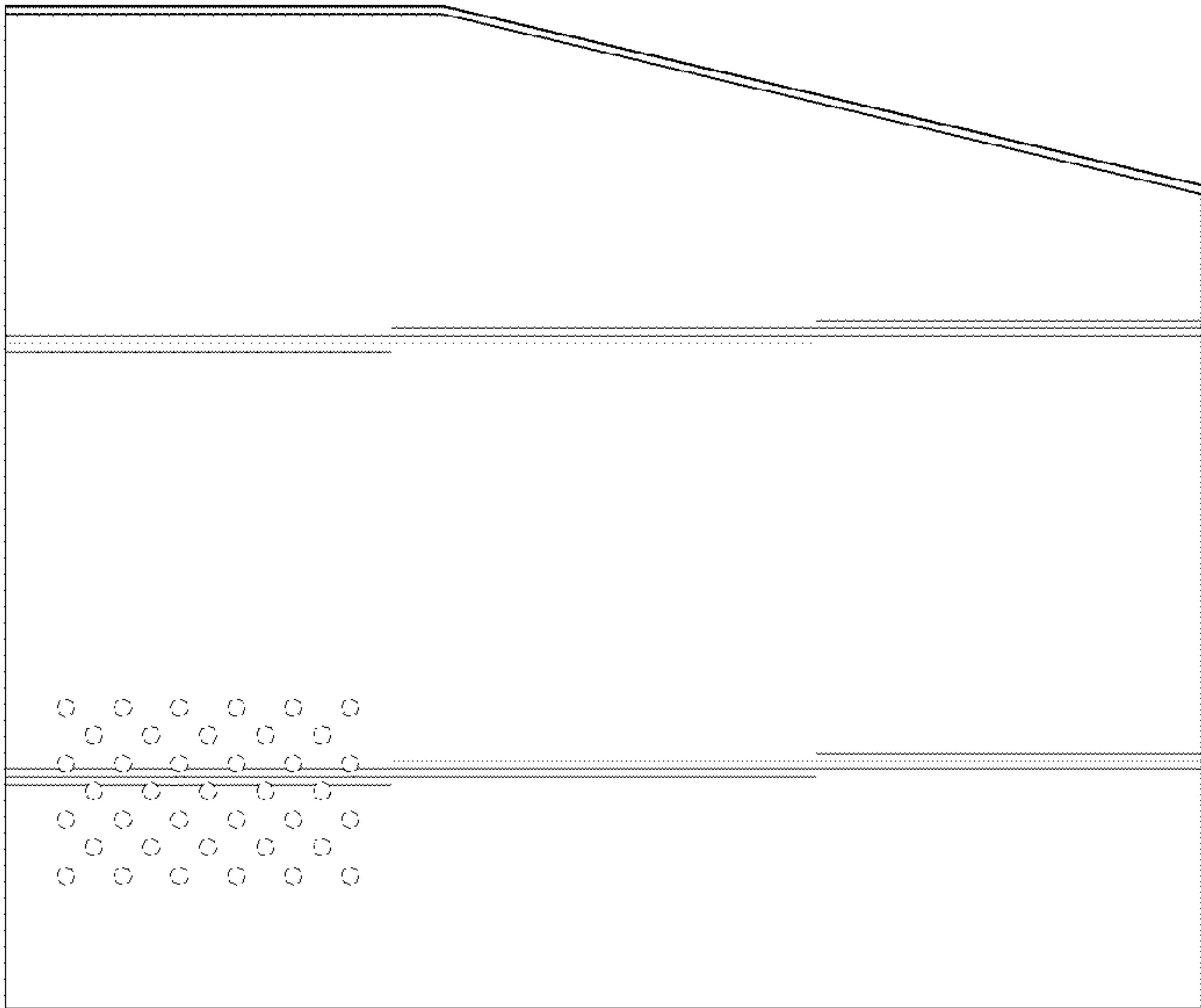

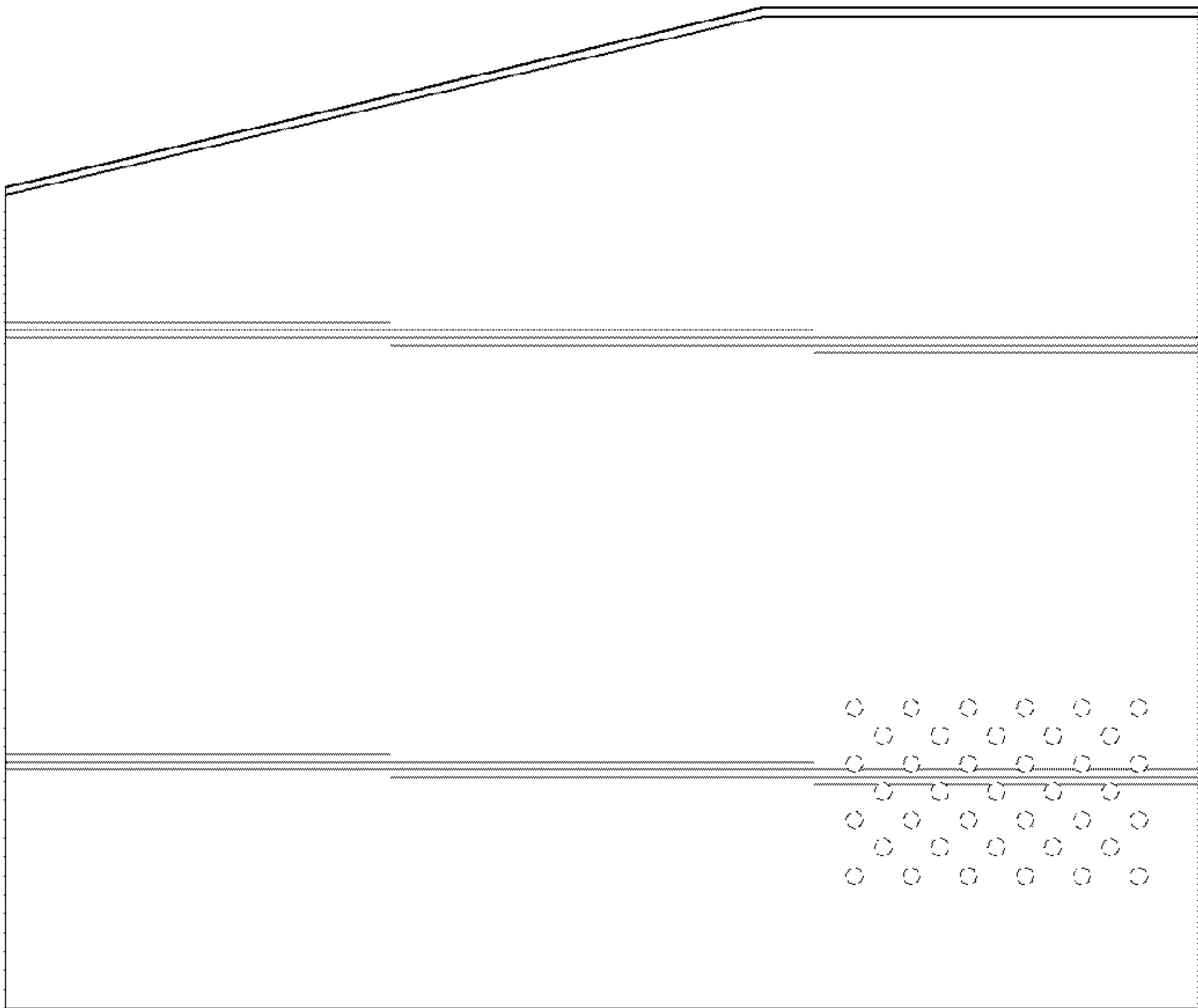

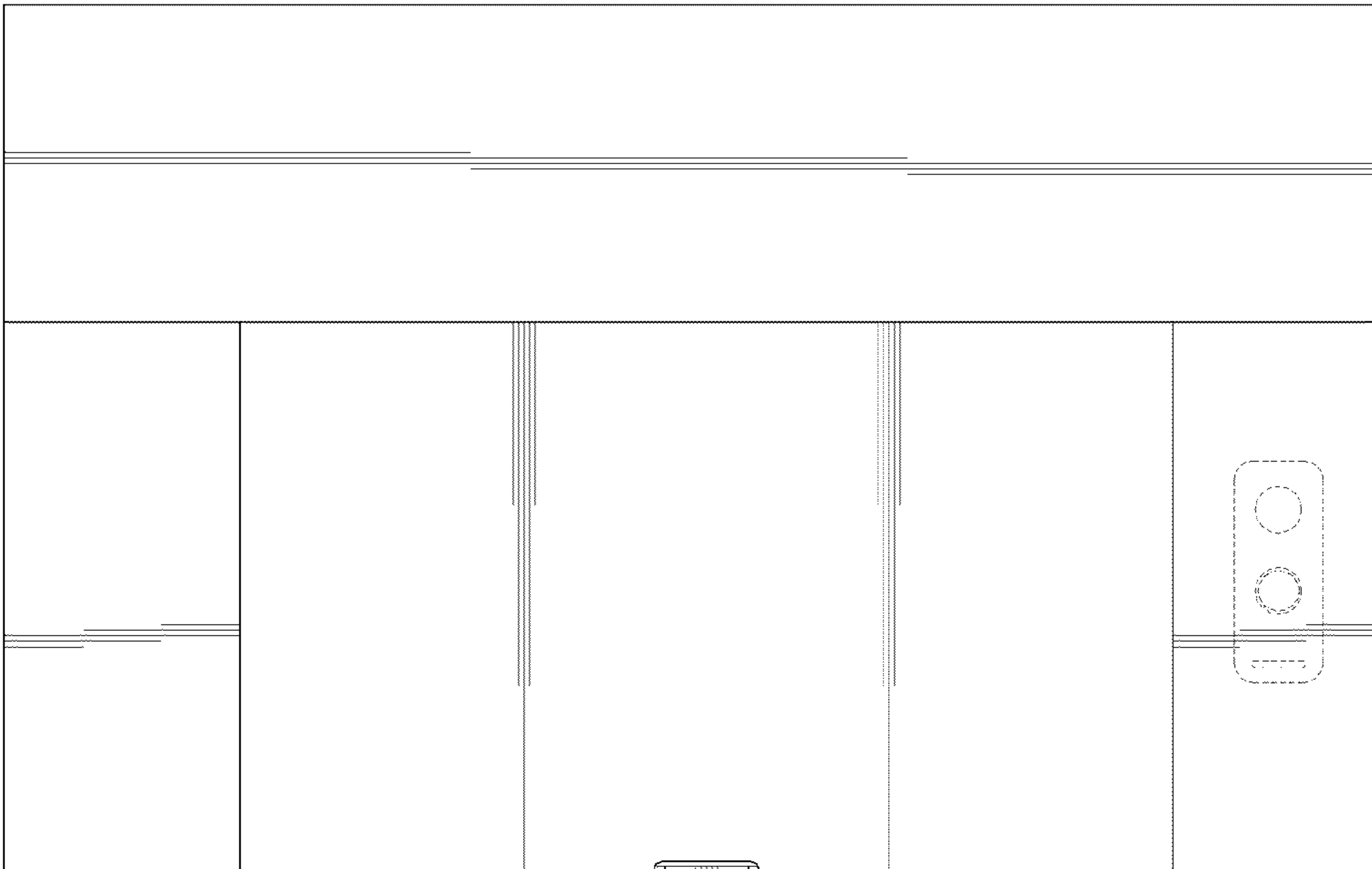

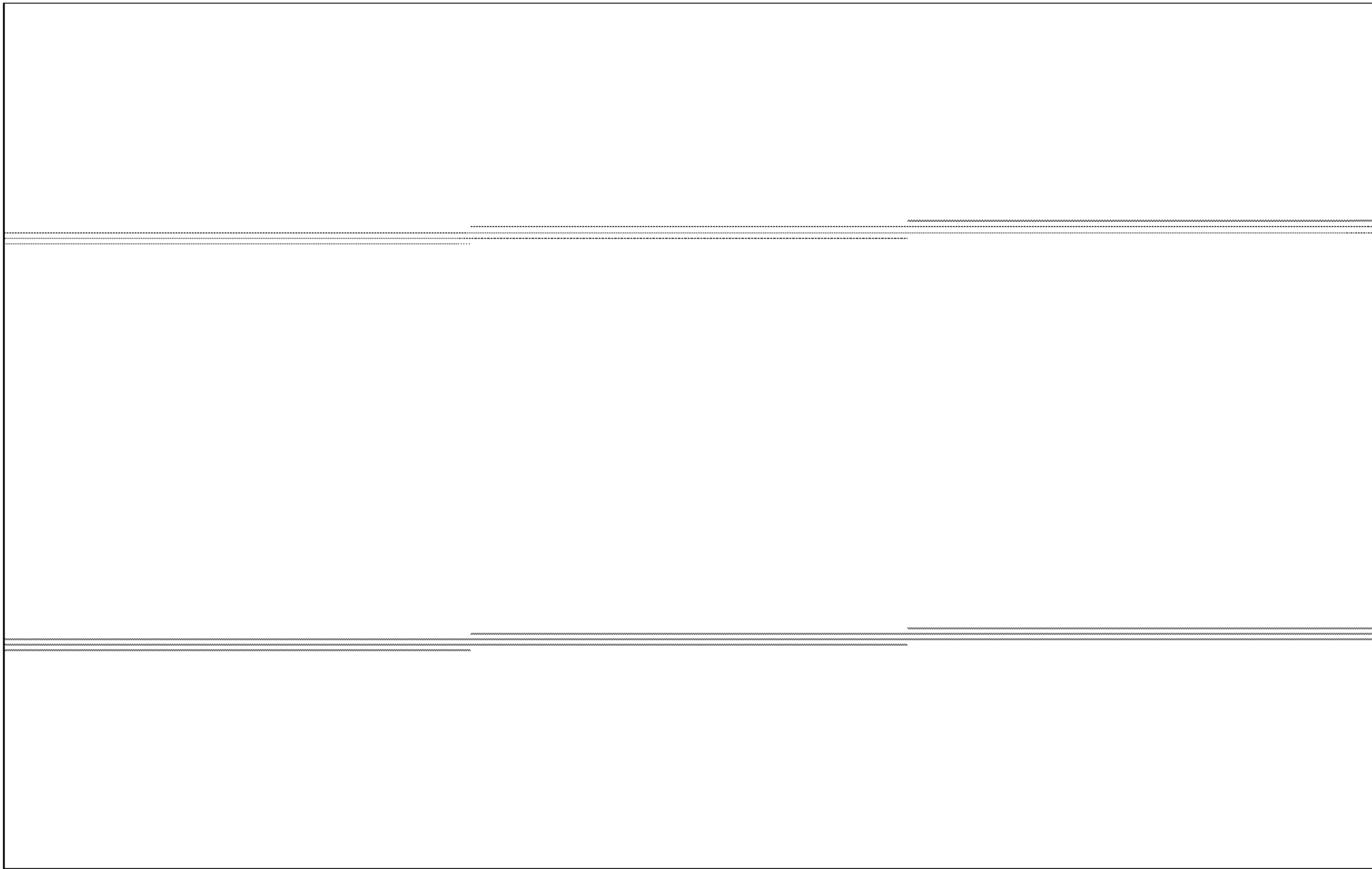

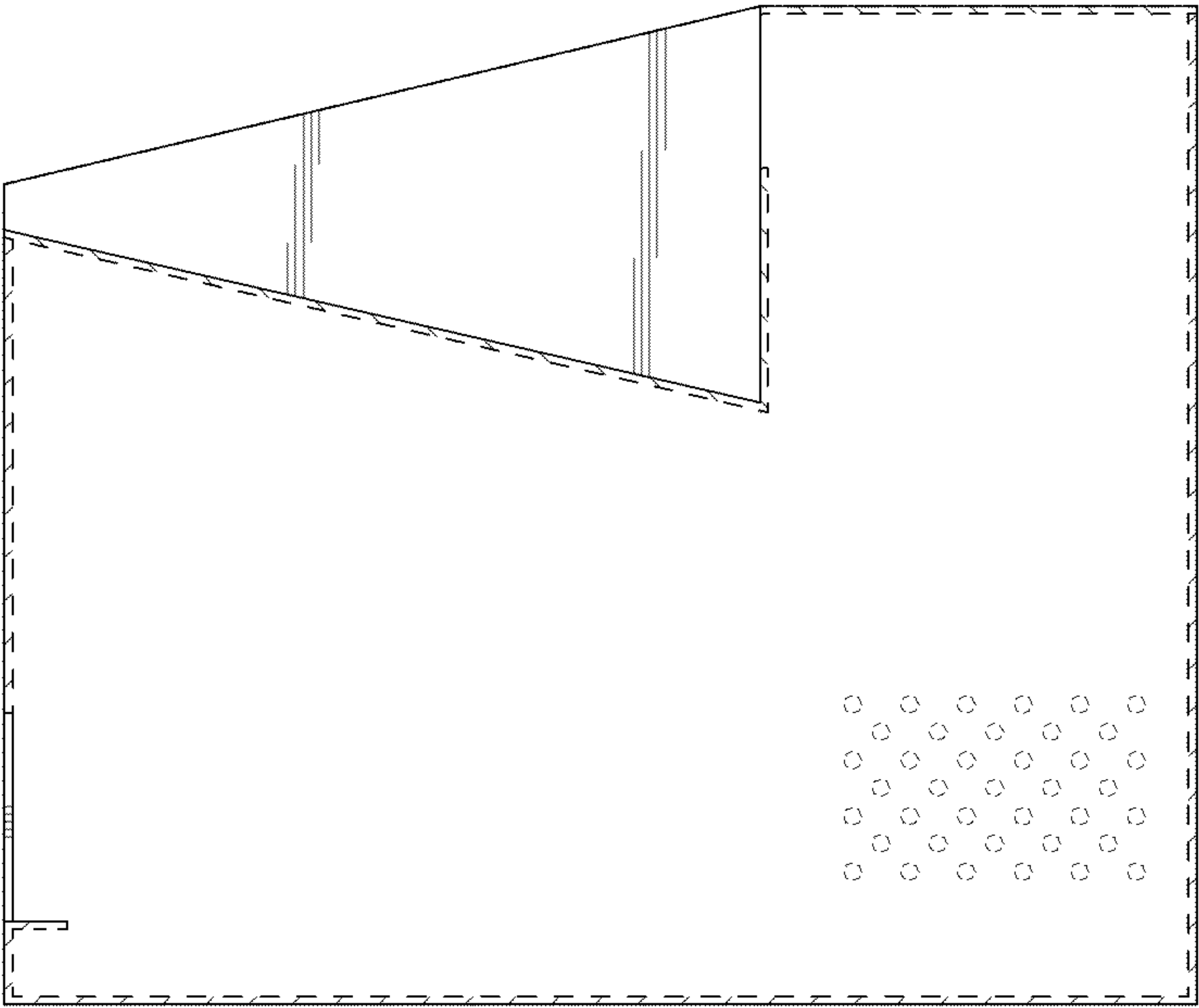
