(57) **CLAIM**

The ornamental design for a gasket for mounting on vehicle to provide seal with hood or trunk lid, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a gasket for mounting on vehicle to provide seal with hood or trunk lid showing my new design; FIG. 2 is a bottom plan view showing my new design; FIG. 3 is a right side elevational view thereof, the left side elevational view being identical thereto; FIG. 4 is a left end elevational view thereof, the right end elevational view being identical thereto; FIG. 5 is a cross-sectional view thereof, taken on section line V-V of FIG. 3; FIG. 6 is a cross-sectional view of a gasket shown in FIG. 5, showing an alternate position; and, FIG. 7 is a perspective view showing my new design. The broken line showing is included for the purpose of illustrating environment and forms no part of the claimed design.

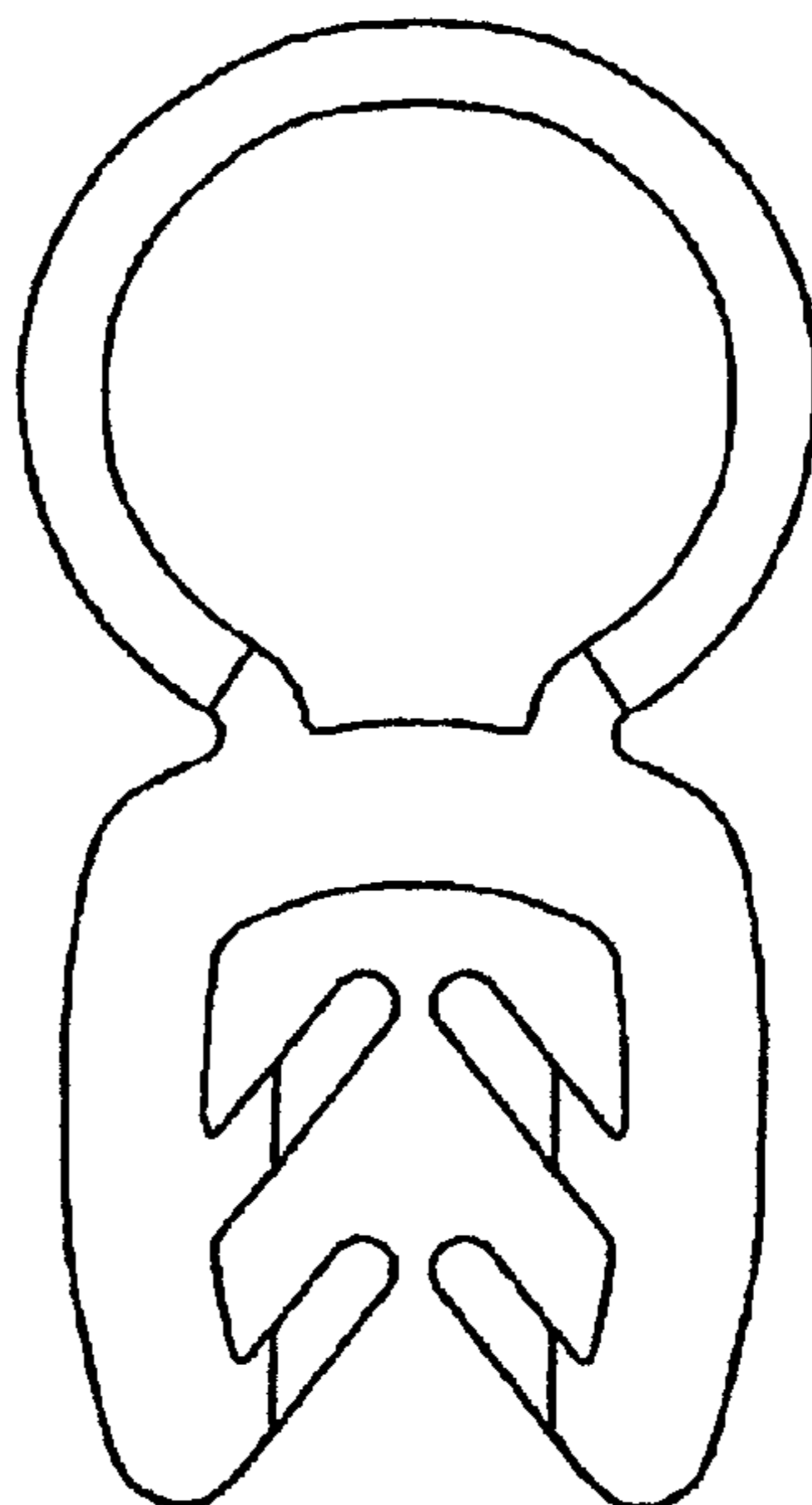

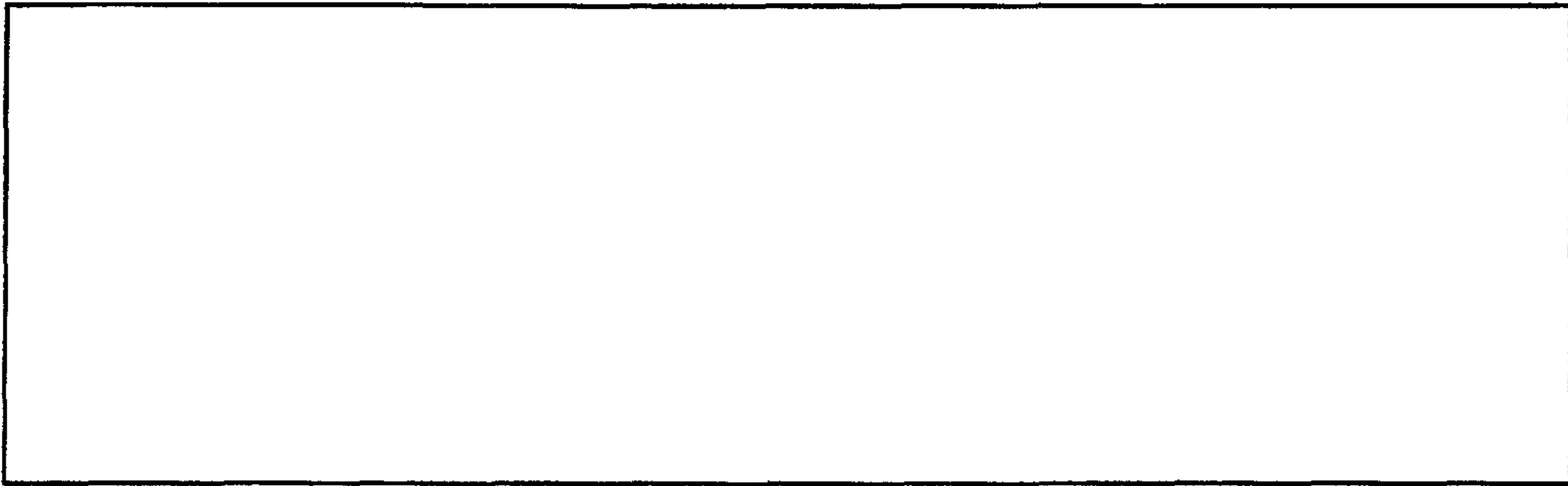

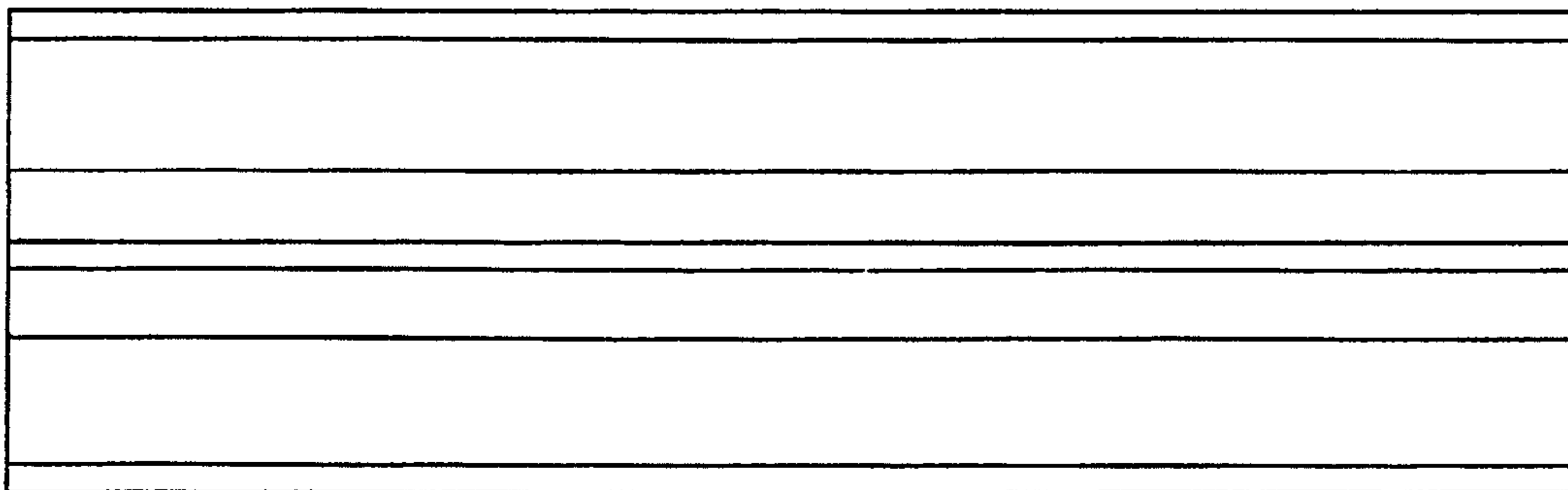

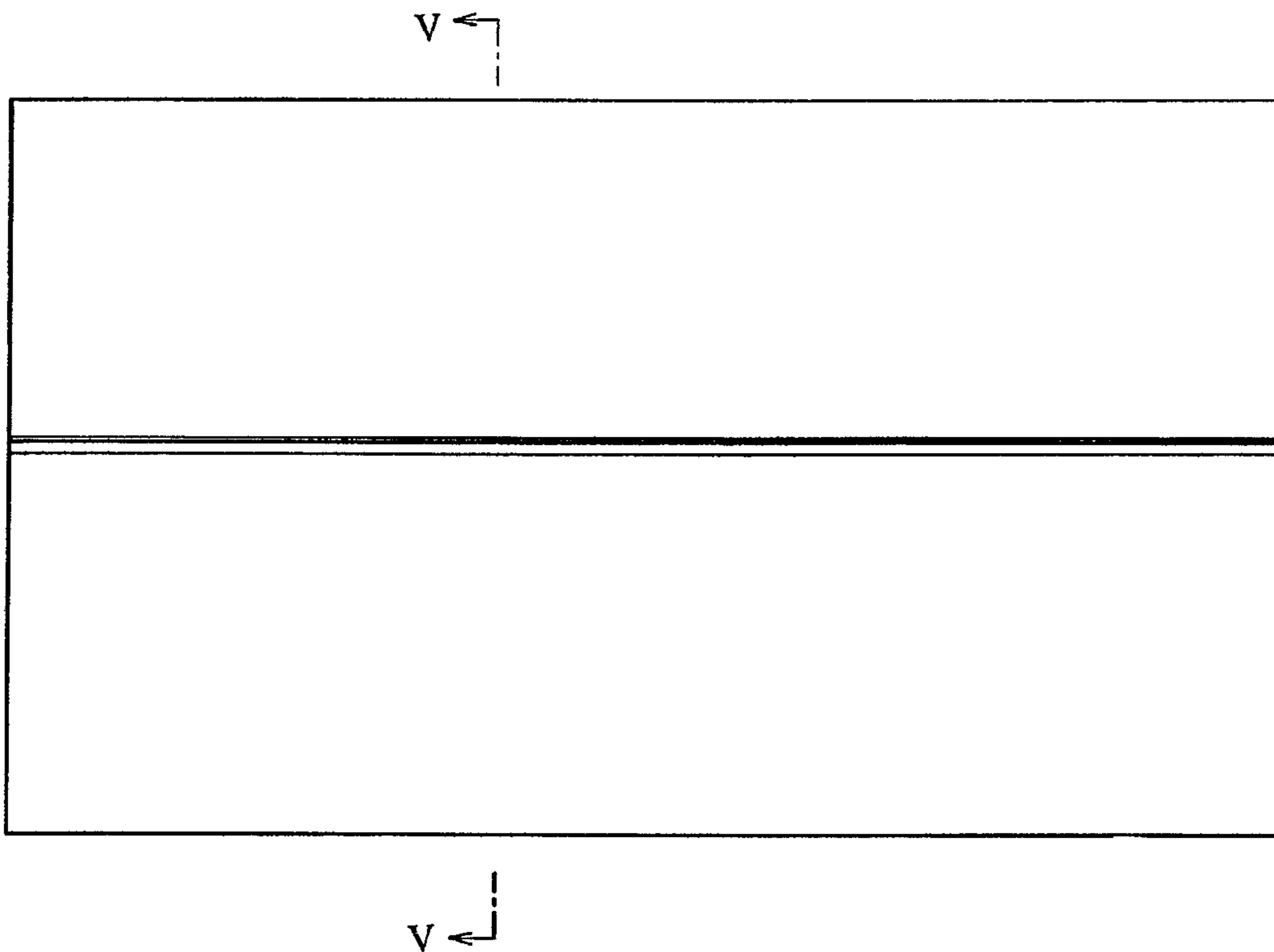

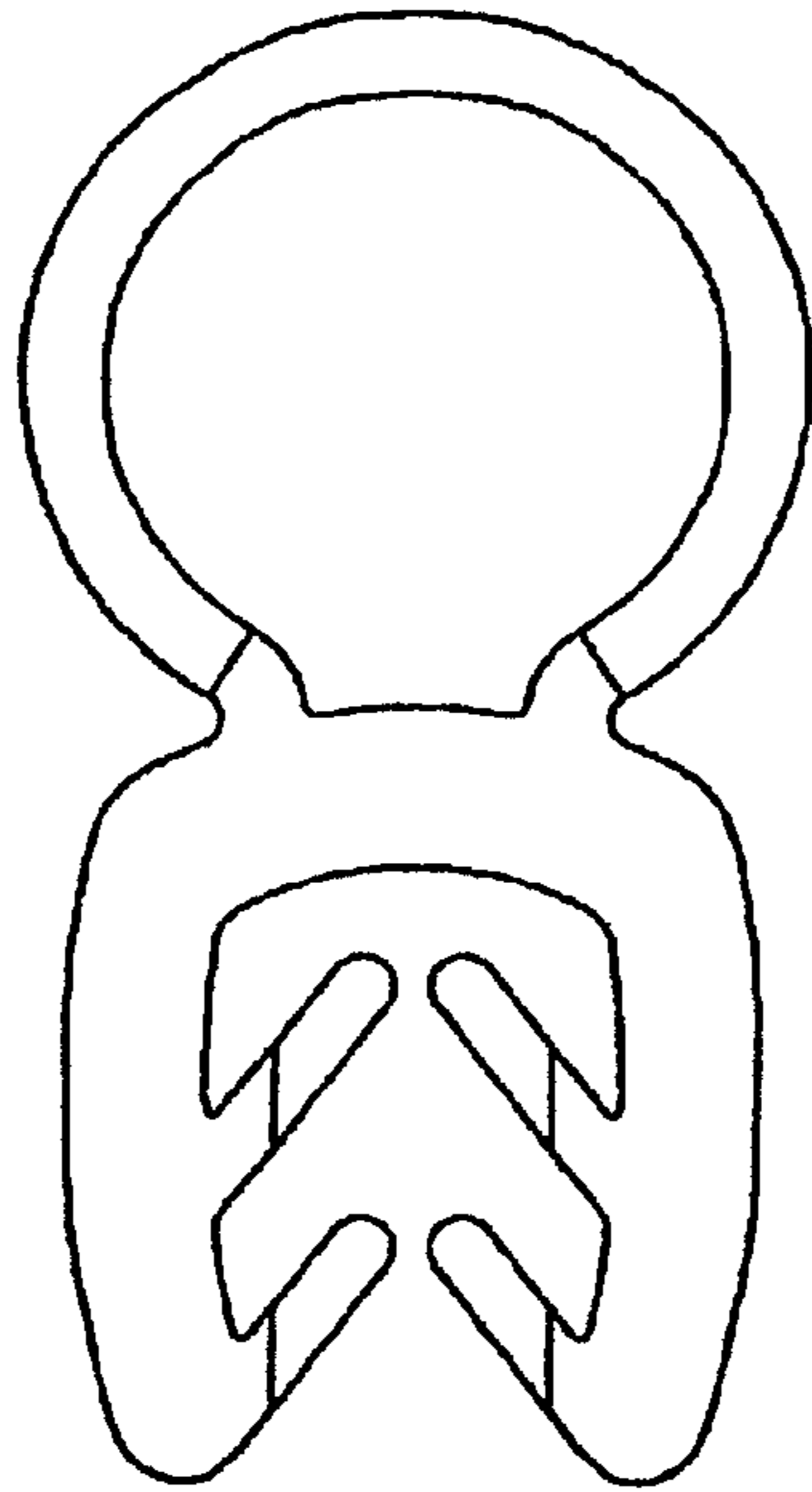
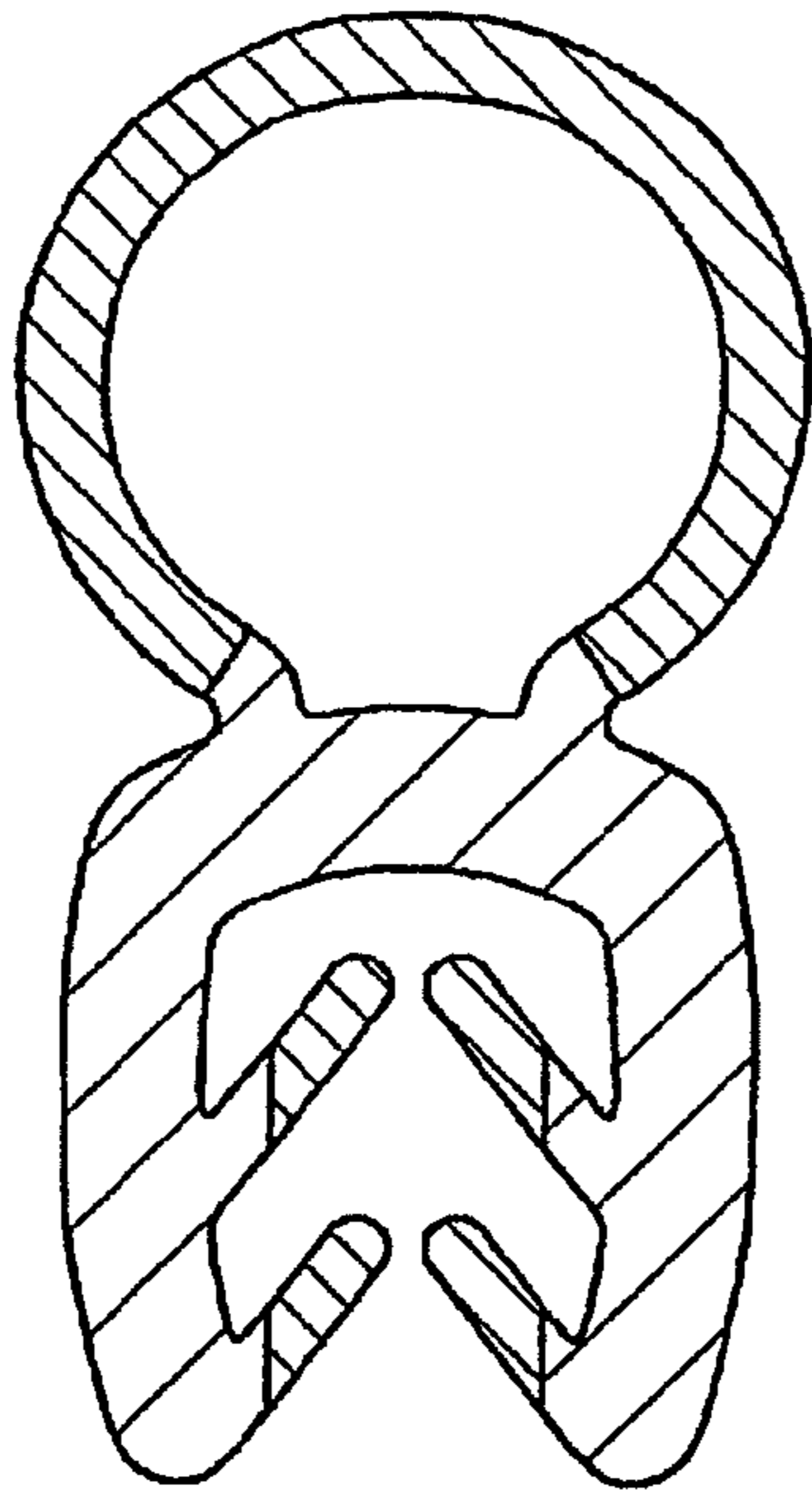

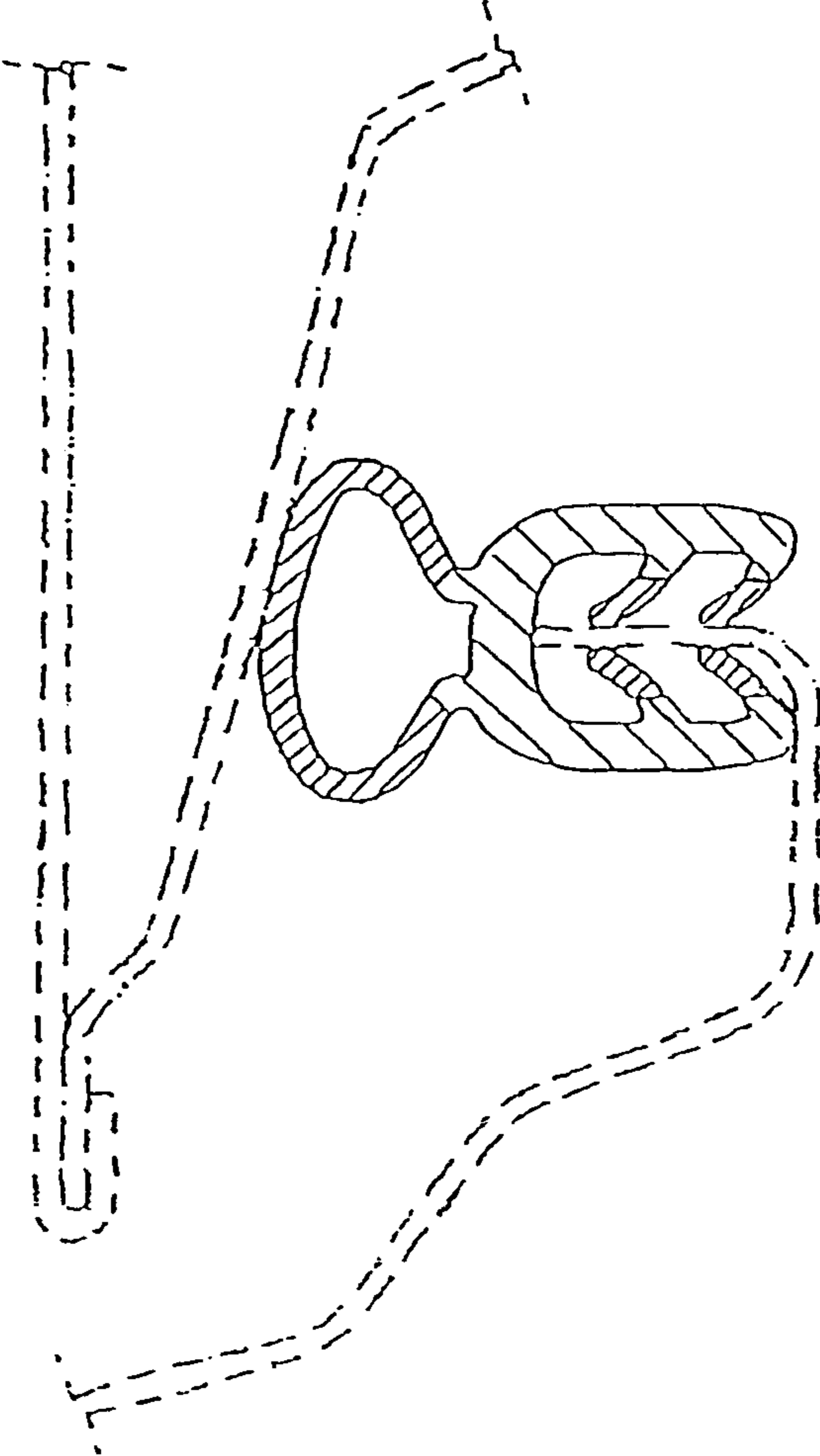
