(57) **CLAIM**

The ornamental design of a cooling face mask, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a face mask design, shown in use wrapped around a representative sample of a human head; FIG. 2 is a right side elevation view of the mask of FIG. 1; the left side elevation view being a mirror image of the left side elevation view.

FIG. 3 is a front elevation view of the mask of FIG. 1.

FIG. 4 is a rear elevation view of the mask of FIG. 1.

FIG. 5 is a top plan view of the mask of FIG. 1.

FIG. 6 is a bottom plan view of the mask of FIG. 1.

FIG. 7 is a front elevation view of the mask of FIG. 1, laid flat in an unused state; and,

FIG. 8 is a rear elevation view of the mask of FIG. 7.

The broken line showing of the human head is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

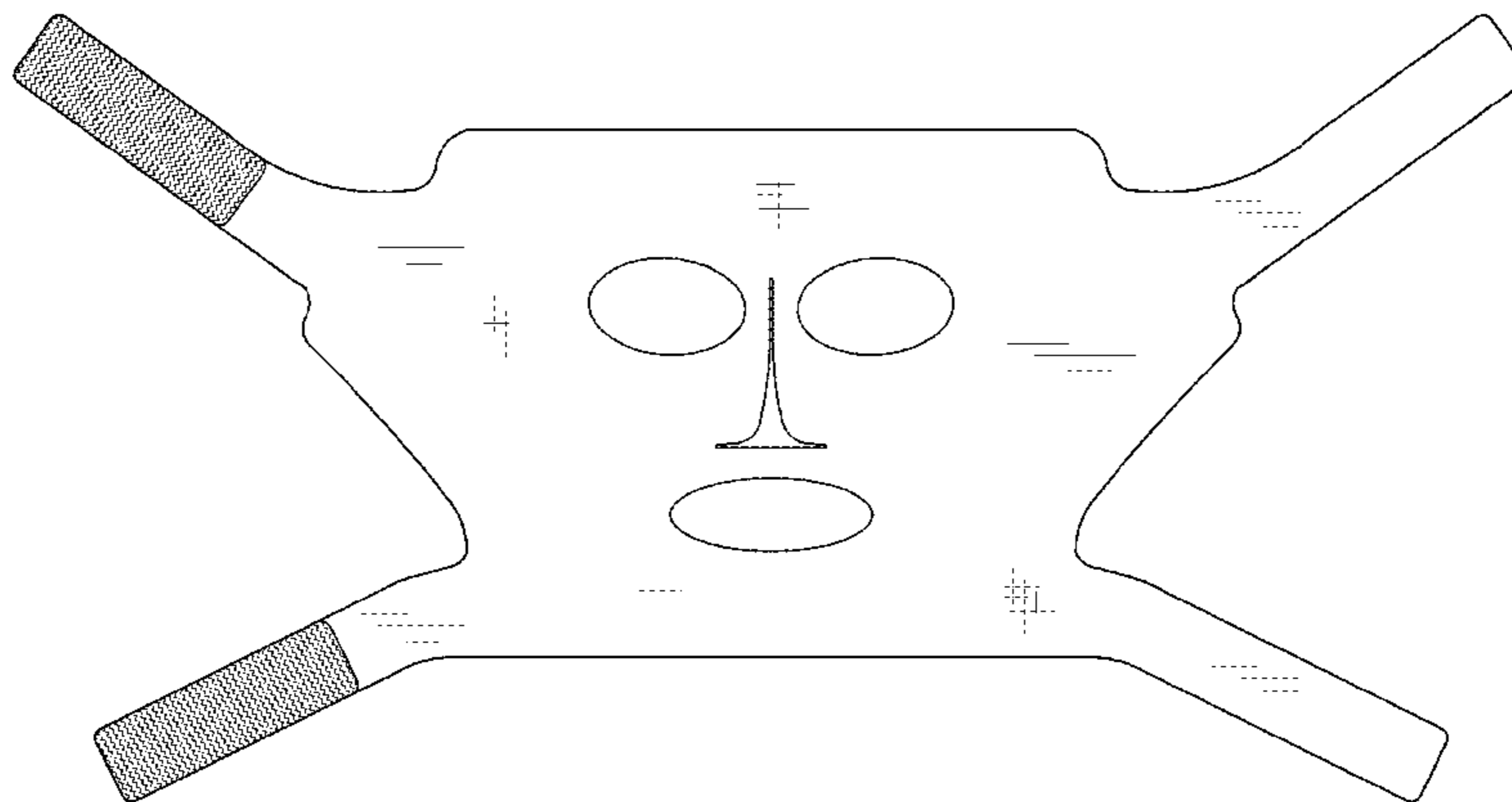

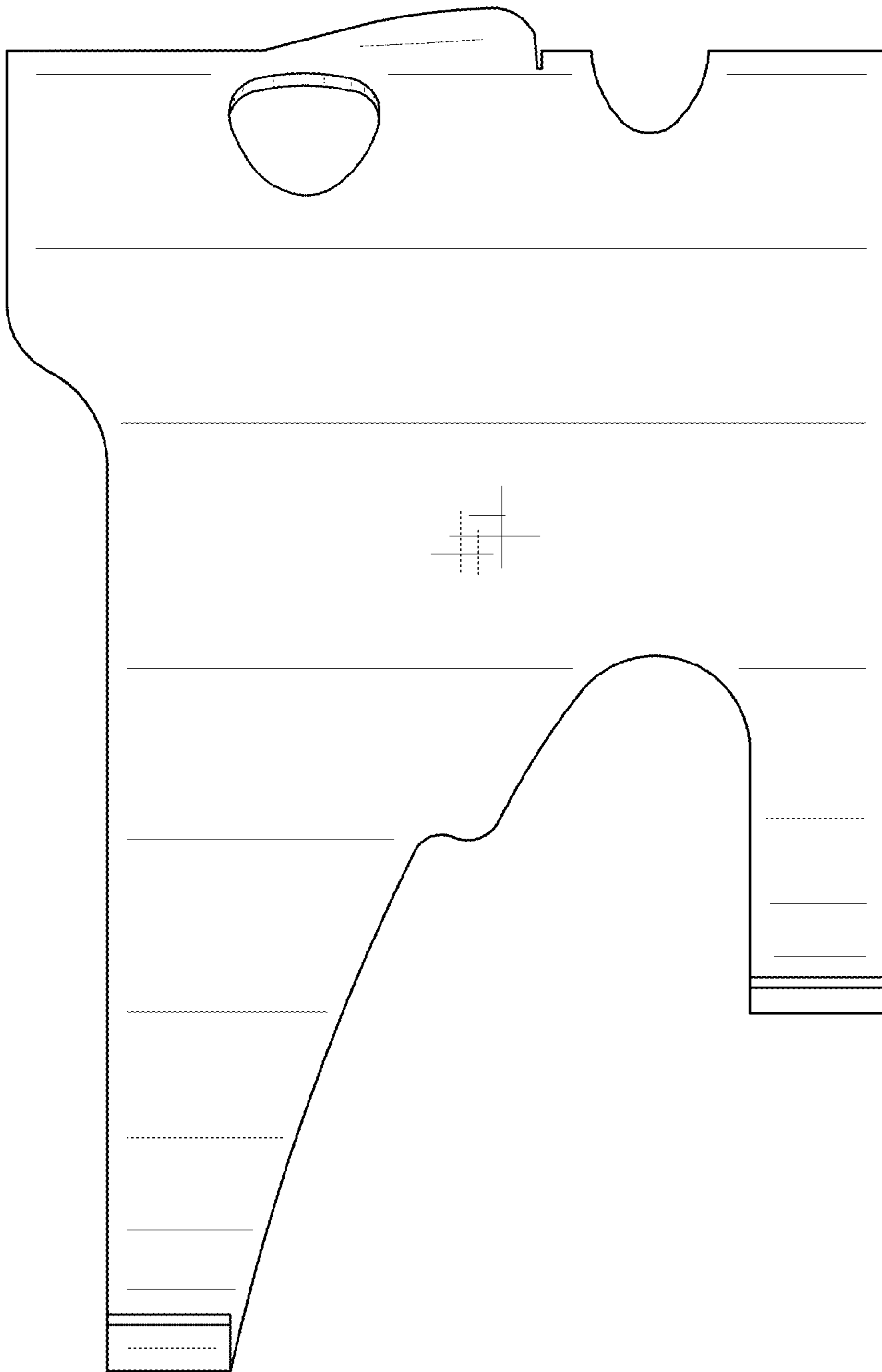

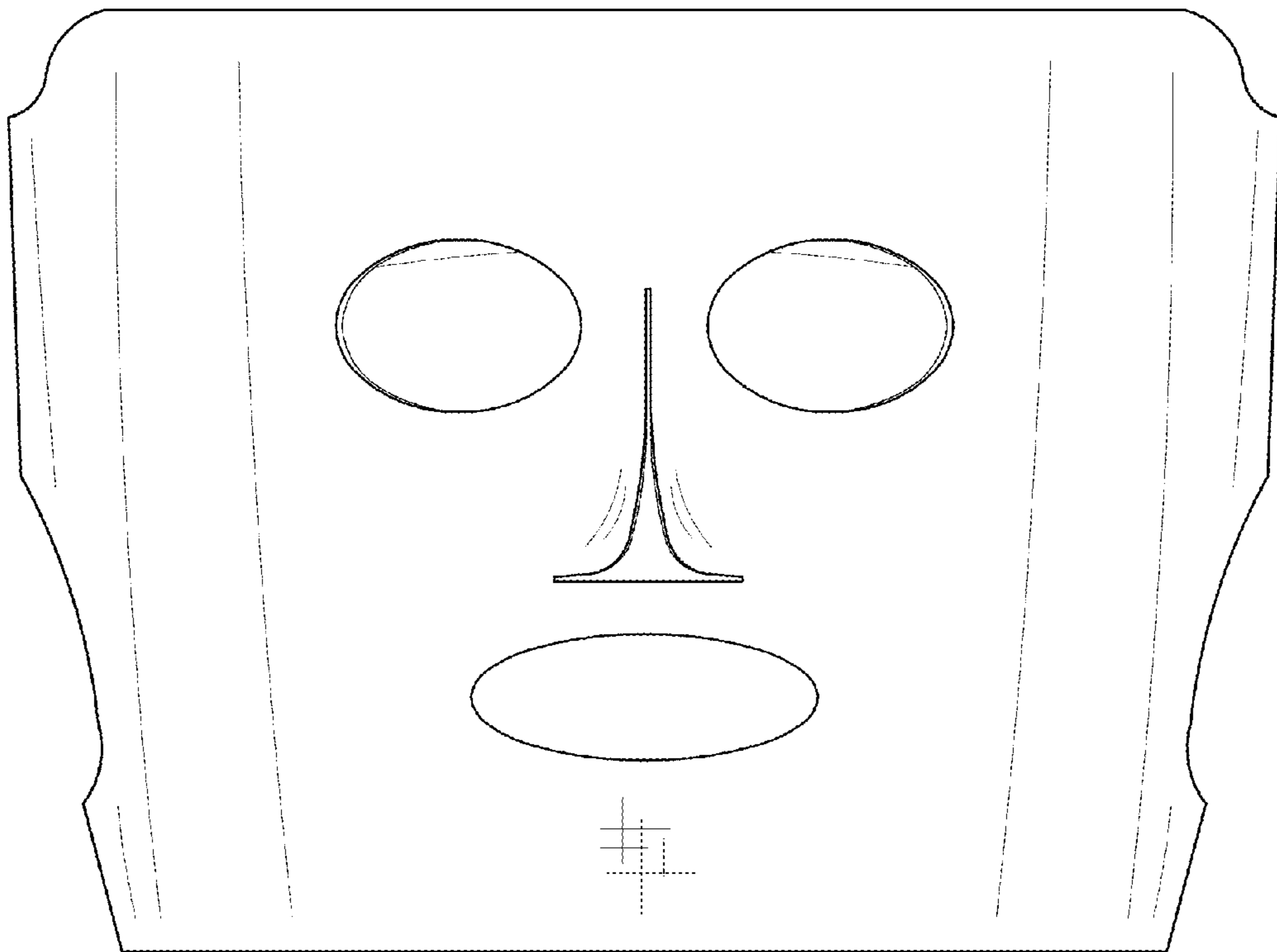

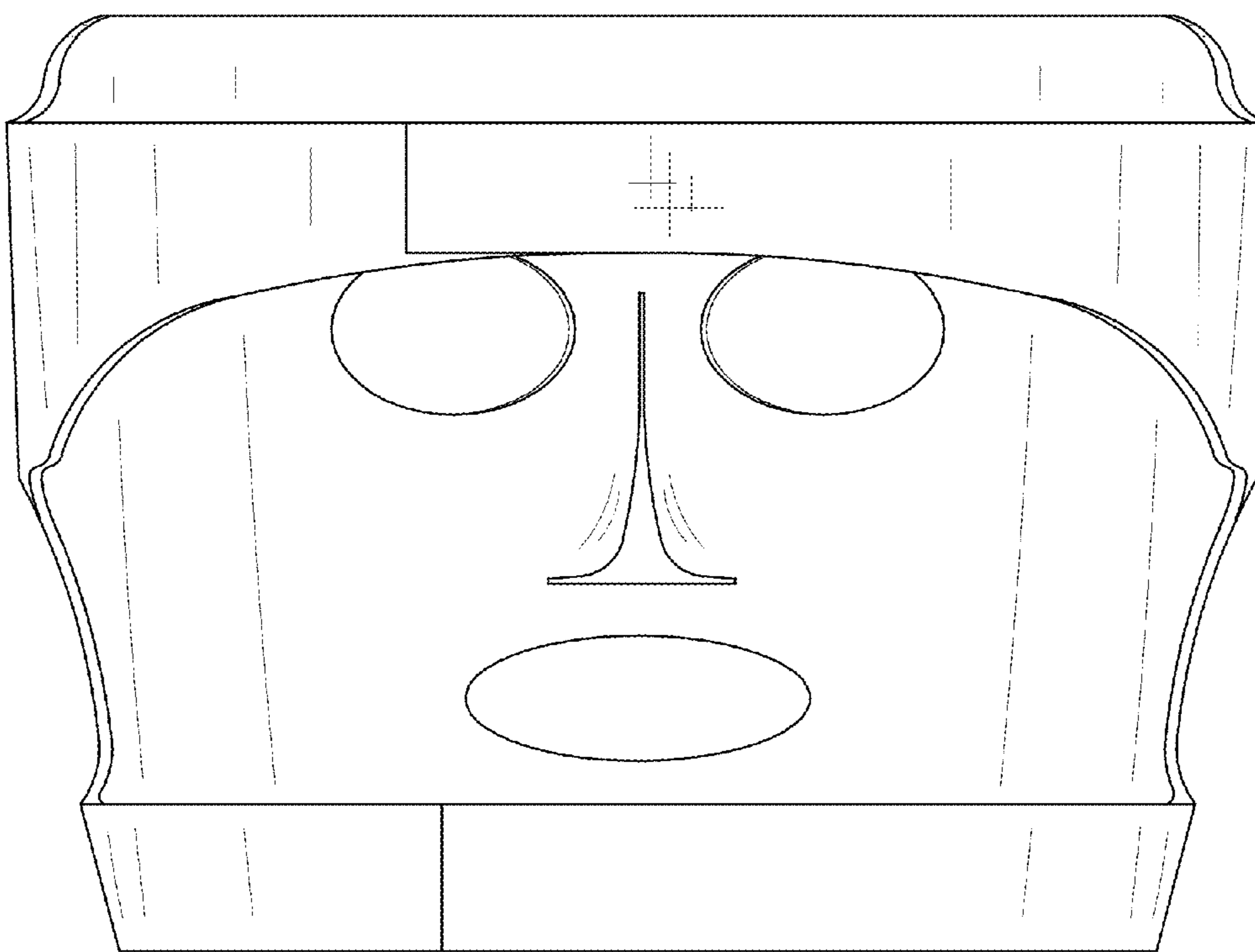

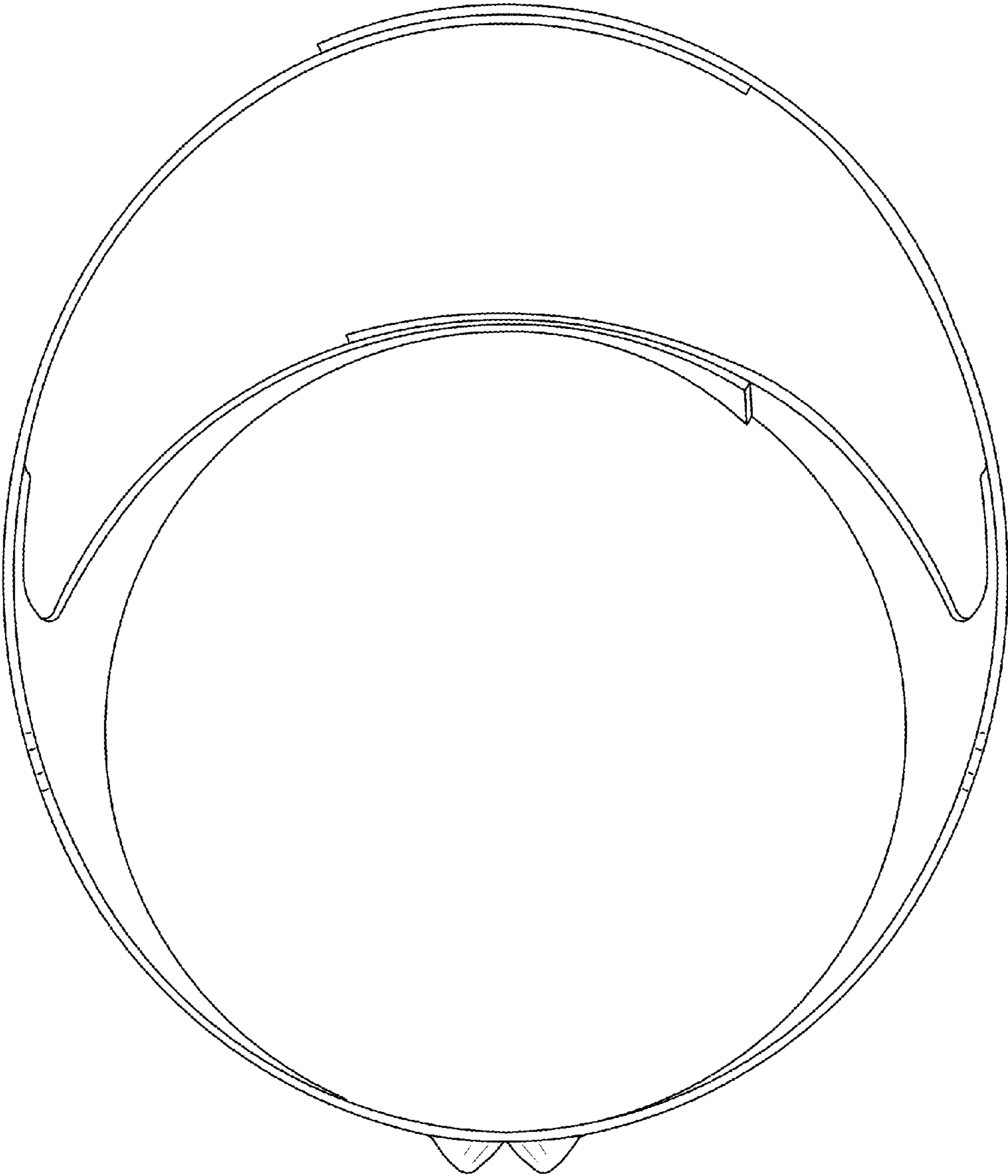

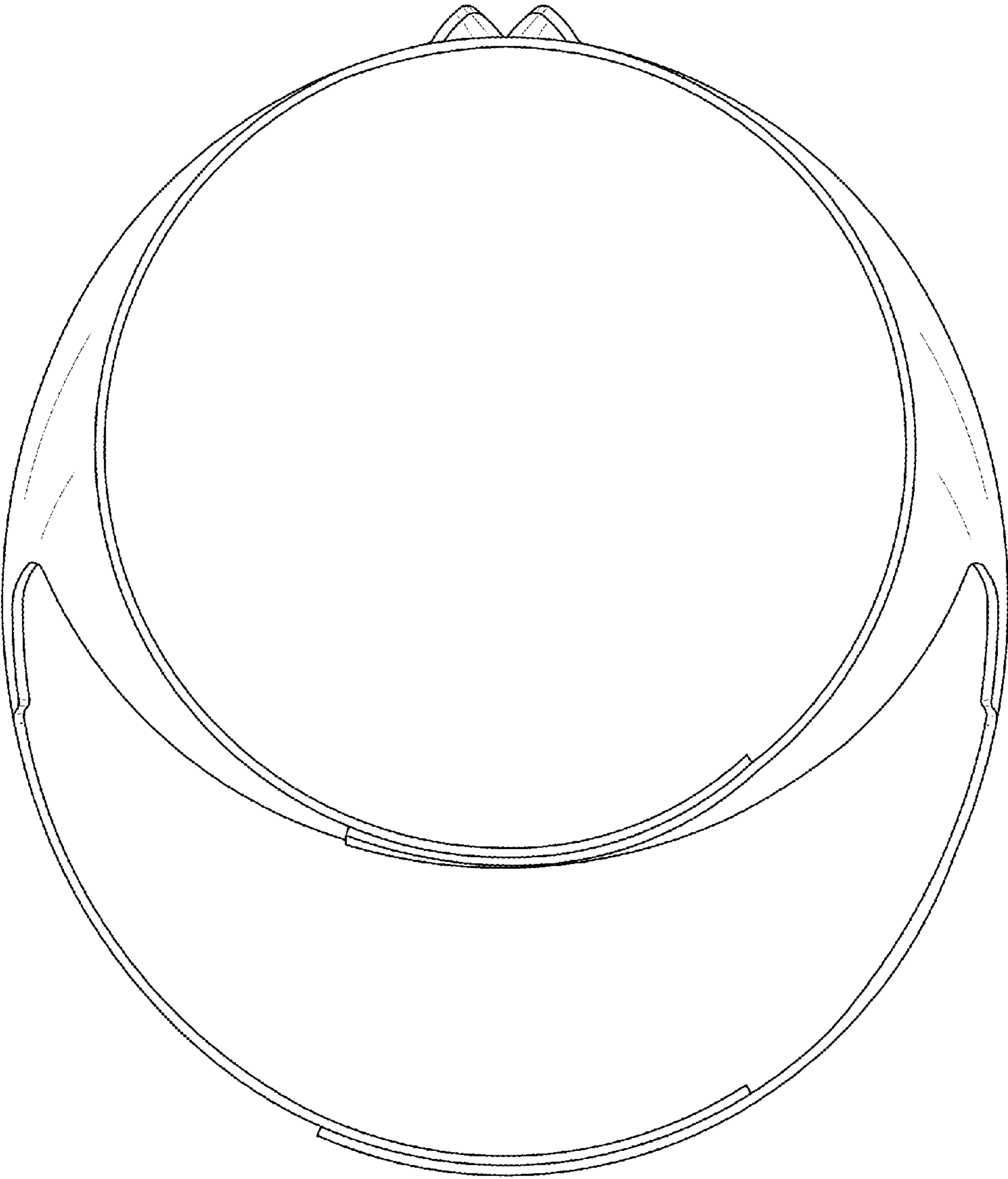

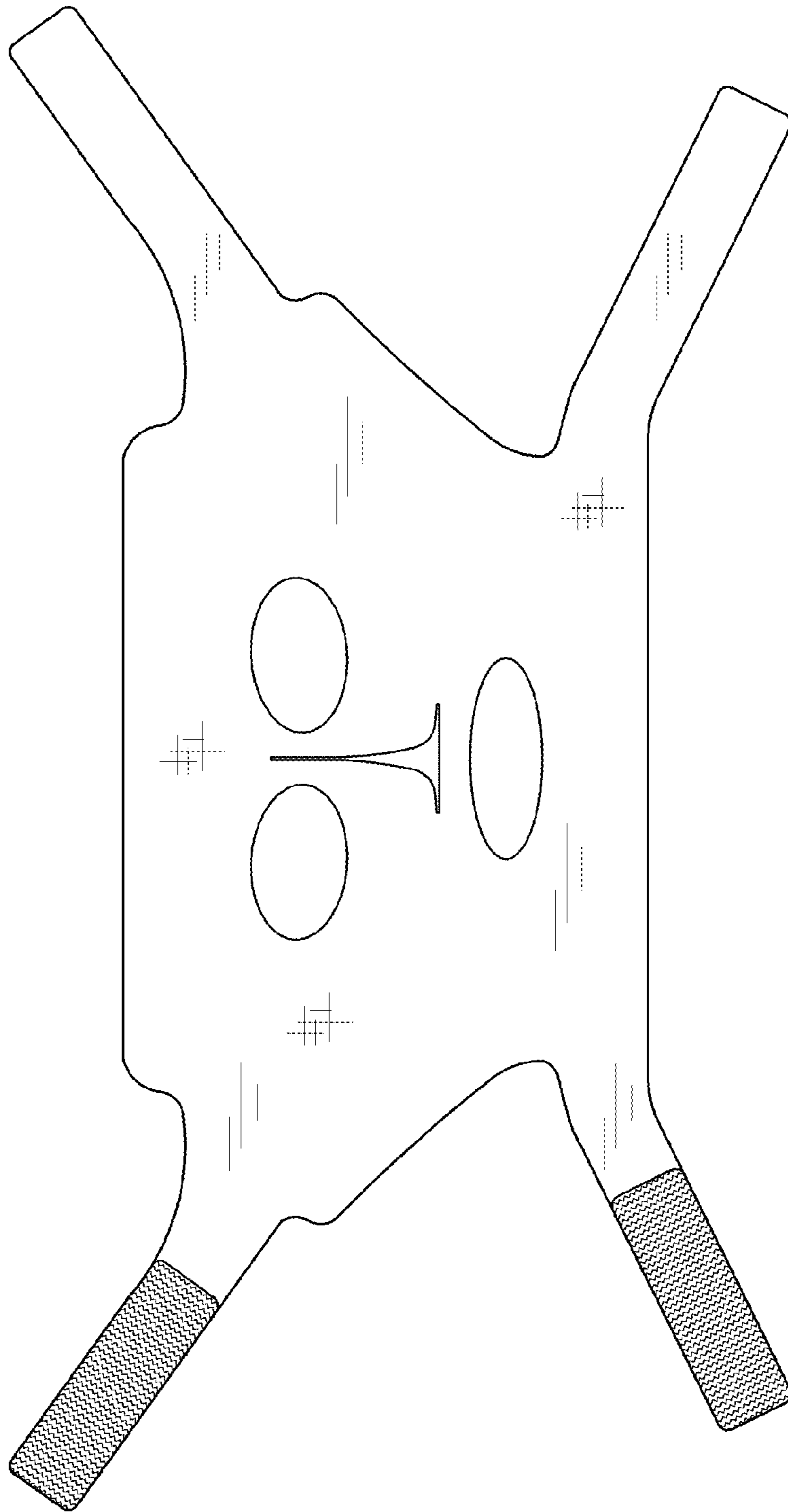

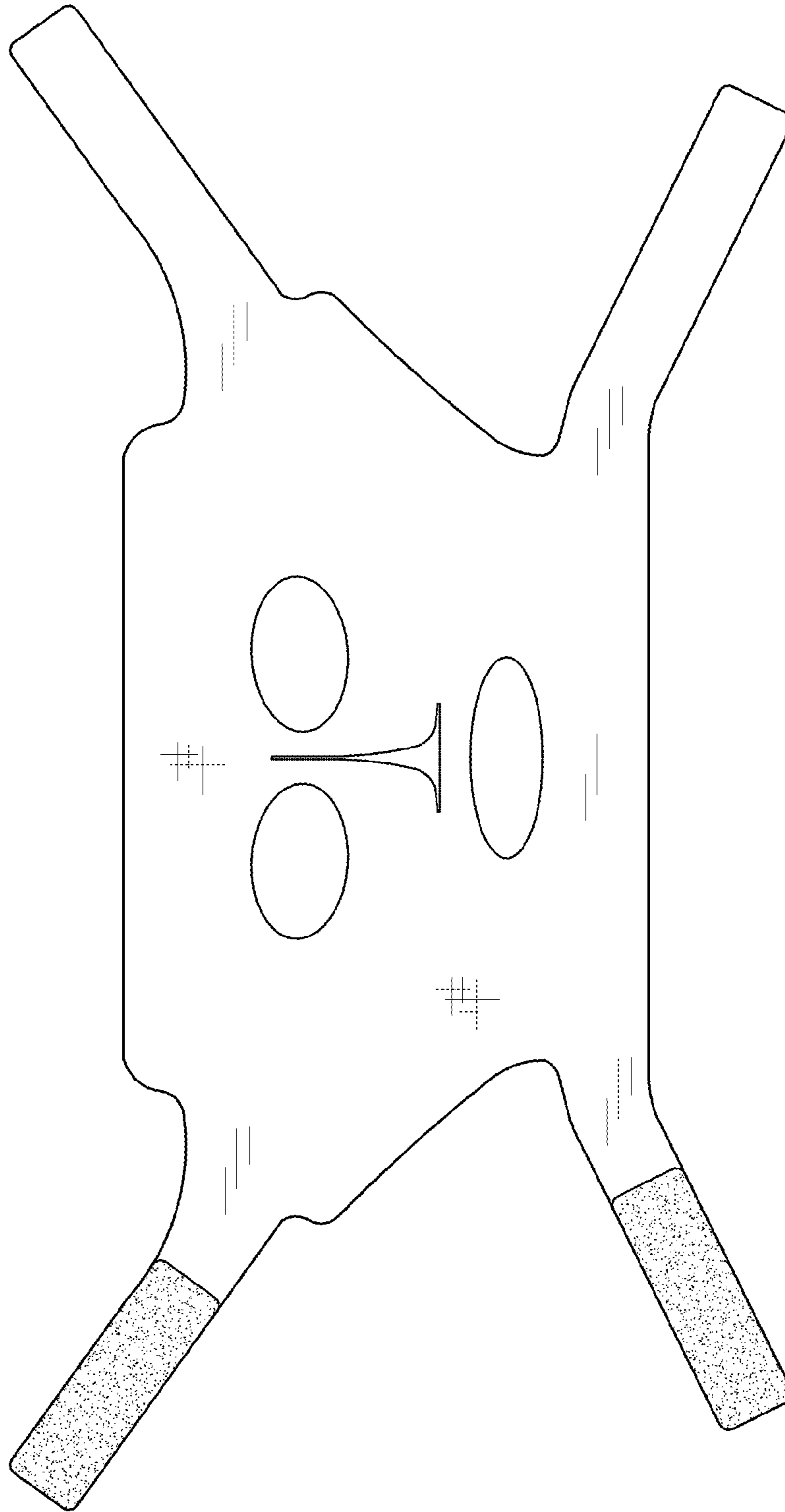
