We claim the ornamental design for a light-emitting diode lamp, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a light-emitting diode lamp of the present invention;

FIG. 2 is a front view thereof;

FIG. 4 is a first side view thereof;

FIG. 5 is a second side view thereof;

FIG. 6 is a top view thereof; and,

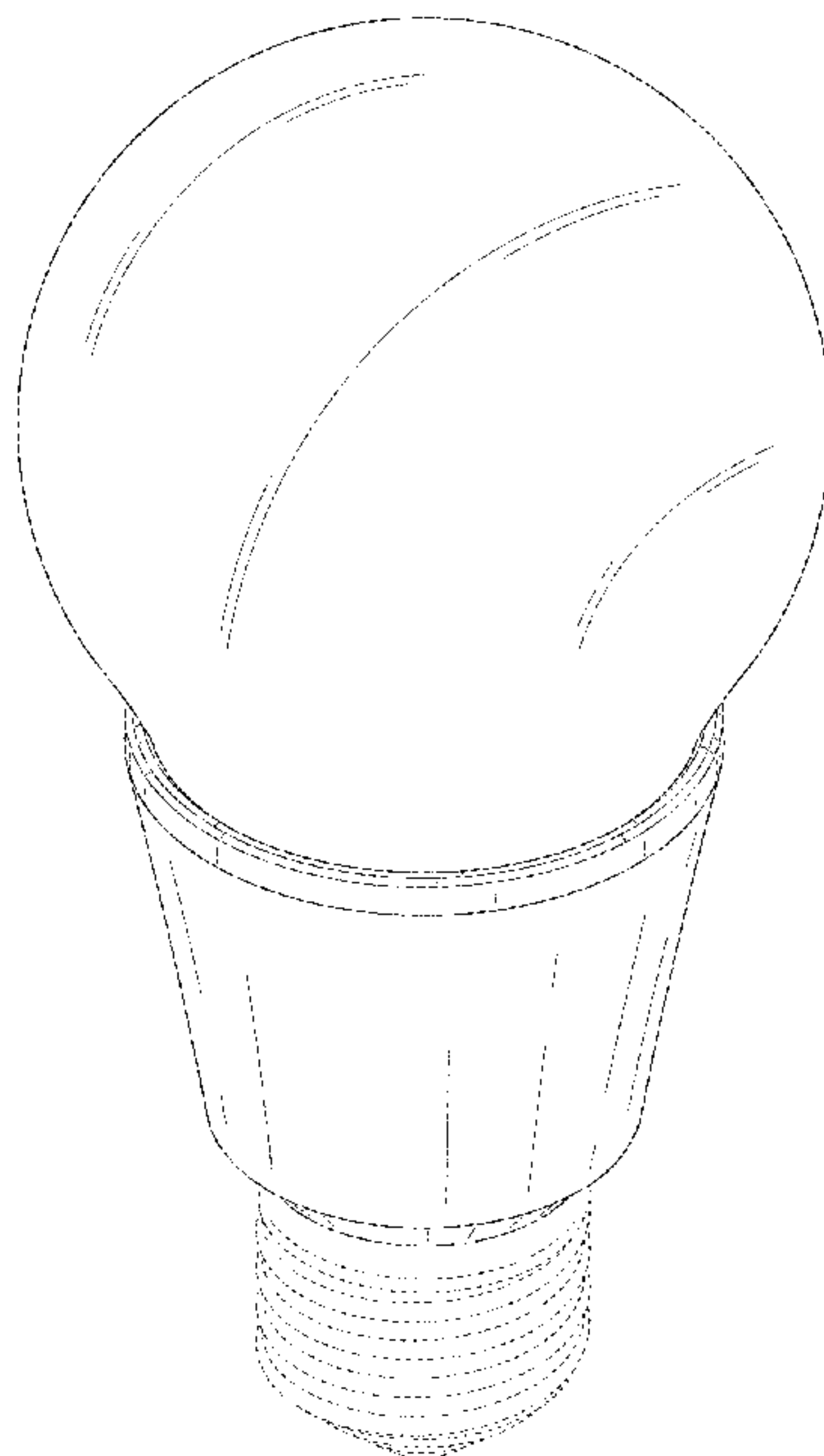

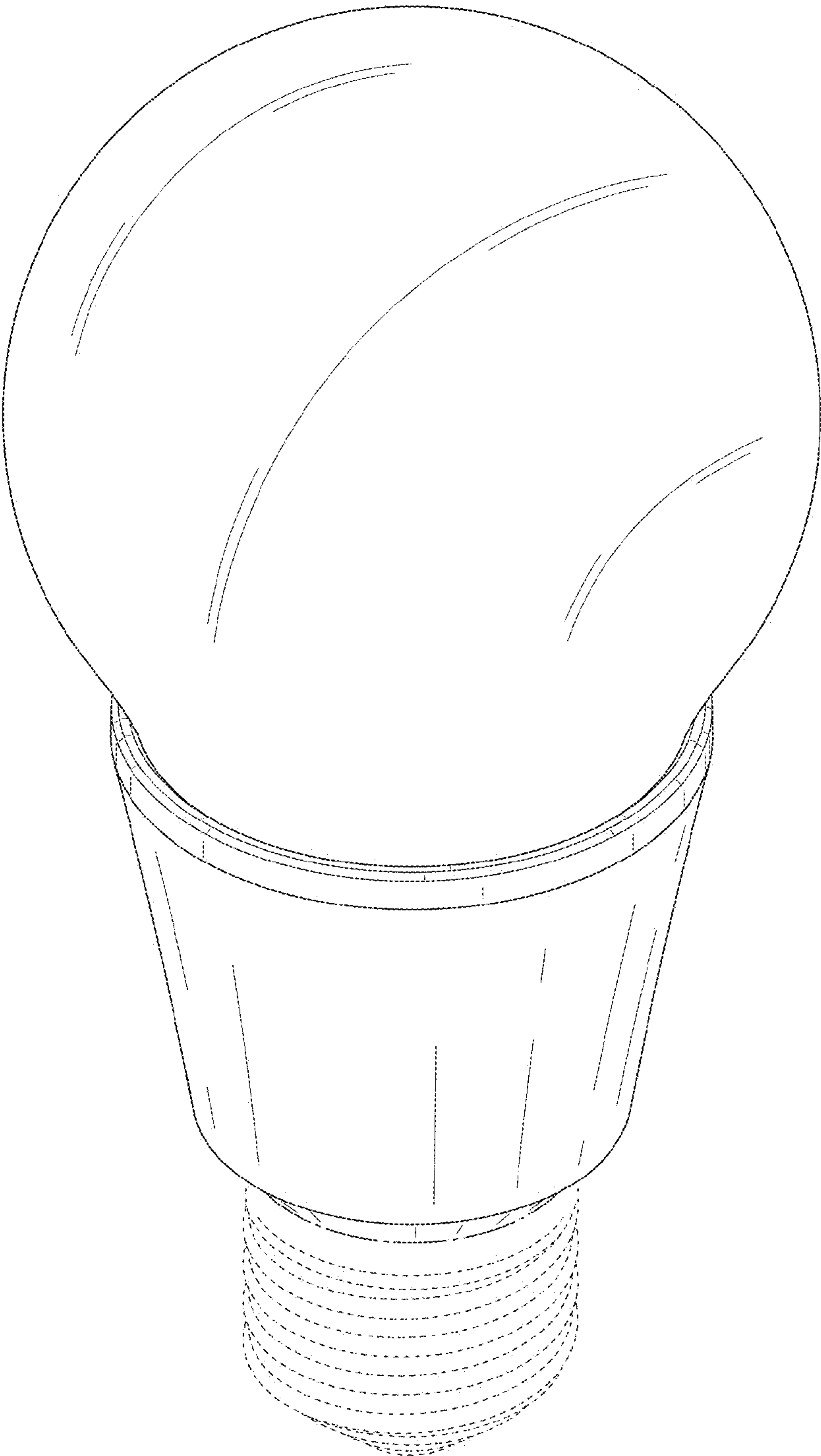

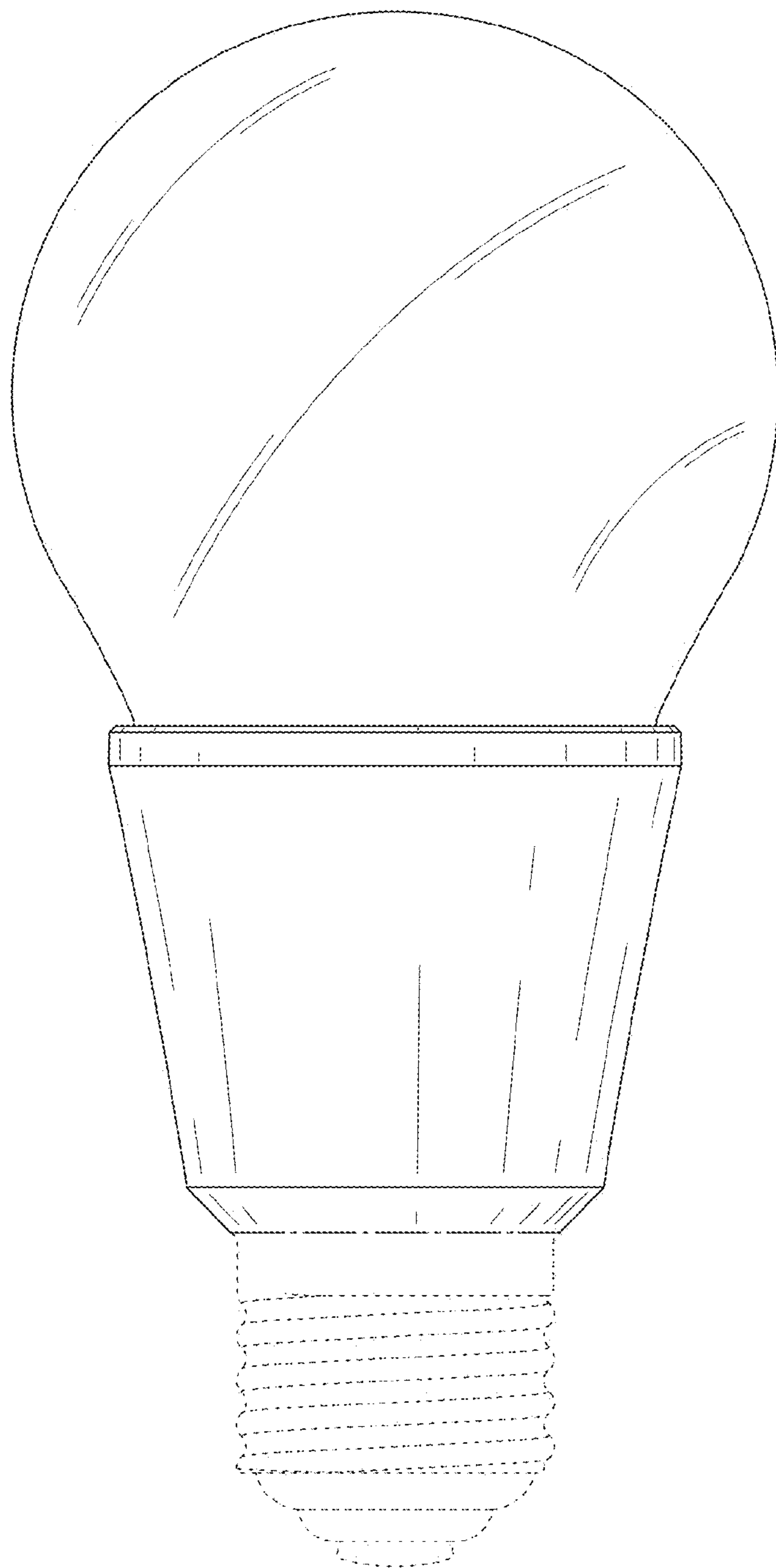

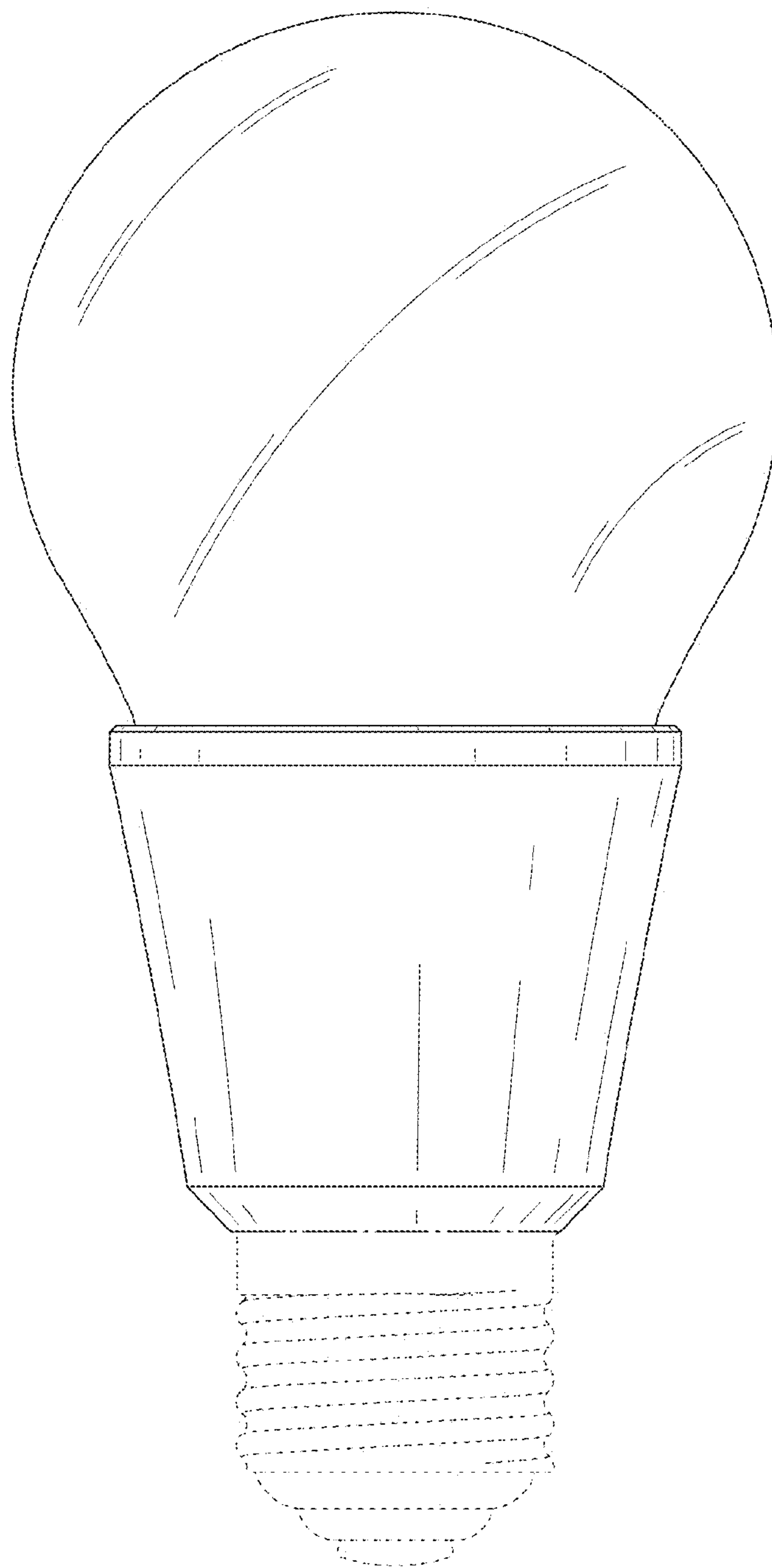

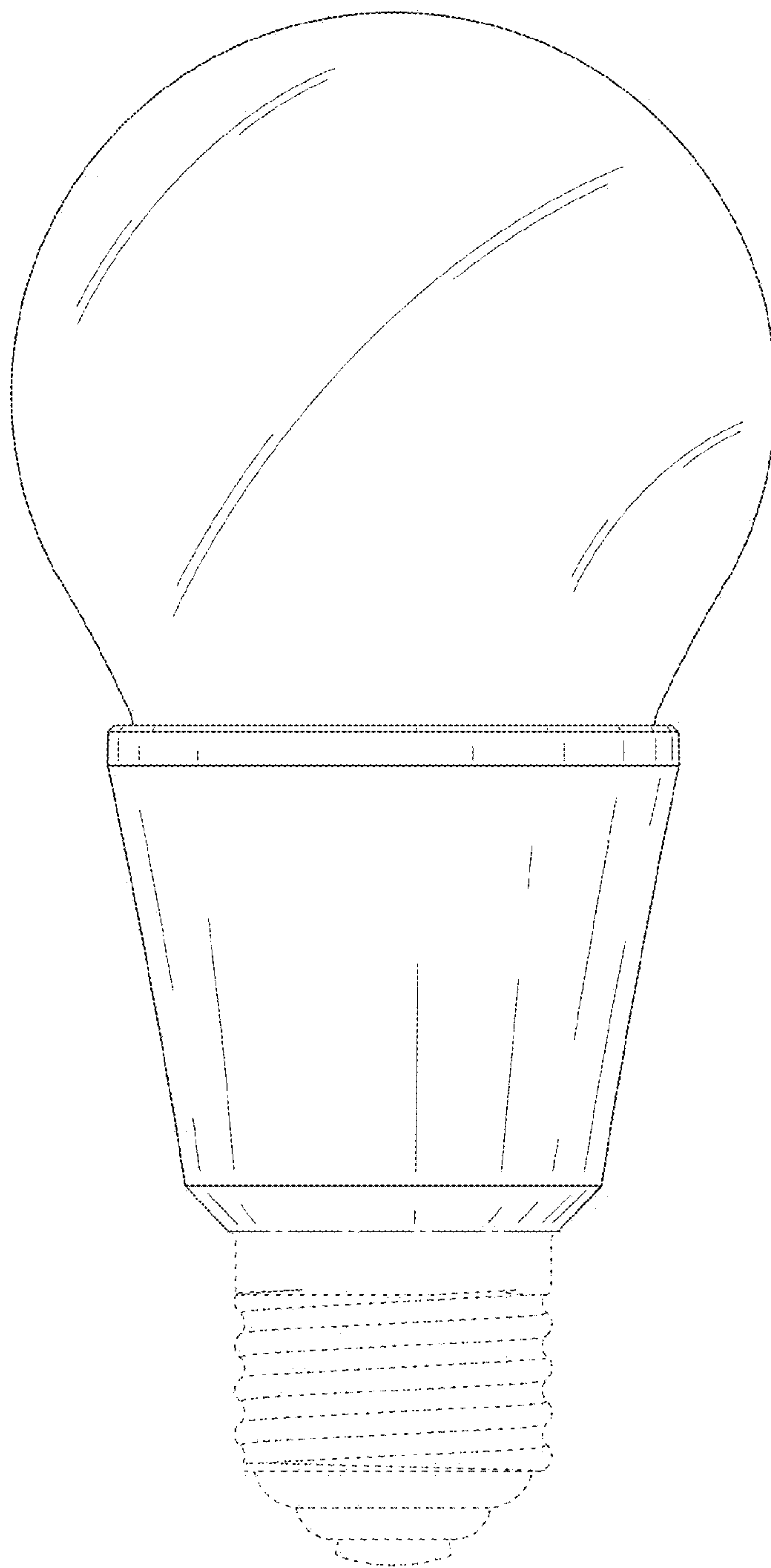

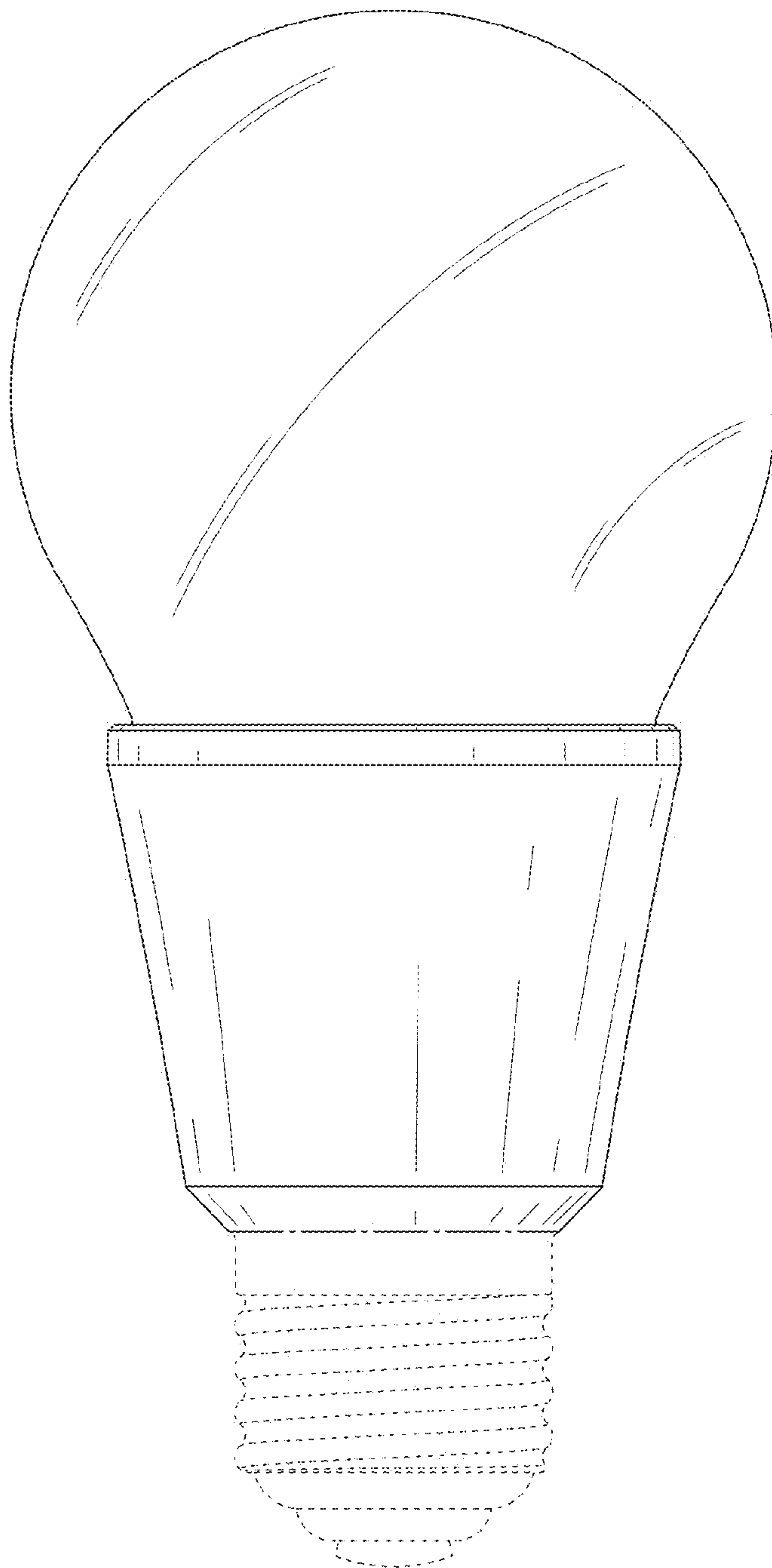

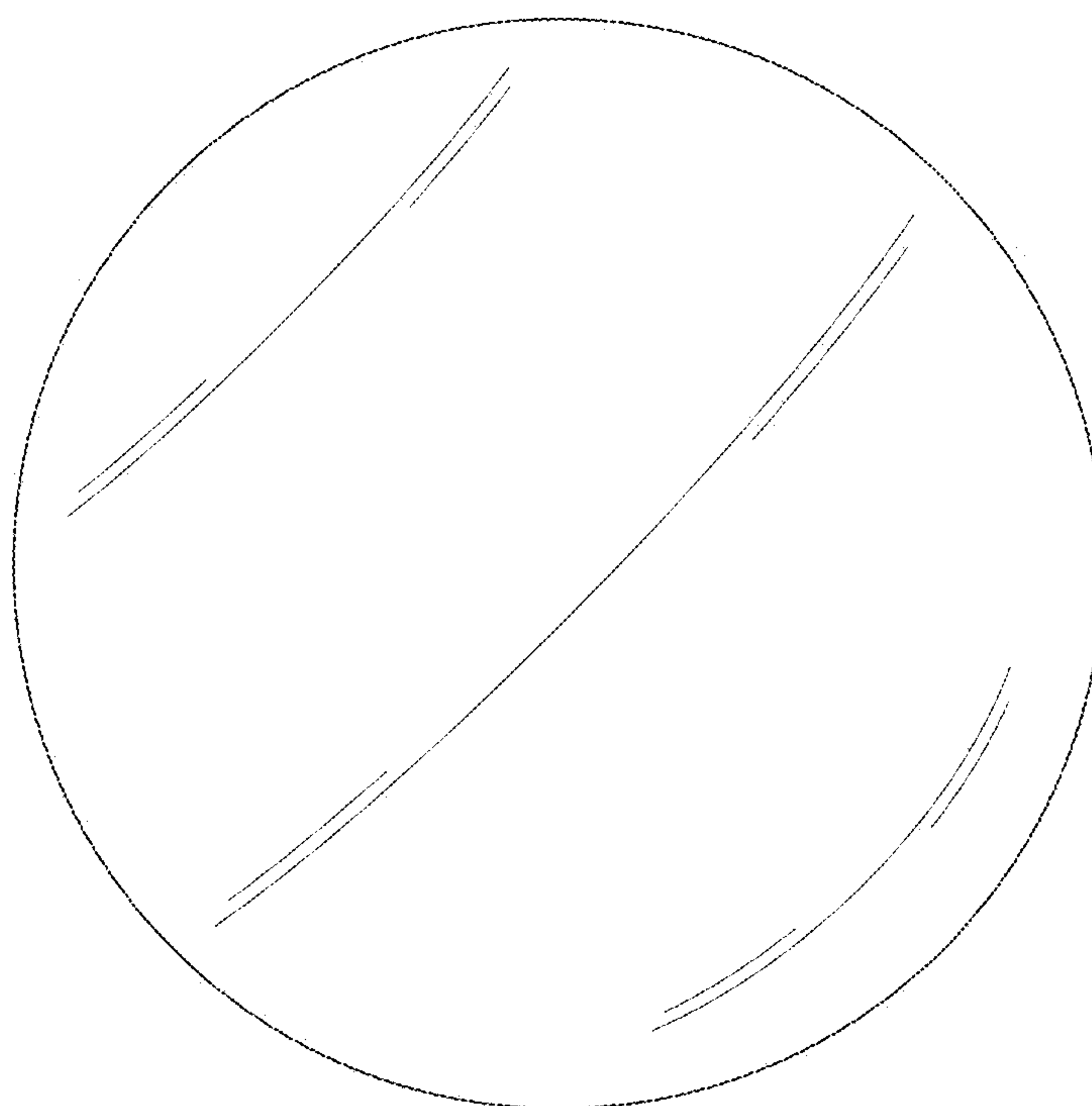
