**DESCRIPTION**

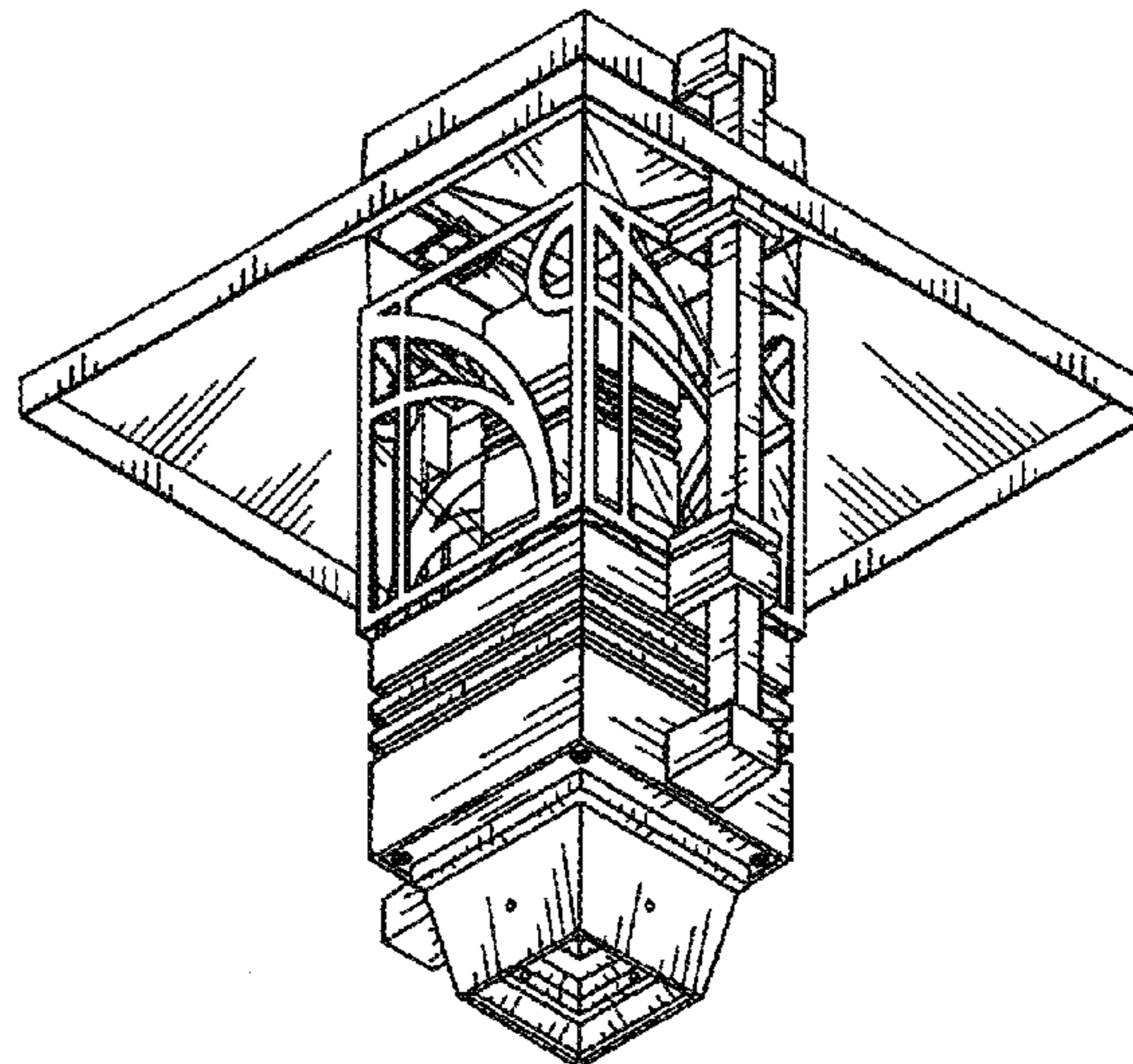
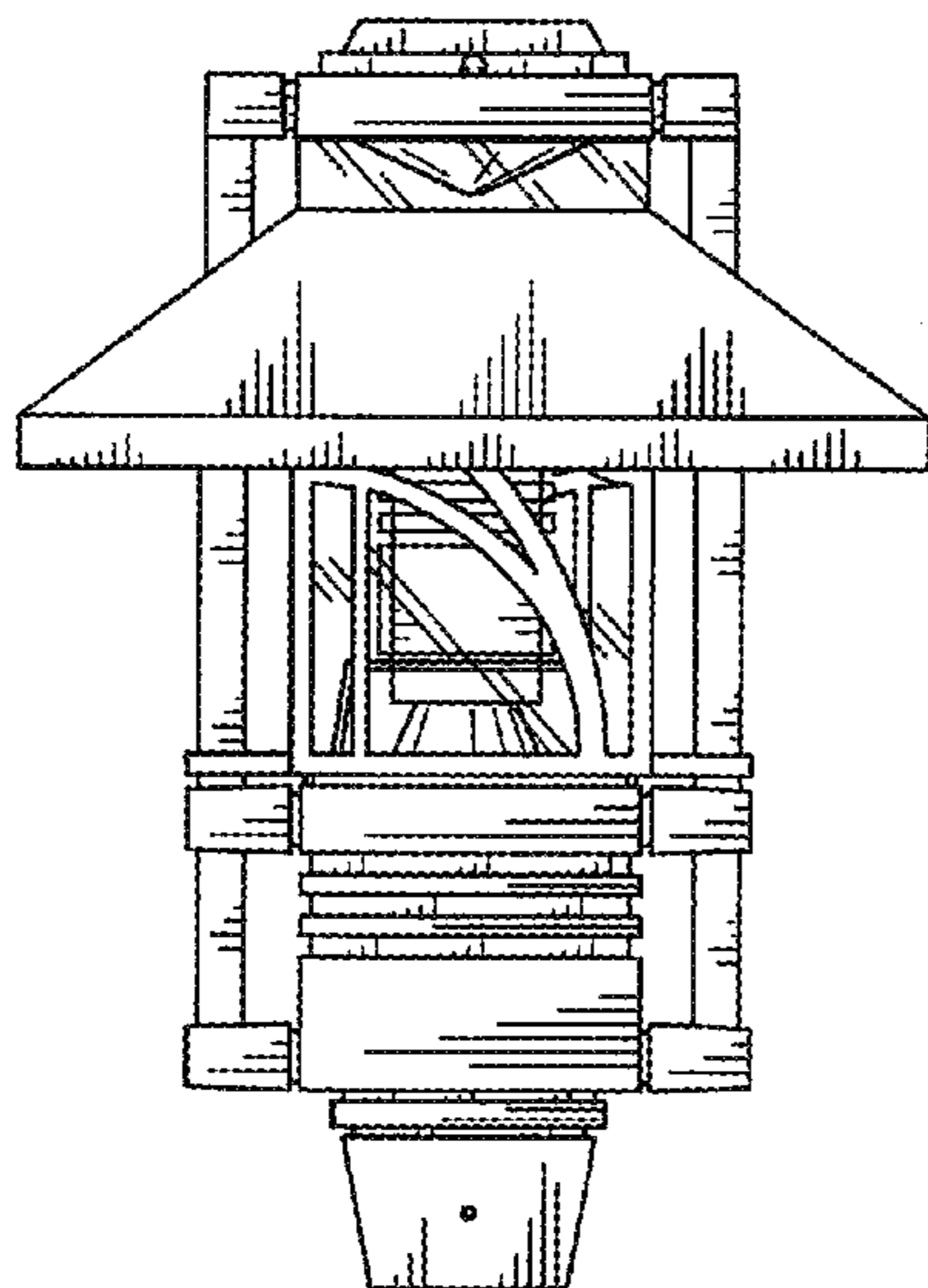
FIG. 1 is a top plan view of a lighting fixture having struts; FIG. 2 is a top perspective view of the lighting fixture illustrated in FIG. 1; FIG. 3 is a front elevational view of the lighting fixture illustrated in FIGS. 1 and 2, the back elevational view being the same; FIG. 4 is a left side elevational view of the lighting fixture illustrated in FIGS. 1-3, the right side being the same; FIG. 5 is a bottom plan view of the lighting fixture illustrated in FIGS. 1-4; and, FIG. 6 is a bottom perspective view of the lighting fixture illustrated in FIGS. 1-5.

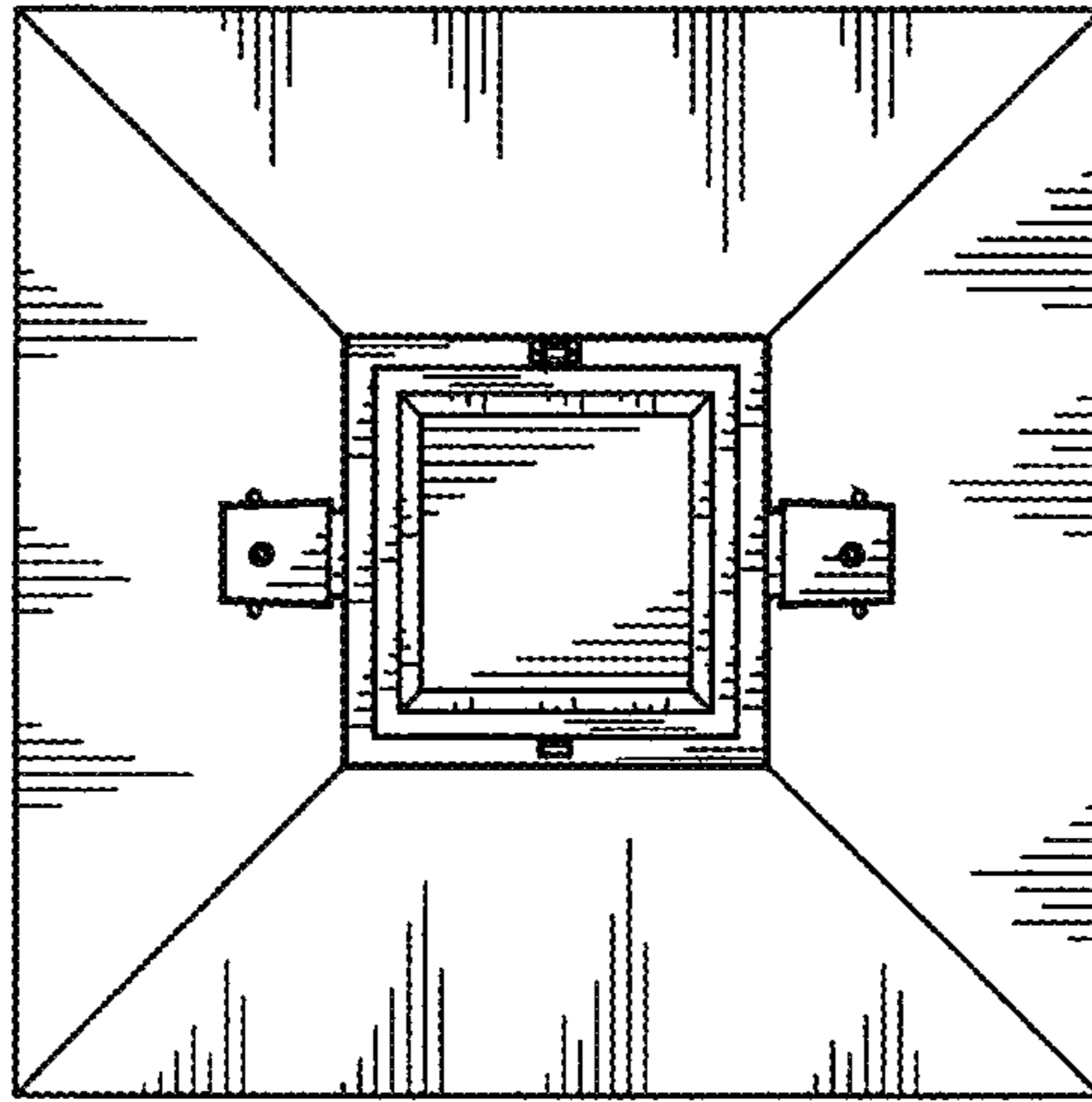

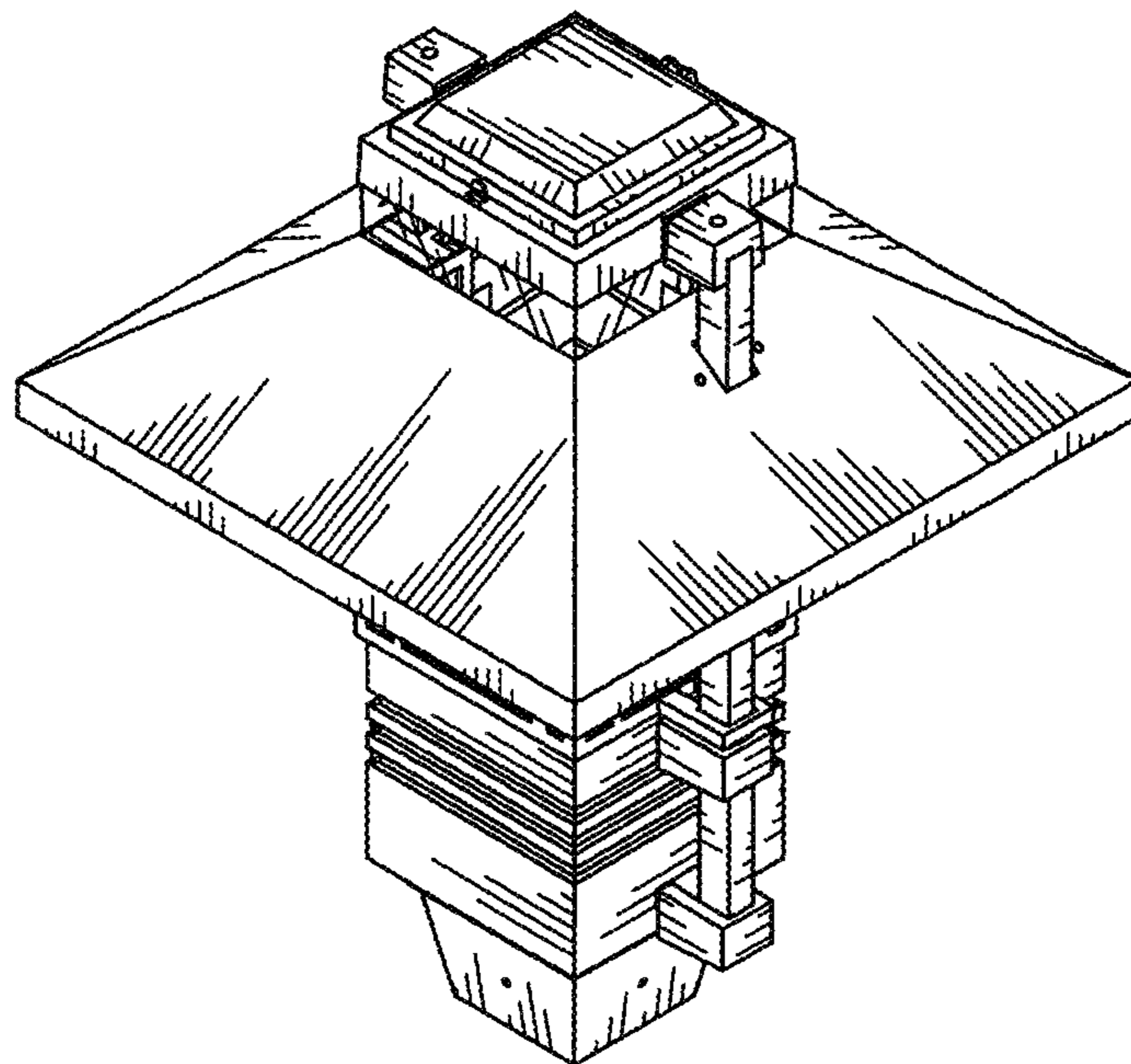

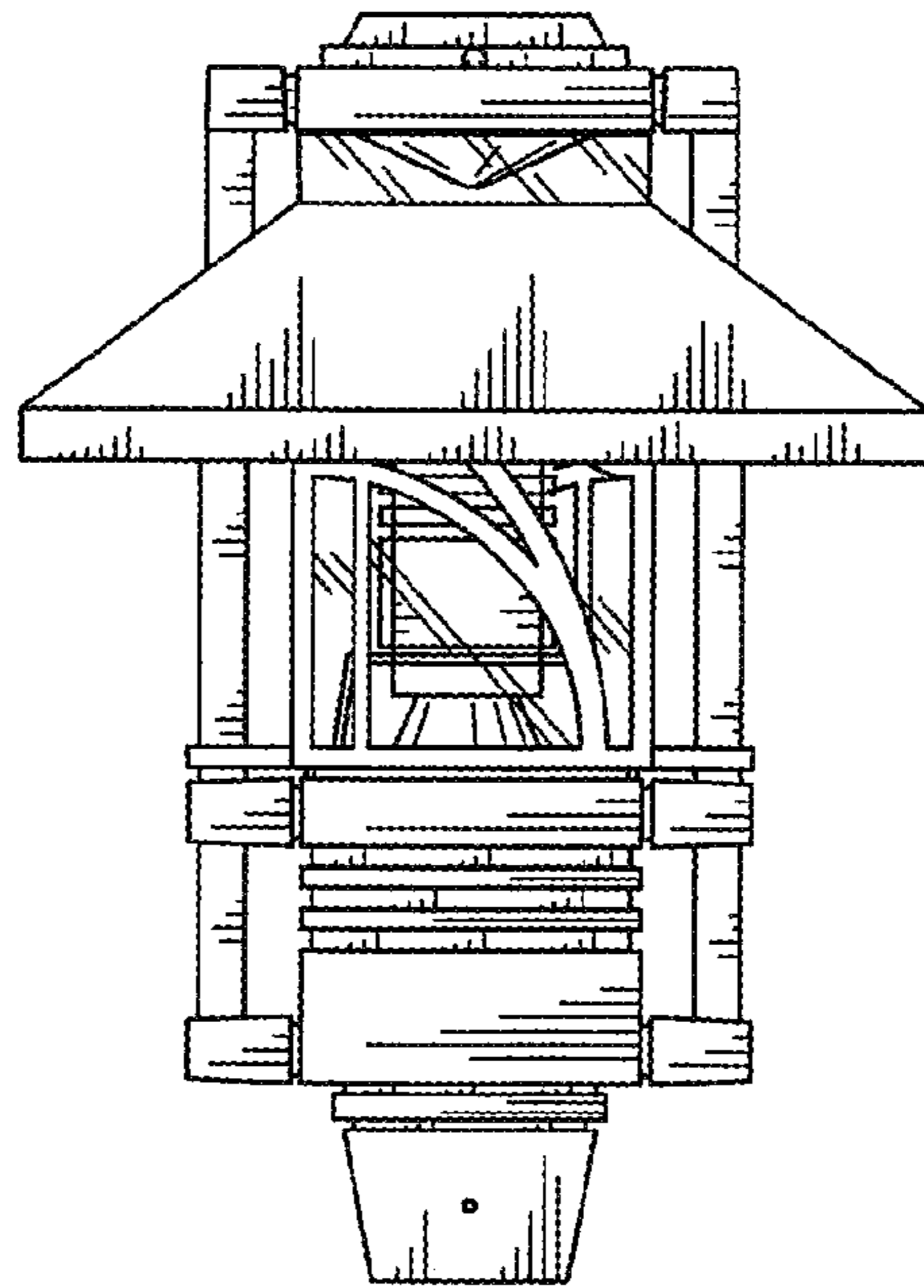

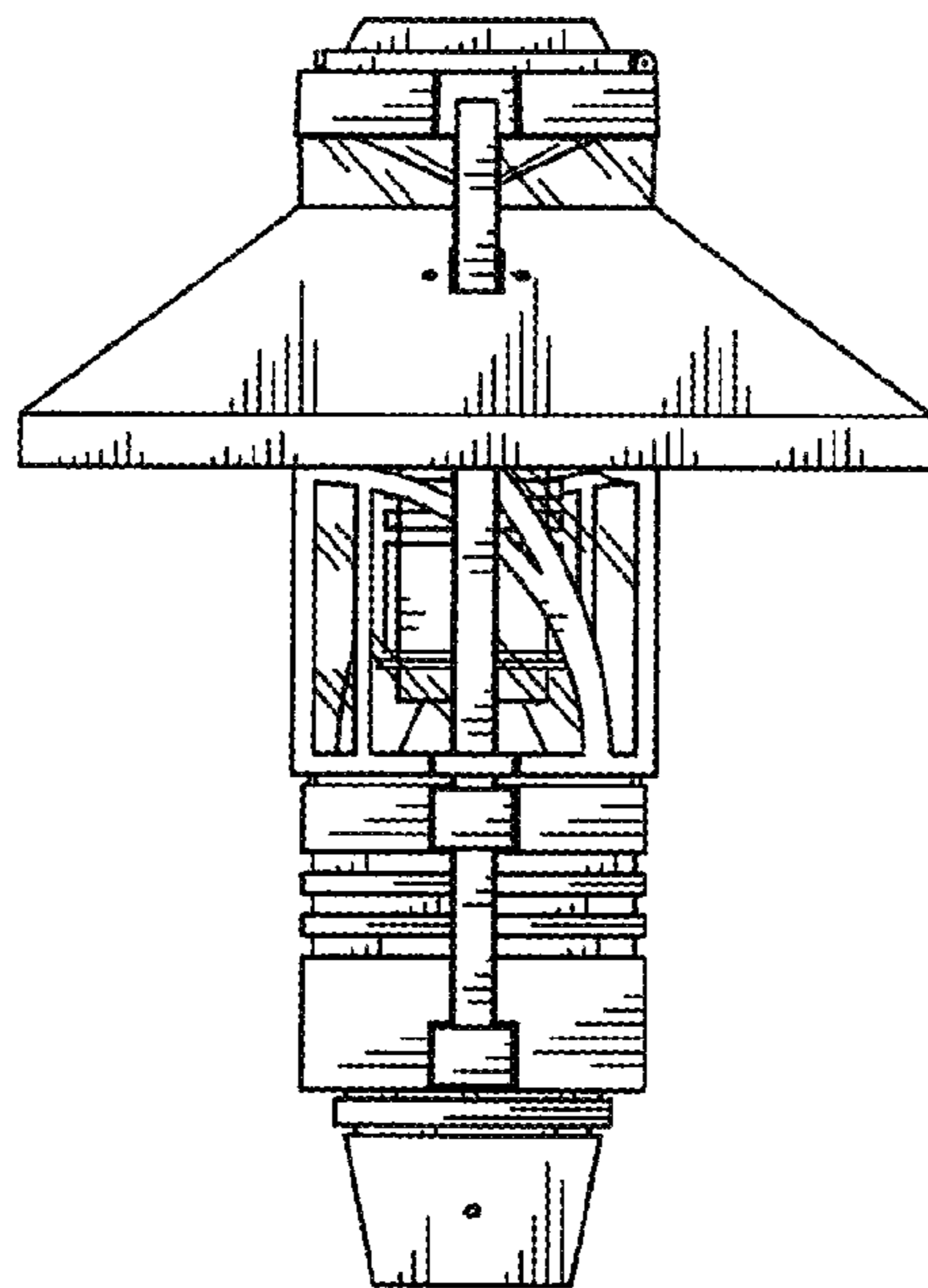

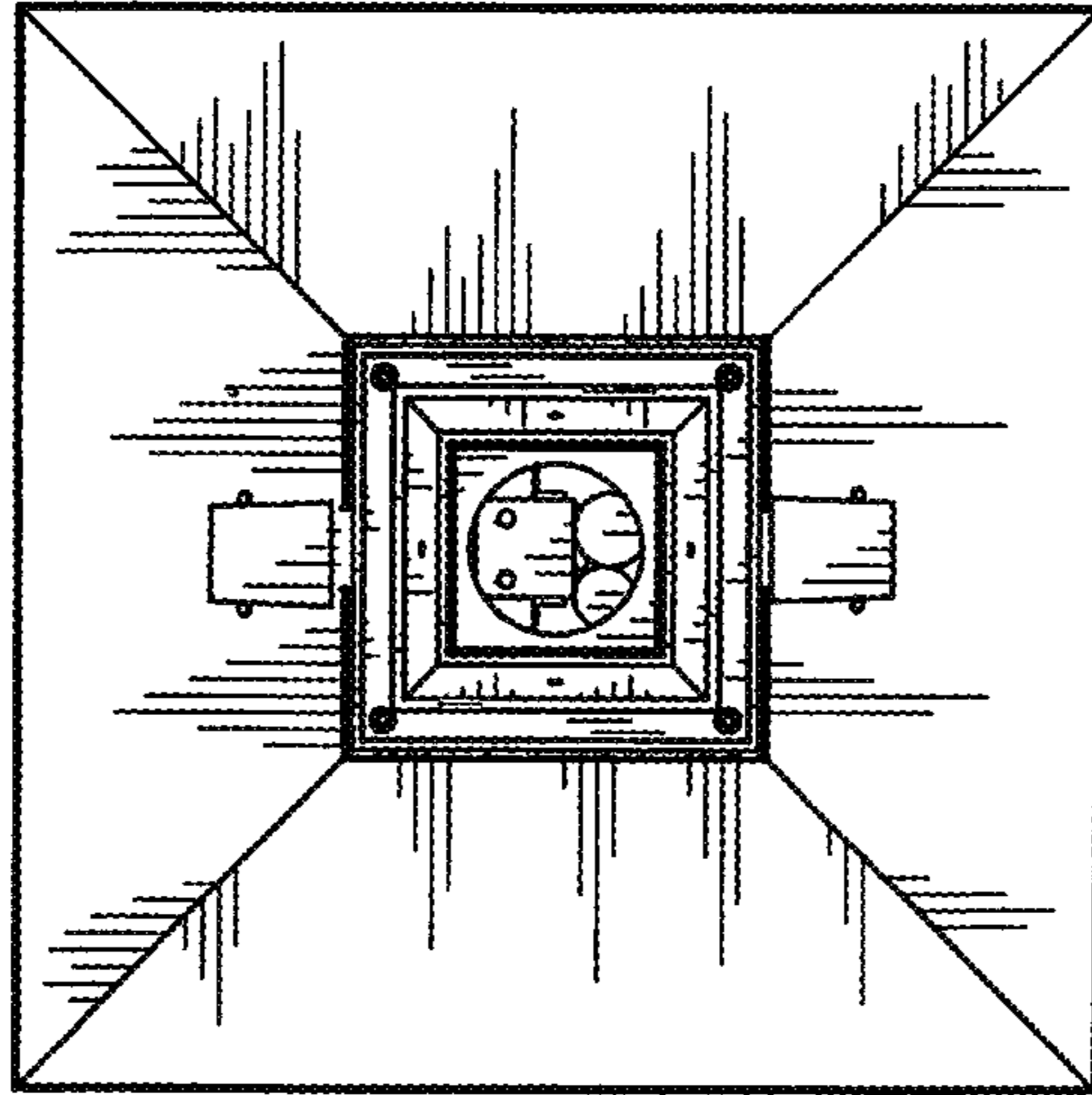

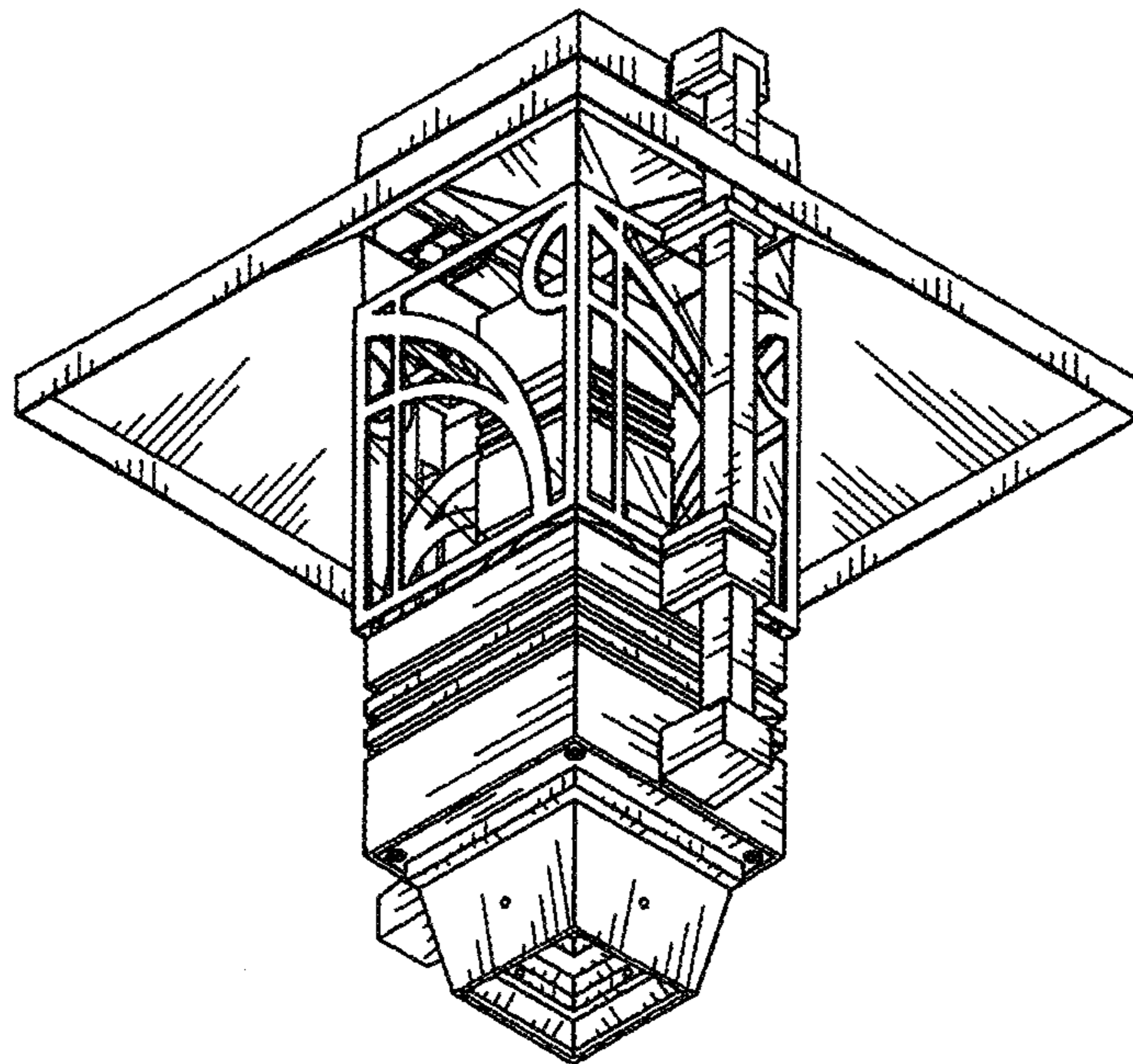
