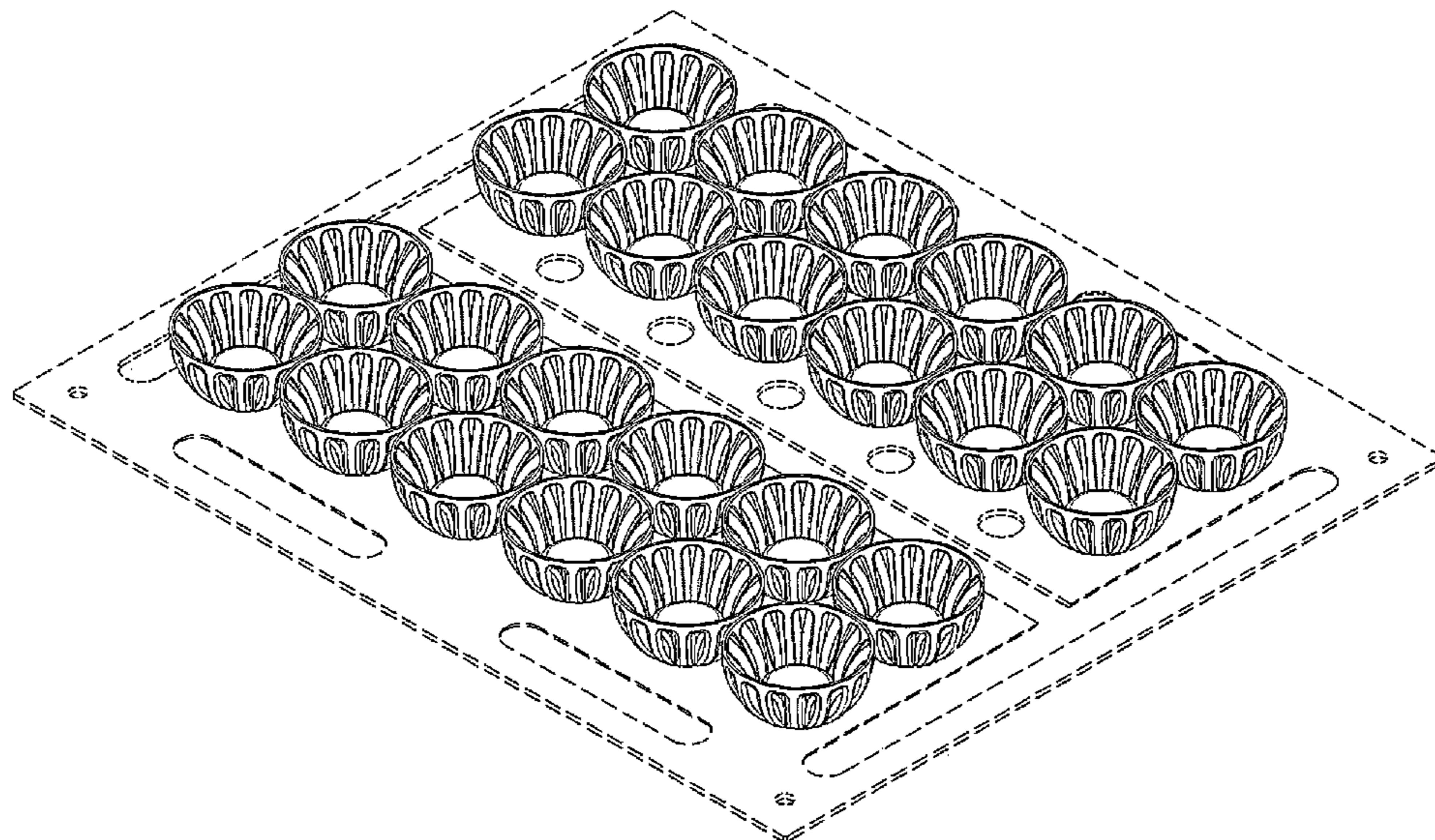
(57) **CLAIM**

I claim the ornamental design for a heat sink of a lamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a heat sink of a lamp showing my new design;  
FIG. 2 is a right side elevational view thereof, with the left side elevational view being a mirror image thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a front elevational view thereof, with the rear elevational view being a mirror image thereof; and,  
FIG. 5 is a bottom plan view of the embodiment.  
The broken lines in the drawings illustrate portions of the heat sink of a lamp which form no part of the claimed design.

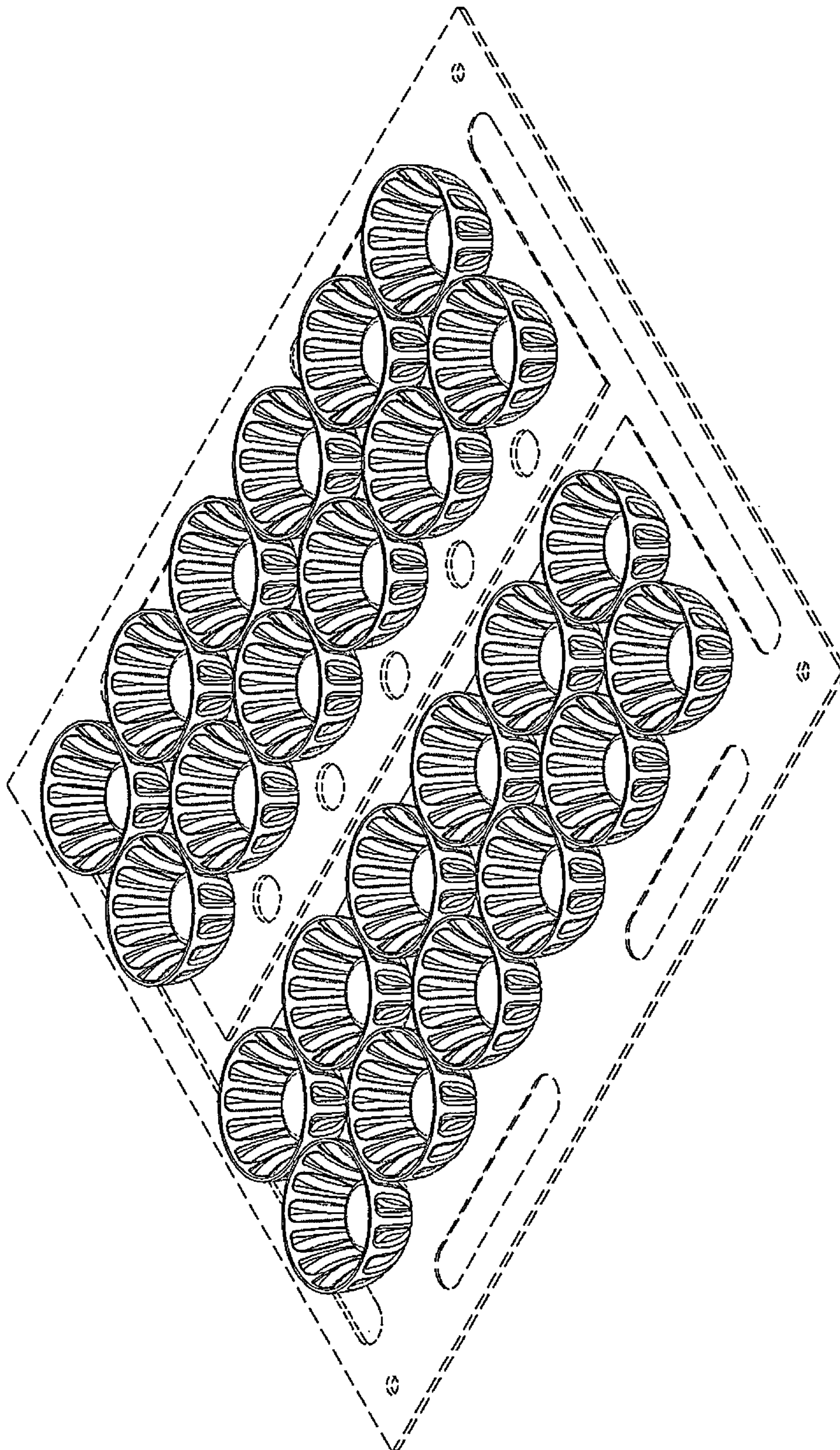

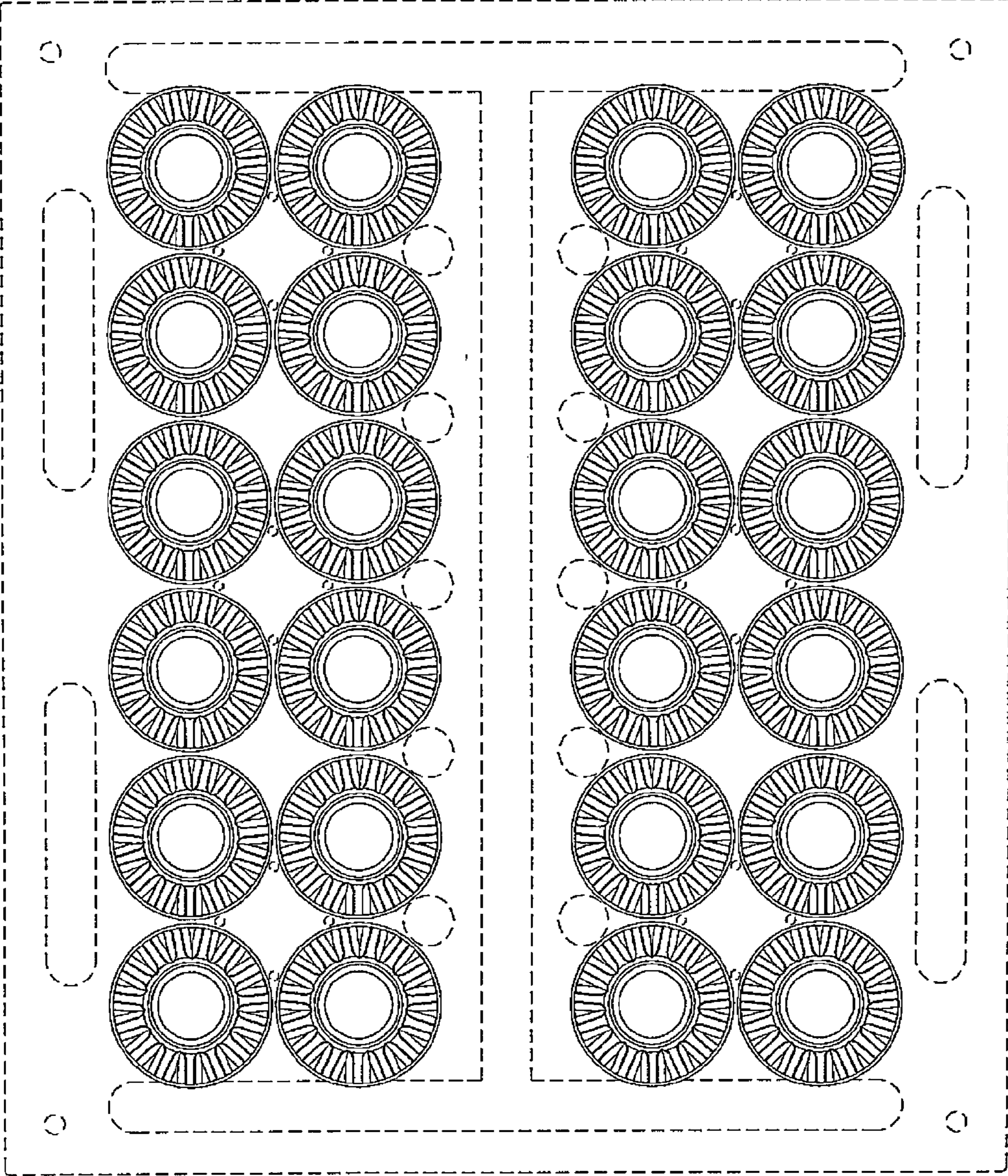

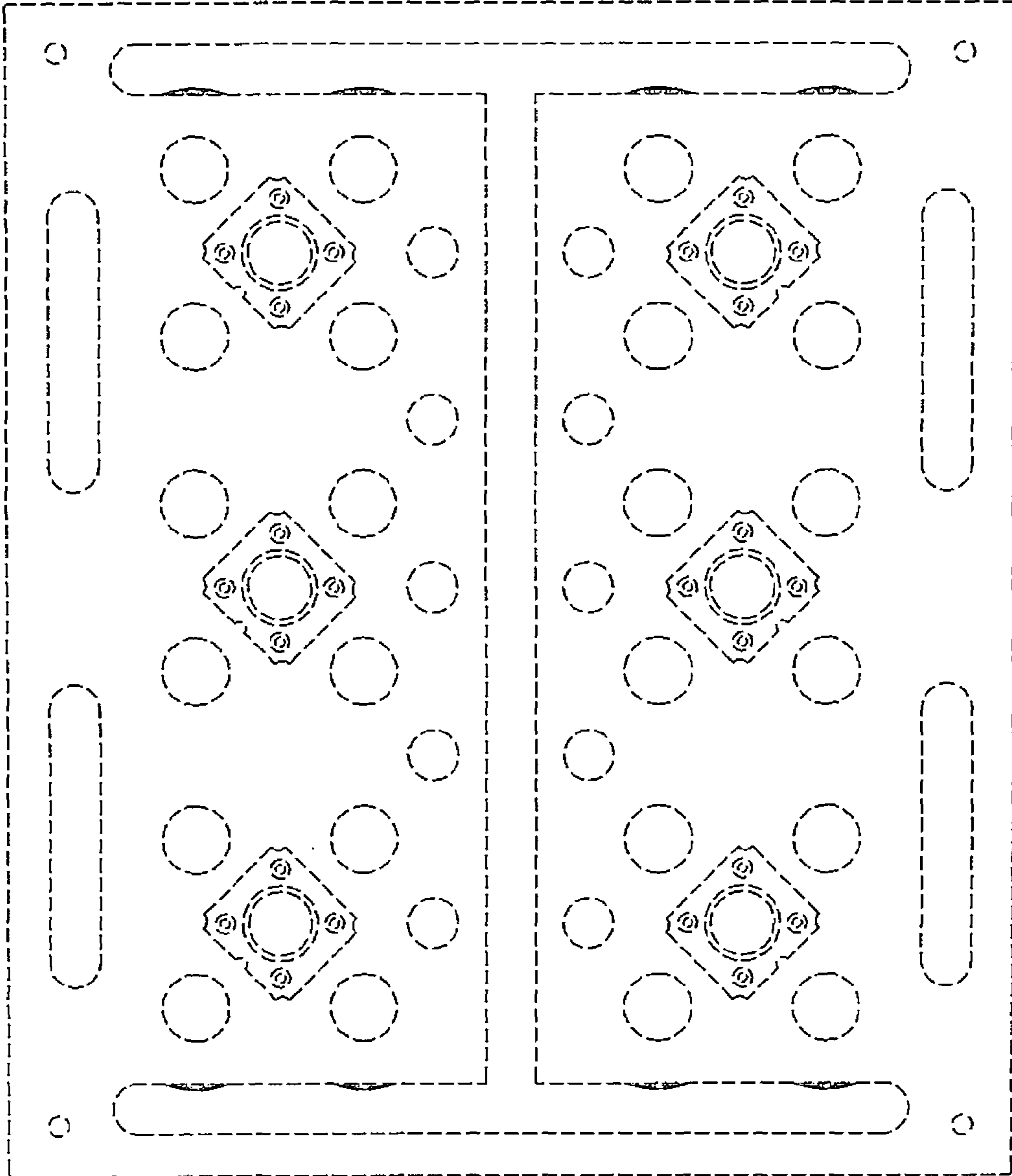
