DESCRIPTION

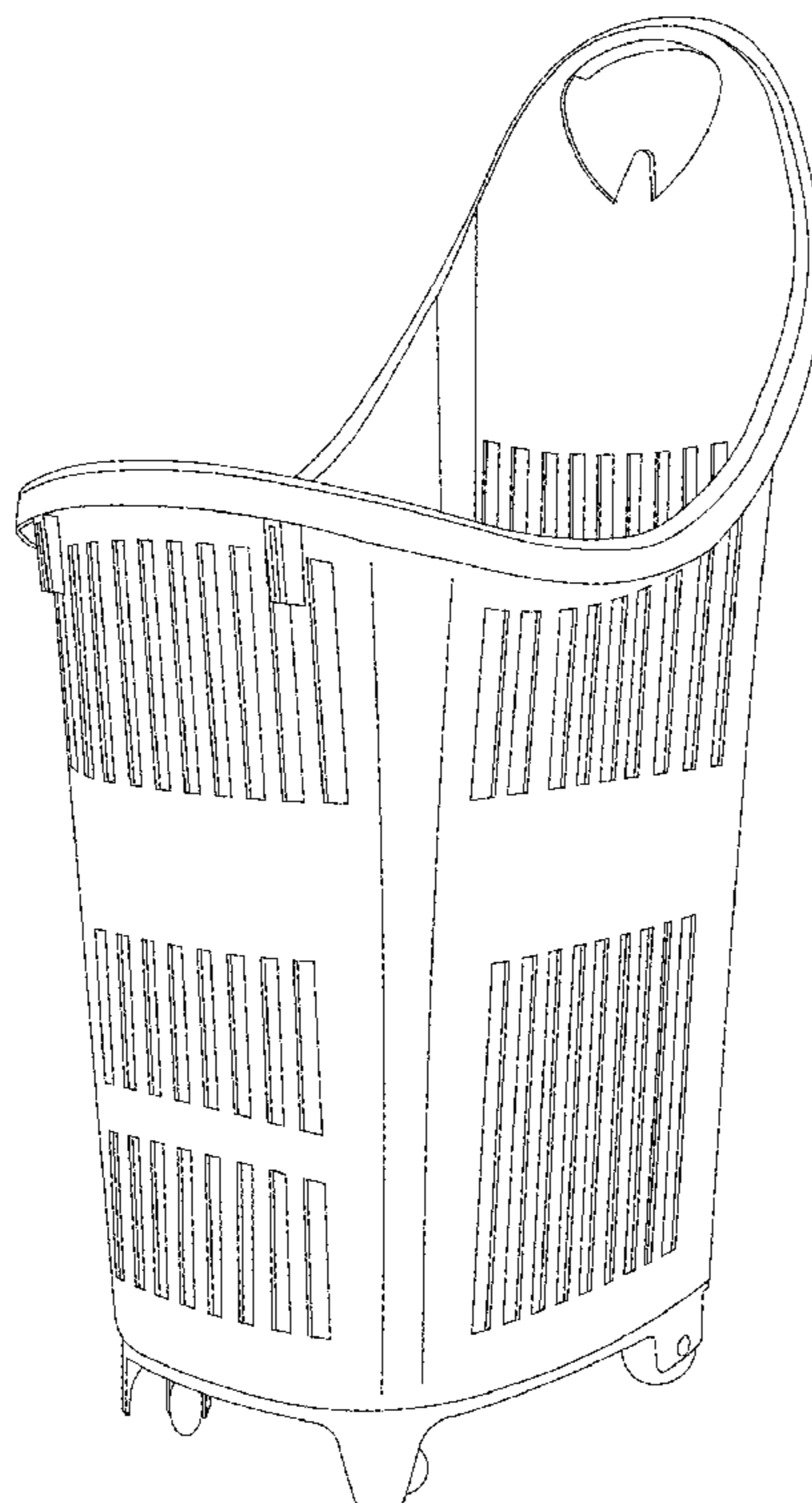
FIG. 1 is a perspective view of a design of the shopping basket; and

FIG. 2 is a front elevation view of the design of the shopping basket of FIG. 1;

FIG. 3. is a rear elevation view of the design of the shopping basket of FIG. 1; and,

FIG. 4 is a side elevation view of the design of the shopping basket of FIG. 1, with the second side elevation view being the mirror image of FIG. 1.

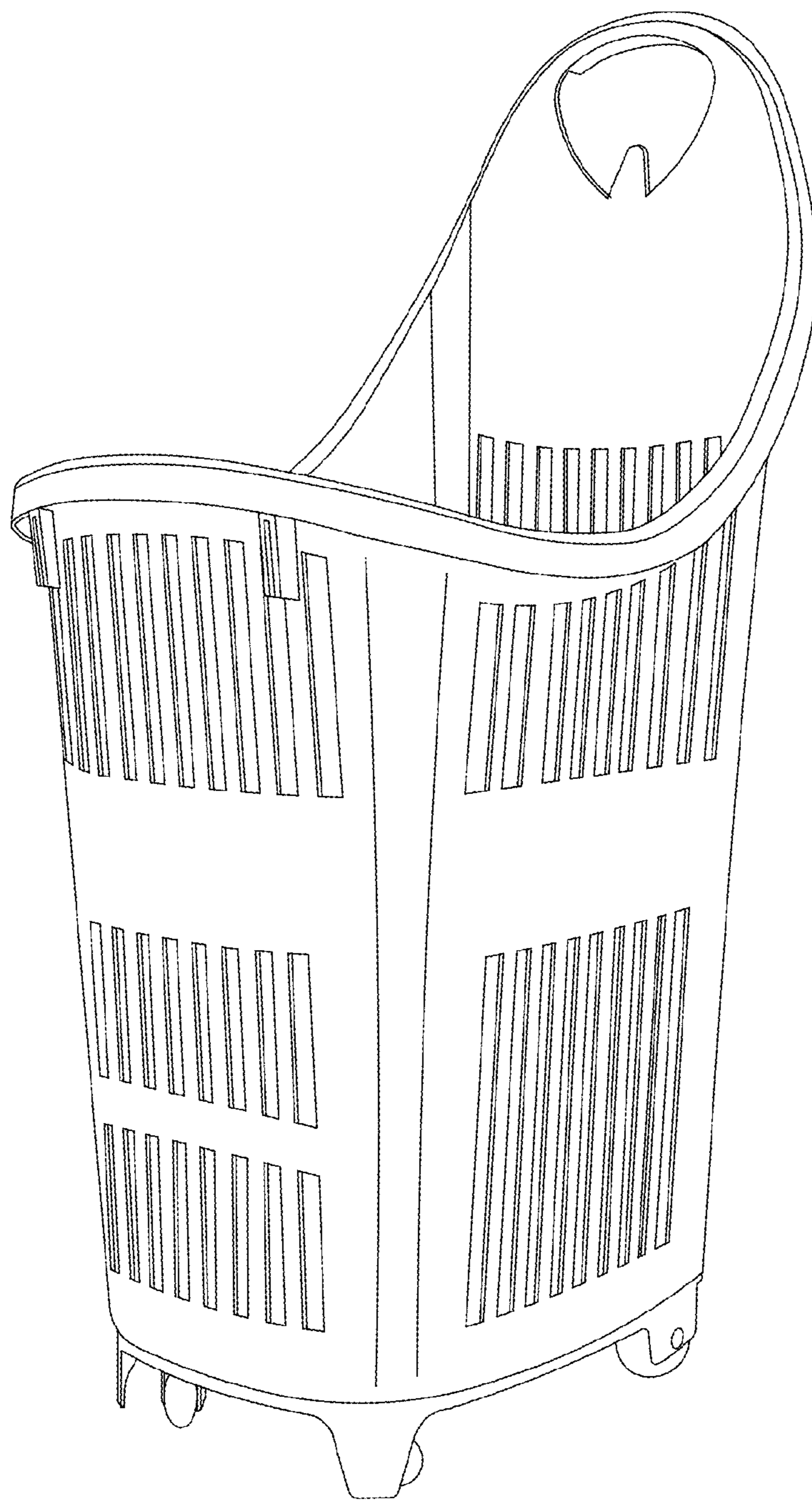

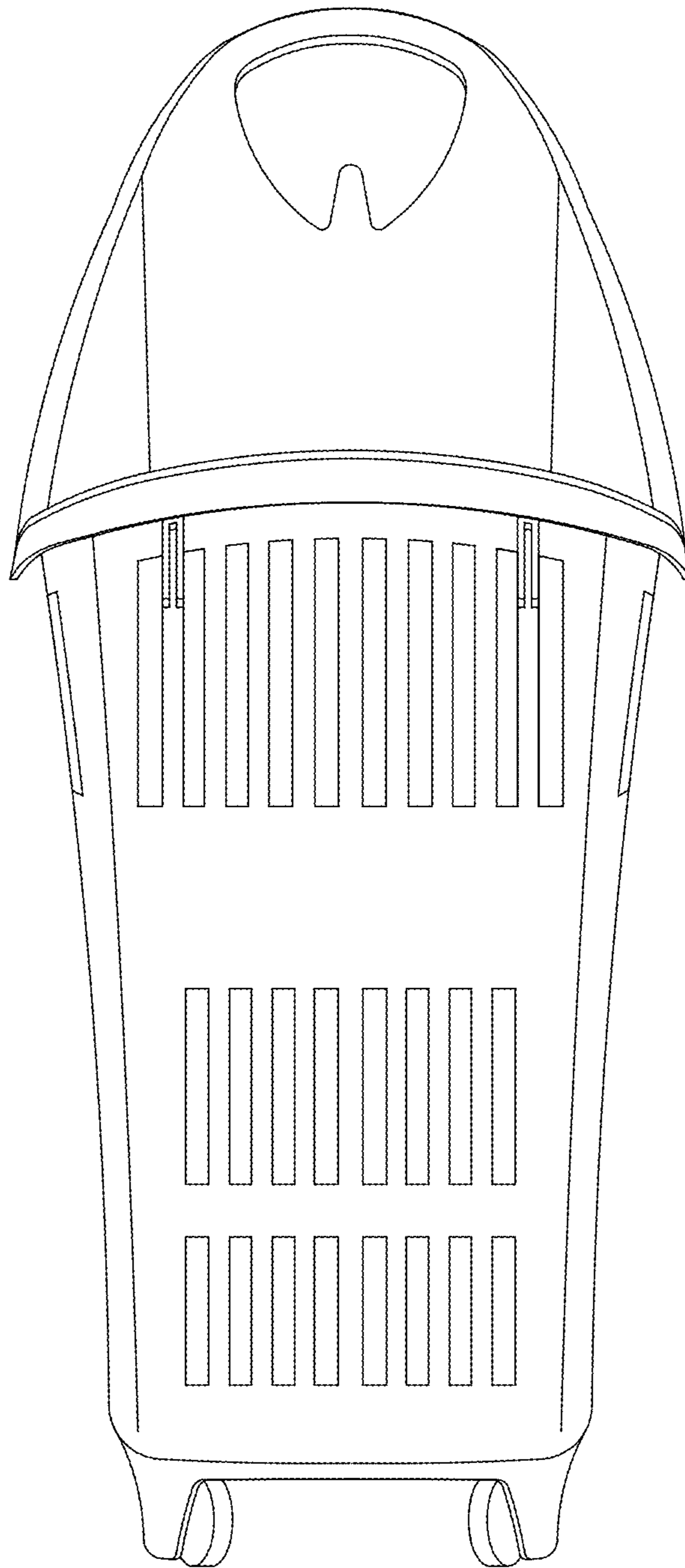

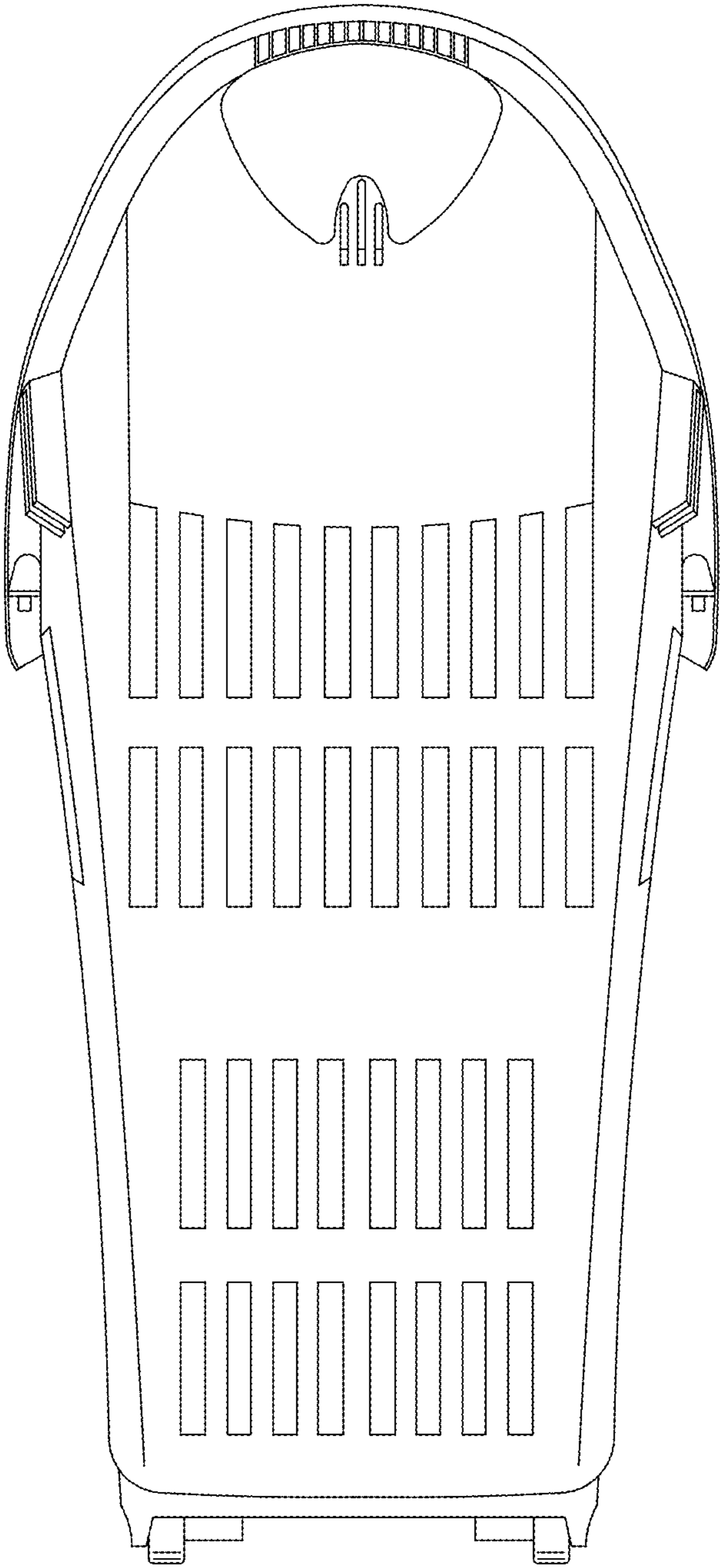

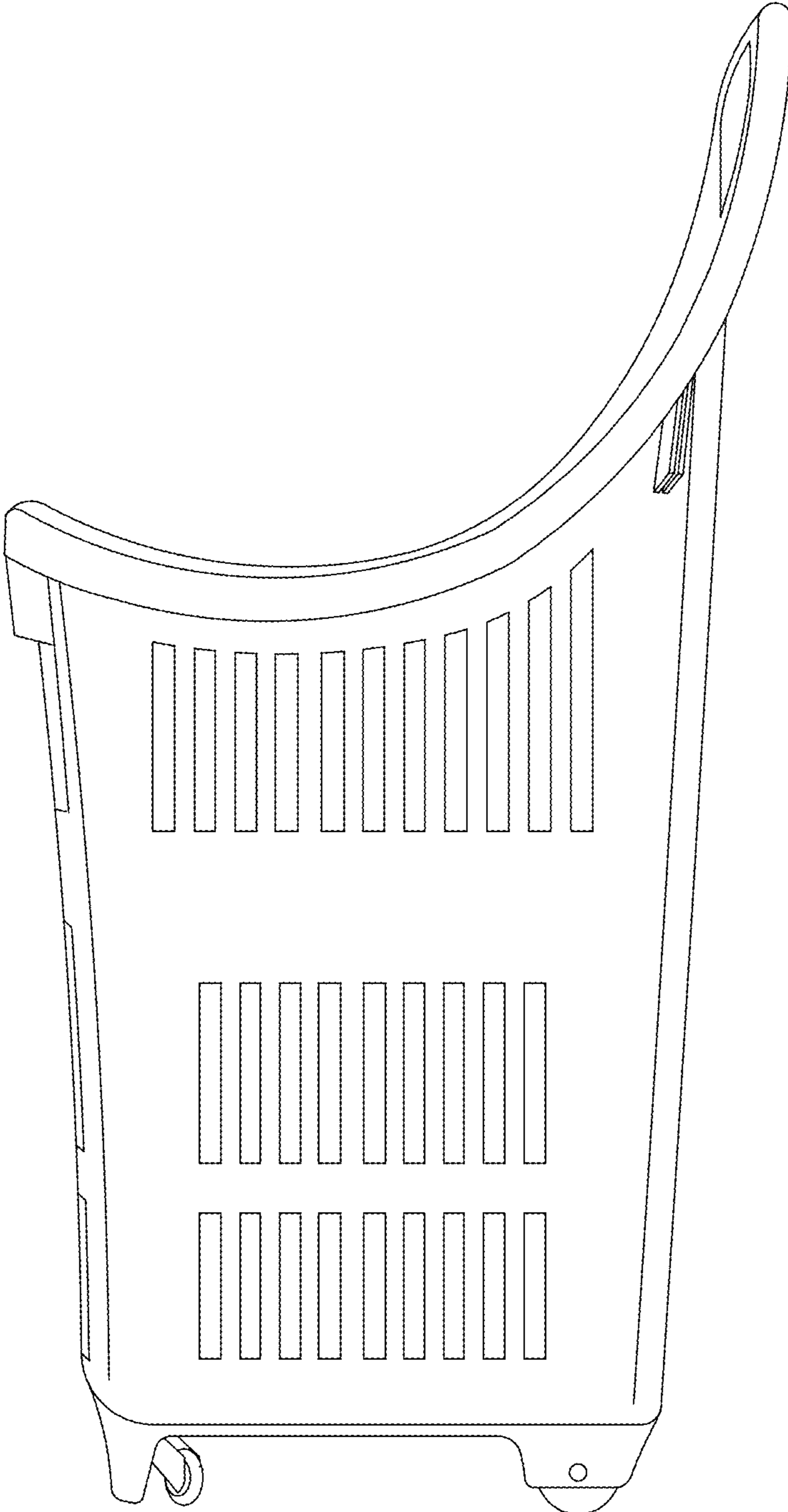
