DESCRIPTION

FIG. 1 is a bottom perspective view of the shoe with decorative sole in accordance with an embodiment of my new design;

FIG. 7 is a rear elevational view thereof.

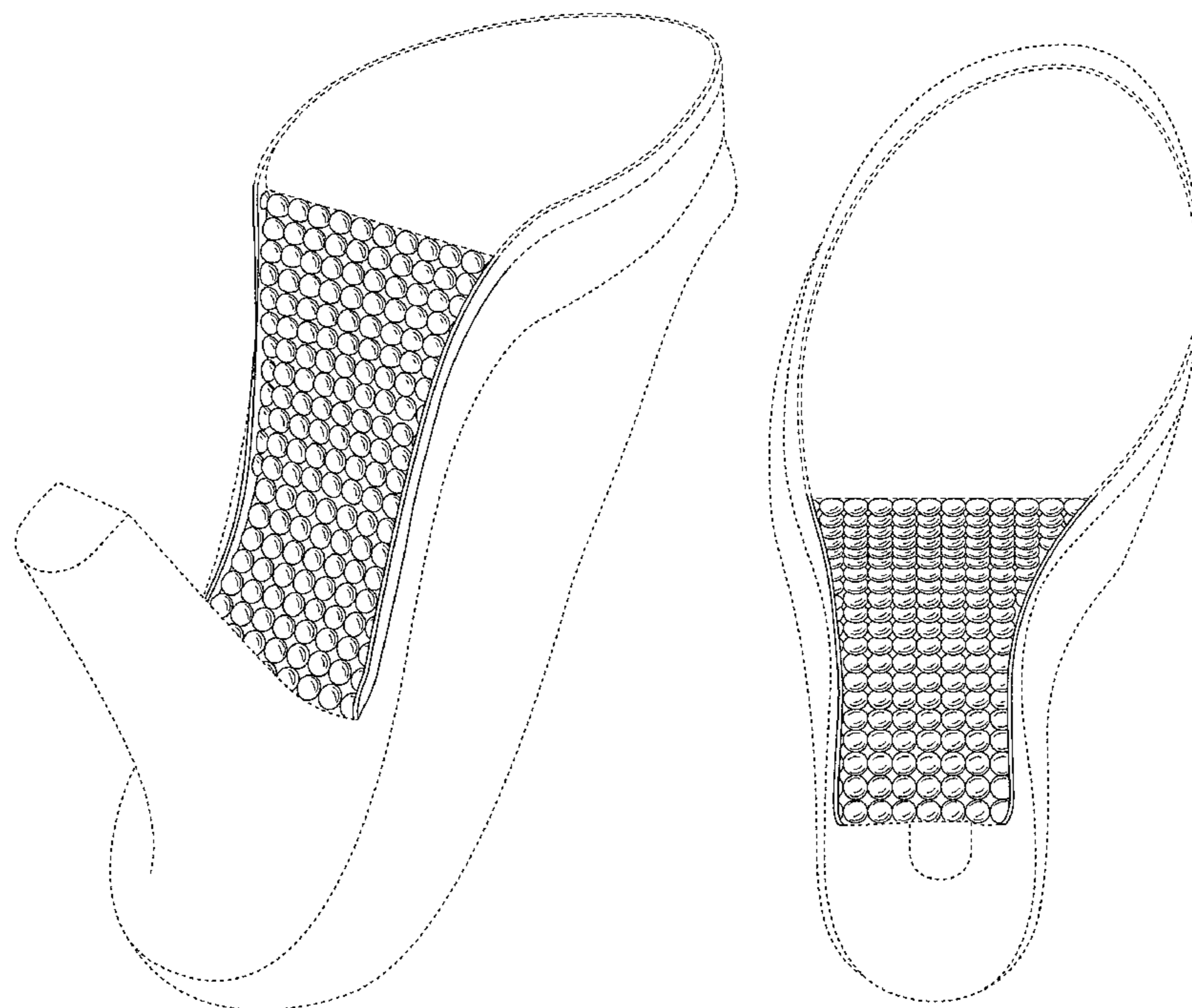
The broken lines showing the shoe designs in FIGS. 1-7 are for illustrative purposes only and form no part of the claimed design.

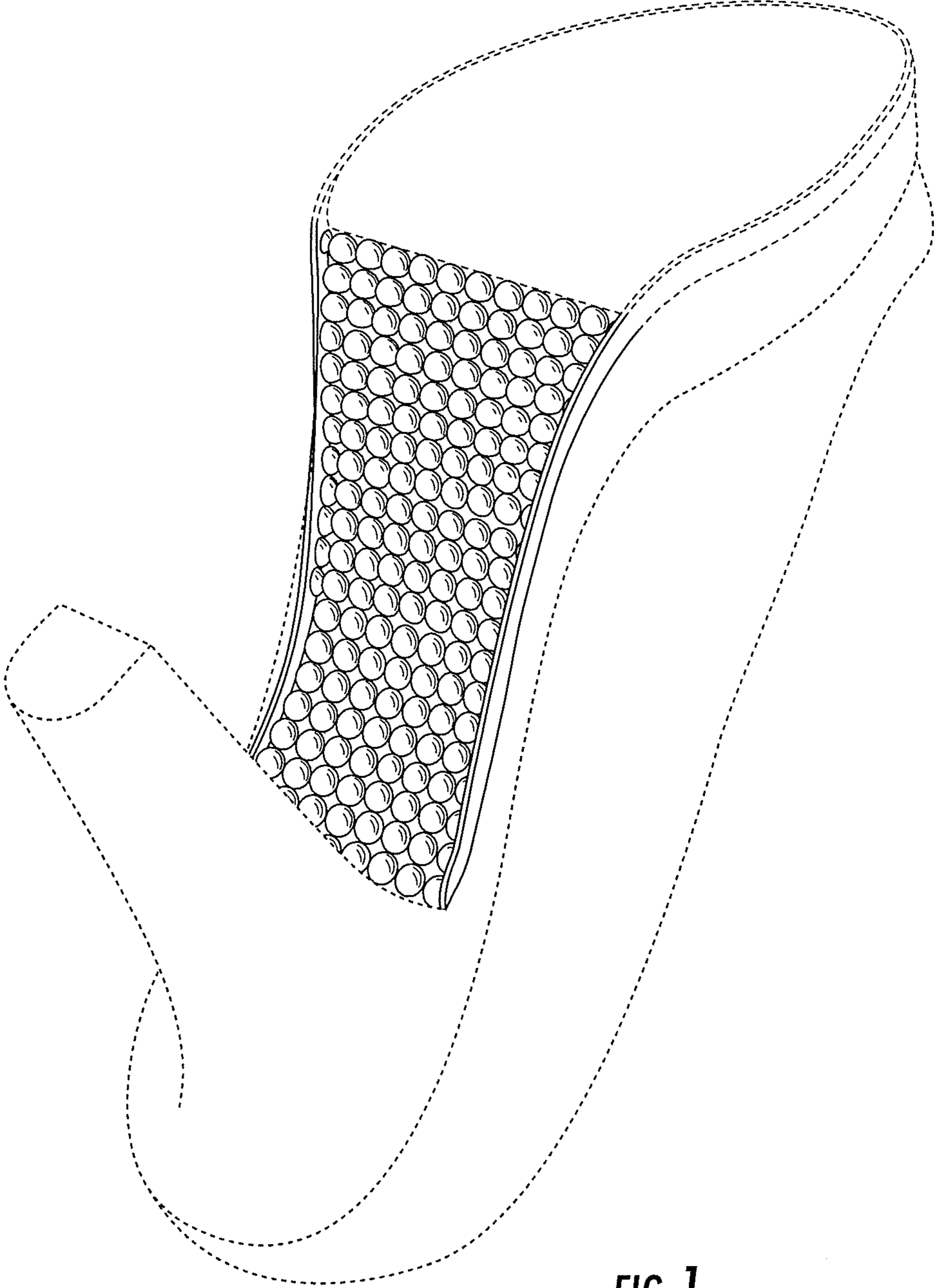

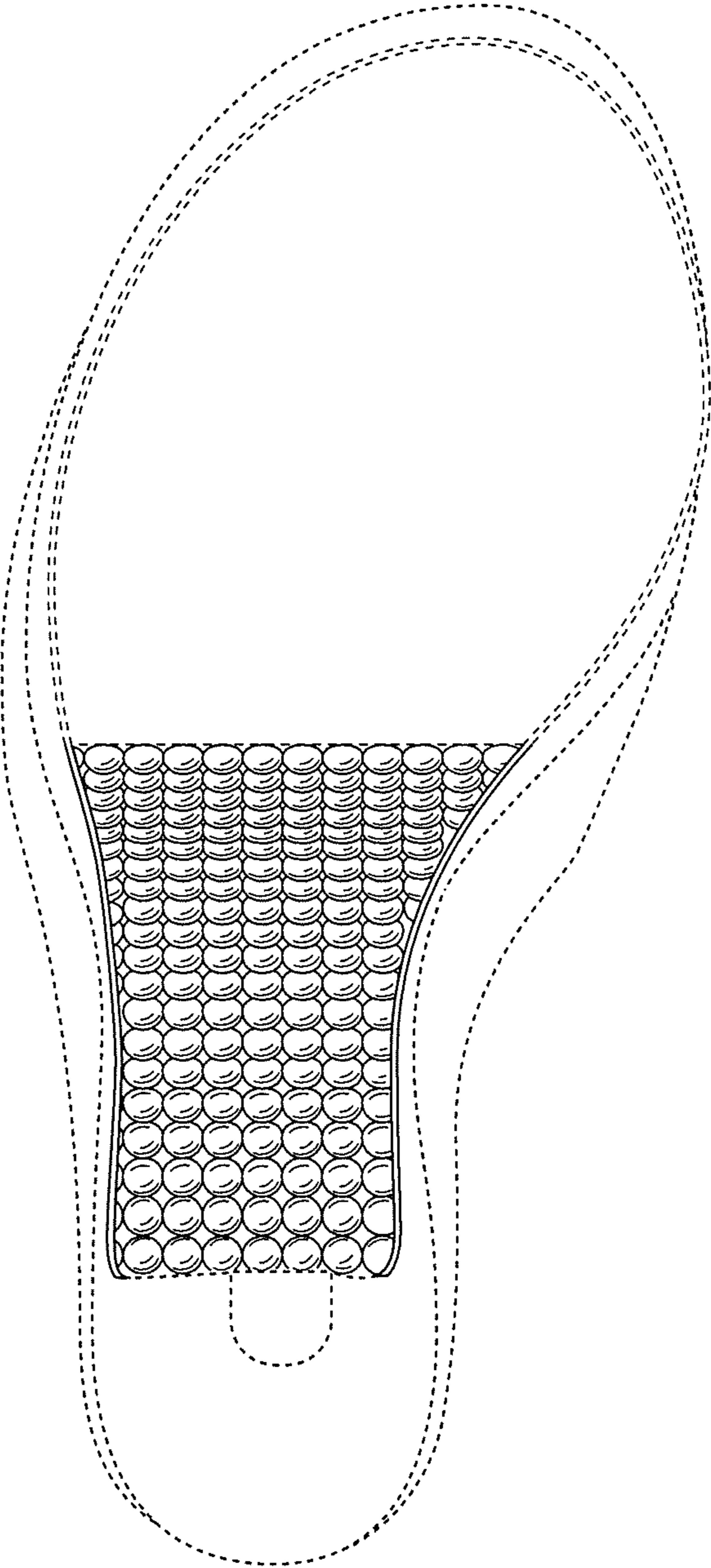

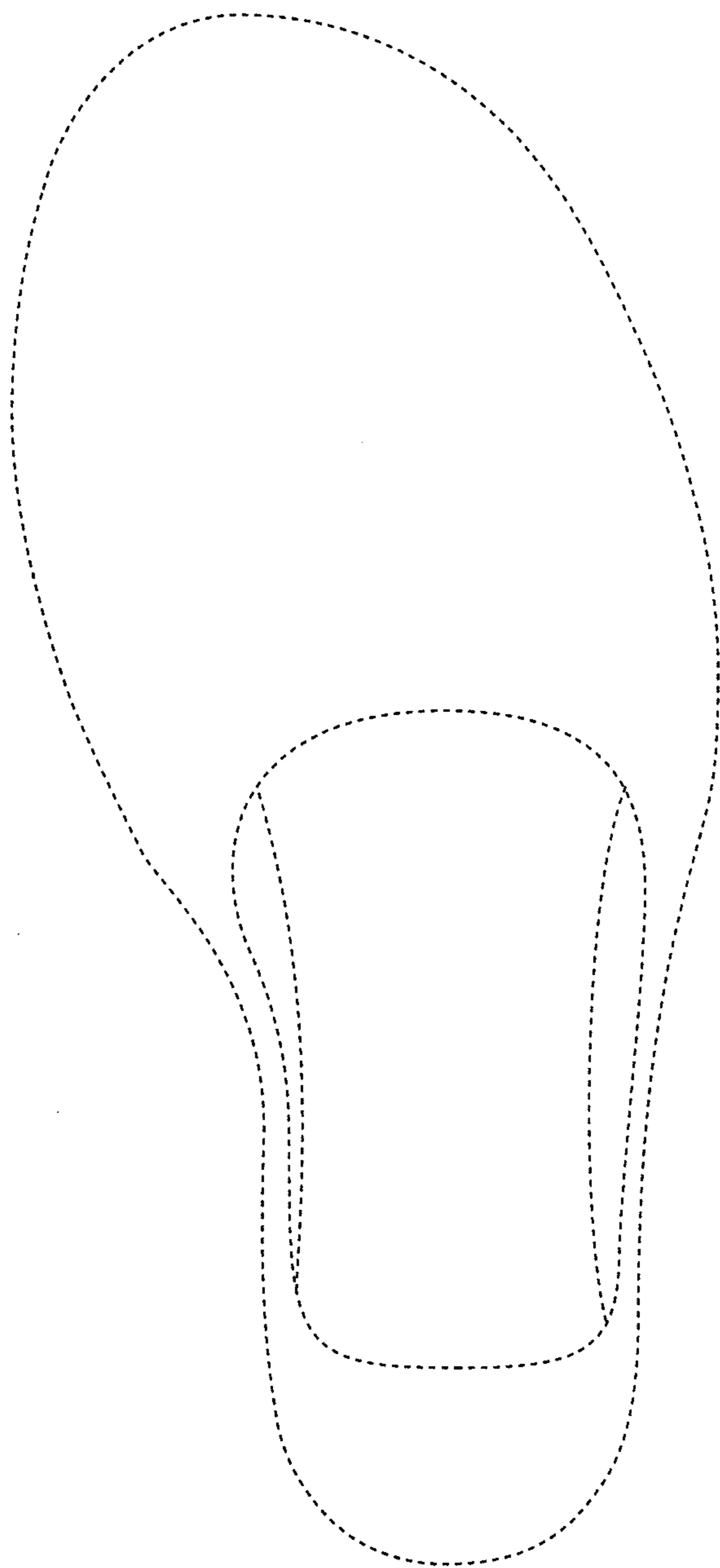

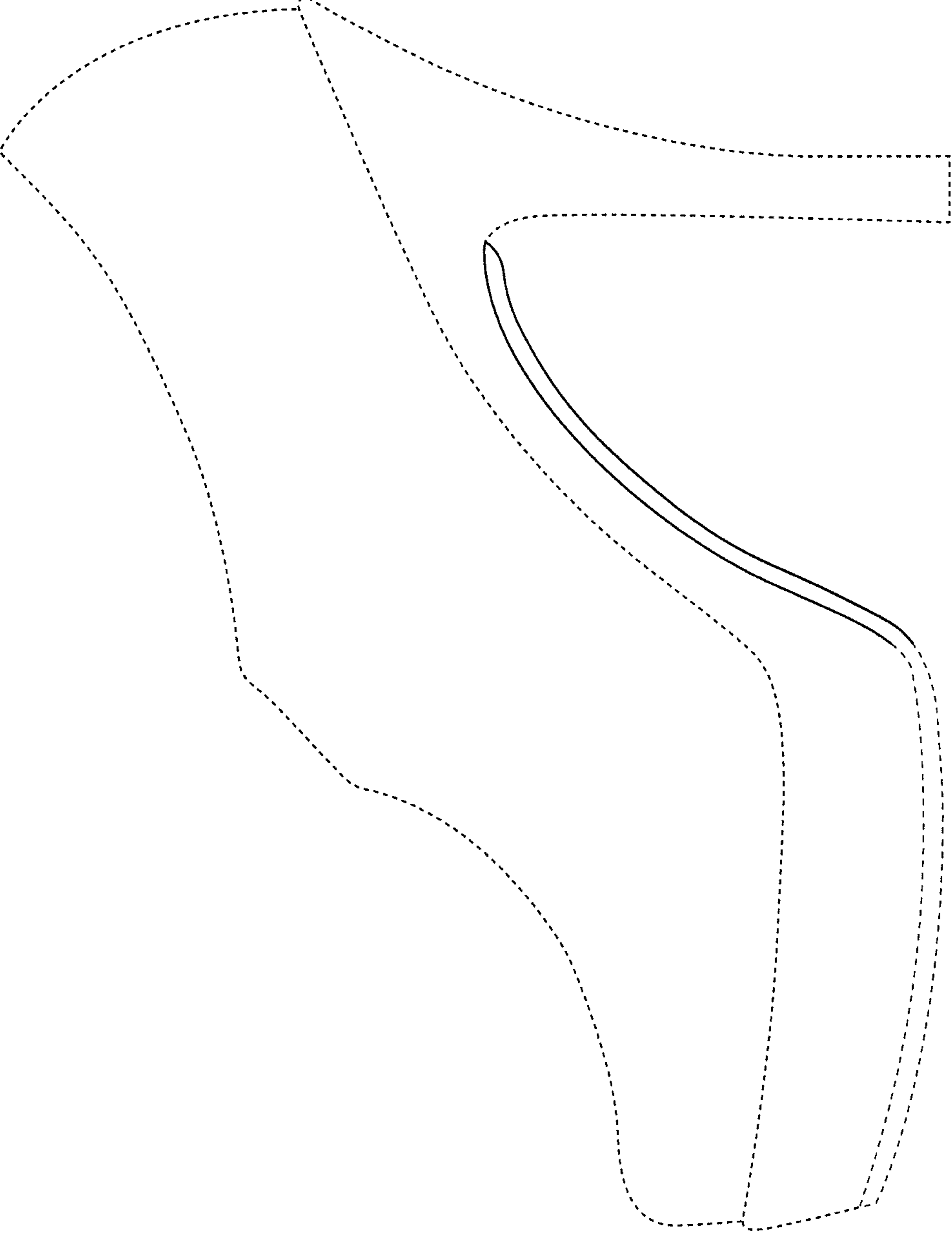

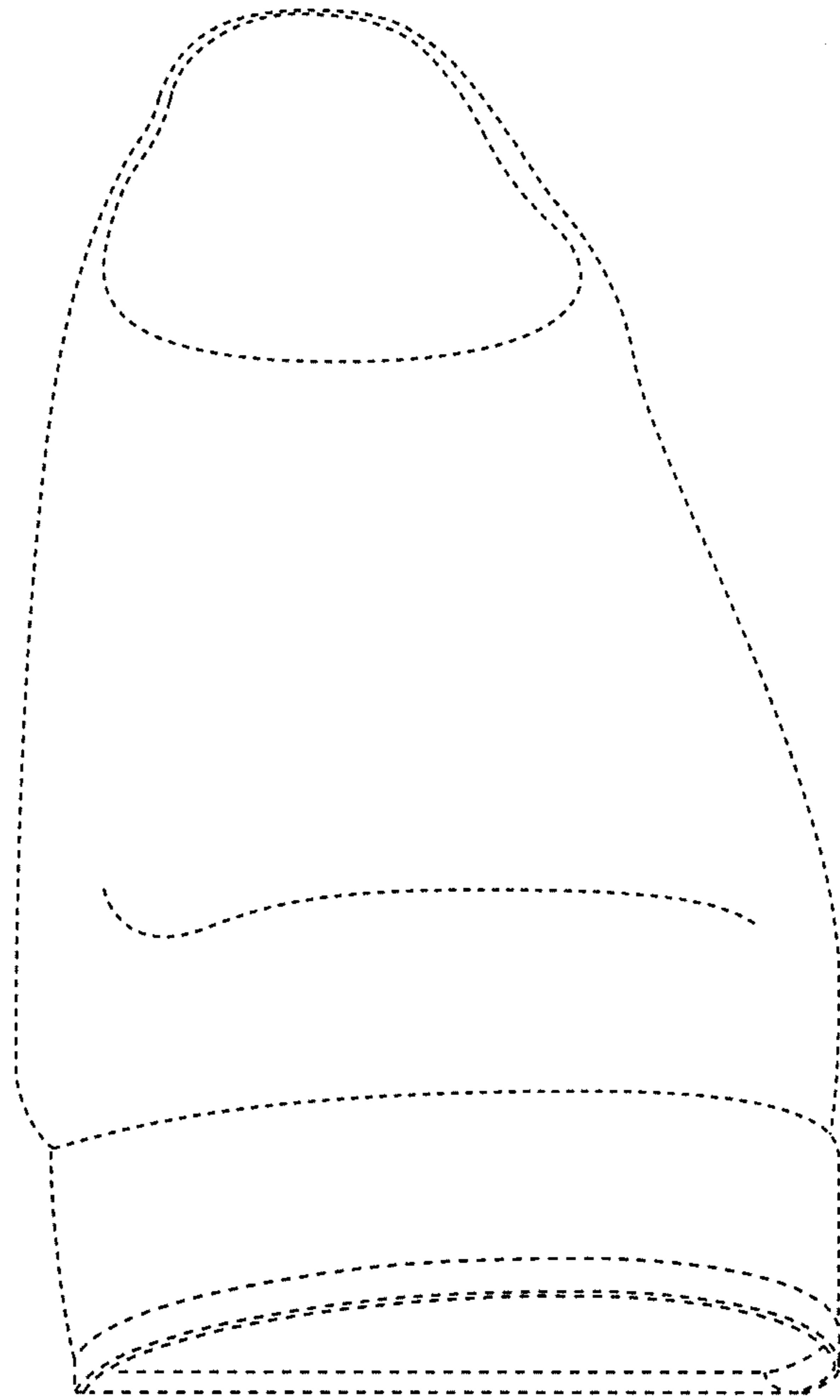

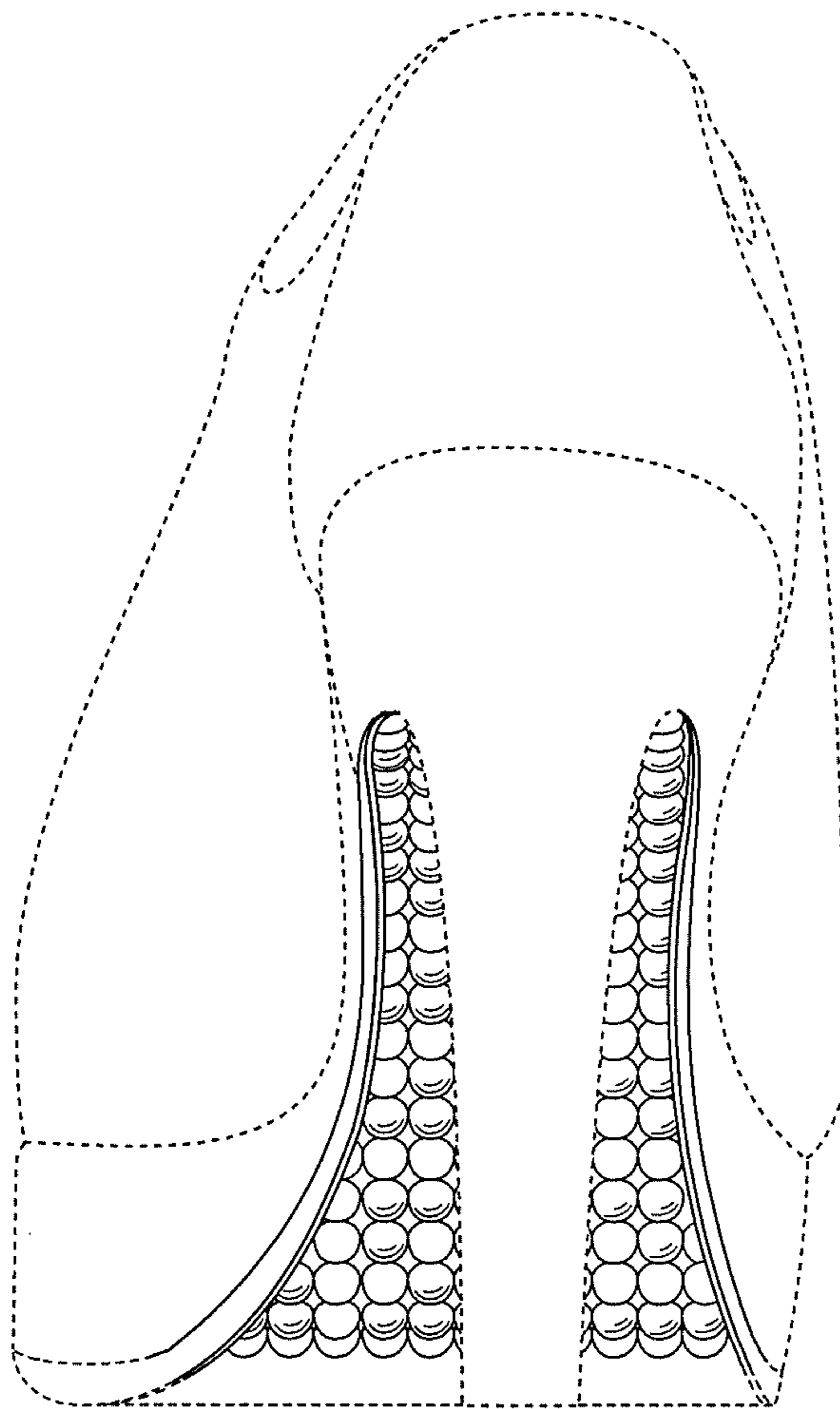
