(57) **CLAIM**

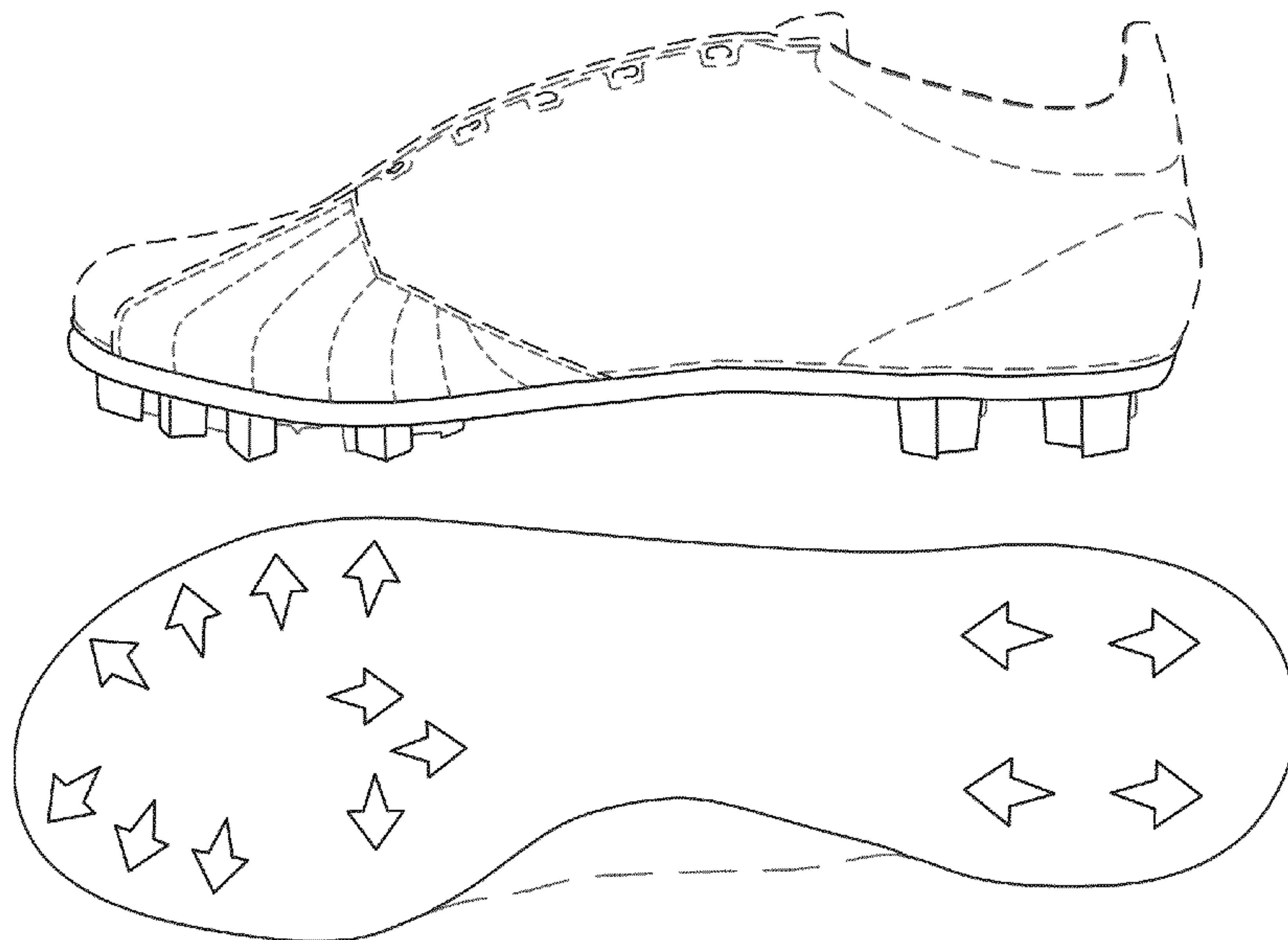
I claim the ornamental design for a sports shoe sole bottom with cleats, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view from a side aspect of my sports shoe sole bottom with cleats, showing my new design; FIG. 2 is a second perspective view of the design from an opposite side as compared to of FIG. 1; FIG. 3 is a bottom plan view of the design of FIG. 1; FIG. 4 is a front aspect perspective view of the design of FIG. 1; and, FIG. 5 is a rear aspect perspective view of the design of FIG. 1.

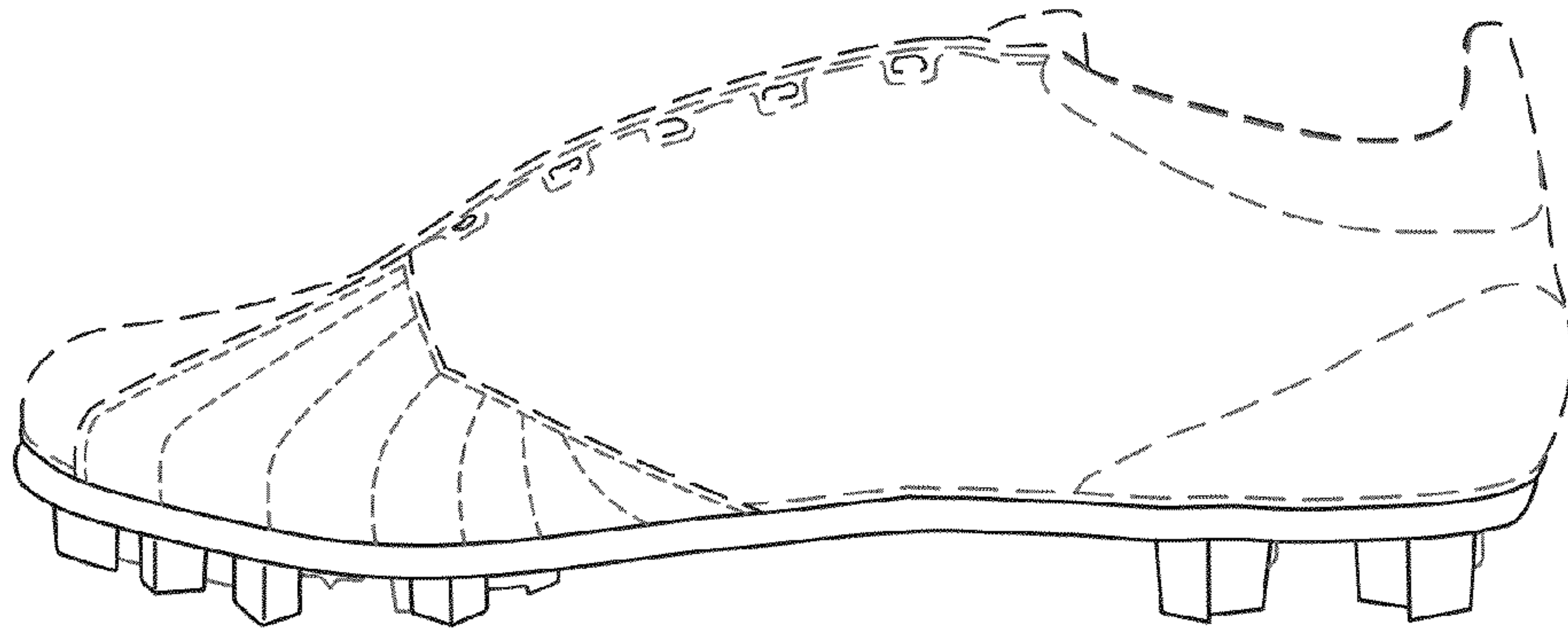

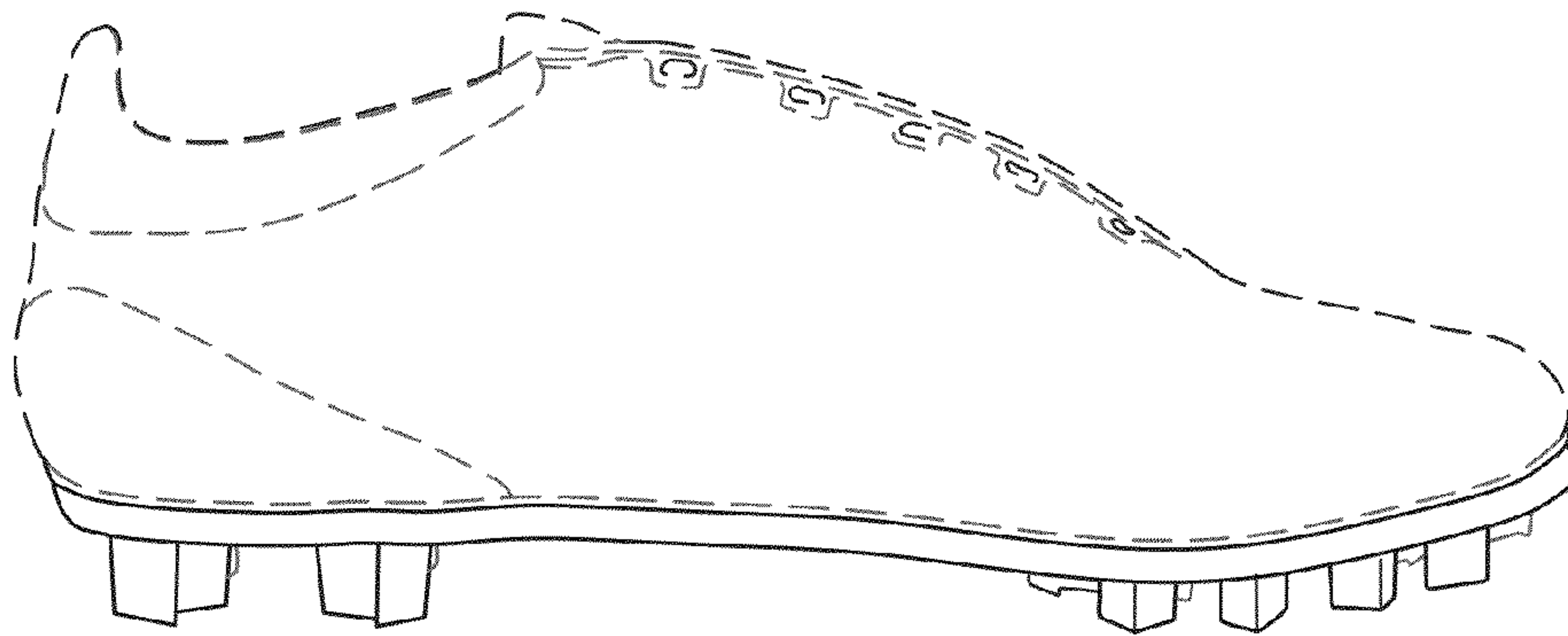

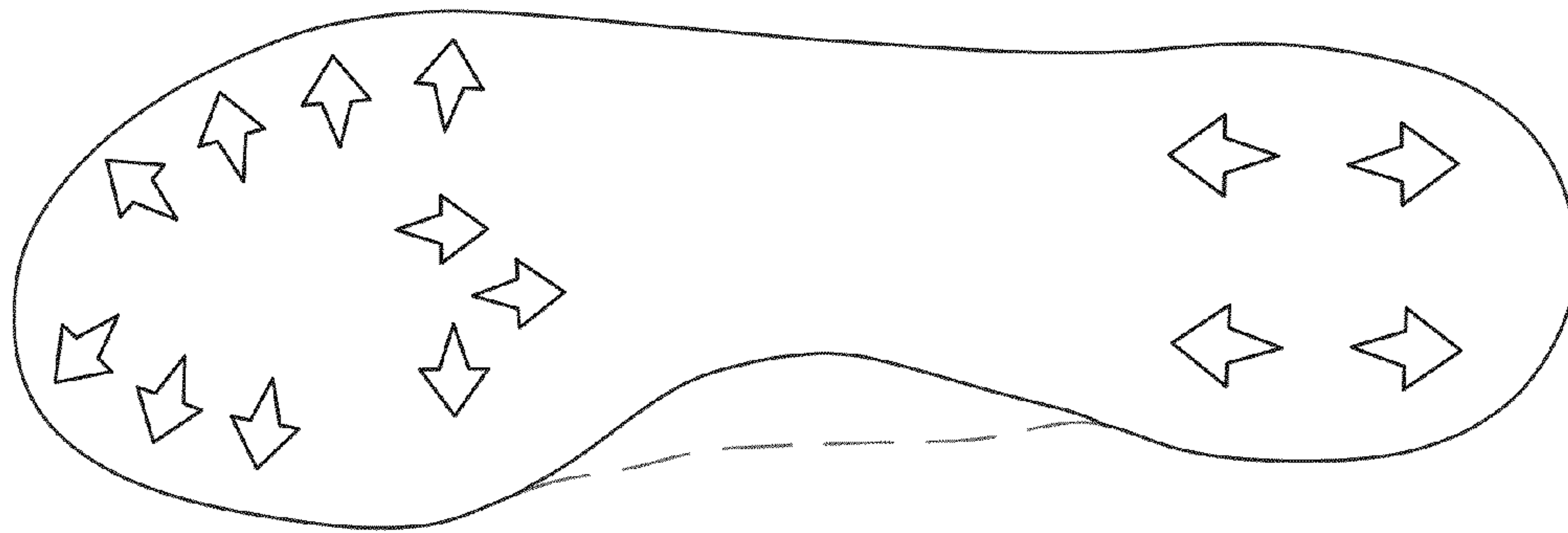

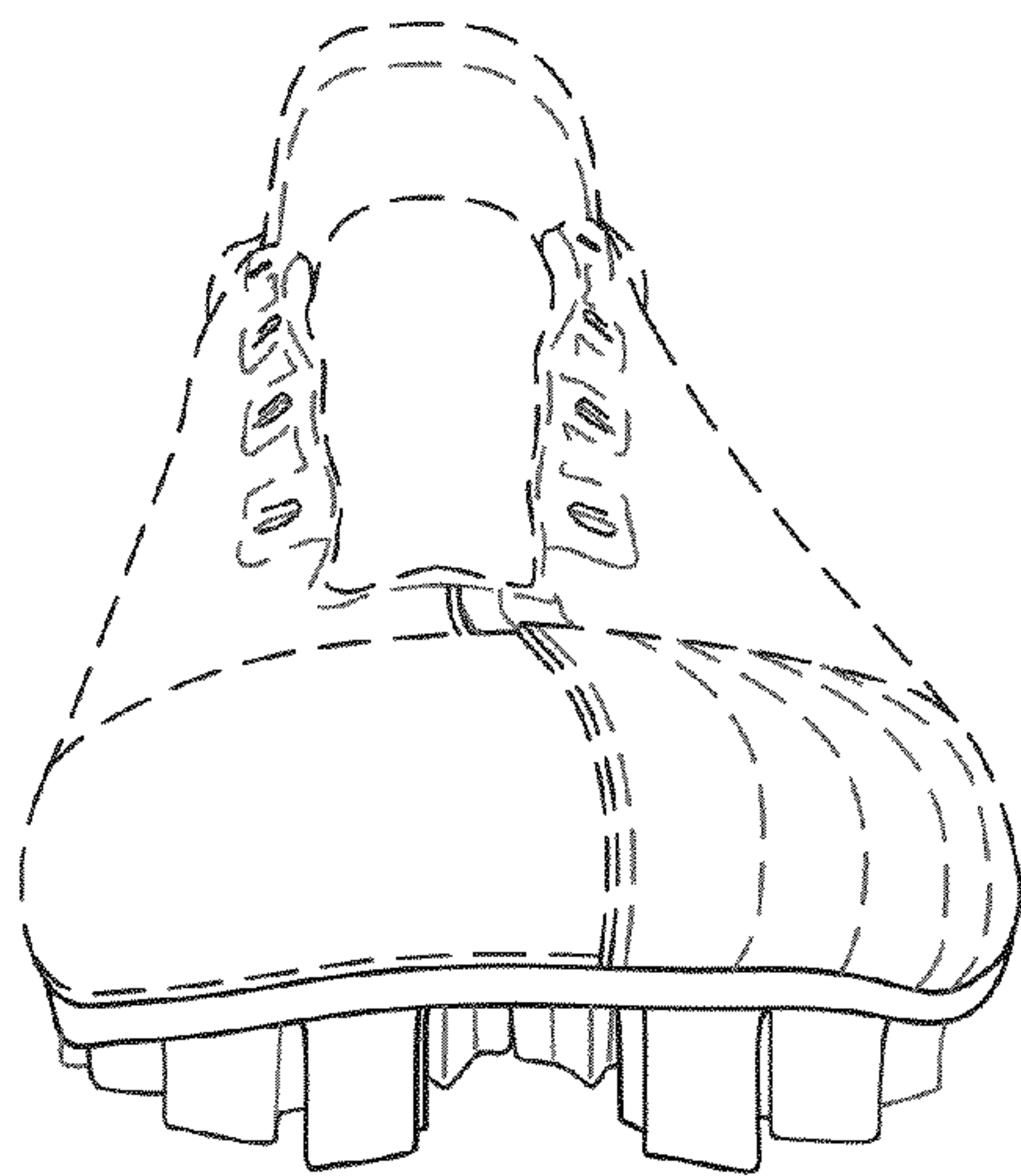

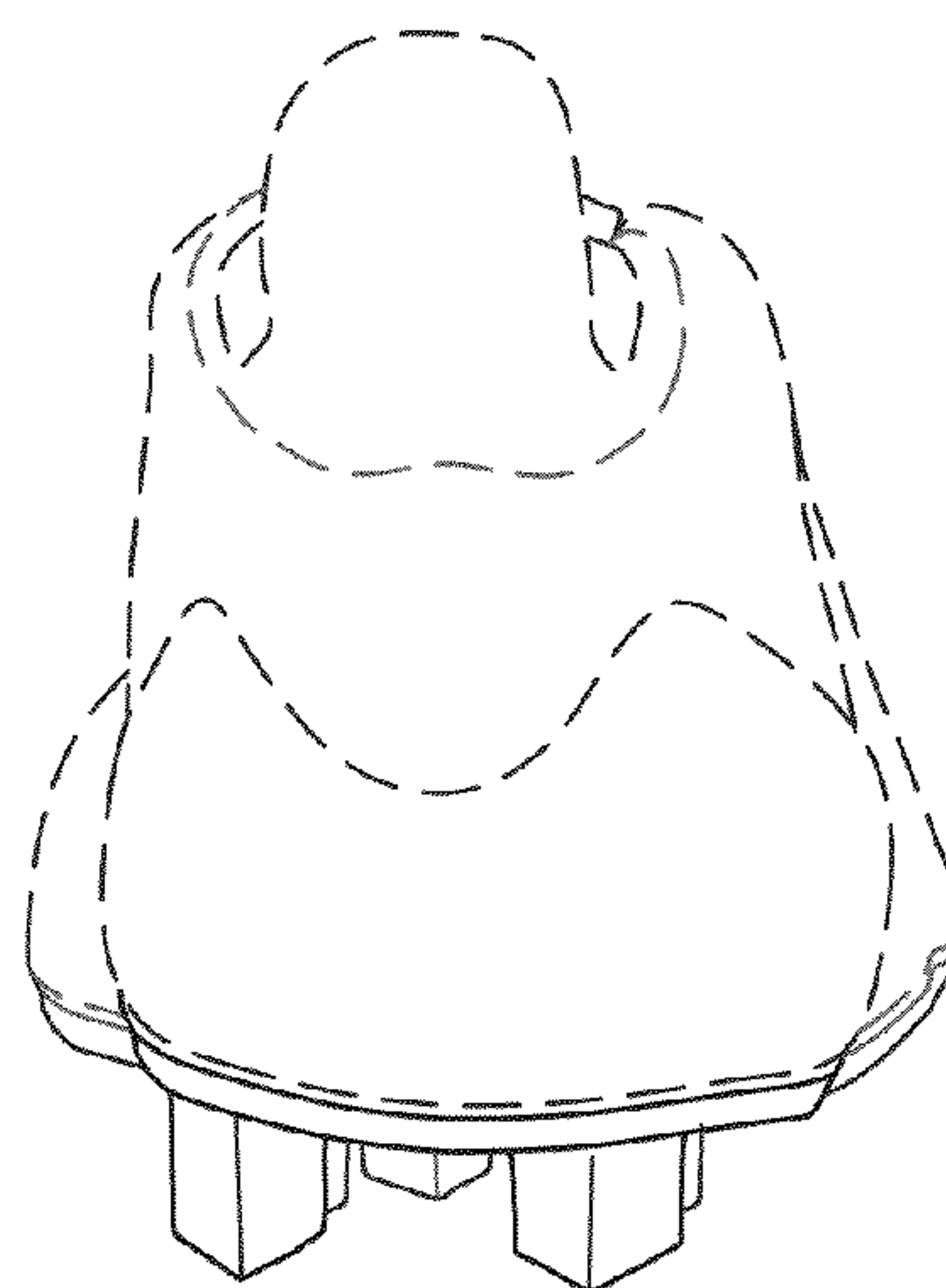
