(57) **CLAIM**

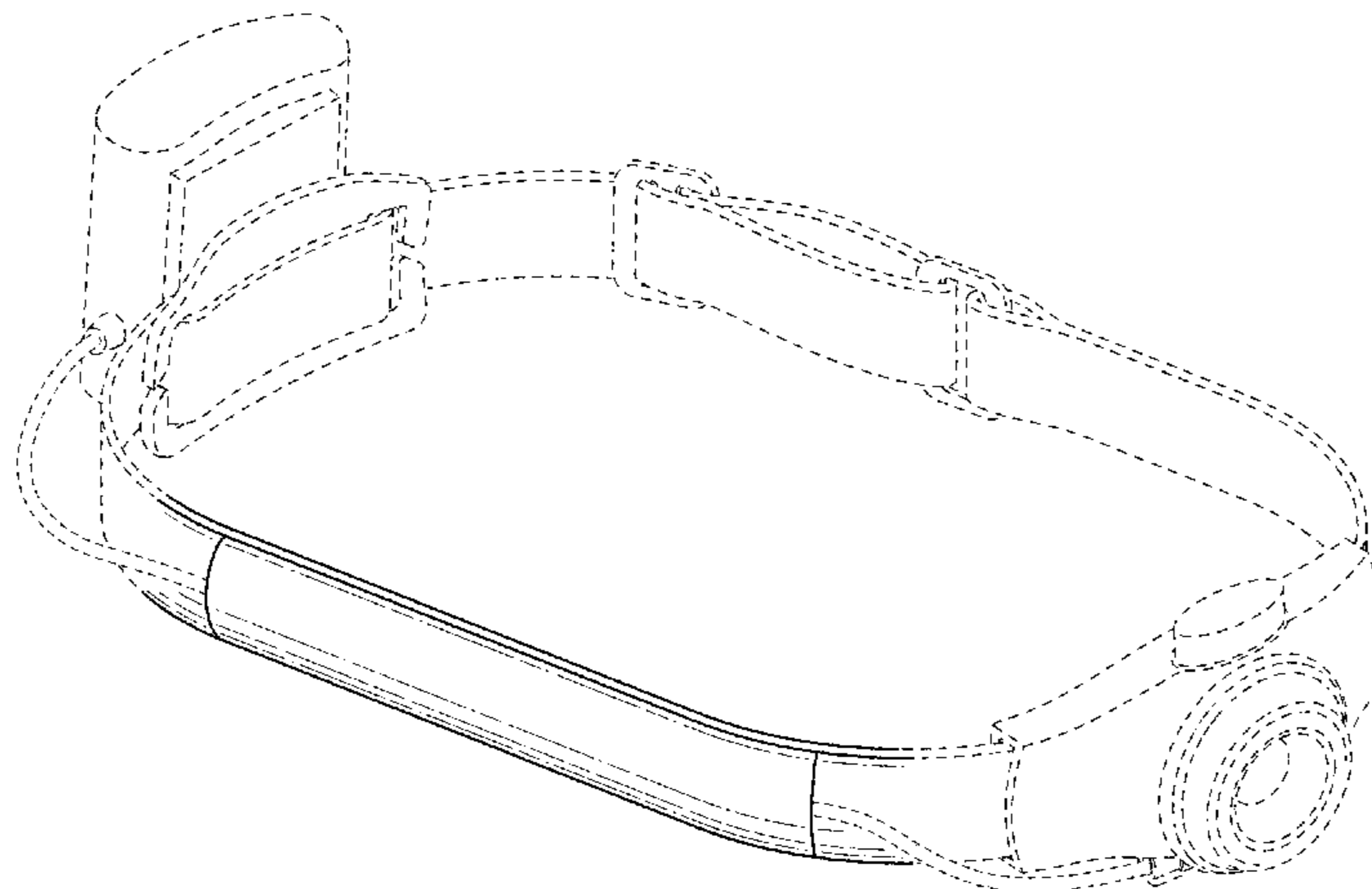
The ornamental design for a headband cord retainer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the headband cord retainer, shown in the environment of the invention;
 FIG. 2 is the perspective view of the headband cord retainer illustrated in FIG. 1;
 FIG. 3 is a front elevational view of the headband cord retainer illustrated in FIG. 1;
 FIG. 4 is a rear elevational view of the headband cord retainer illustrated in FIG. 1;
 FIG. 5 is a left side elevational view of the headband cord retainer illustrated in FIG. 1;
 FIG. 6 is a right side elevational view of the headband cord retainer illustrated in FIG. 1;
 FIG. 7 is a top view of the headband cord retainer illustrated in FIG. 1; and,
 FIG. 8 is a bottom view of the headband cord retainer illustrated in FIG. 1.

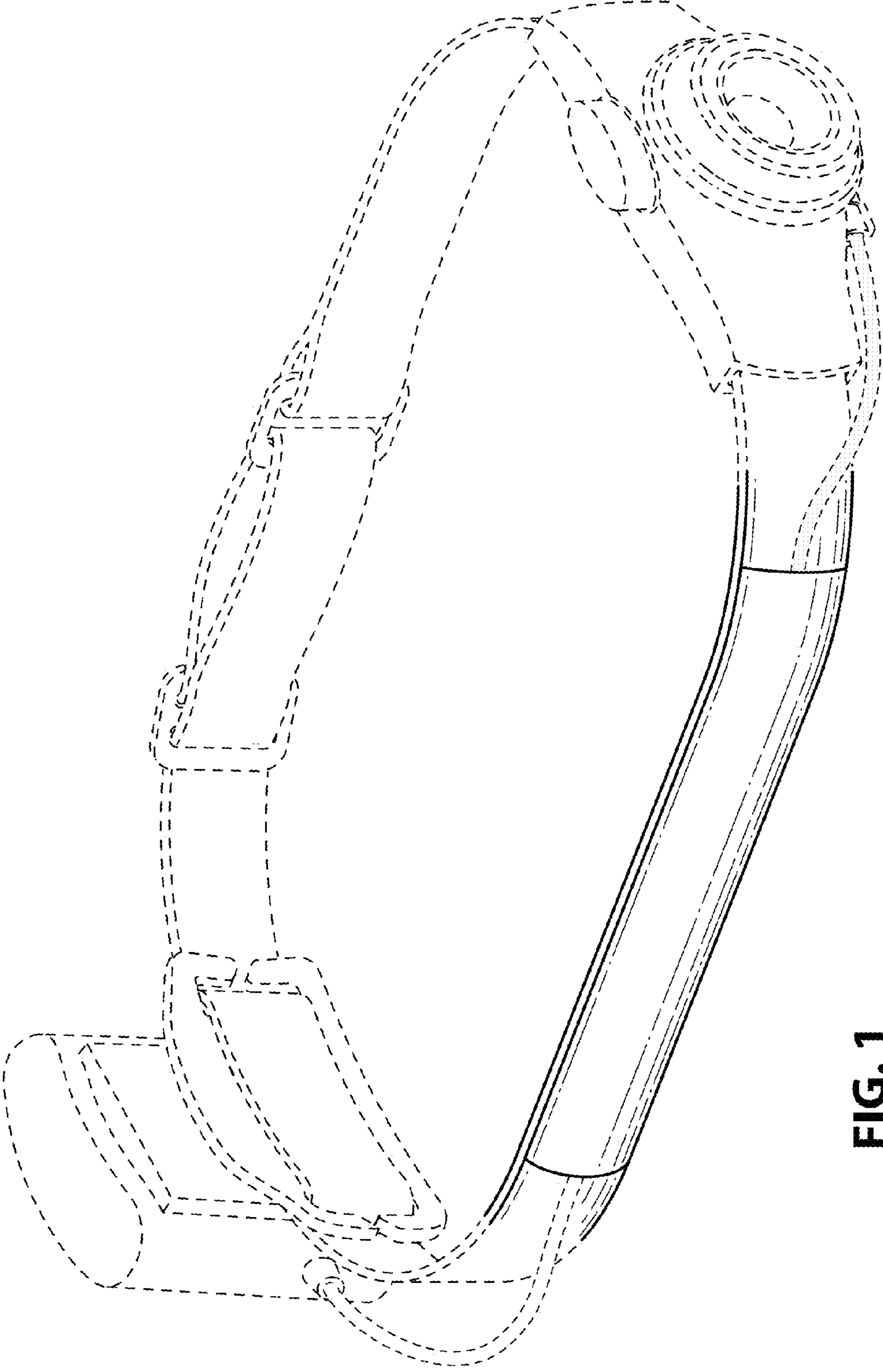

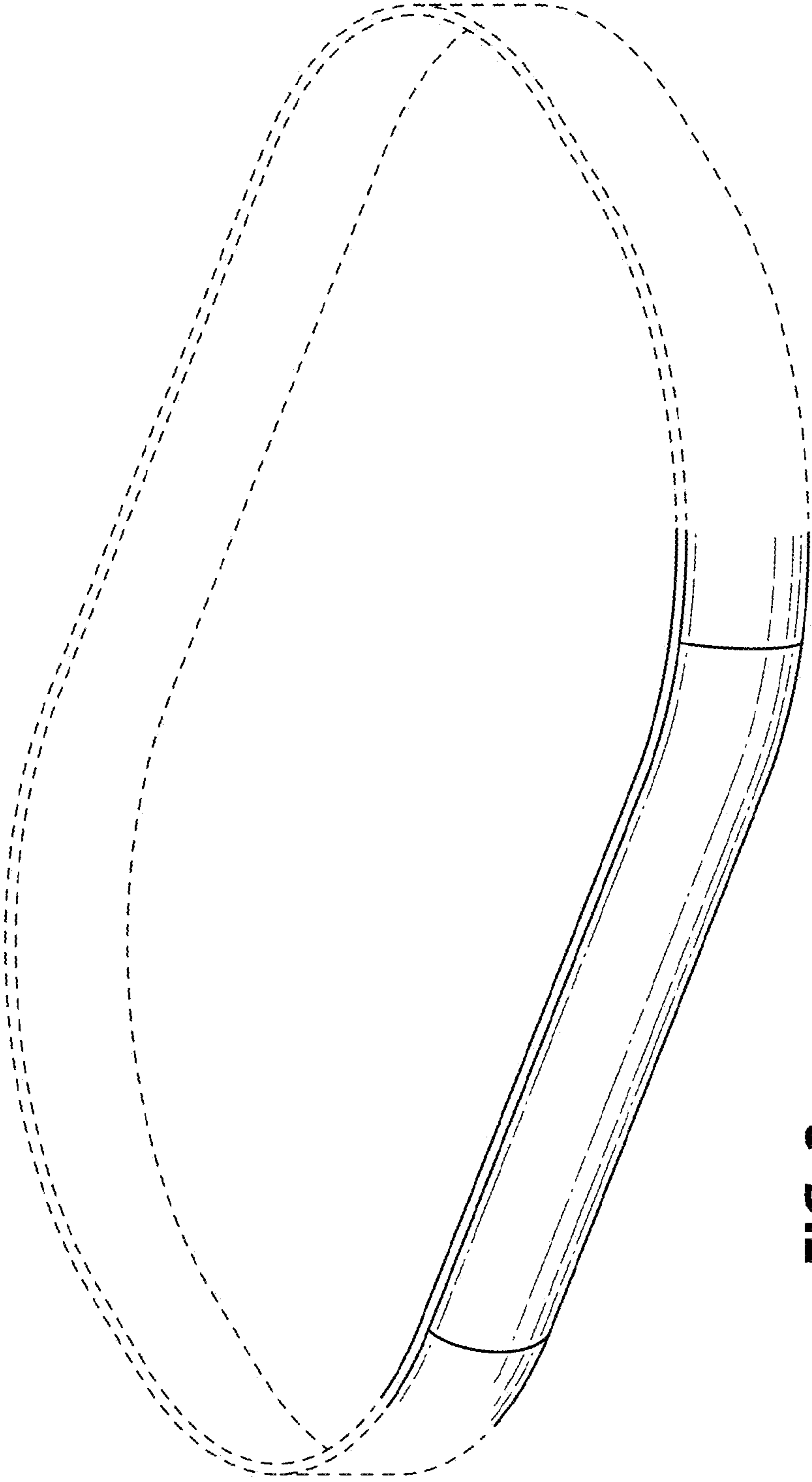

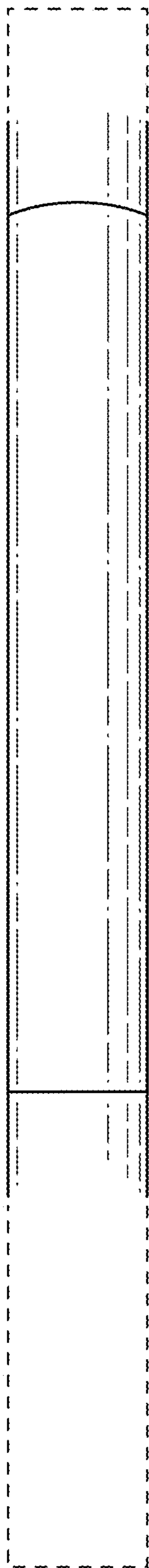

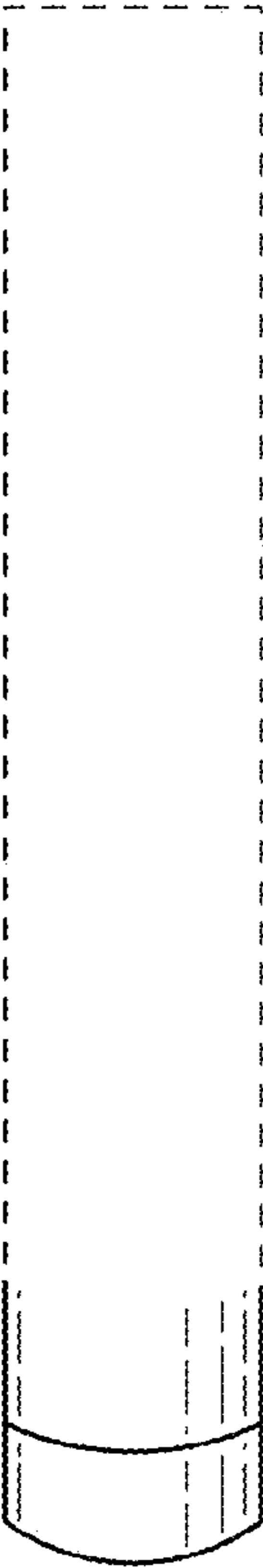

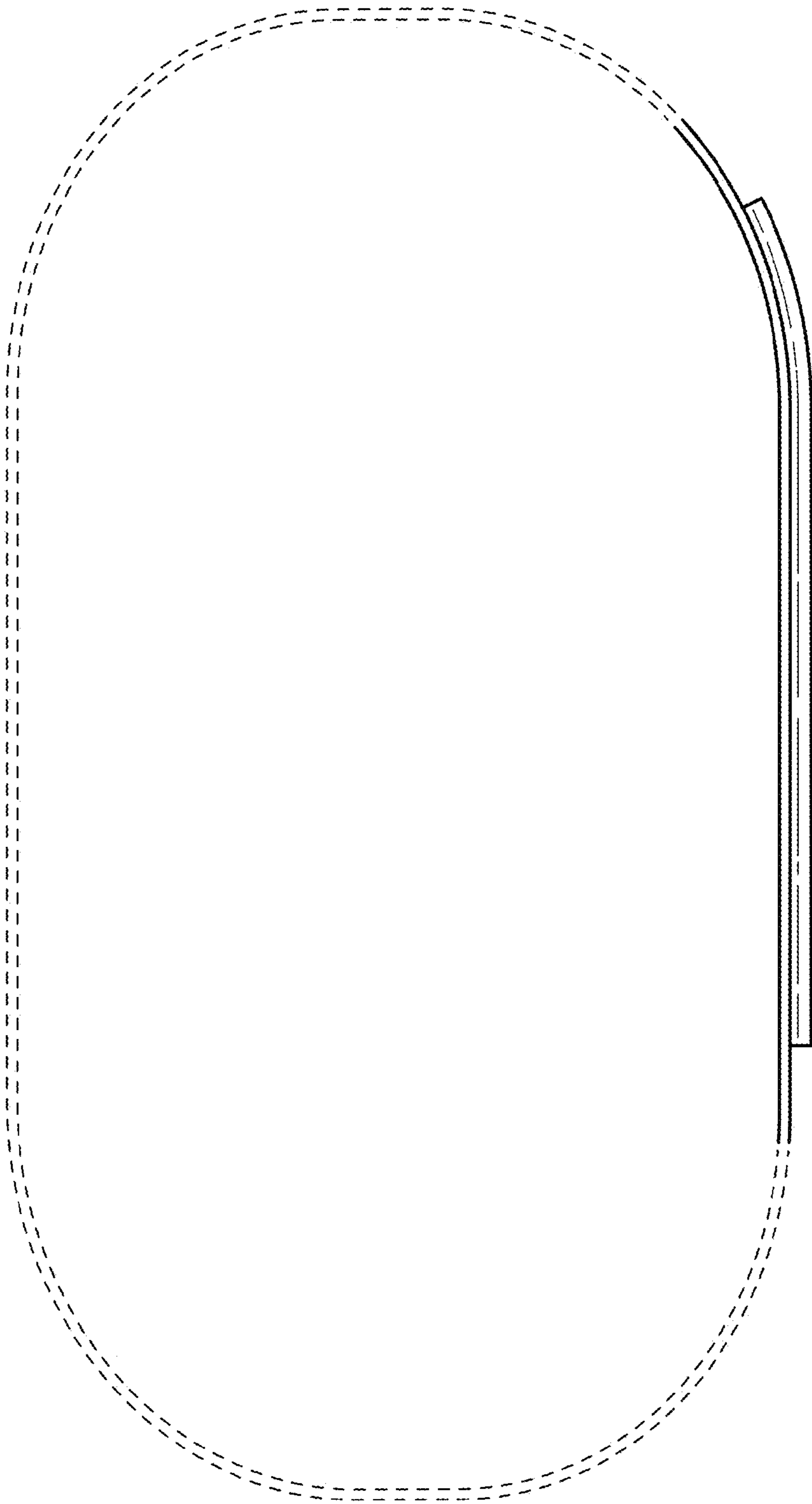

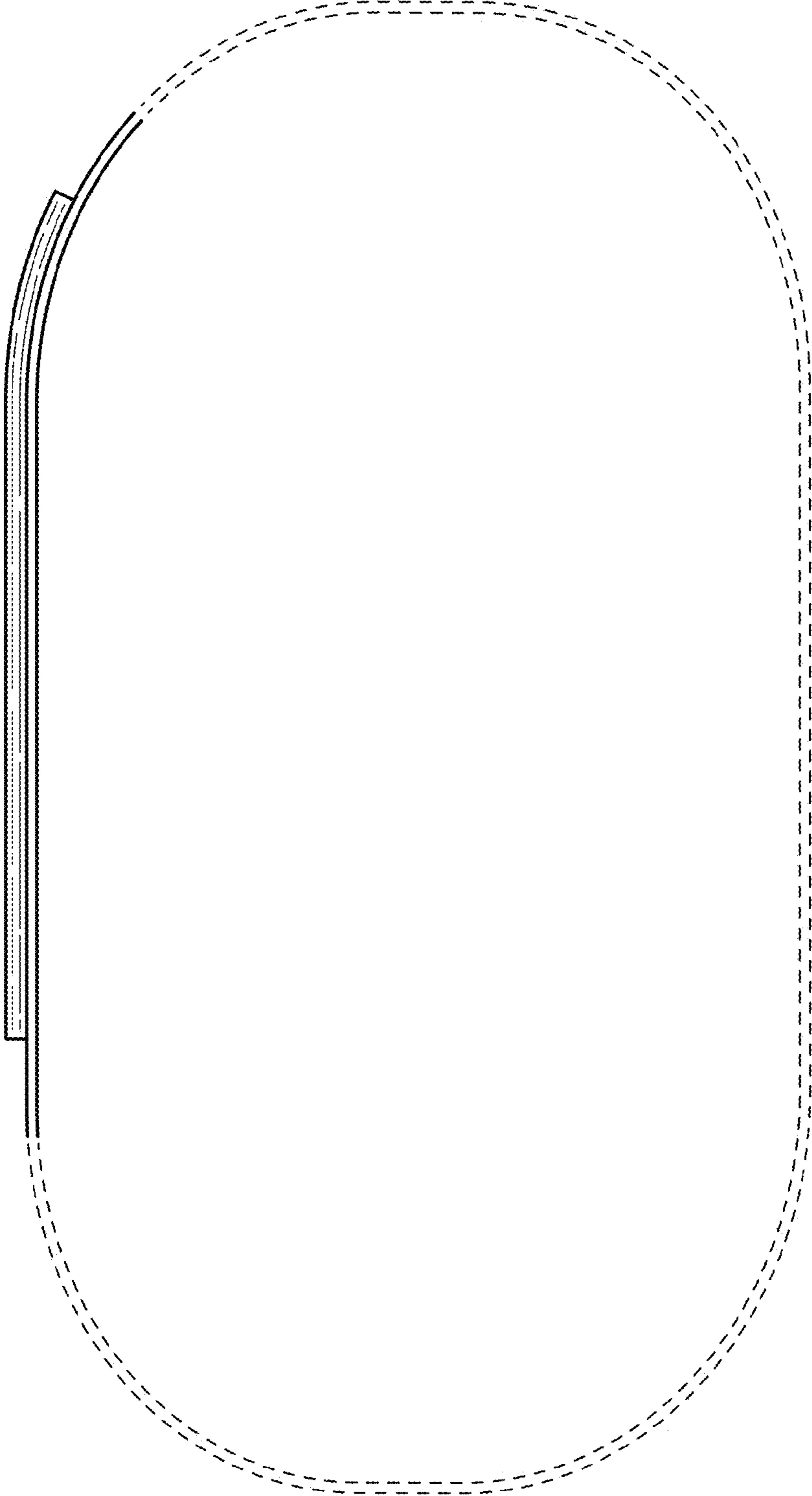
