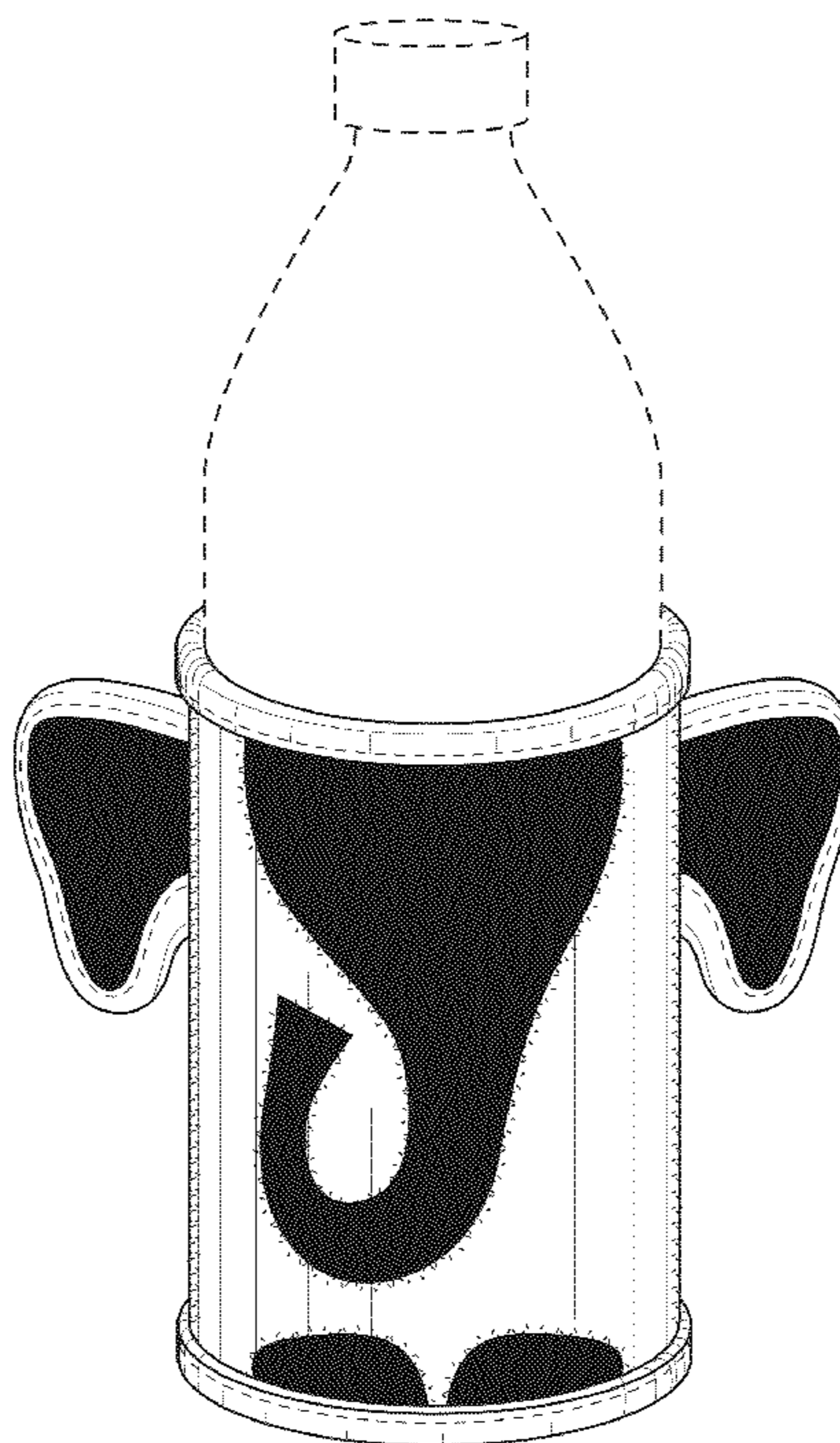
(57) **CLAIM**  
The ornamental design for a sleeve for a drink container, as shown and described.

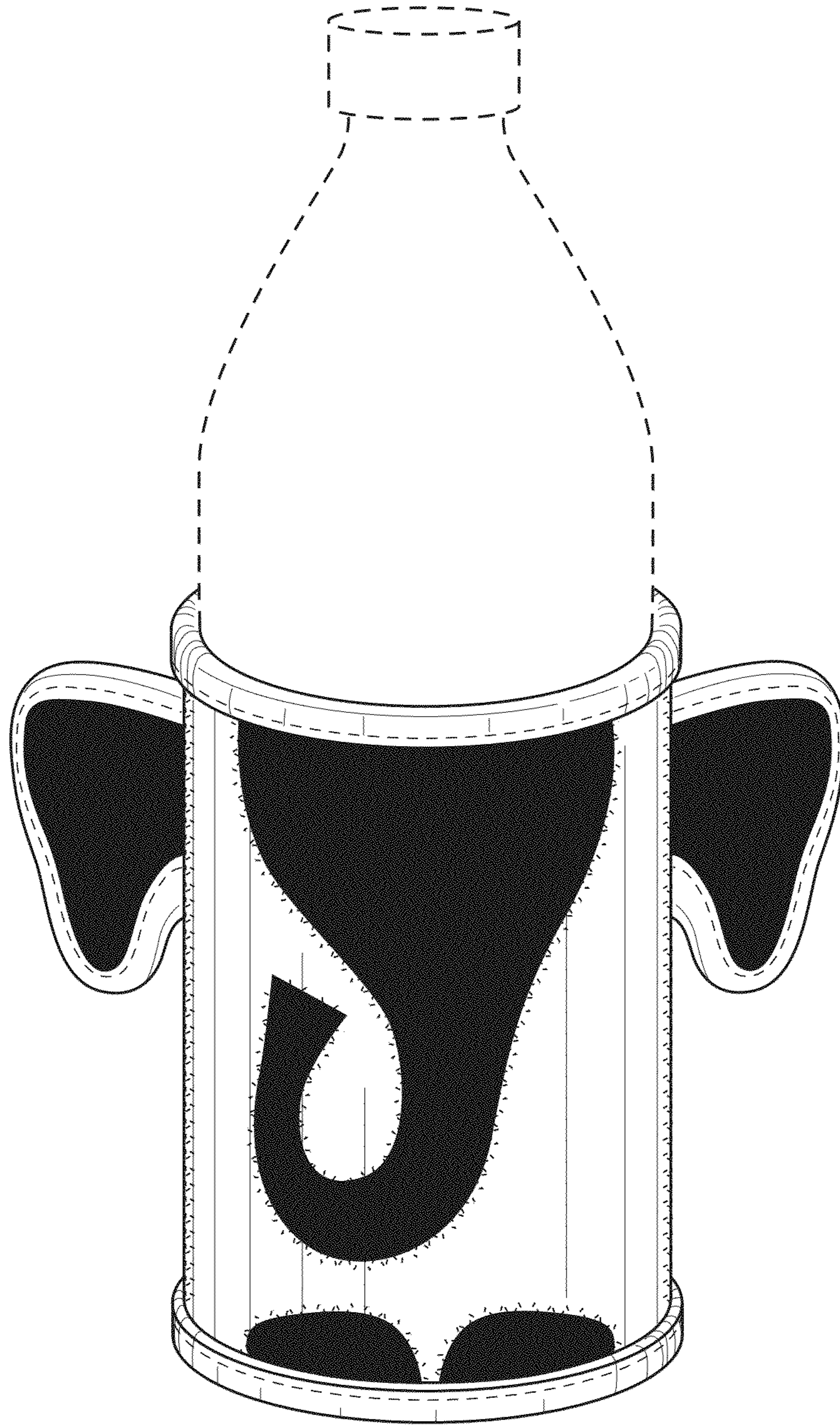
**DESCRIPTION**

FIG. 1 is a front perspective view of a sleeve for a drink container according to the new design.  
 FIG. 2 is a front view of the sleeve for a drink container of FIG. 1.  
 FIG. 3 is a rear view of the sleeve for a drink container of FIG. 1.  
 FIG. 4 is a left side view of the sleeve for a drink container of FIG. 1.  
 FIG. 5 is a right side view of the sleeve for a drink container of FIG. 1.  
 FIG. 6 is a top view of the sleeve for a drink container of FIG. 1; and,  
 FIG. 7 is a bottom view of the sleeve for a drink container of FIG. 1.

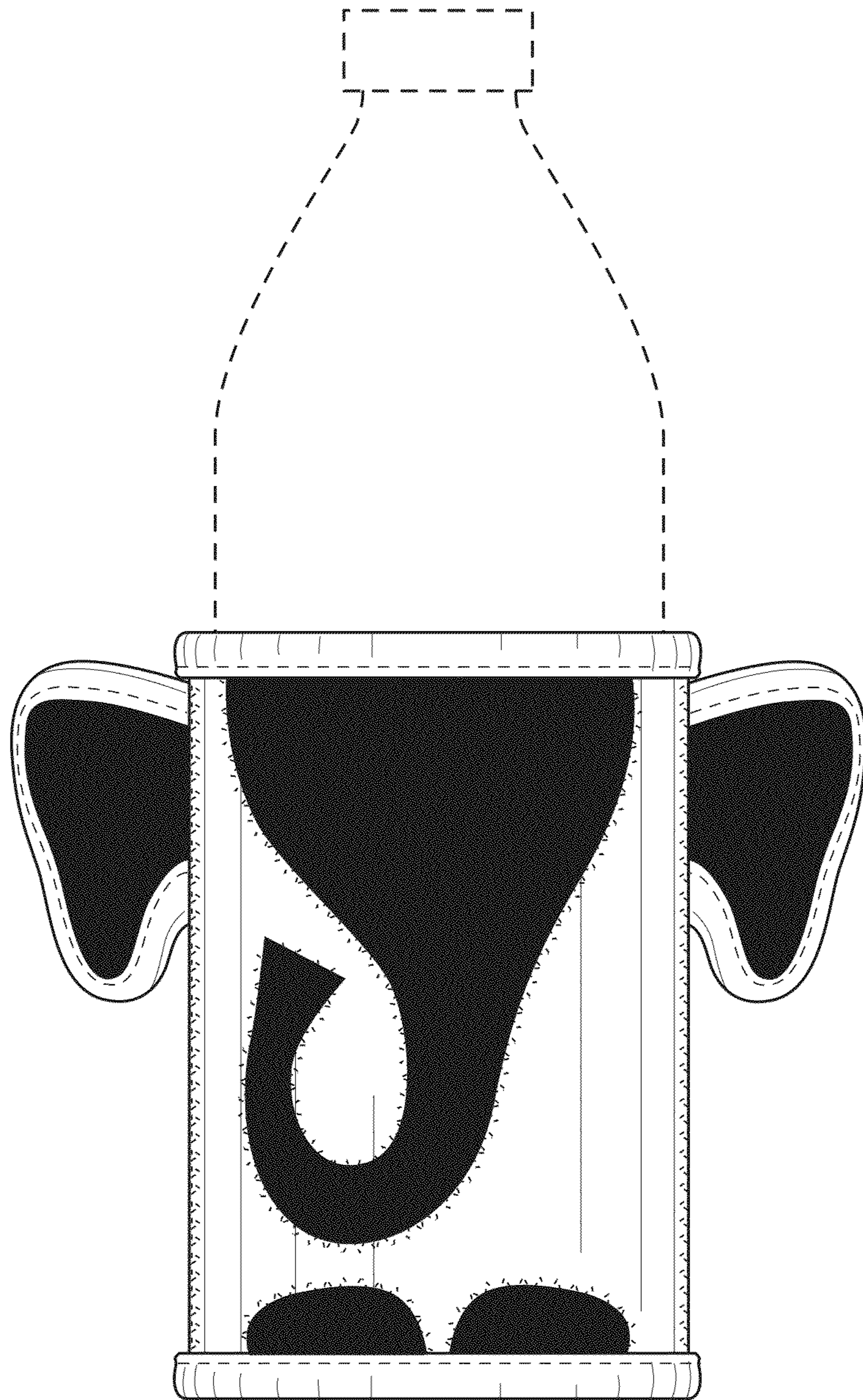
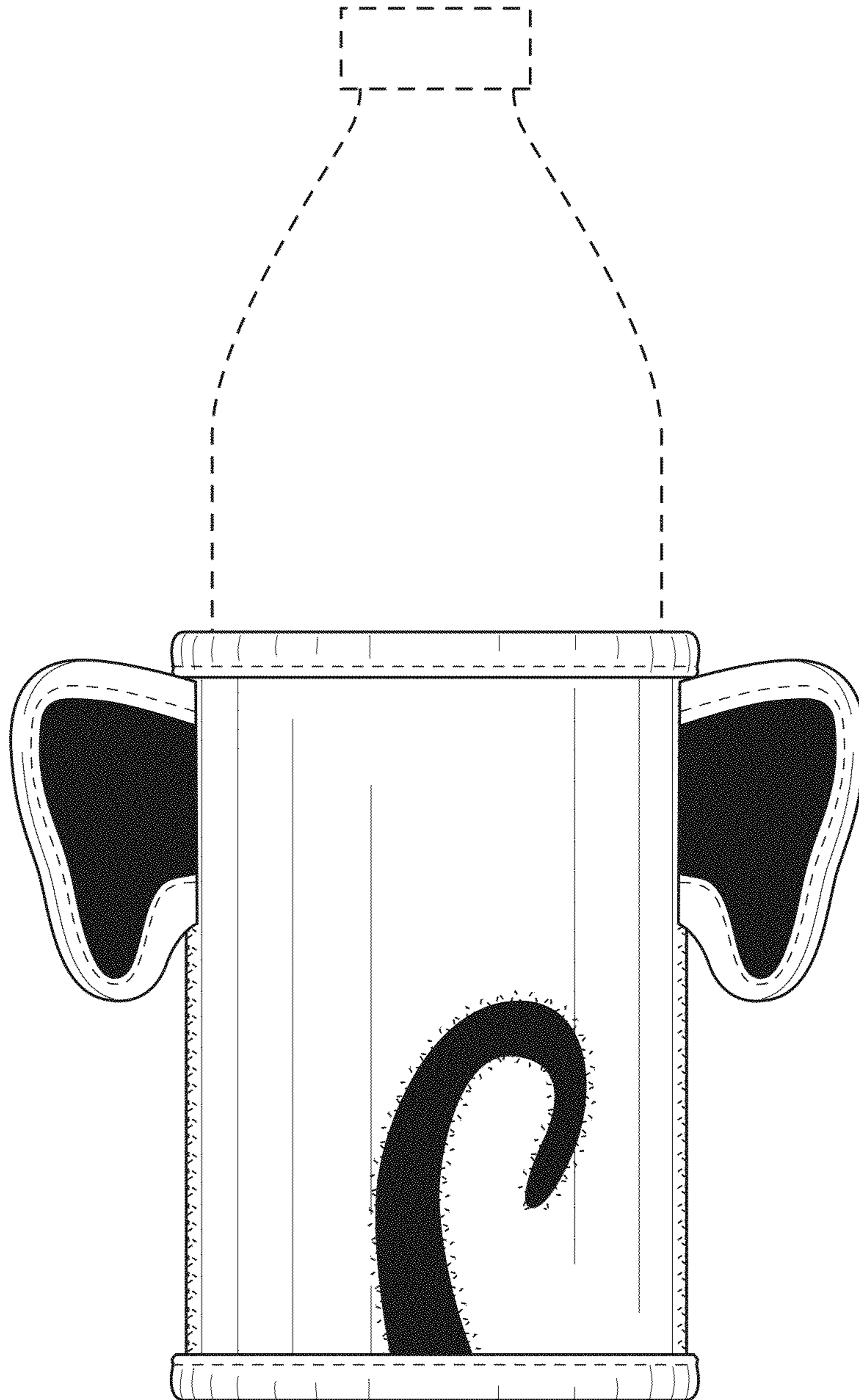

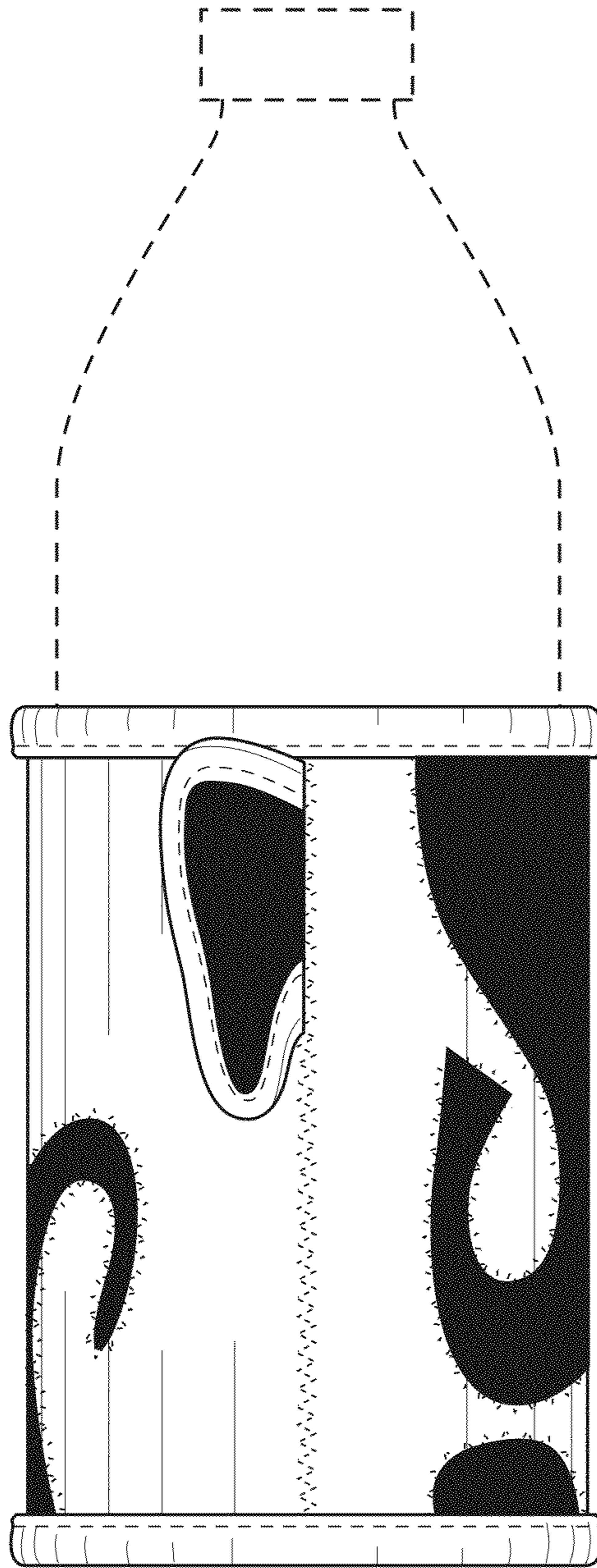
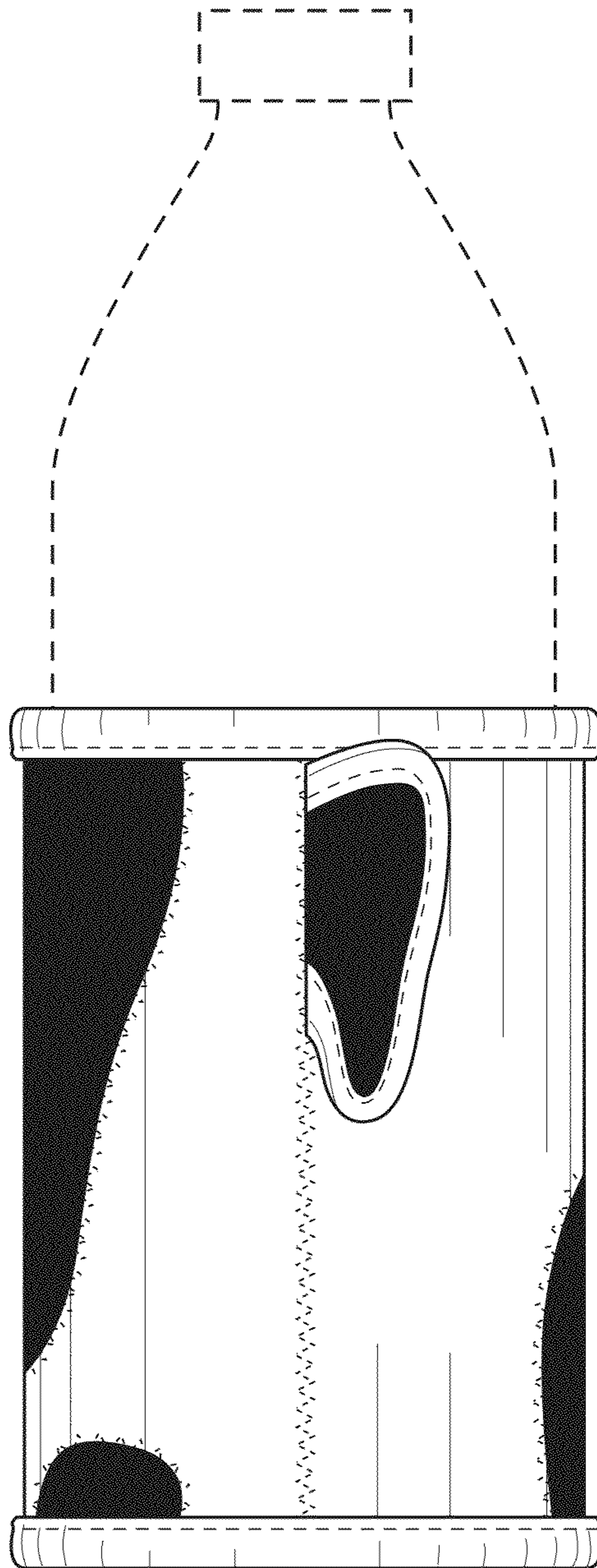
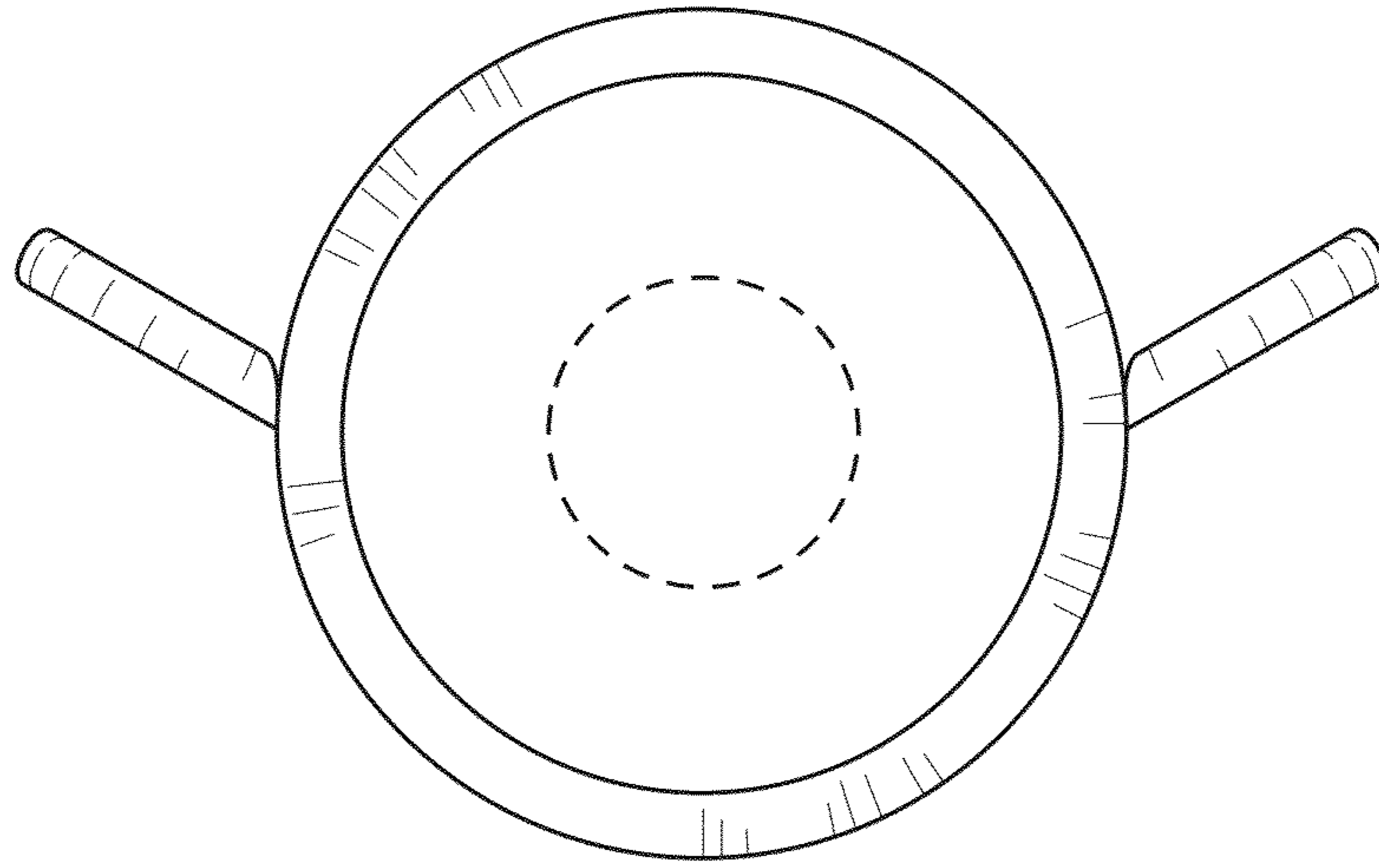

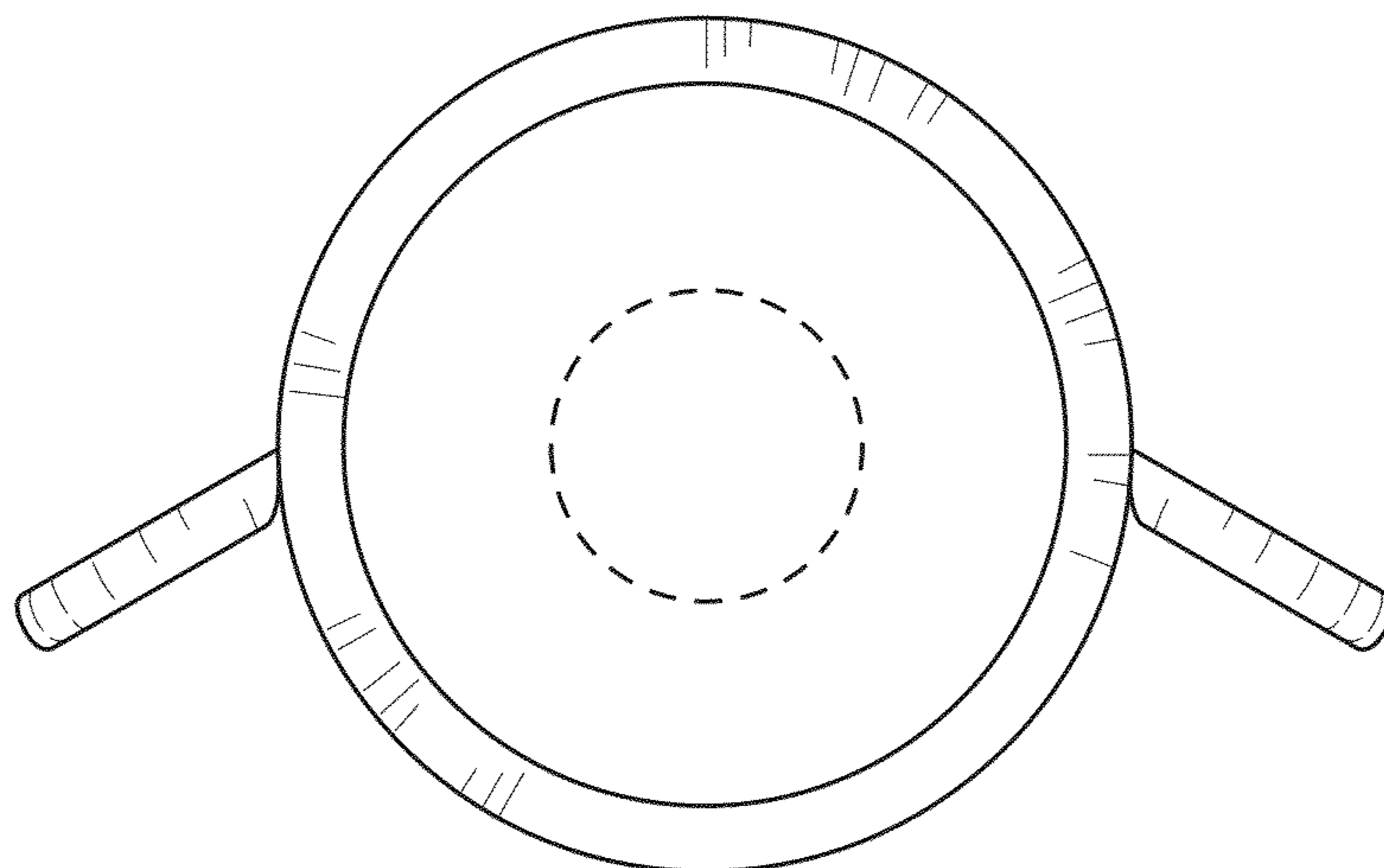
