DESCRIPTION

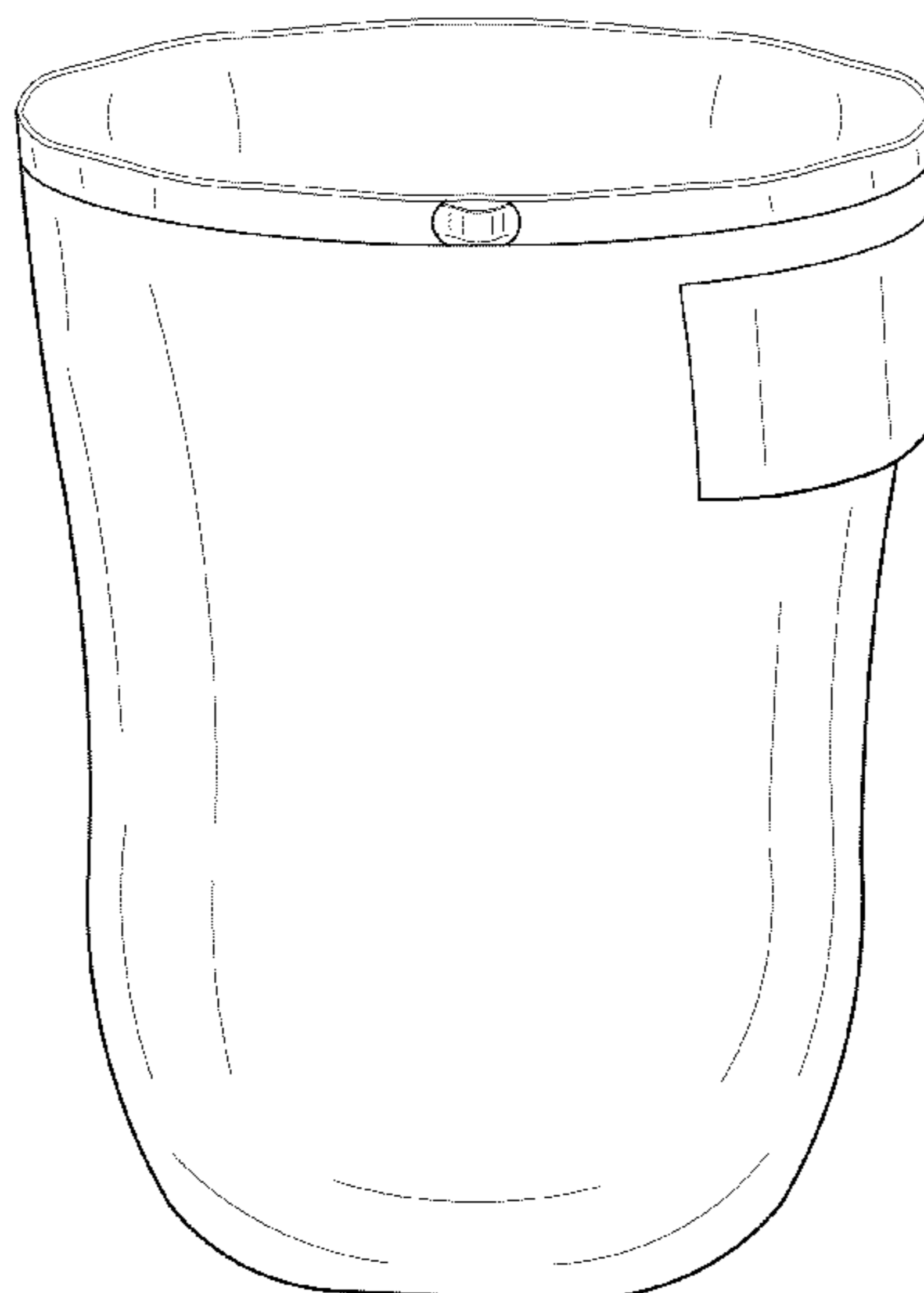
FIG. 1 is a perspective view of a trash/waste bag with extra flap for hanging showing my new design;
 FIG. 2 is a side view (opposite side view is mirror image) thereof;

 FIG. 6 is a bottom view thereof; and,
 FIG. 7 is another perspective view showing the trash/waste bag with extra flap for hanging in use.

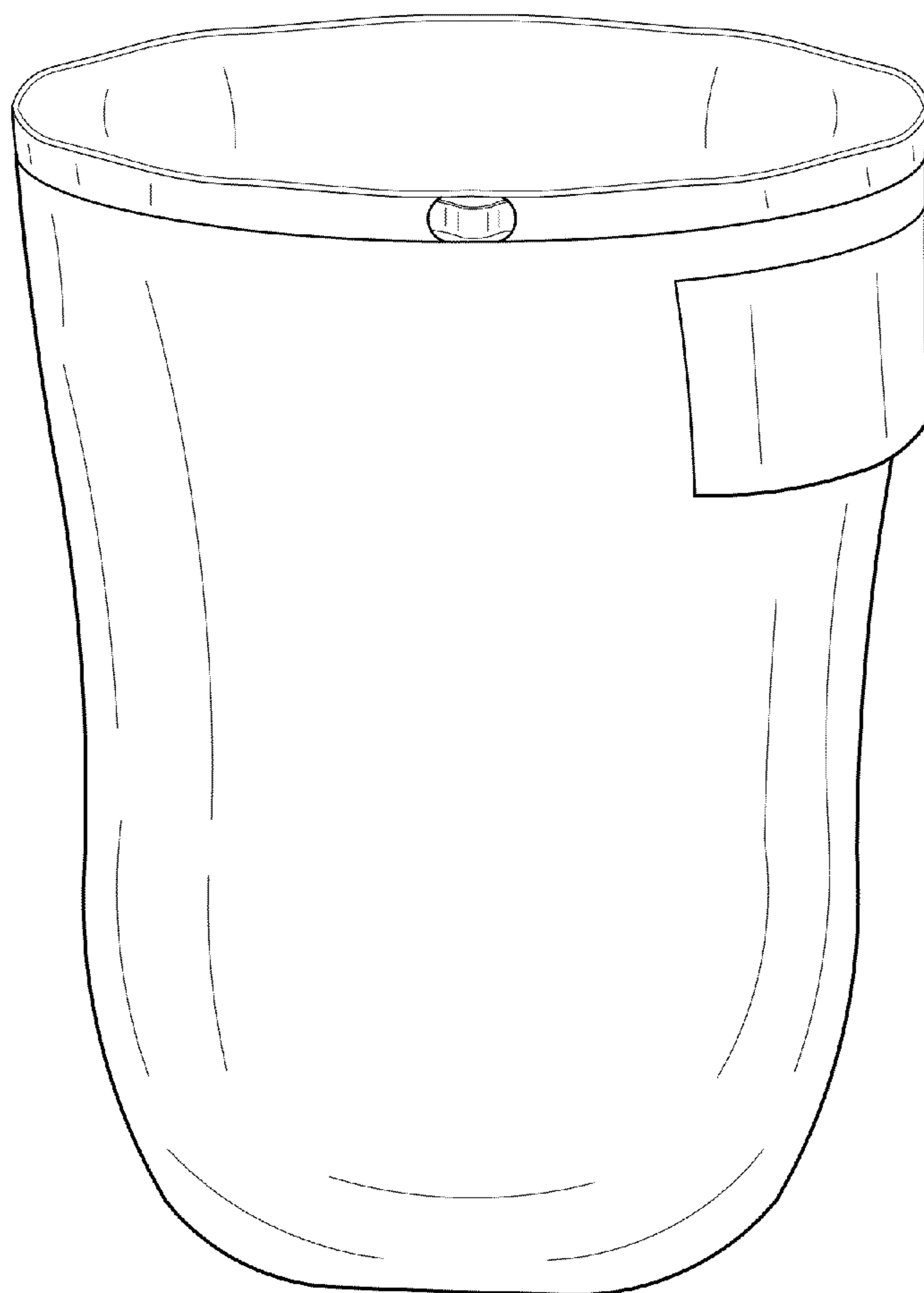

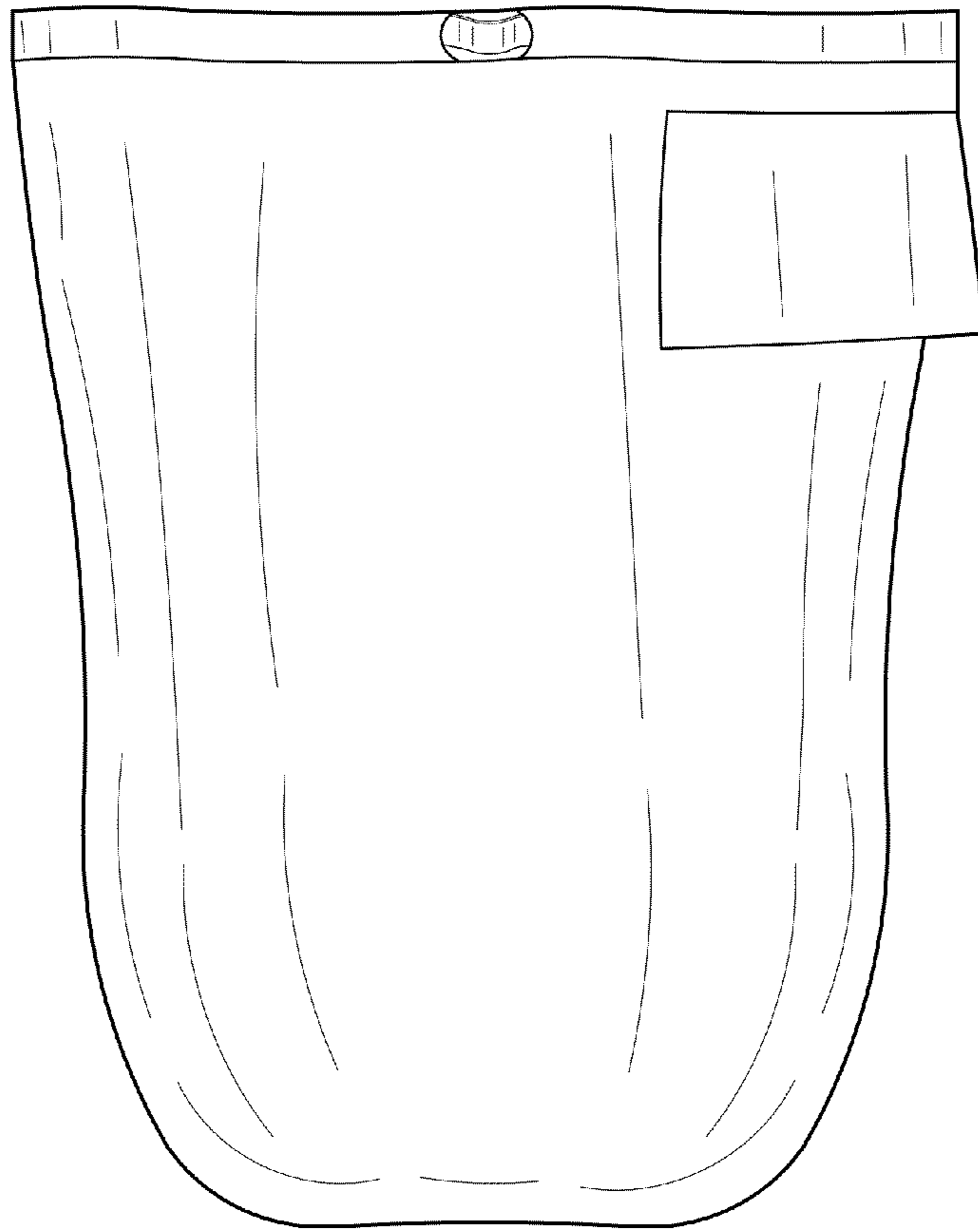

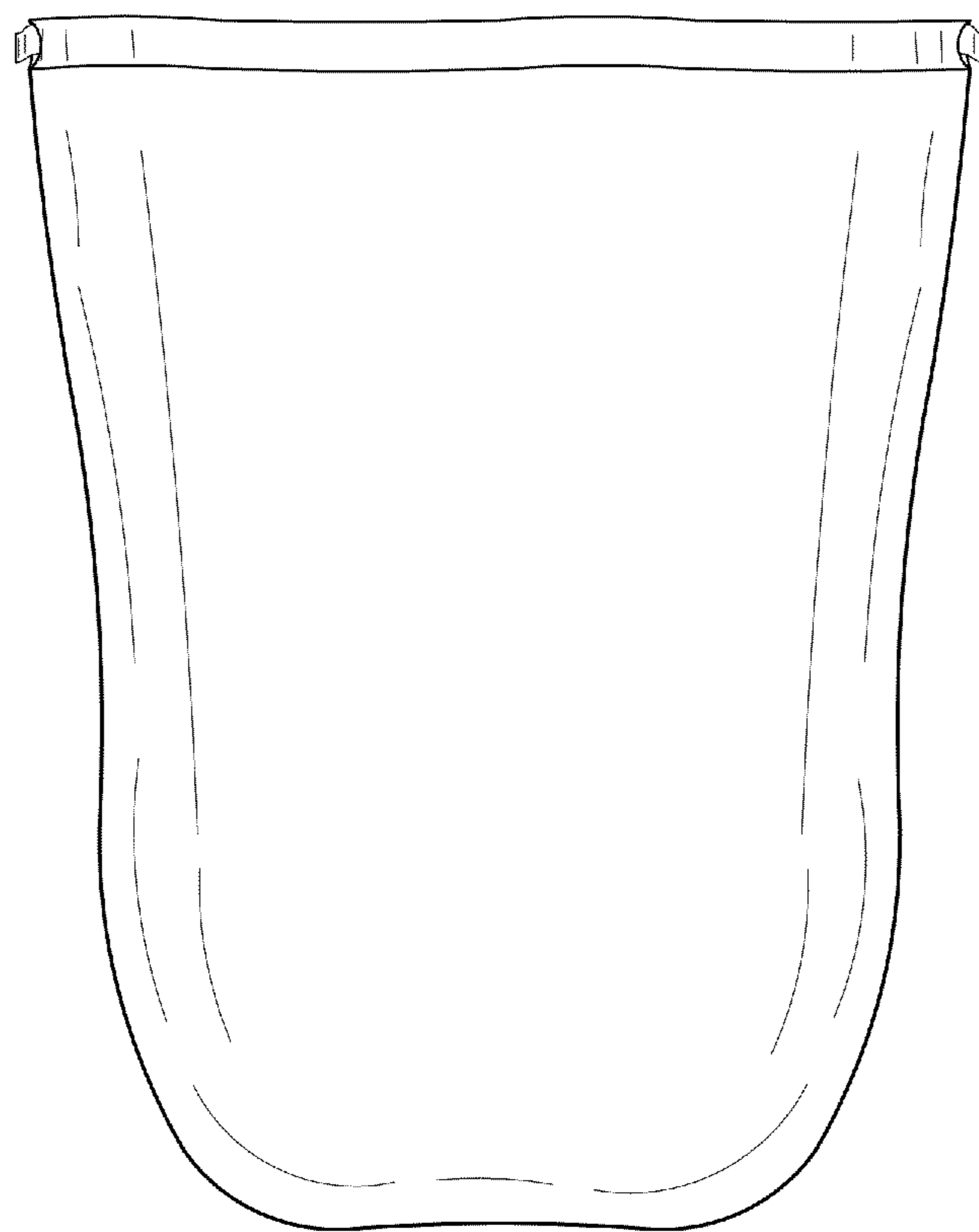

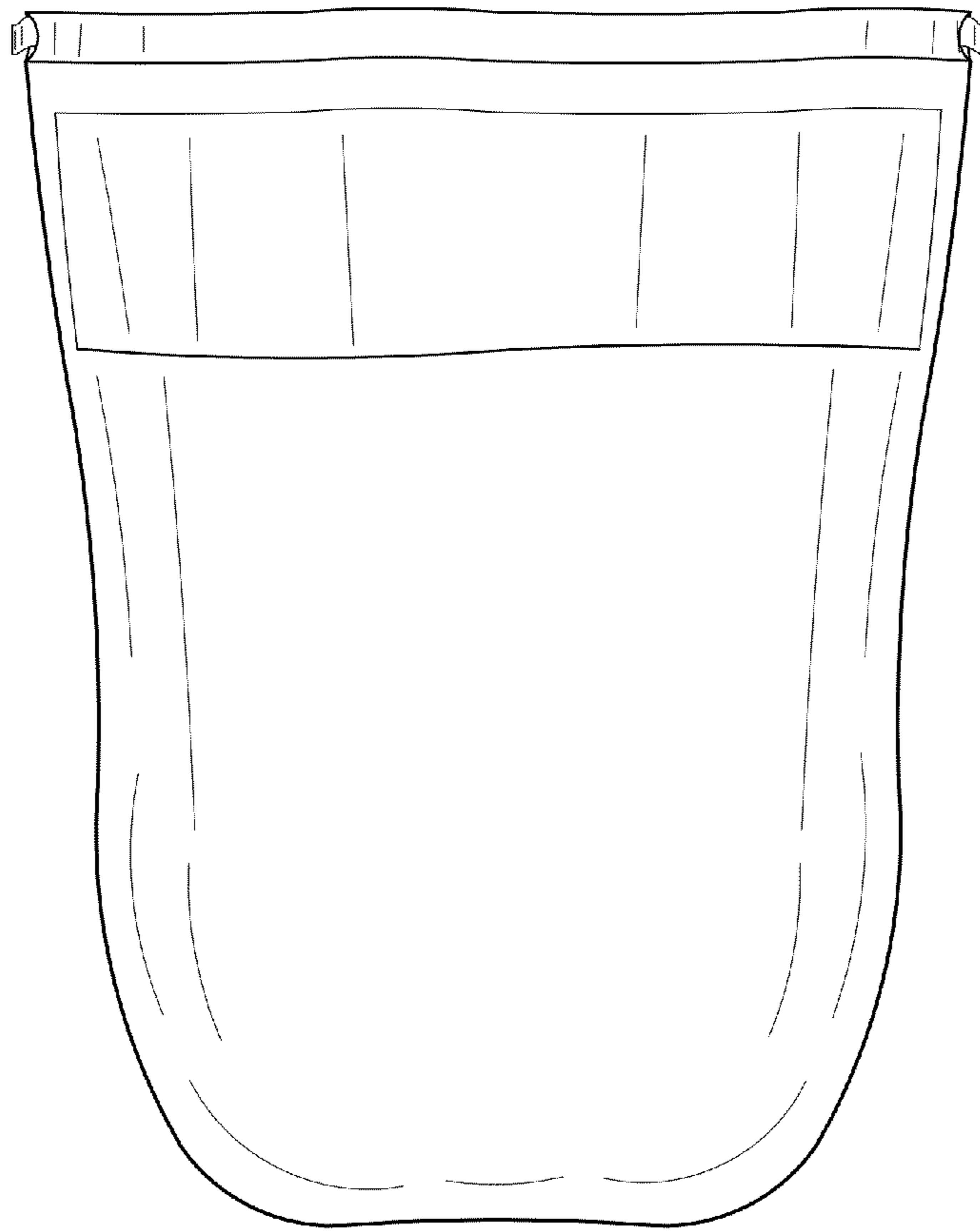

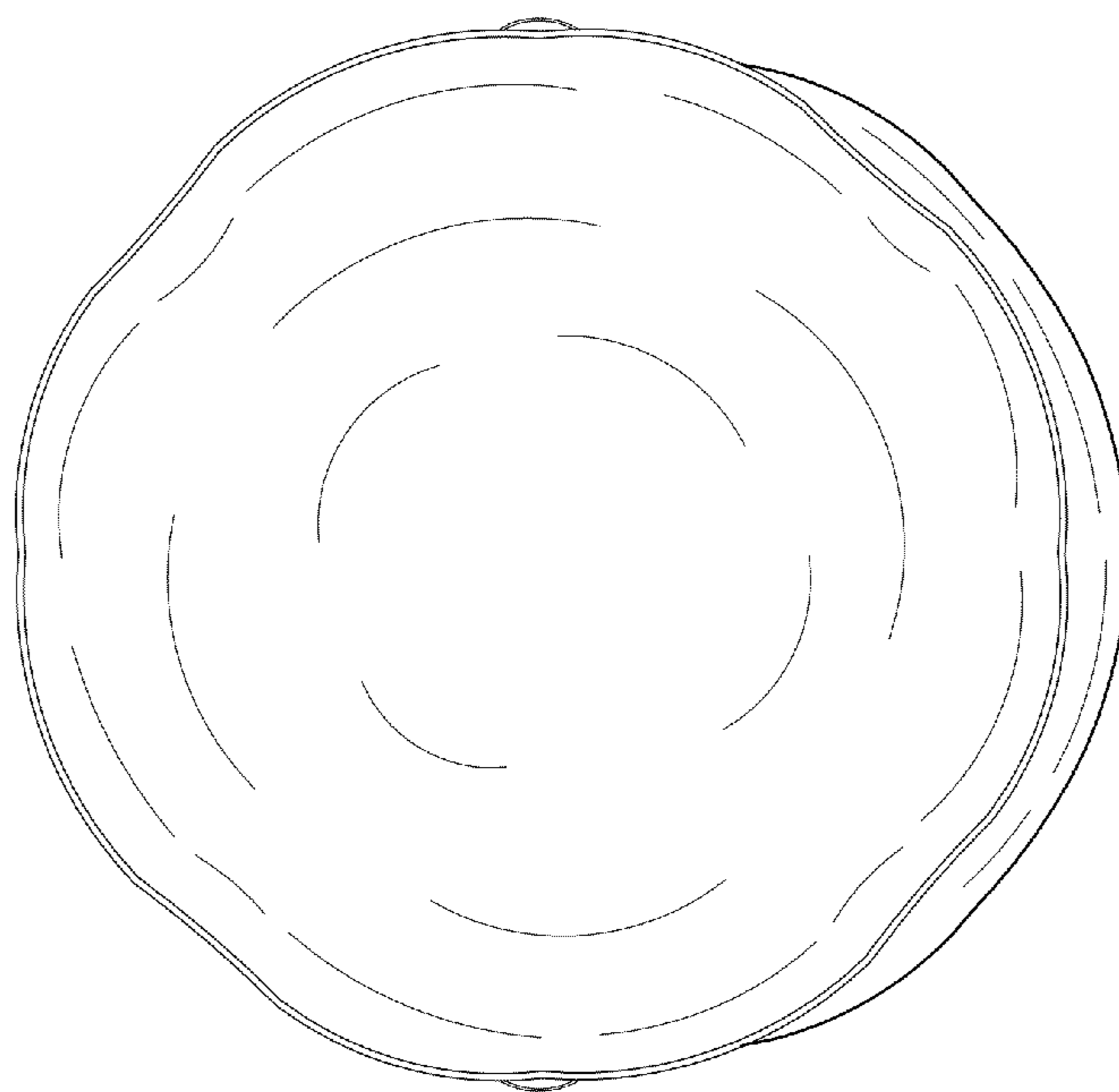
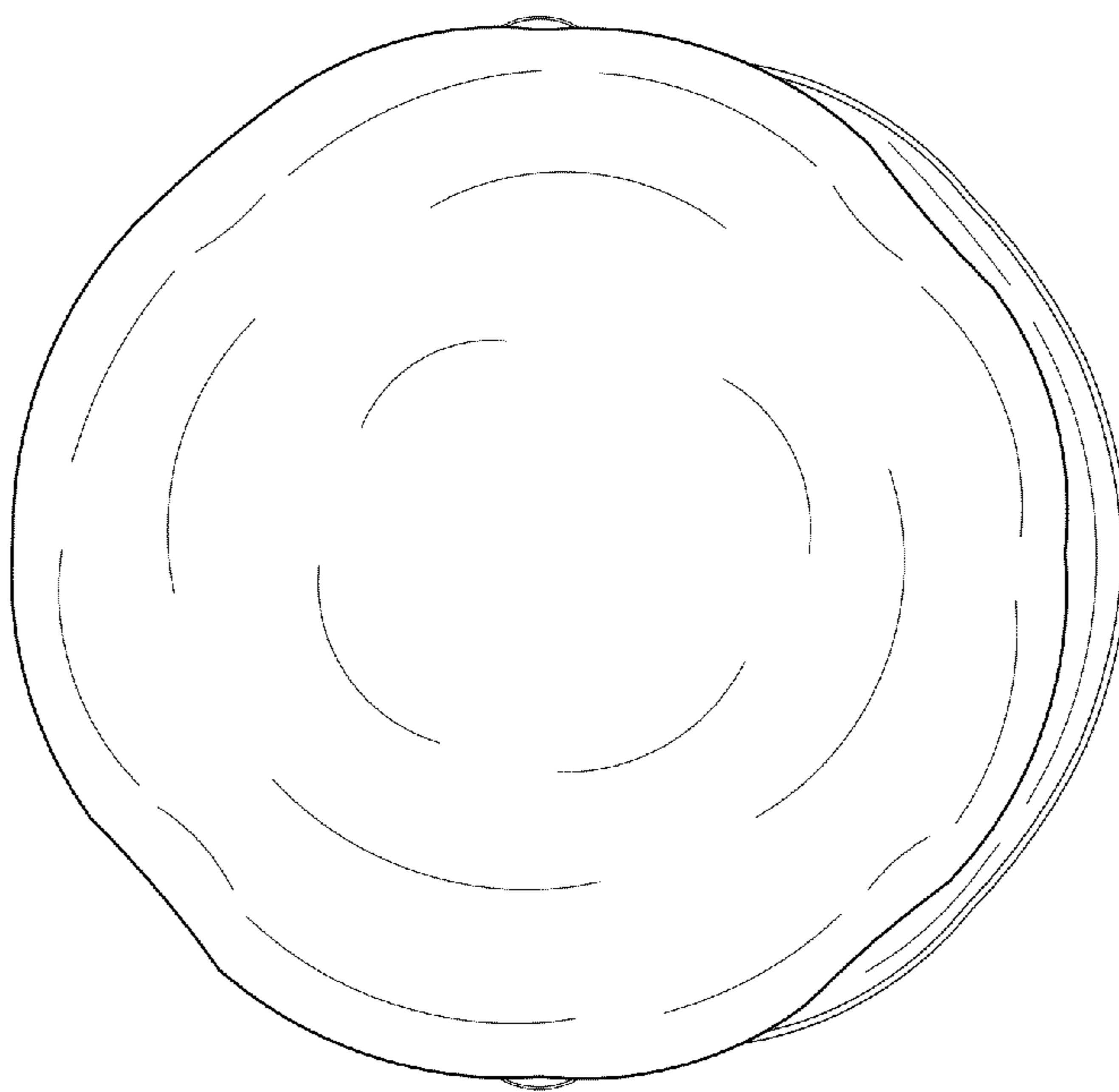

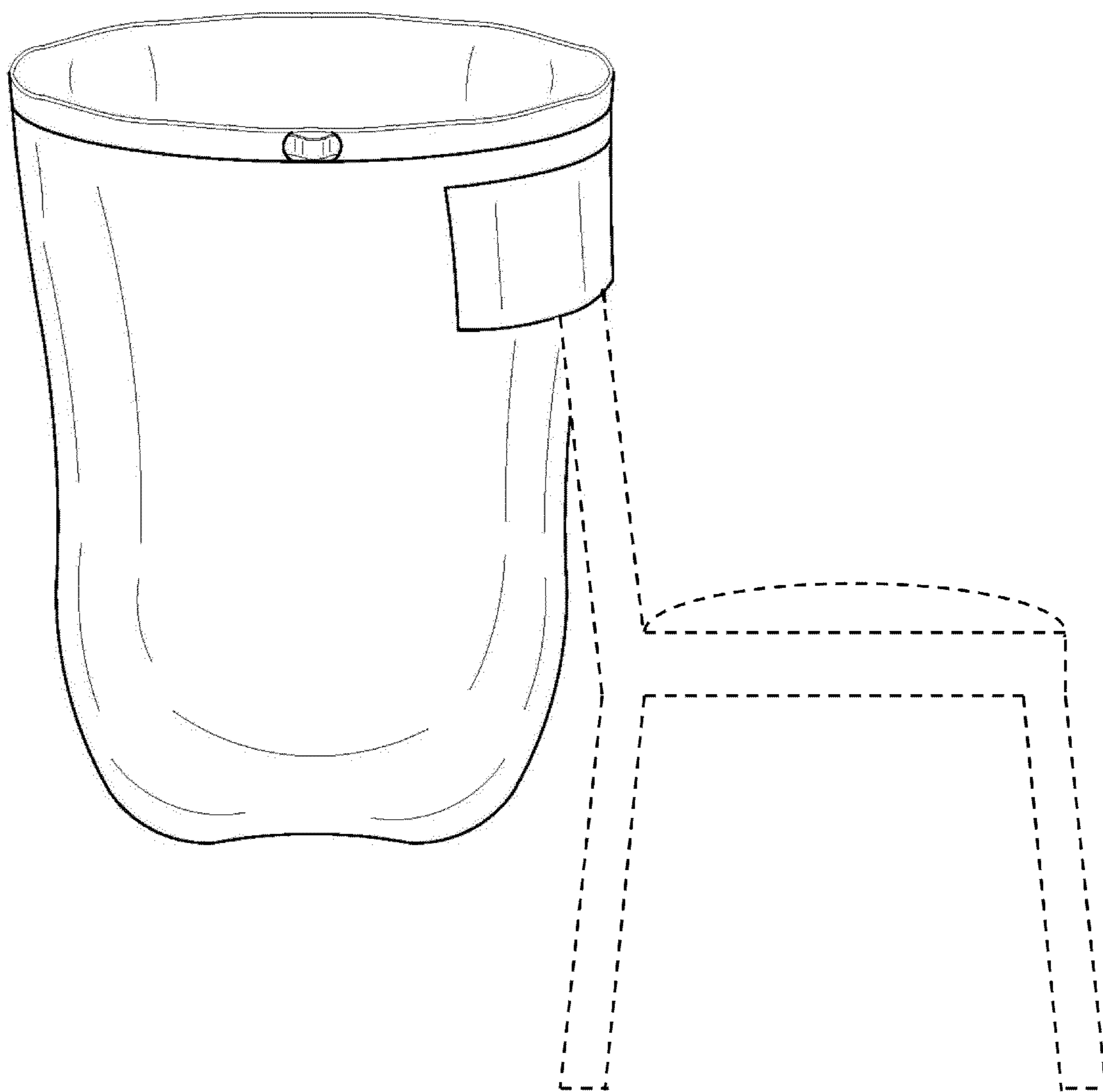
