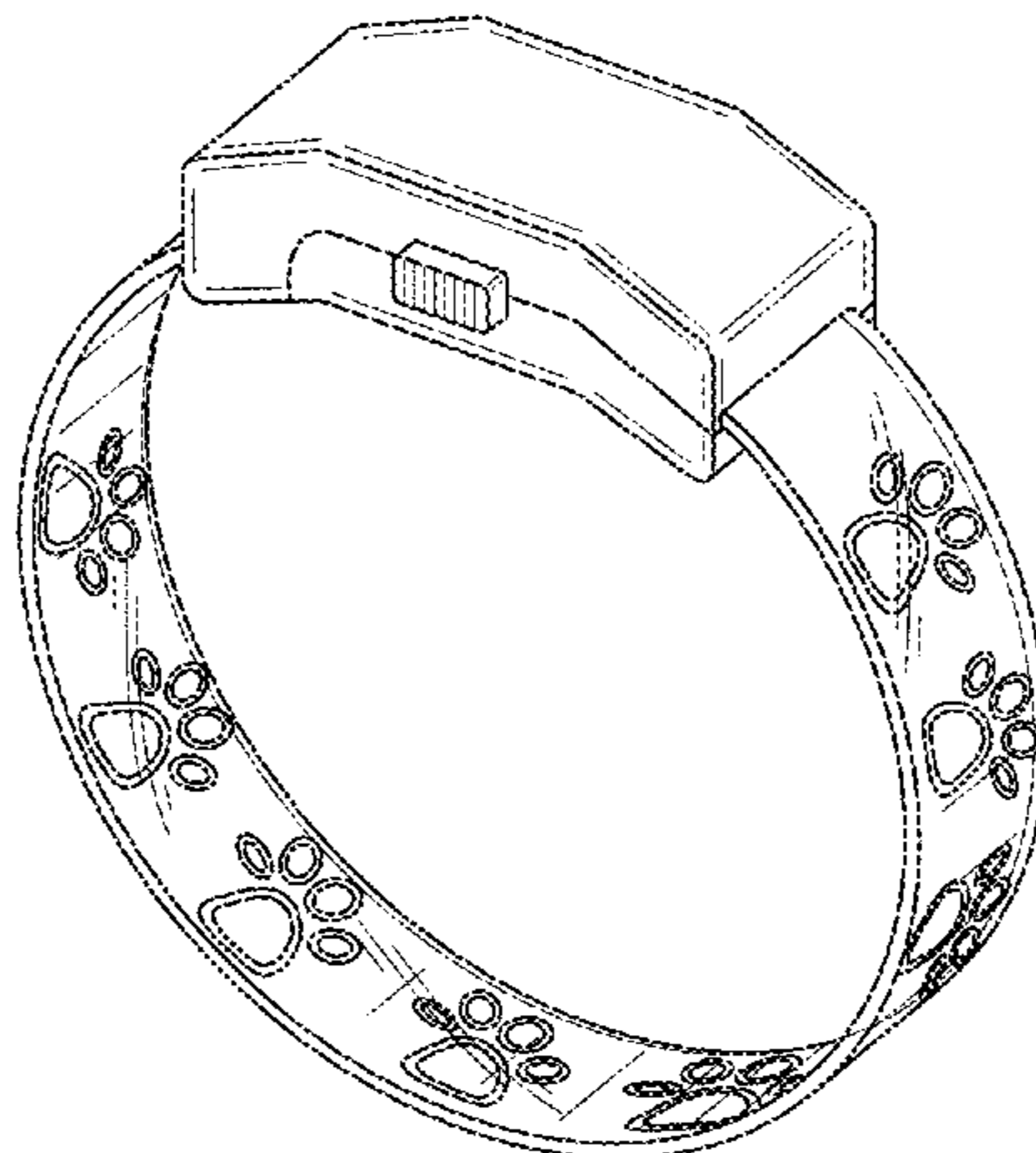

What is claimed is the ornamental design for a novelty bracelet, as shown and described.

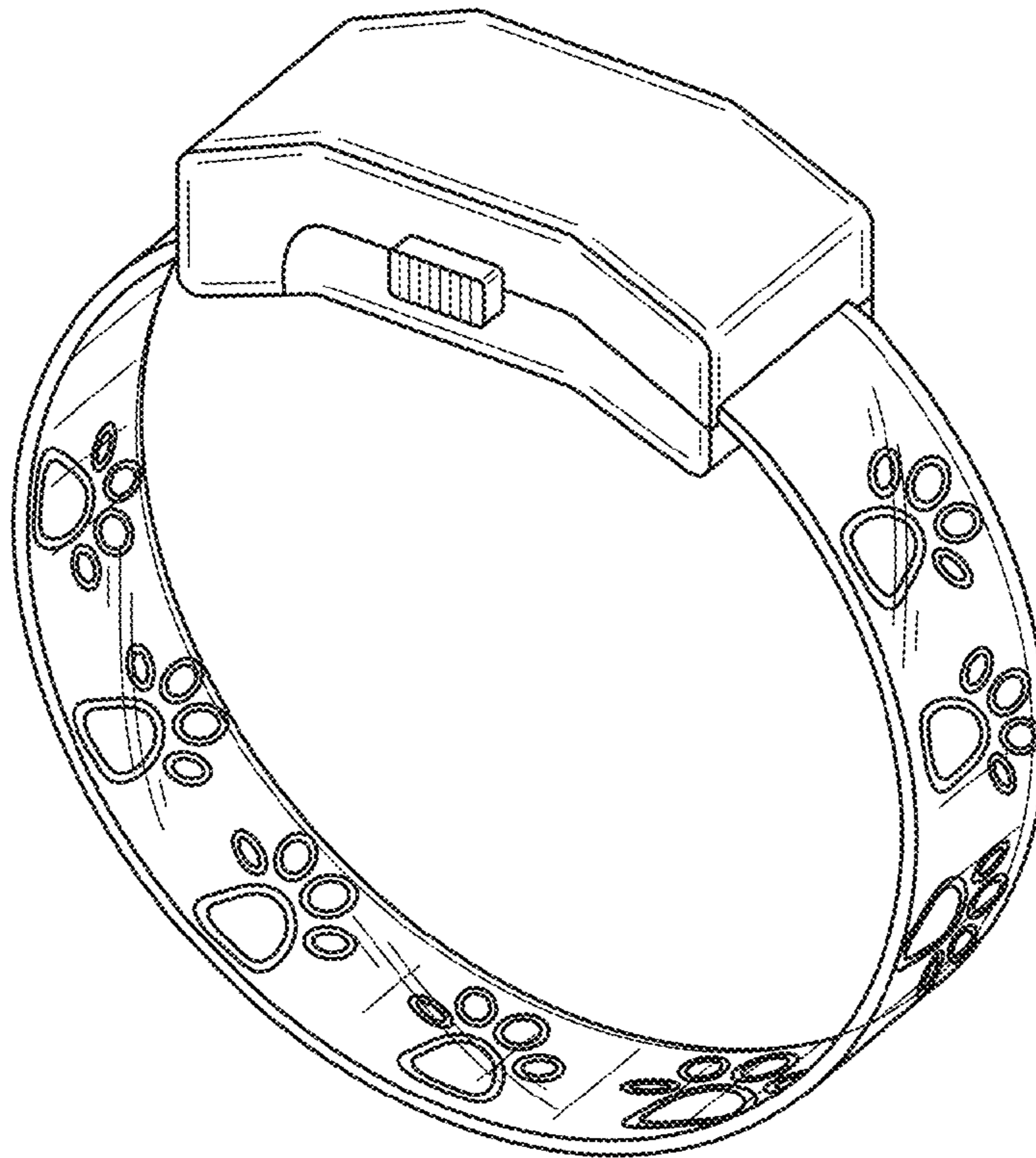

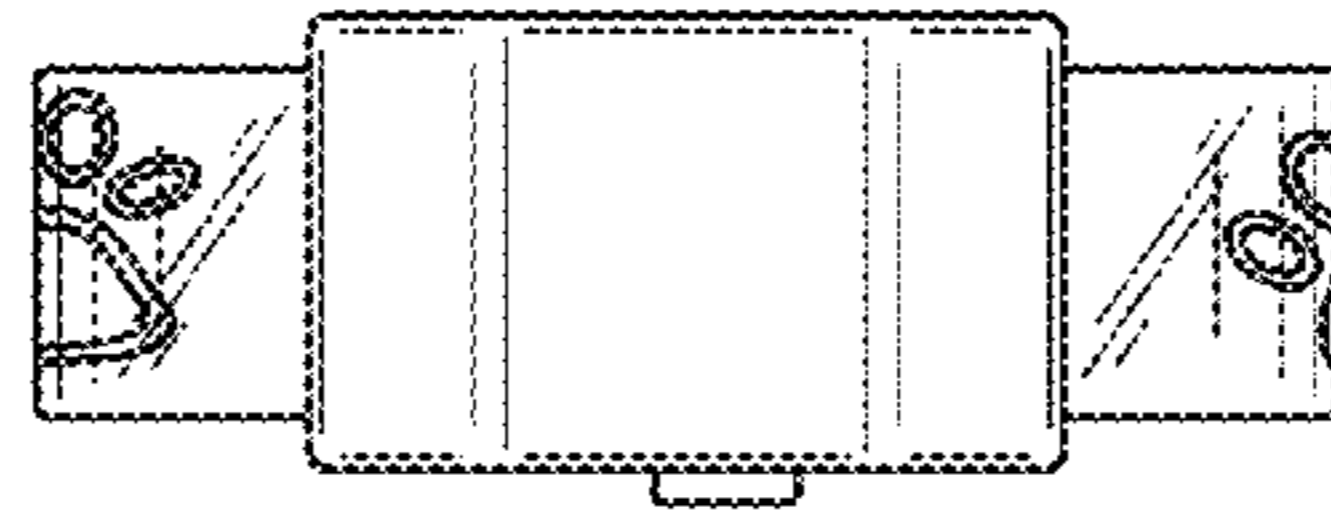

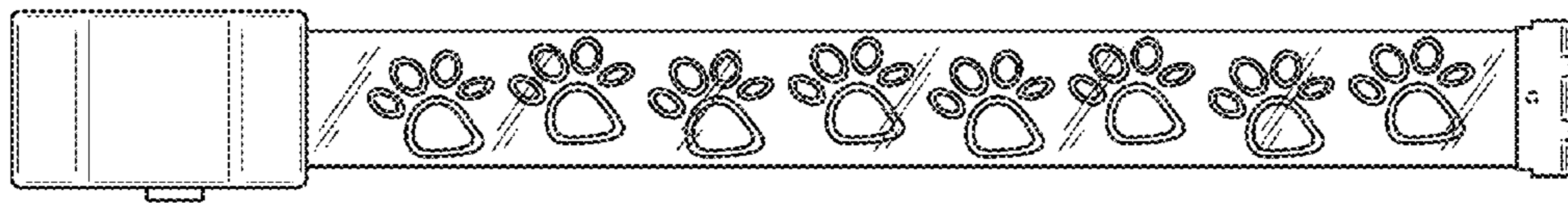

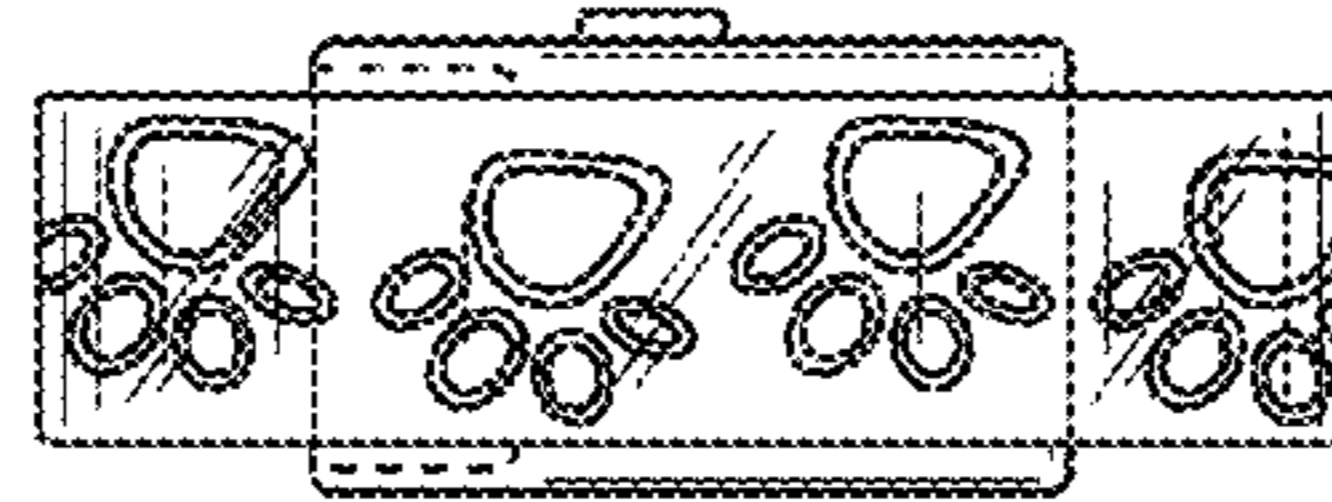

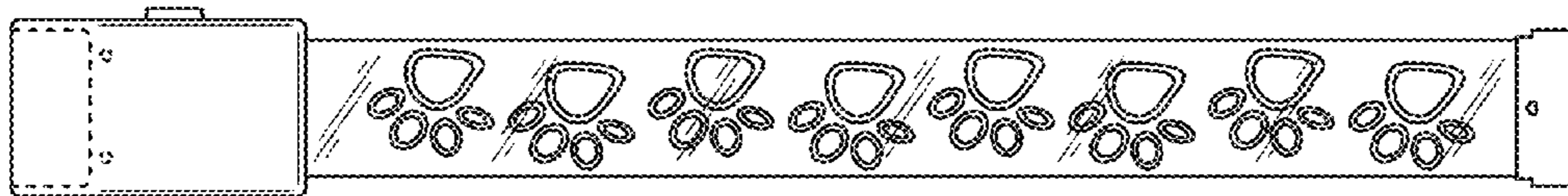

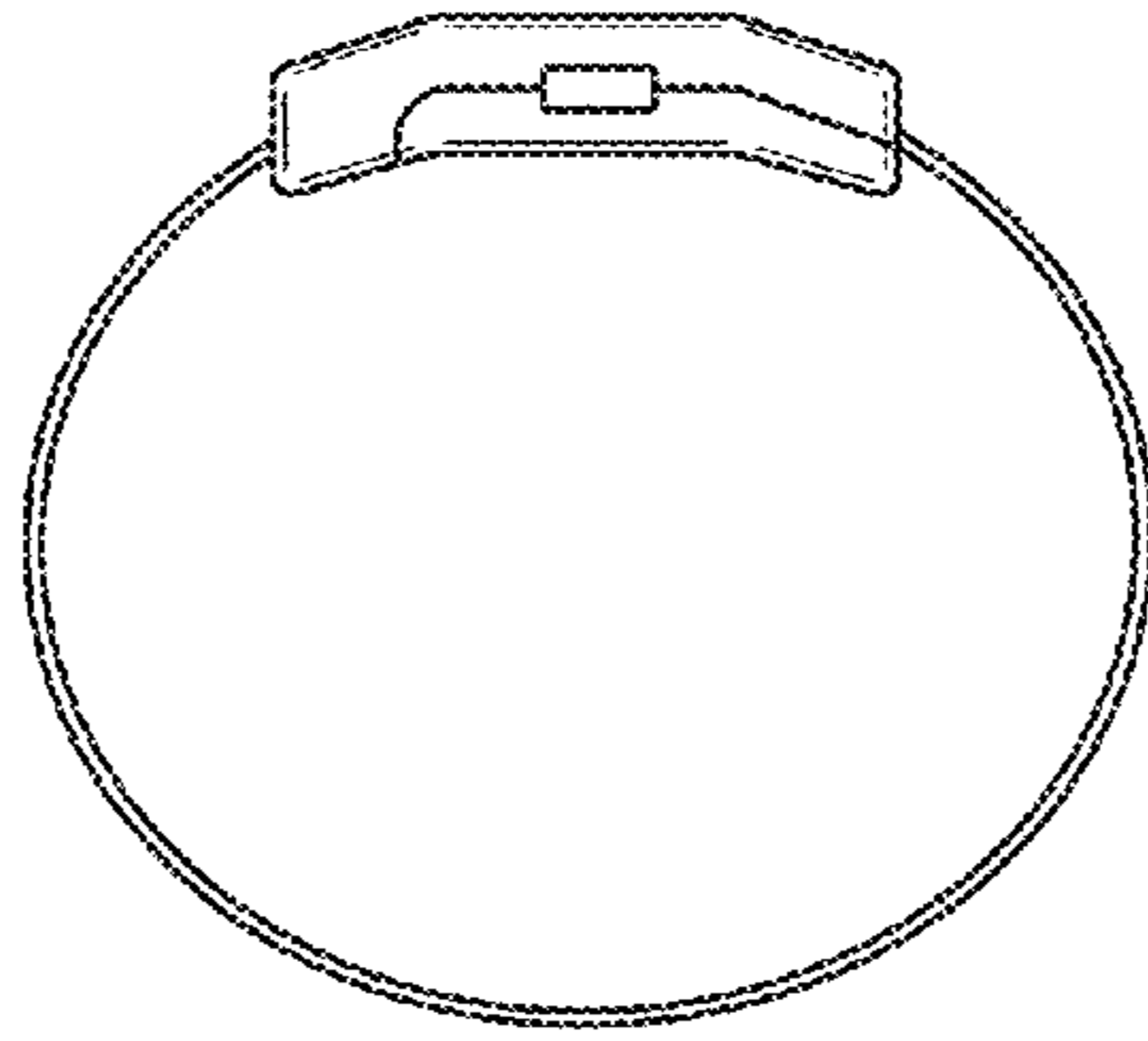

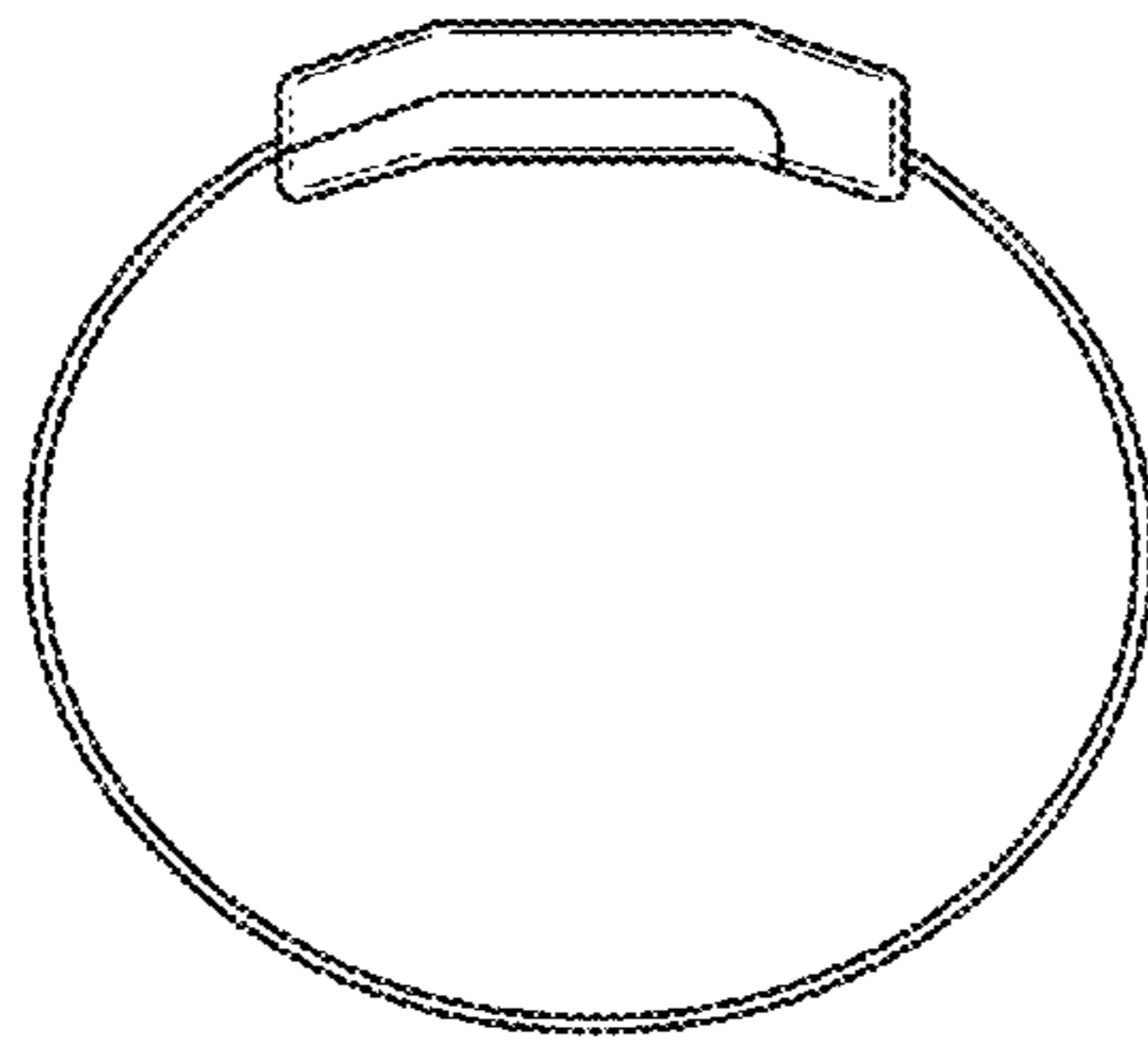

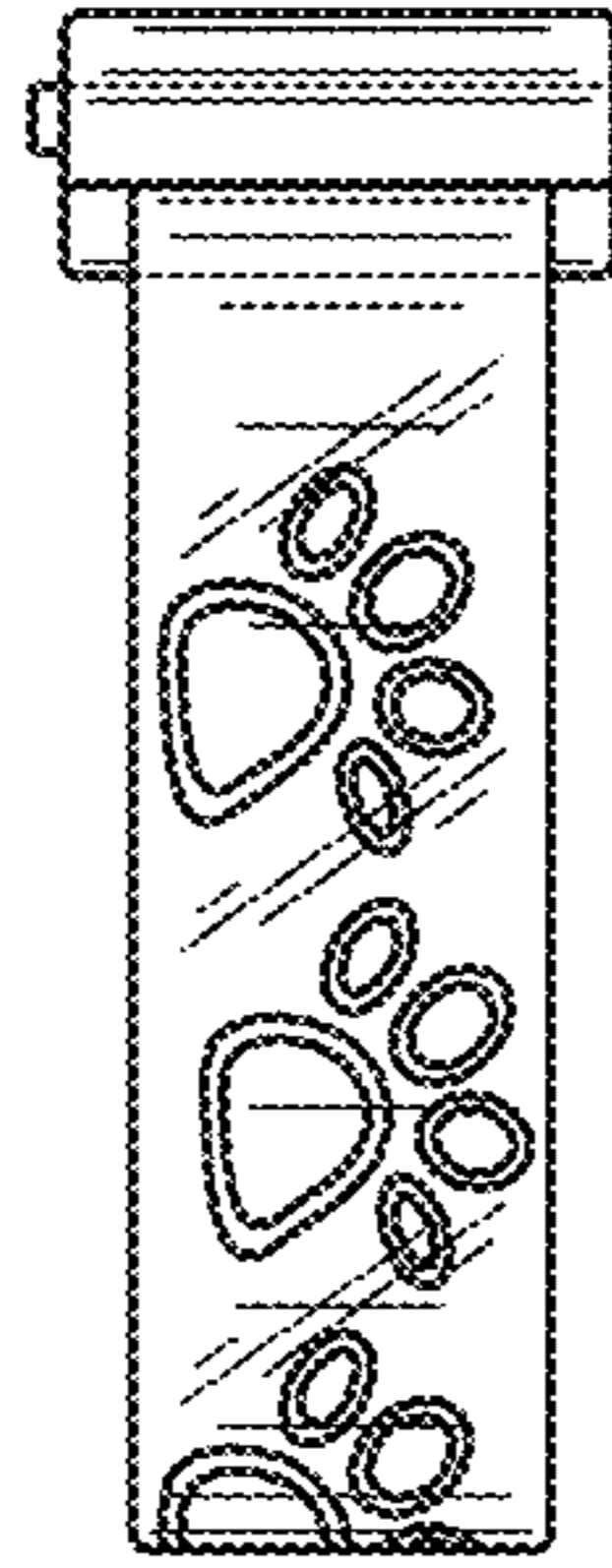

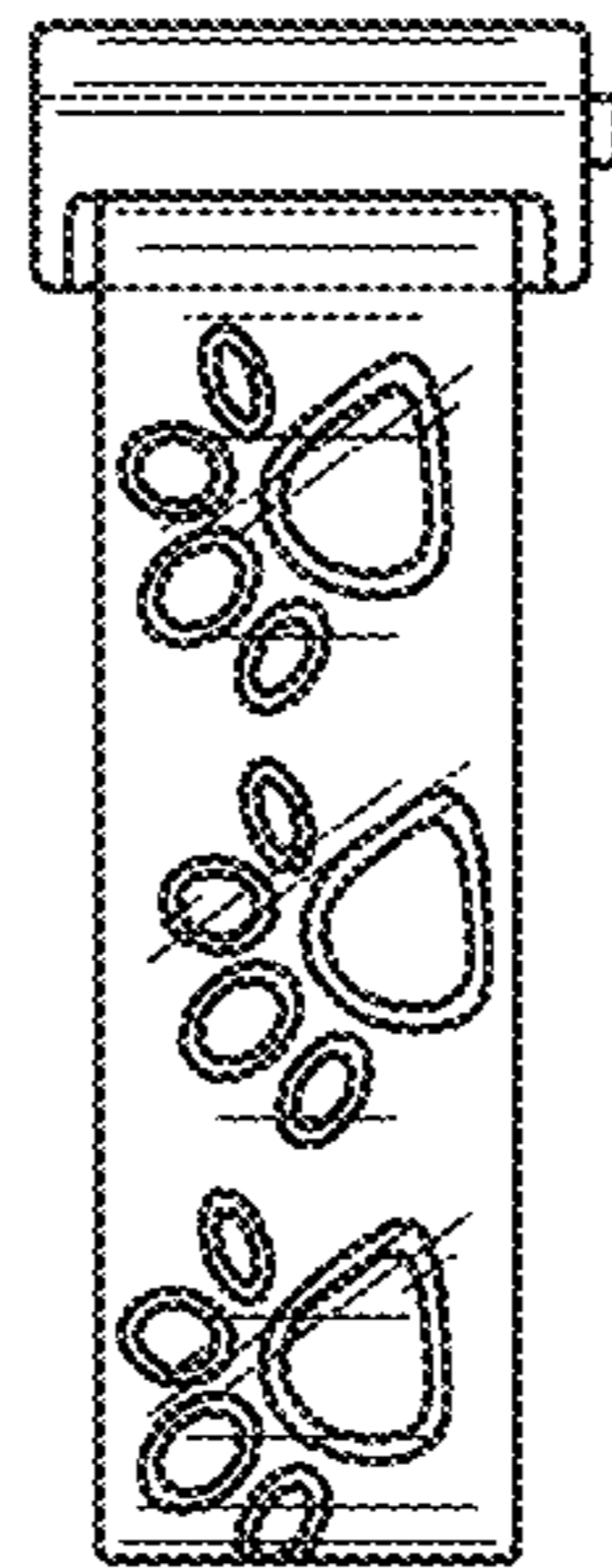
