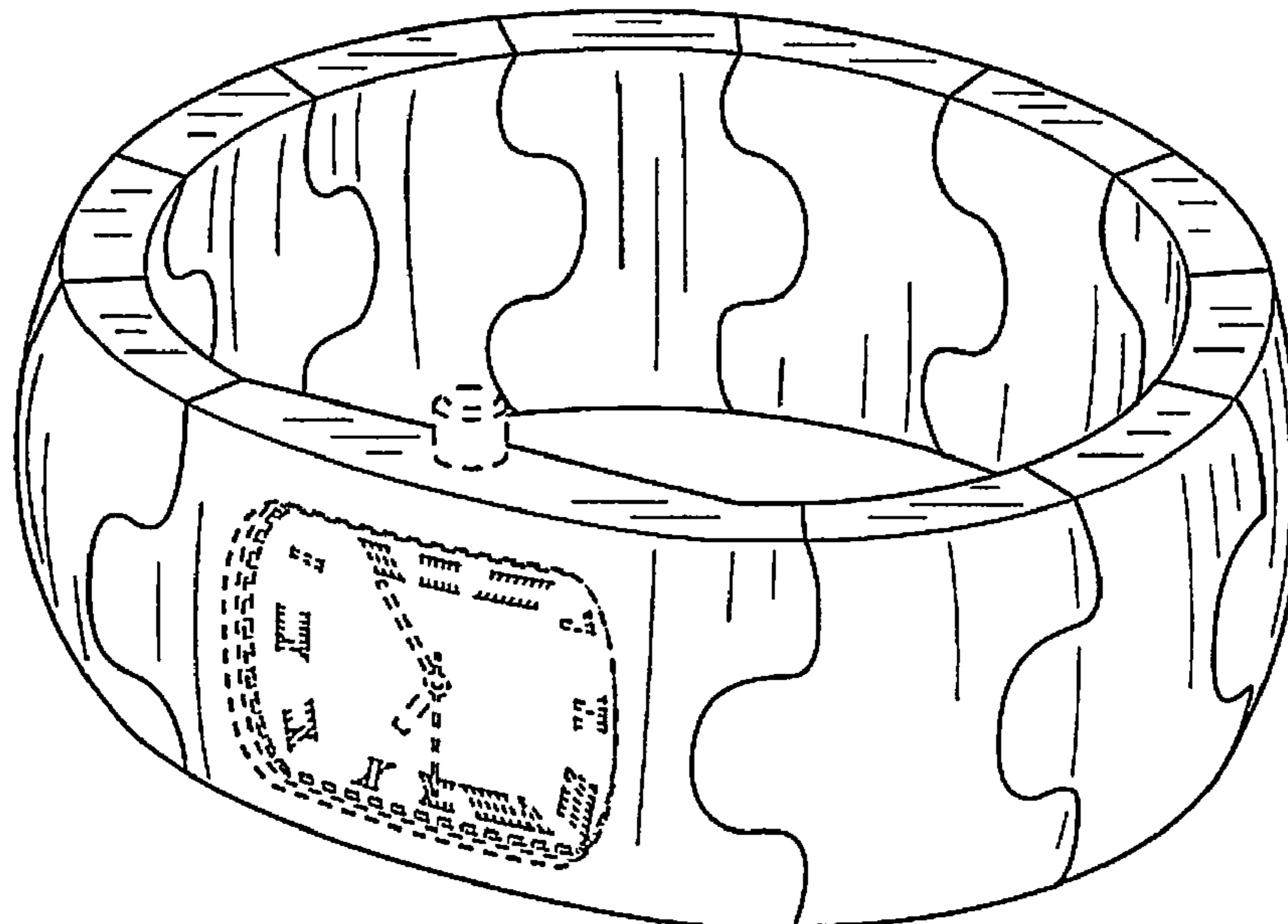
(57) **CLAIM**

I claim the ornamental design for a watch bracelet, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of a watch bracelet showing the new design;
FIG. 2 is a top view of the watch bracelet of FIG. 1;
FIG. 3 is a bottom view of the watch bracelet of FIG. 1;
FIG. 4 is a right side view of the watch bracelet of FIG. 1;
FIG. 5 is the left side view of the watch bracelet of FIG. 1;
FIG. 6 is a top view of the watch bracelet of FIG. 1; and
FIG. 7 is a bottom view of the watch bracelet of FIG. 1.
The broken lines shown in FIGS. 1-7 represent portions of the watch bracelet that form no part of the claimed design.

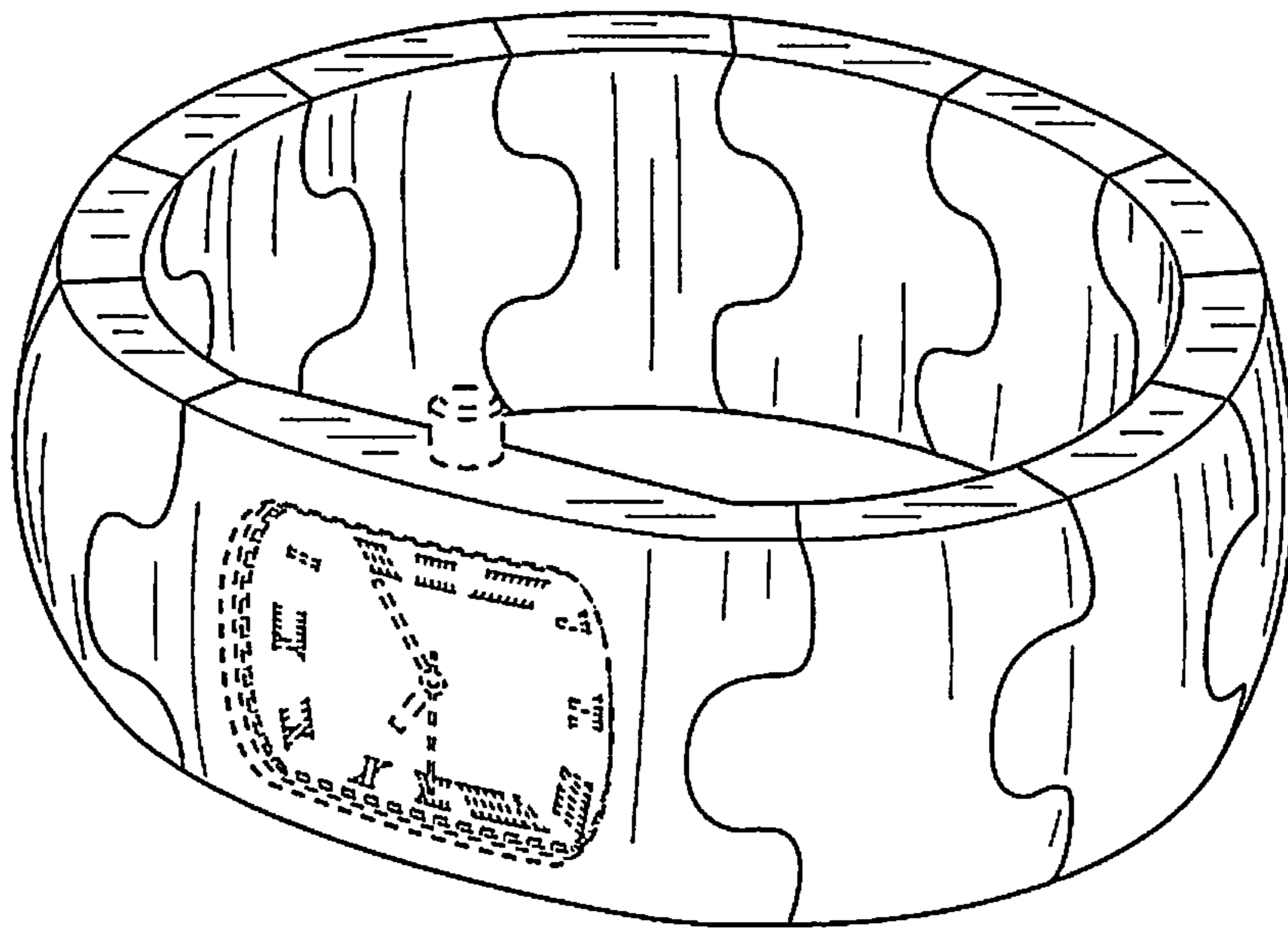

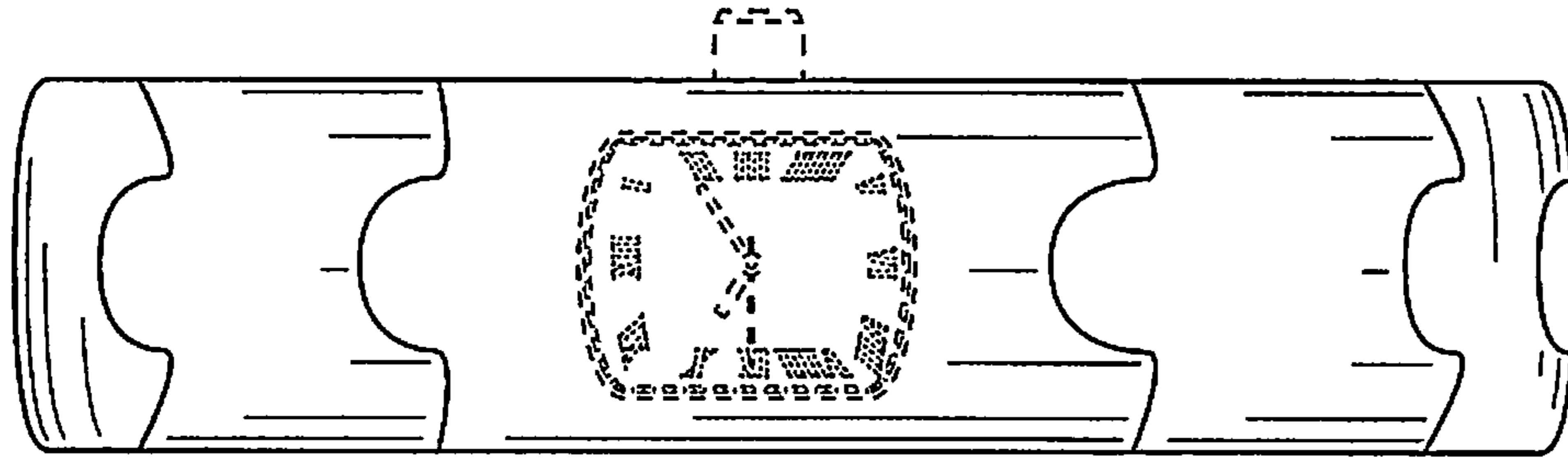

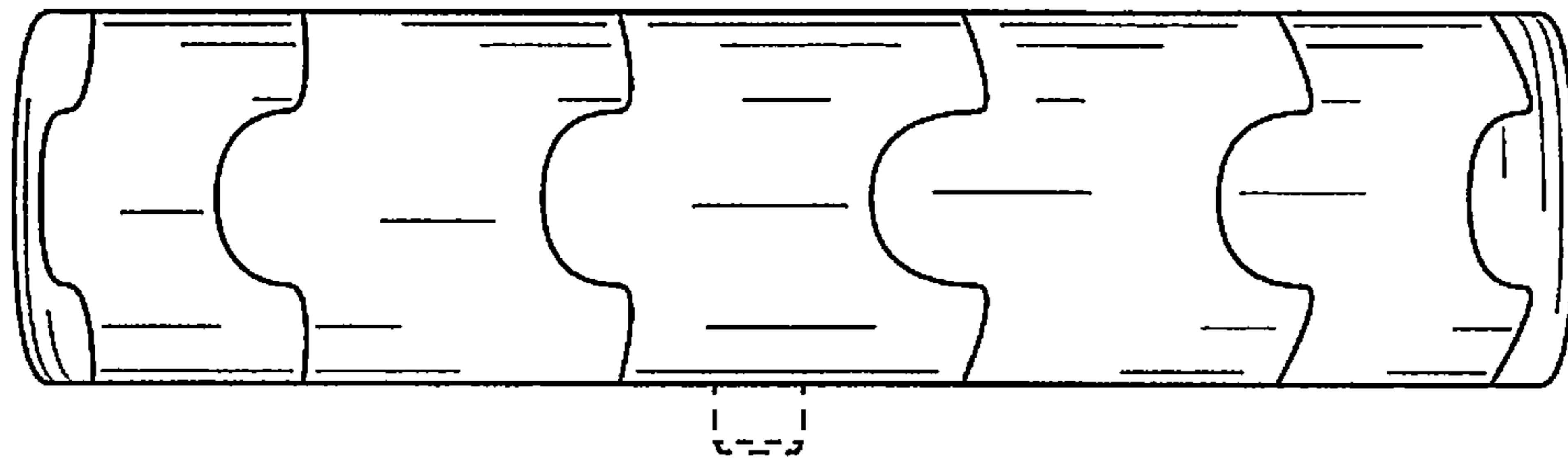

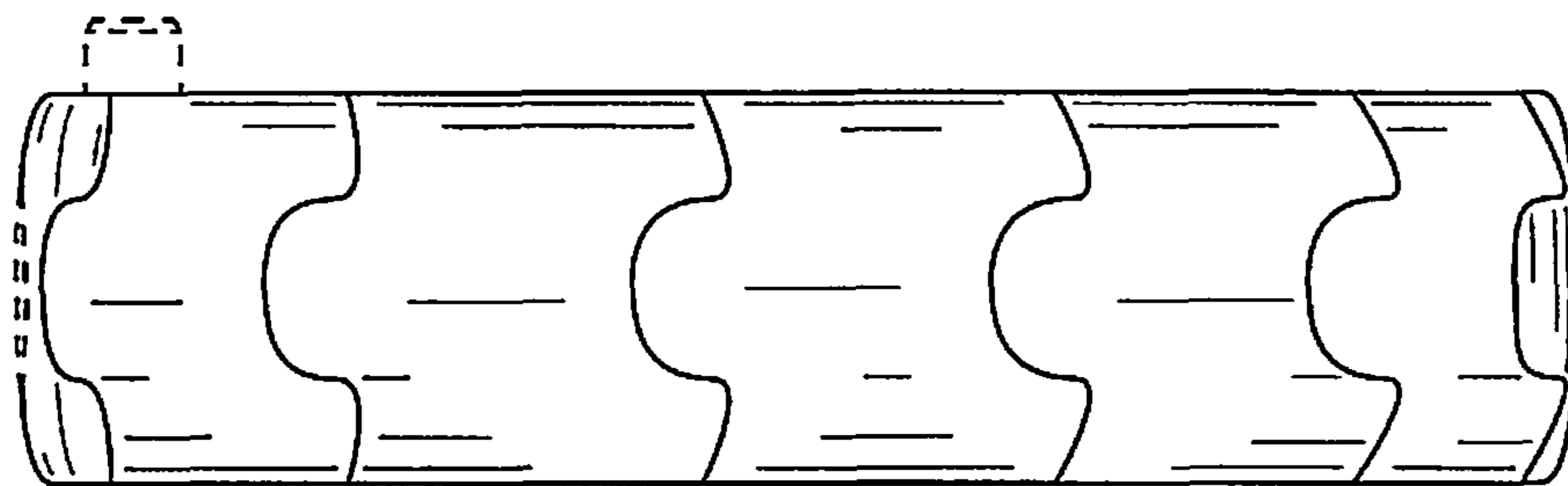

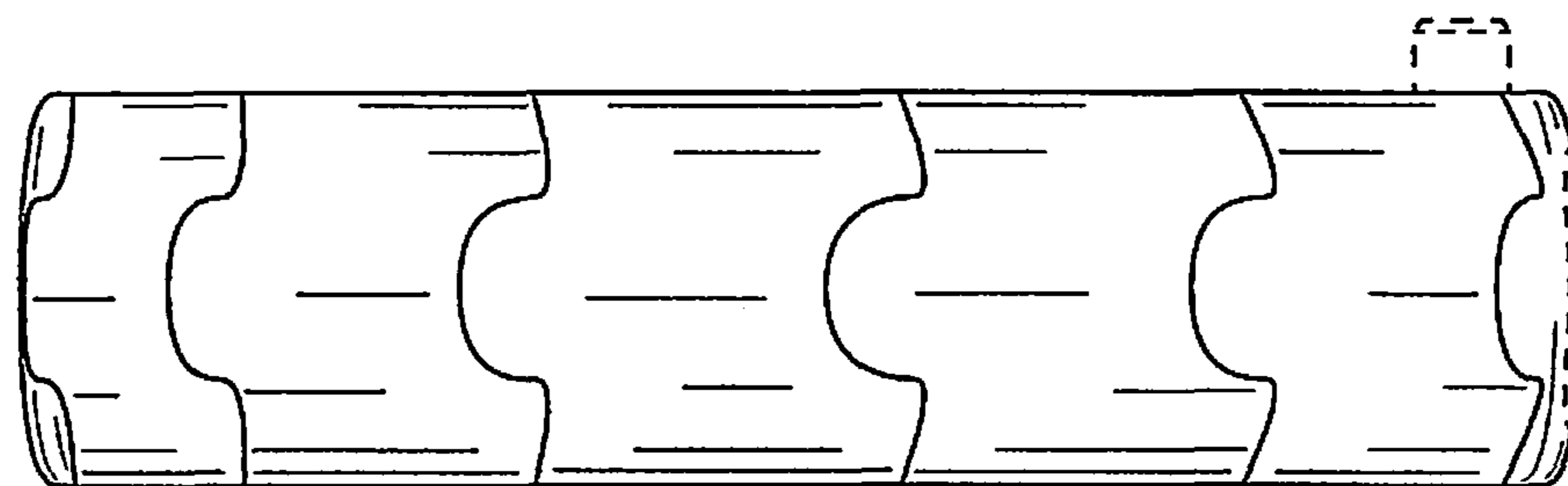

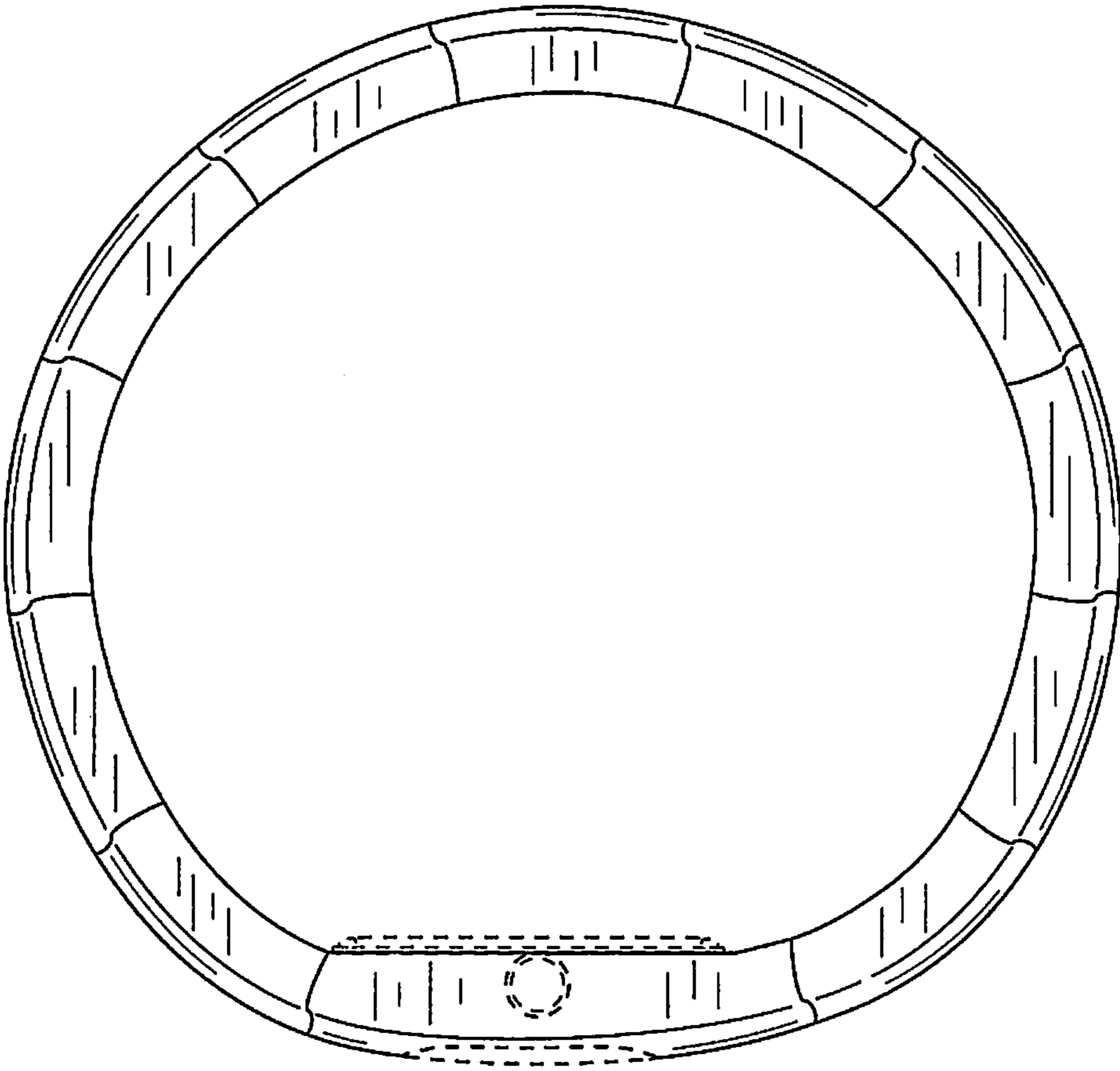

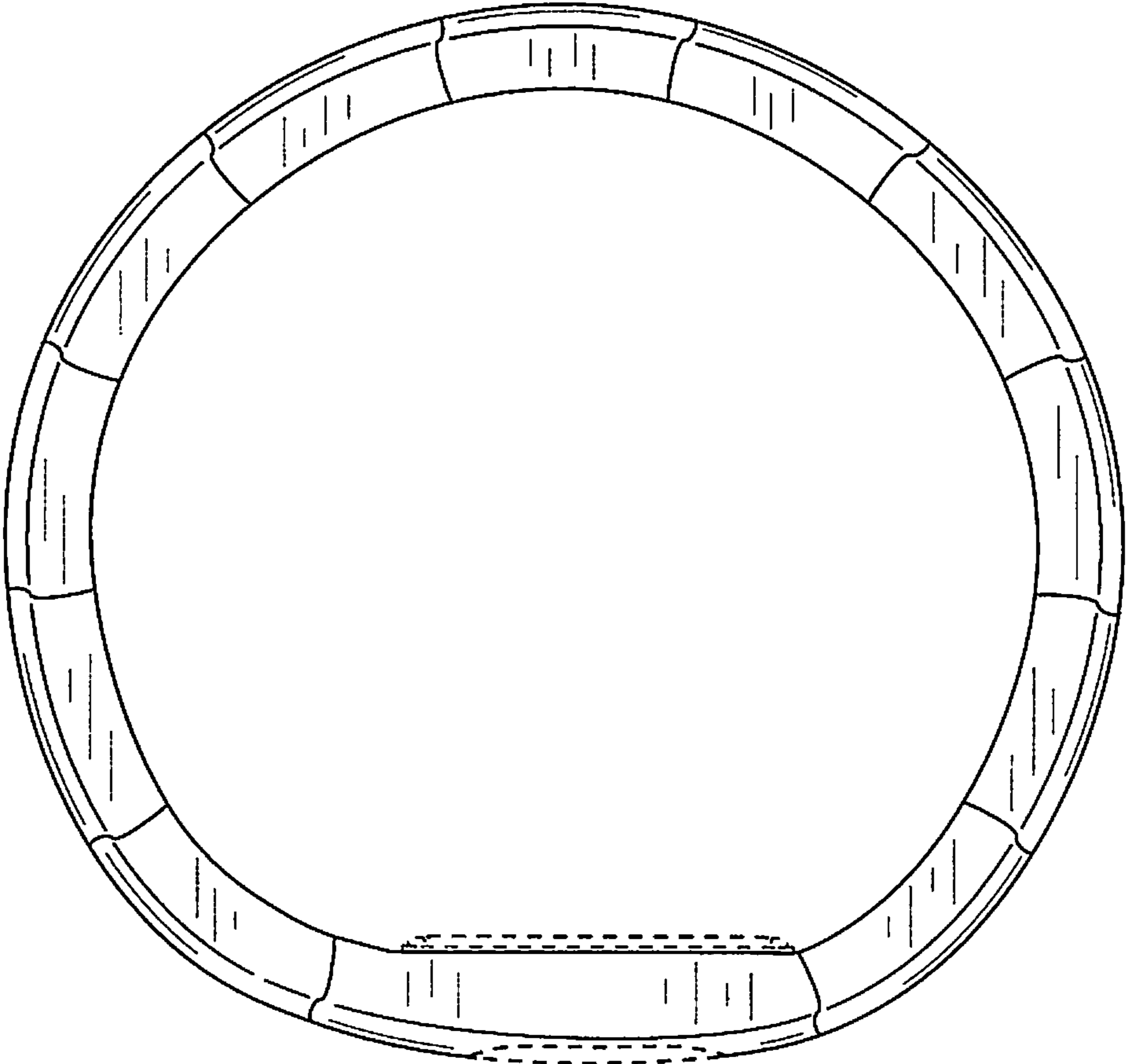
