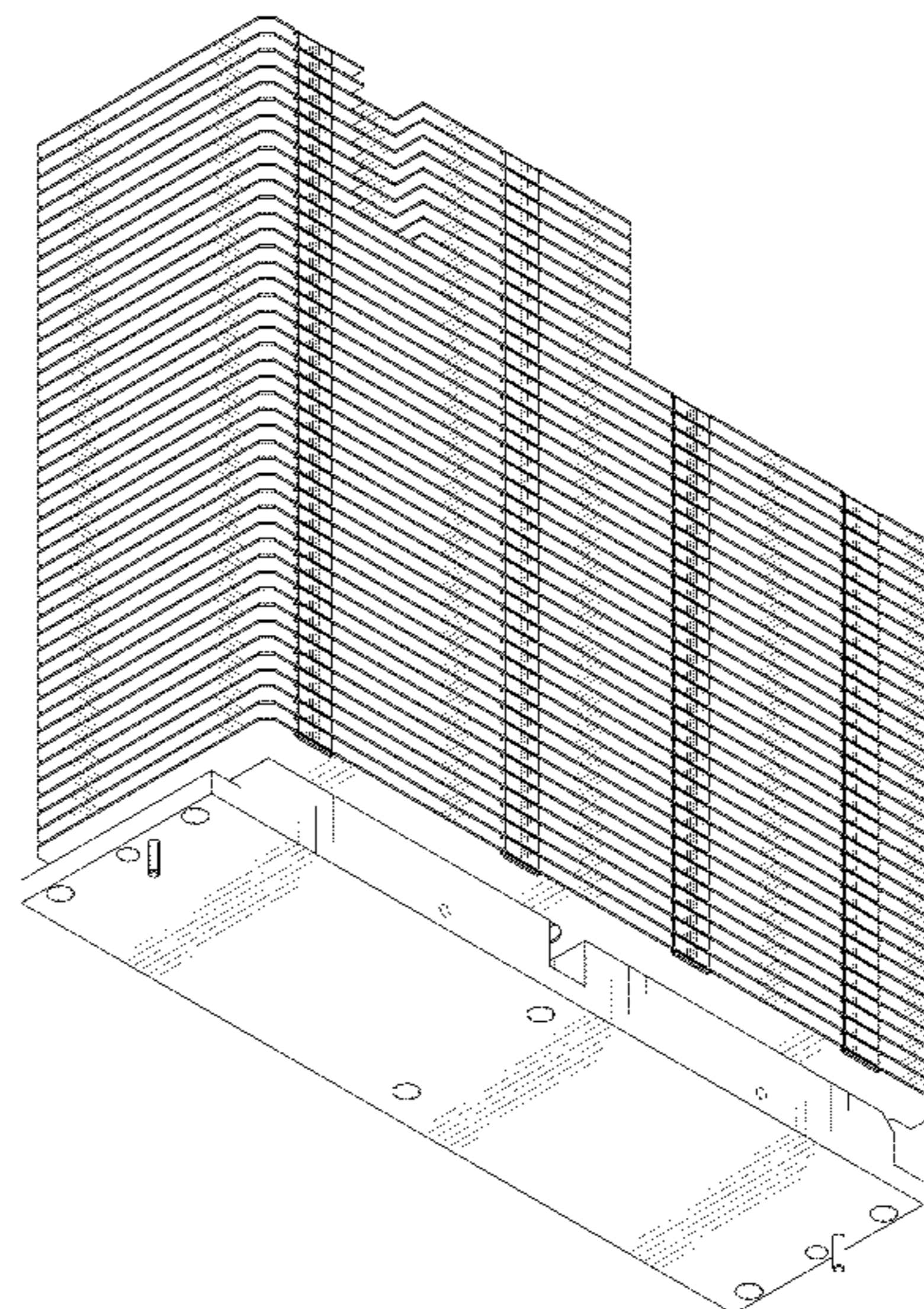
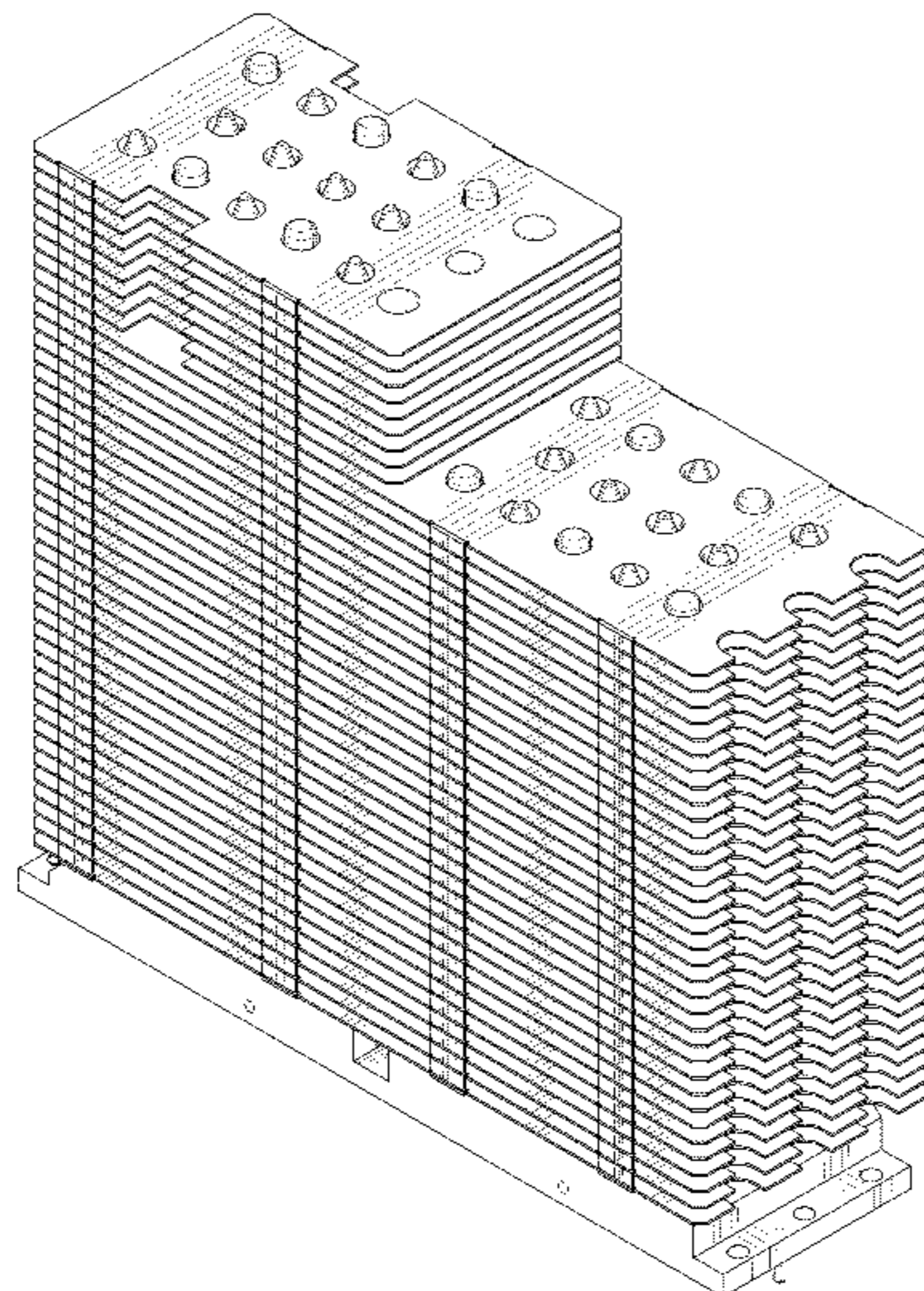
(57) **CLAIM**

The ornamental design for a high performance high power tower heat sink, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a high performance high power tower heat sink showing our new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a right side elevational view thereof; FIG. 8 is a disassembled view corresponding to the high performance high power tower heat sink of FIG. 1; and, FIG. 9 is another disassembled view corresponding to the high performance high power tower heat sink of FIG. 1. The broken line showing on the drawing disclosure is for illustrative purposes only and forms no part of the claimed design.

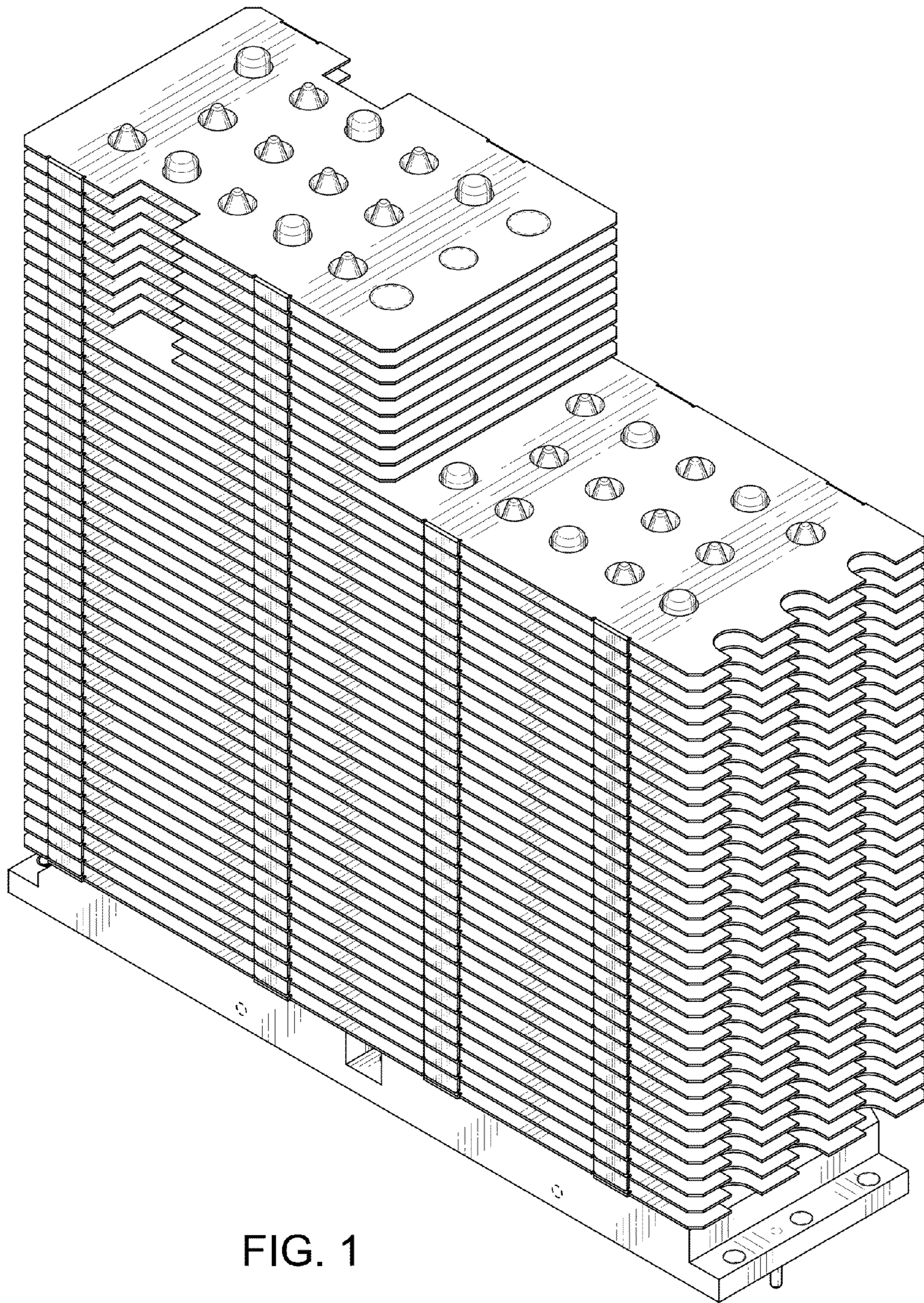

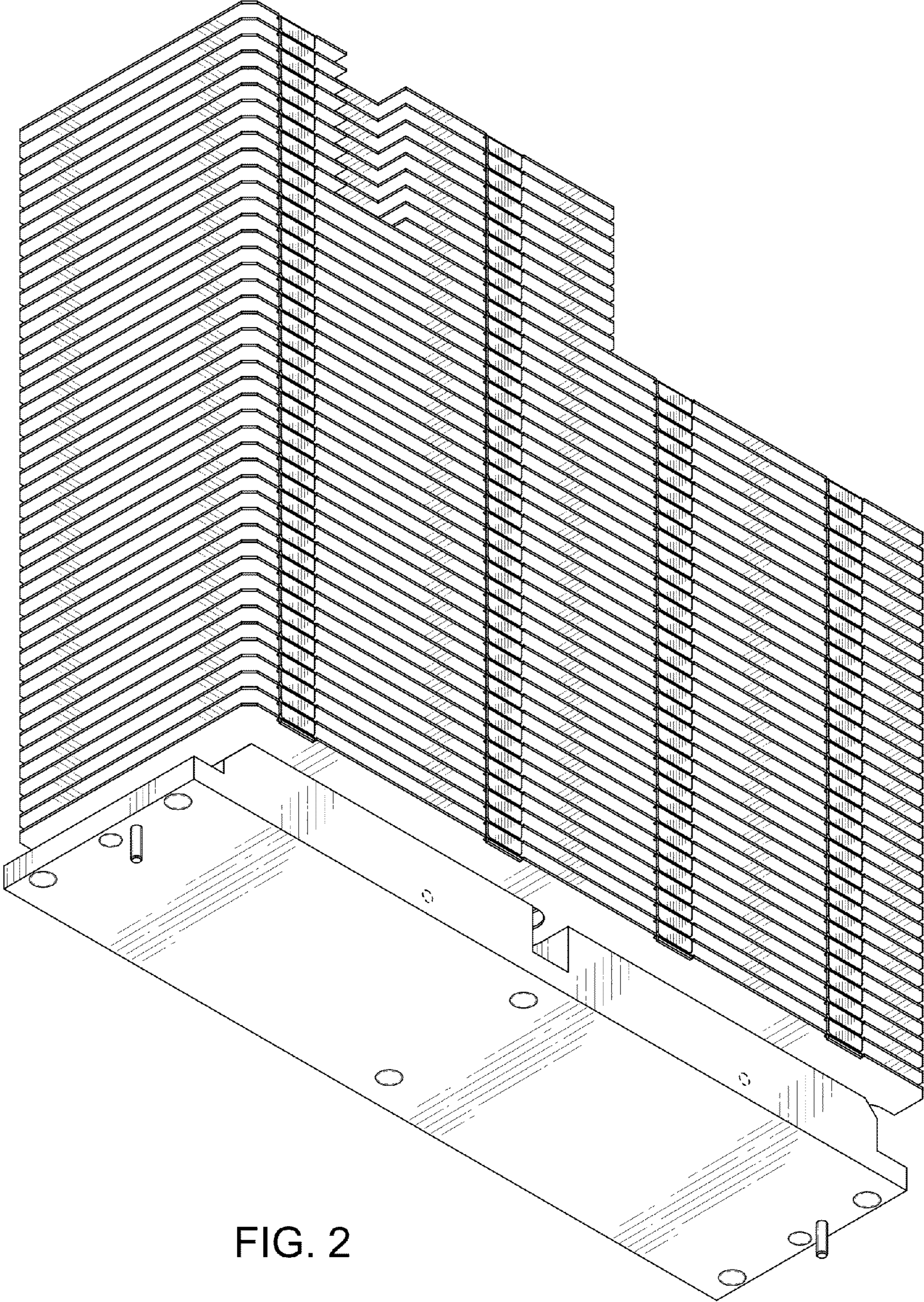

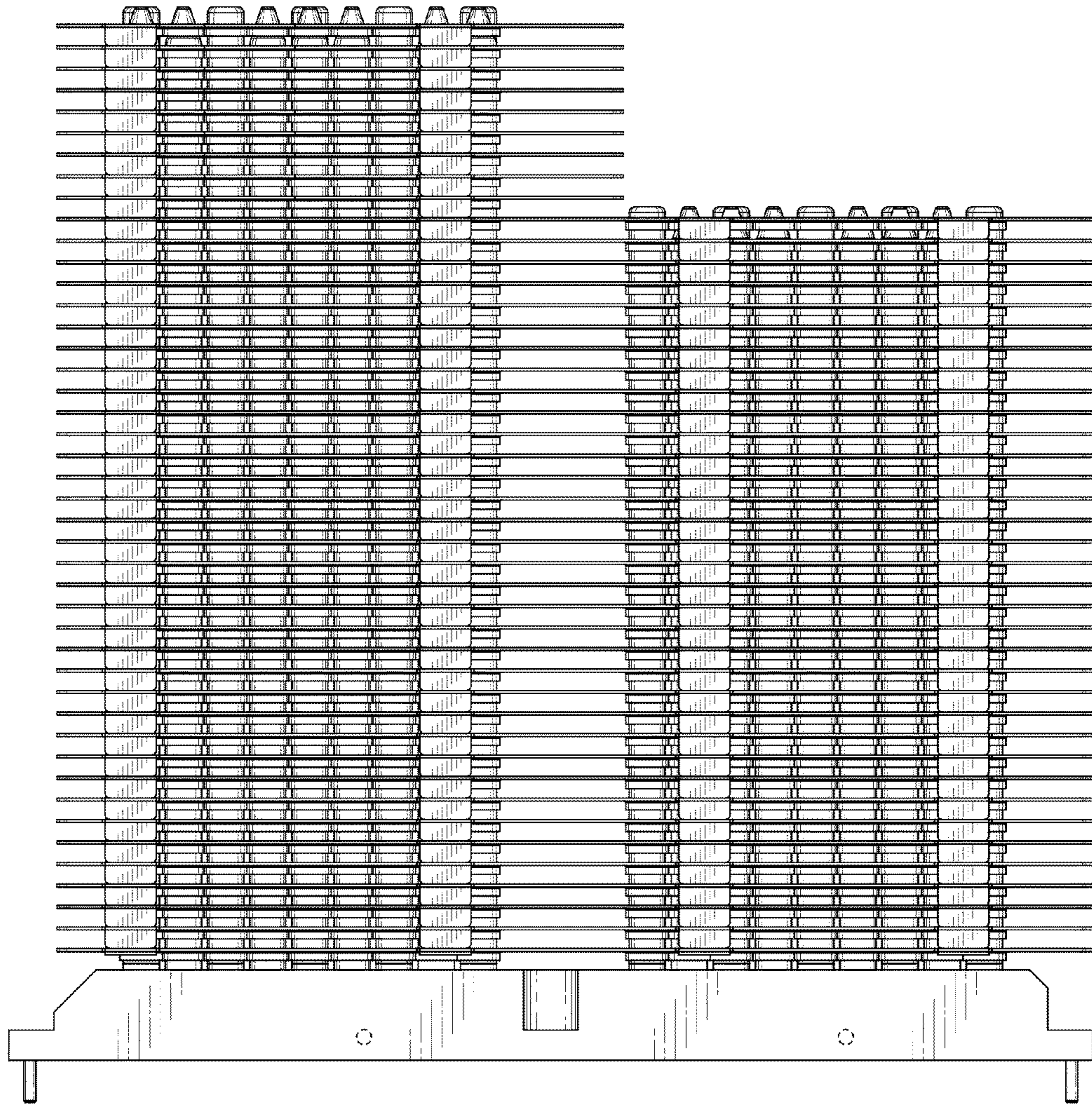

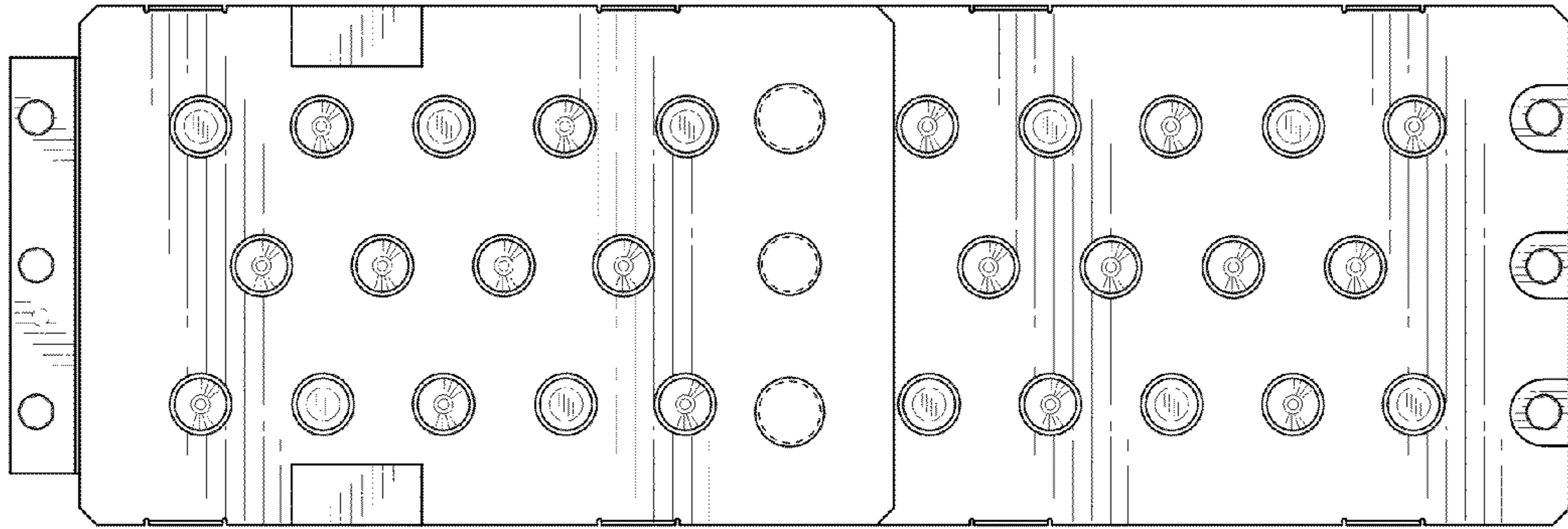

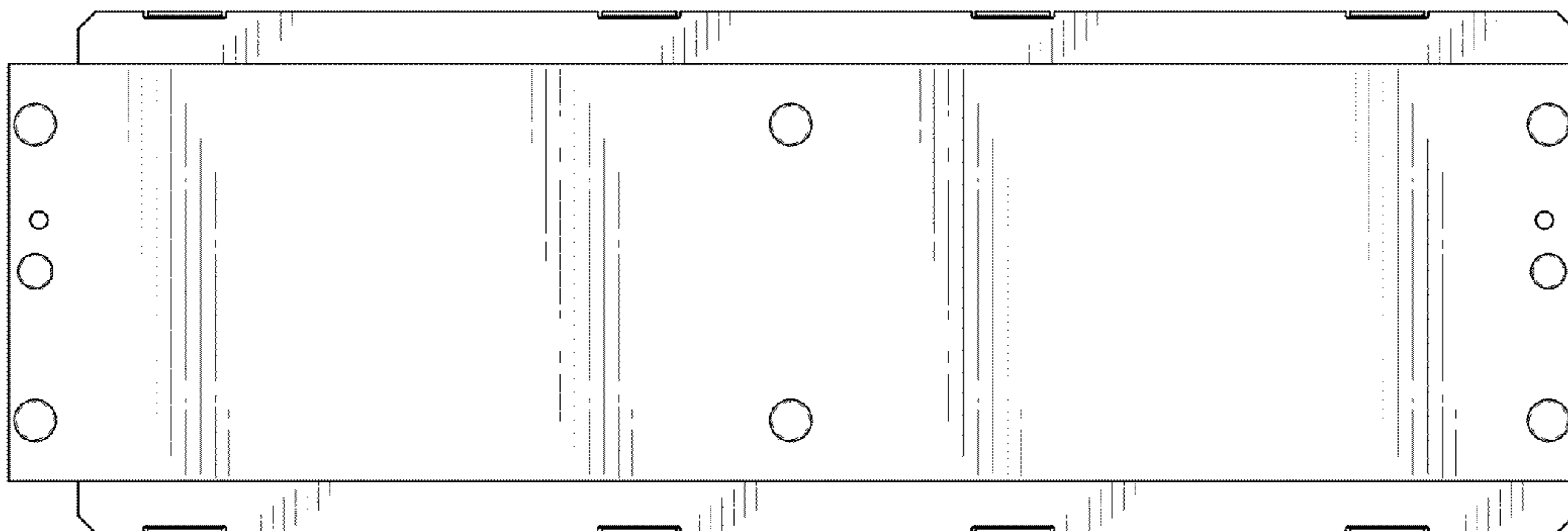

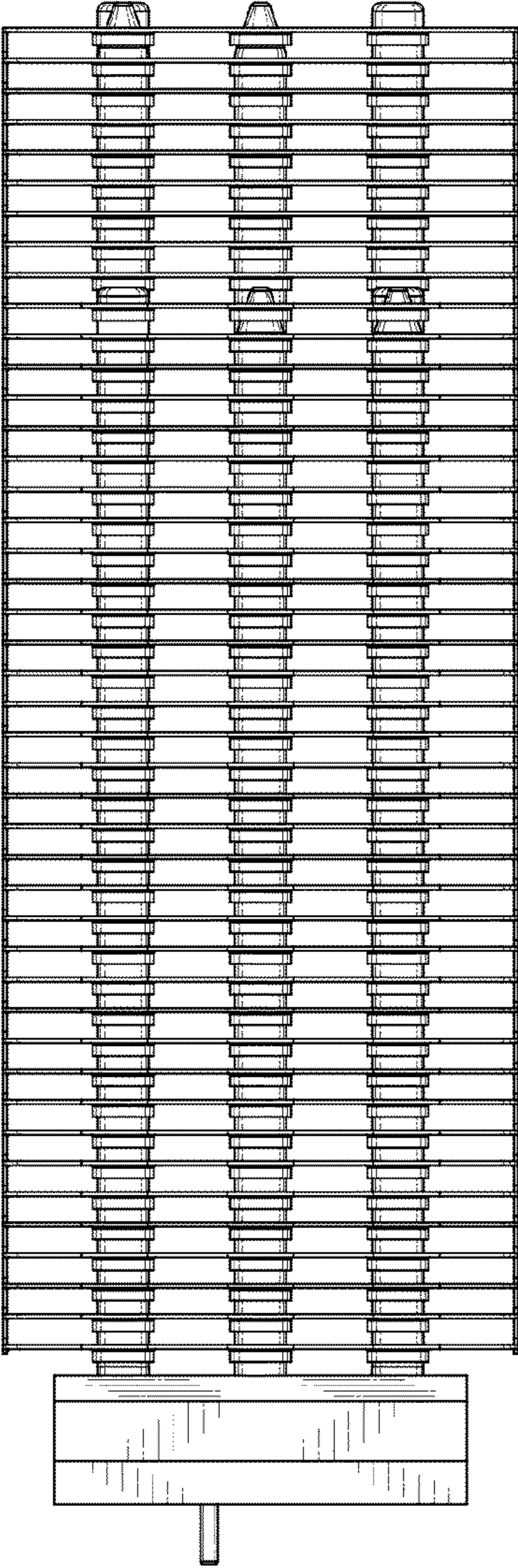

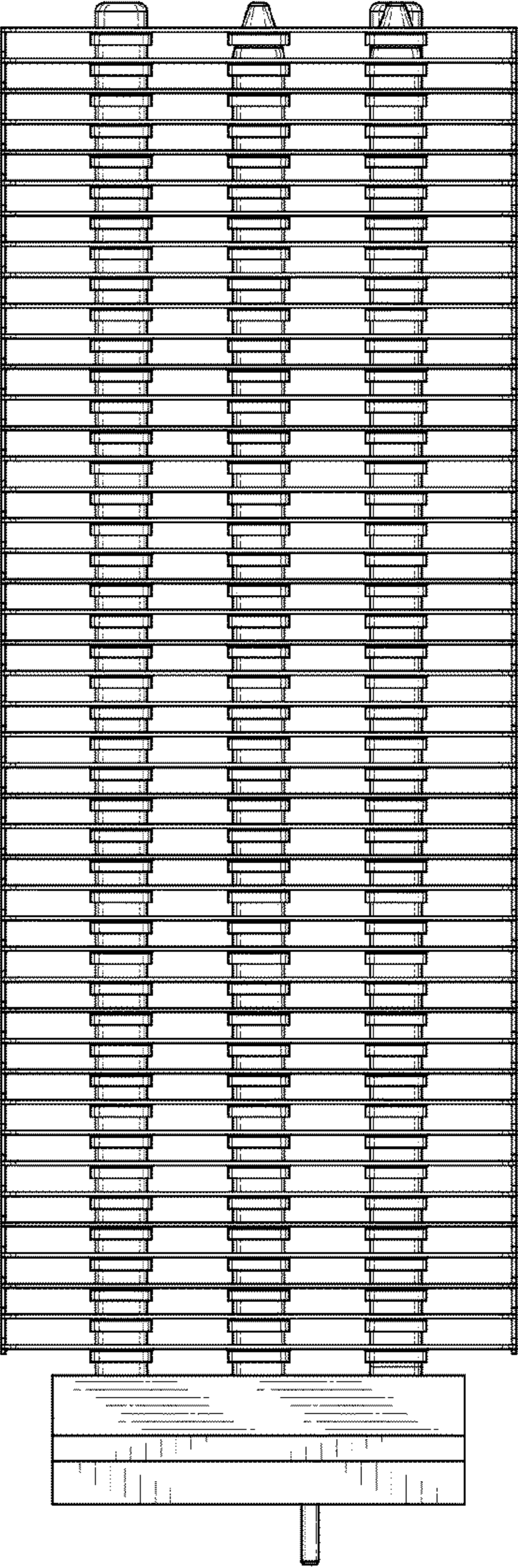

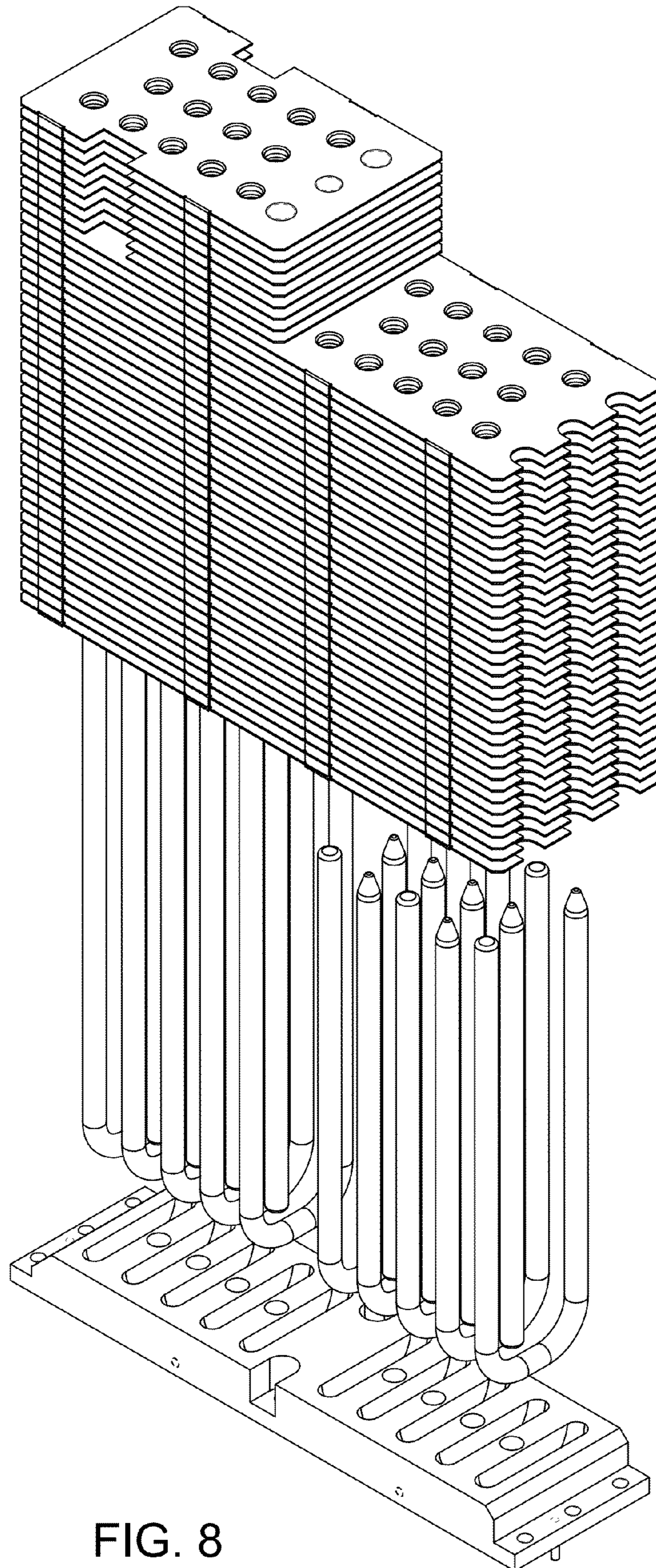

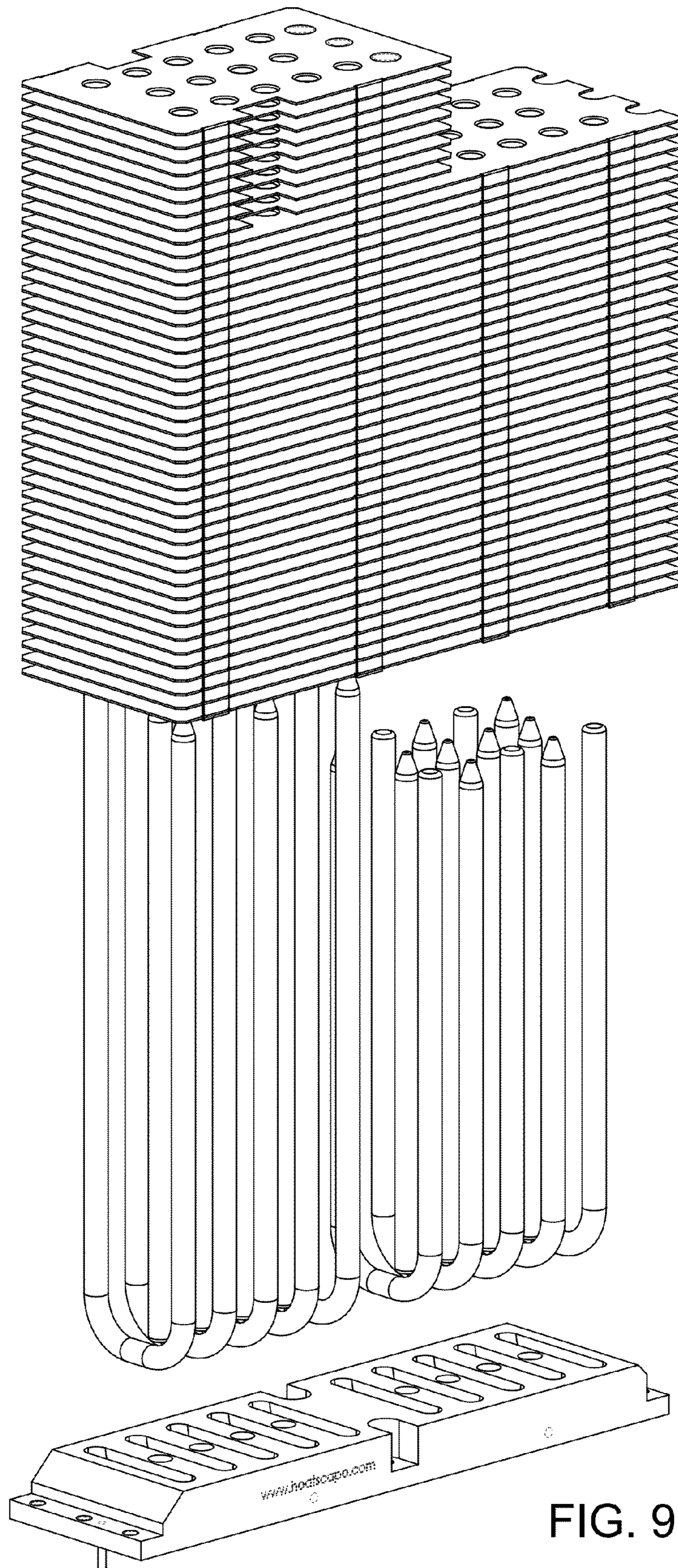
