(57) **CLAIM**

The ornamental design for a set-top box, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a set-top box showing the new design; FIG. 2 is a rear view thereof; FIG. 3 is a right side view thereof, the left side view being a mirror image of the right side view; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; and, FIG. 6 is a perspective view of the front, left side and top thereof.

The broken lines in the figures illustrate unclaimed environment and form no part of the claimed design.

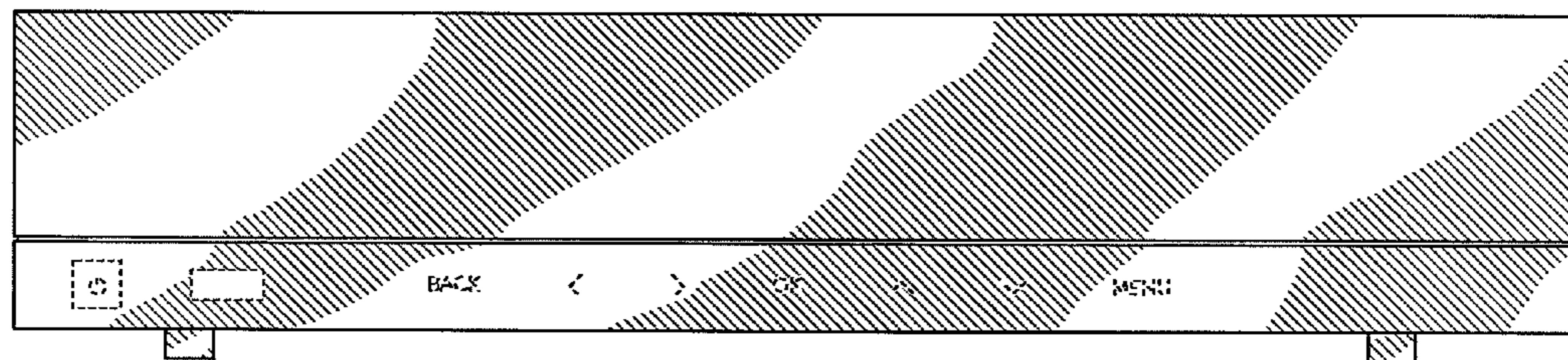

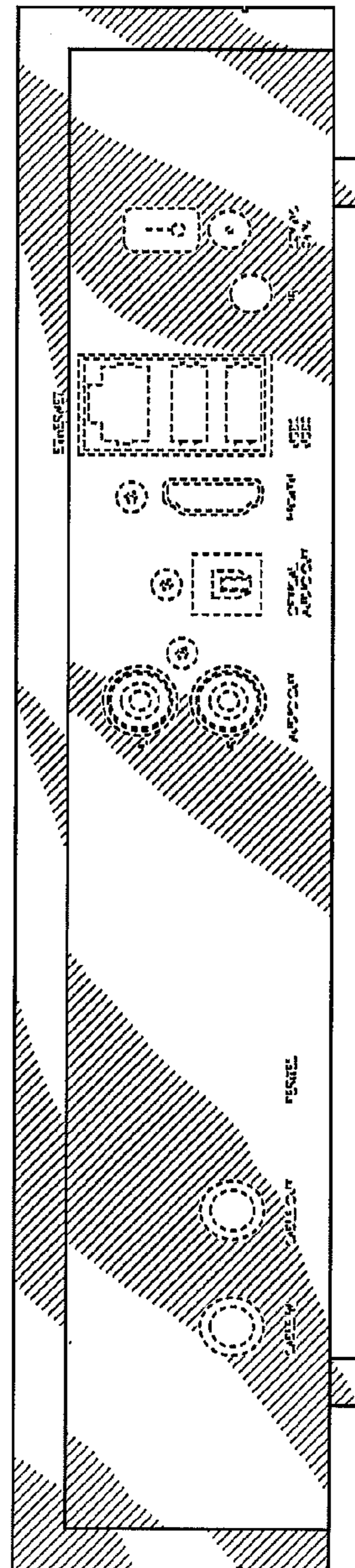

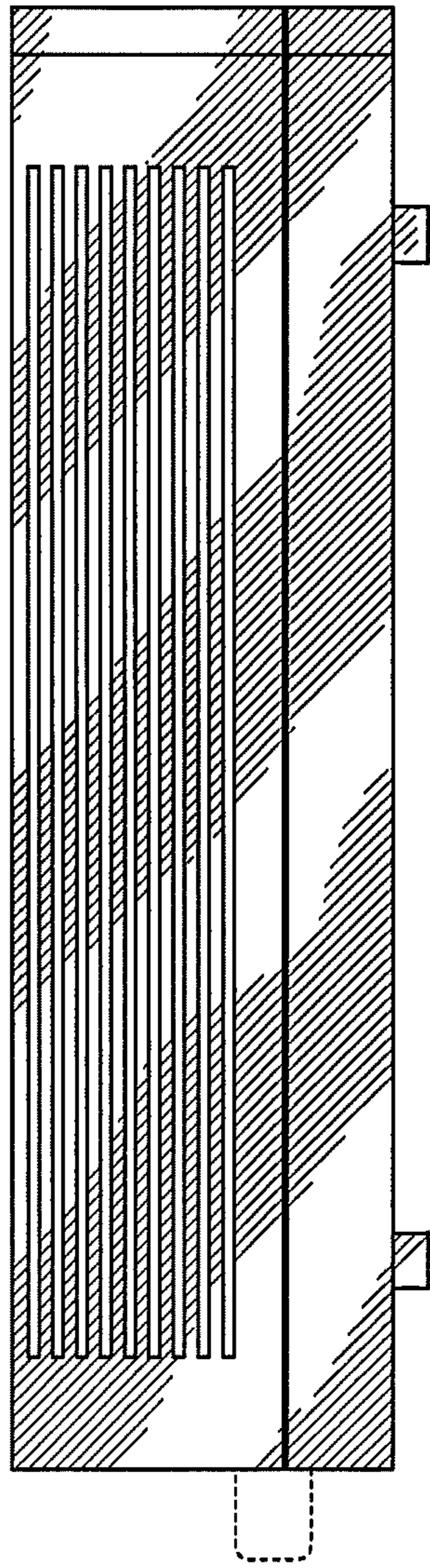

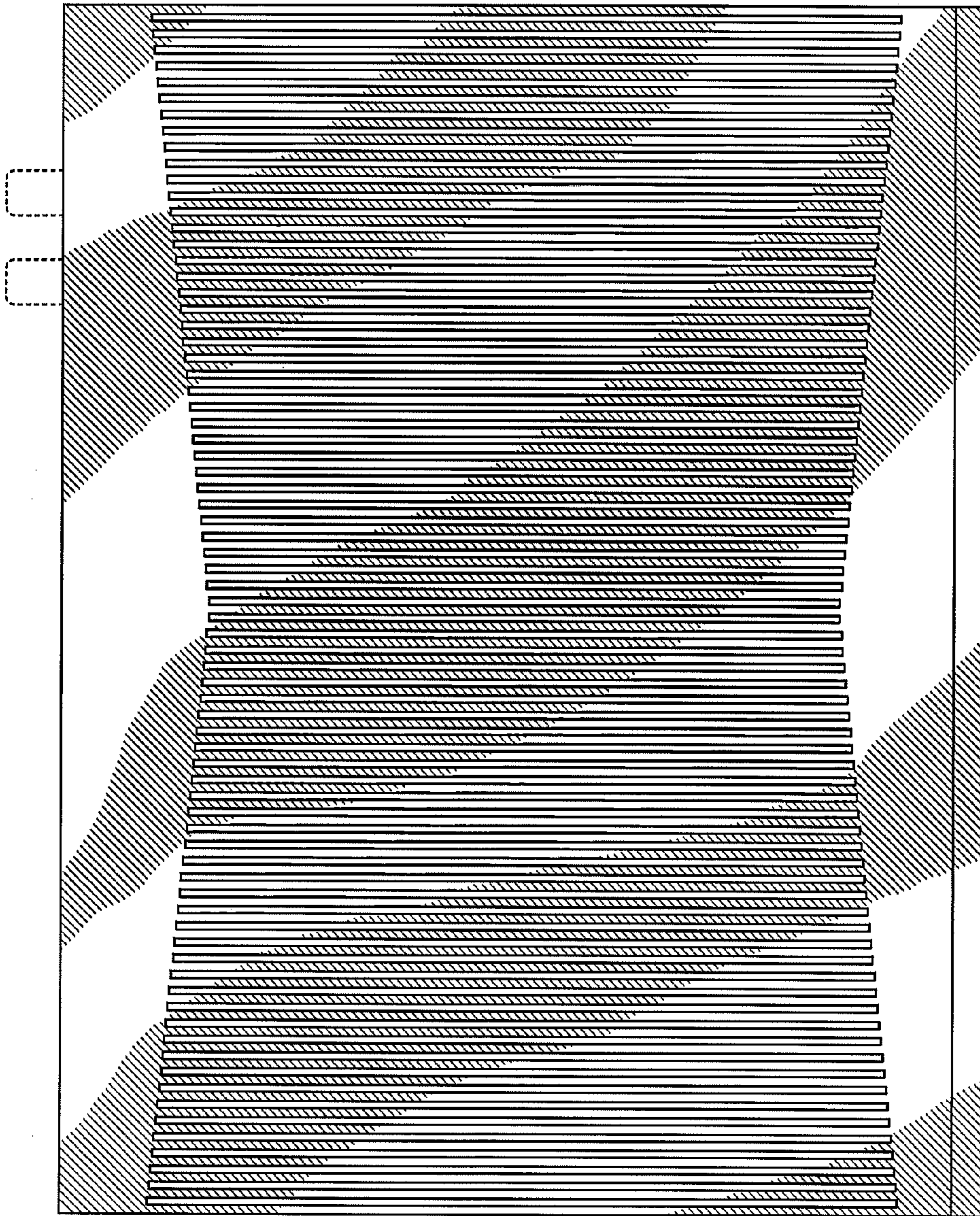

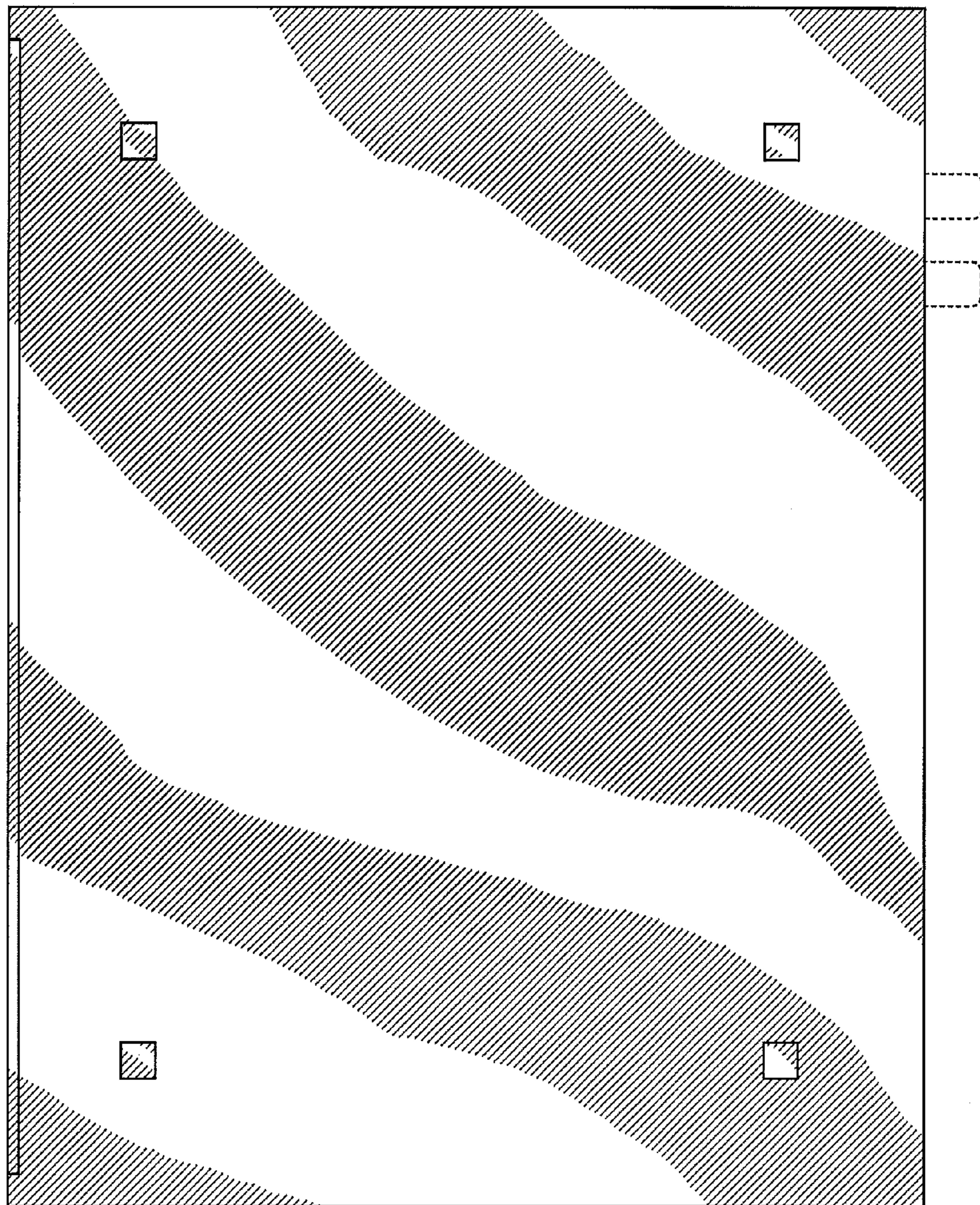

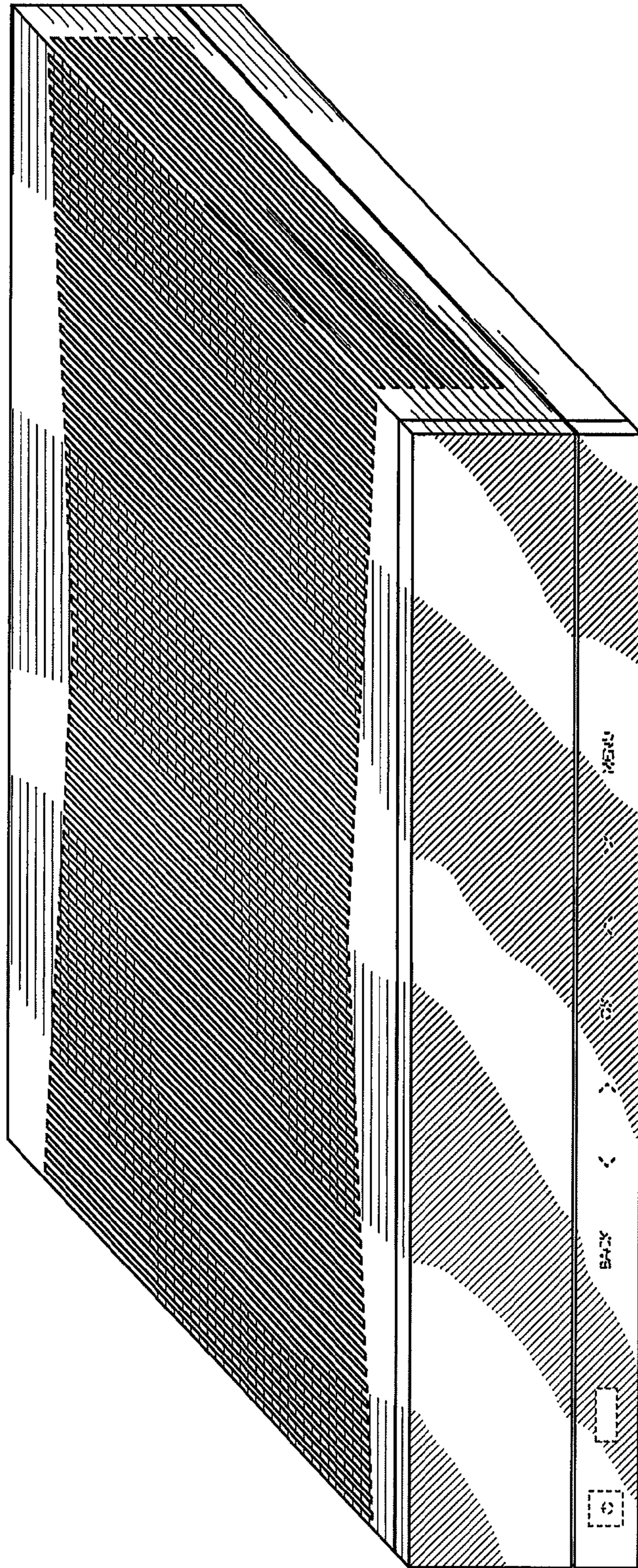
