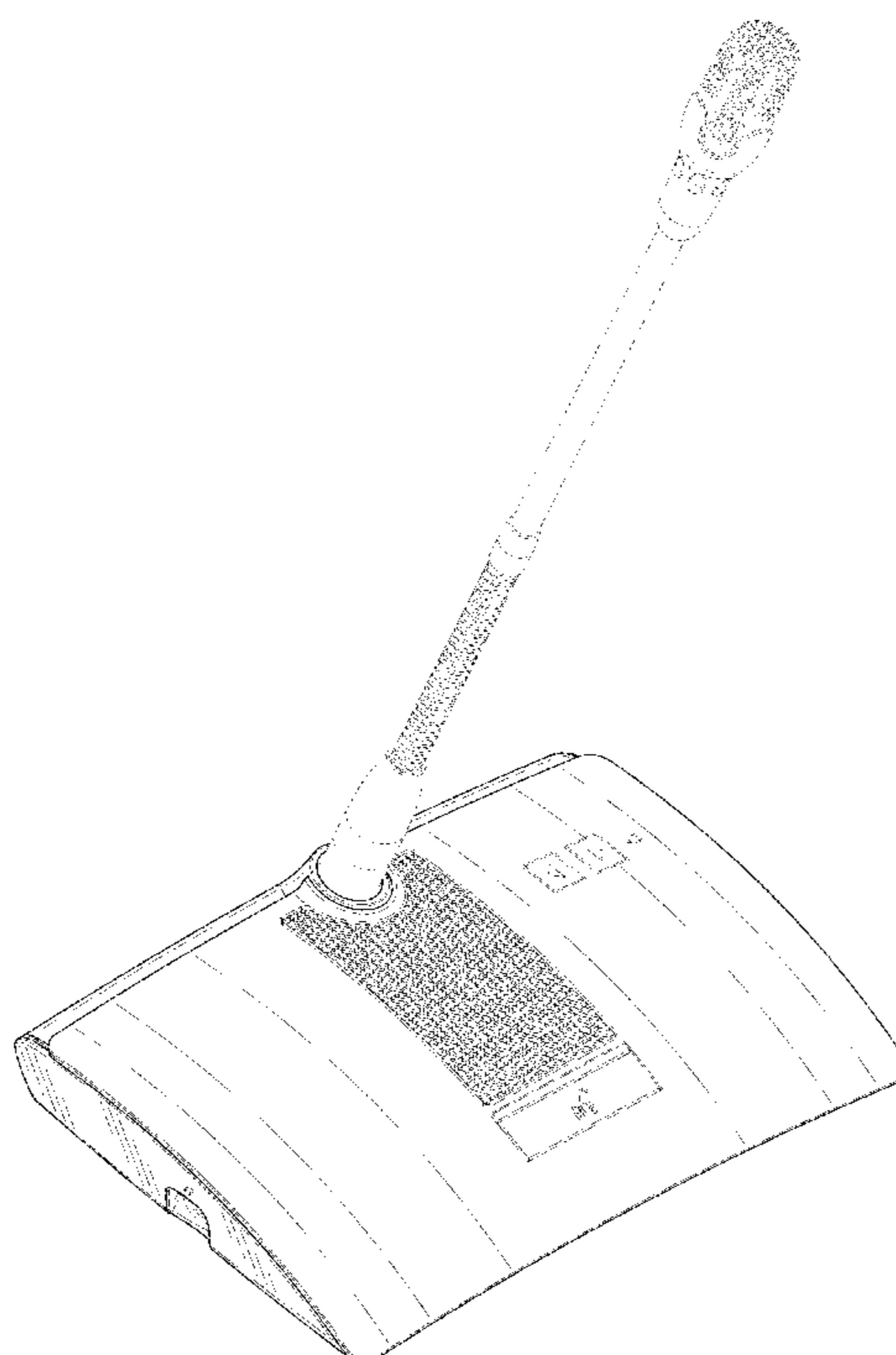
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a sound reproduction apparatus showing my new design;  
FIG. 2 is left side elevational view thereof;

FIG. 4 is a top plan view thereof;

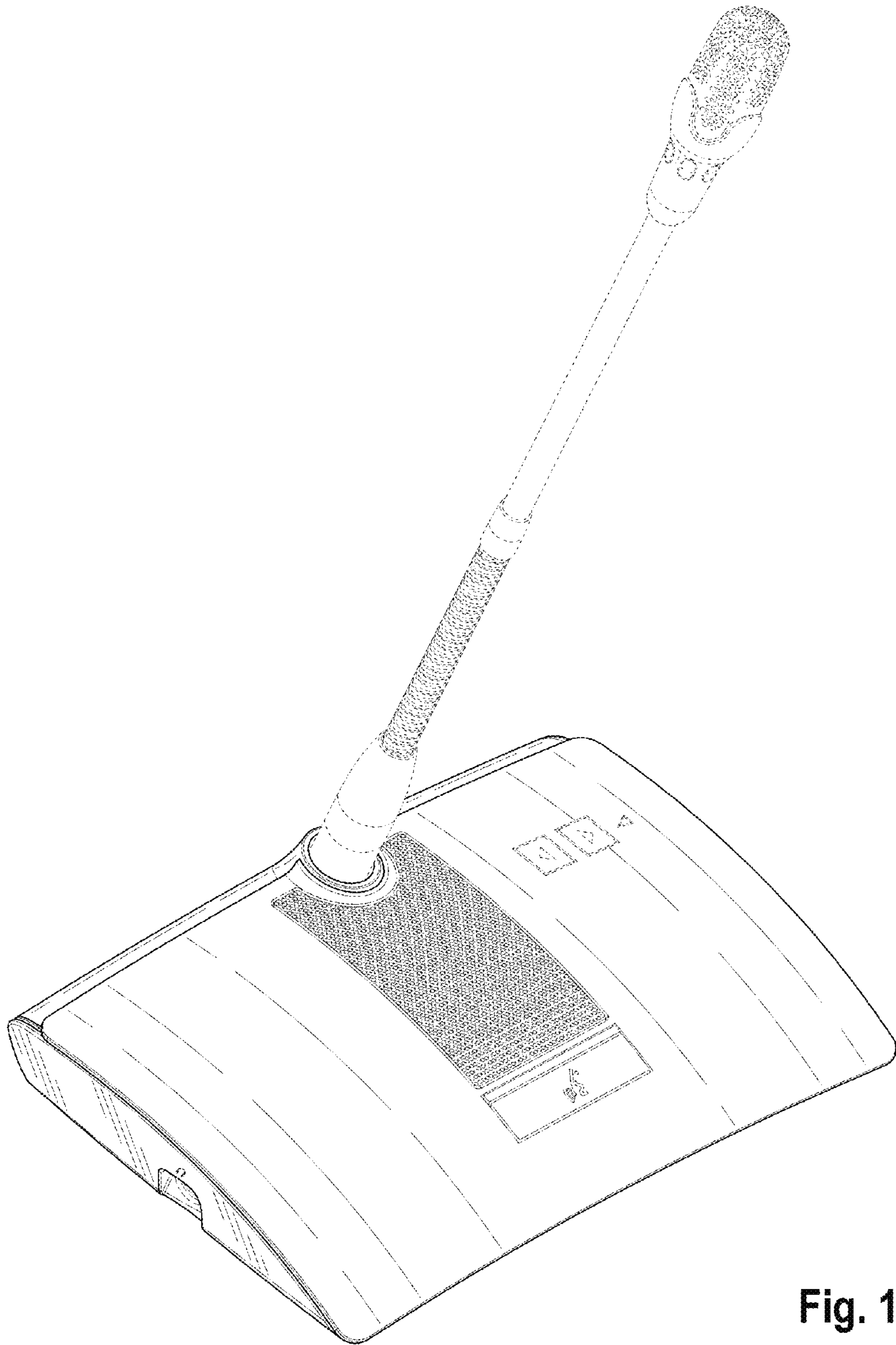

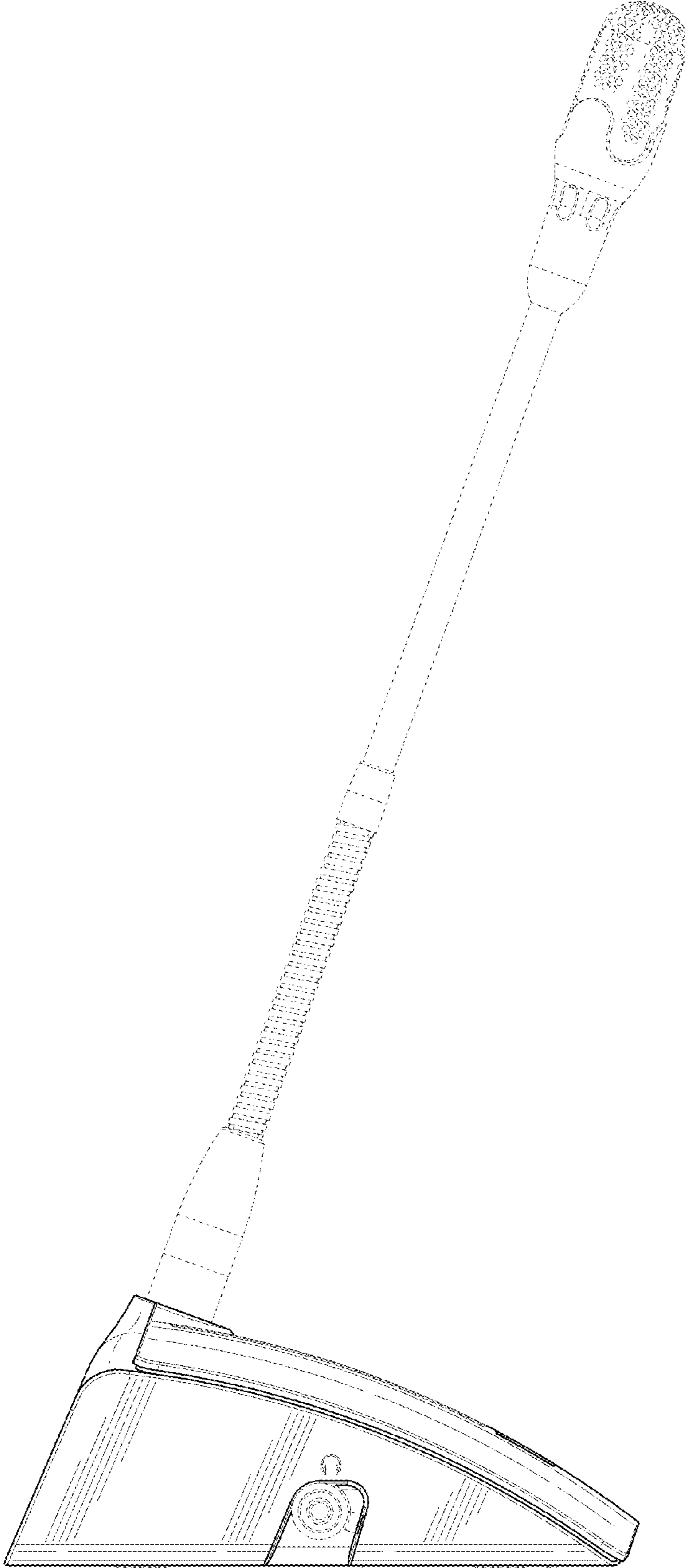

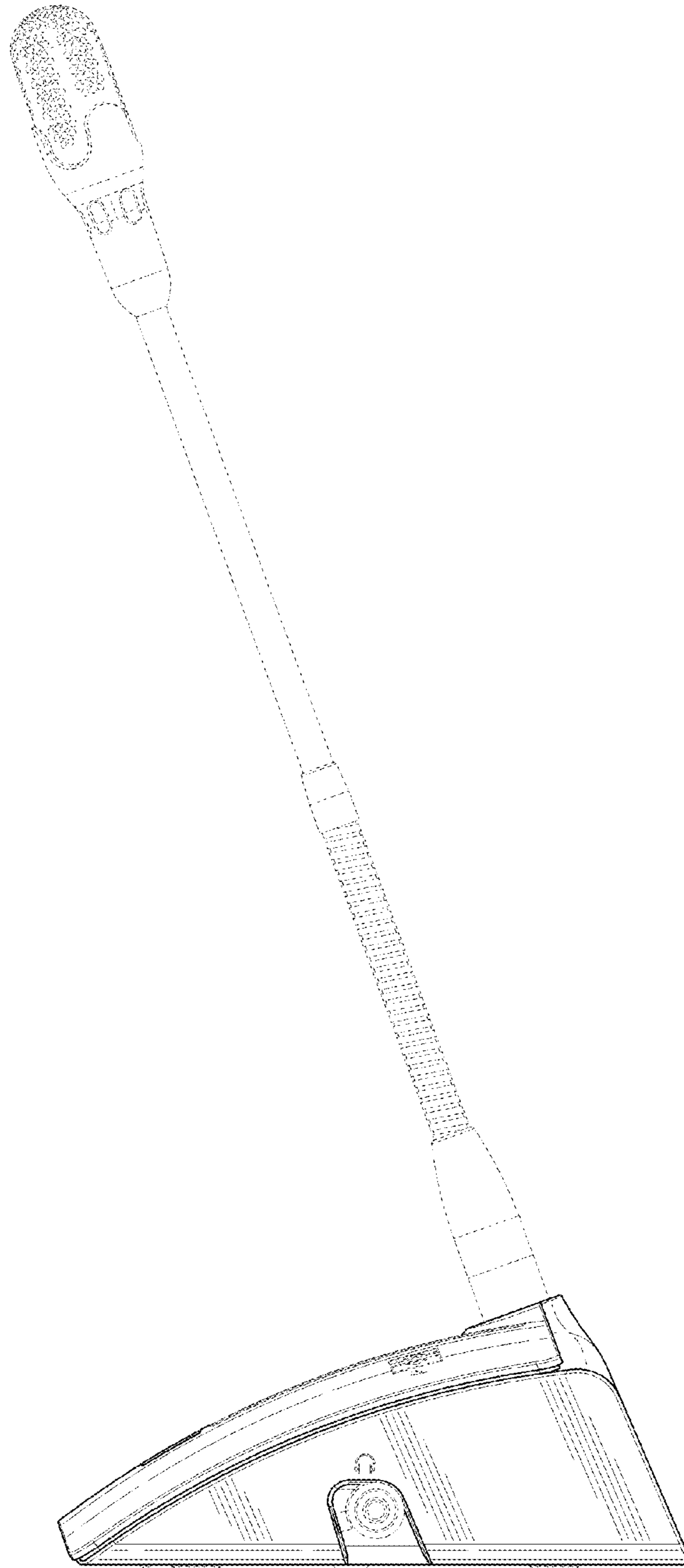

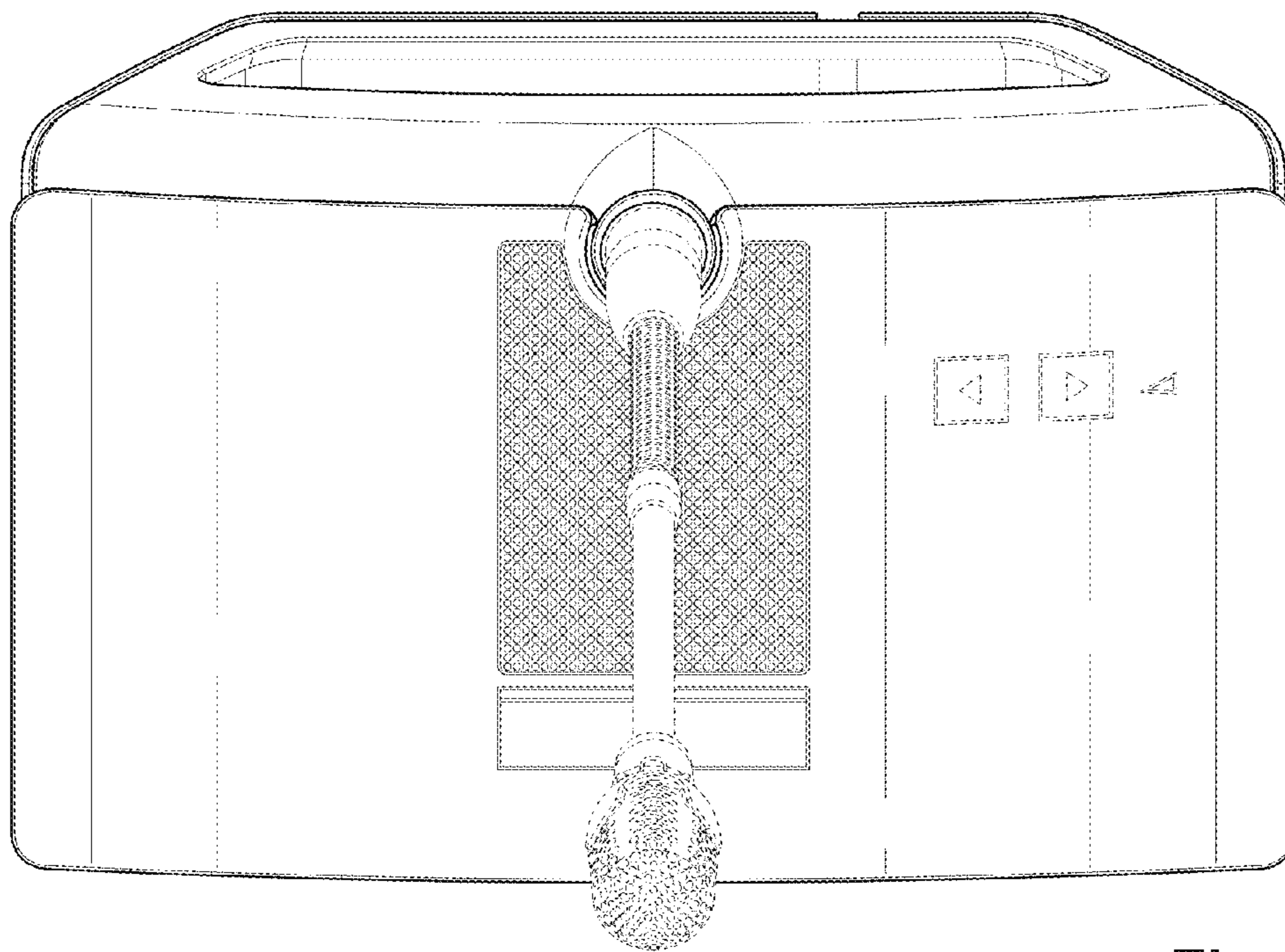

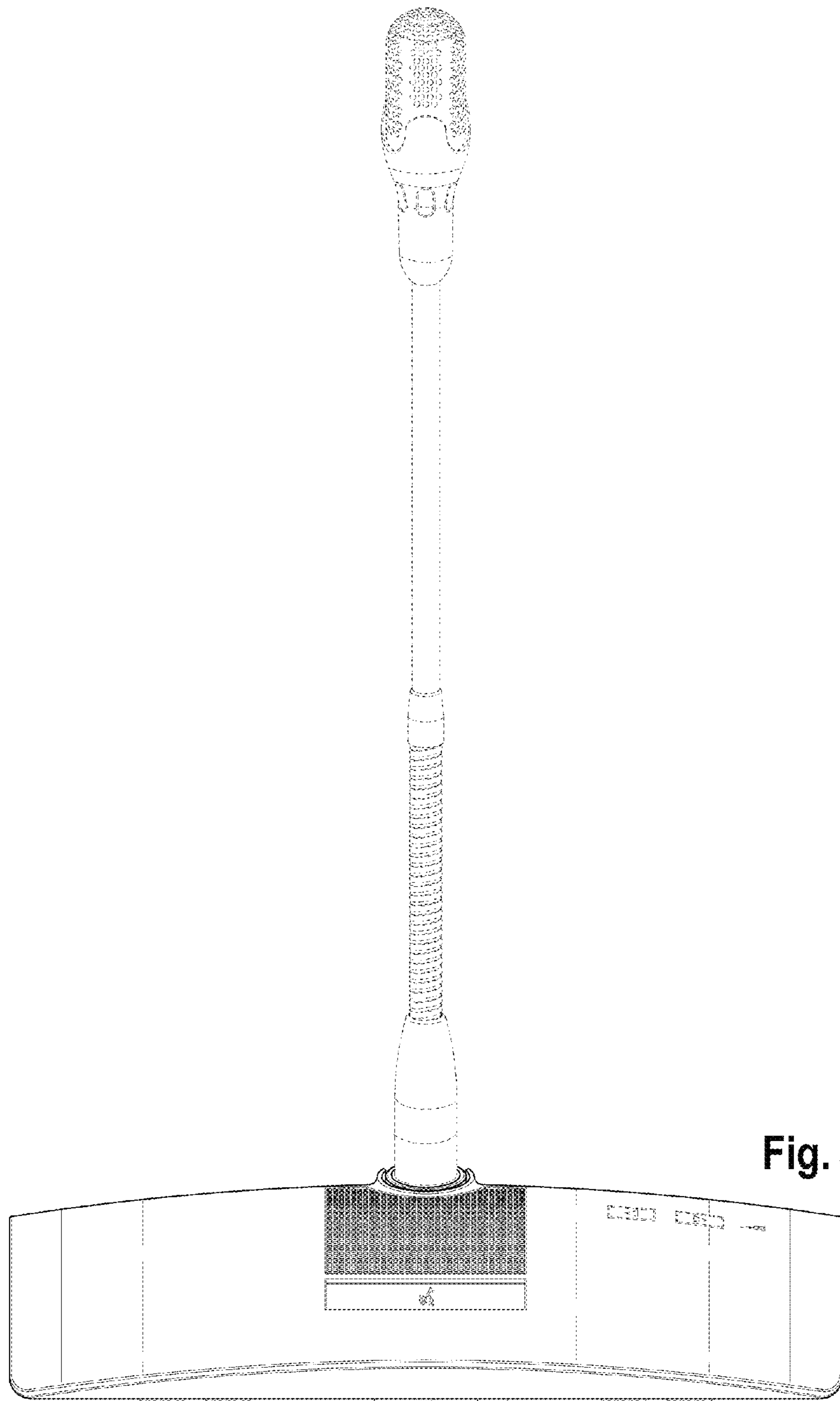

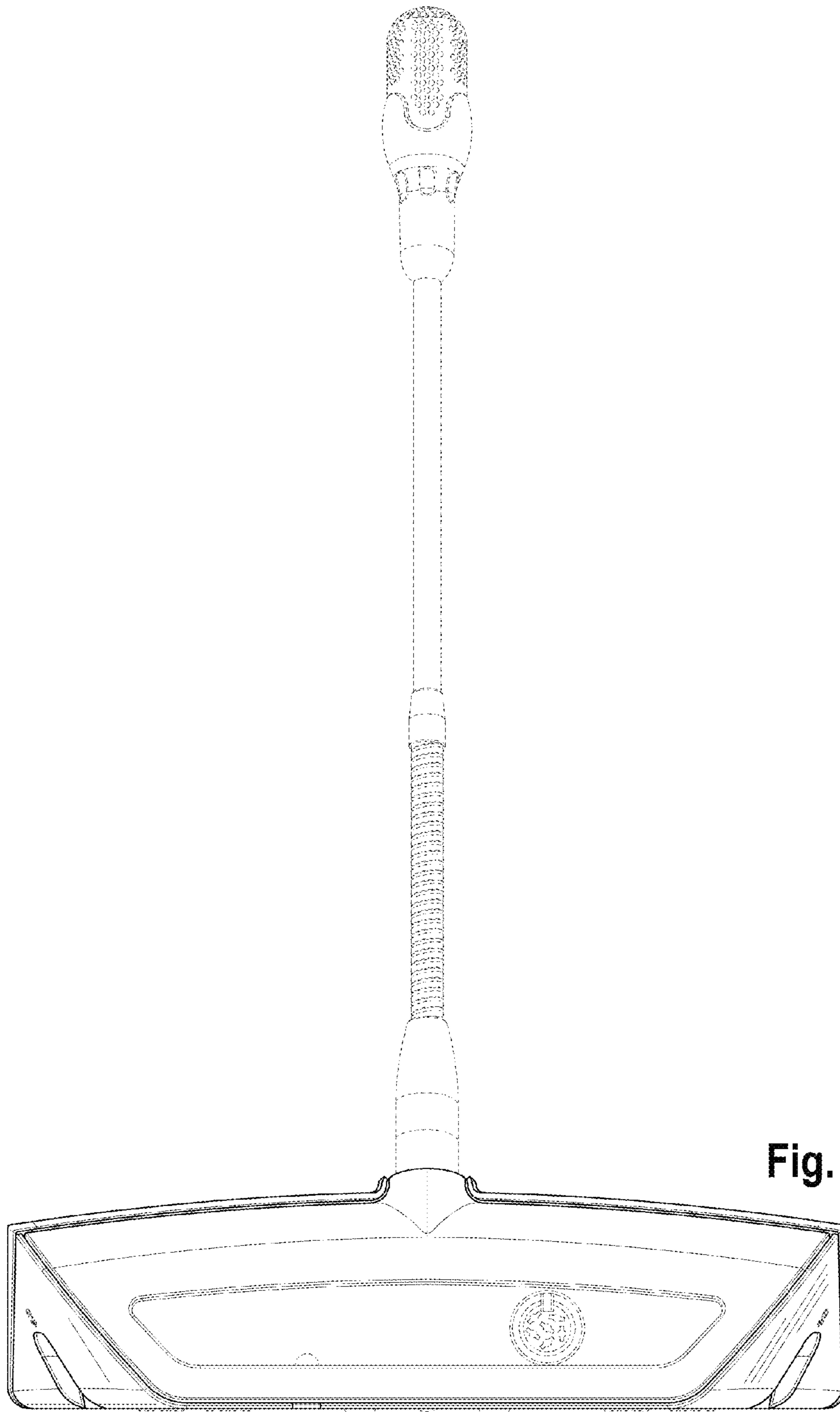

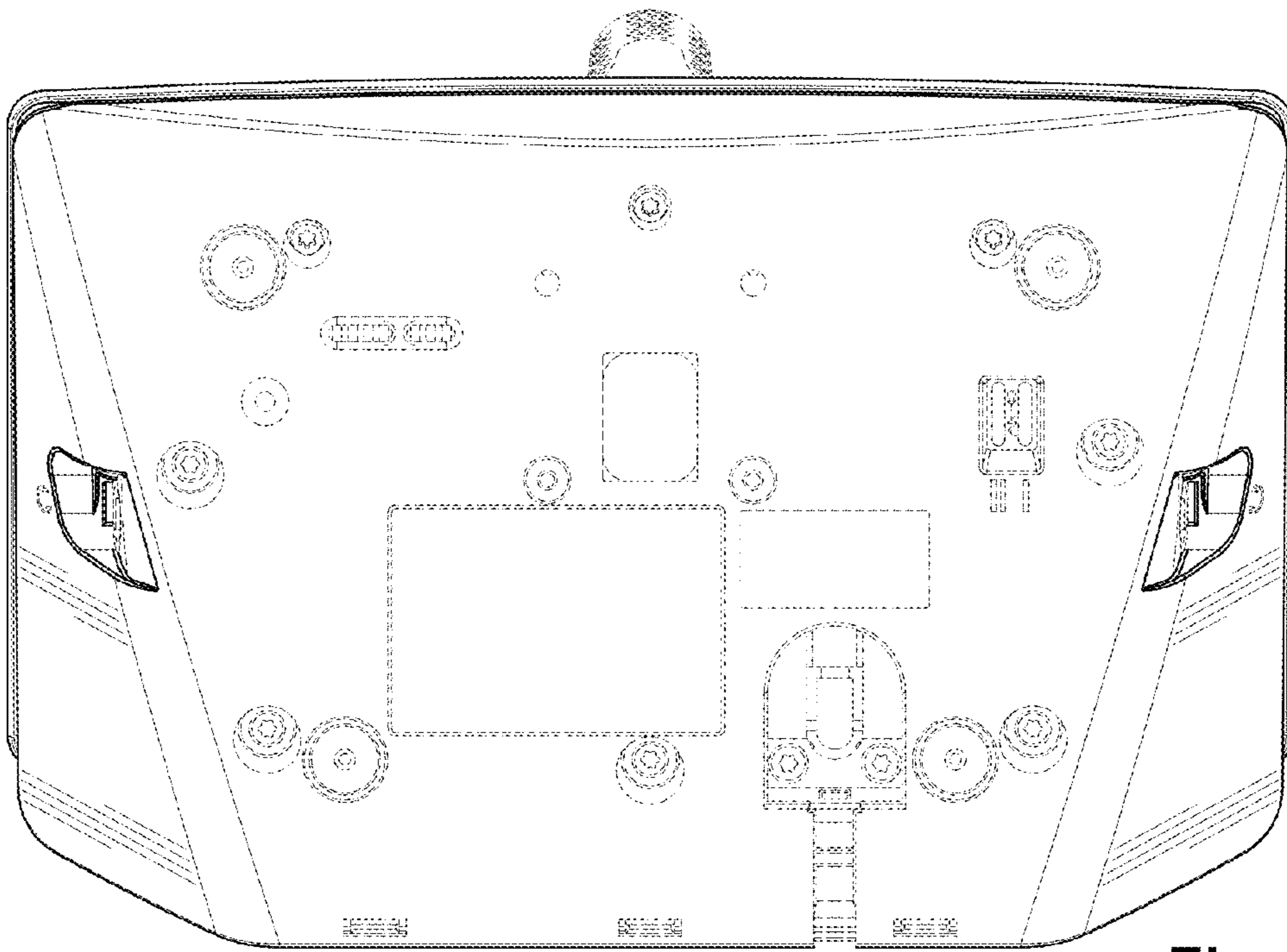
