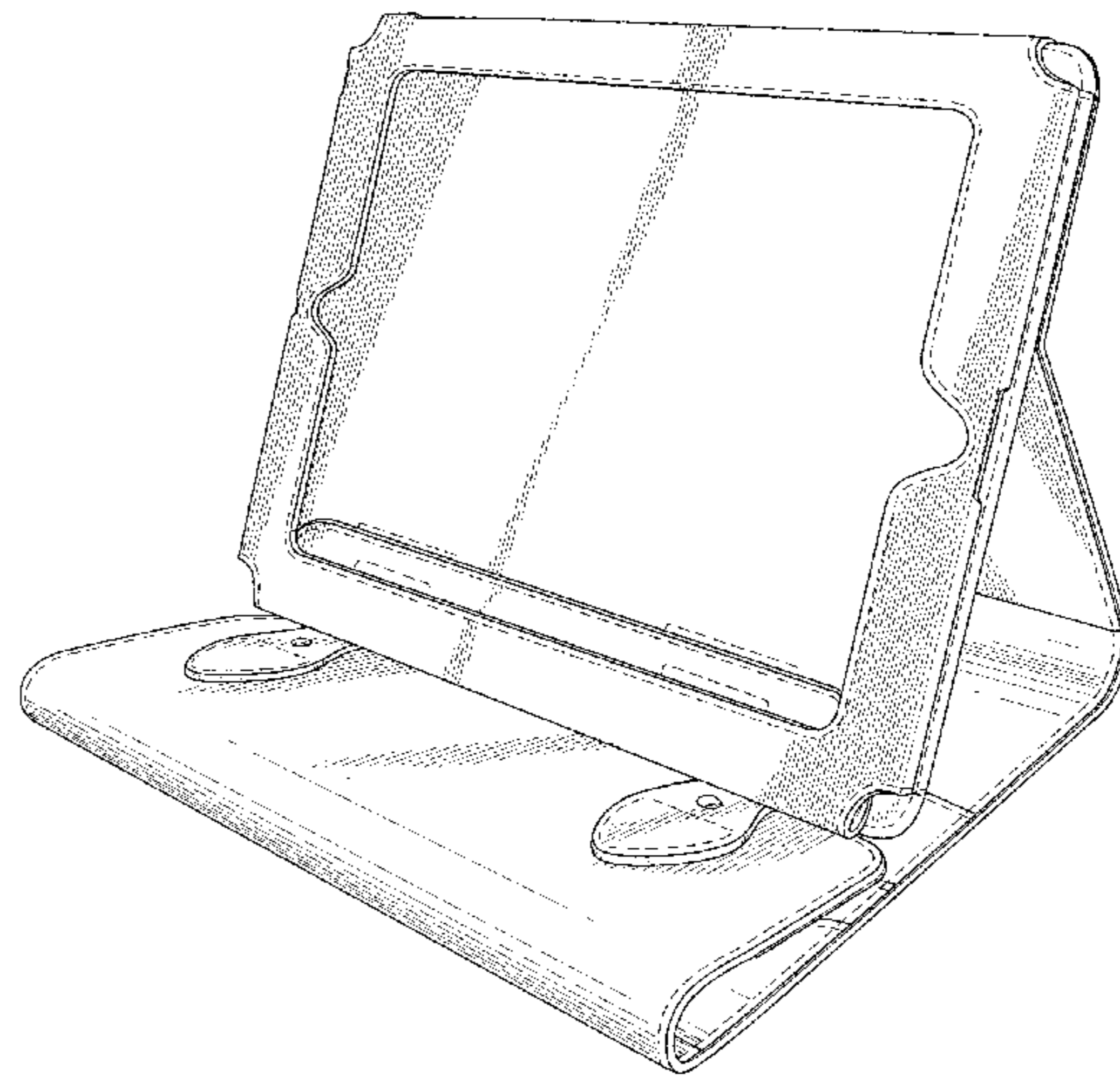
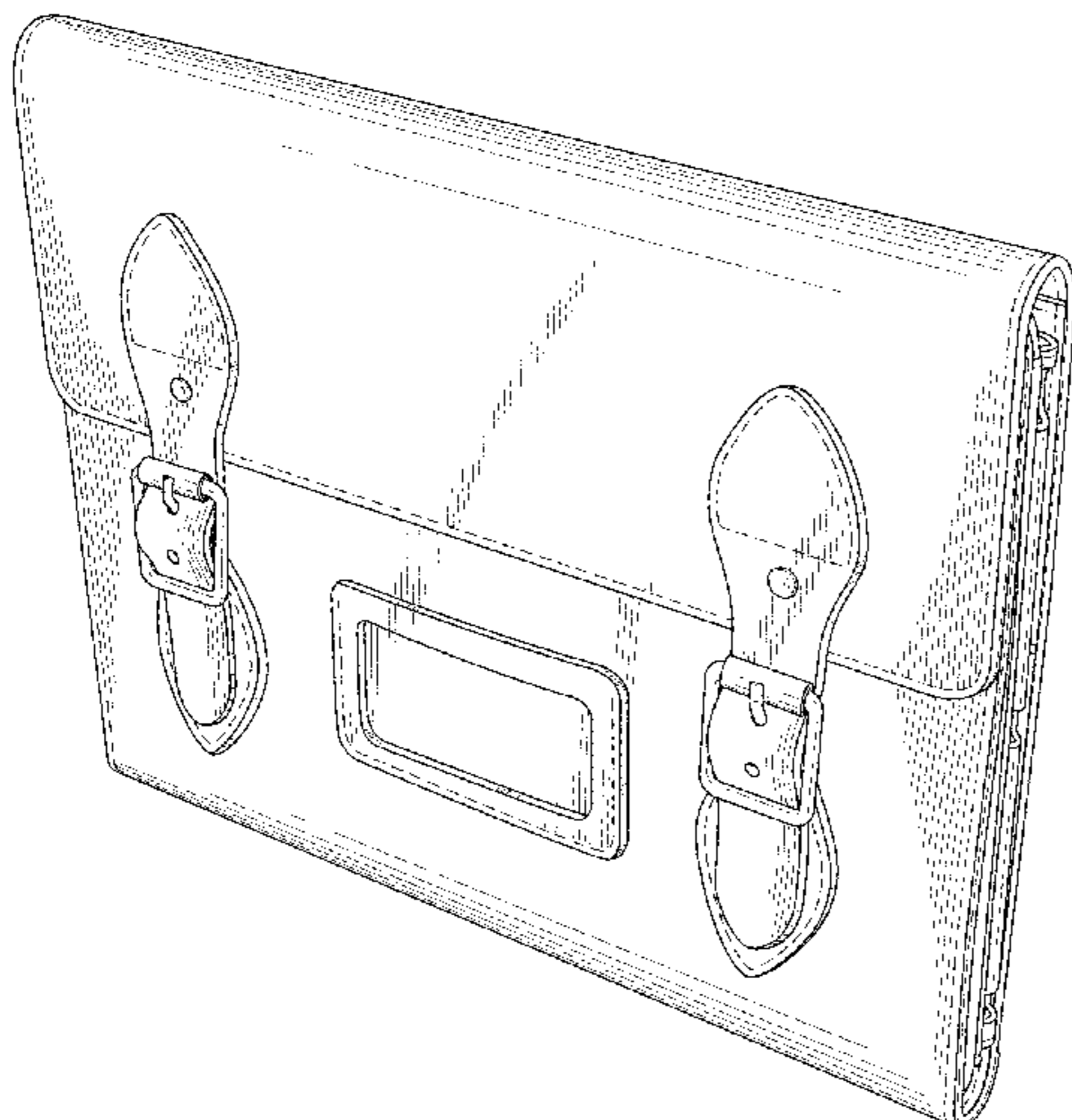
(57) **CLAIM**

What is claimed is the ornamental design for a case for mobile phones and hand held technological devices, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a case in a folded, closed position, showing the new design, with broken lines indicating stitching;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left-side elevational view thereof;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof, and
FIG. 8 is a perspective view of the case in a partially unfolded, propped-up position; and
FIG. 9 is a front elevational view of the case in a completely unfolded, open position.

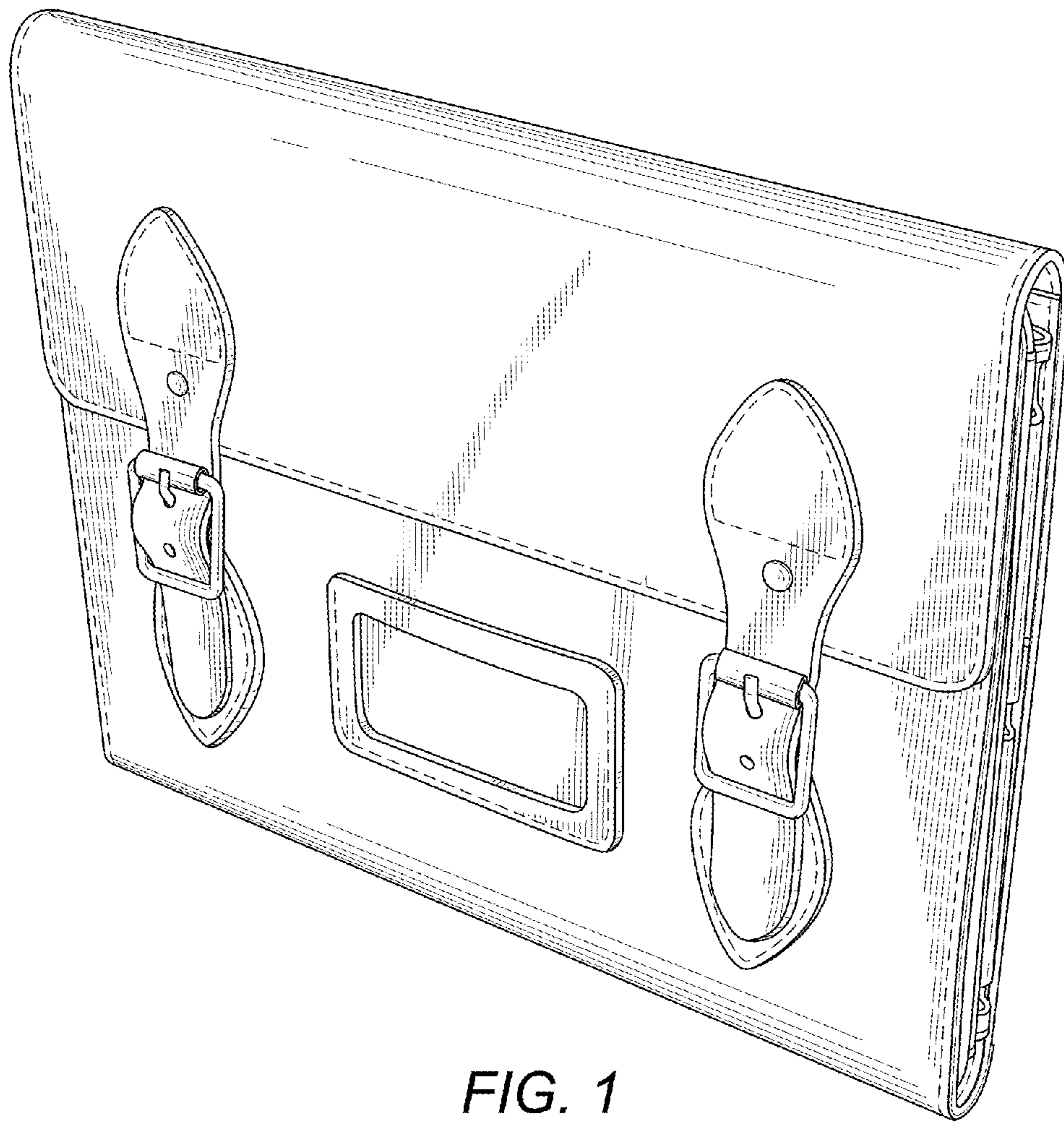

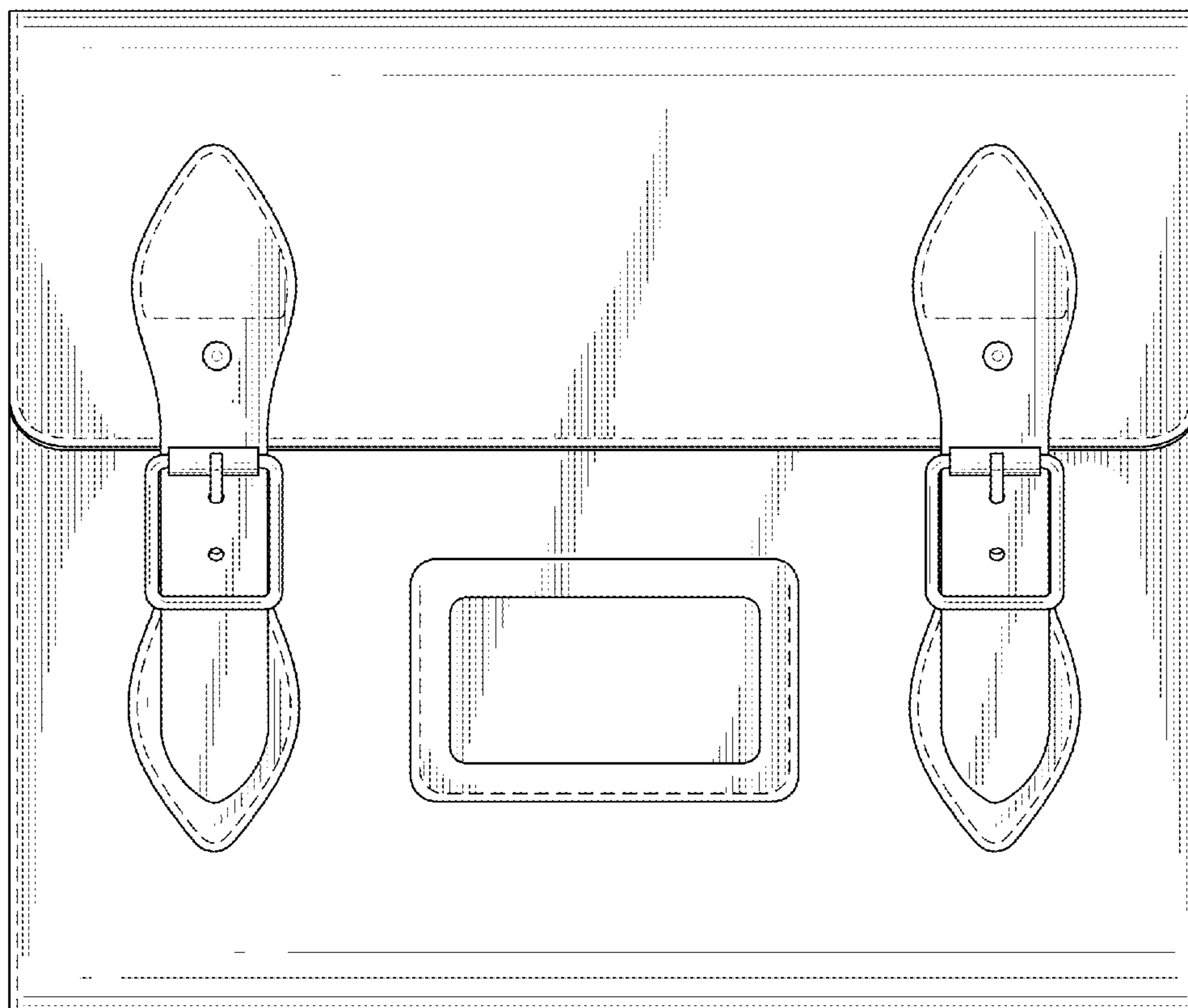

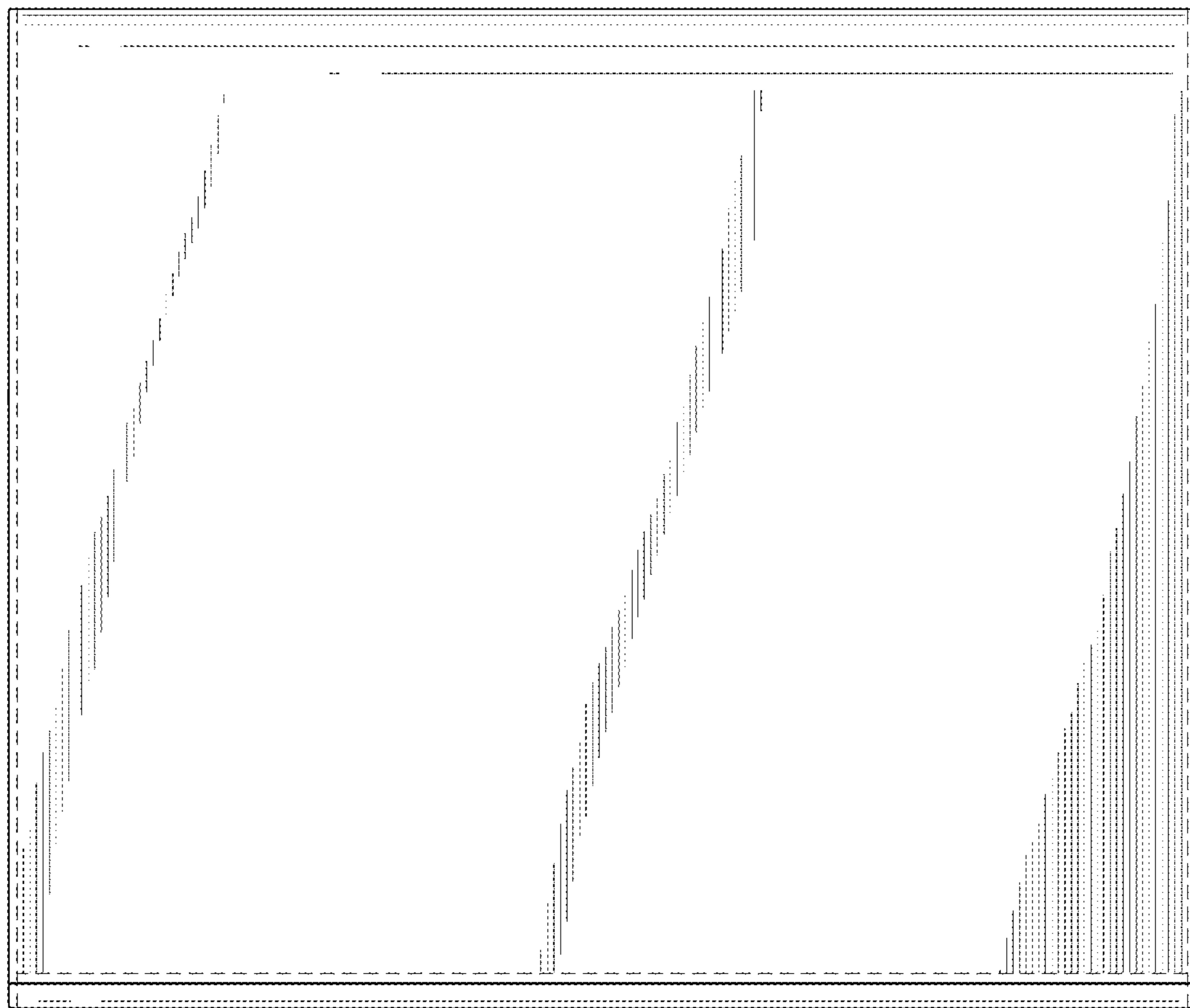

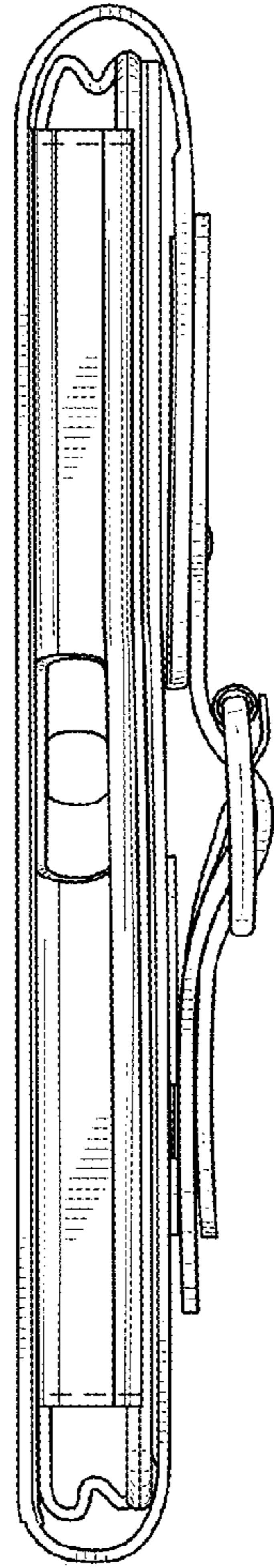

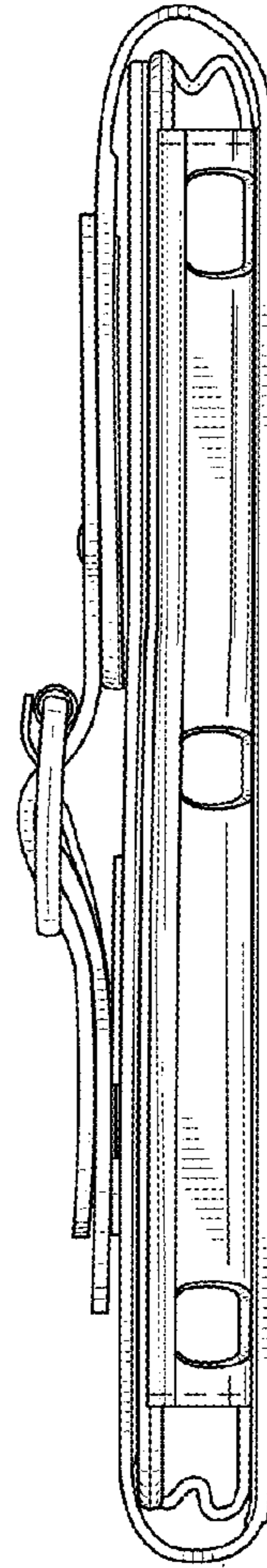

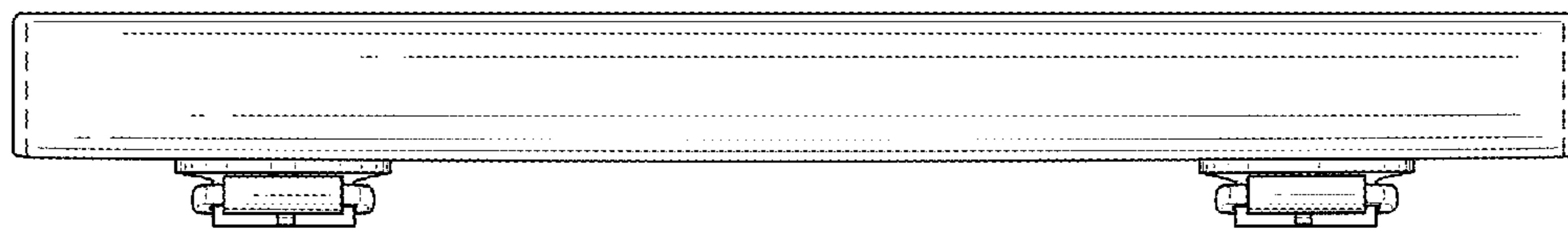

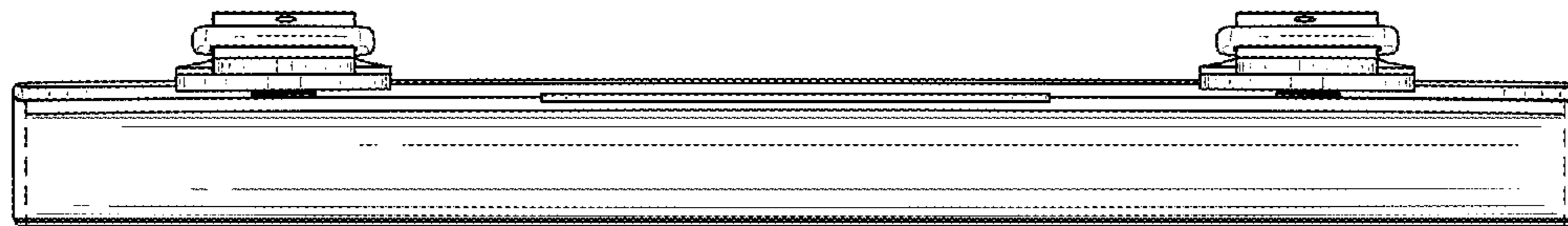

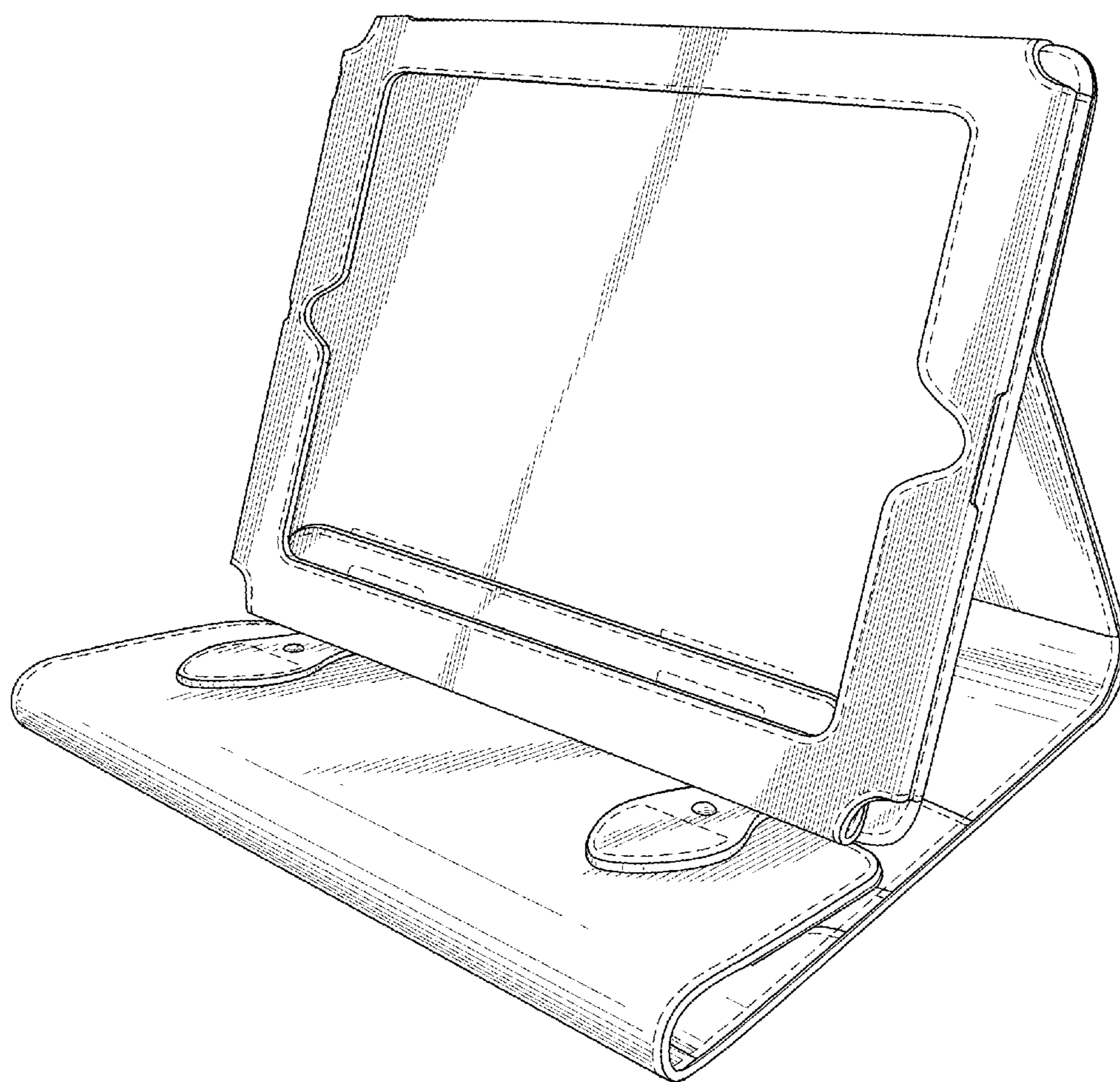

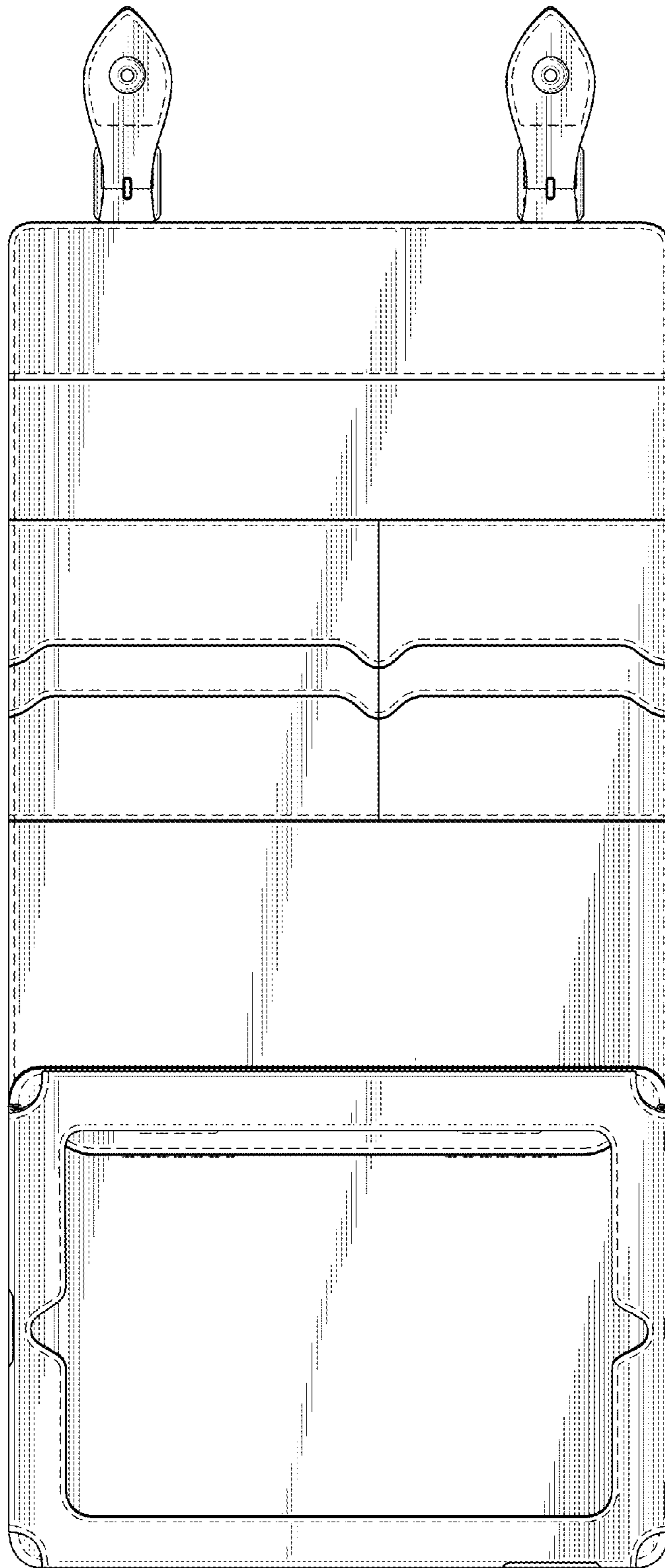
