(57) **CLAIM**

The ornamental design for a display screen with generated user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen with generated user interface, for a display screen or portion thereof showing my new design; and,  
FIG. 2 is a front view of the display screen with generated user interface of FIG. 1, in which a mobile phone in broken lines is provided to illustrate an example environment.  
The broken line drawing of the mobile phone, and the text/words, numbers and otherwise images shown in broken lines in the generated image of FIGS. 1 and 2 are for illustrative purpose only and form no part of the claimed design.

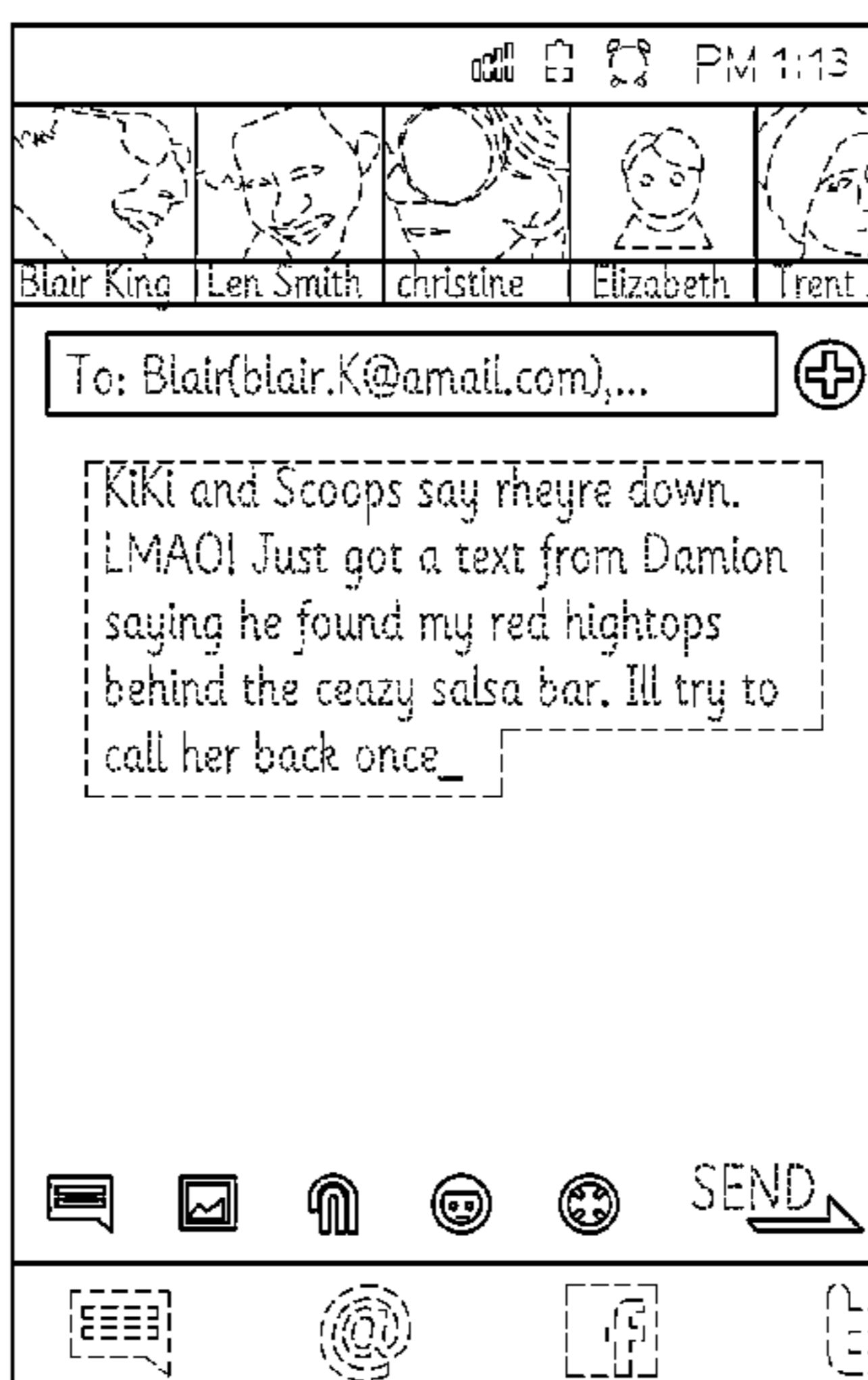
