(57) **CLAIM**

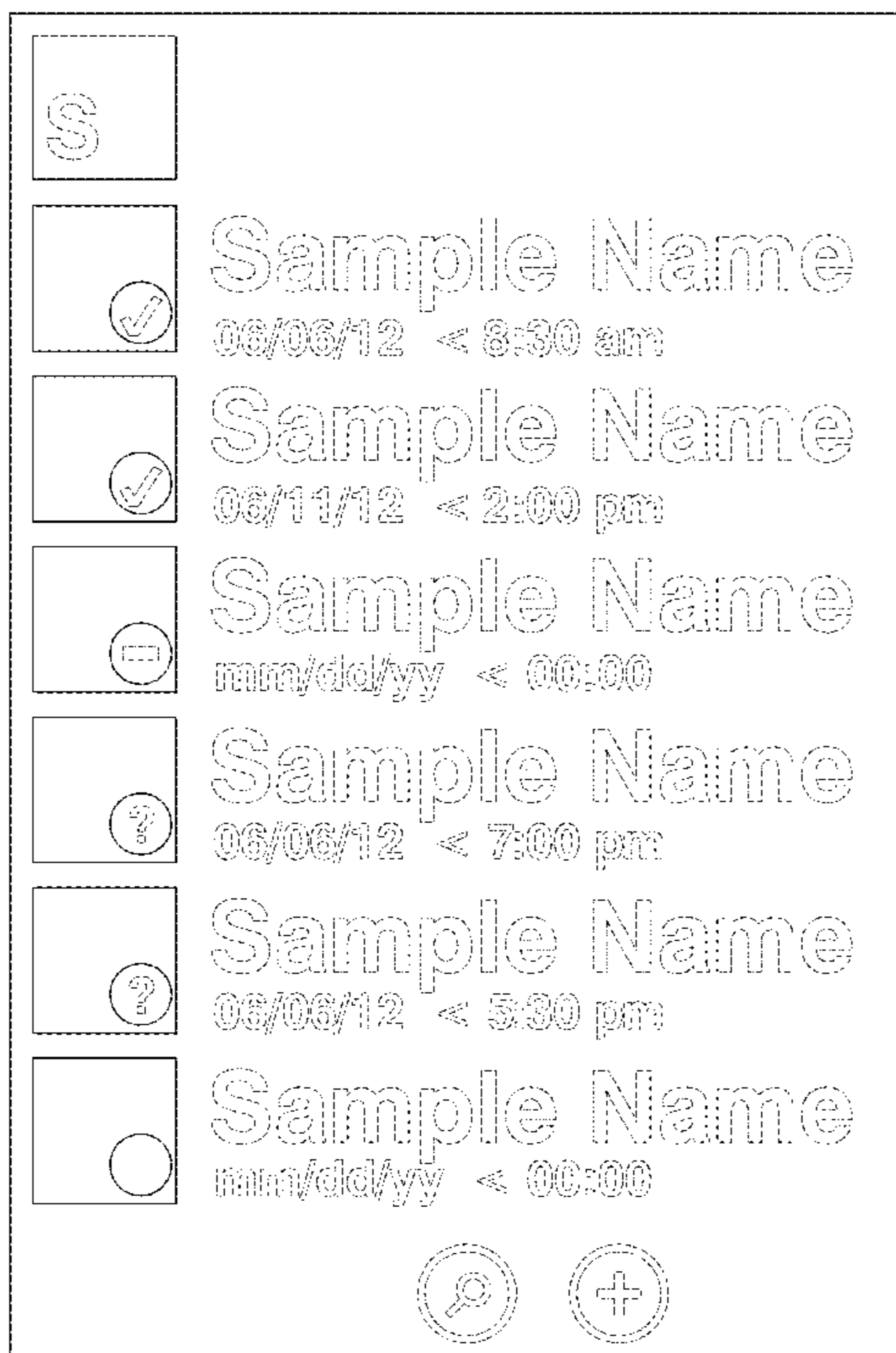
The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with graphical user interface showing my new design; and, FIG. 2 is a front view thereof, showing the display screen with graphical user interface on a device.

The broken line showing of the device in FIG. 2 illustrates environmental structure and forms no part of the claimed design. 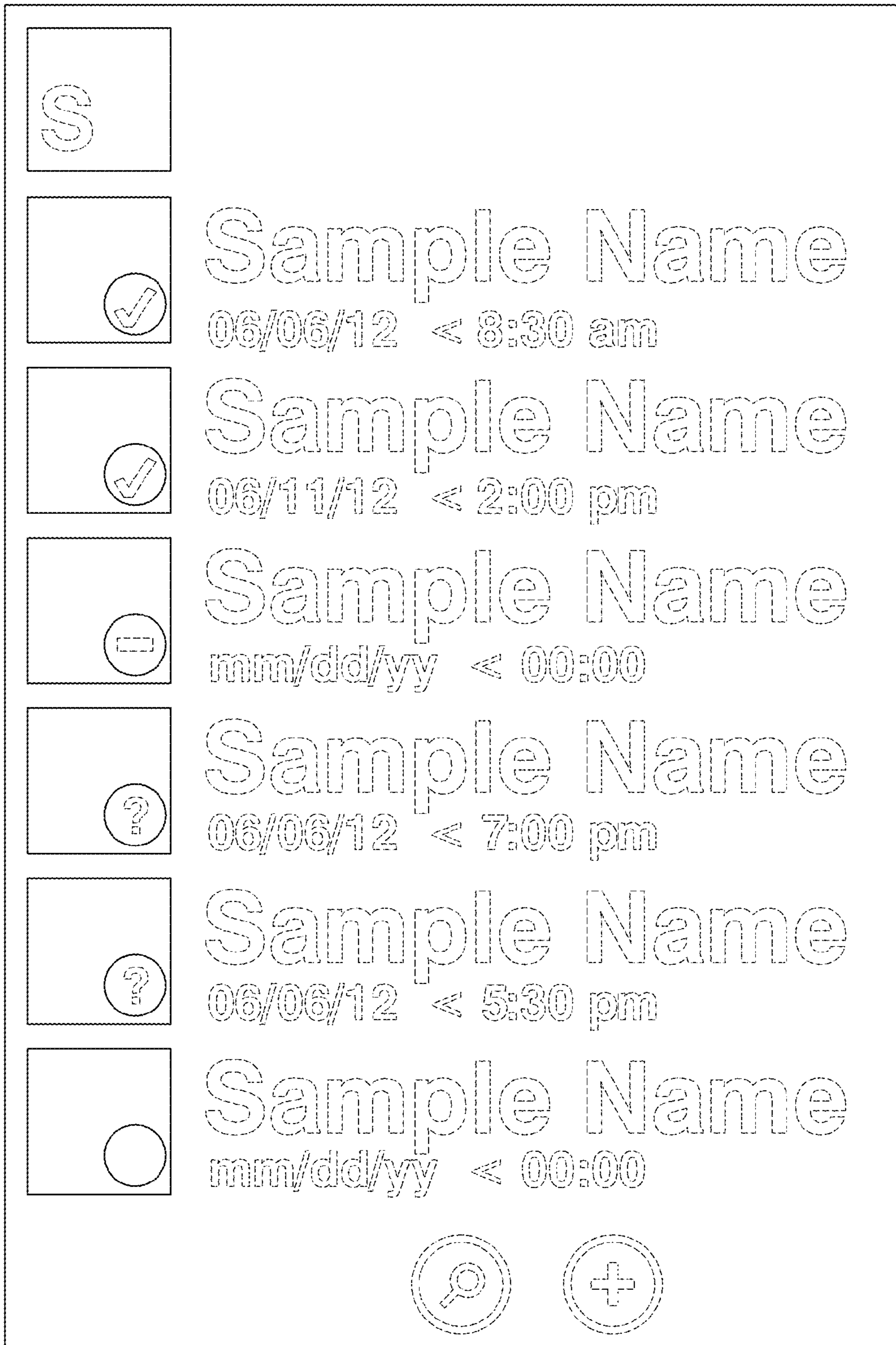

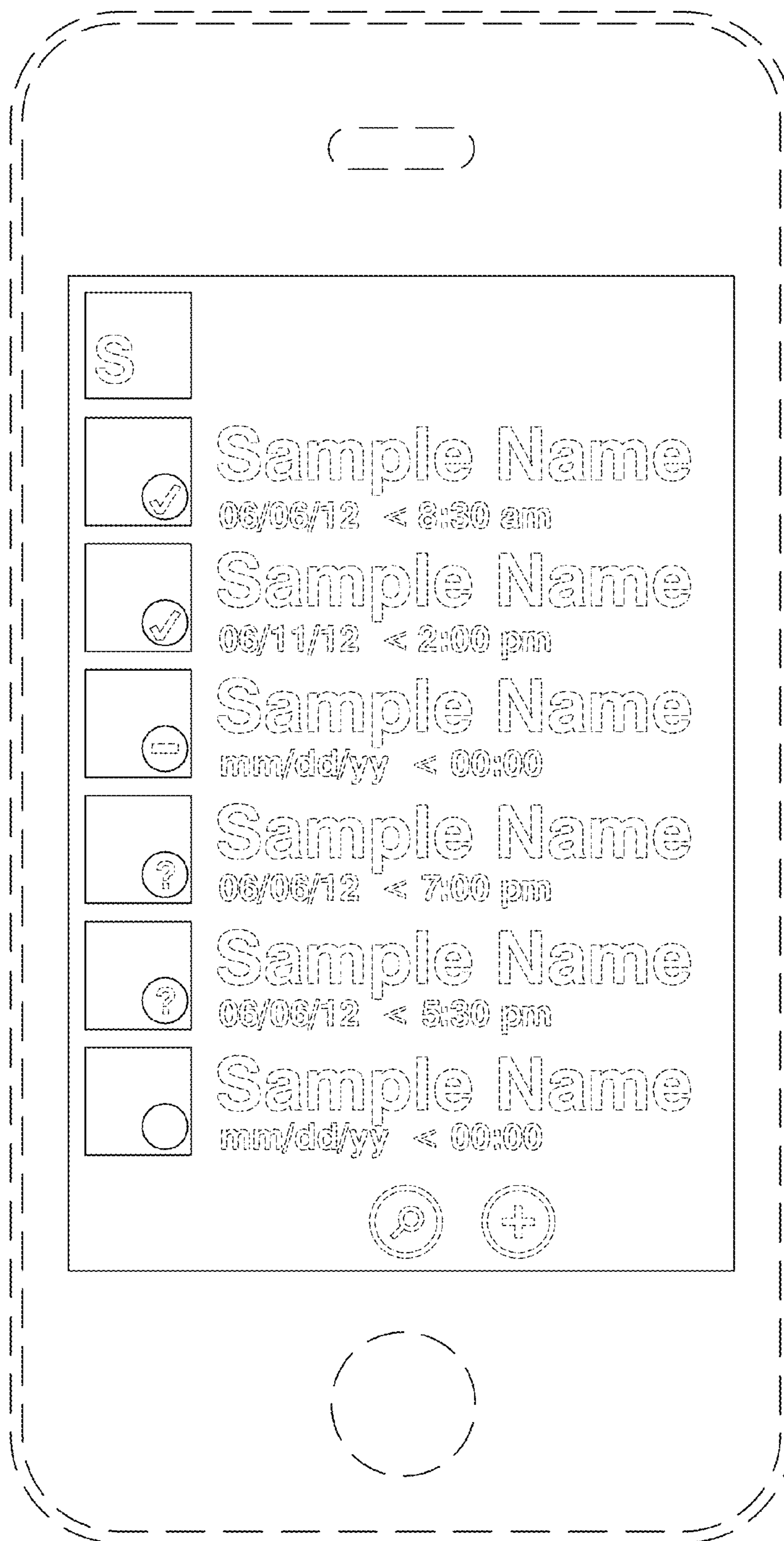
