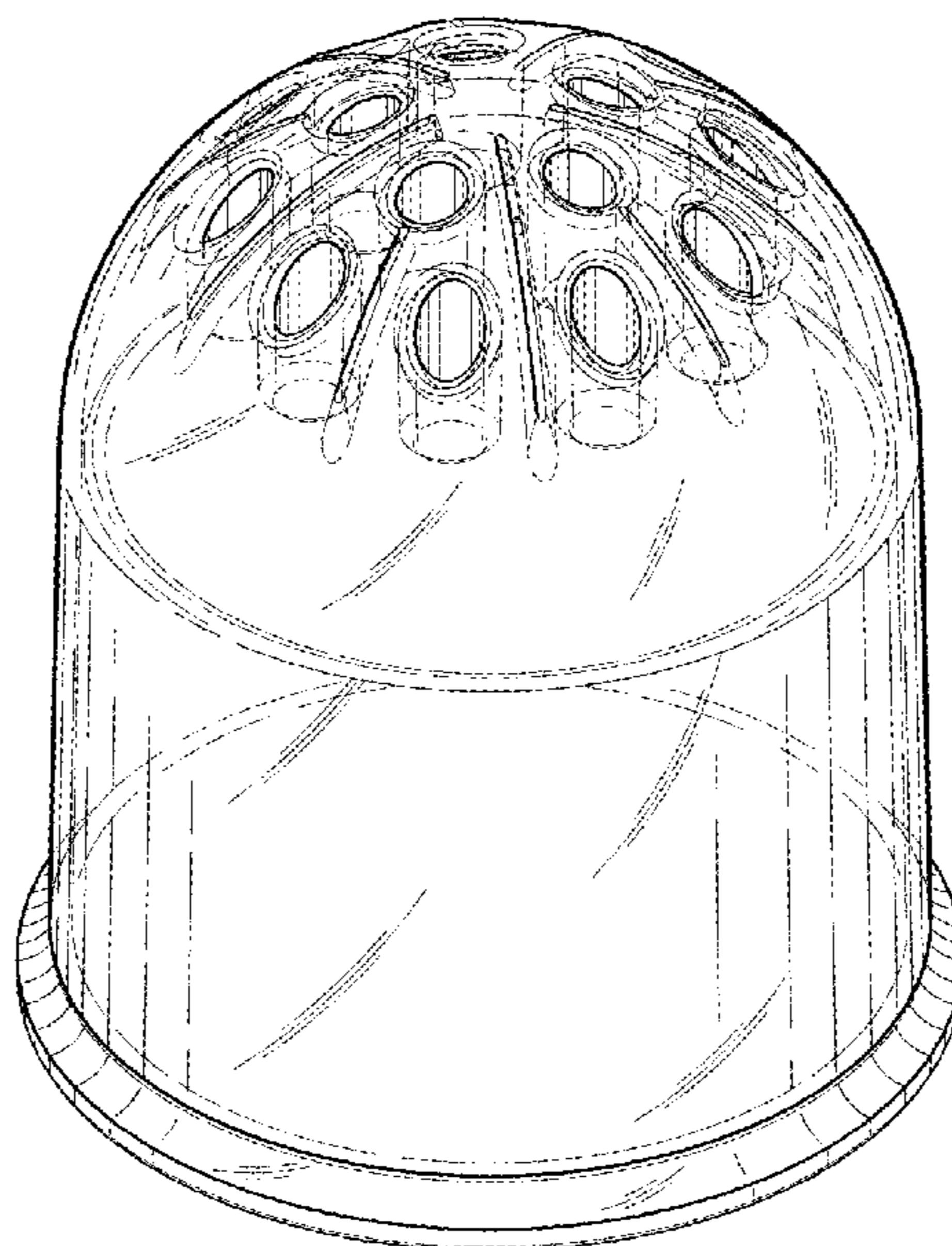
FIG. 1 is an upper perspective view of a translucent fruit fly trap in accordance with the present design;

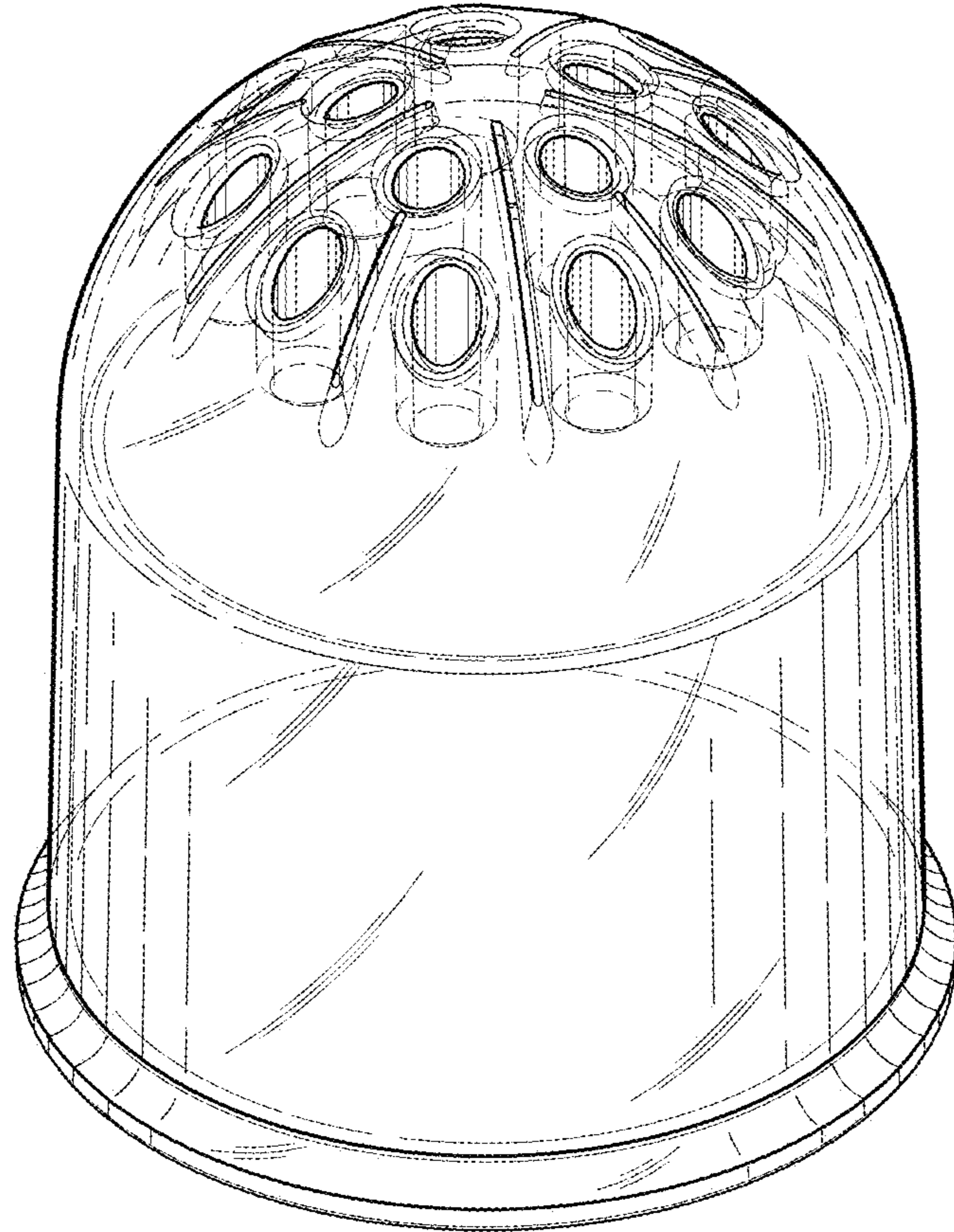

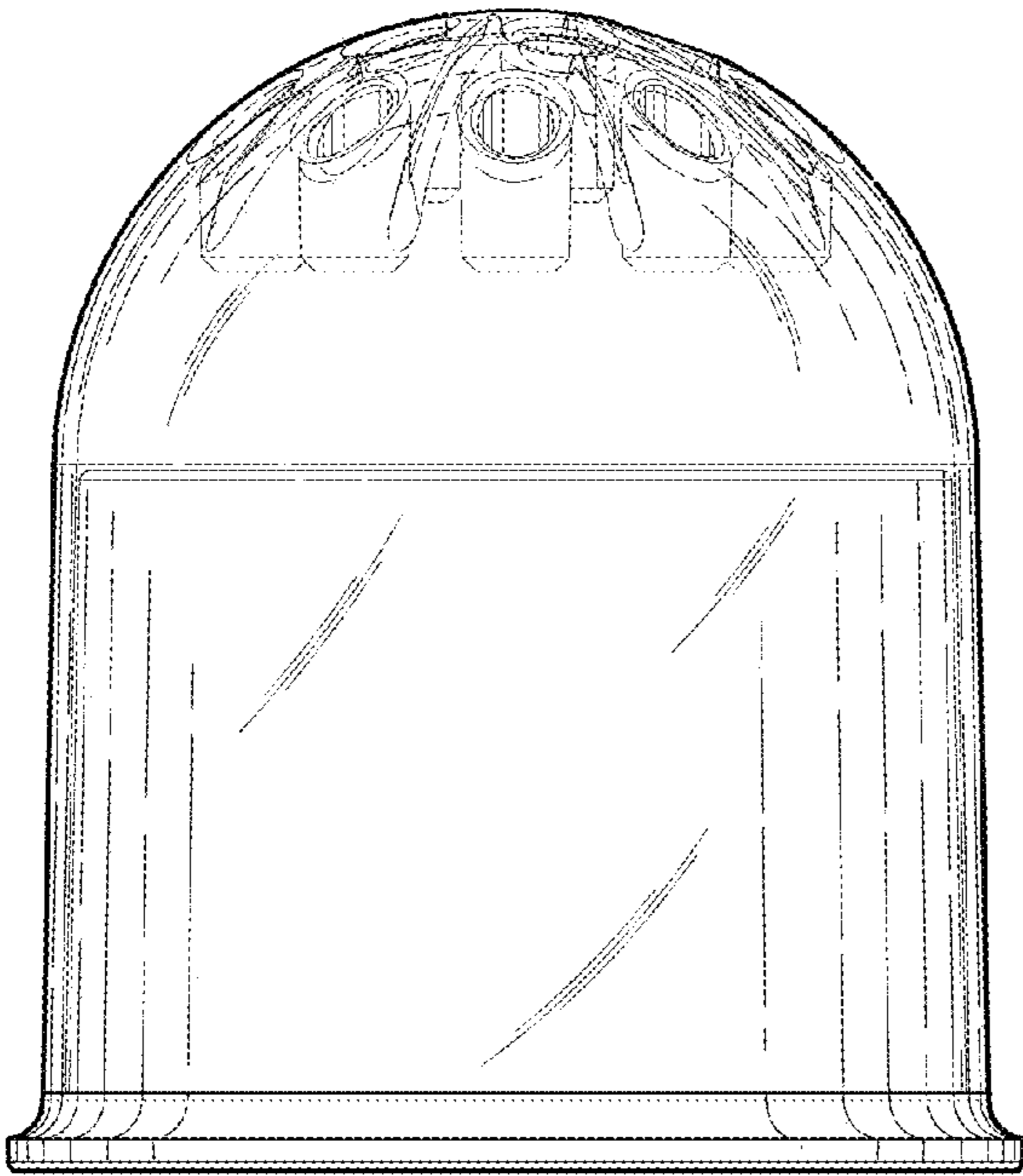

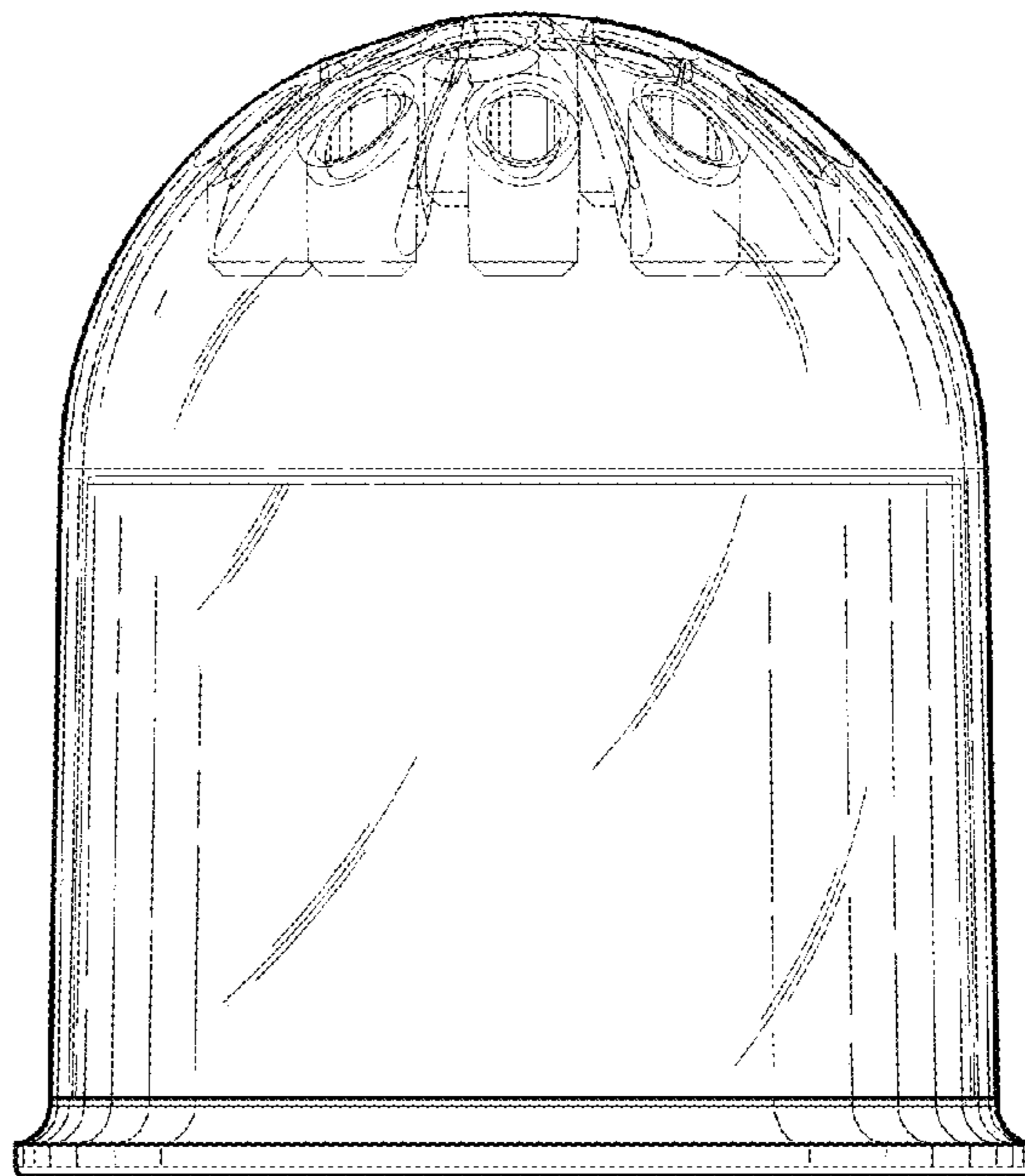

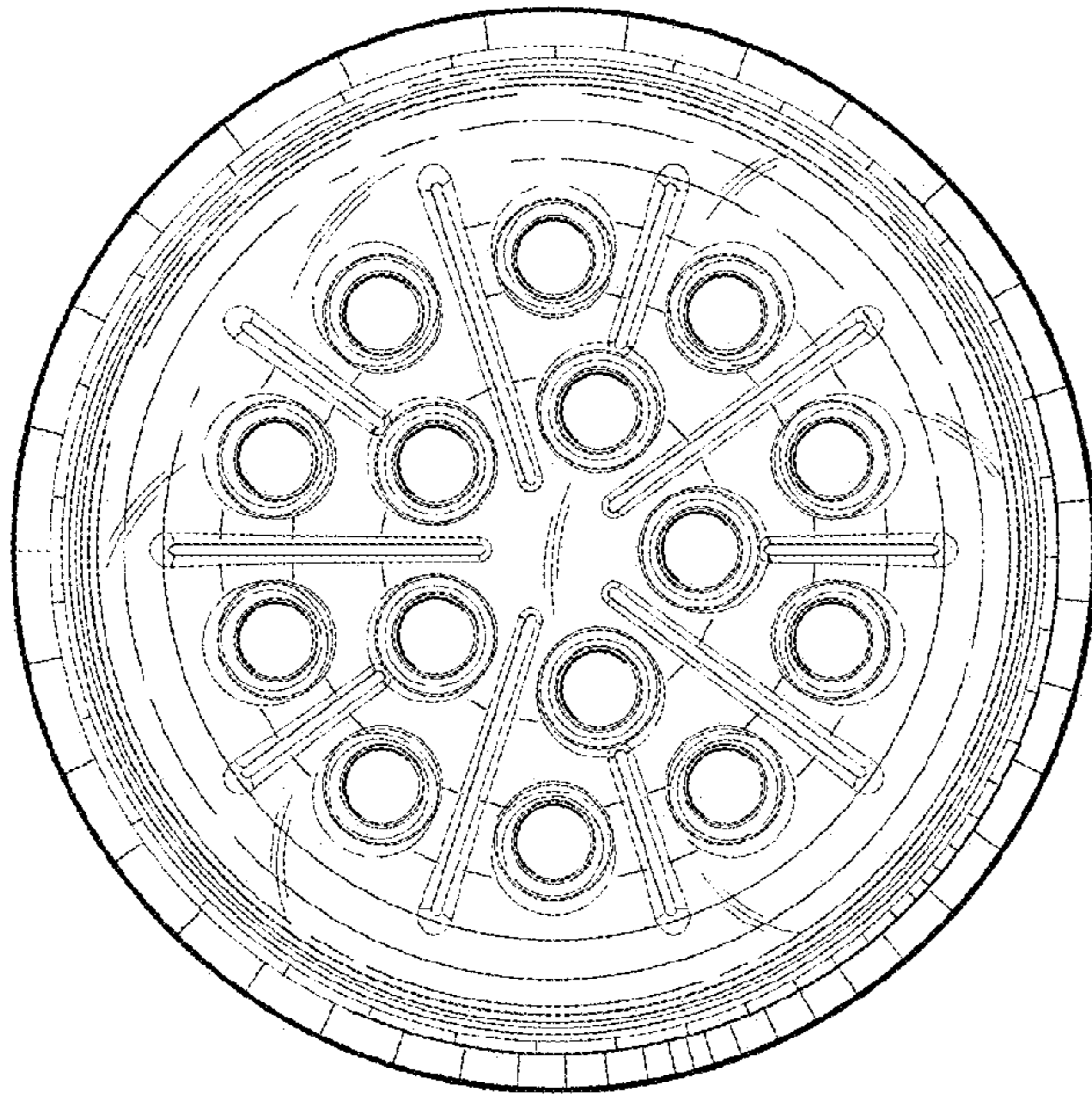

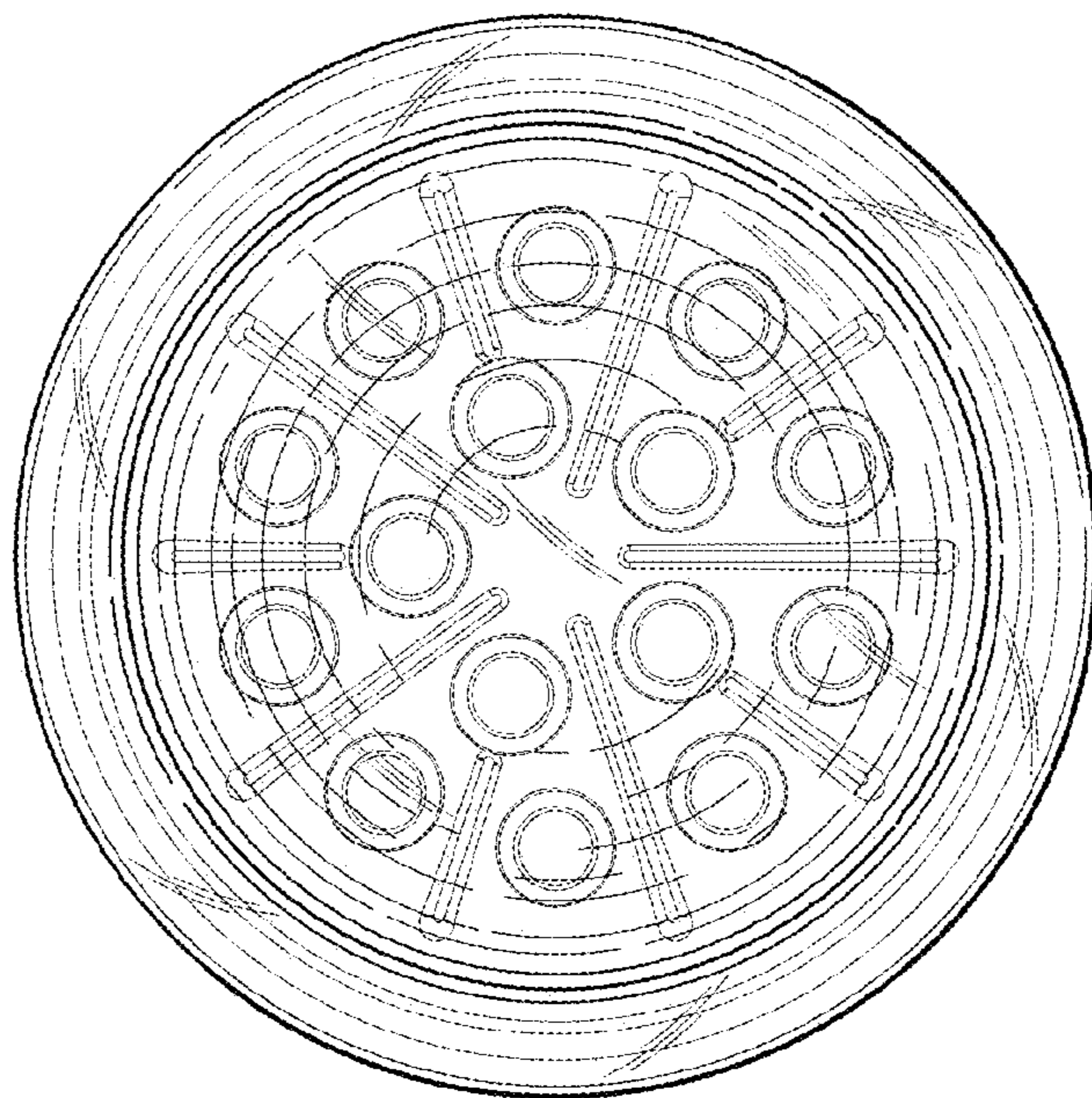

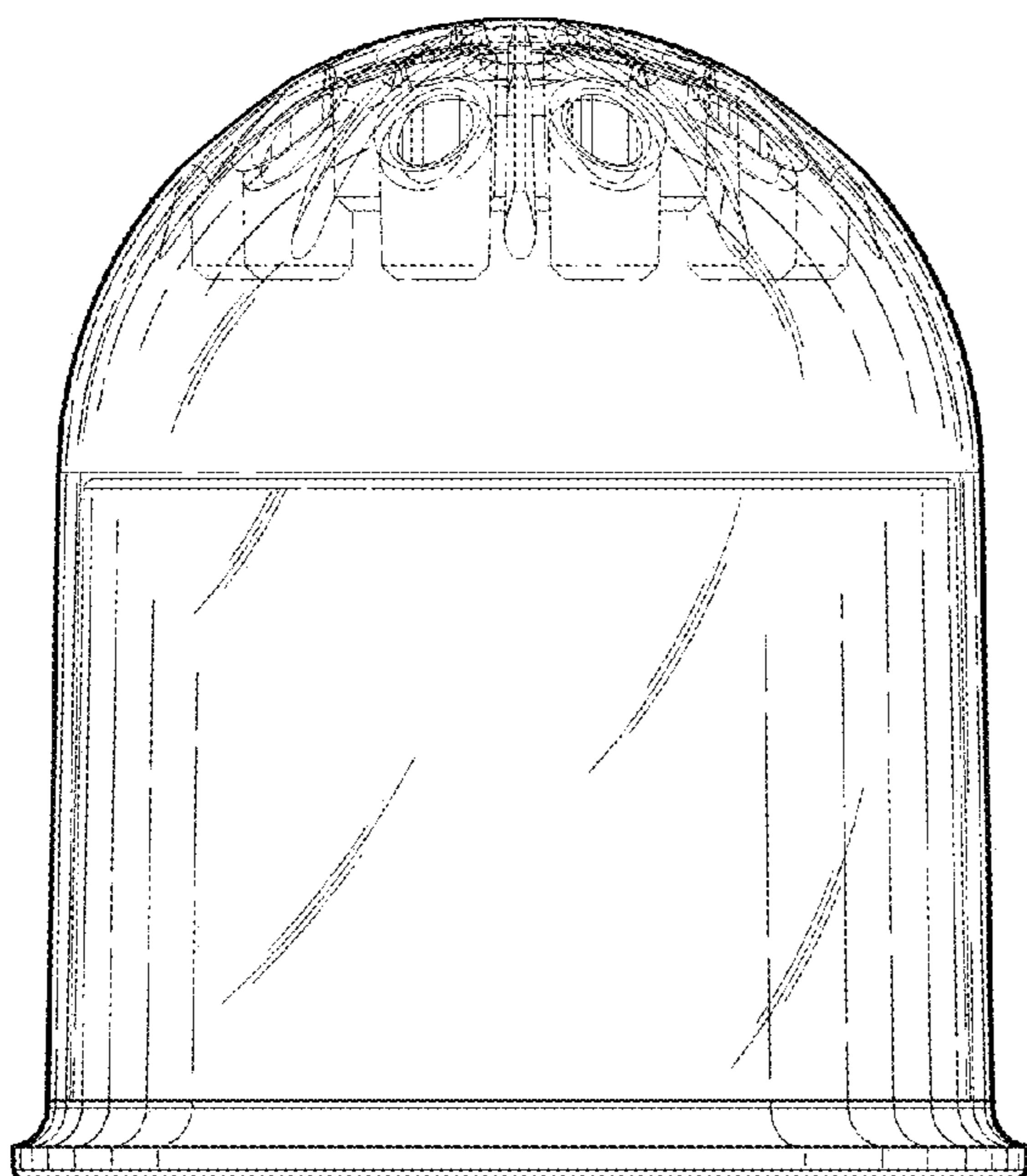

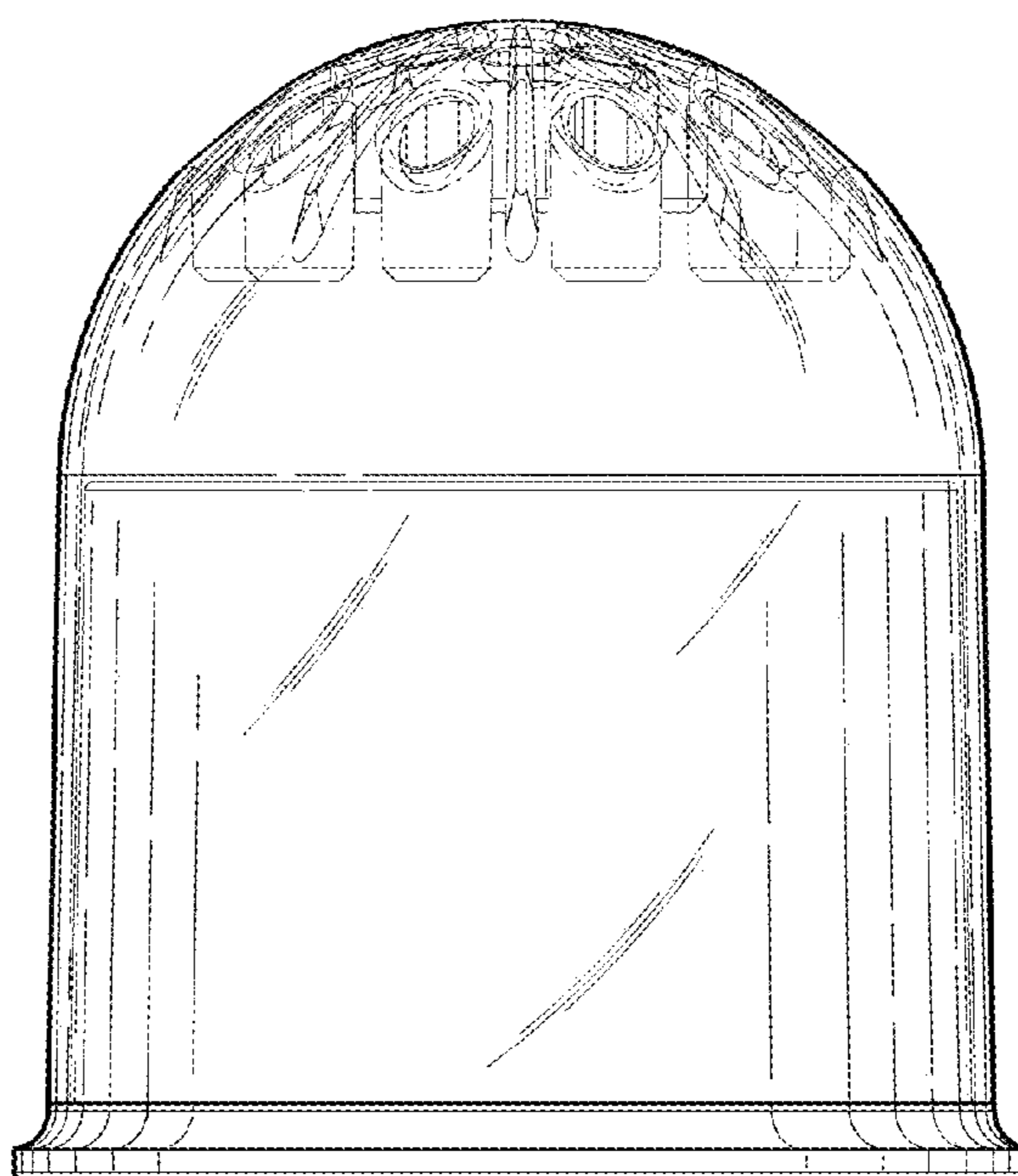
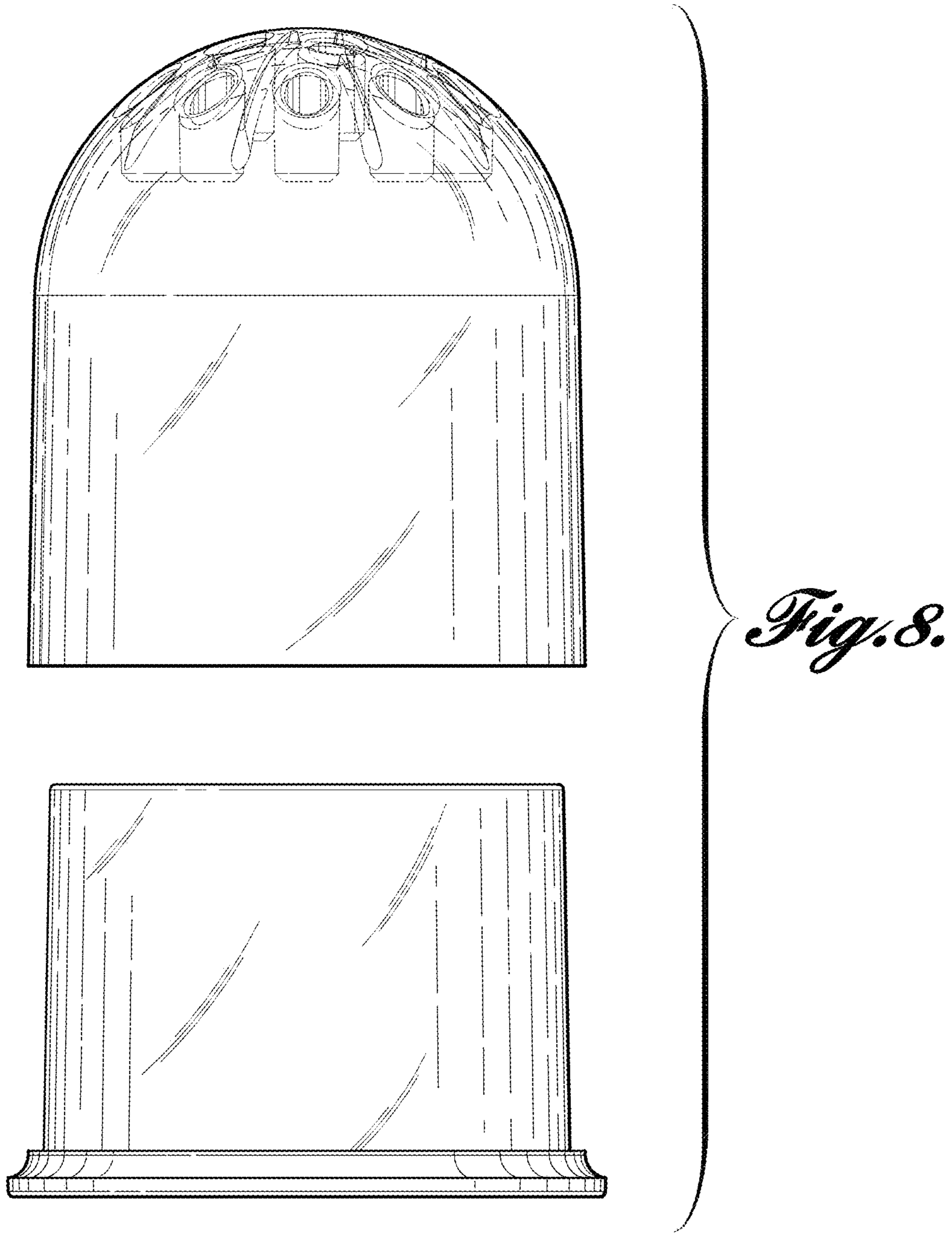

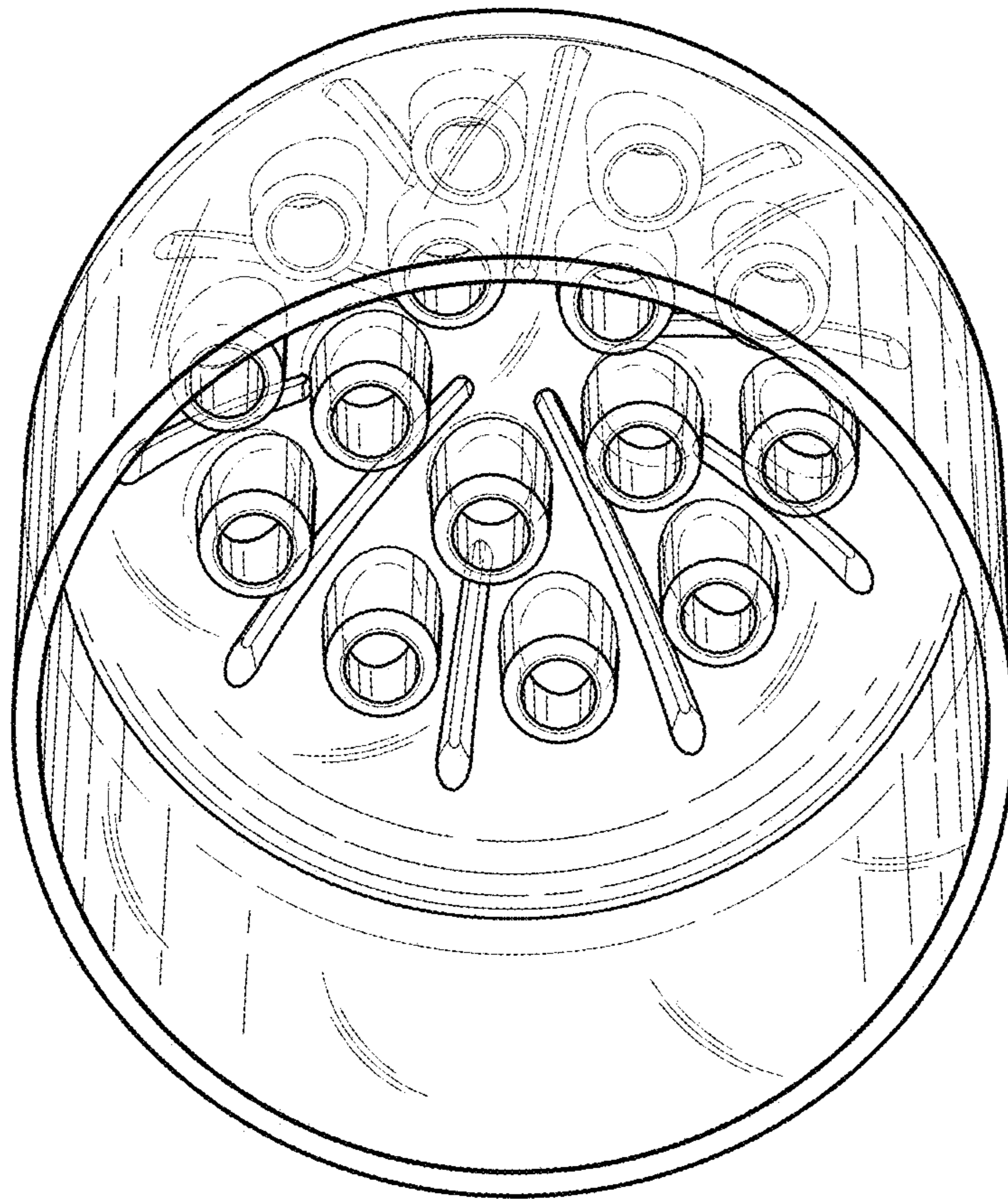
