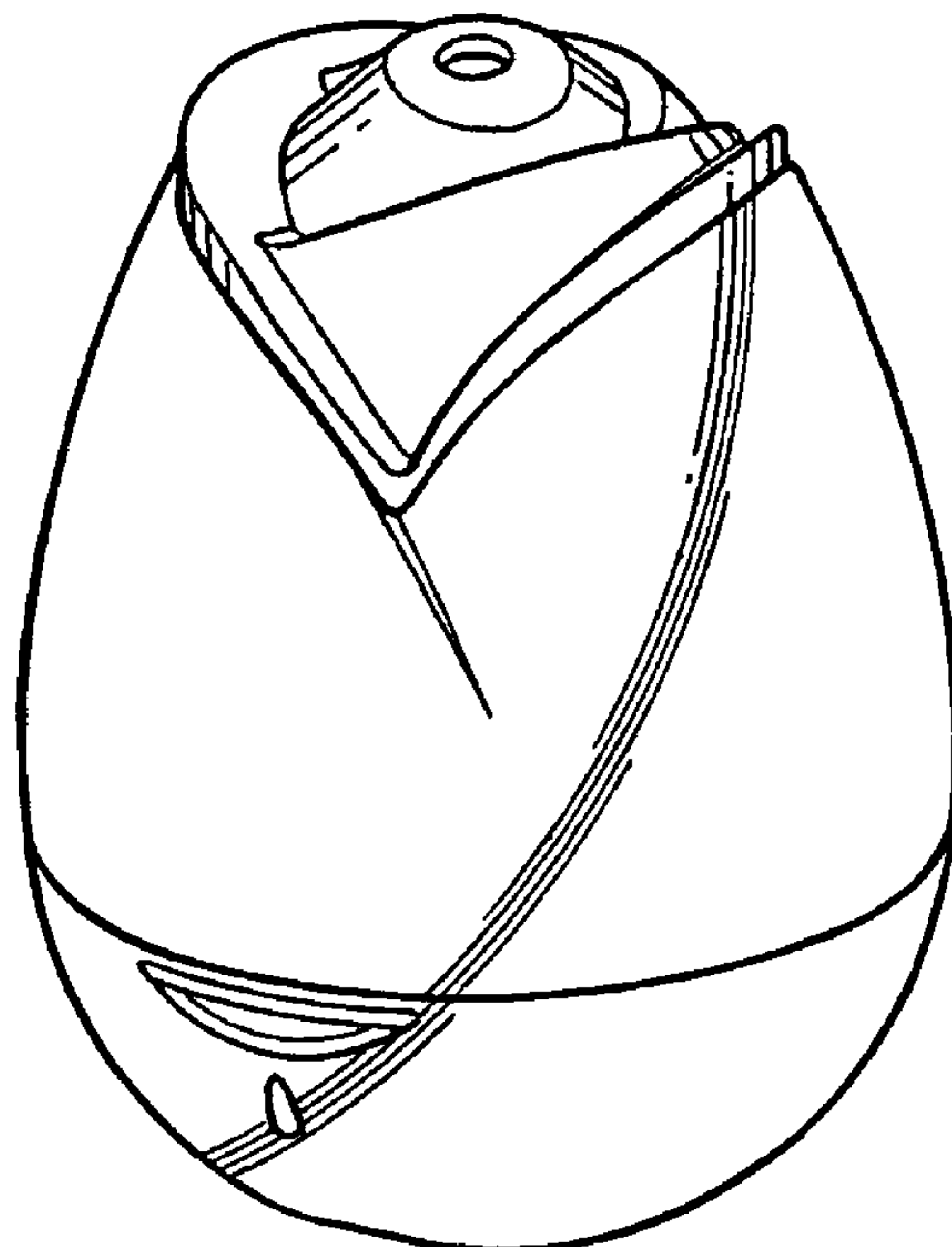

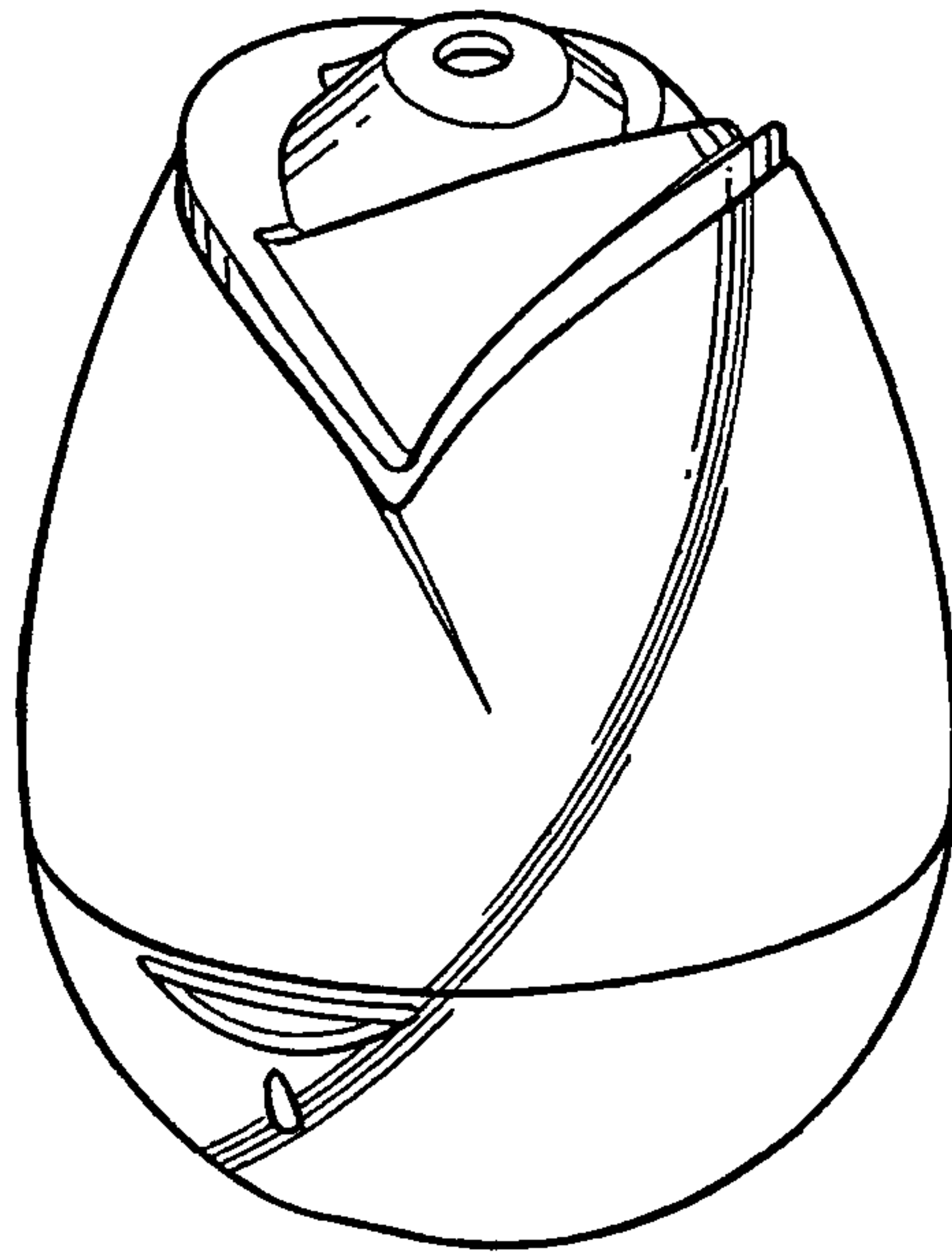

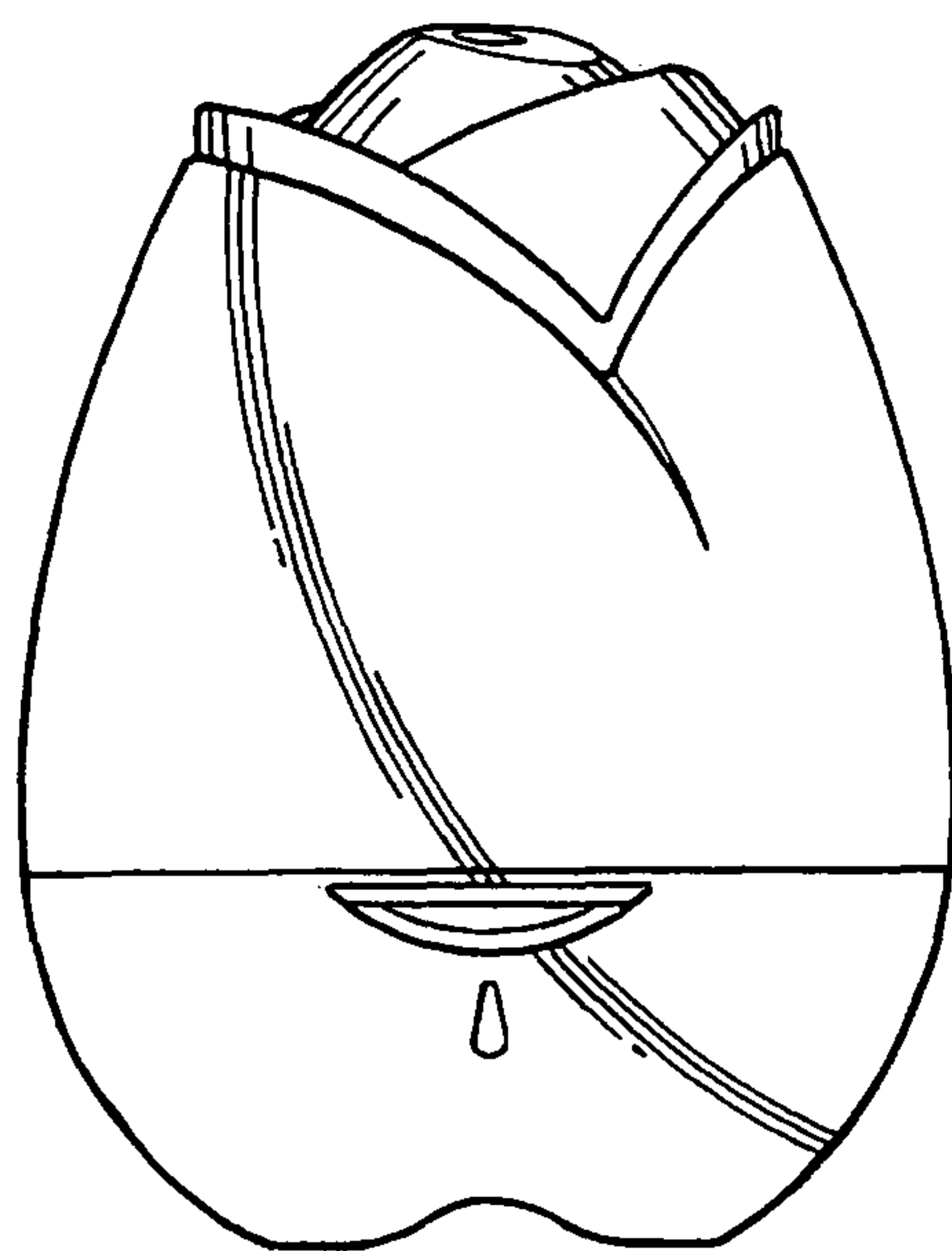
FIG. 1 is a front perspective view of an aroma nebulizing diffuser showing my new design;

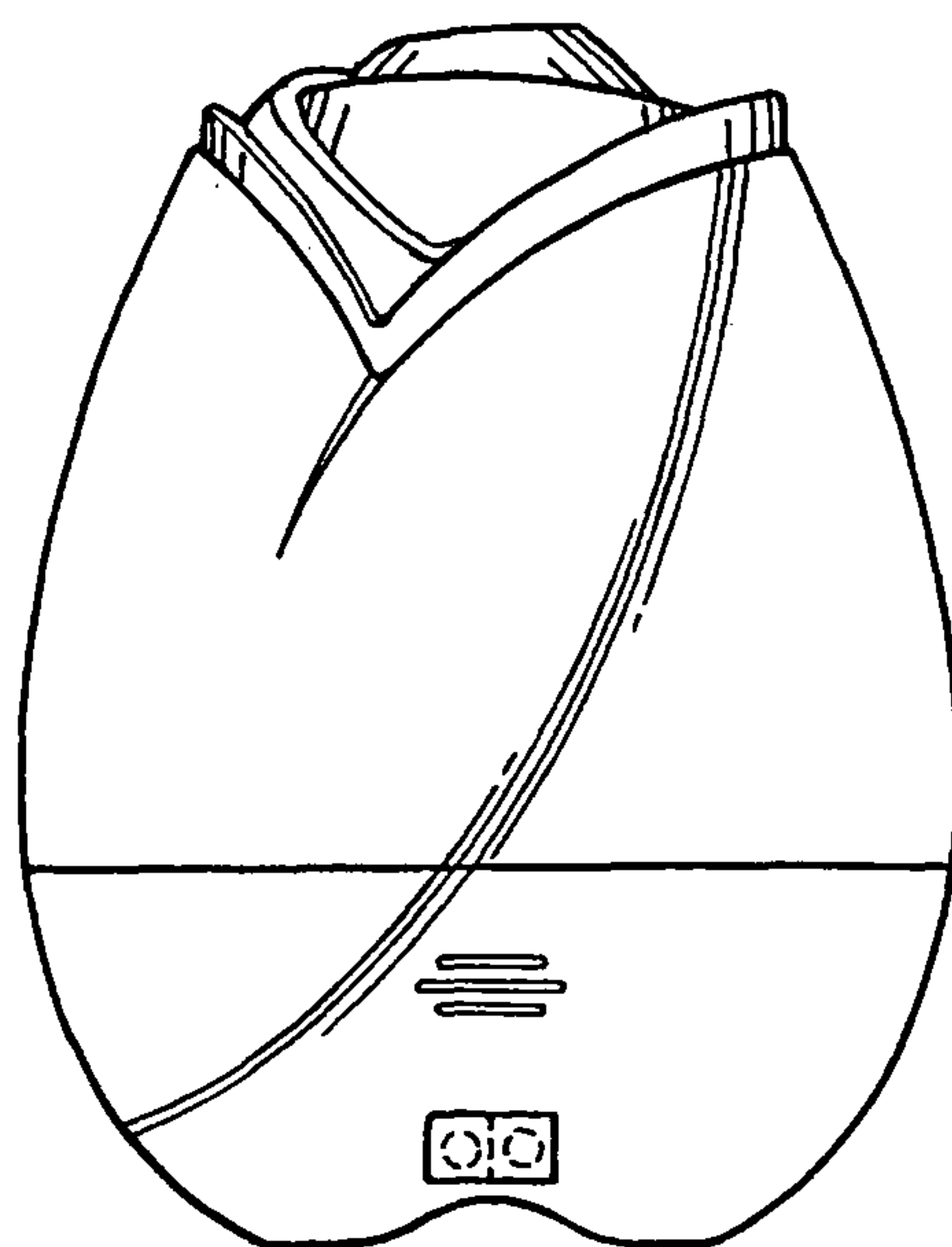




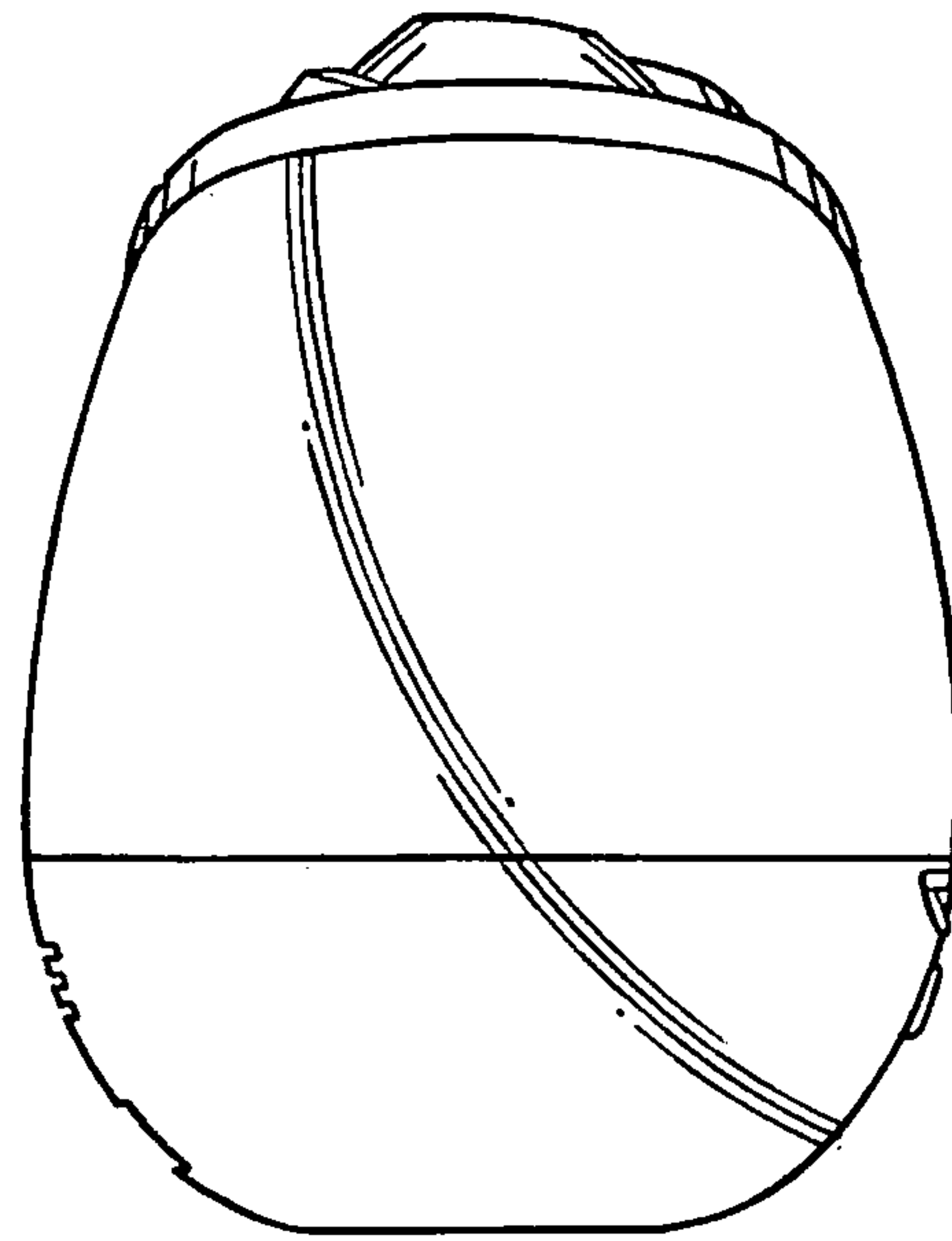

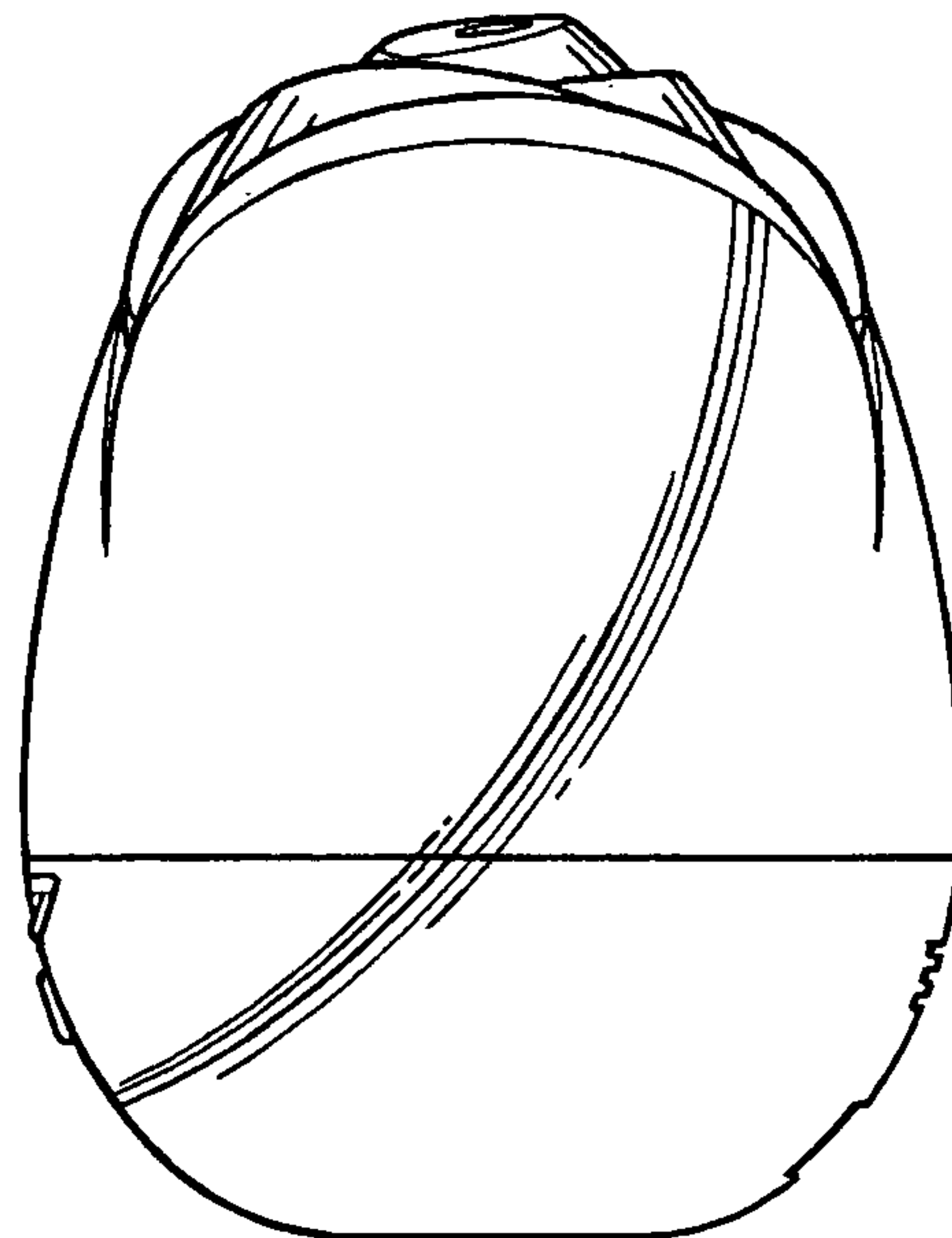

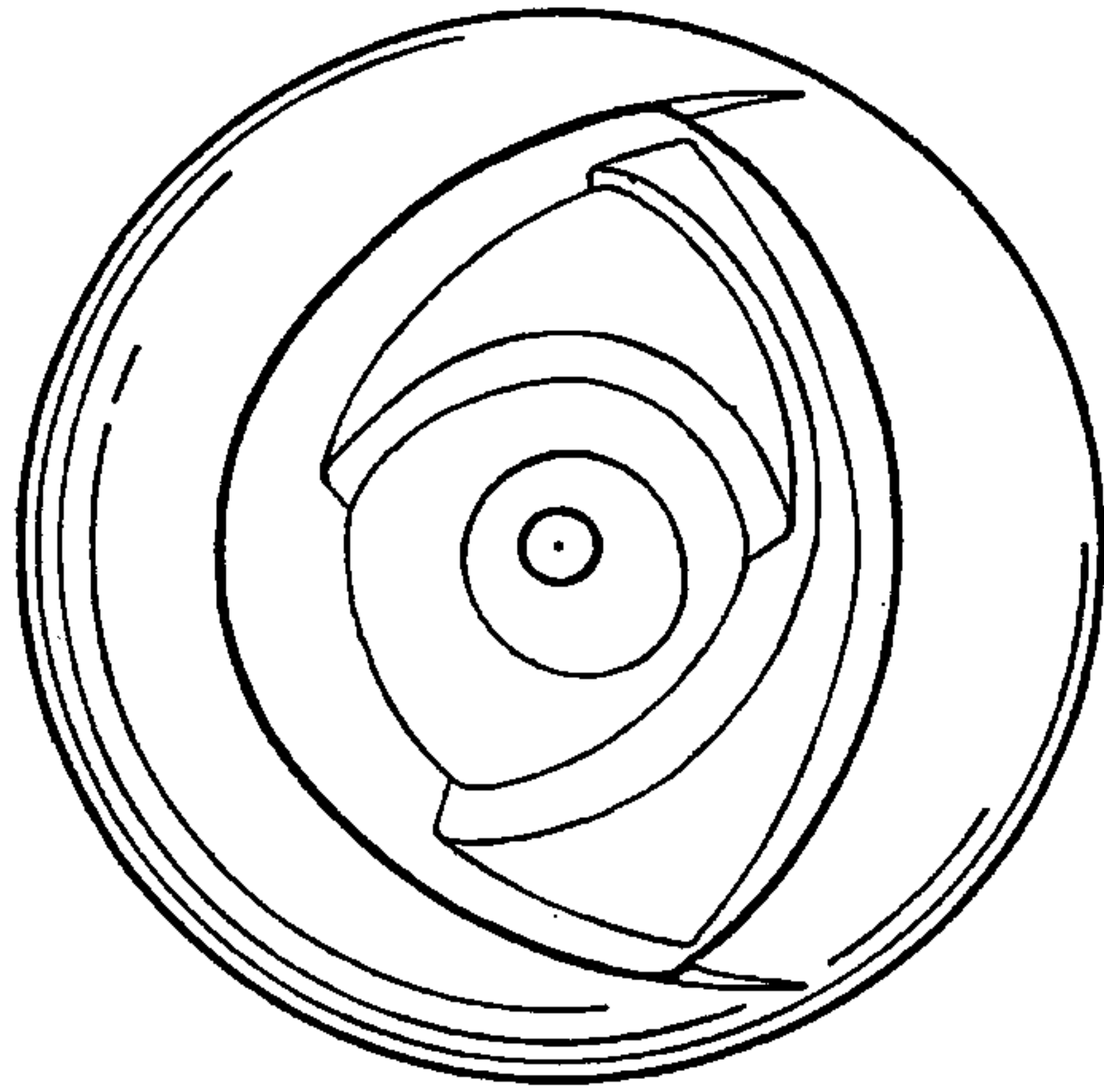

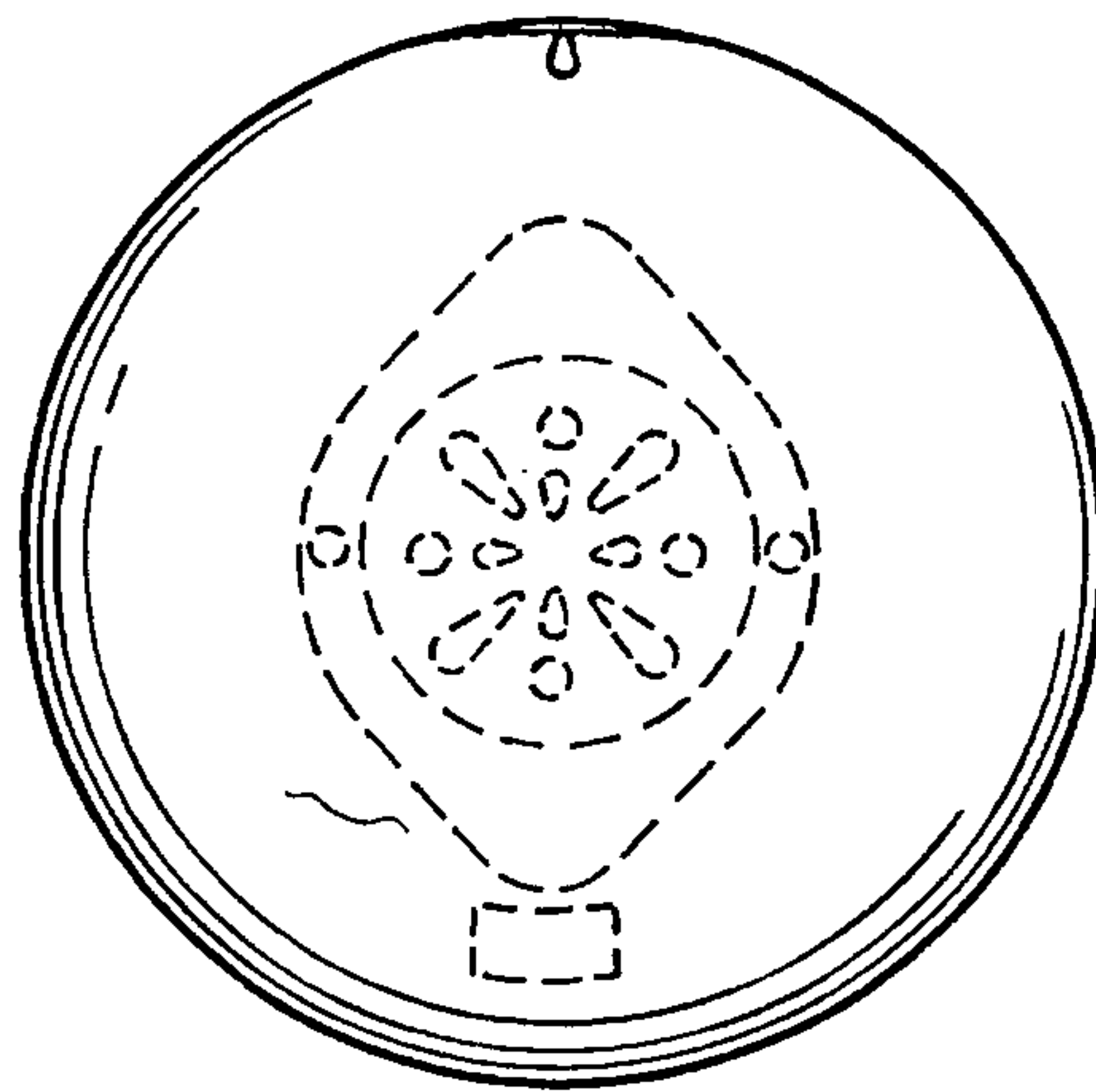
