The ornamental design for a light protection cover, as shown and described.

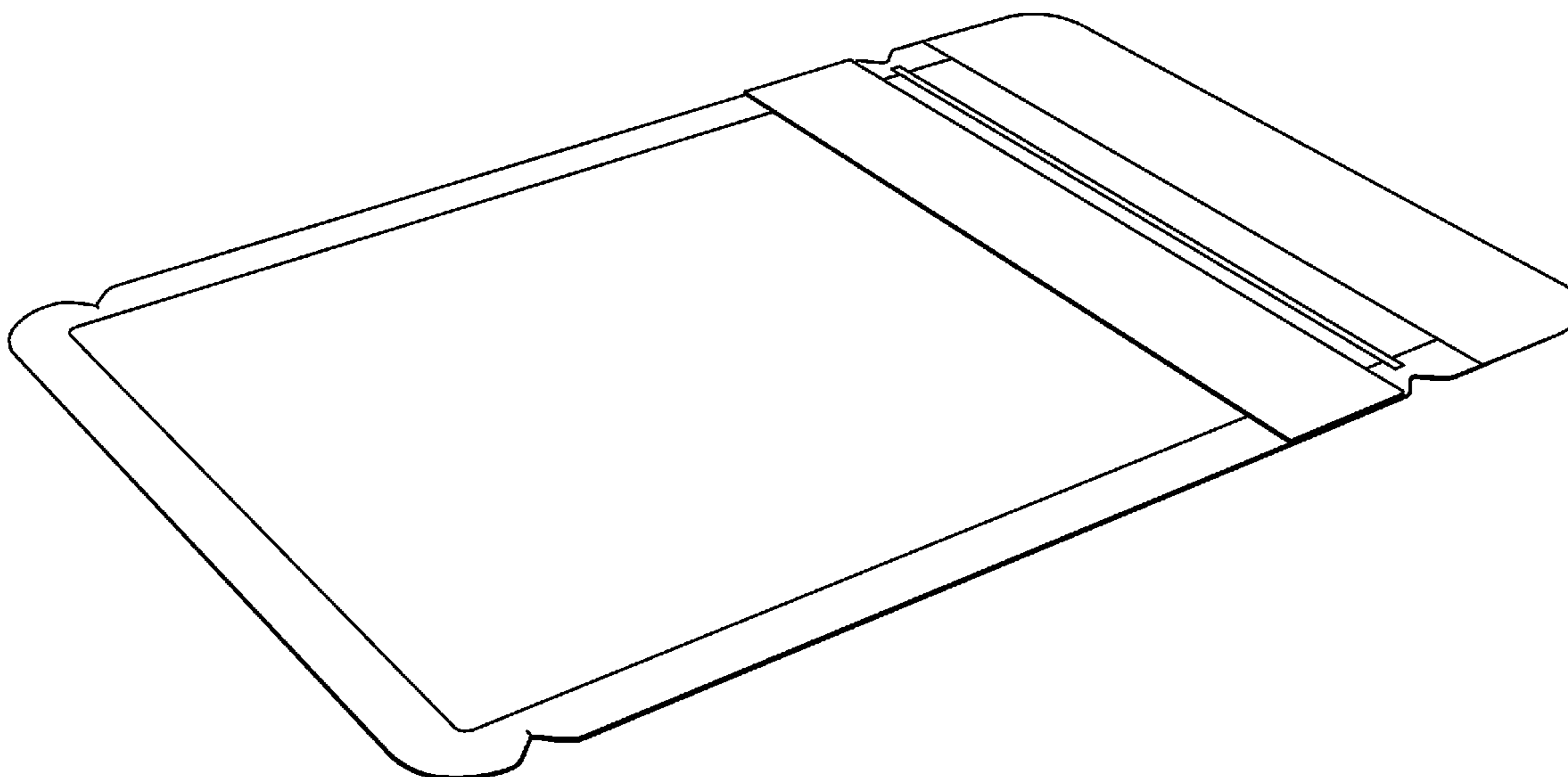
DESCRIPTION

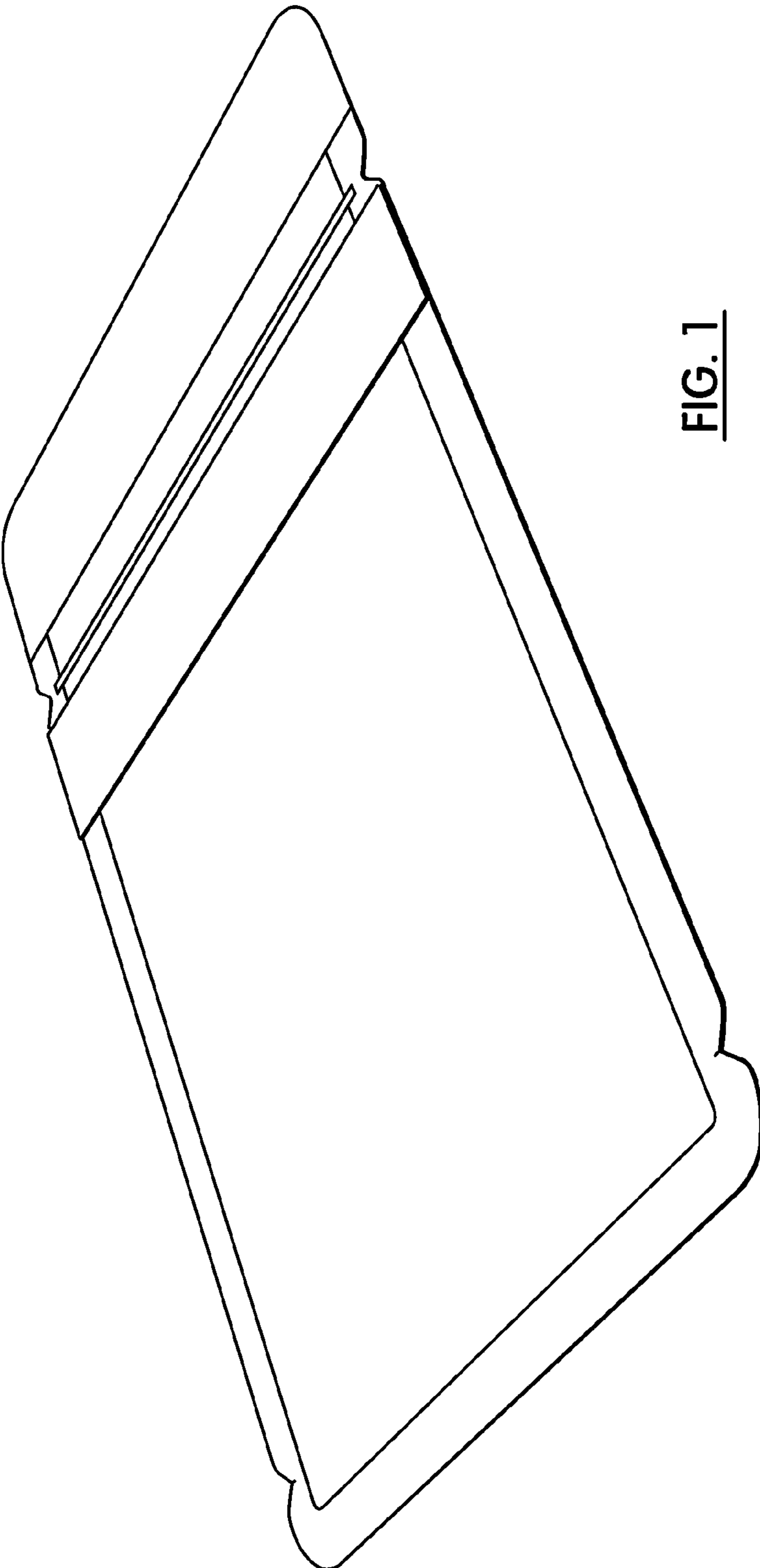

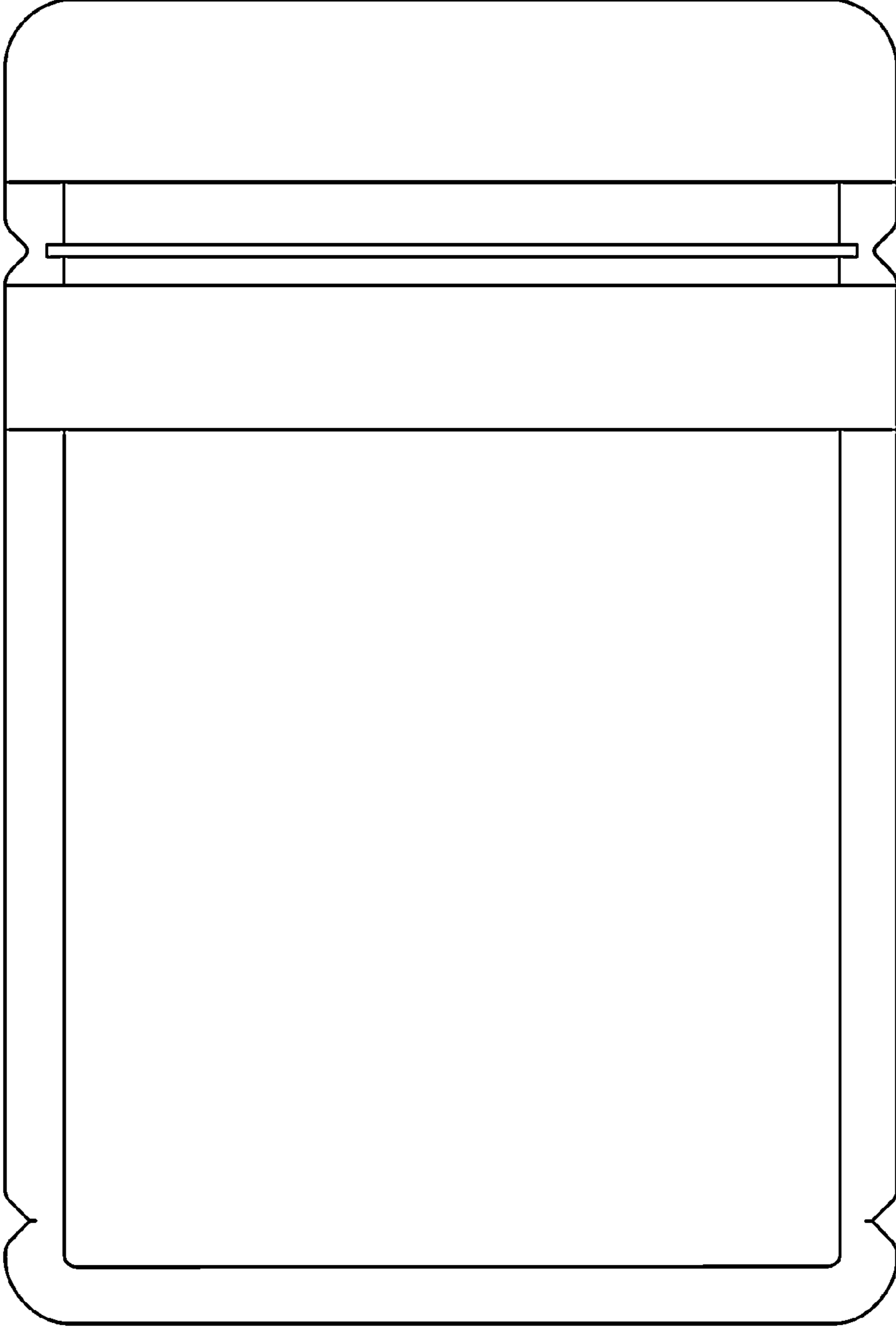

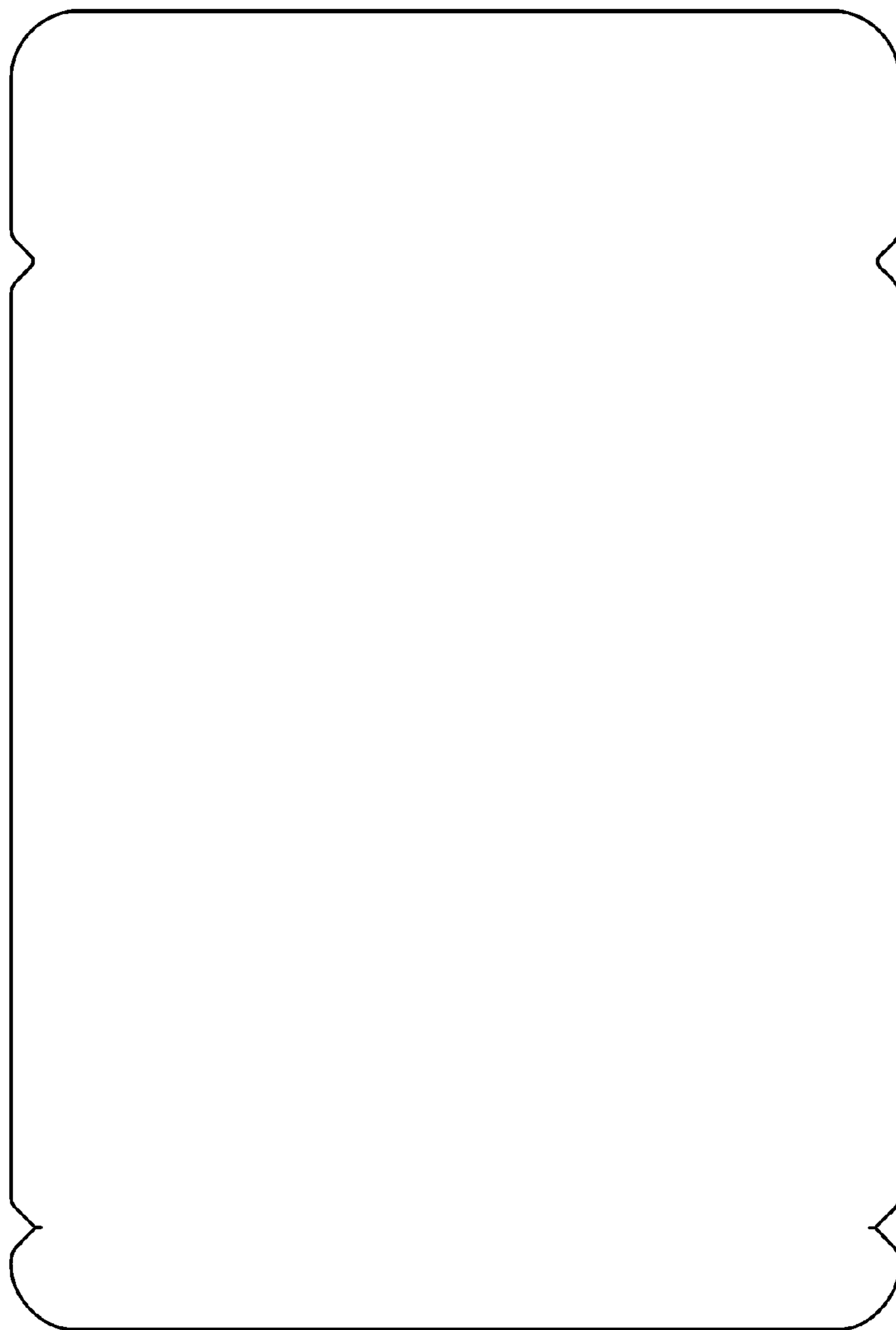
