The ornamental design for an undergarment, as shown and described.

FIG. 5 is a back elevation view of the undergarment turned inside-out.

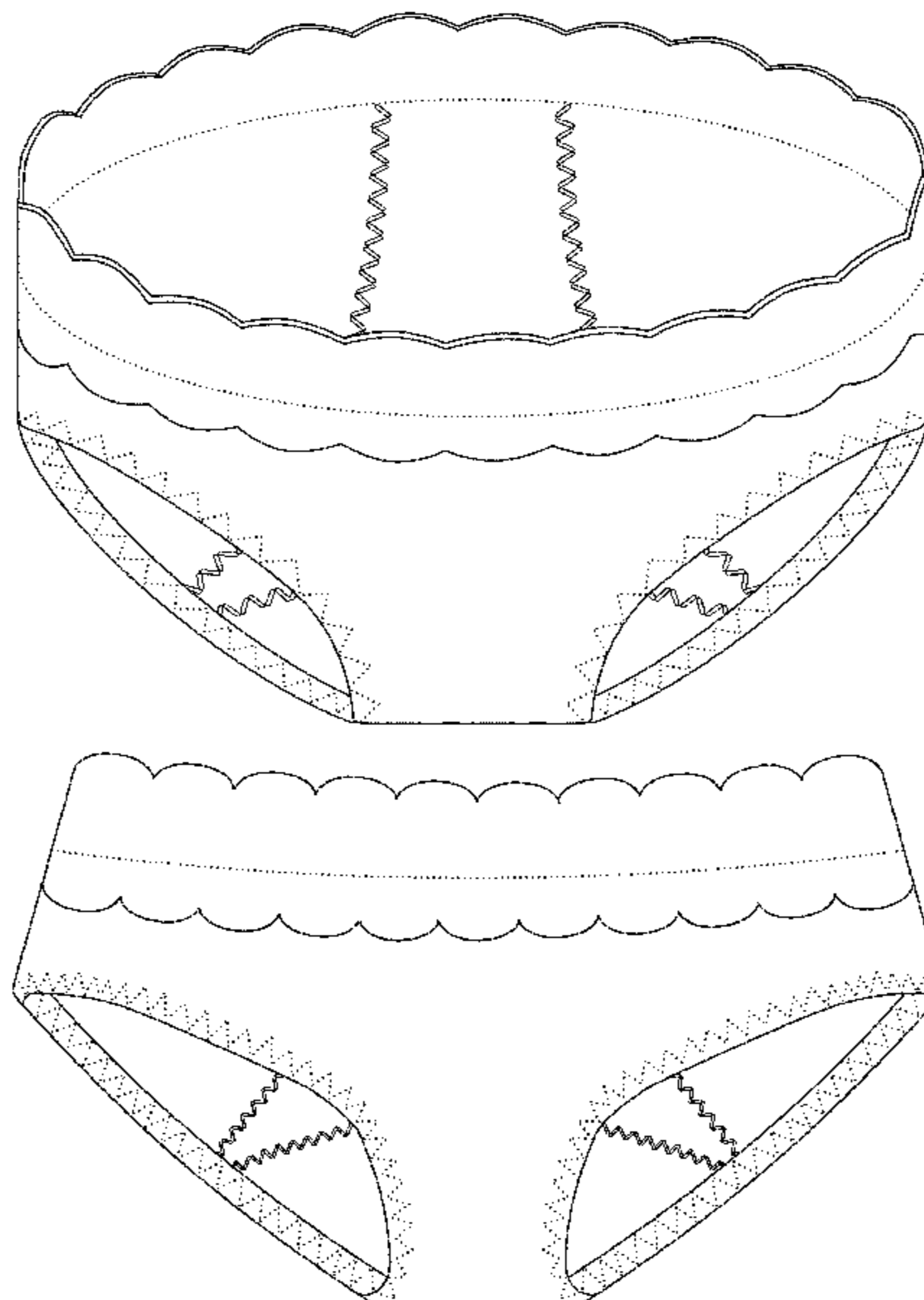
The broken, dotted lines shown in the figures show stitches that are not claimed.

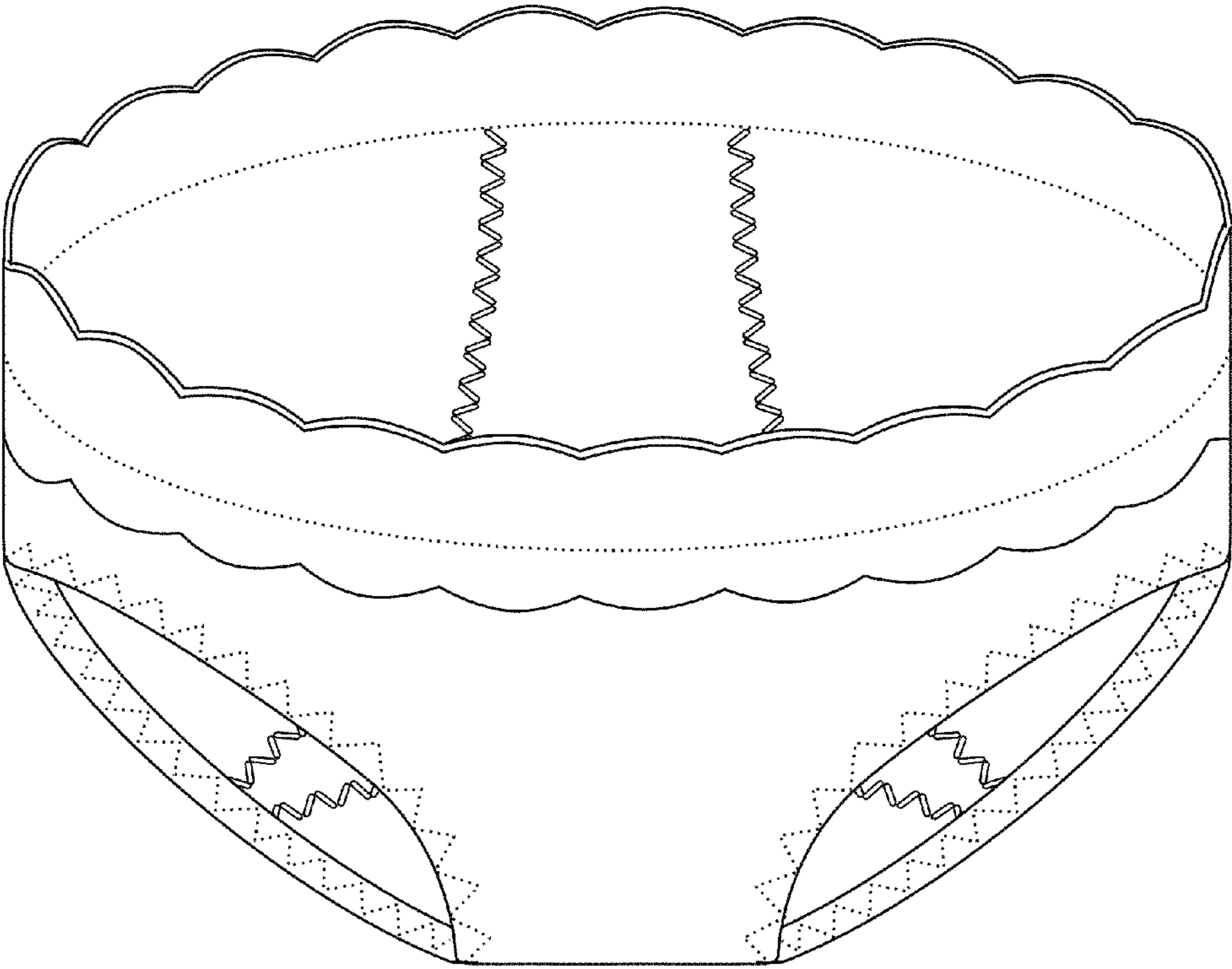

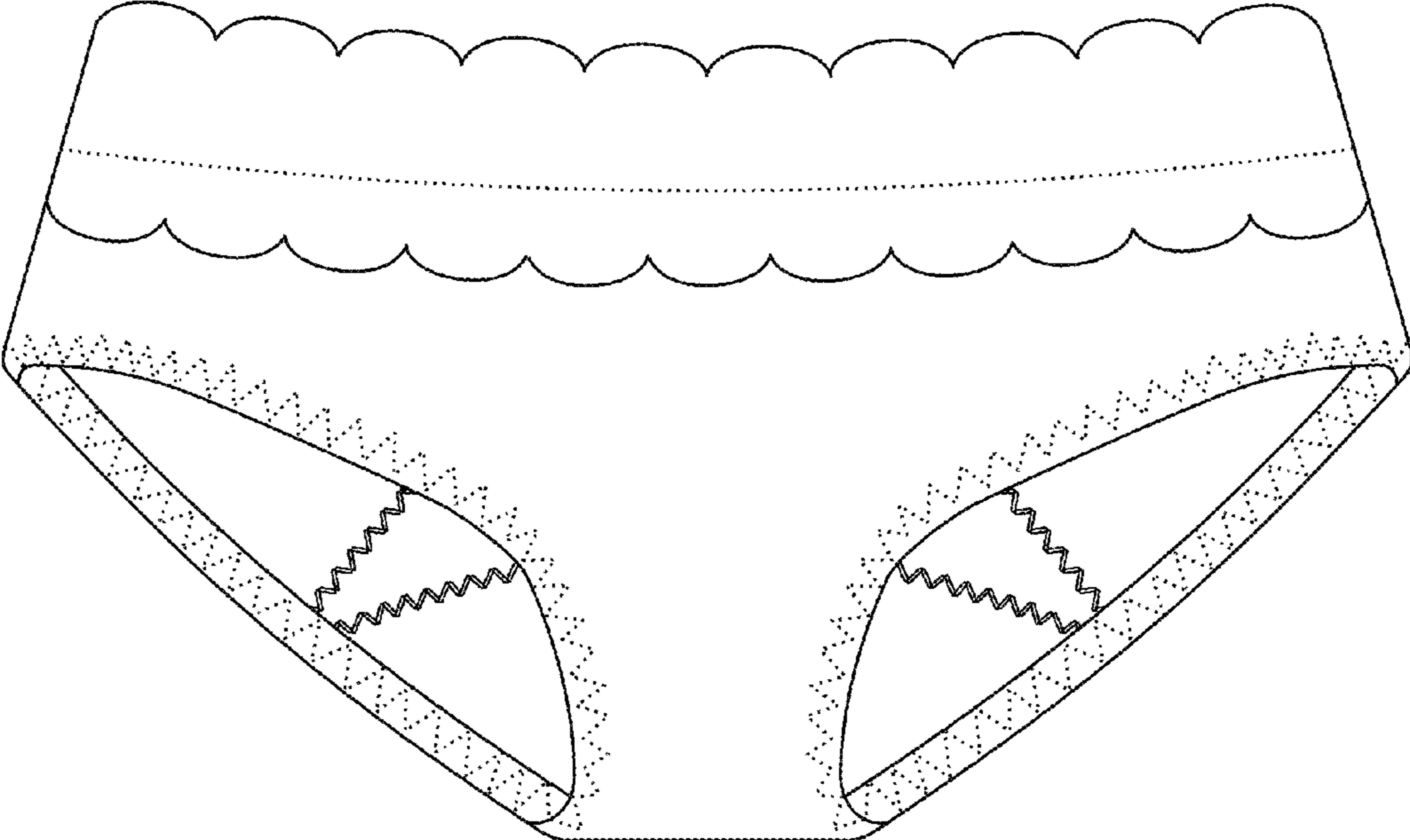

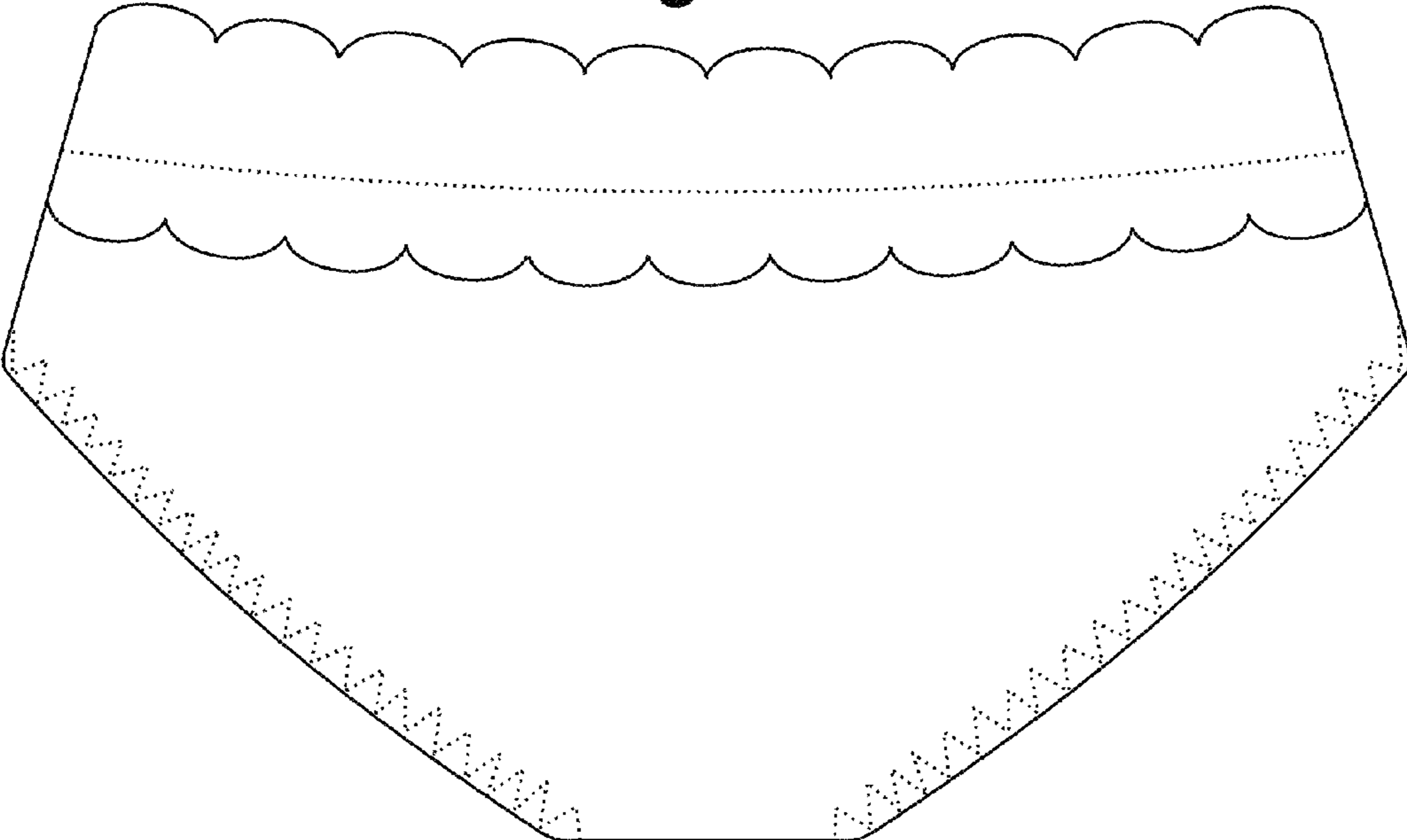

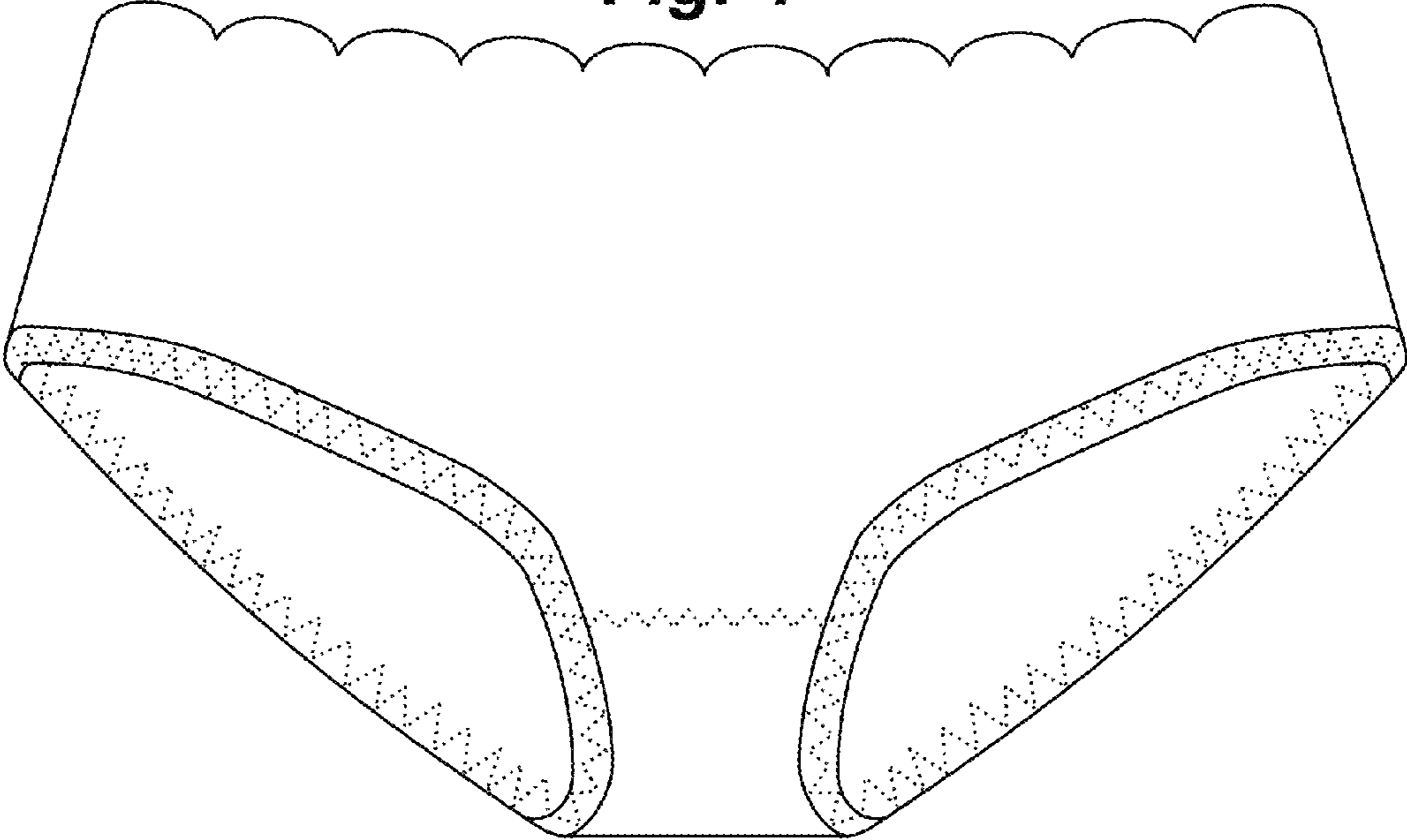
