The ornamental design for a shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe outsole showing my new design;

FIG. 2 is a plan view thereof;

FIG. 3 is a rear perspective view thereof;

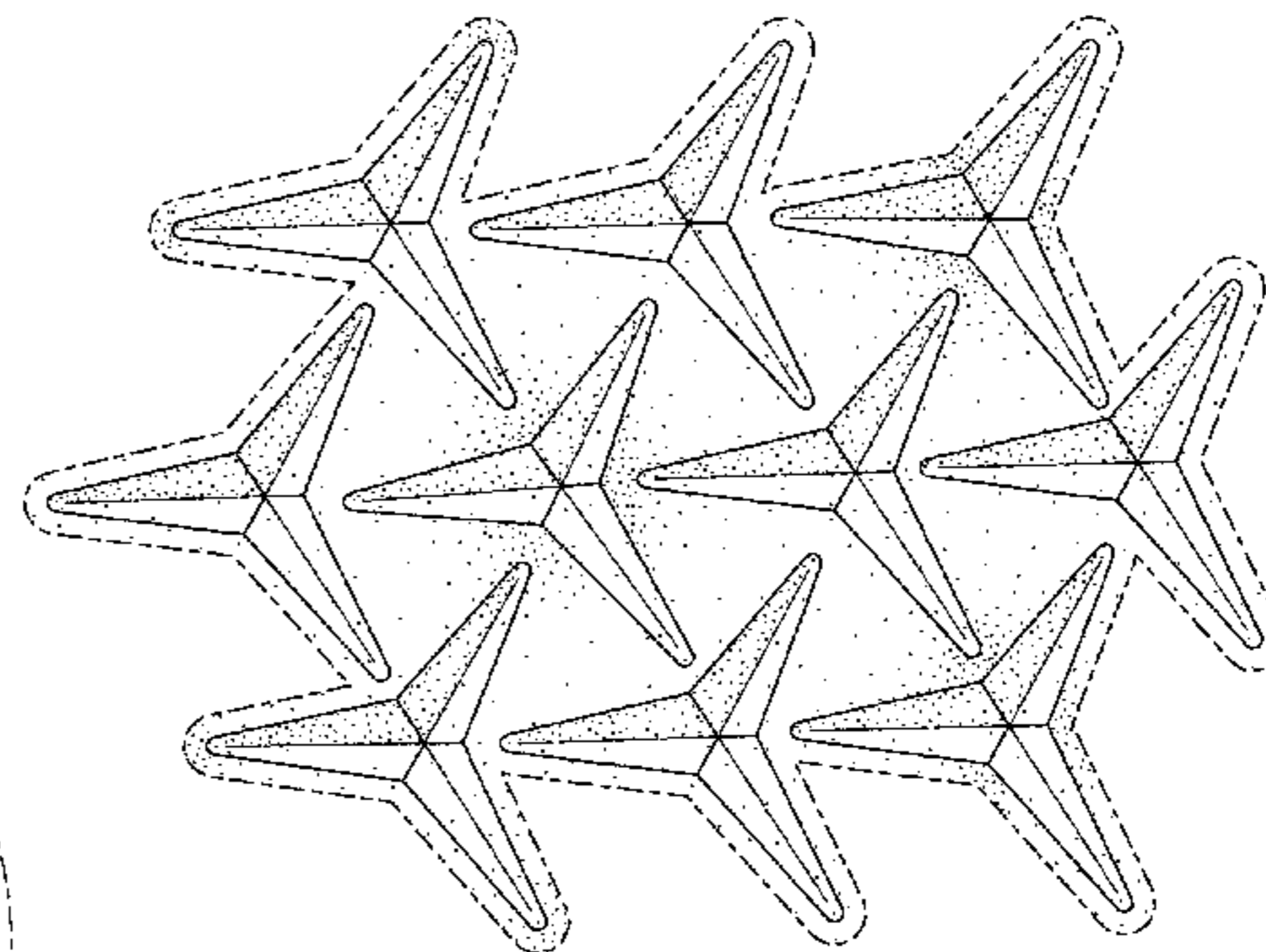
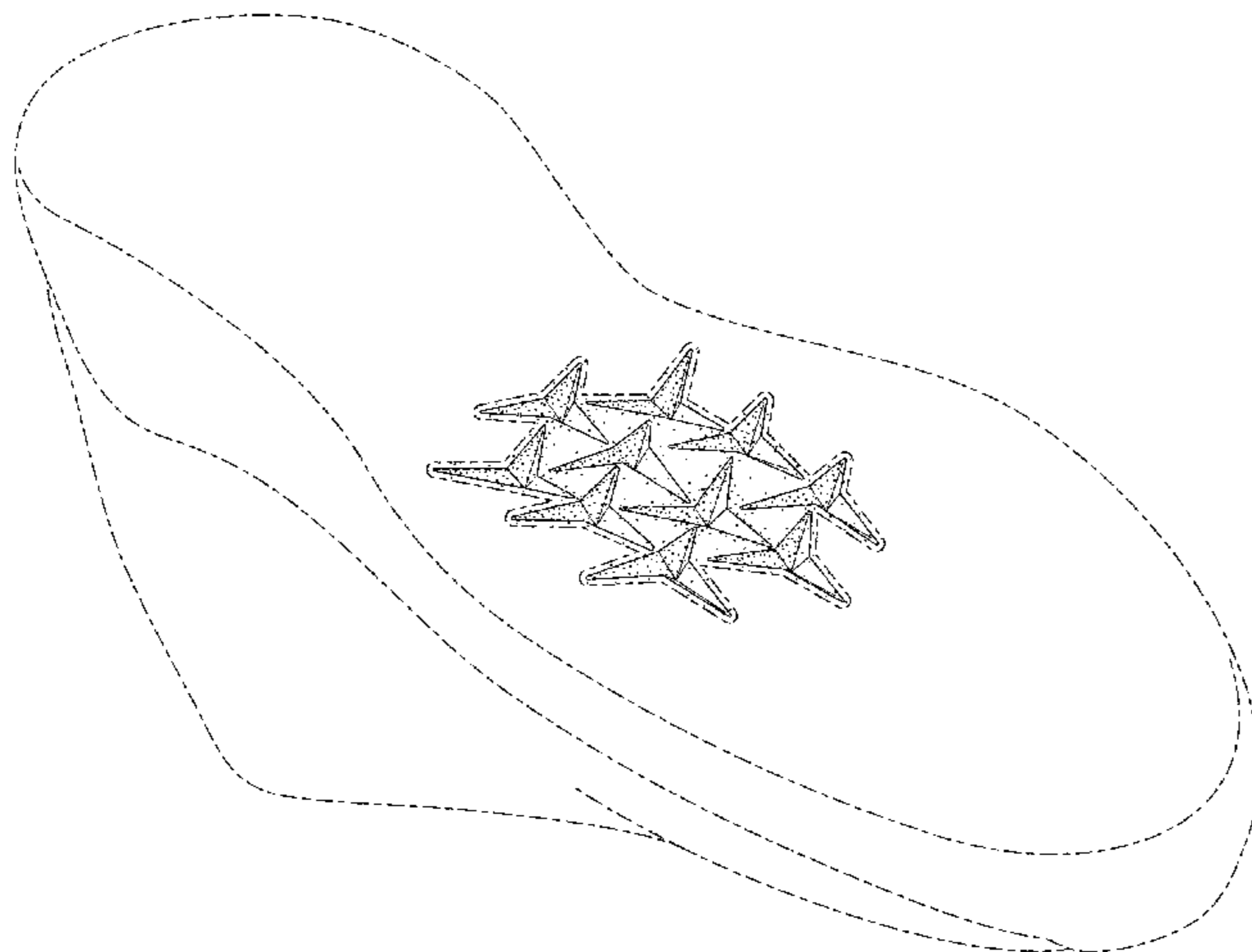
FIG. 4 is an enlarged view of the claimed region in FIG. 1 shown in isolation;

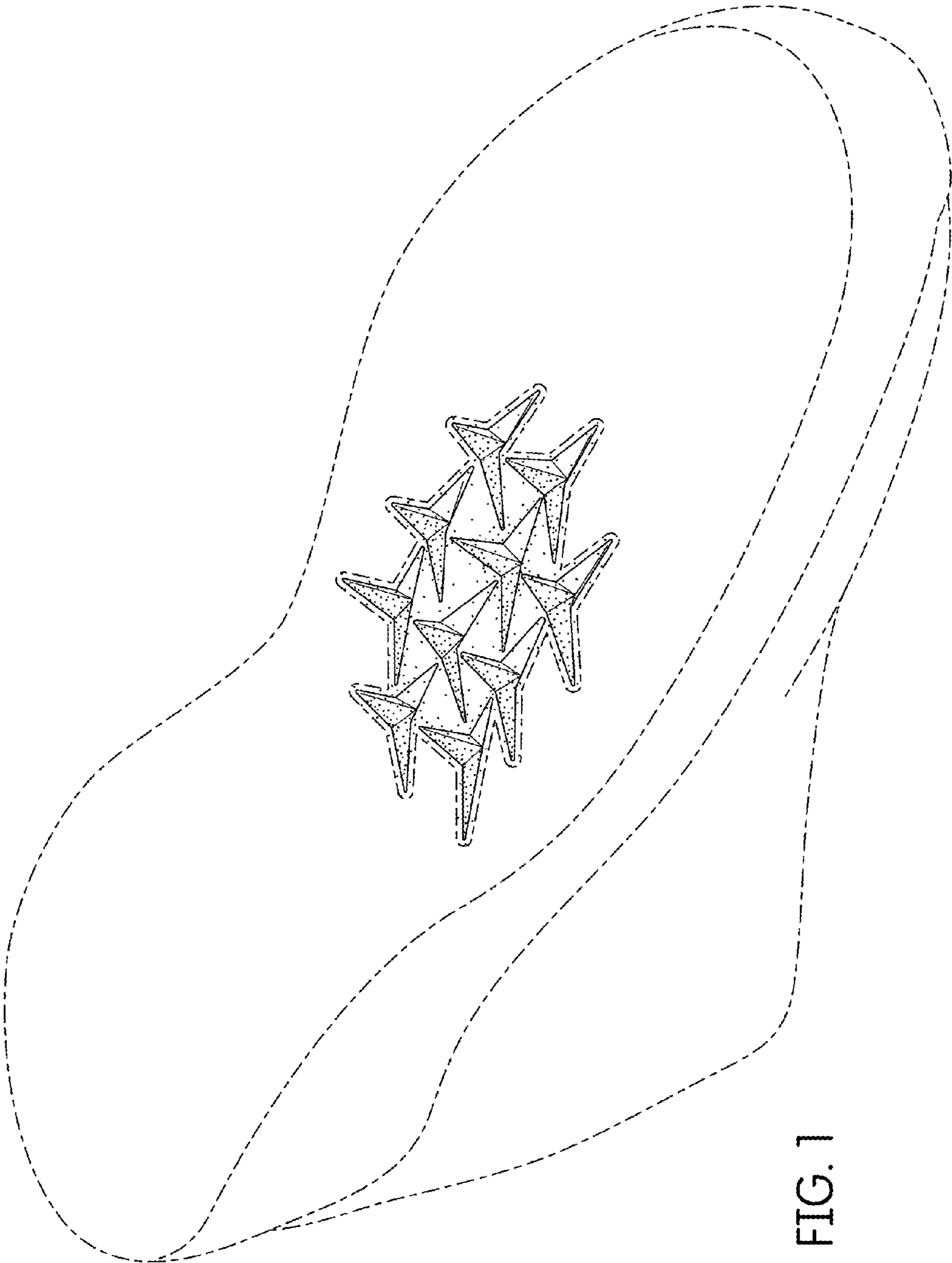

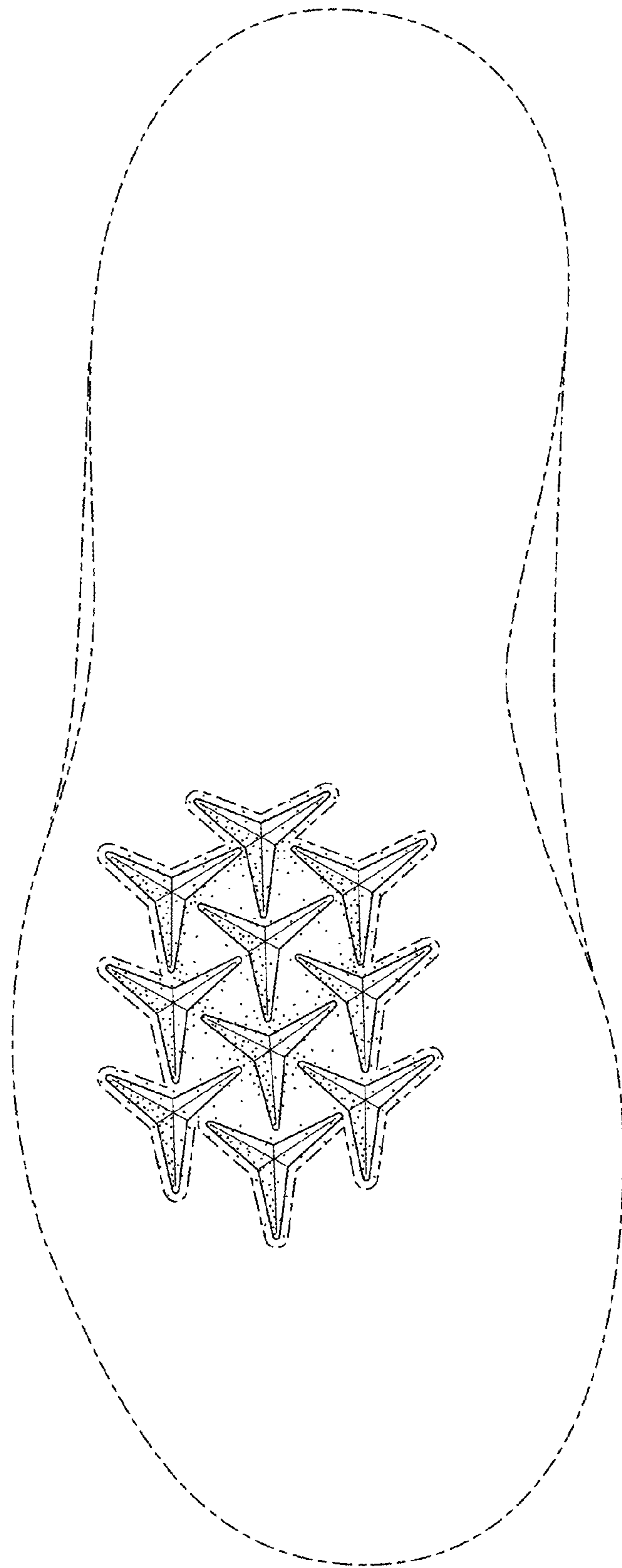

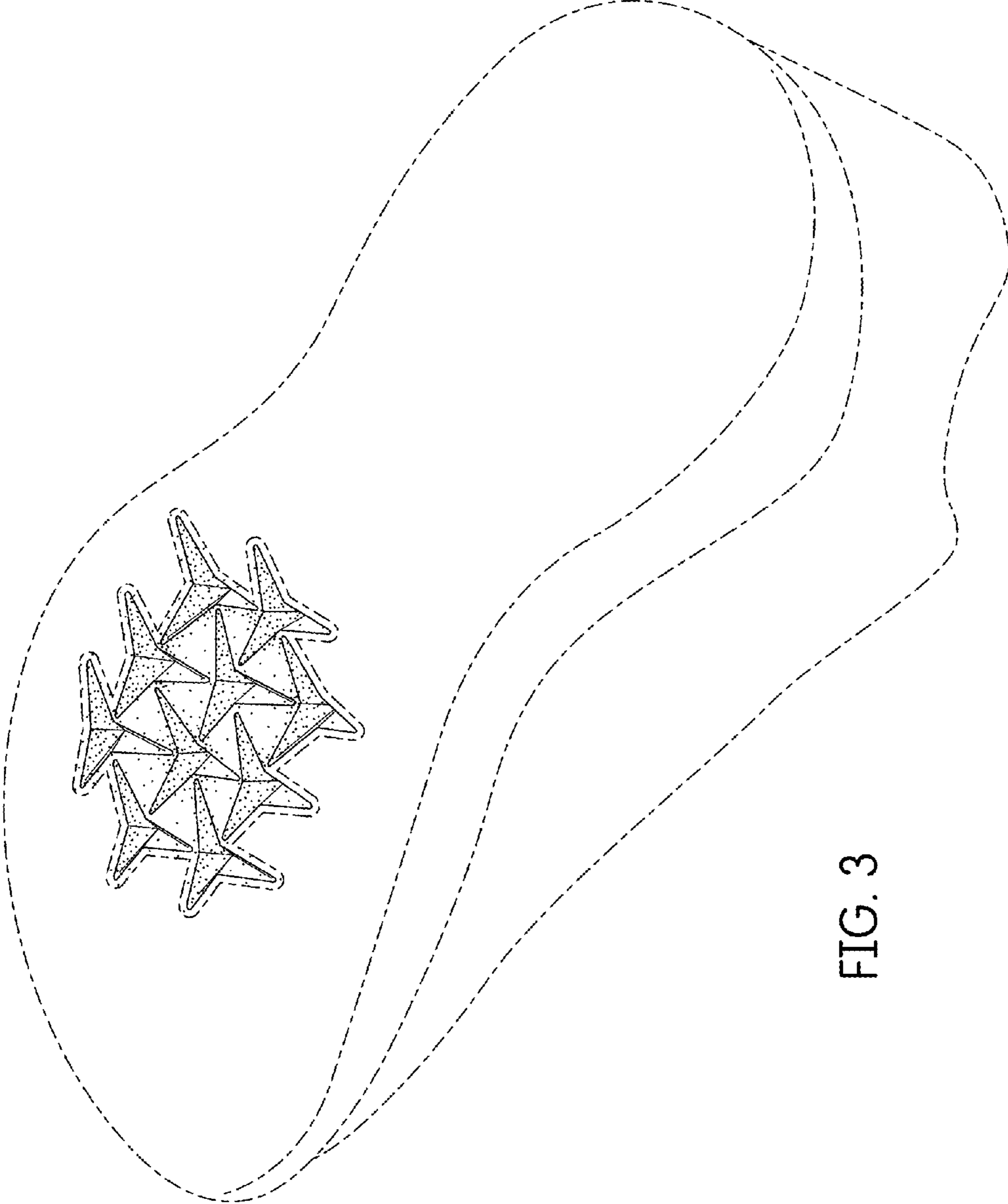

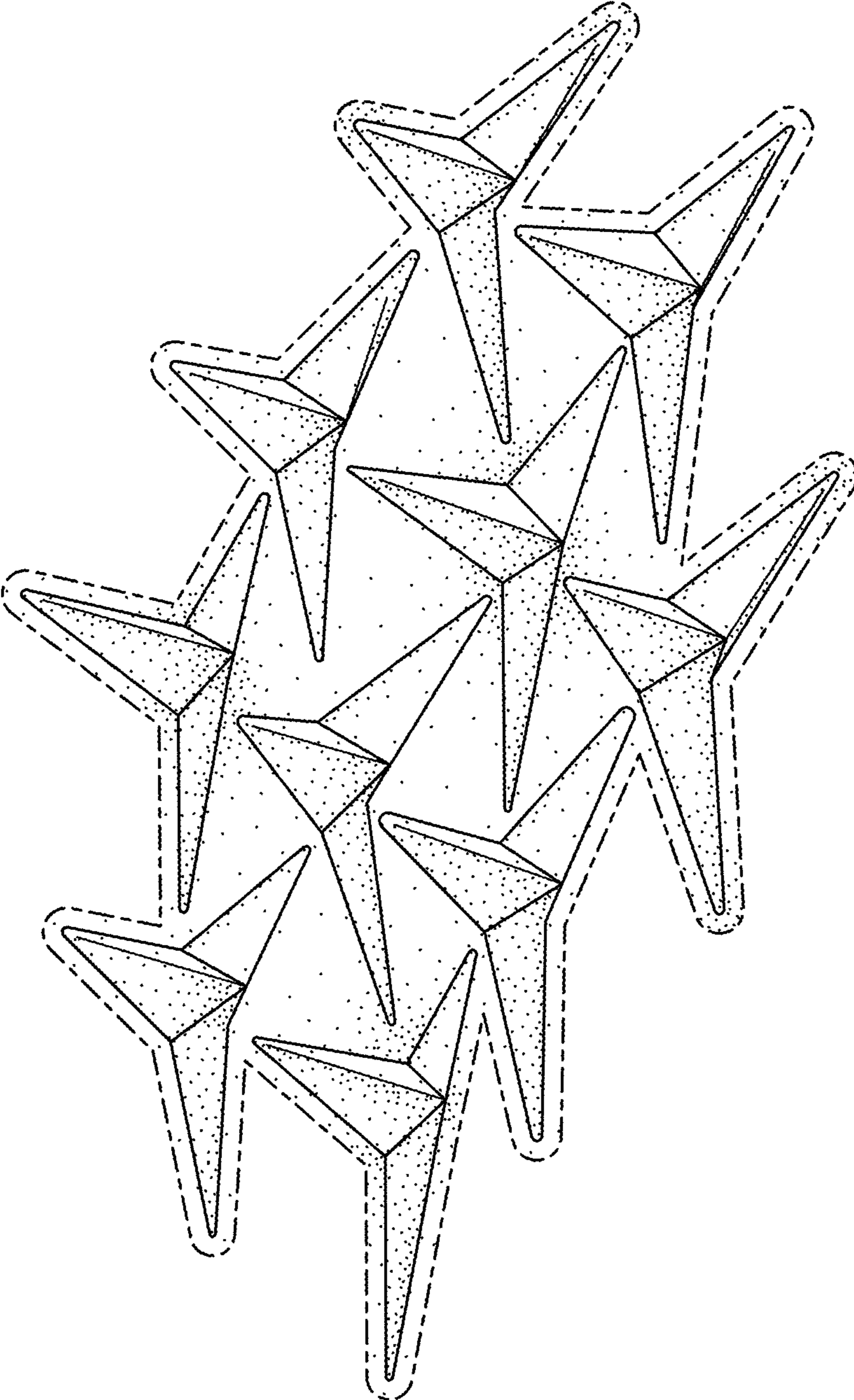

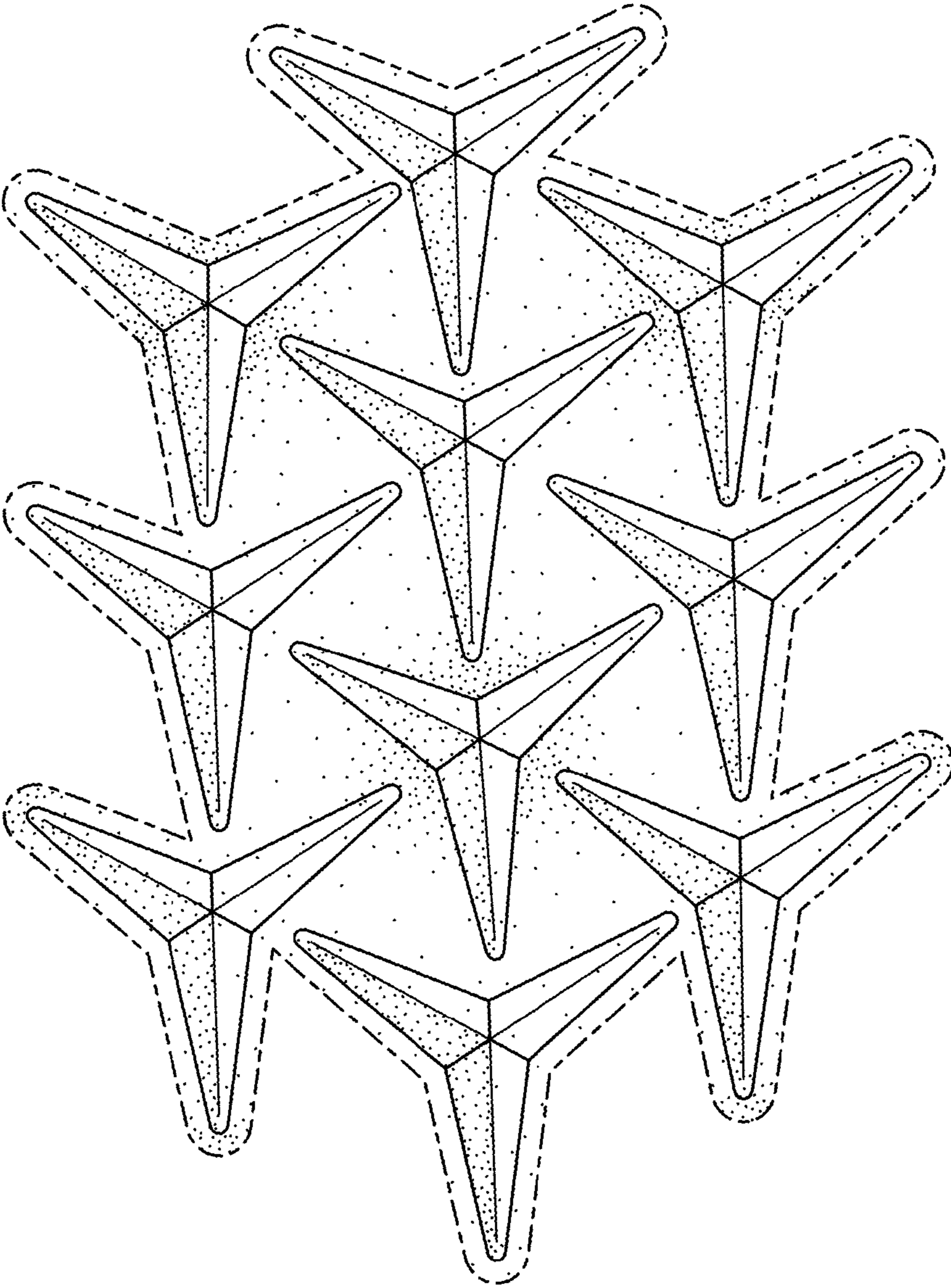

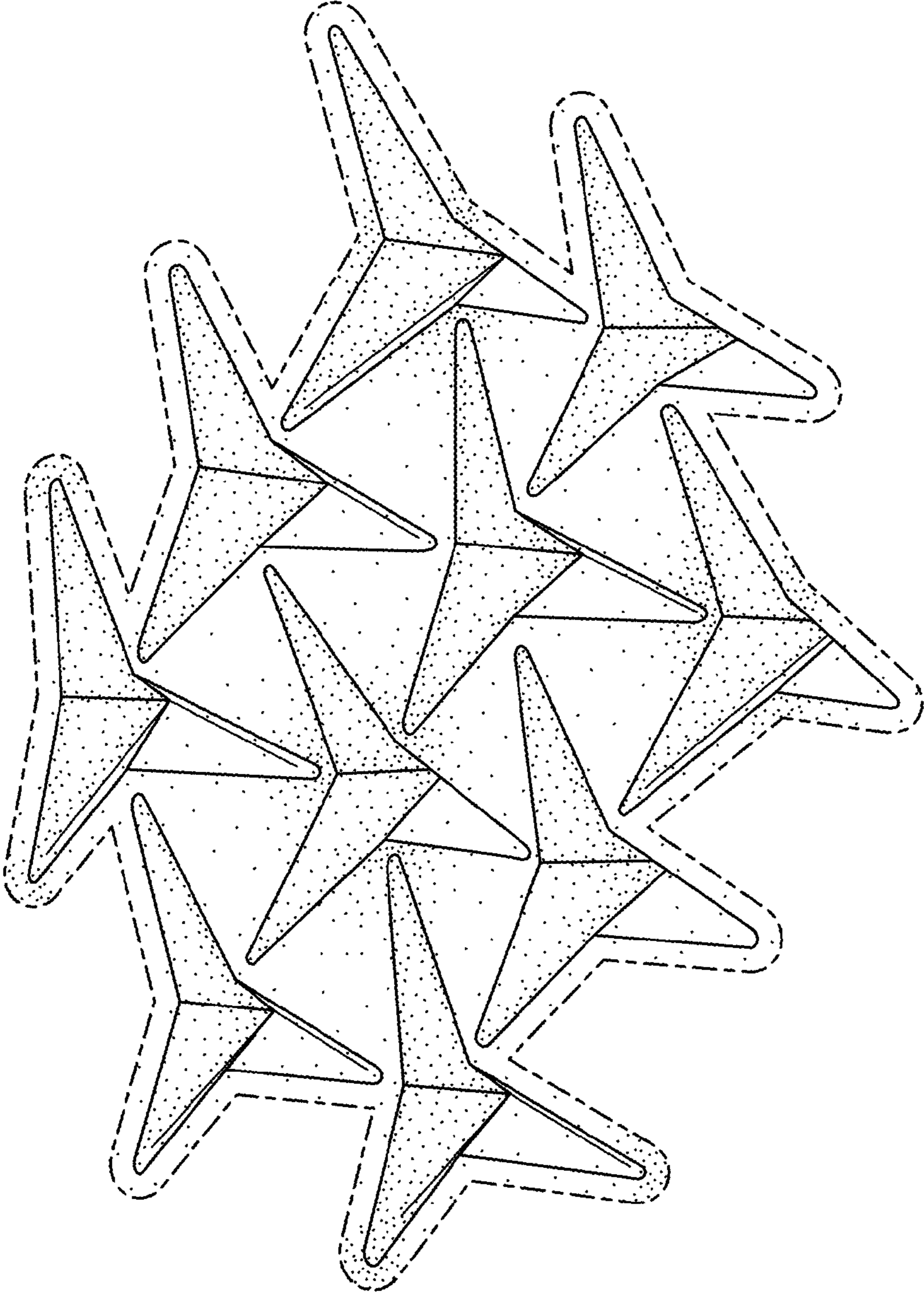
