FIG. 2 is a left side, elevation view thereof;

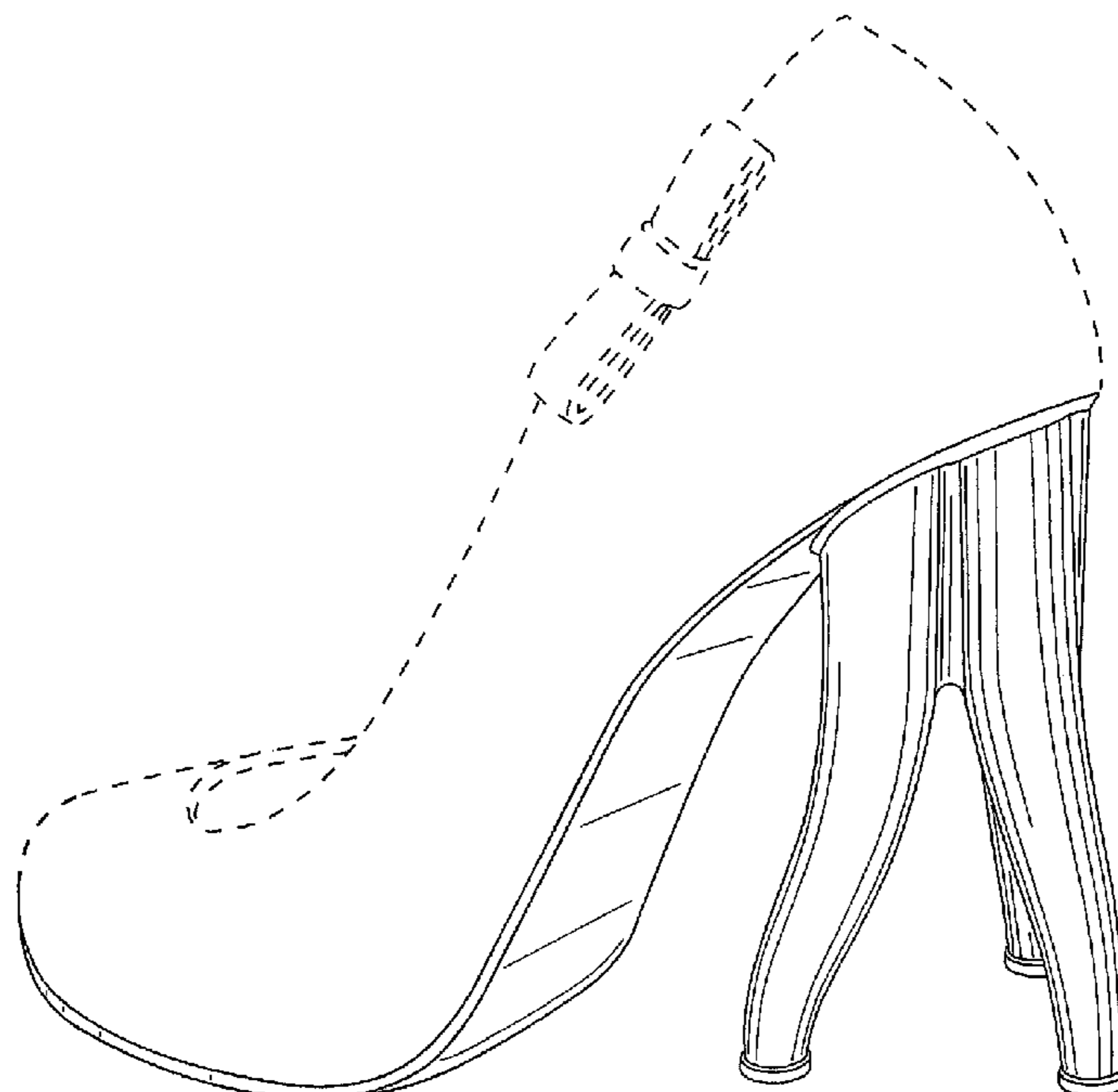
FIG. 3 is a rear elevation view thereof; and,

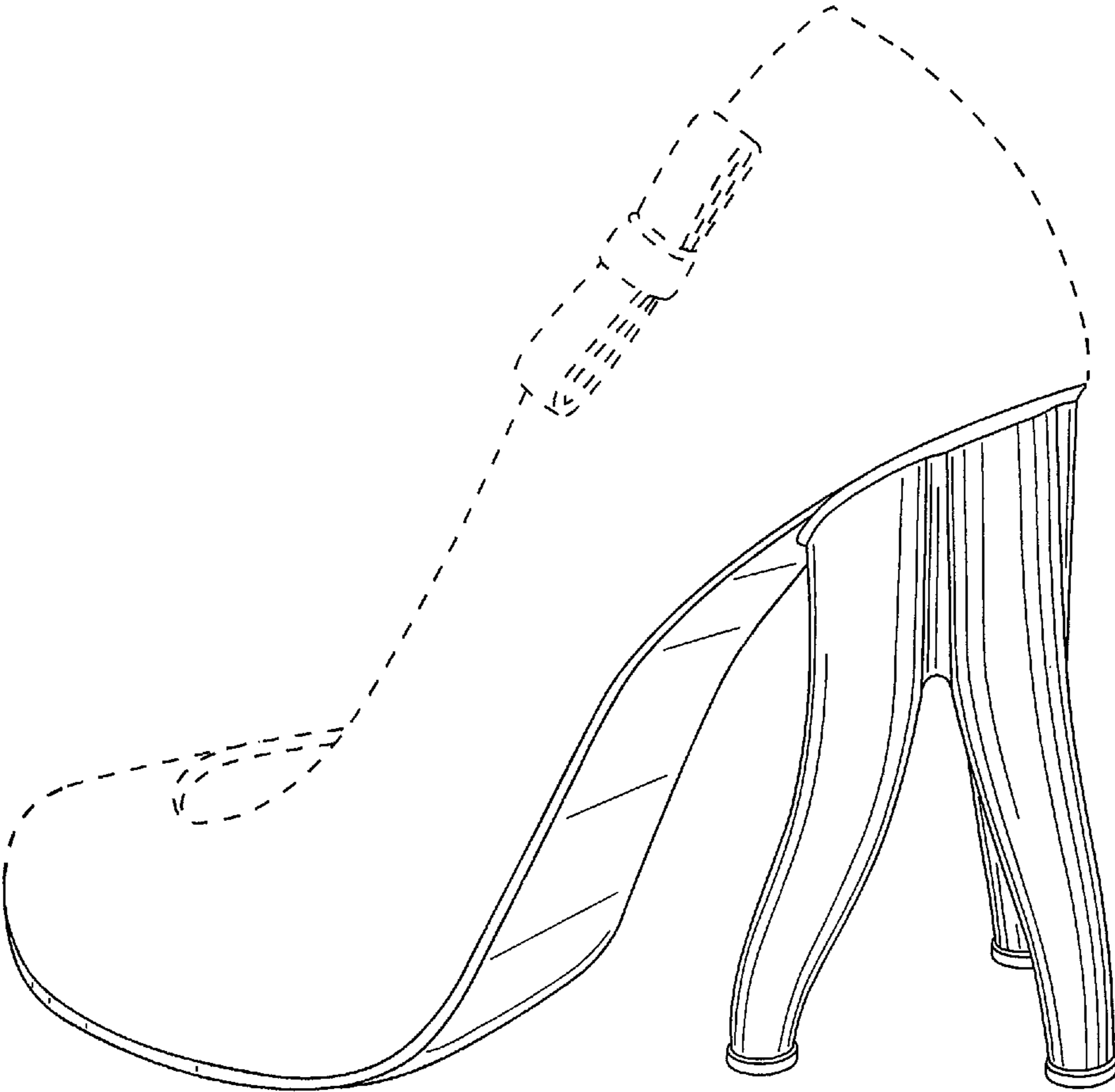

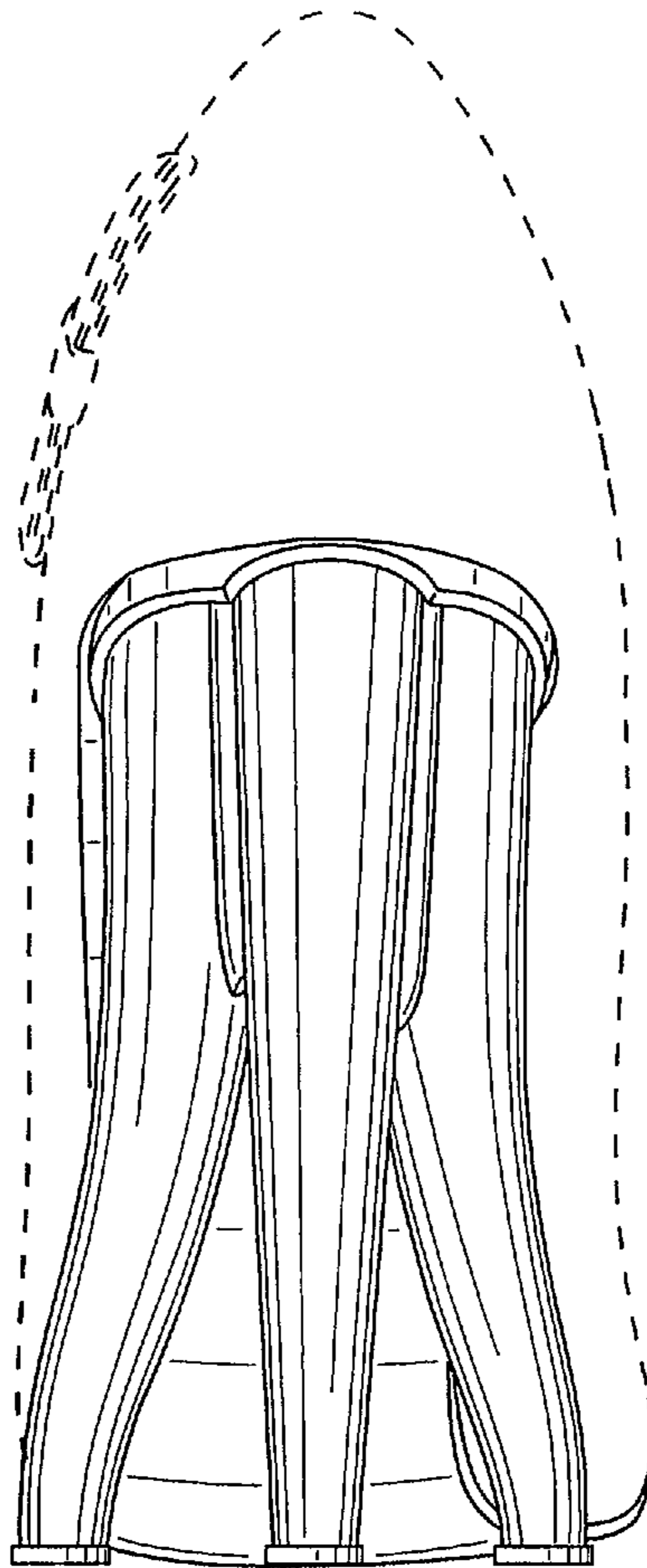

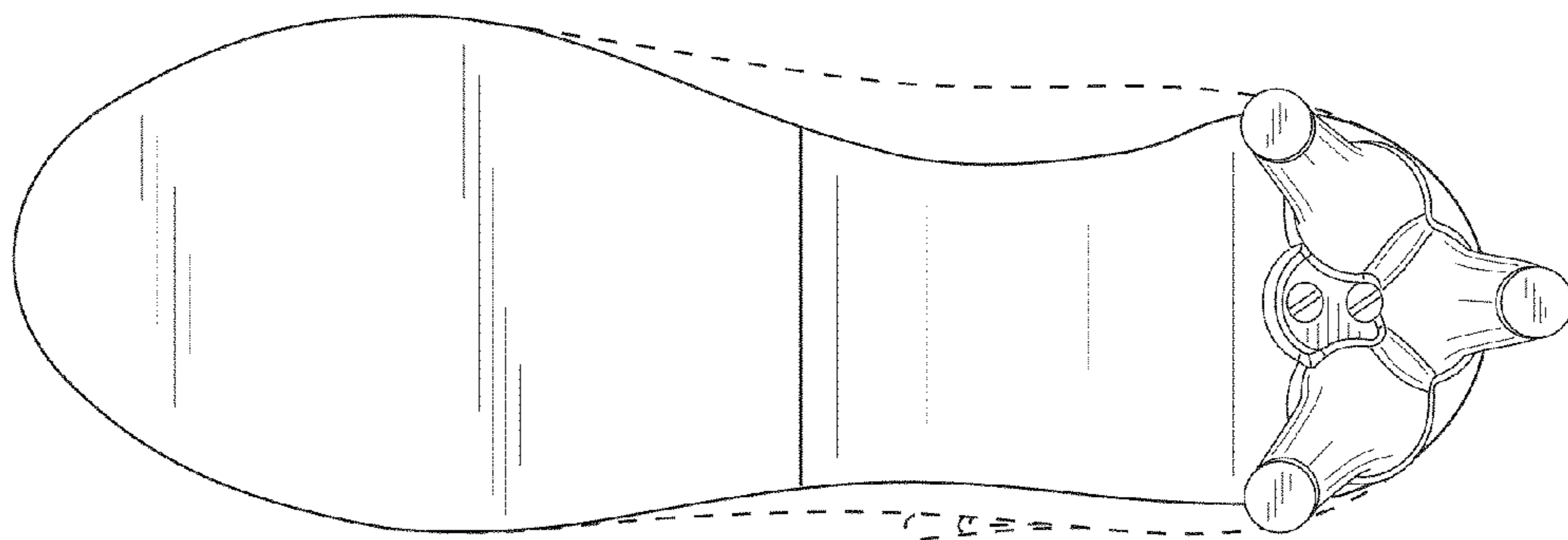

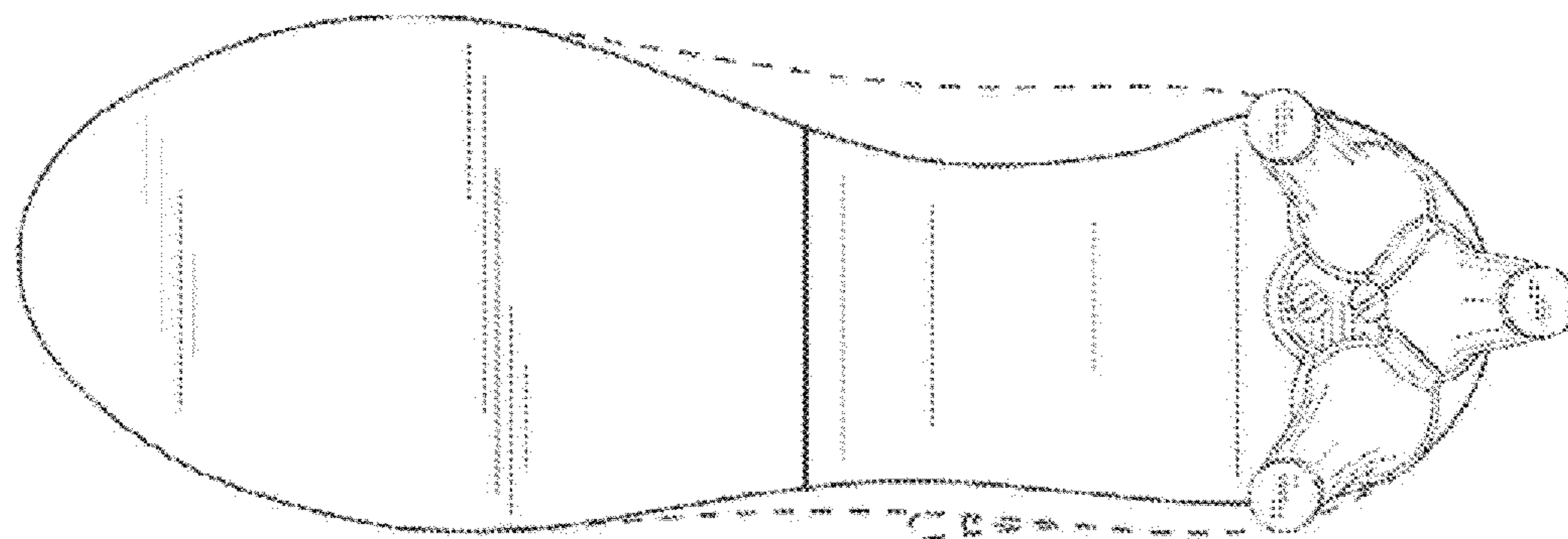


FIG. 4
