(57) **CLAIM**

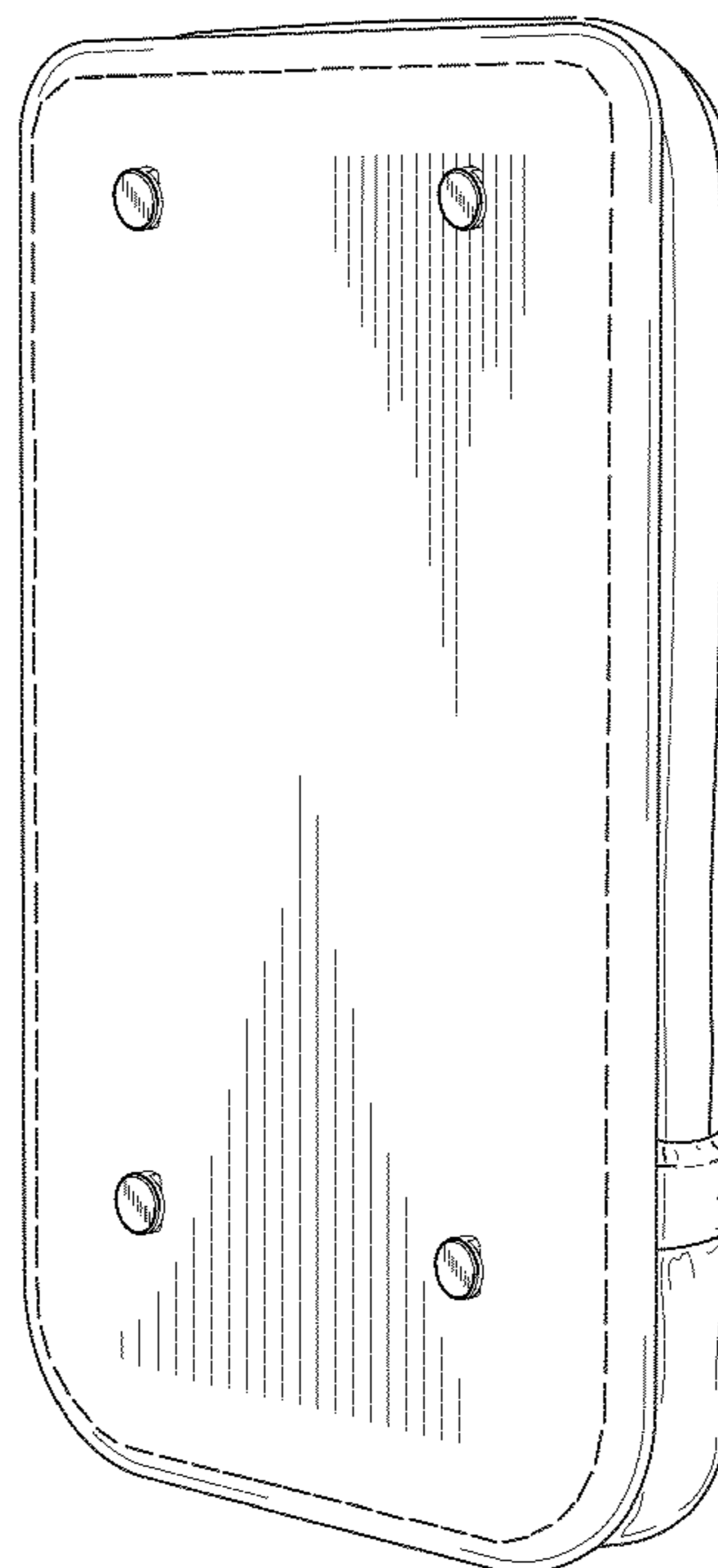
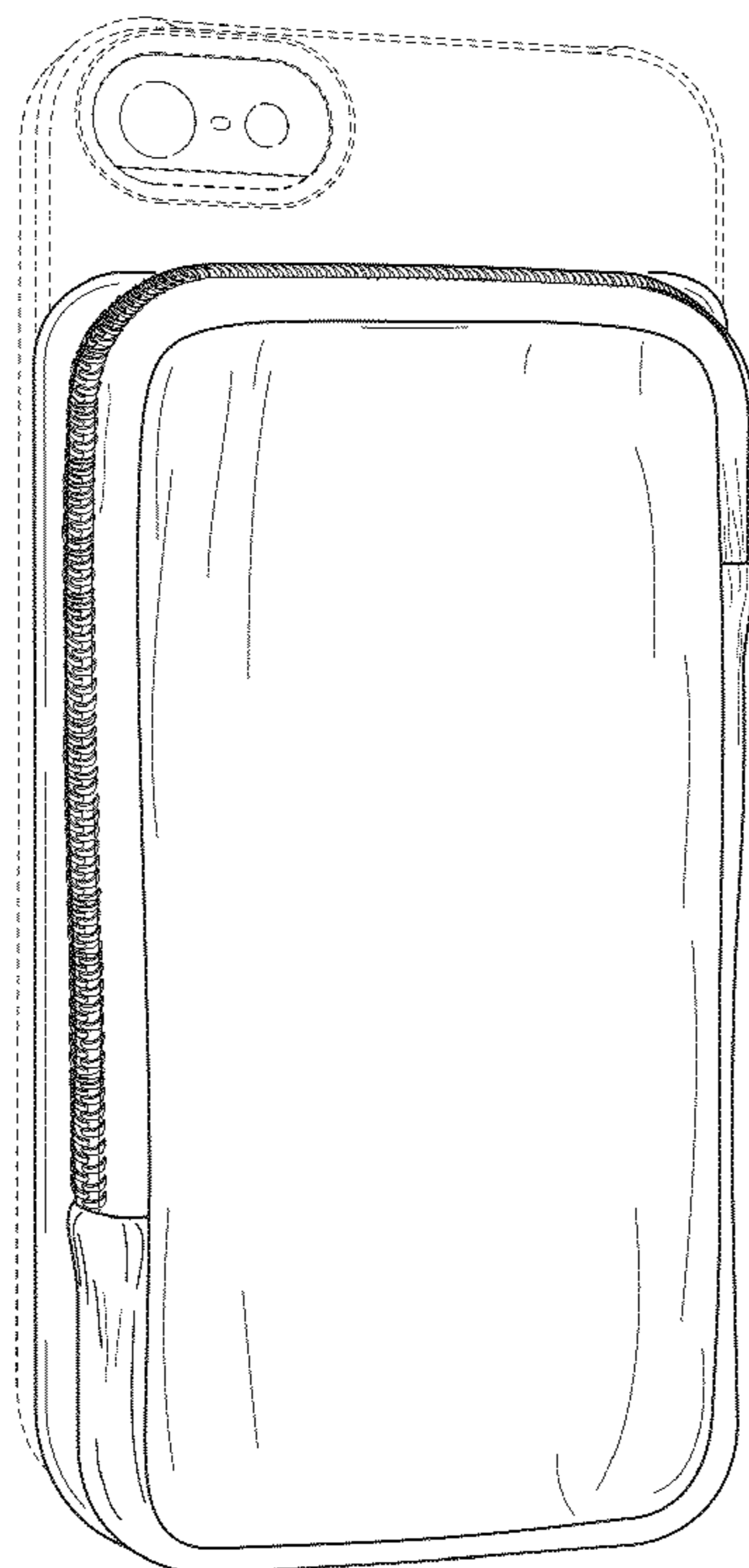
I claim the ornamental design for an attachable pouch wallet, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an attachable pouch wallet, showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a right-side elevational view thereof;
 FIG. 5 is a left-side elevational view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof; and,
 FIG. 8 is a rear perspective view thereof.

The broken lines showing a cell phone case in FIG. 1 and a logo in FIG. 3 depict environmental matter and form no part of the claimed design. The remaining broken lines in FIGS. 2-5 and 8 represent stitching, and are part of the claimed design.

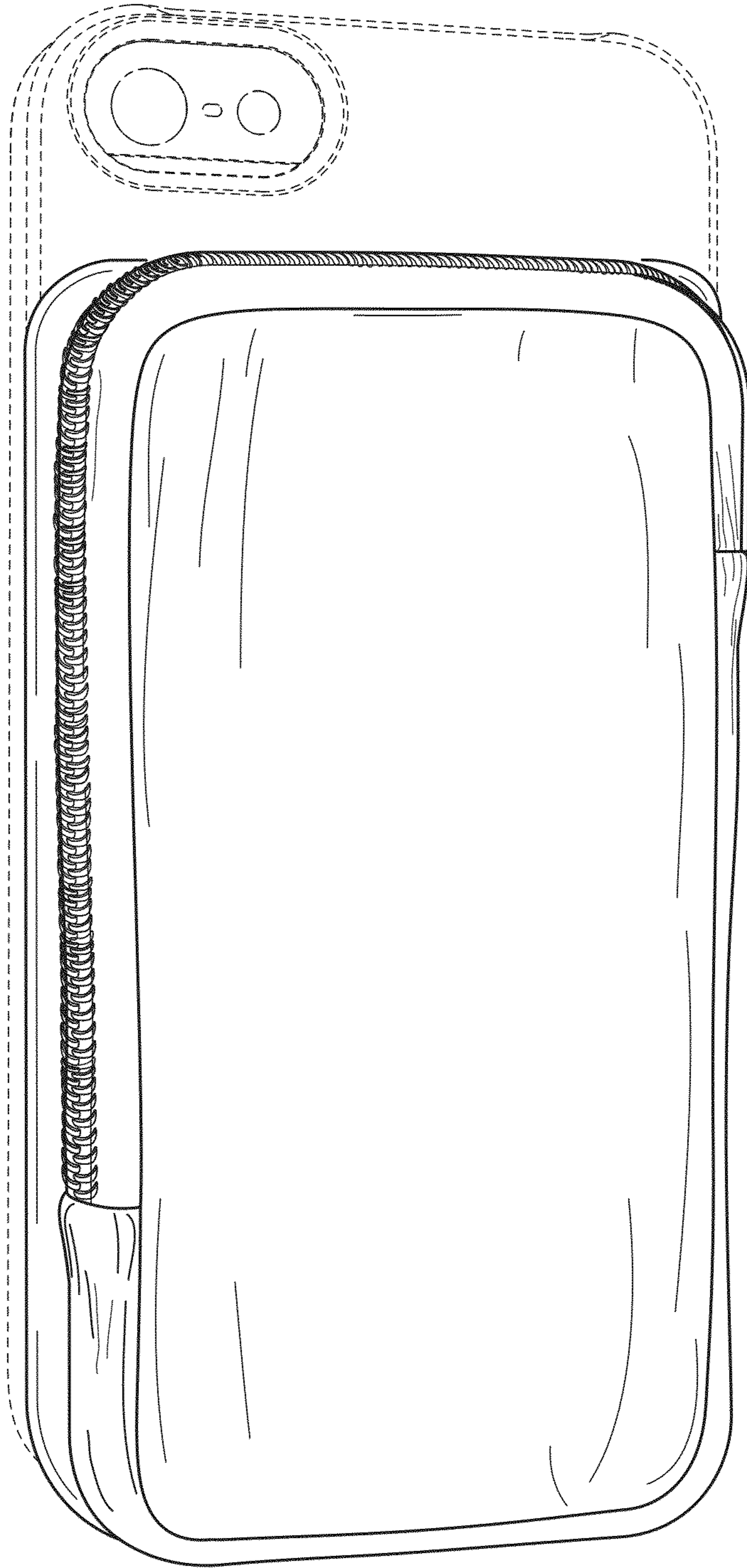

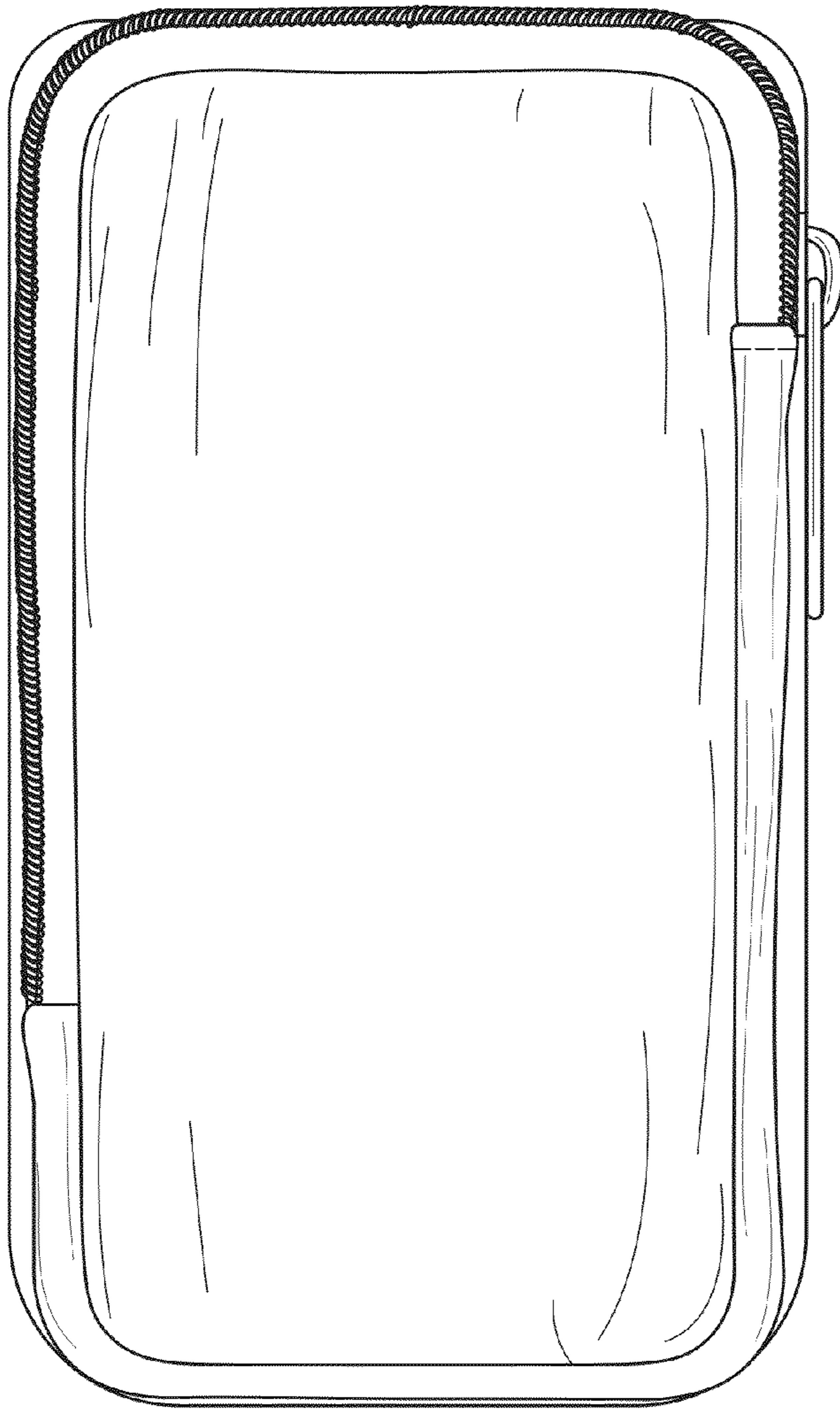

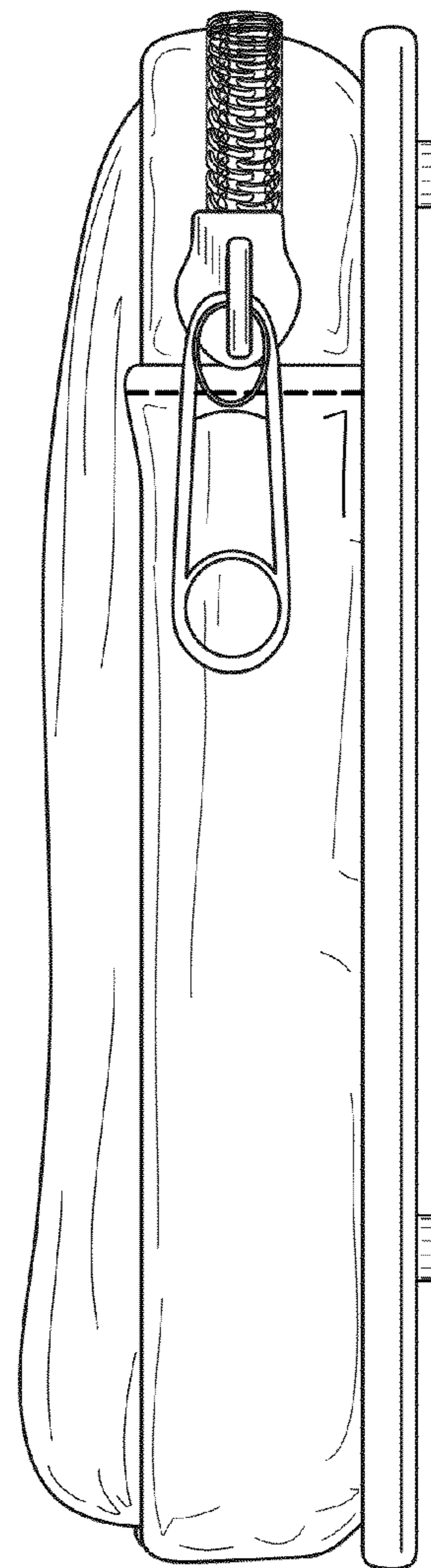

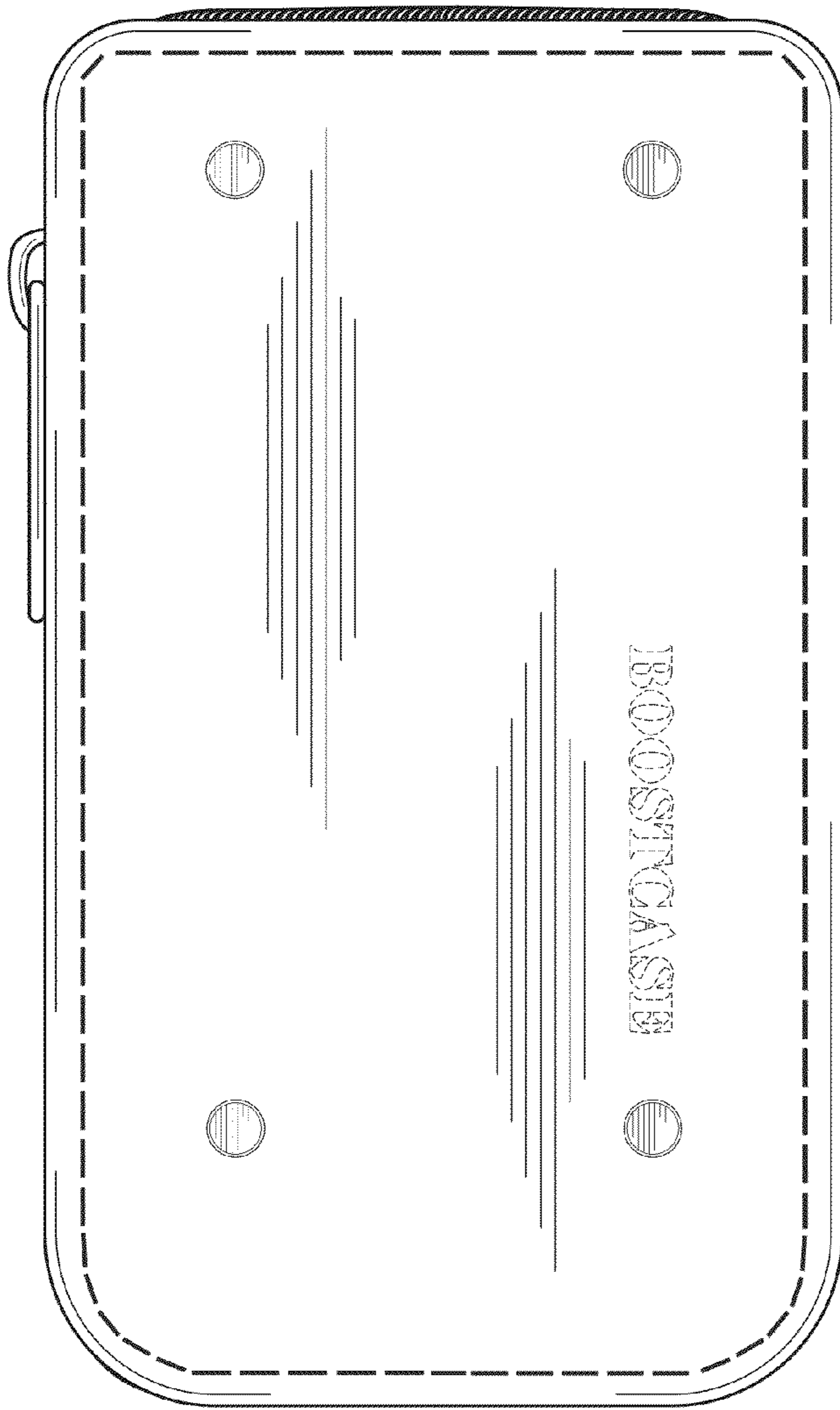

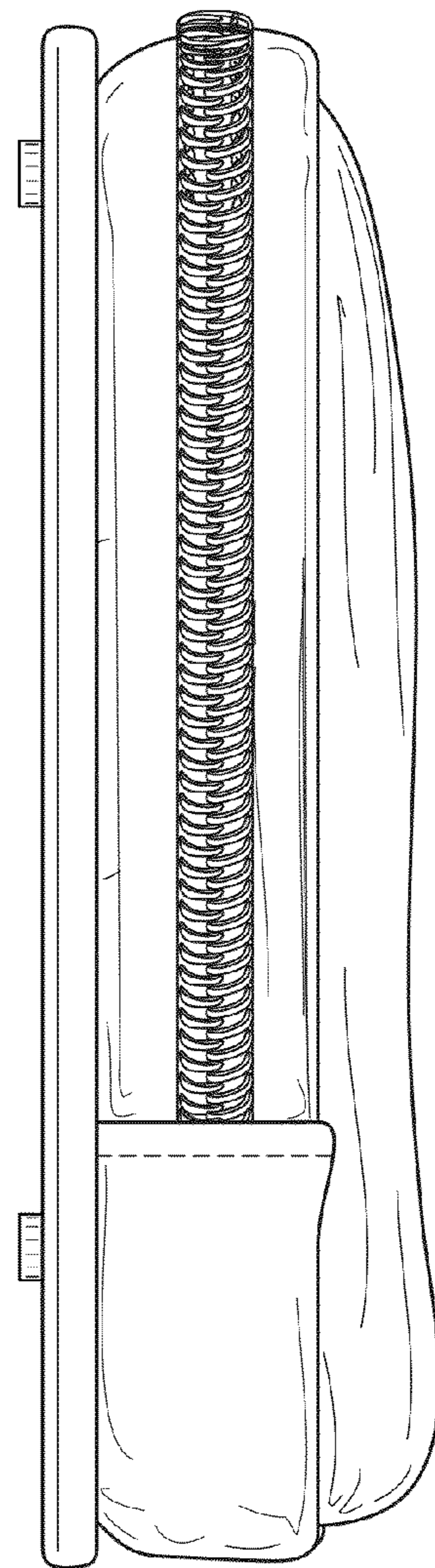

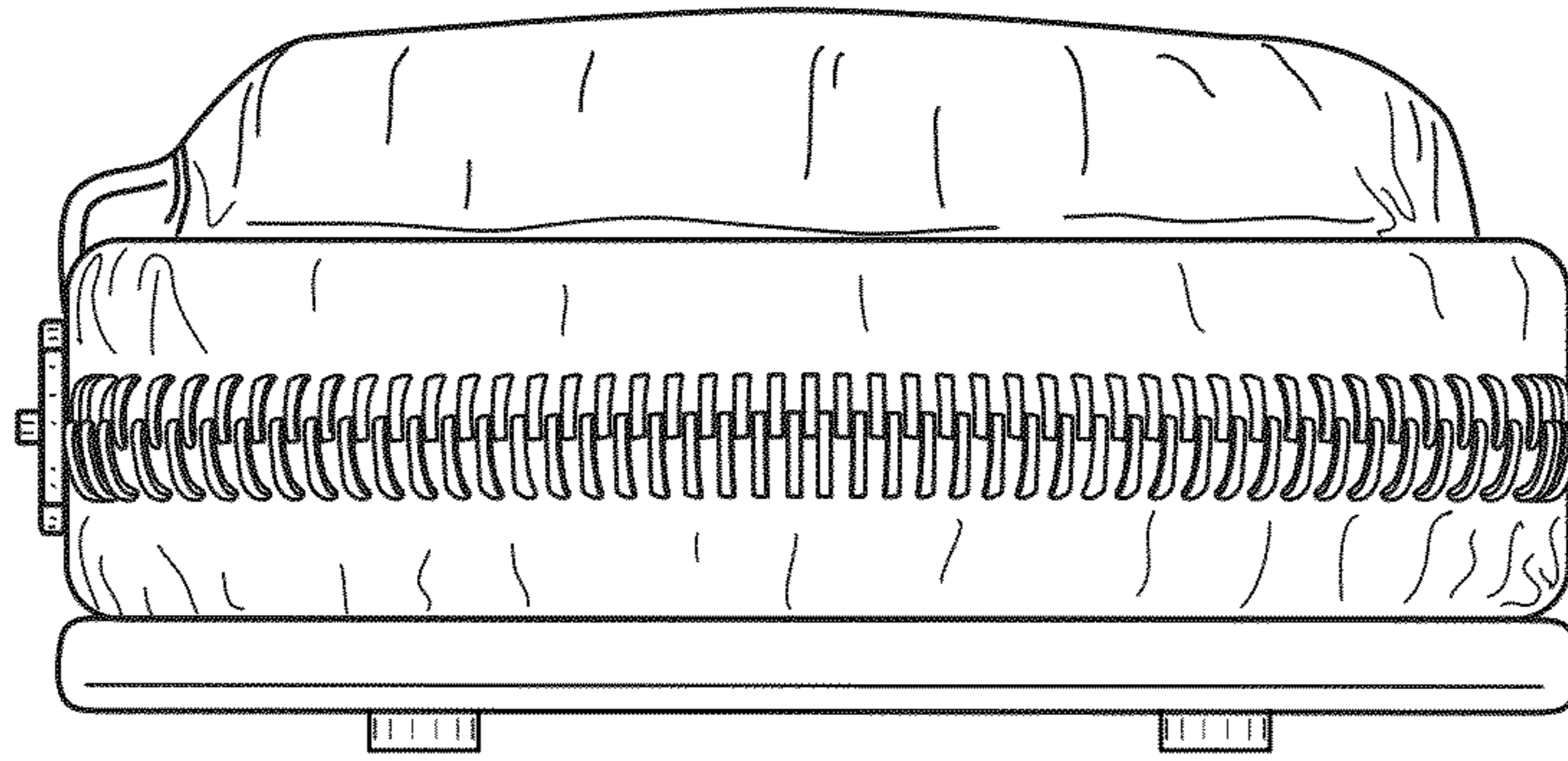

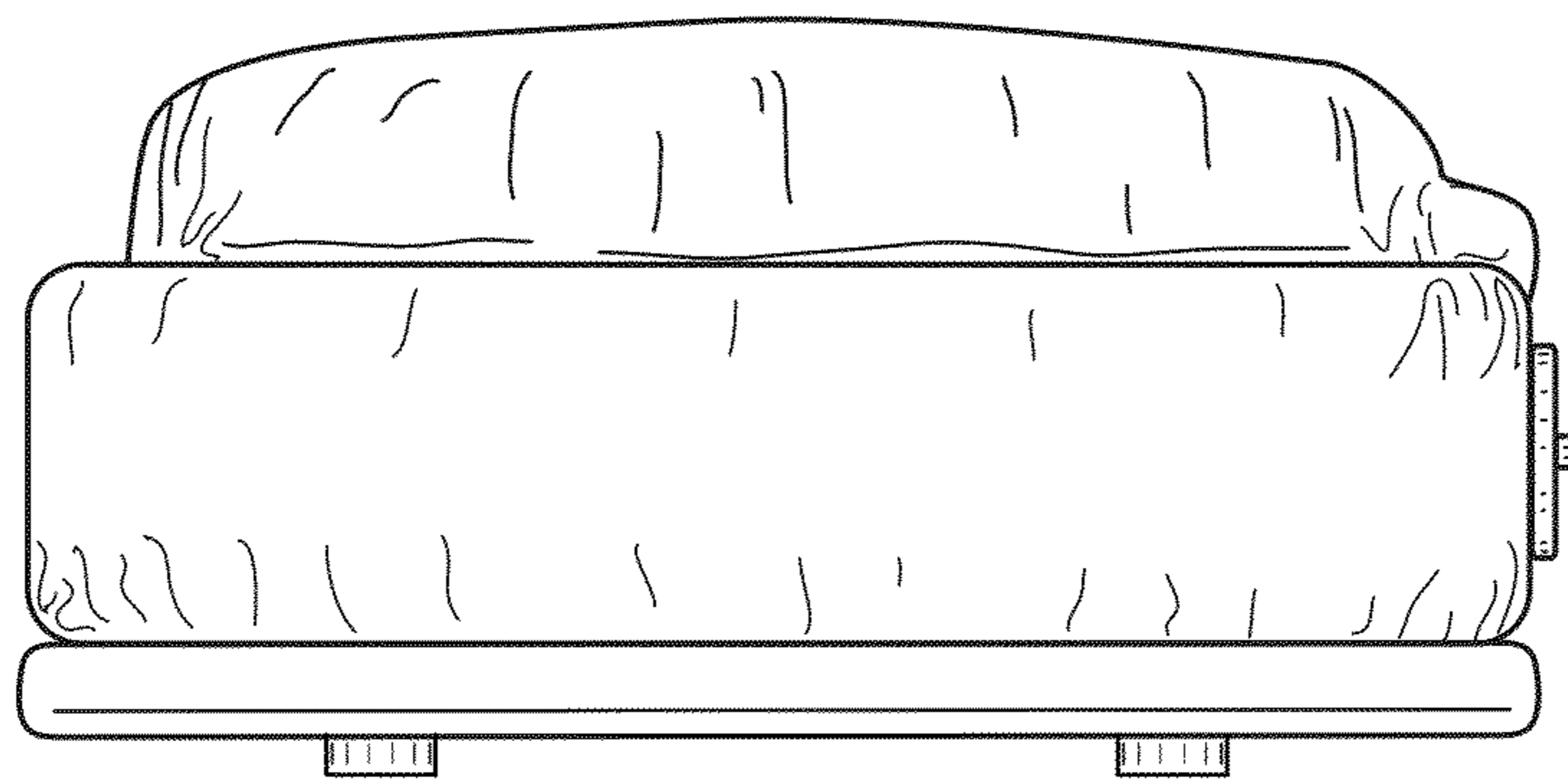

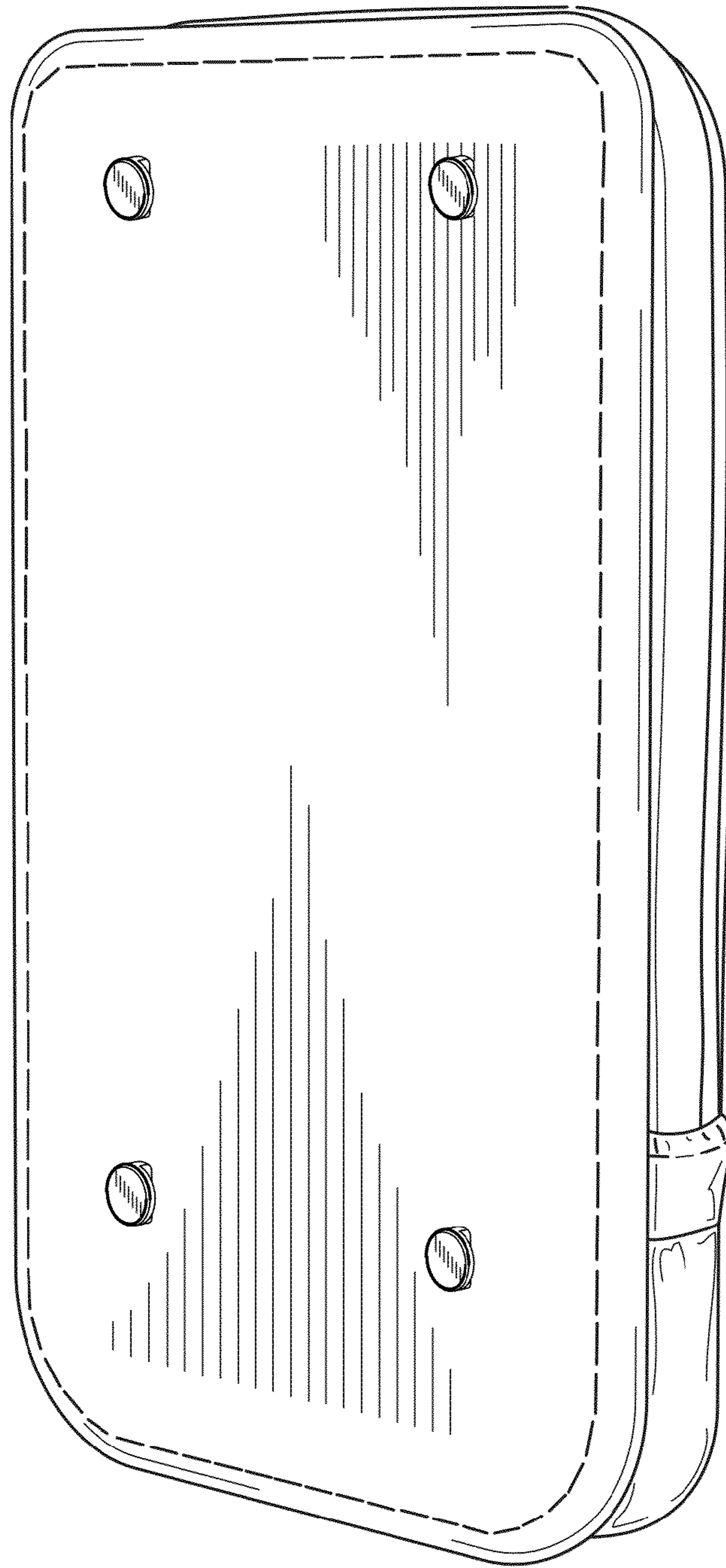
