(57) **CLAIM**

I claim the ornamental design for the integrated bed storage unit, as shown and described.

**DESCRIPTION**

FIG. 7 is a bottom view of the integrated bed storage unit.

FIG. 9 is the second perspective view of the integrated bed storage unit with slideouts in open position.

FIG. 10 is the front view of the integrated bed storage unit with slideouts in open position.

FIG. 11 is the left side view of the integrated bed storage unit with slideouts in open position.

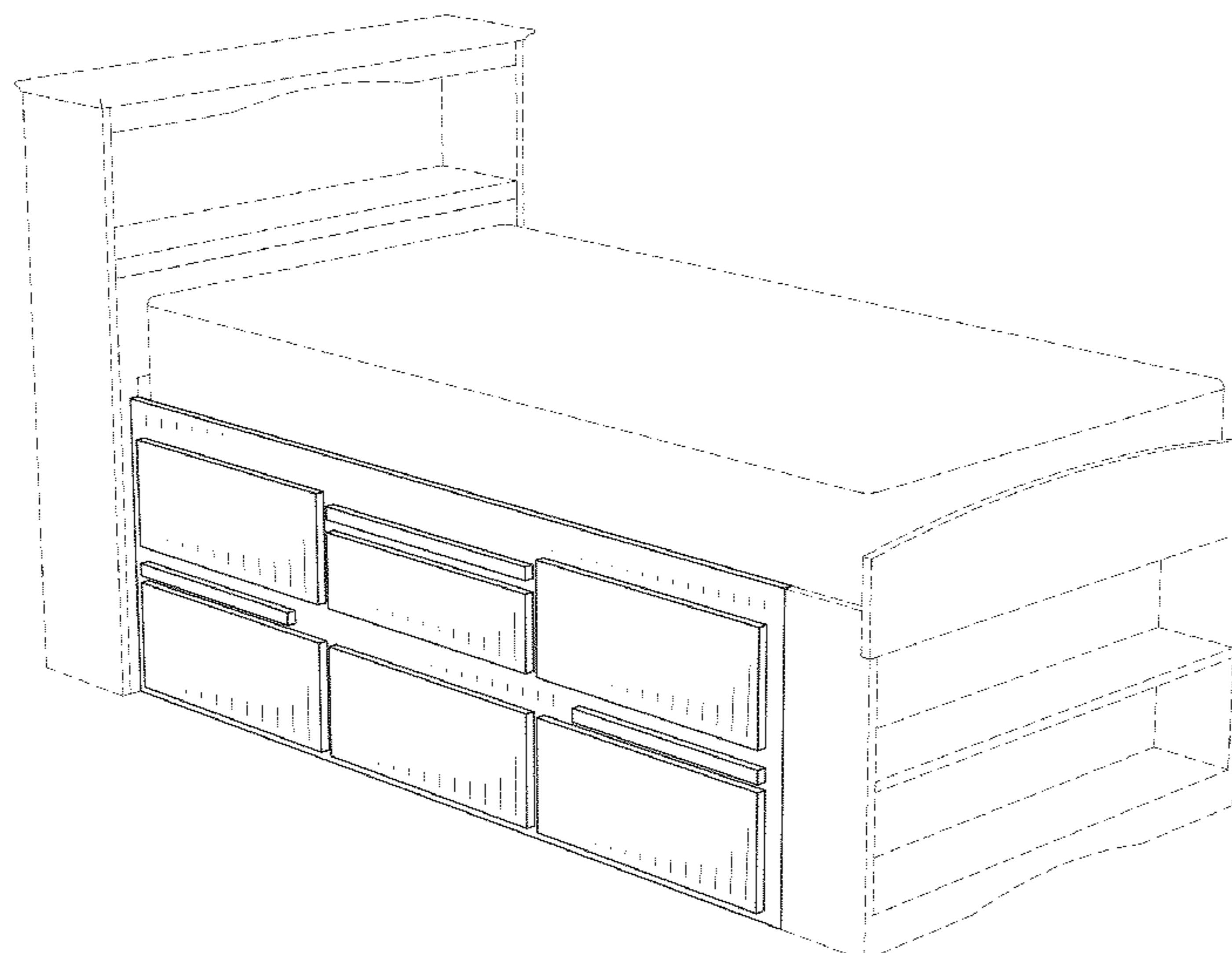
FIG. 12 is the back view of the integrated bed storage unit with slideouts in open position.

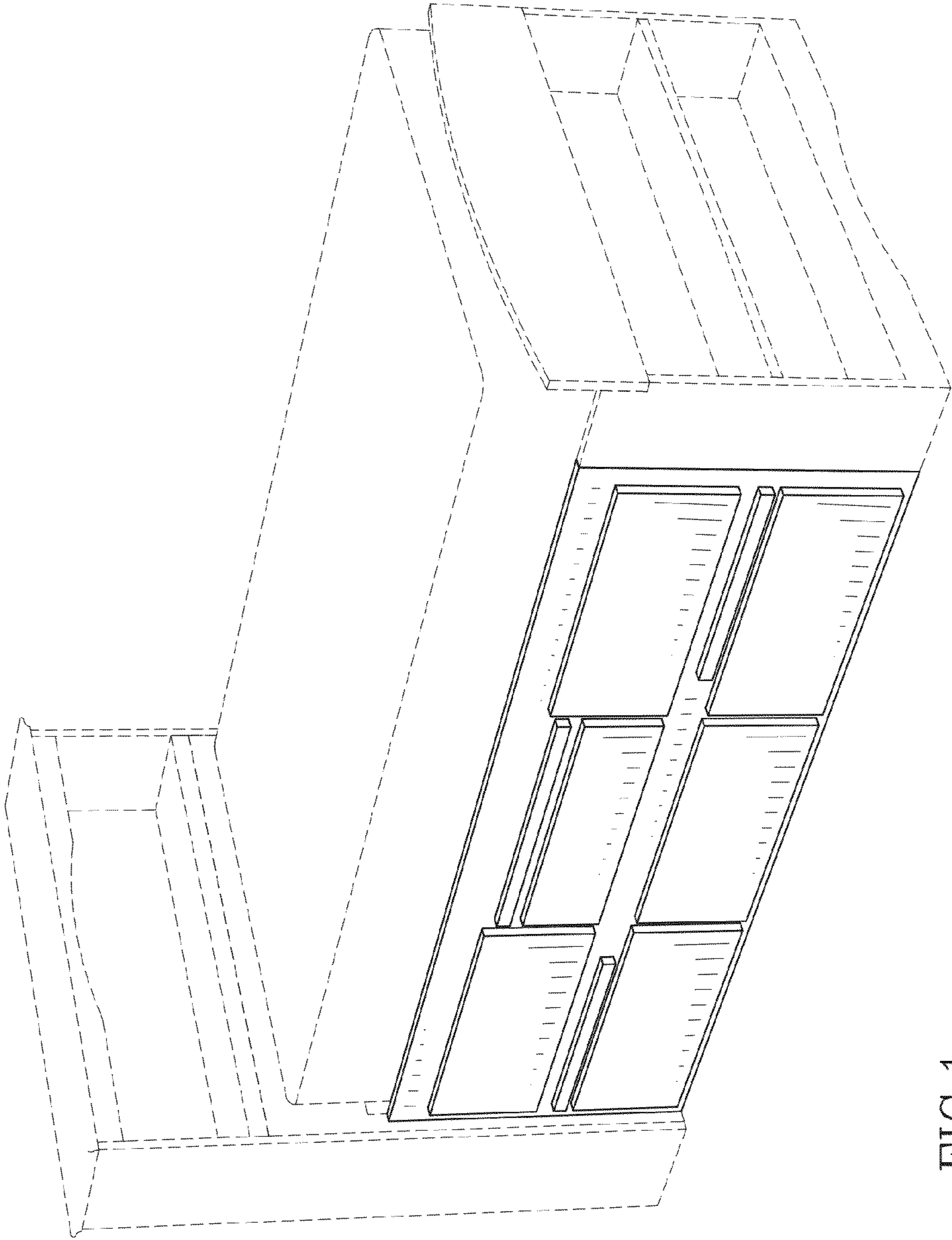

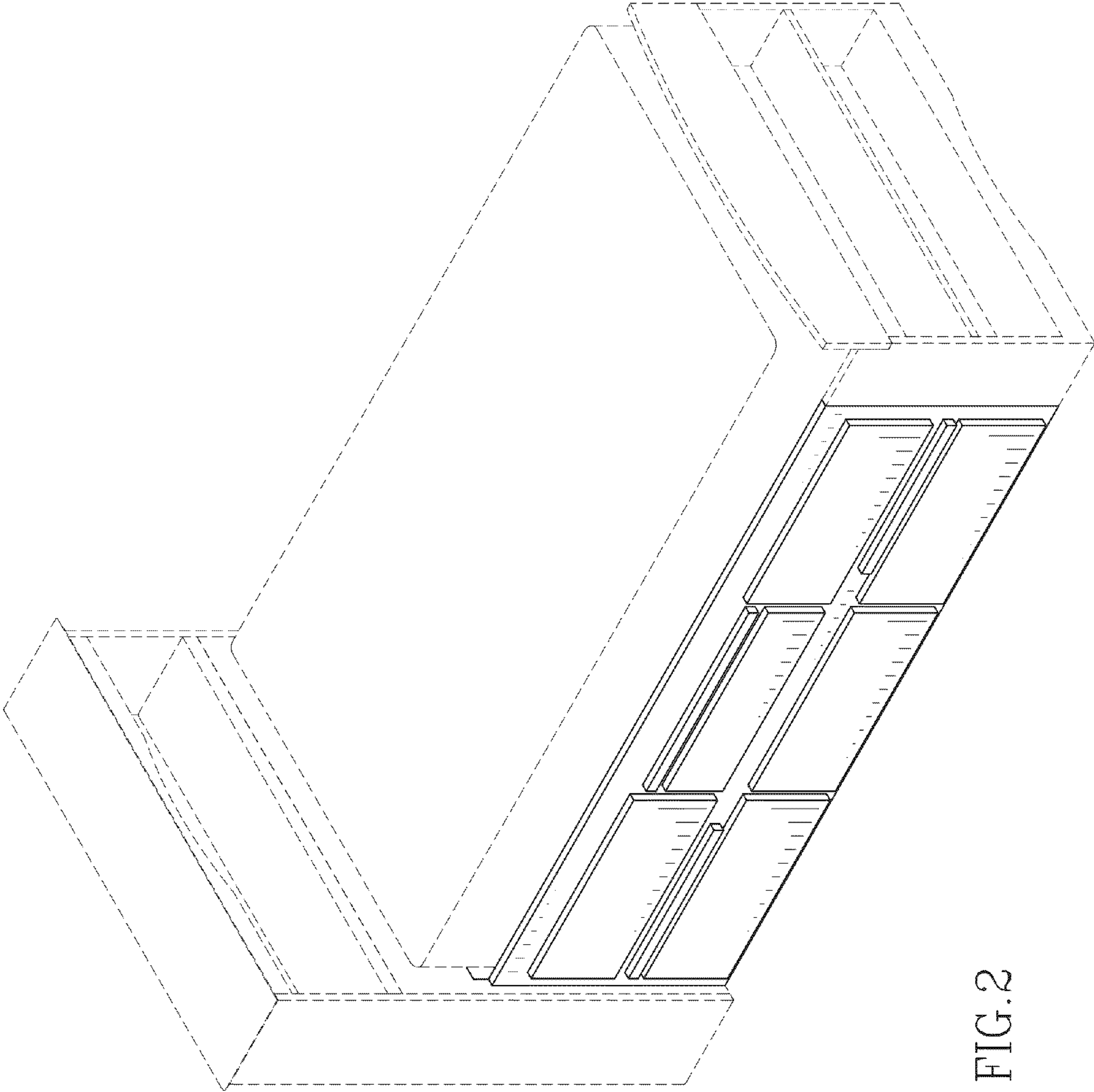

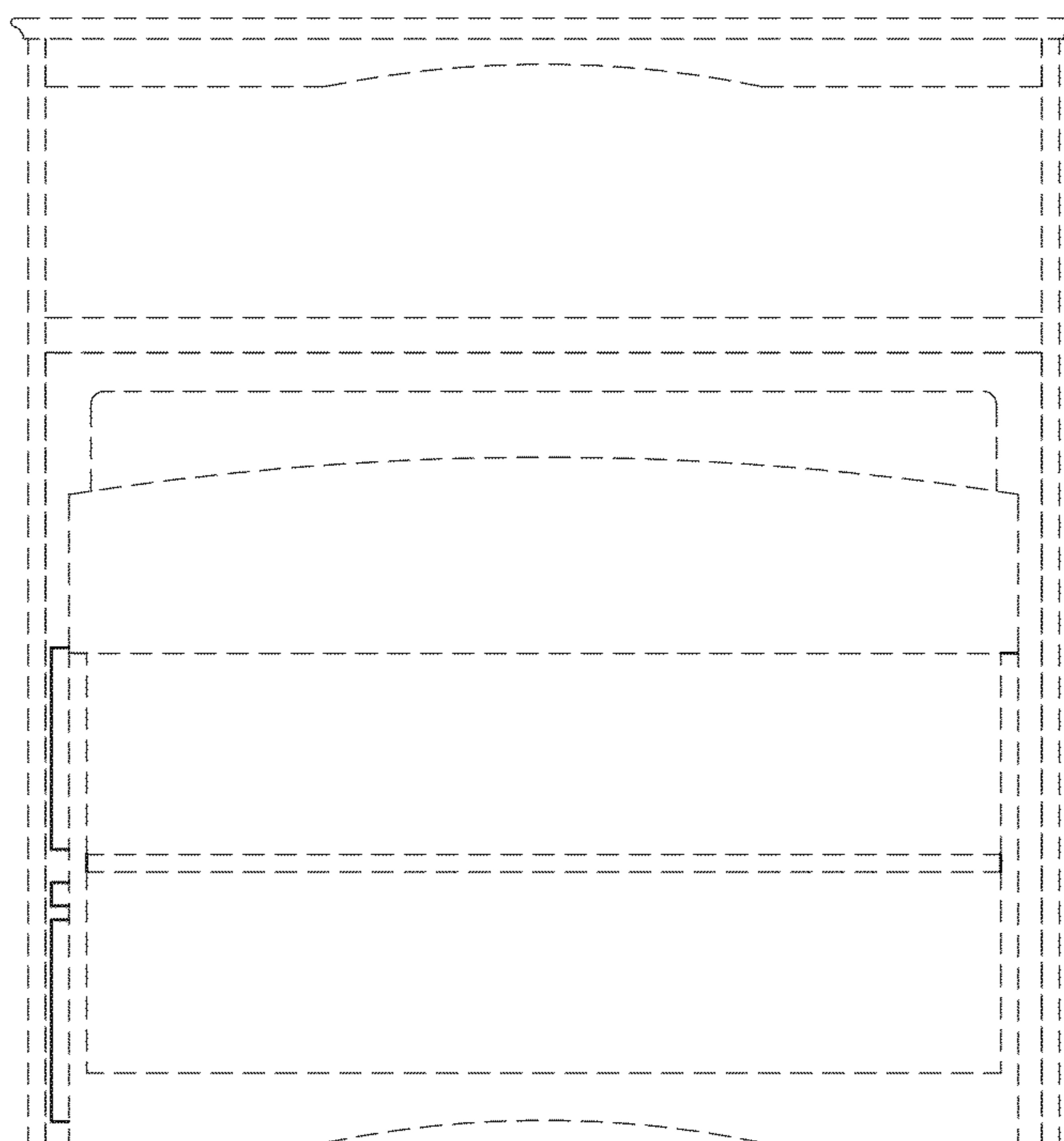

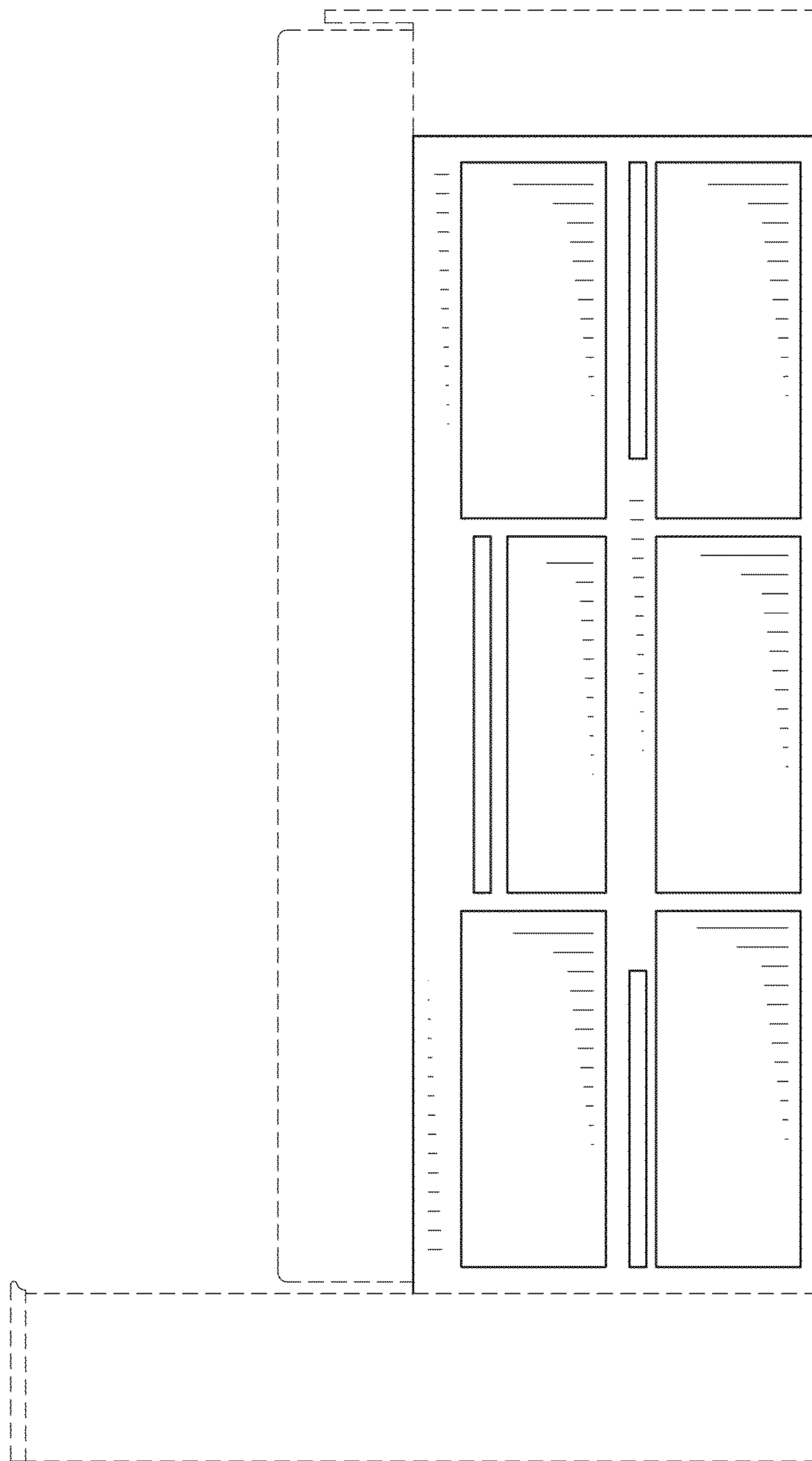

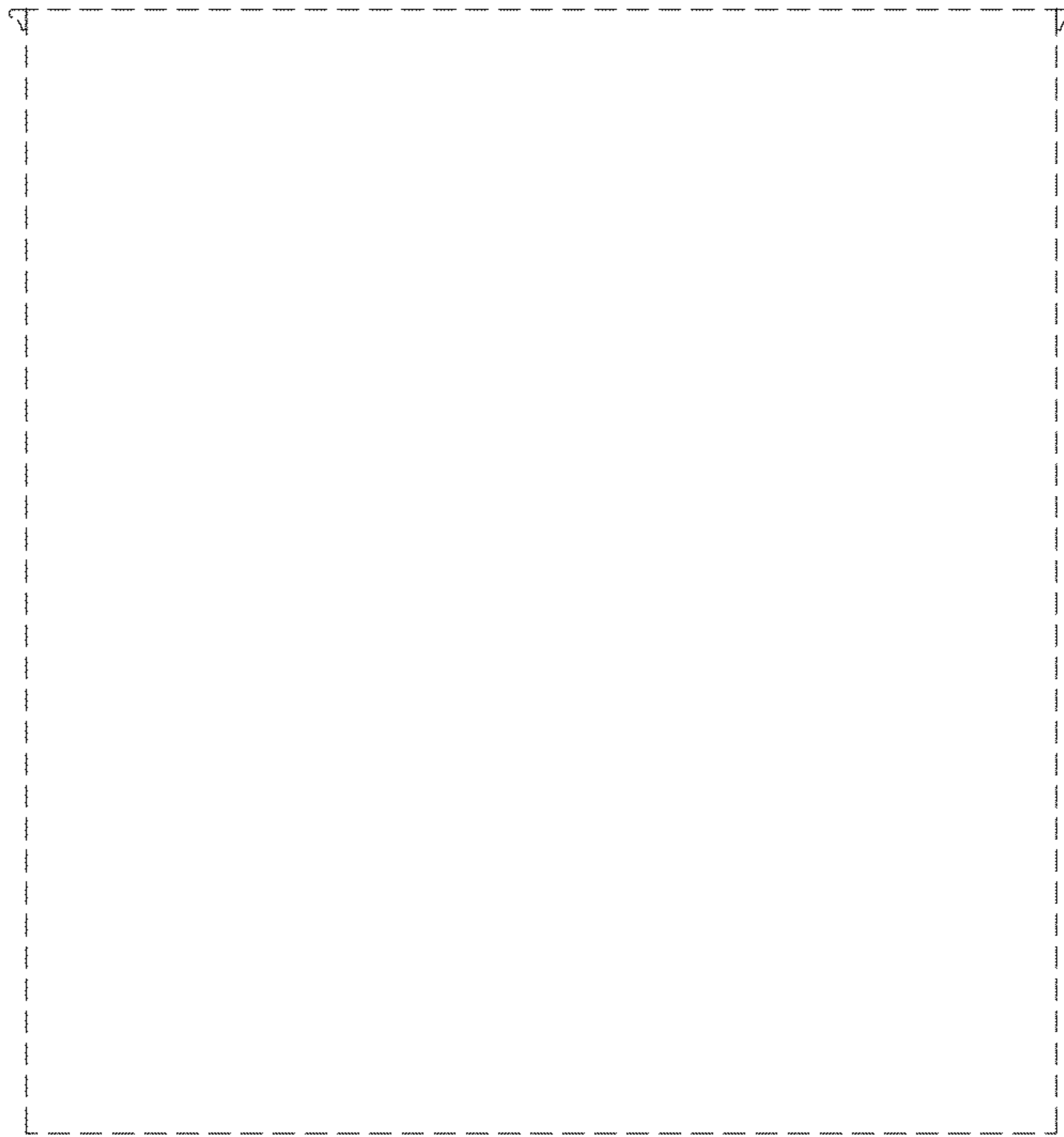

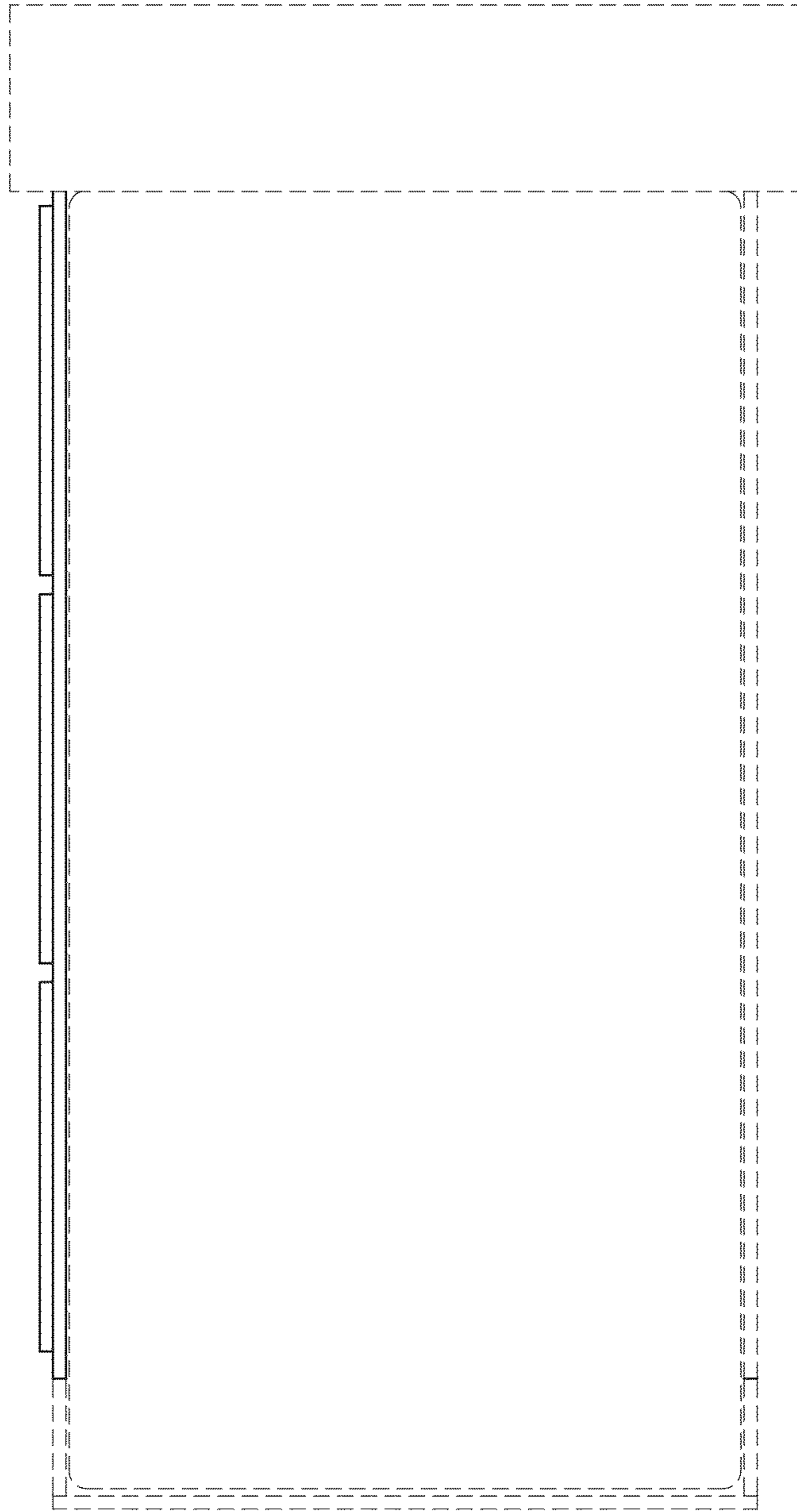

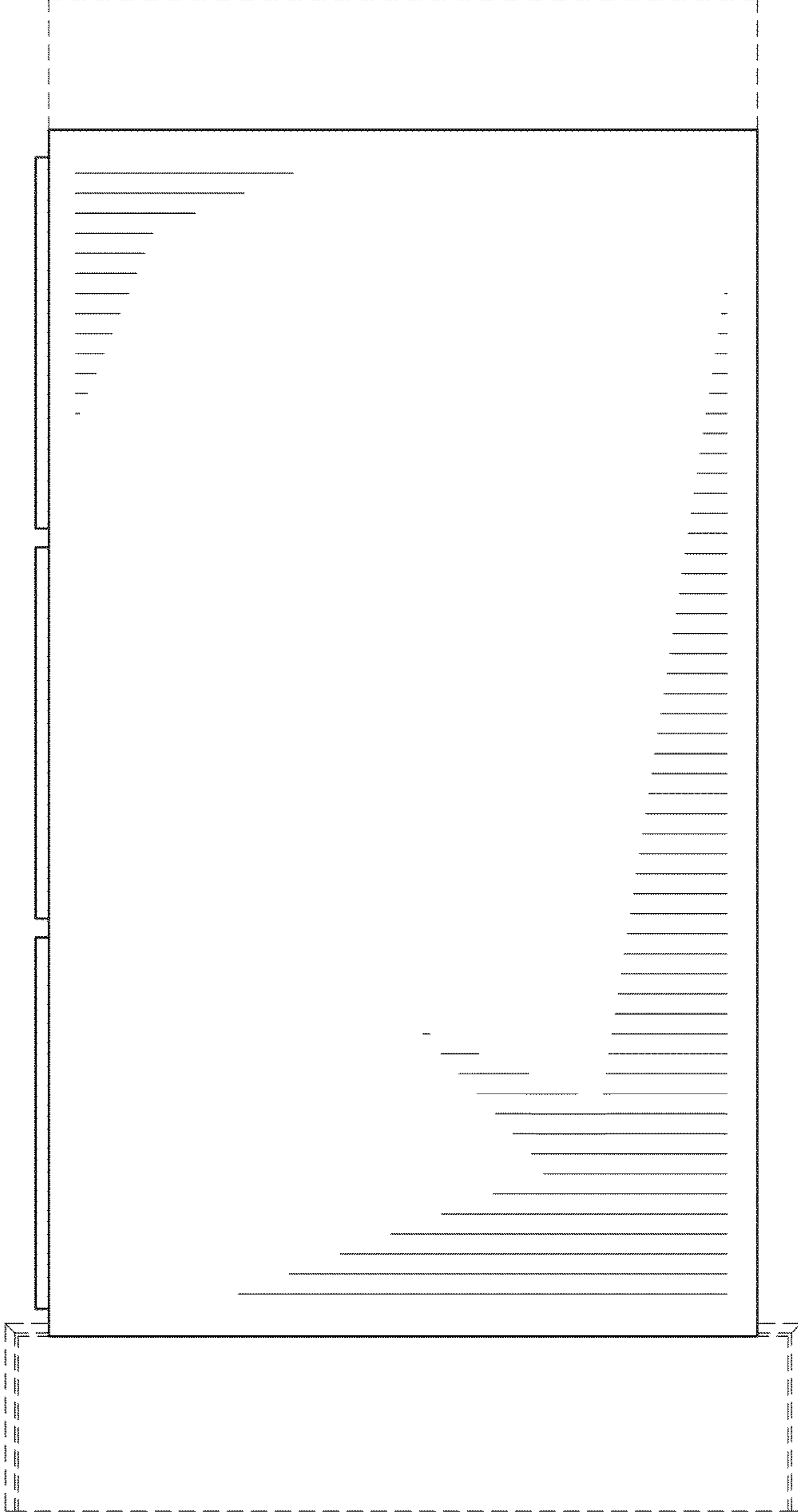

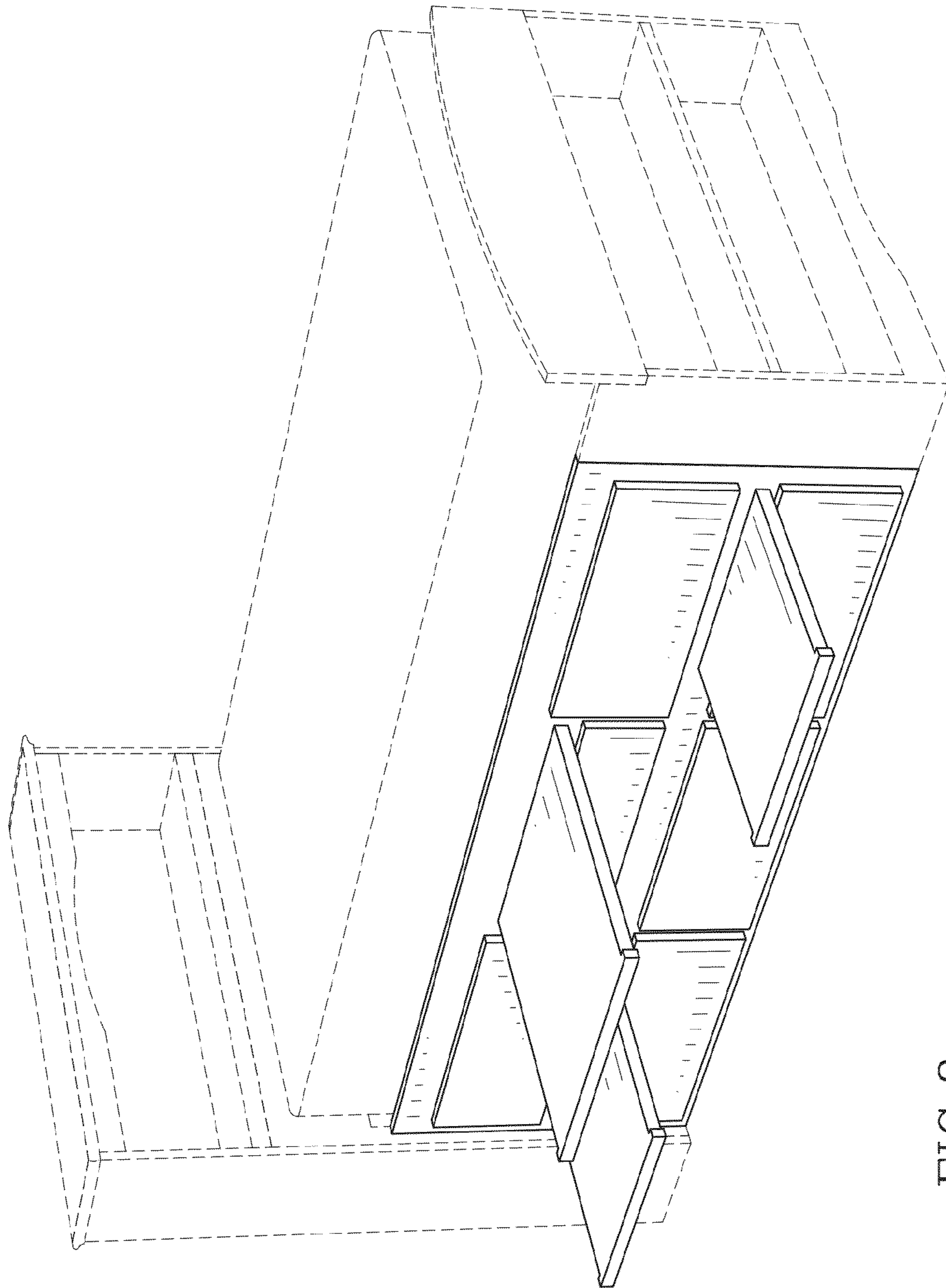

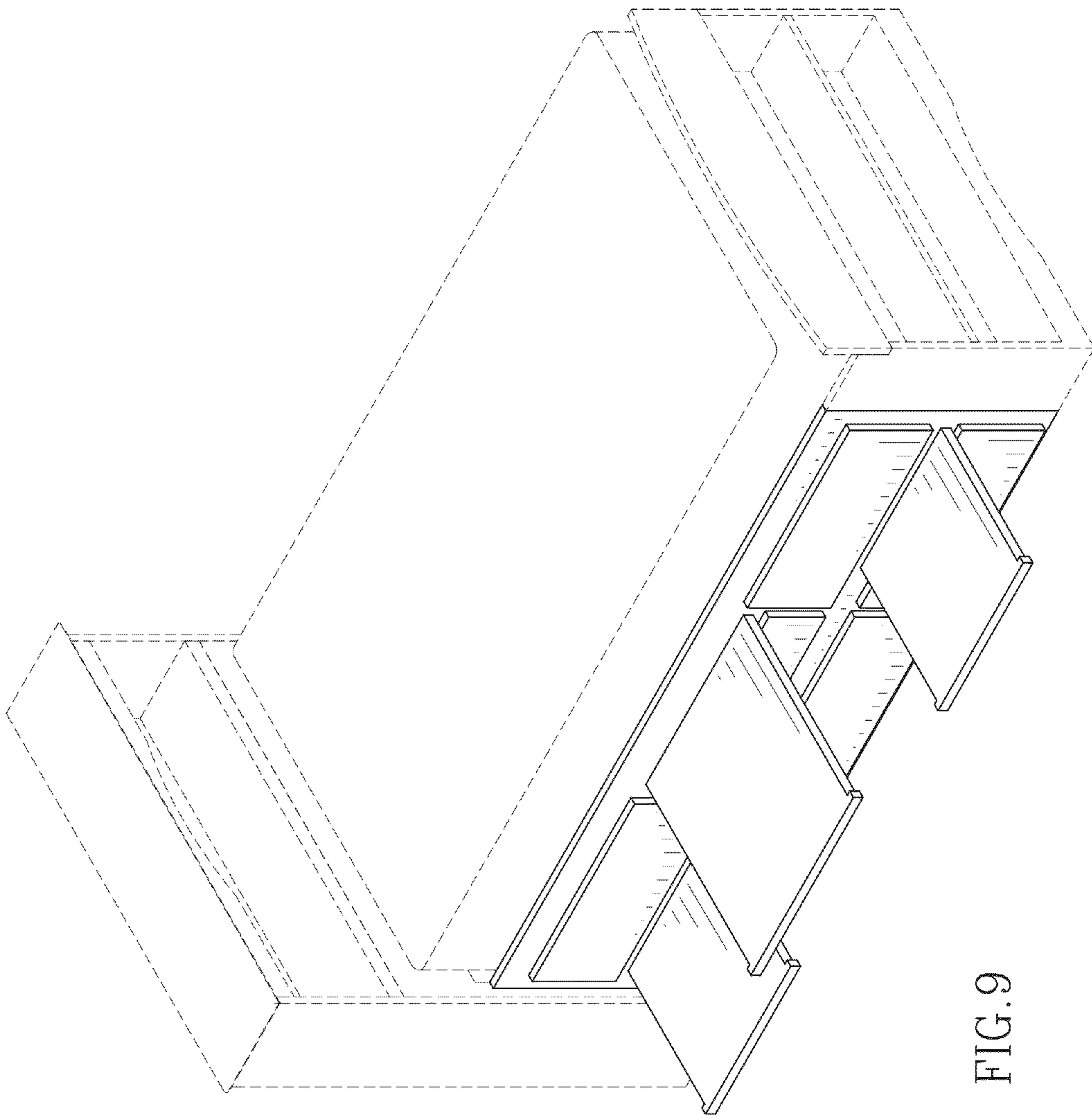

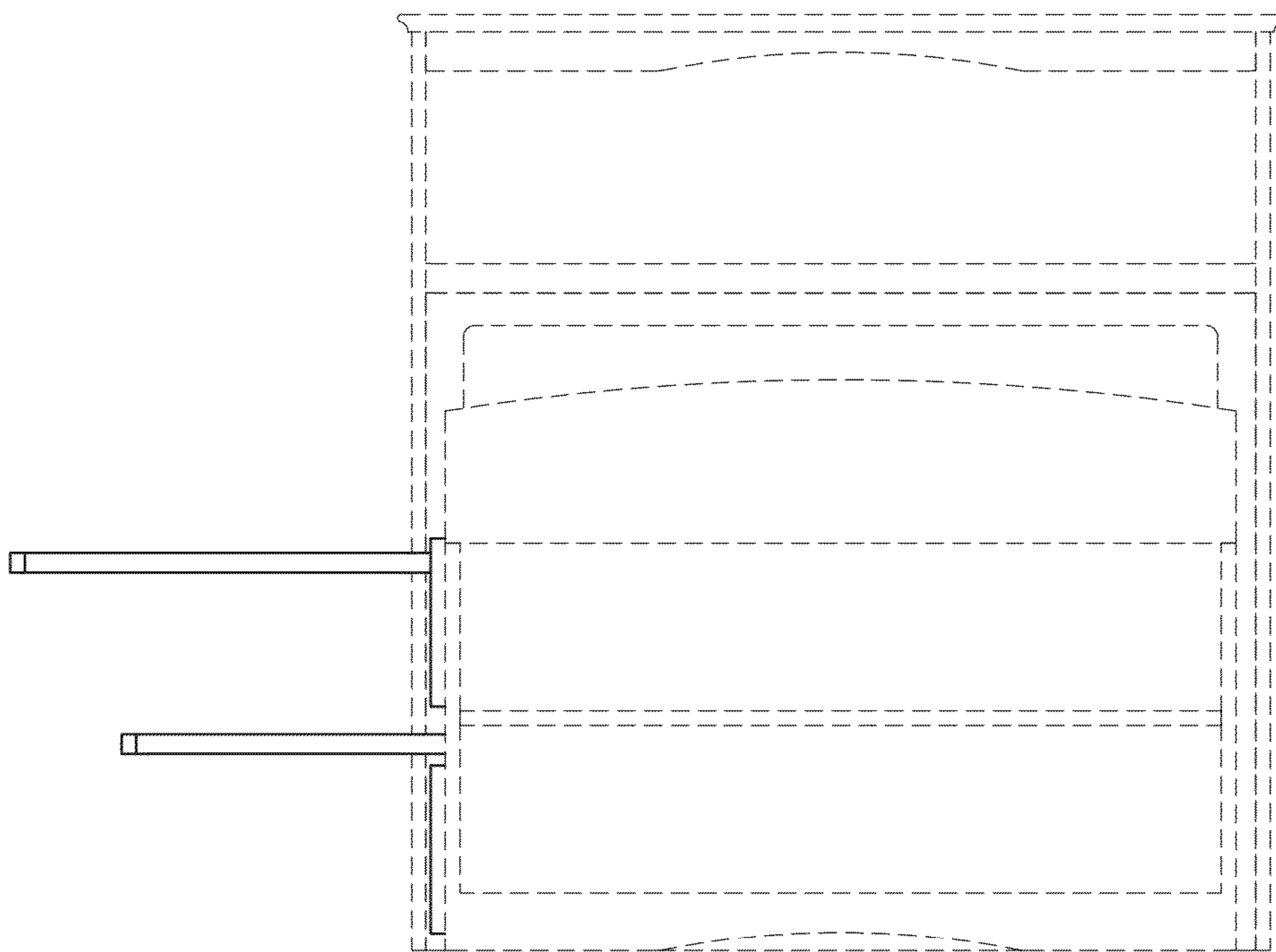

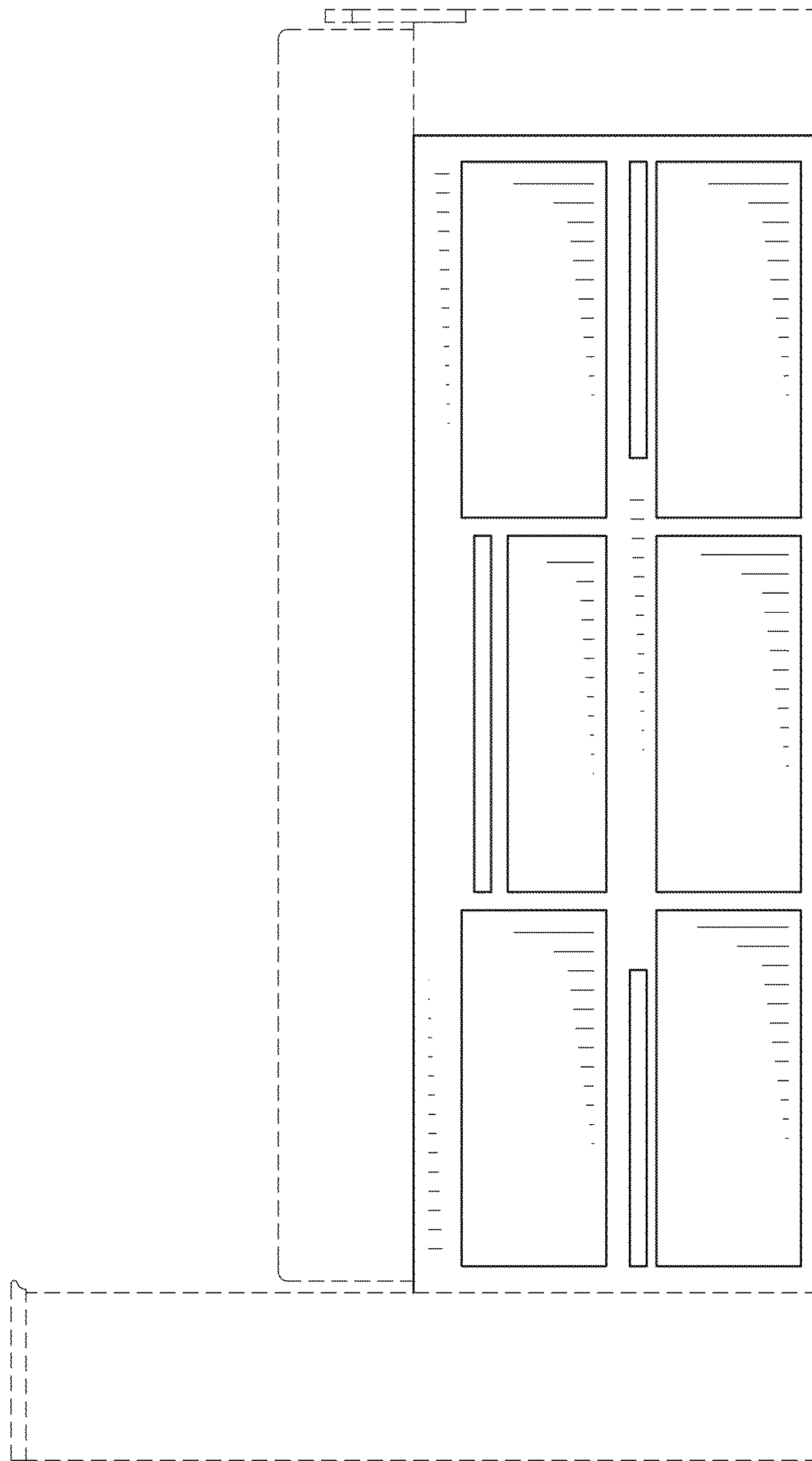

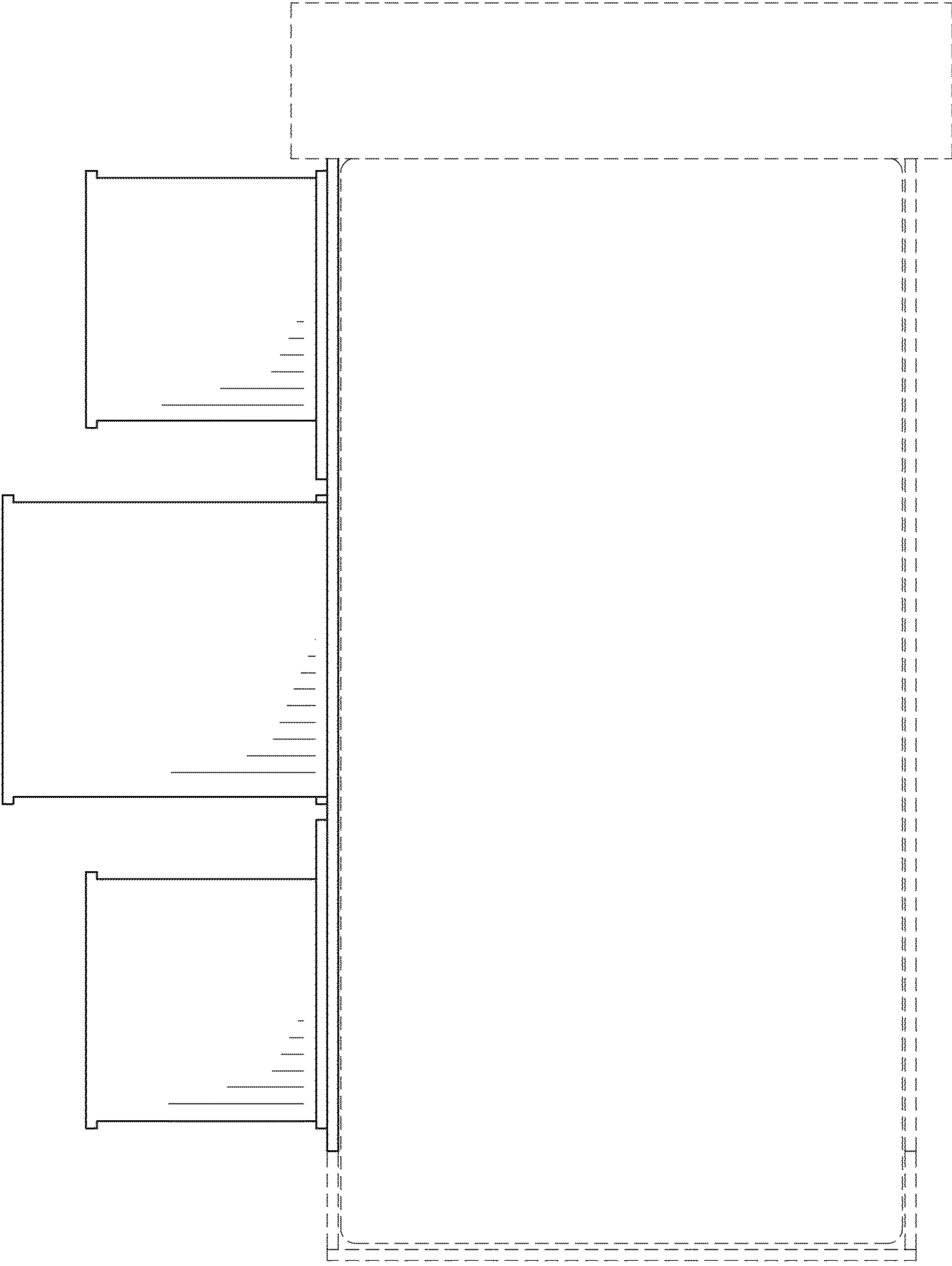

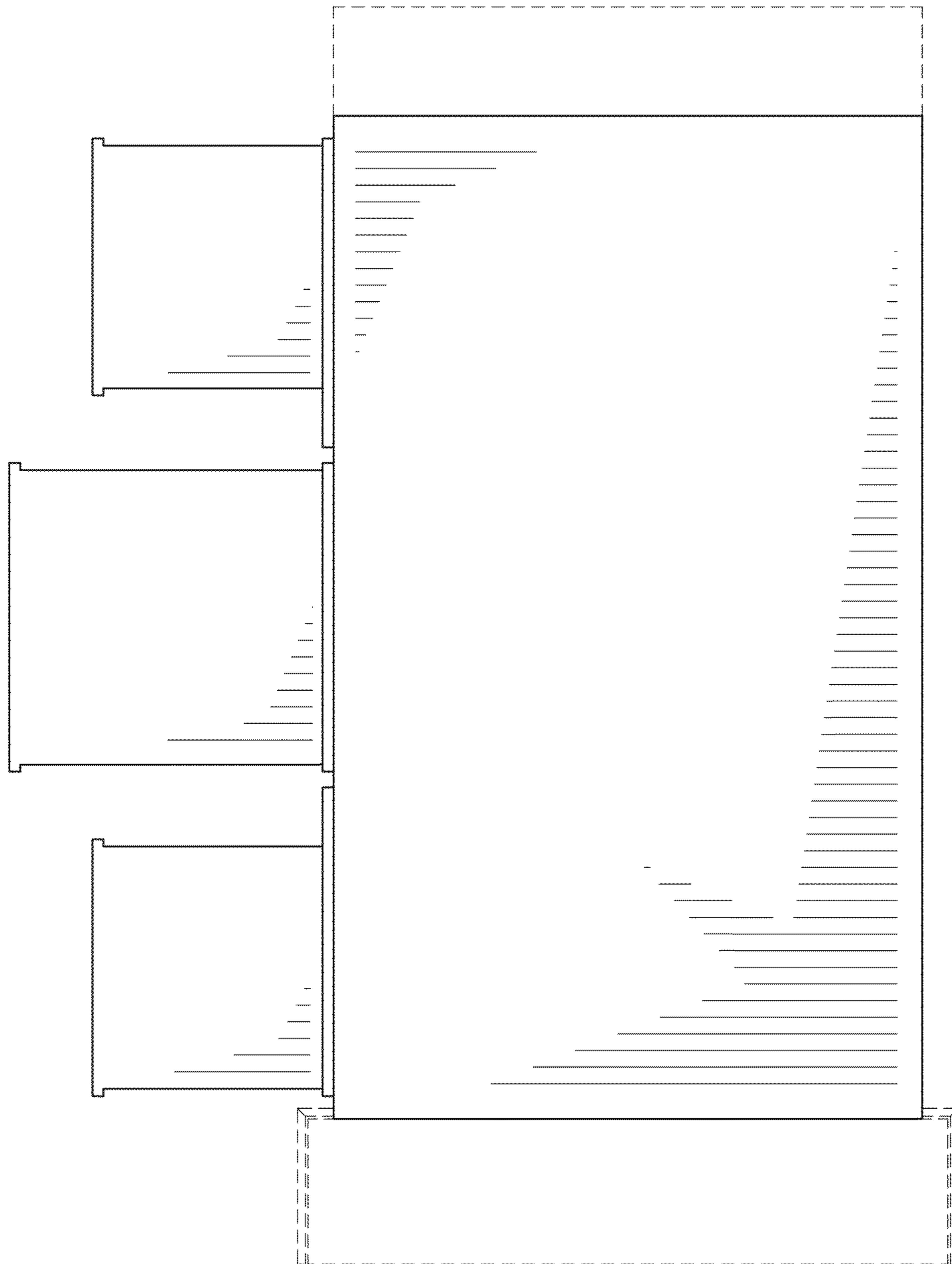
