**DESCRIPTION**

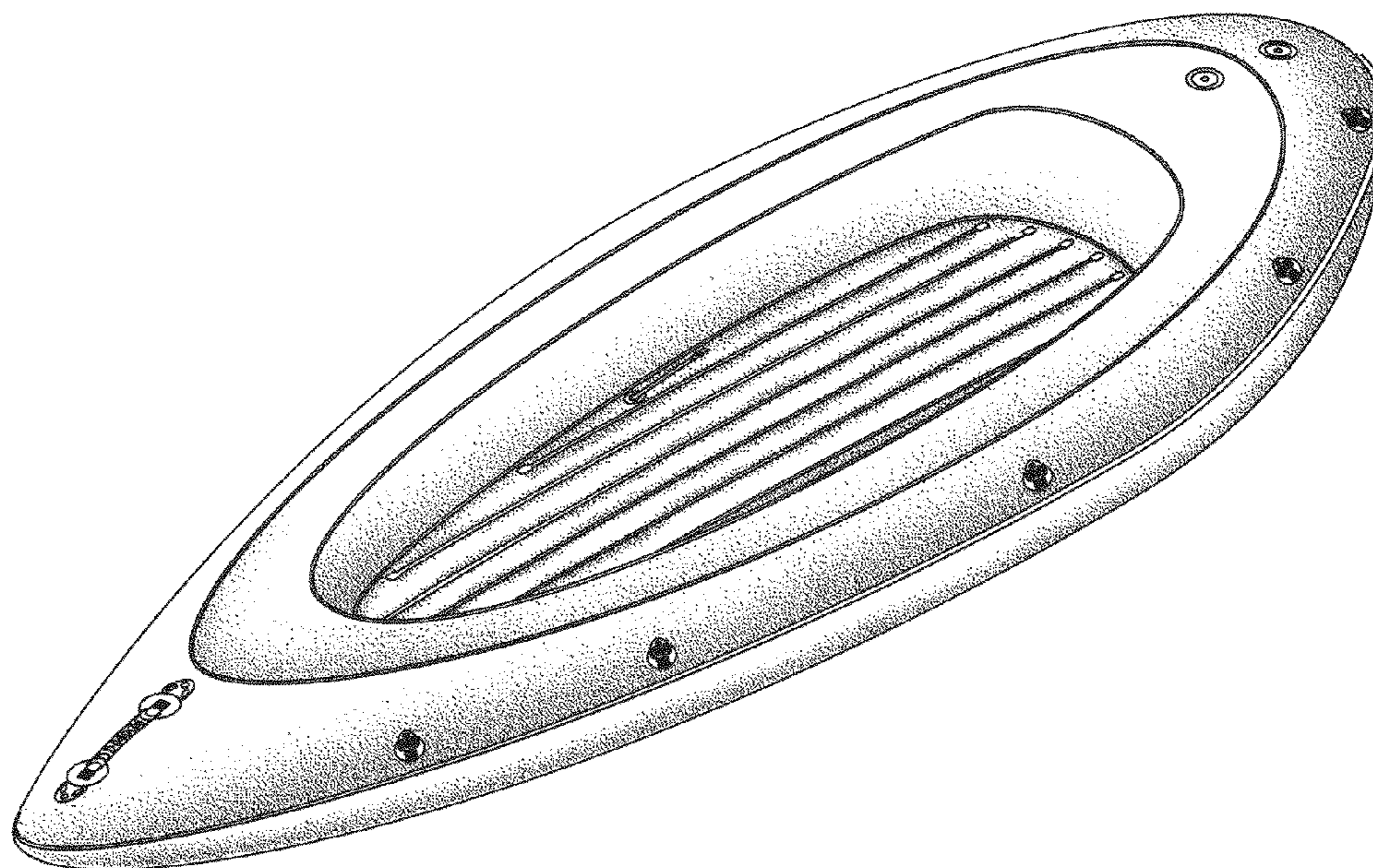
FIG. 1 is a perspective view of an inflatable kayak showing their new design;

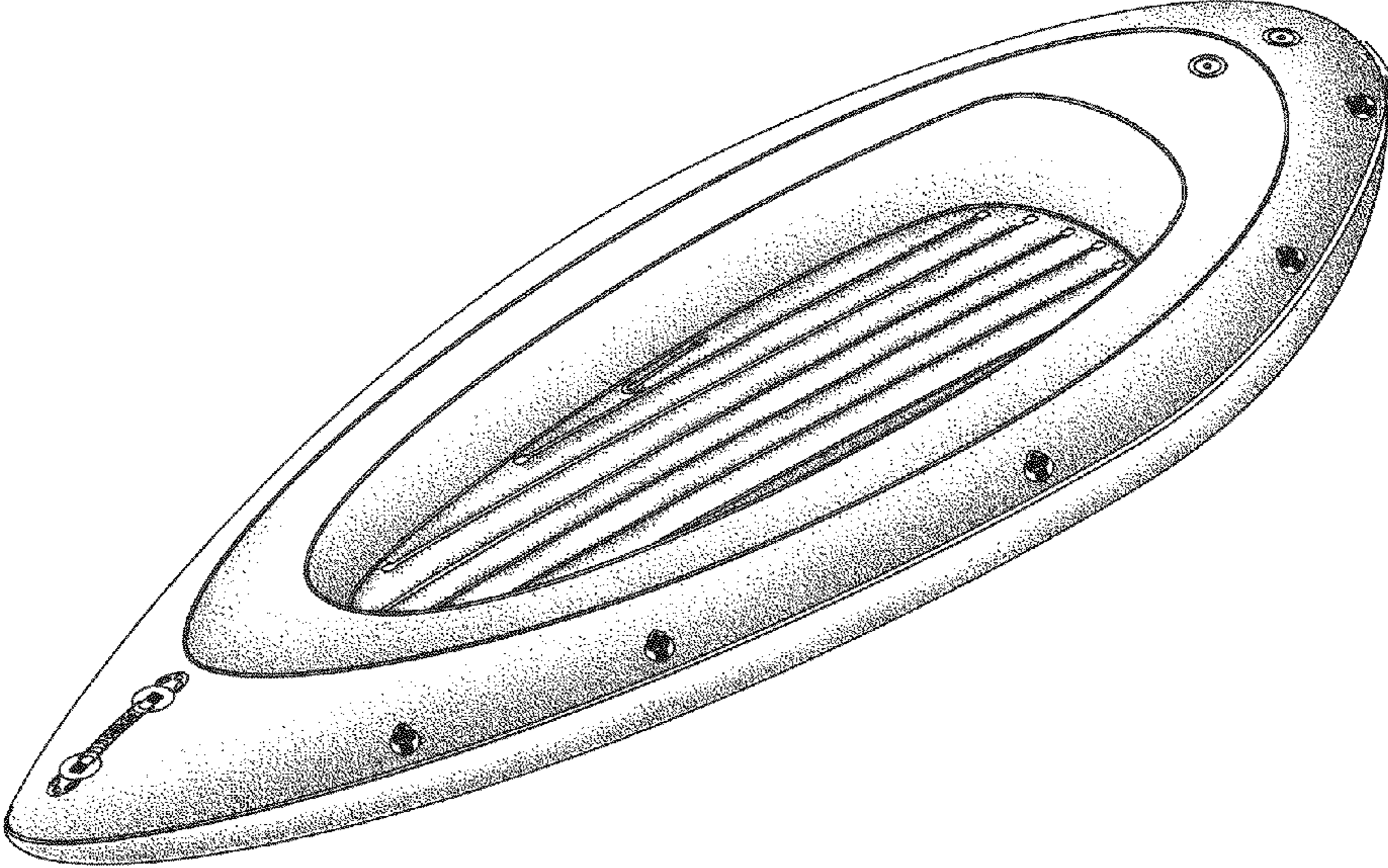

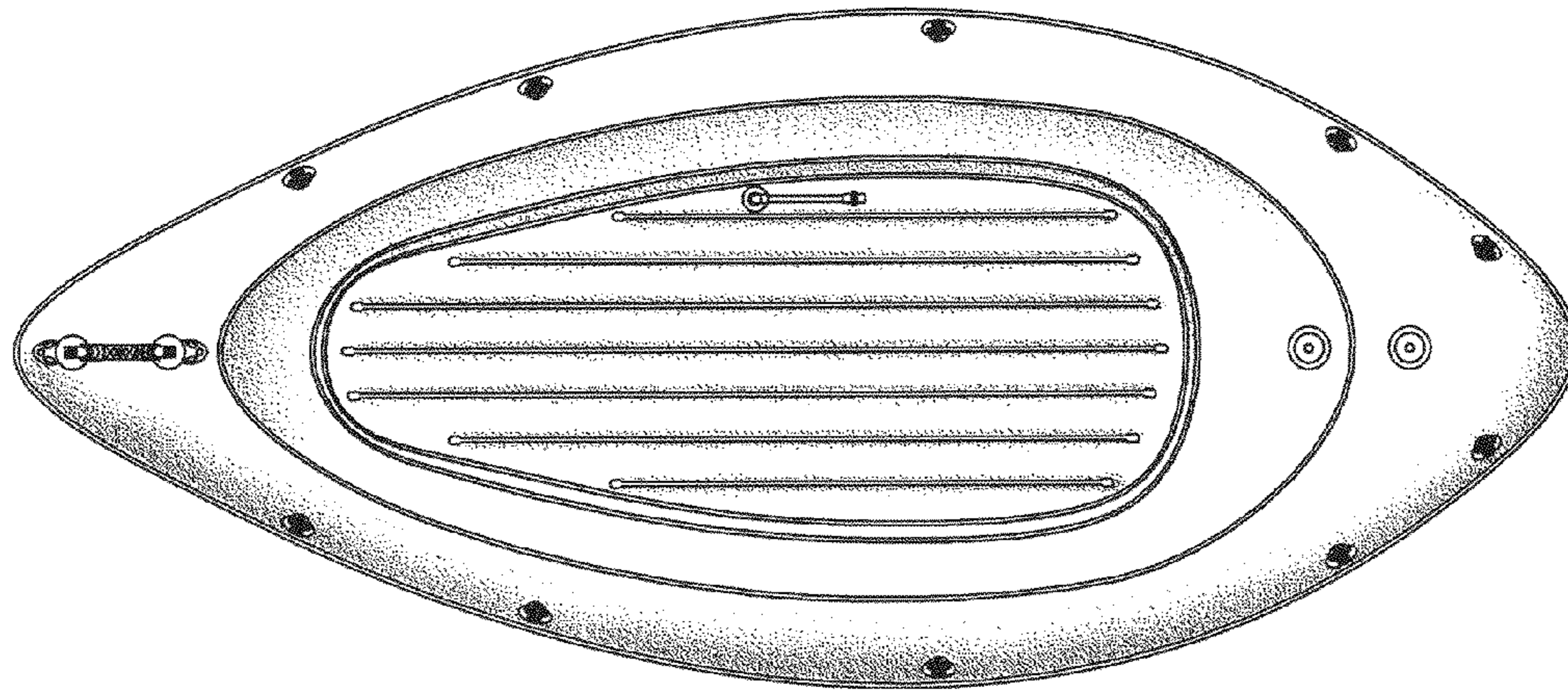

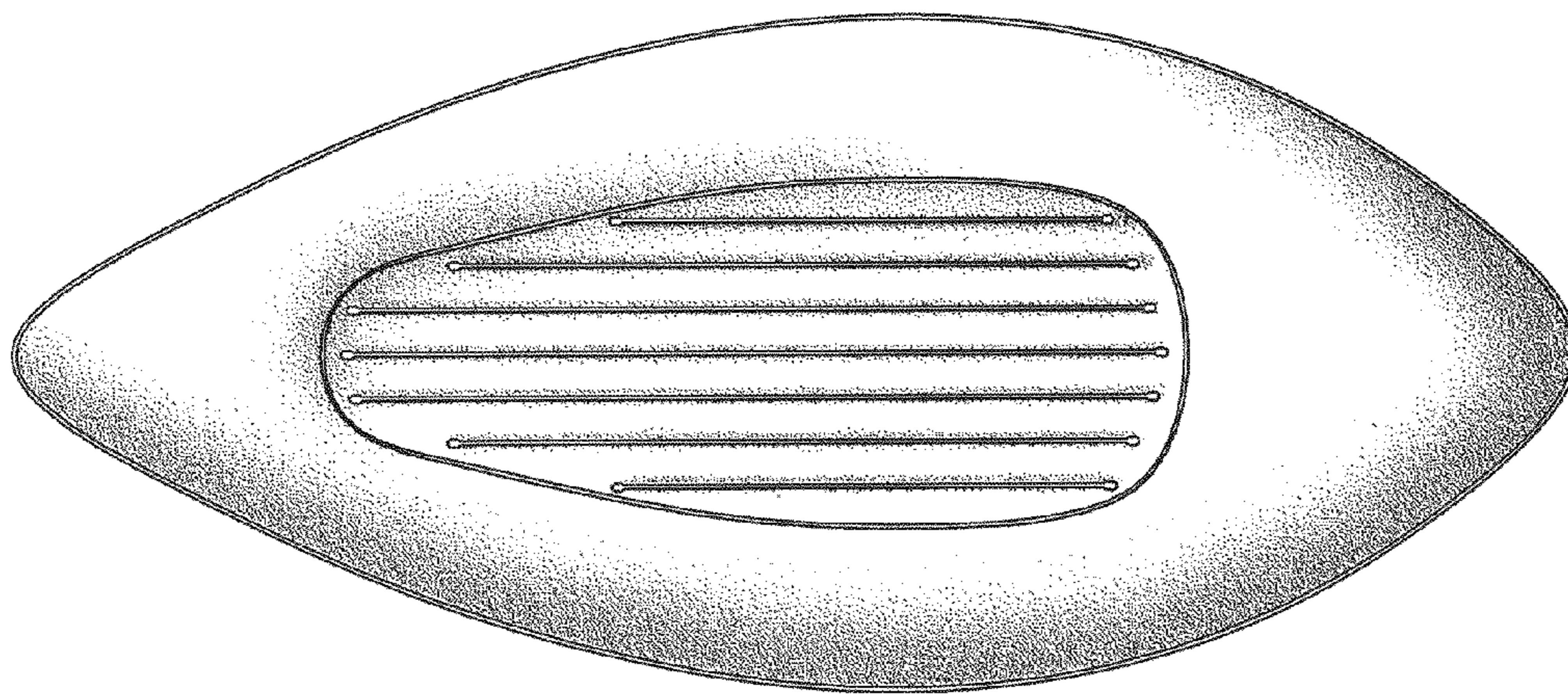

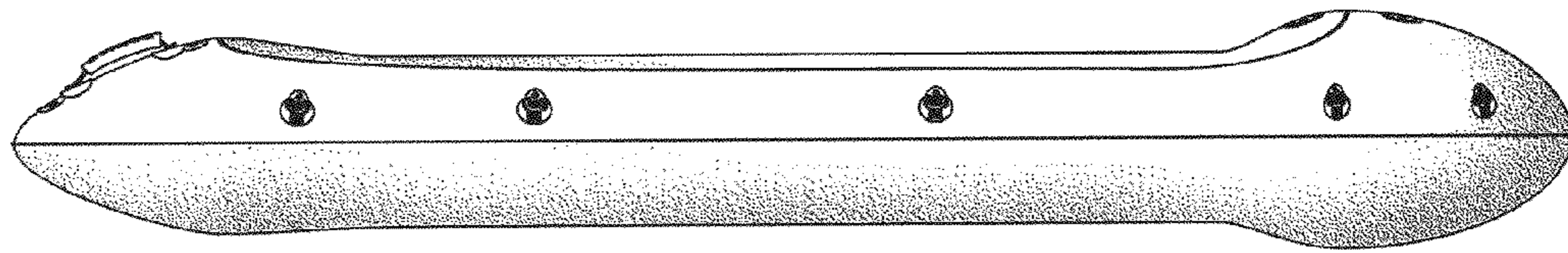

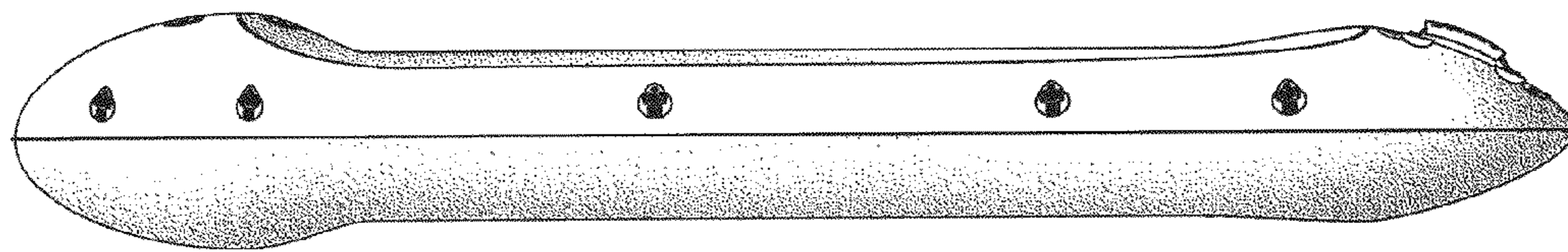

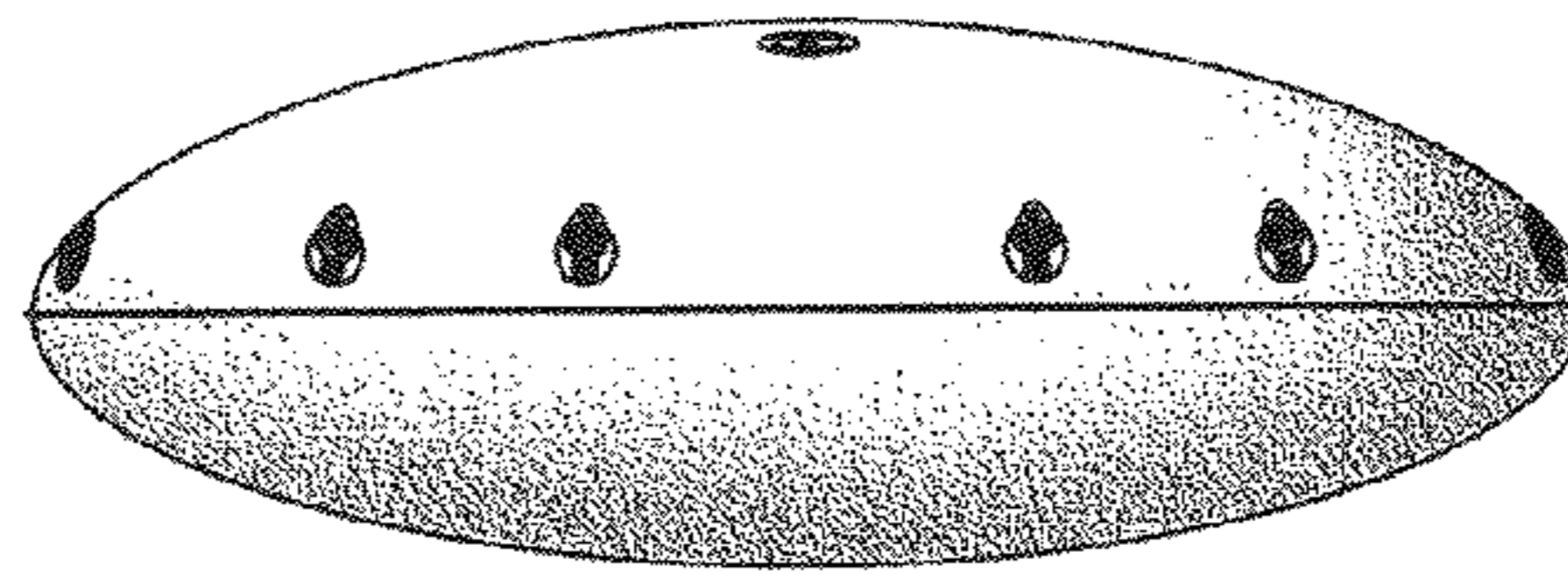

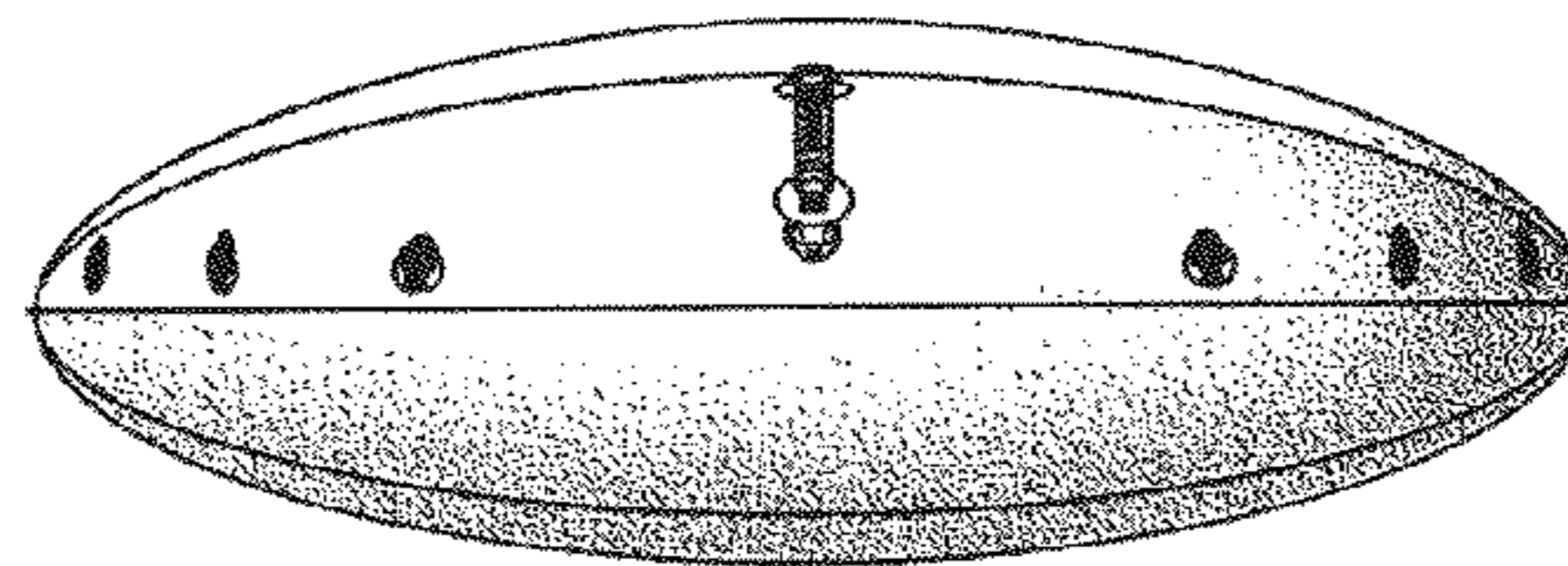
