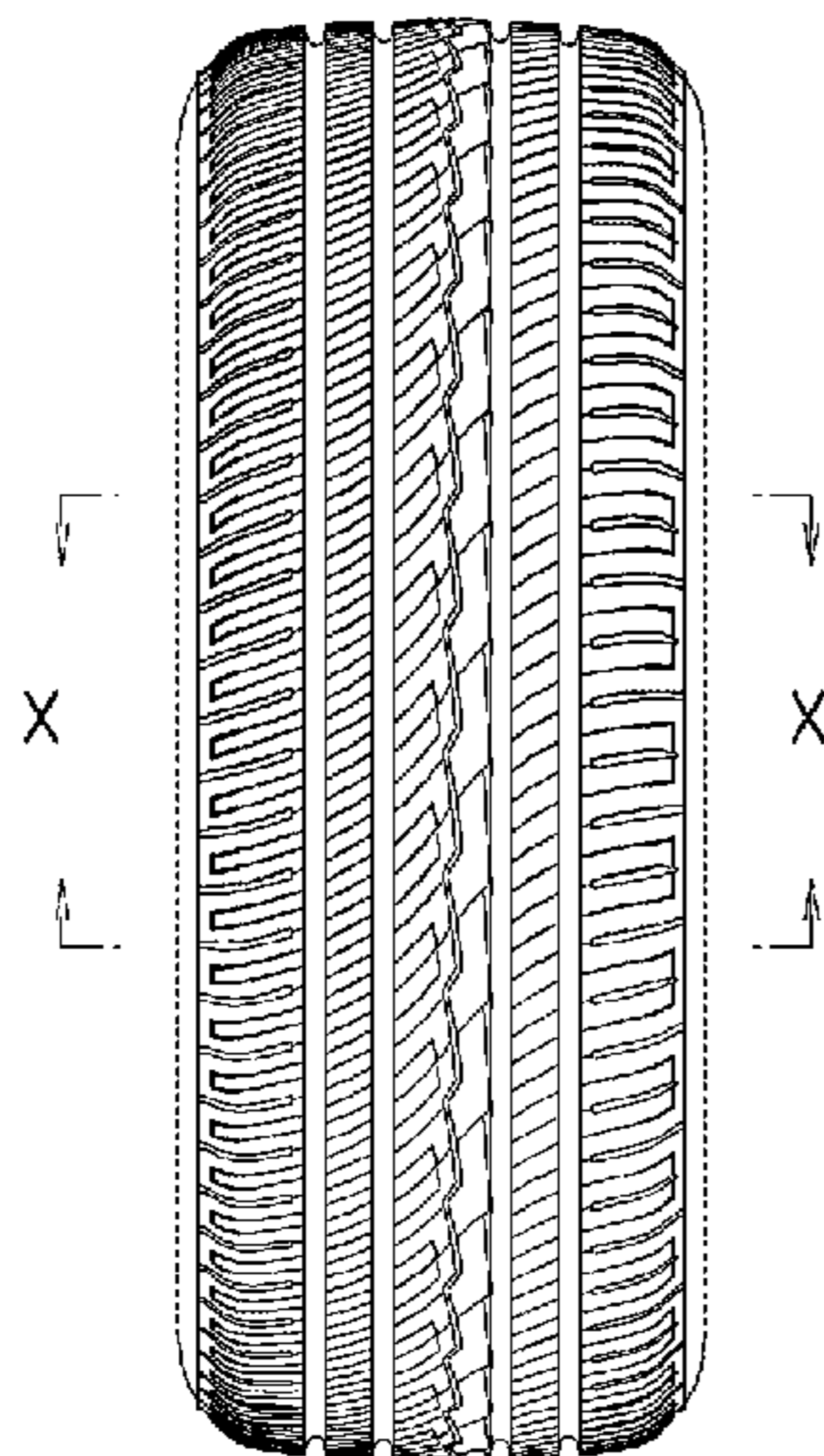
(57) **CLAIM**

The ornamental design for an automobile tire, as shown and described.

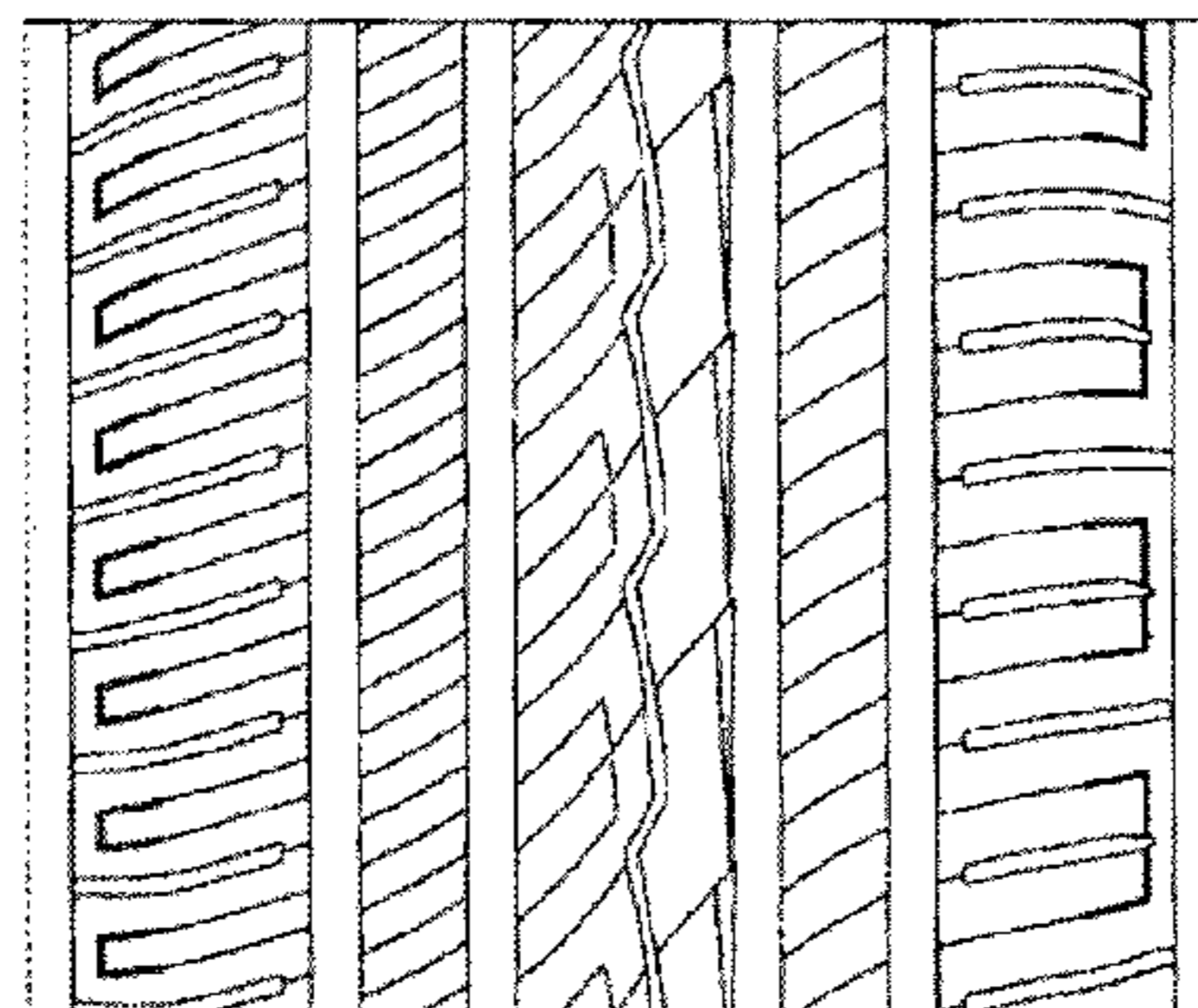
DESCRIPTION

FIG. 1 is a front view of the present automobile tire;
 FIG. 2 is a rear view;
 FIG. 3 is a top view;
 FIG. 4 is a bottom view;
 FIG. 5 is a right side view;
 FIG. 6 is a left side view;
 FIG. 7 is an enlarged view of the section marked between the lines X-X in FIG. 1;
 FIG. 8 is a cross-sectional diagram taken along lines A-A in FIG. 7;
 FIG. 9 is a reference diagram where the grooves of the tire thread have been filled with black; and,
 FIG. 10 is a perspective view.
 The broken lines show the environment in which the design is associated, and form no part of the claimed design.

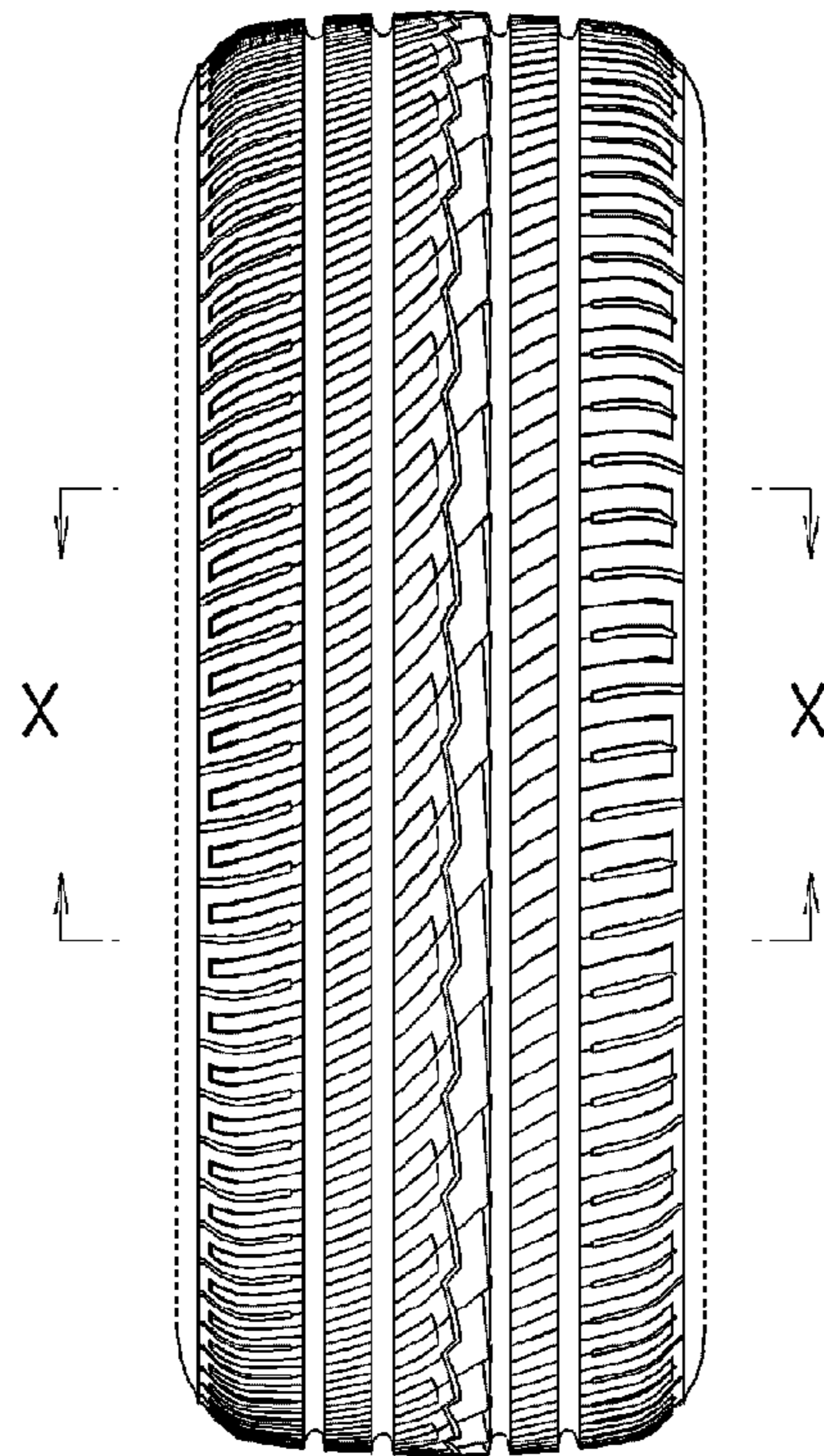

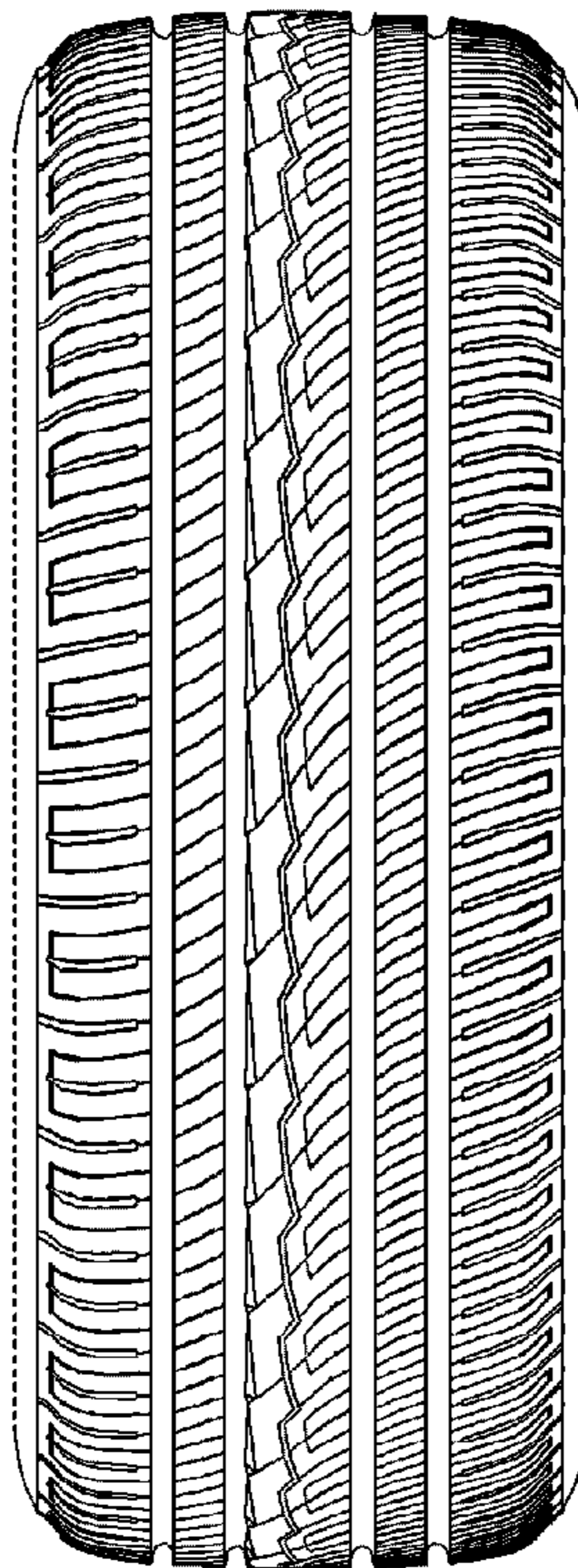

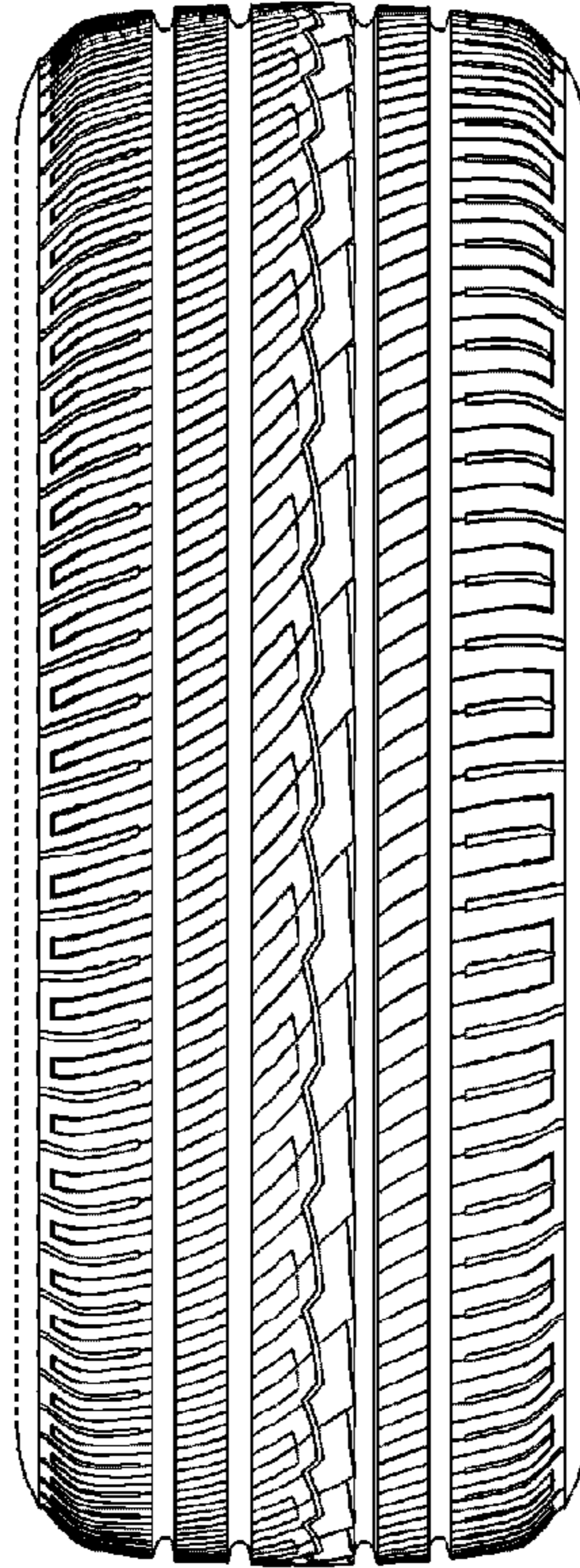

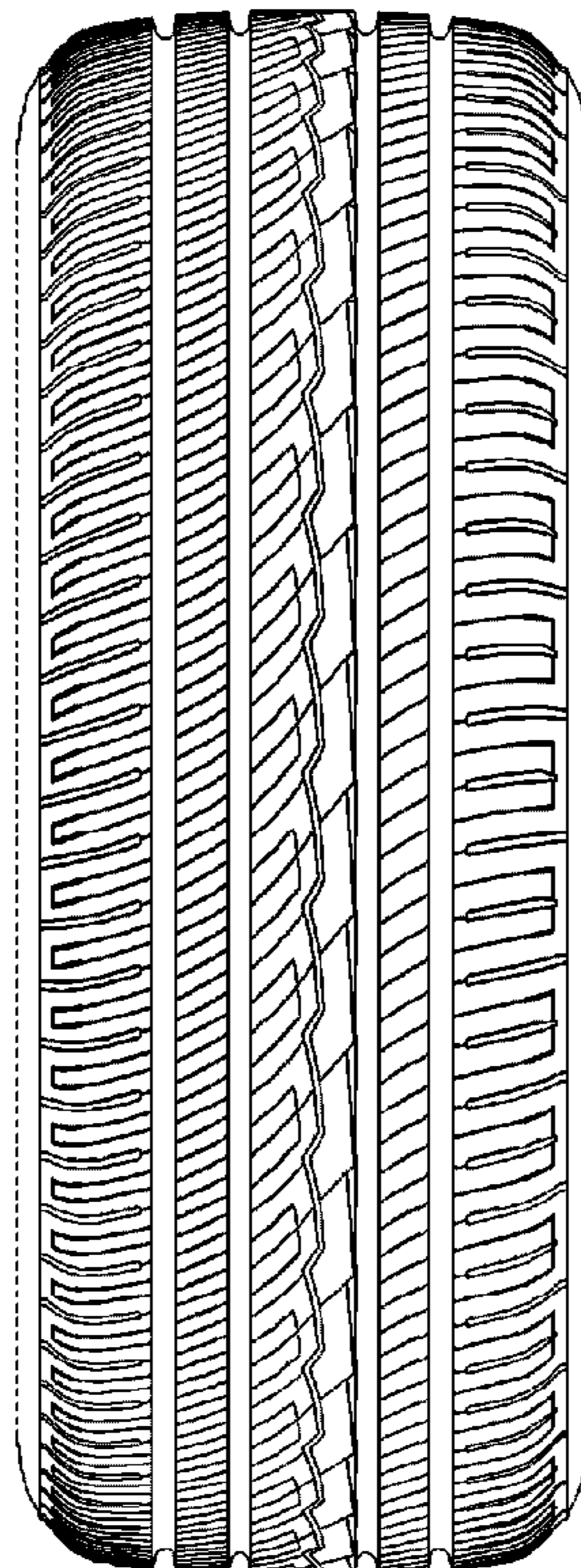

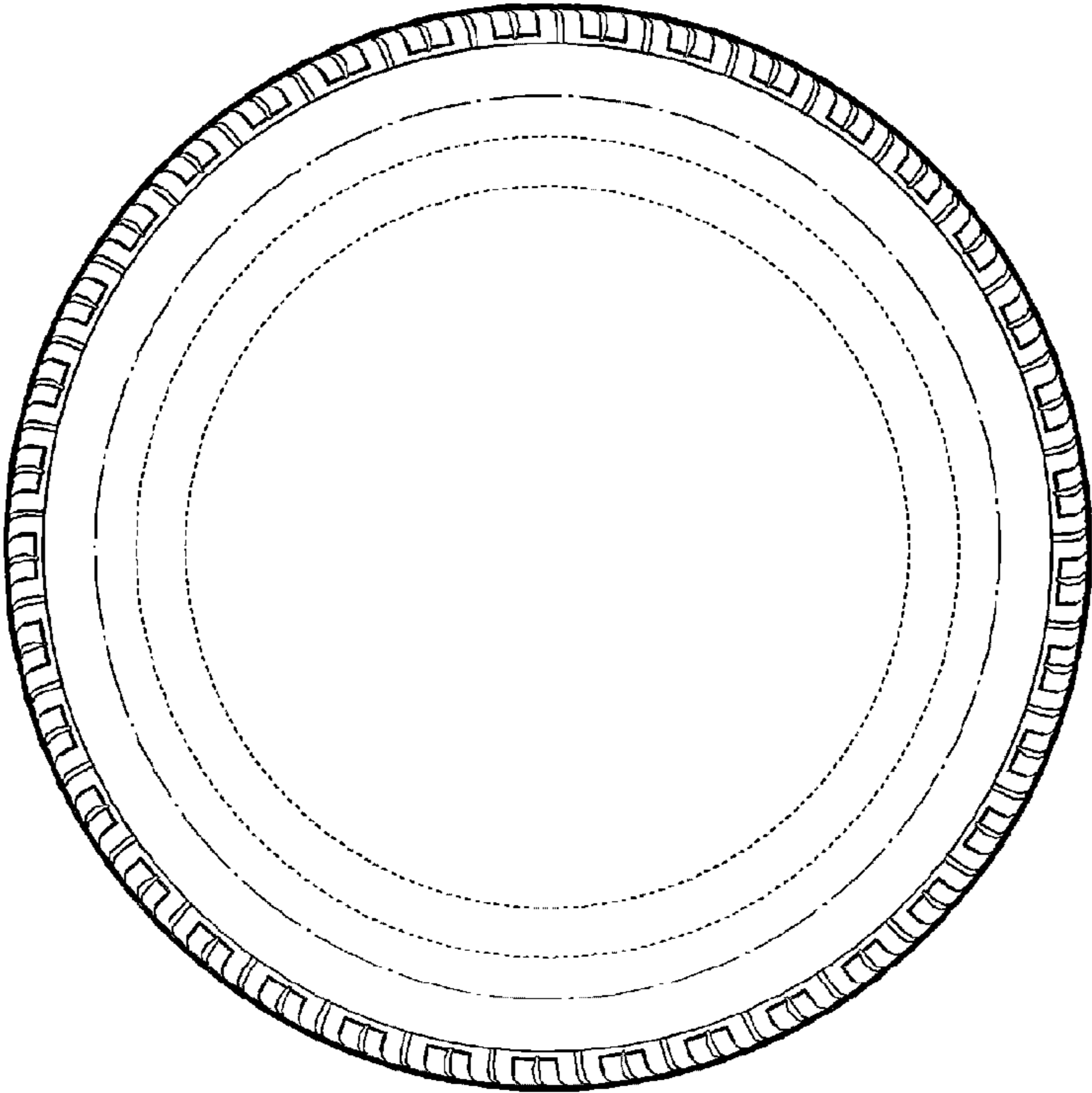

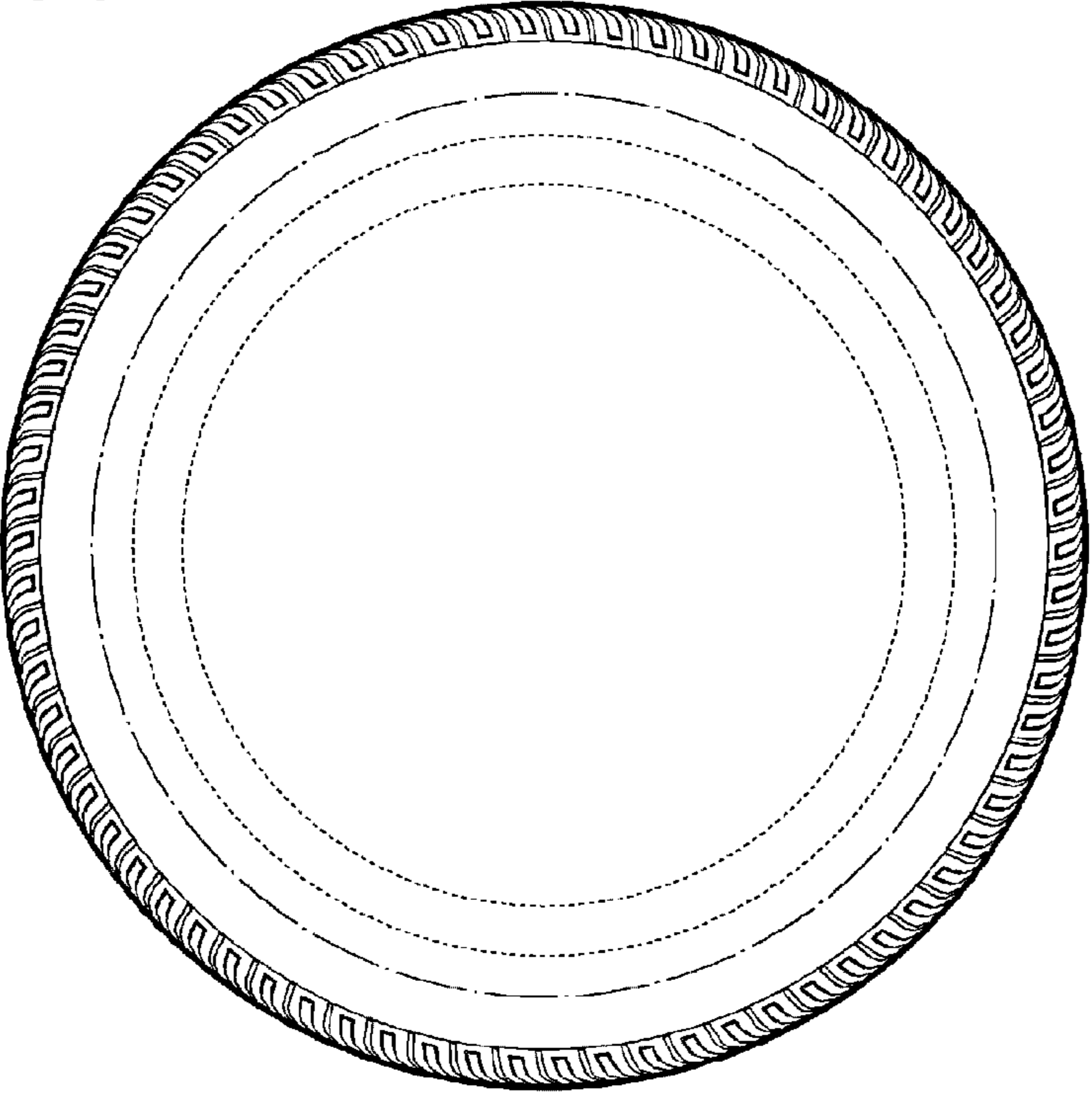

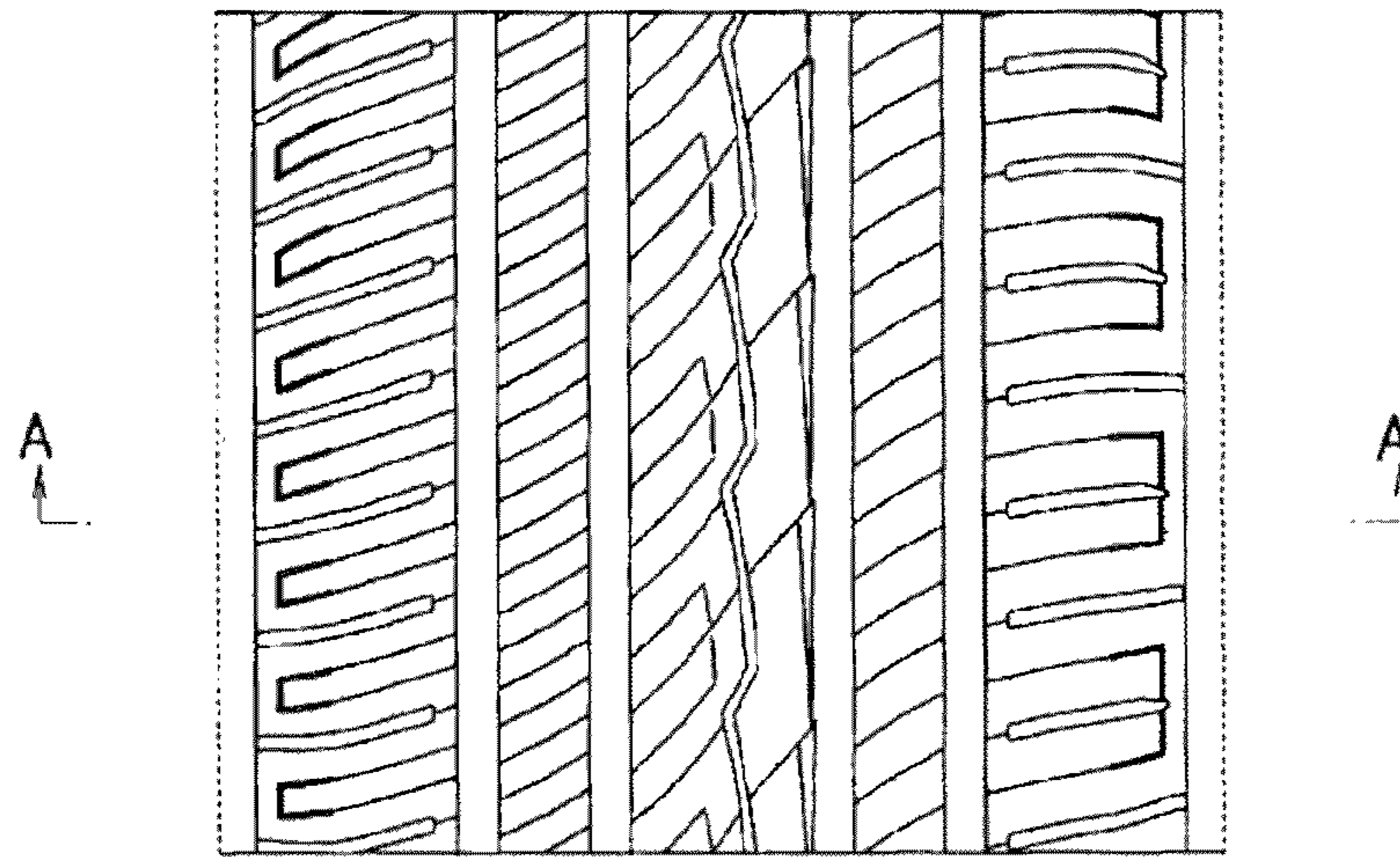

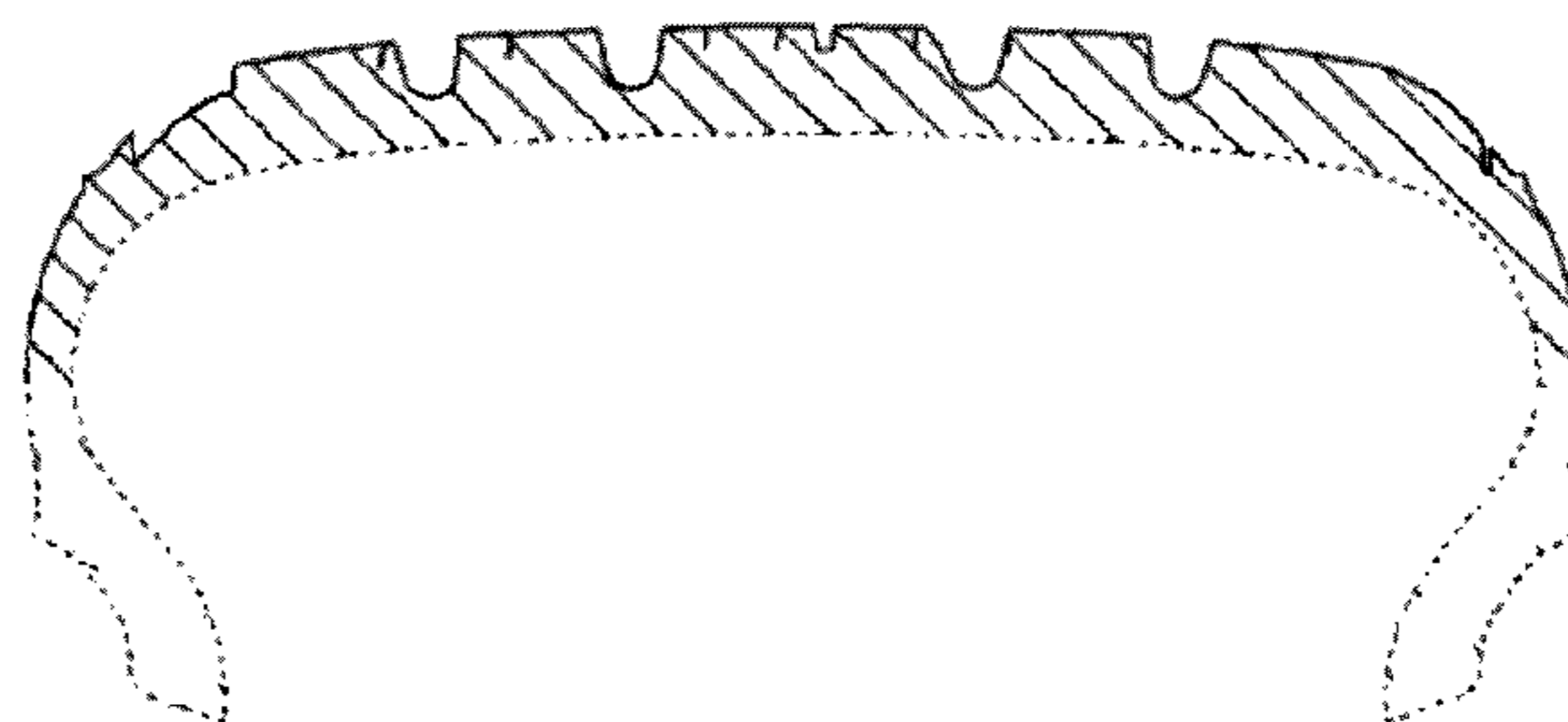

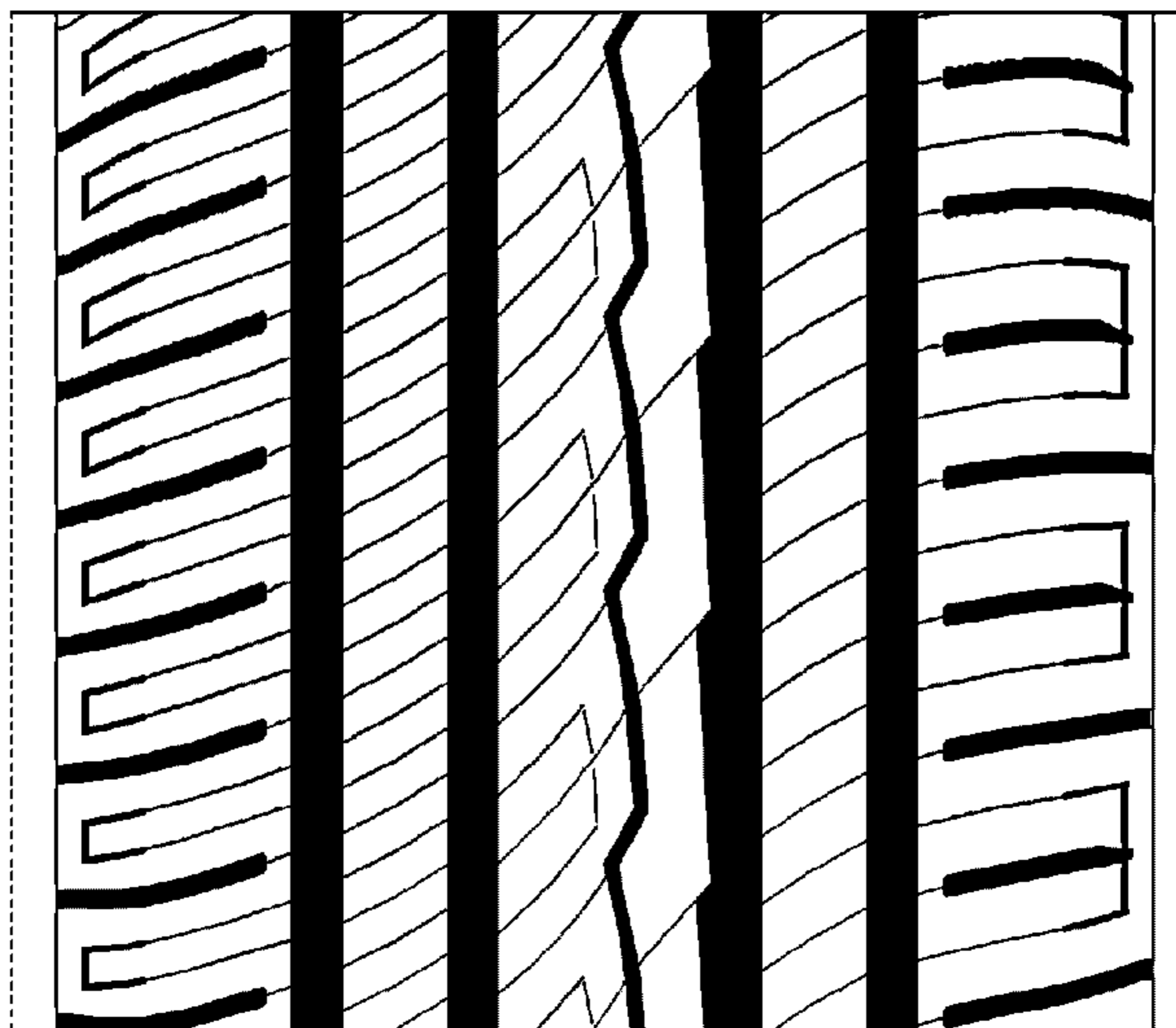
