FIG. 3 is a right side view of the cellular phone of FIG. 1.

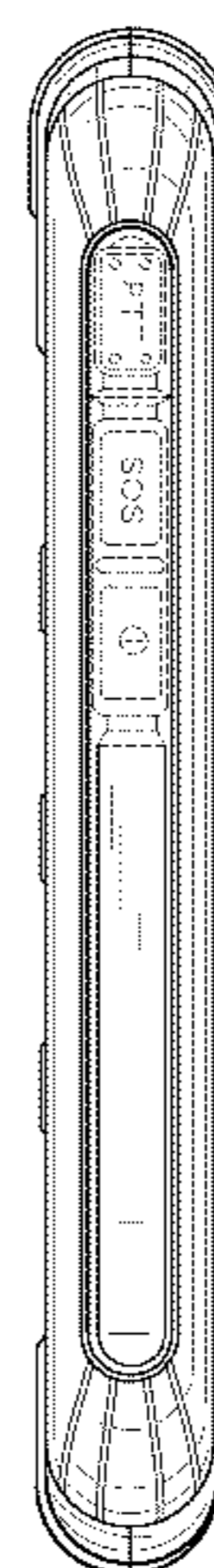
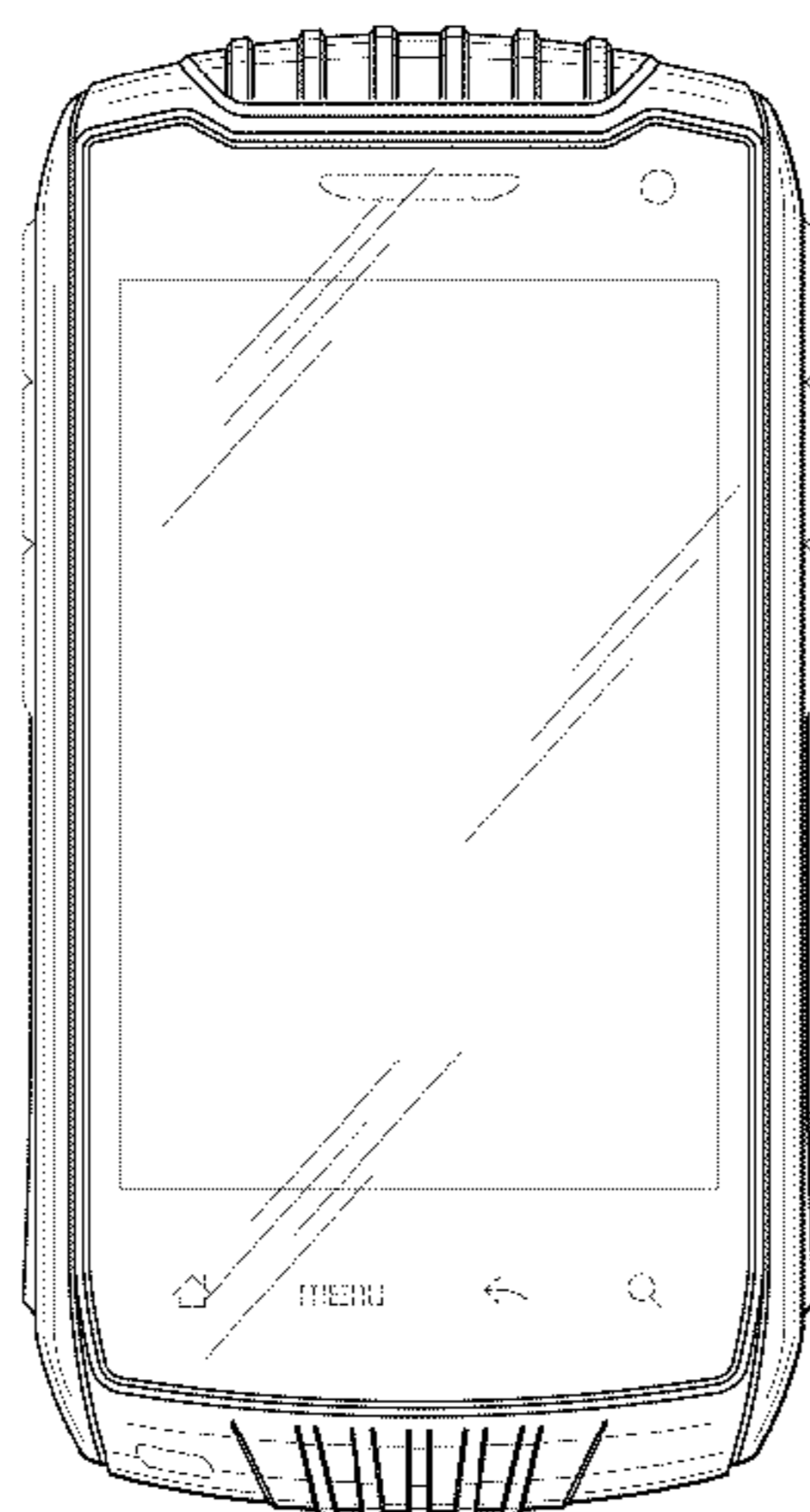
FIG. 4 is a left side view of the cellular phone of FIG. 1.

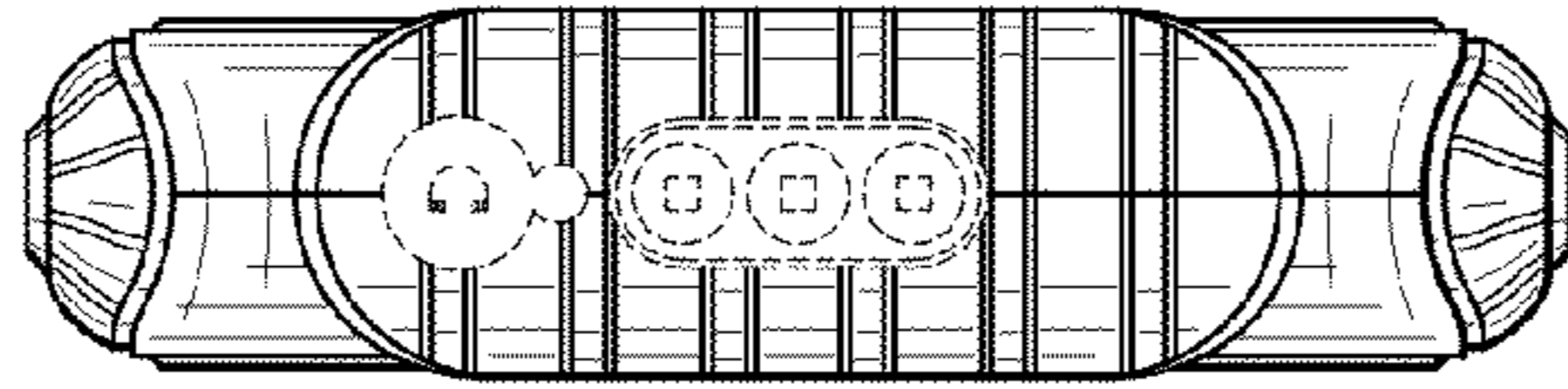

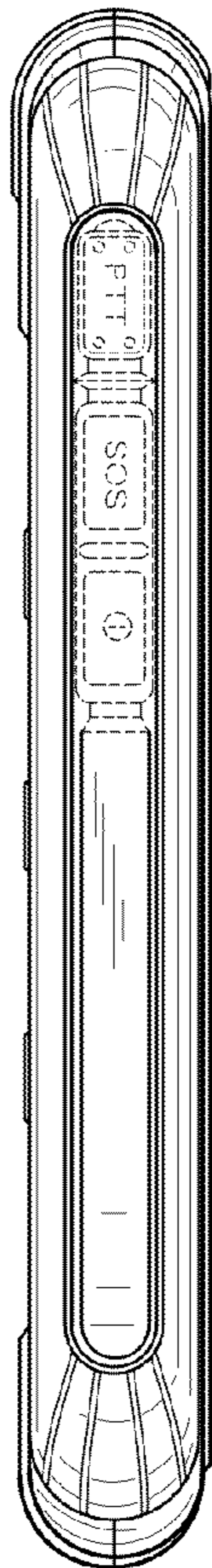

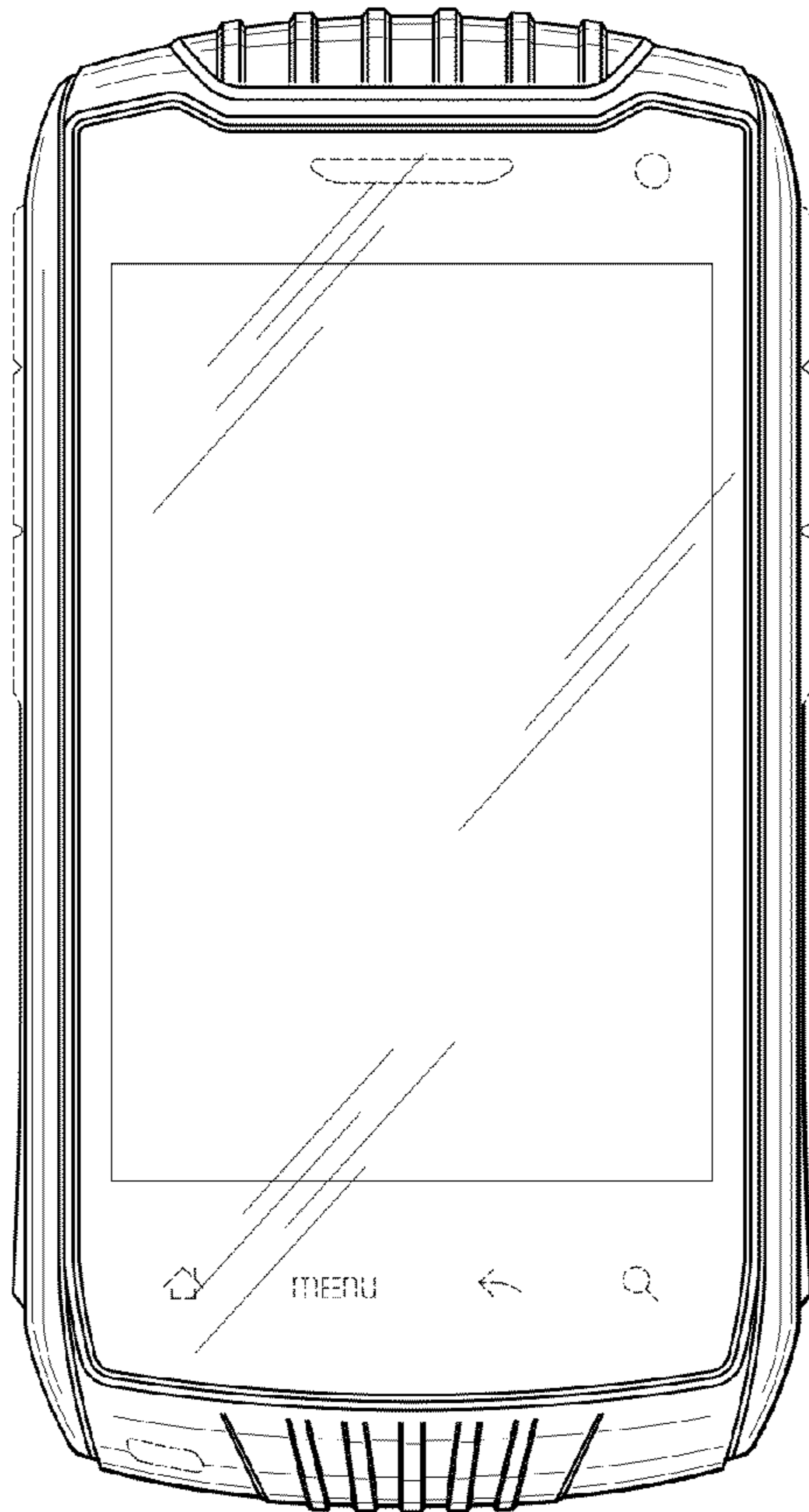

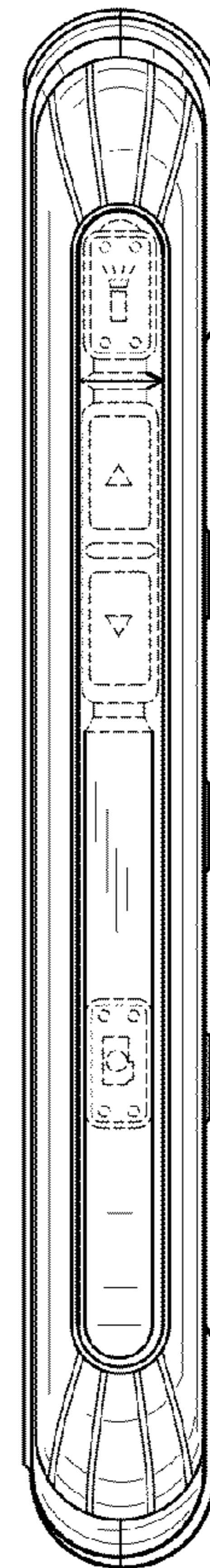

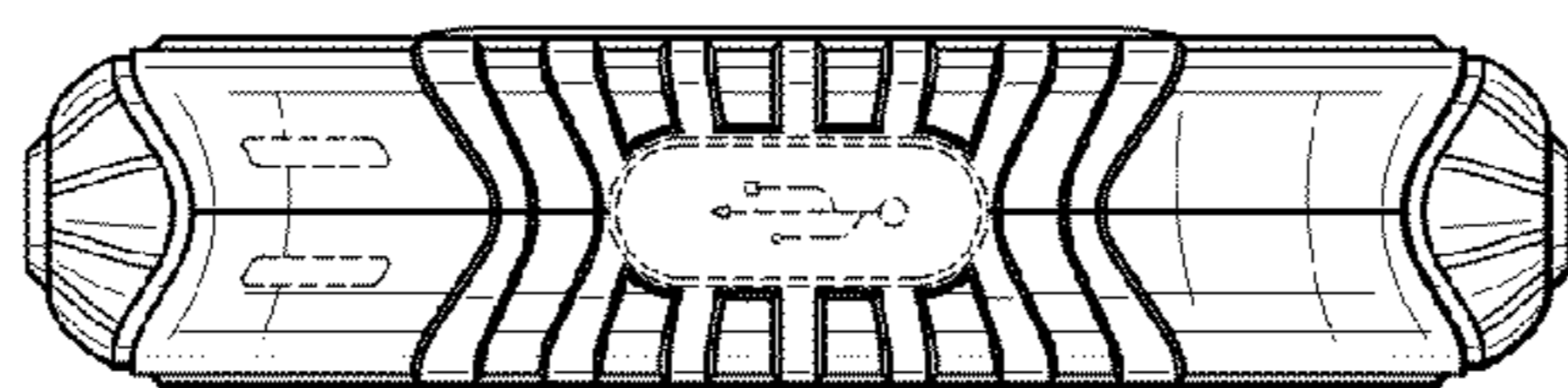

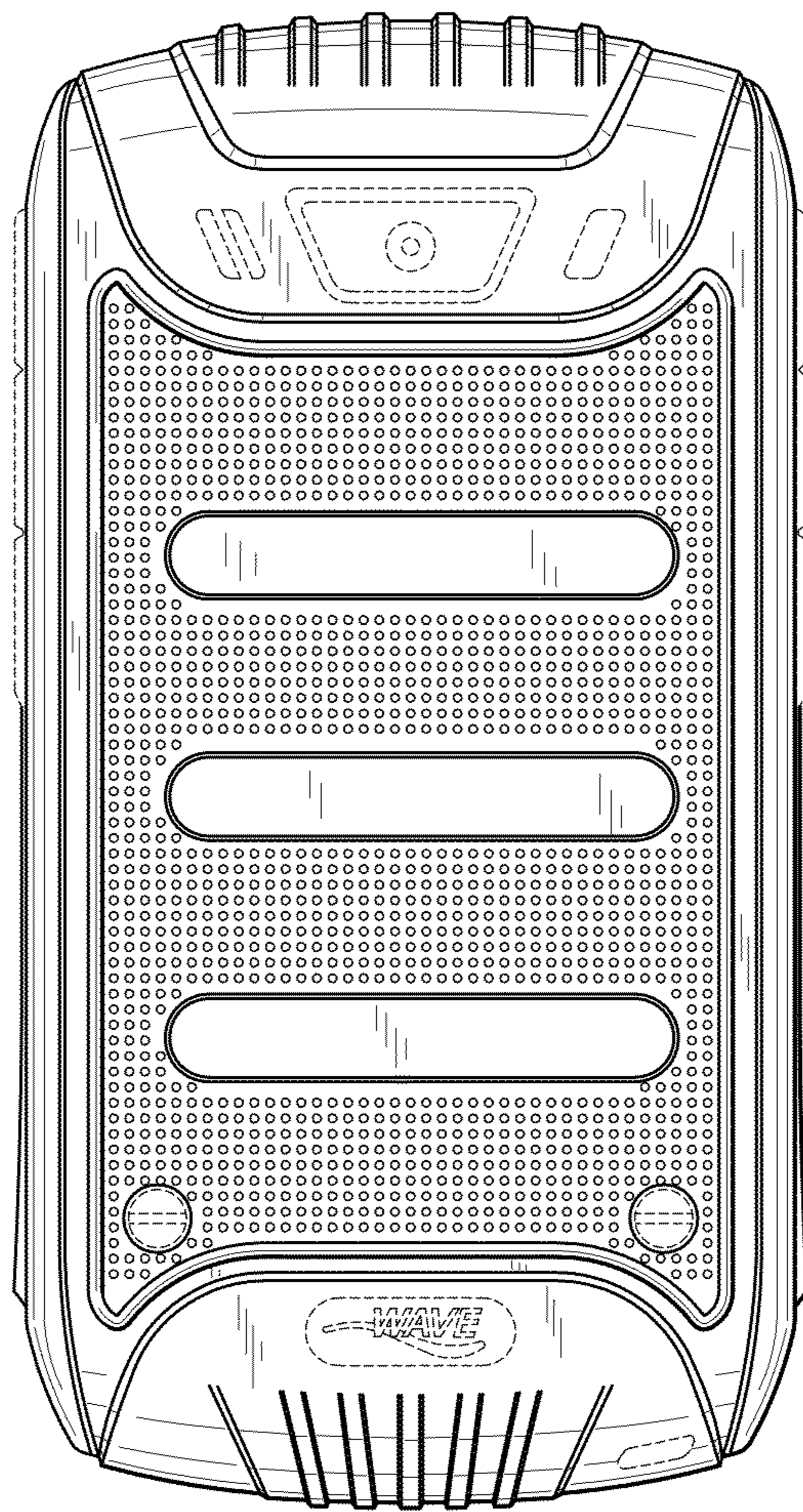
