(57) **CLAIM**

The ornamental design for a card payment terminal, as shown and described.

DESCRIPTION

FIG. 1 is a front, right and bottom side perspective view of a card payment terminal showing our new design;
FIG. 2 is a front, left and bottom side perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.
The broken lines in the drawings are included for the purpose of illustrating portions of the card payment terminal that form no part of the claimed design.
“Pidion” forming part of the claimed design is a registered trademark of BLUEBIRD INC of Seoul, Republic of Korea.

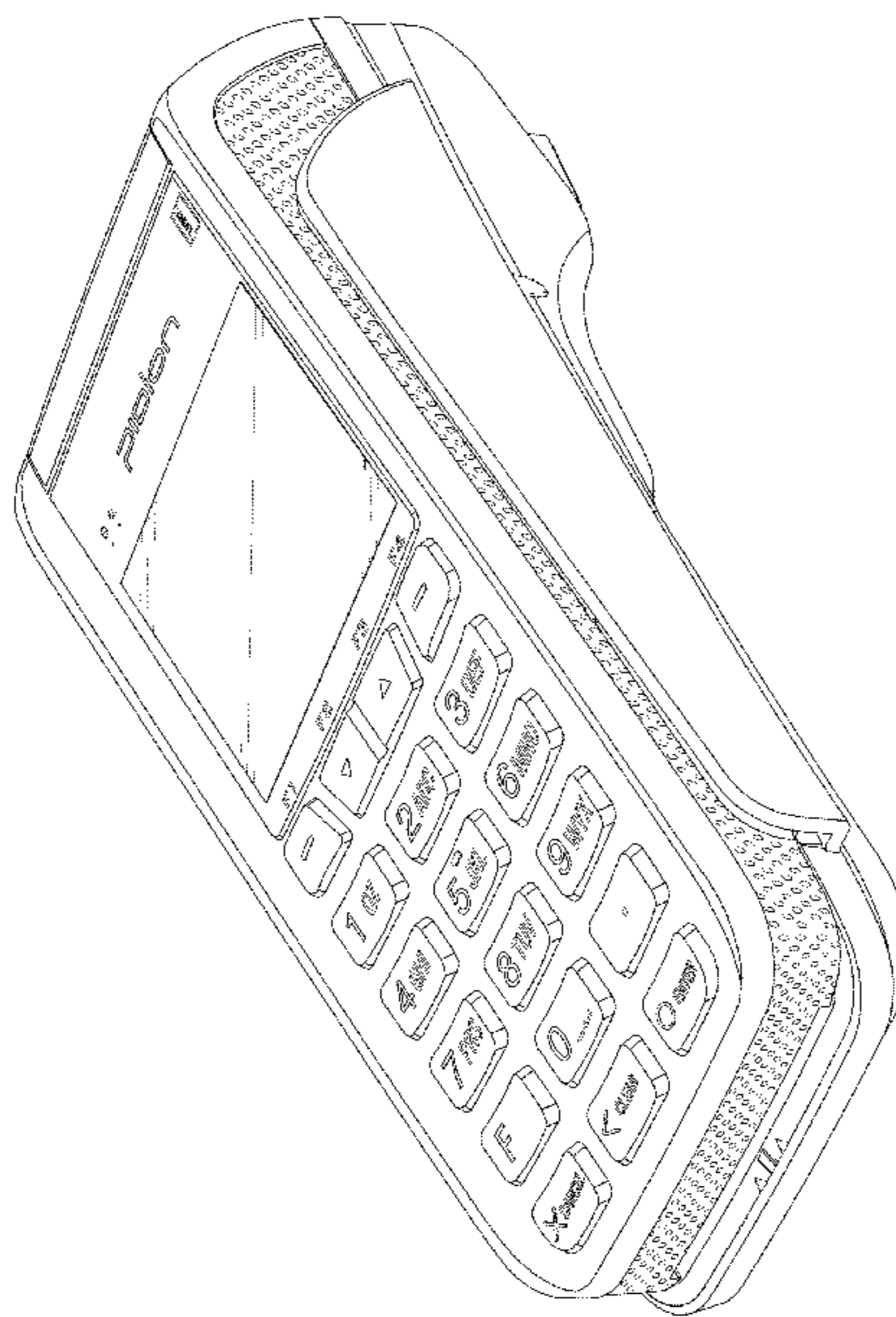

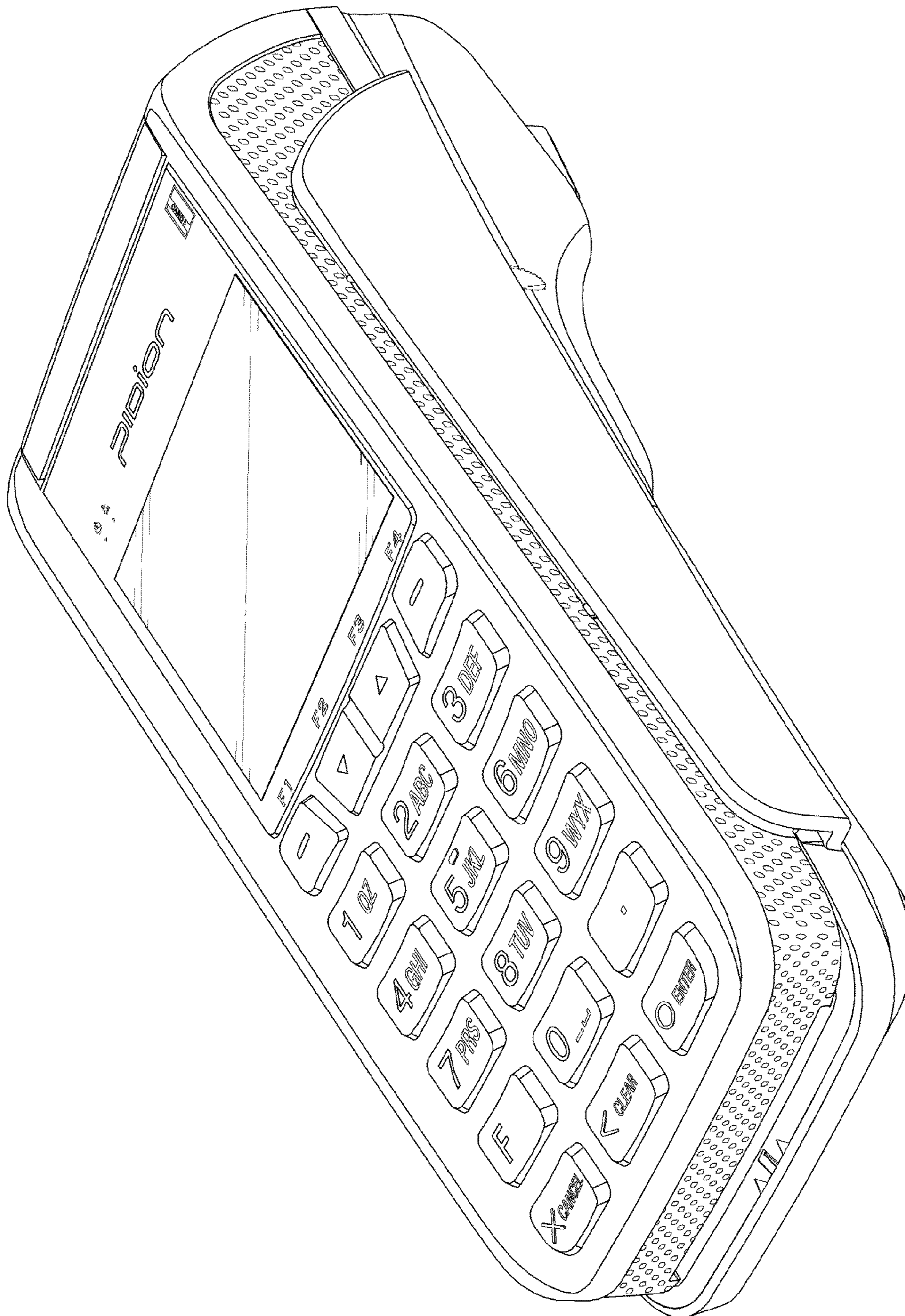

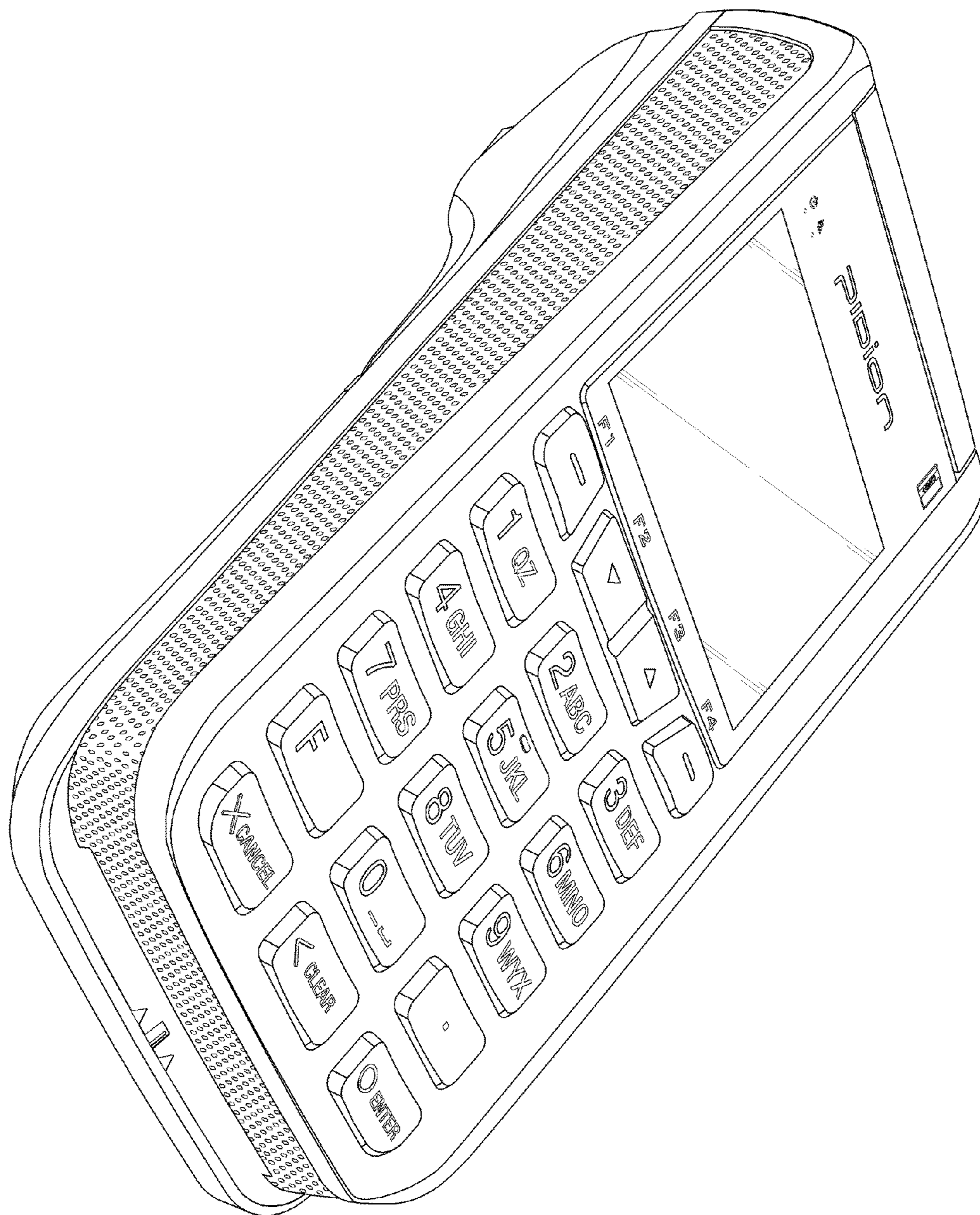

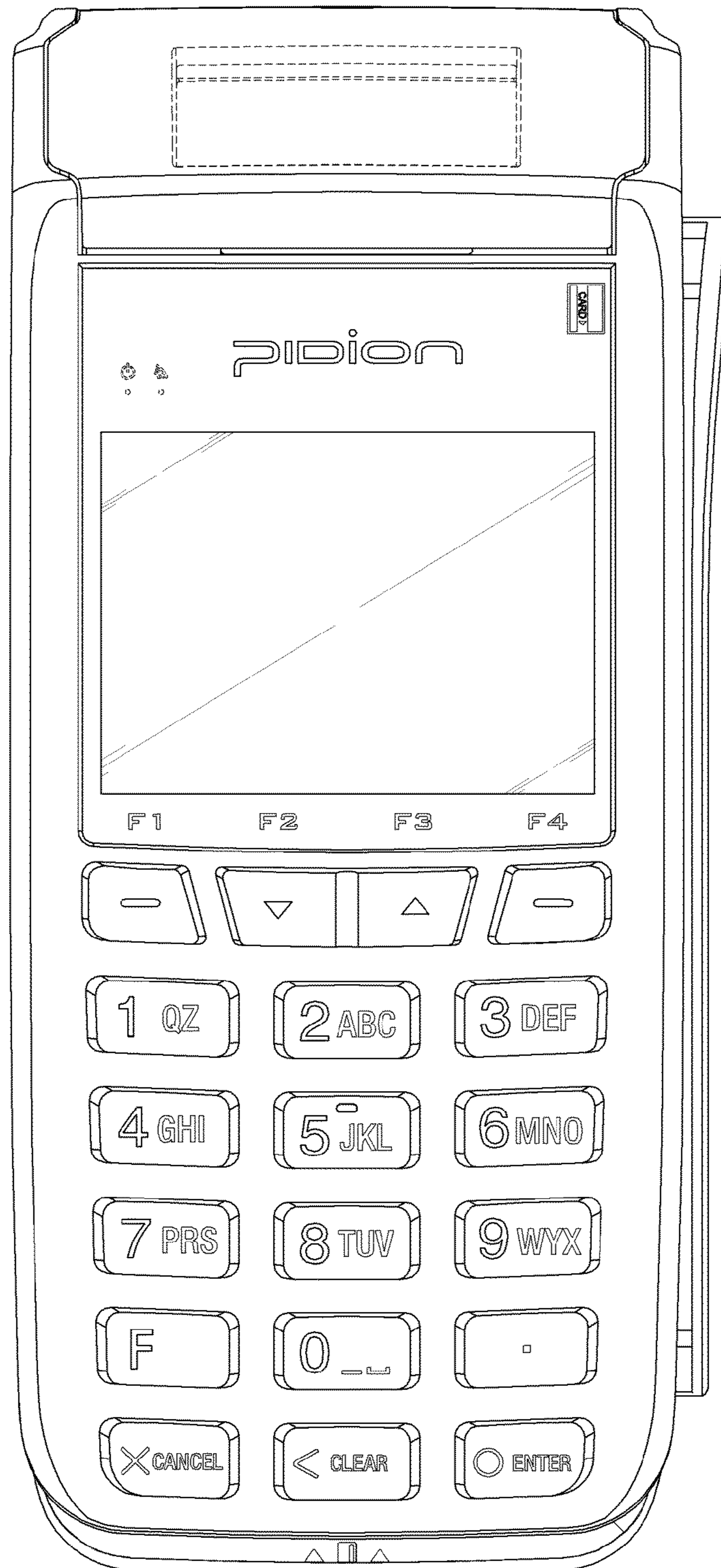

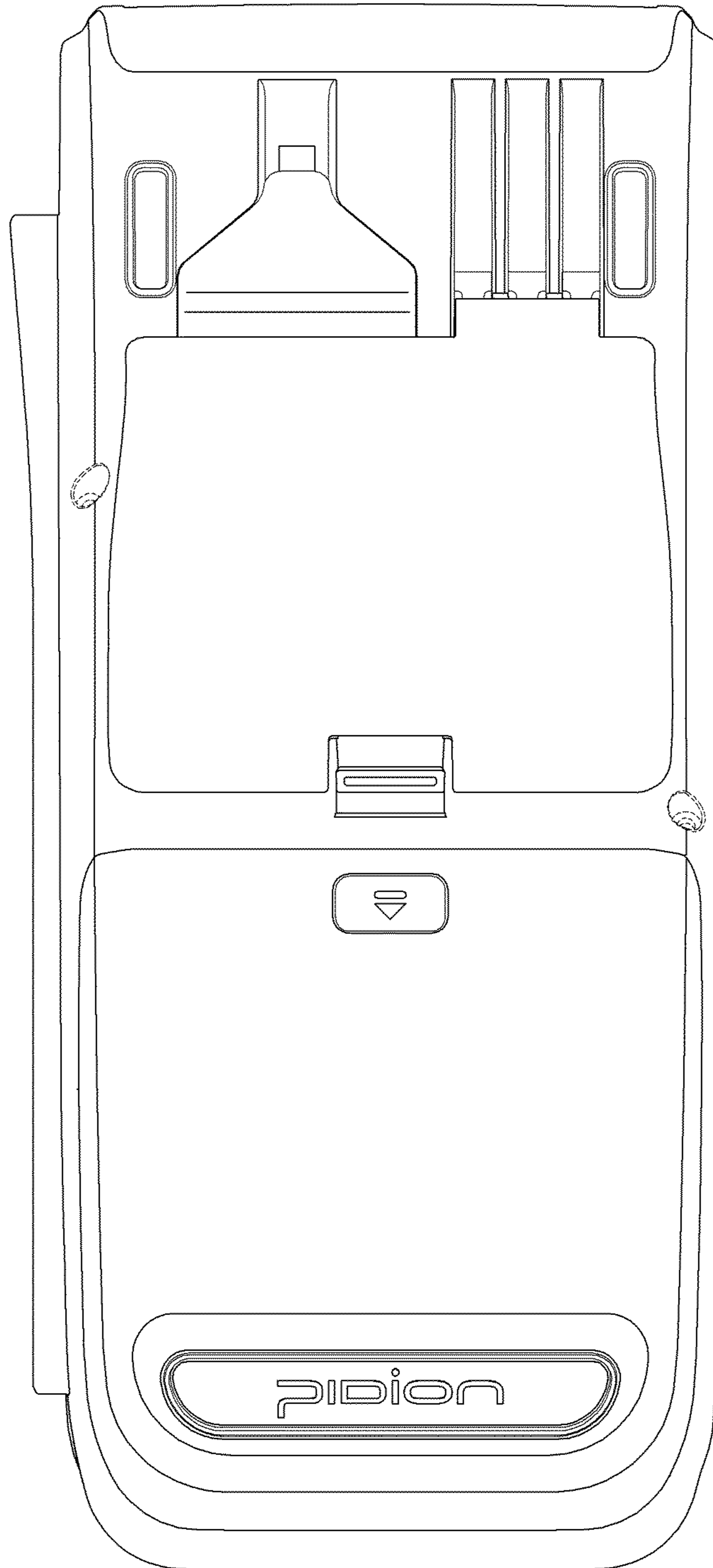

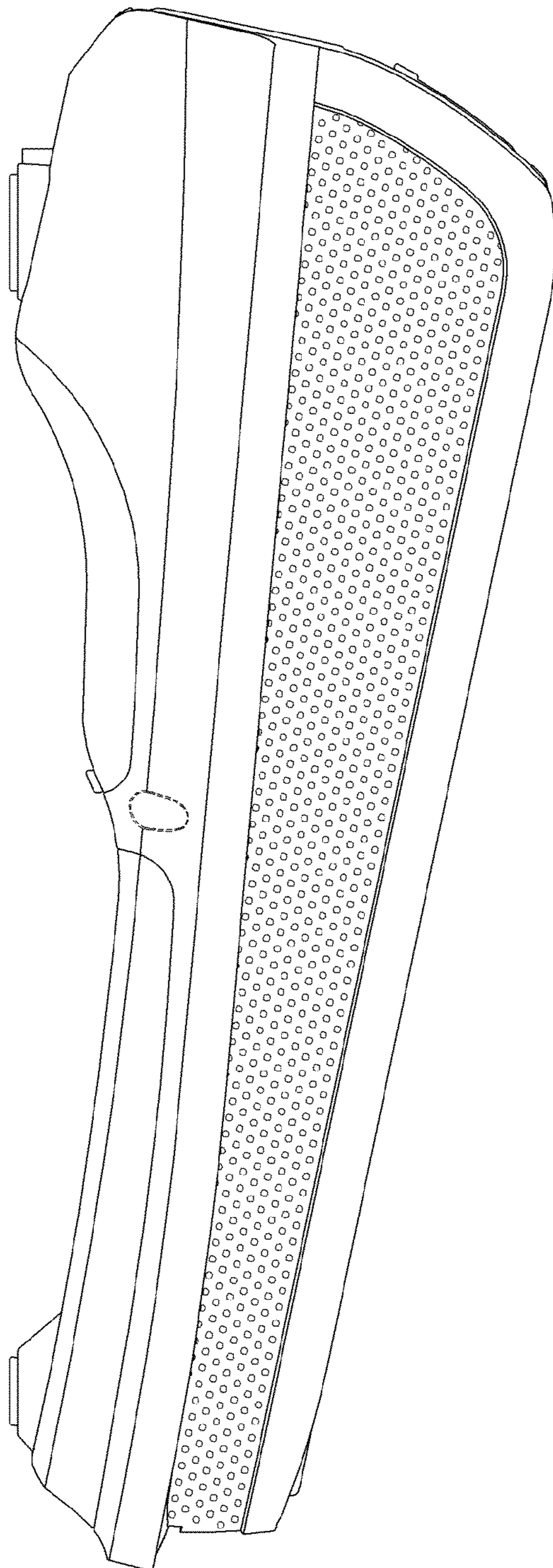

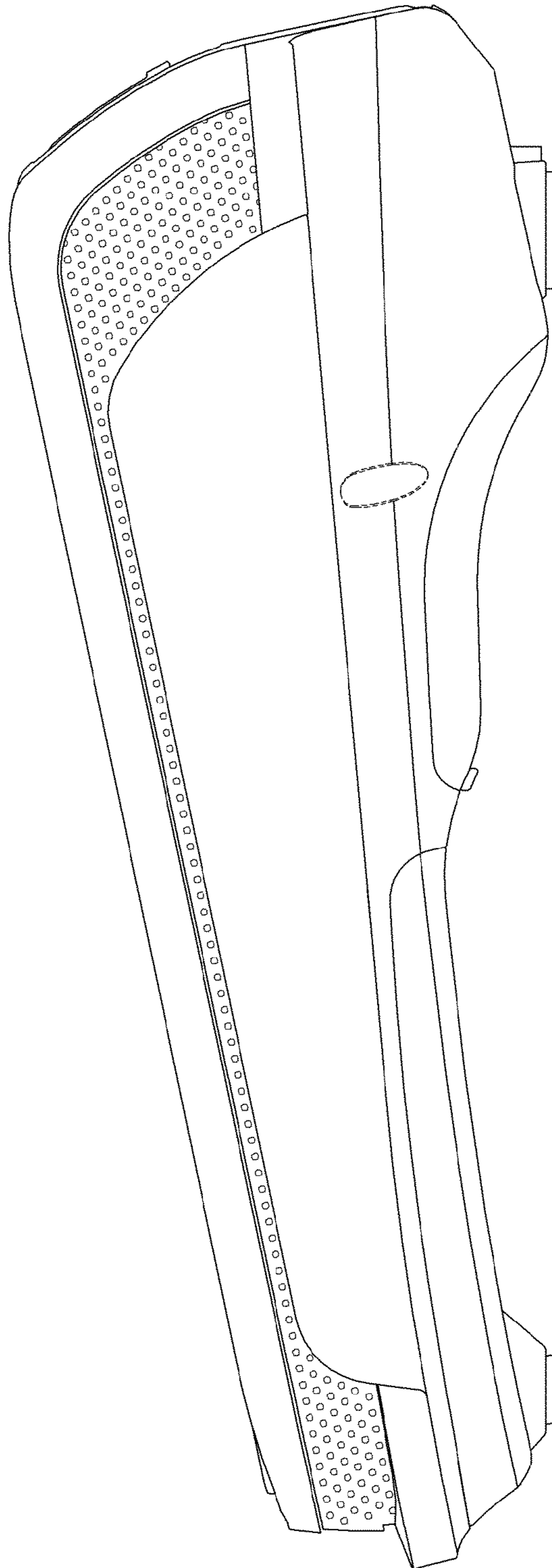

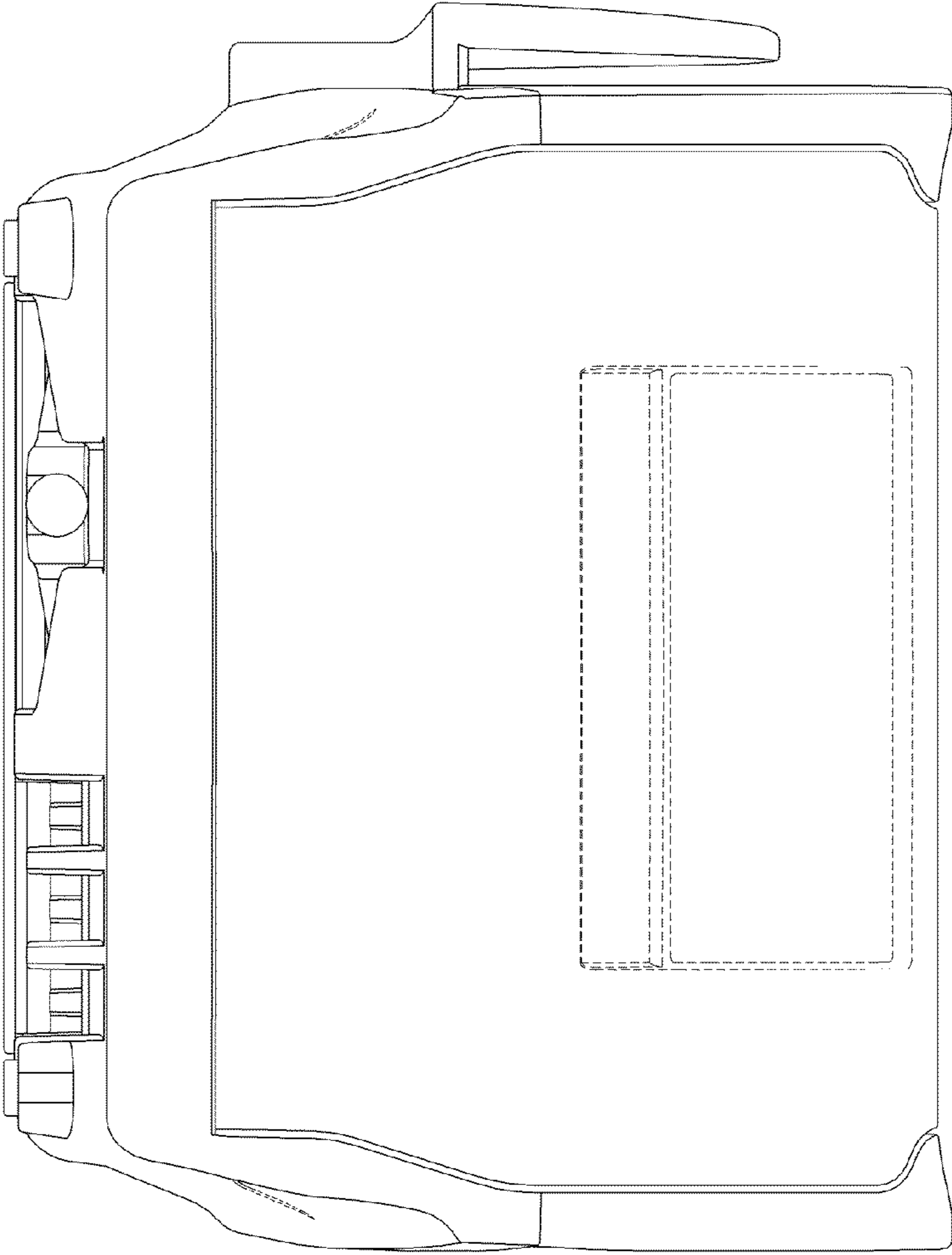
