DESCRIPTION

FIG. 1 is a front view of a transferrable label sheet showing our new design;

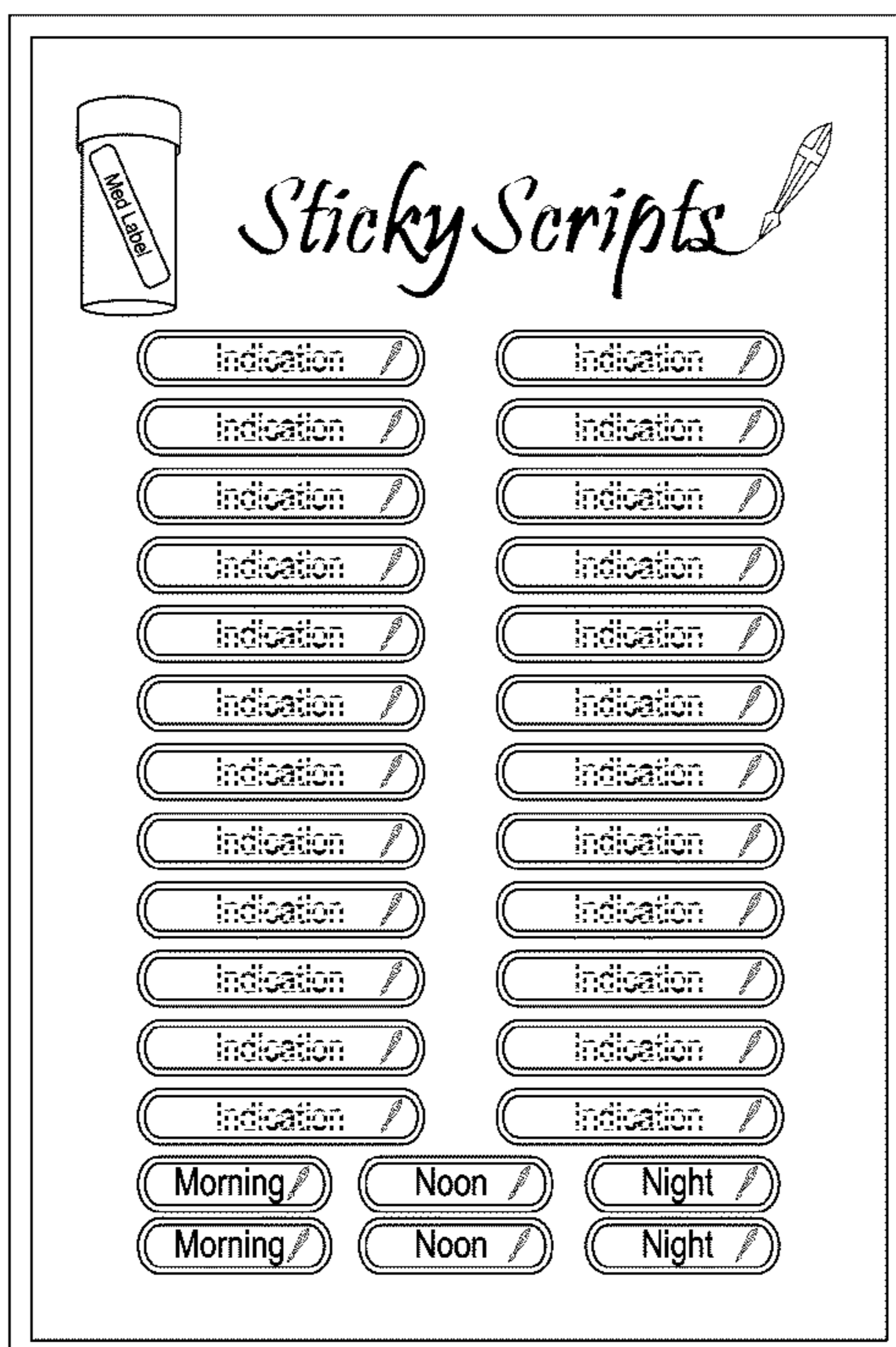

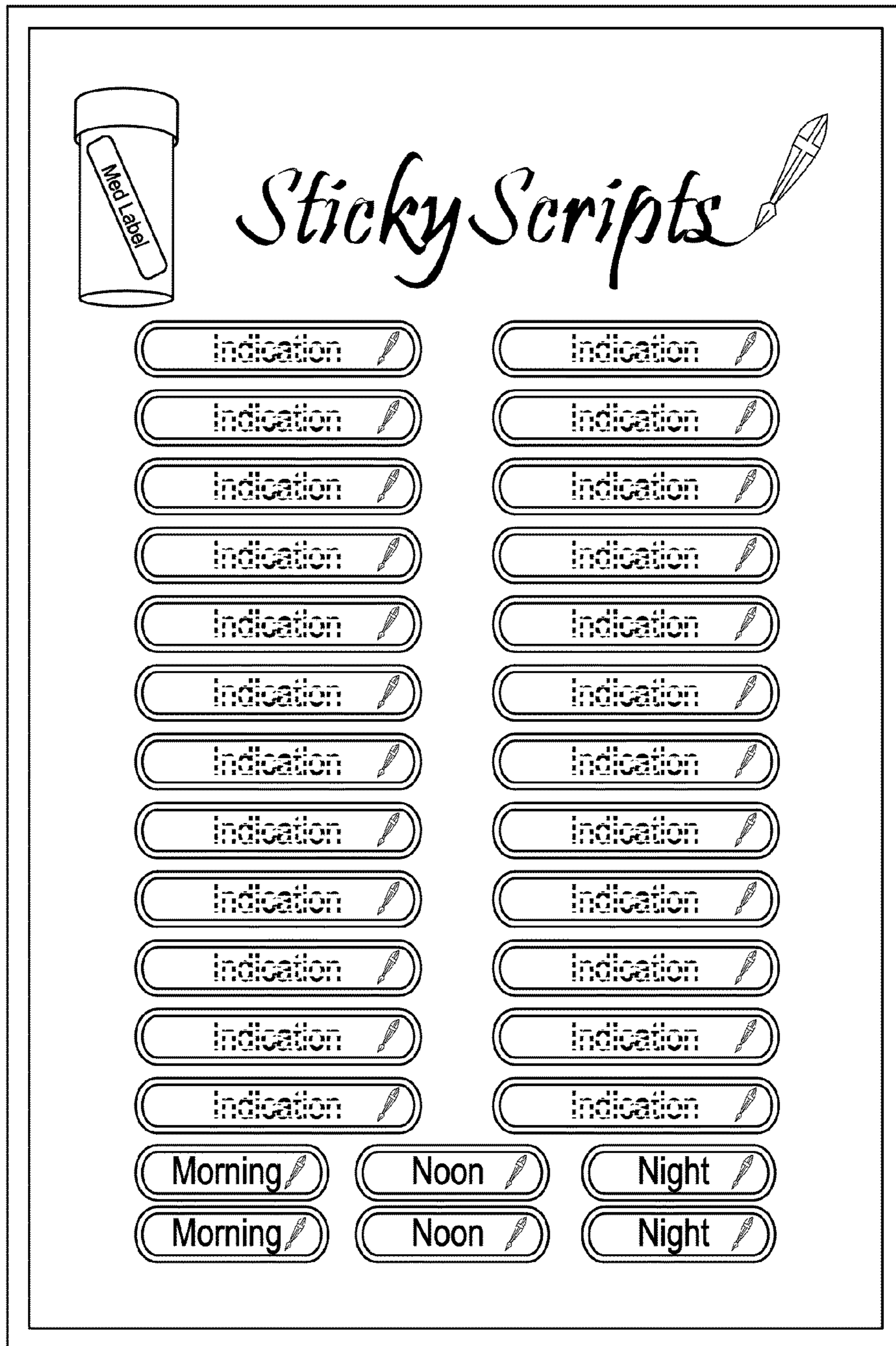

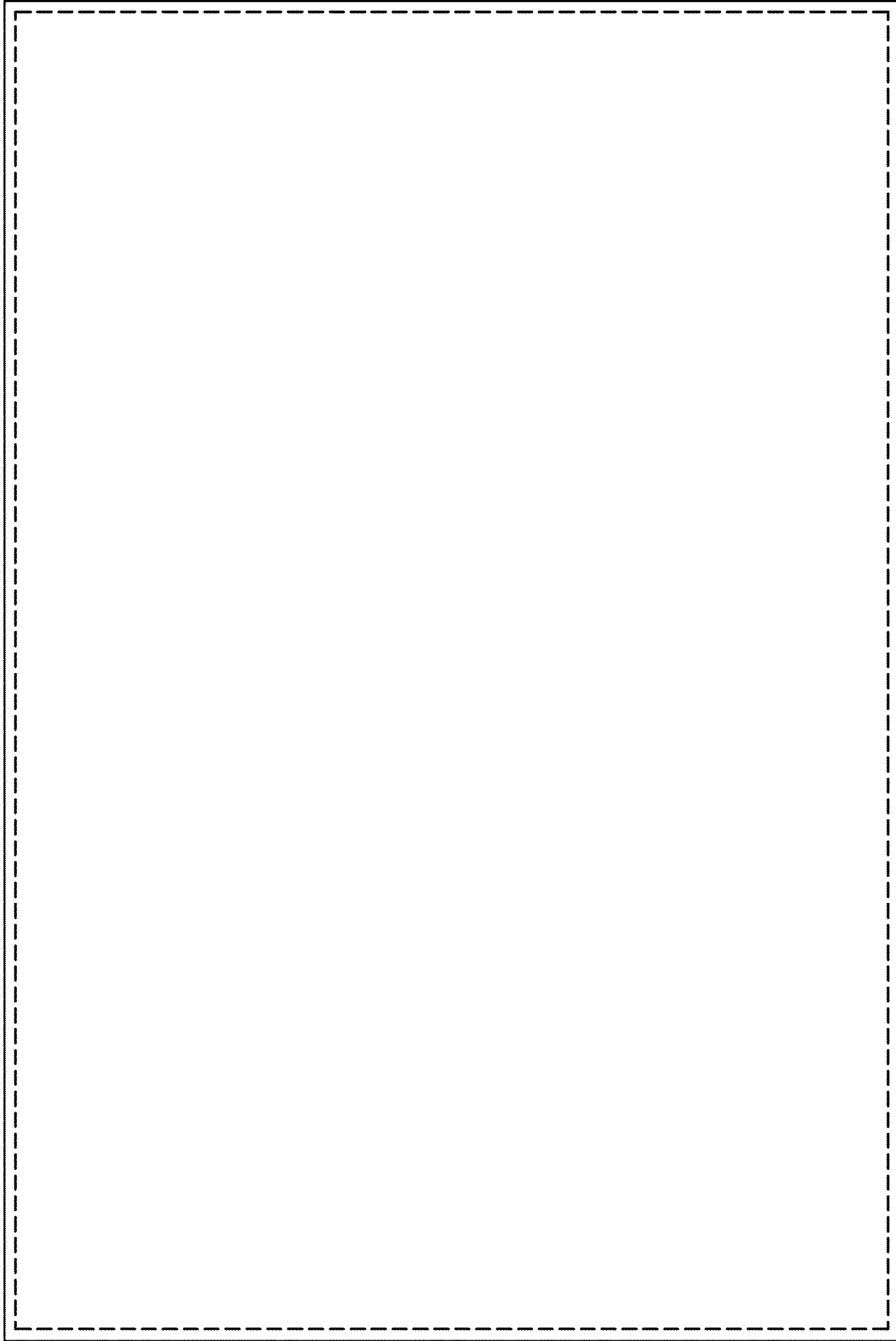
