**DESCRIPTION**

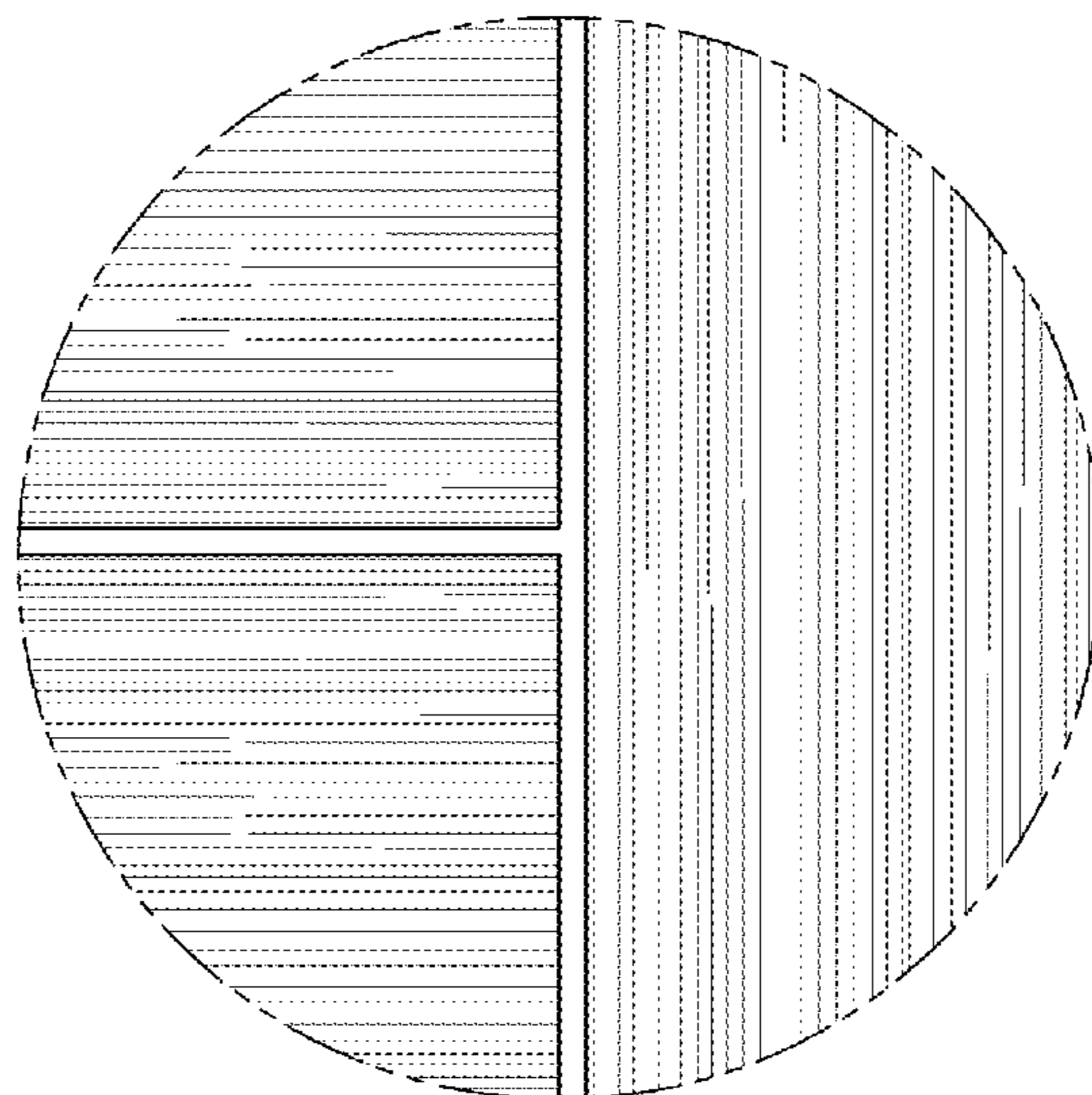

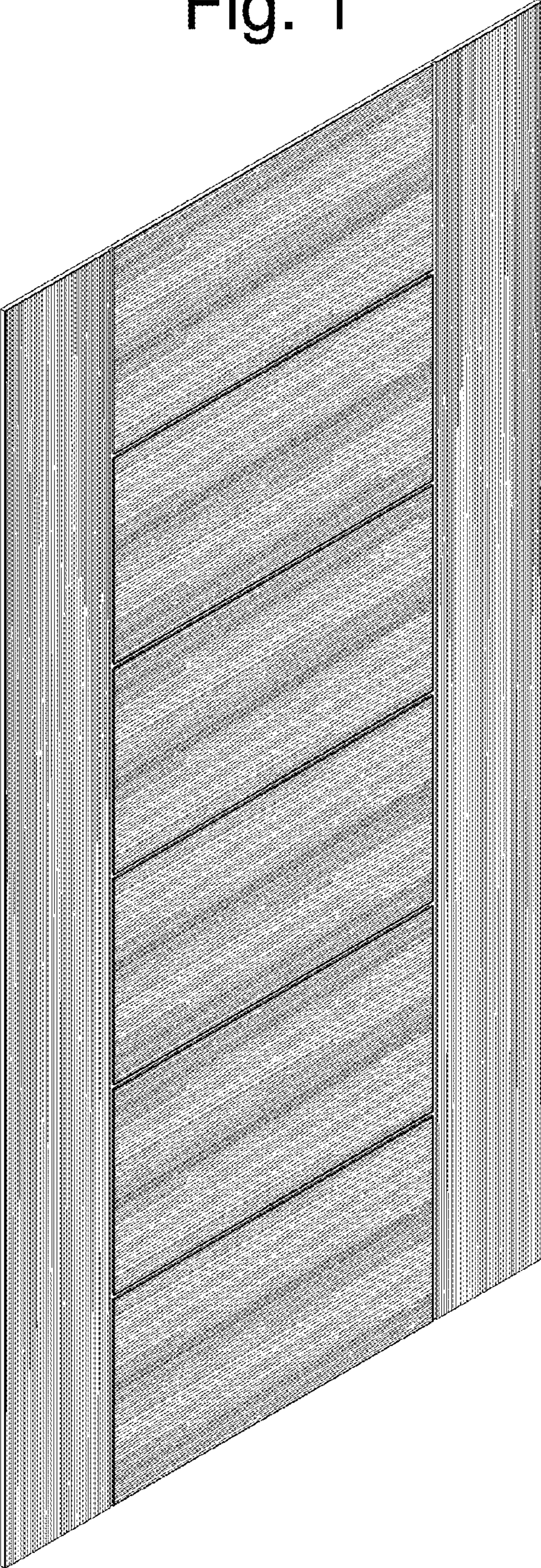

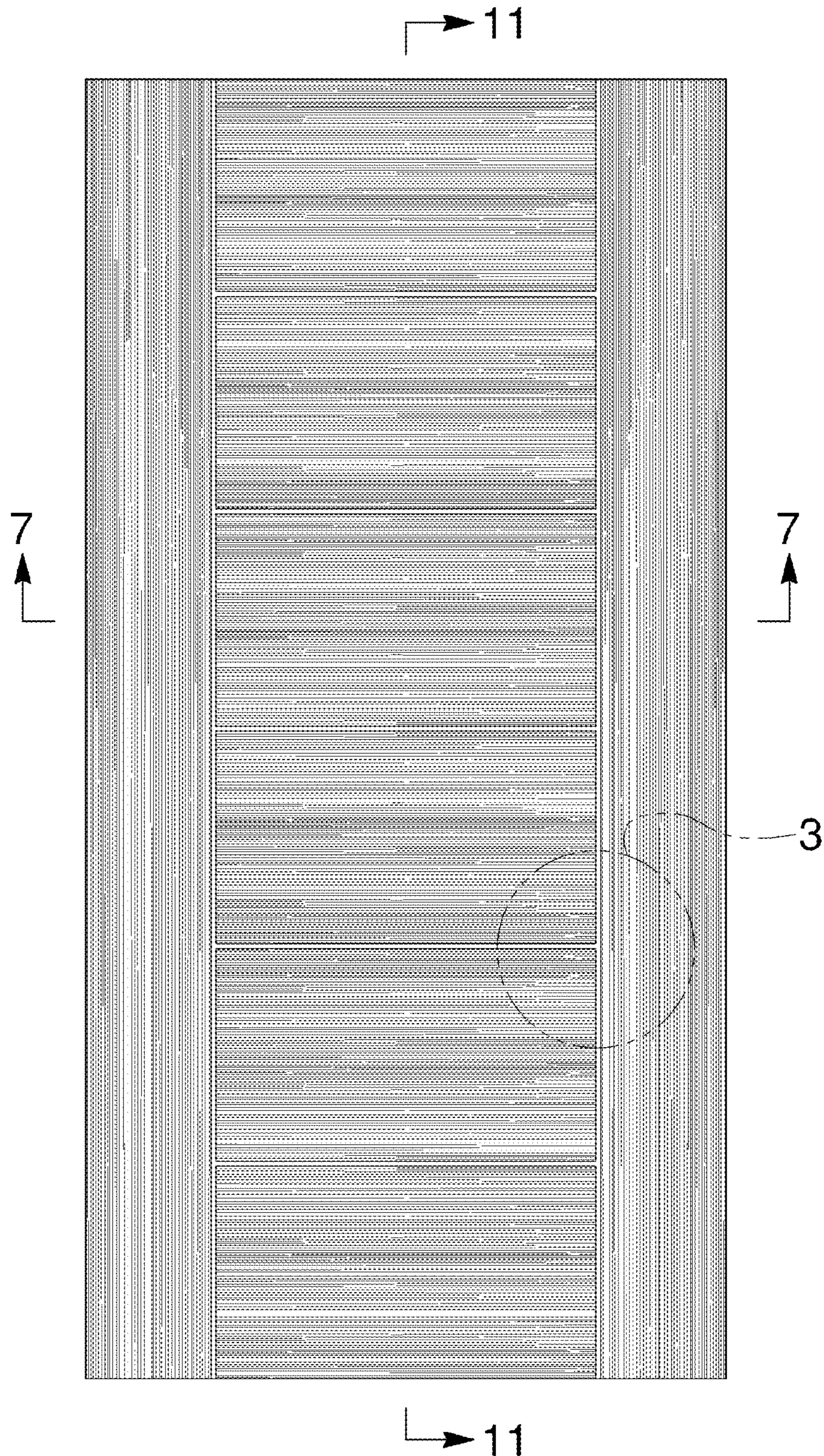

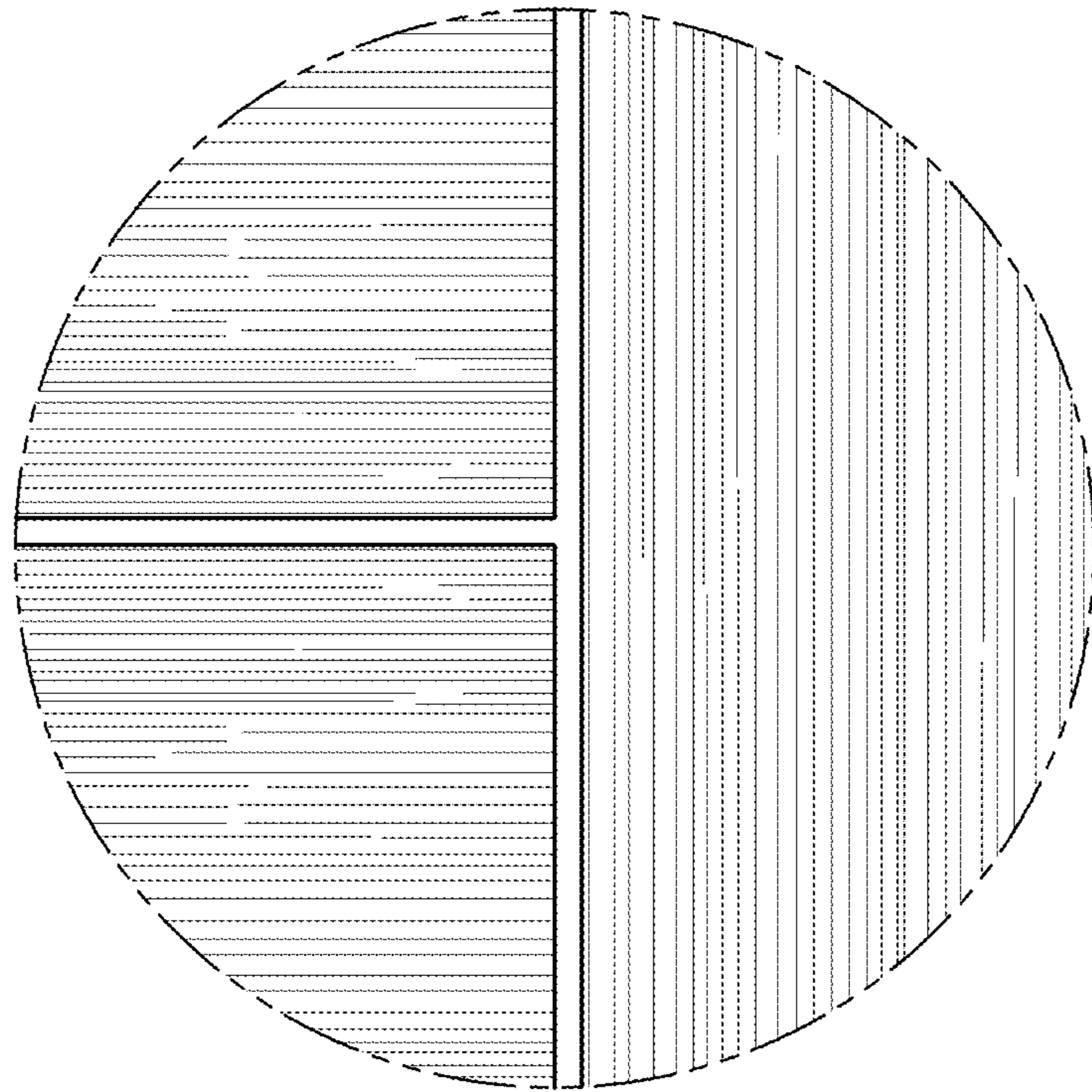

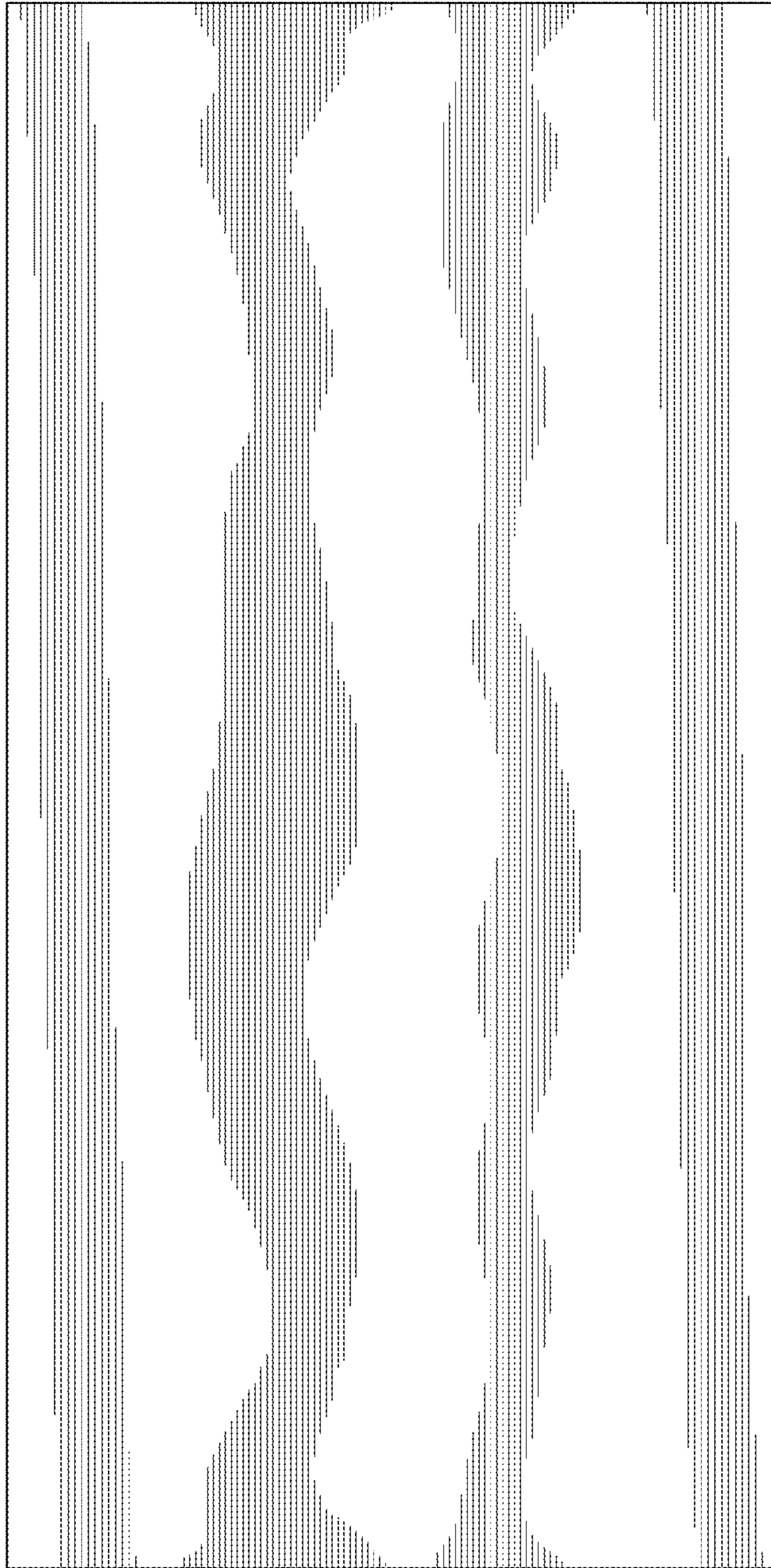

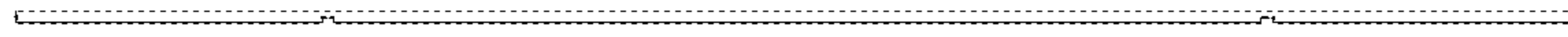

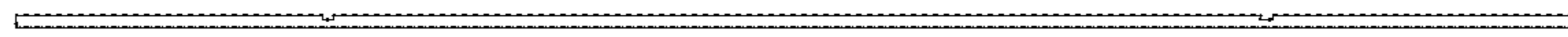

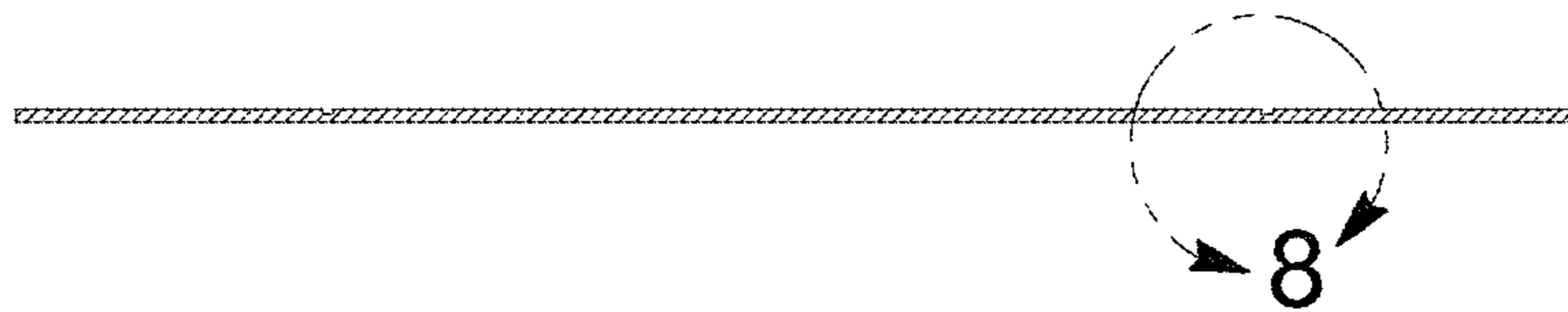

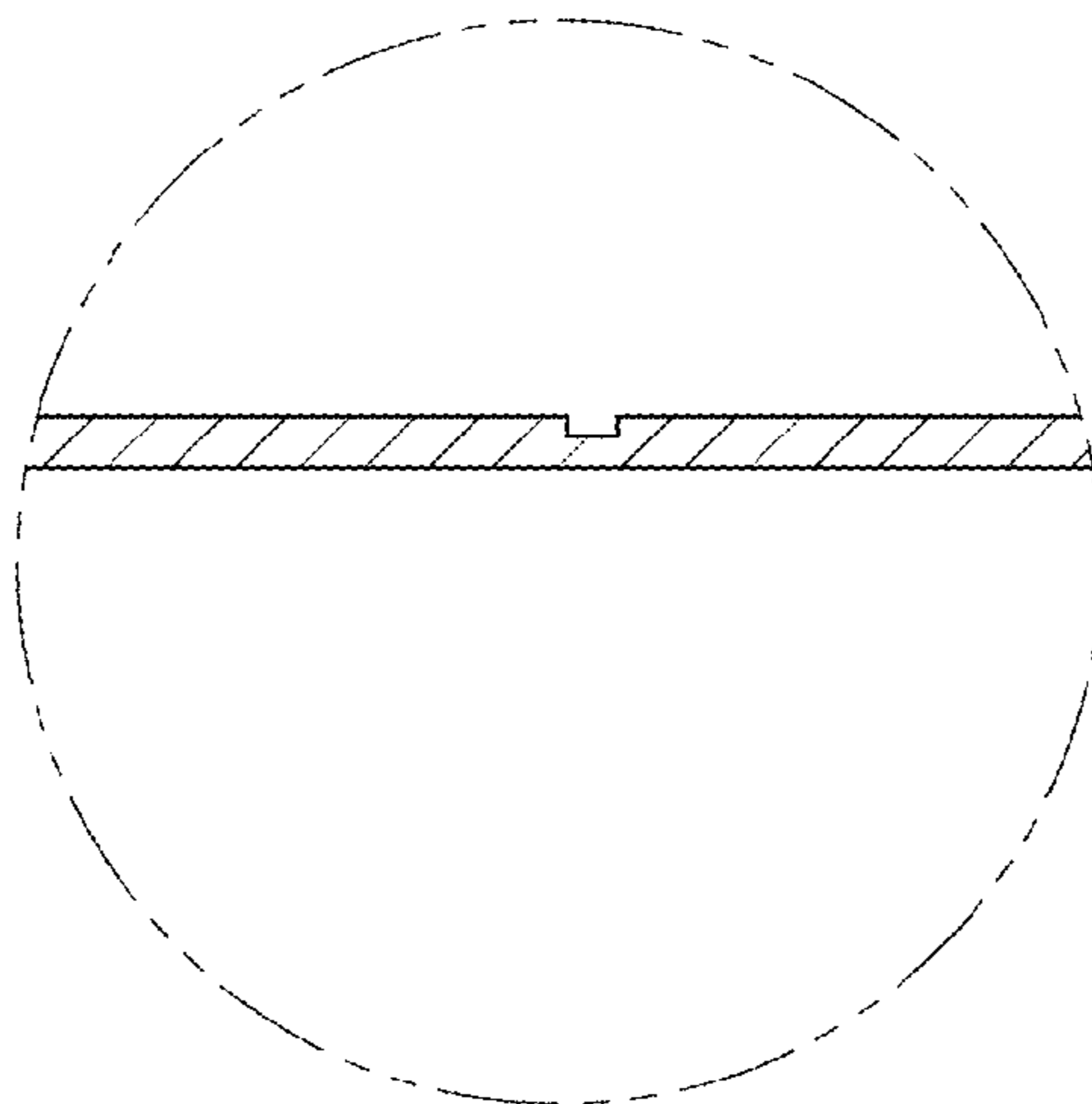

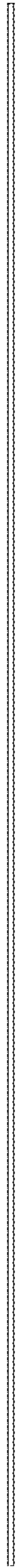

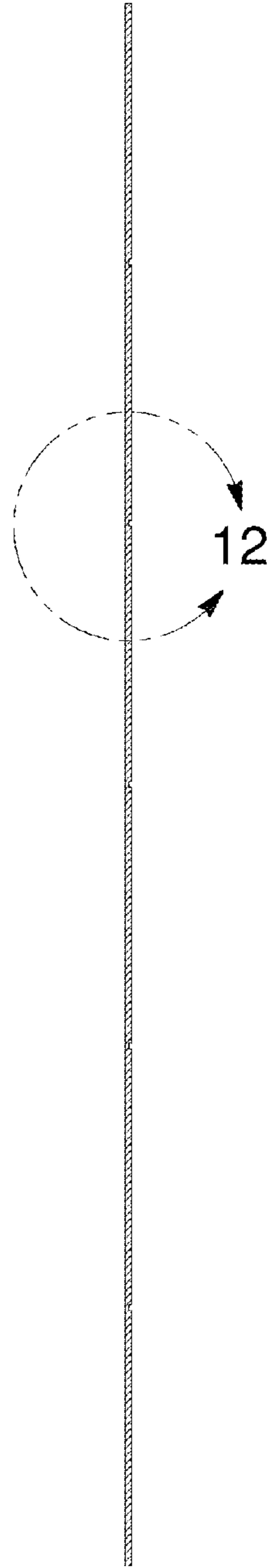

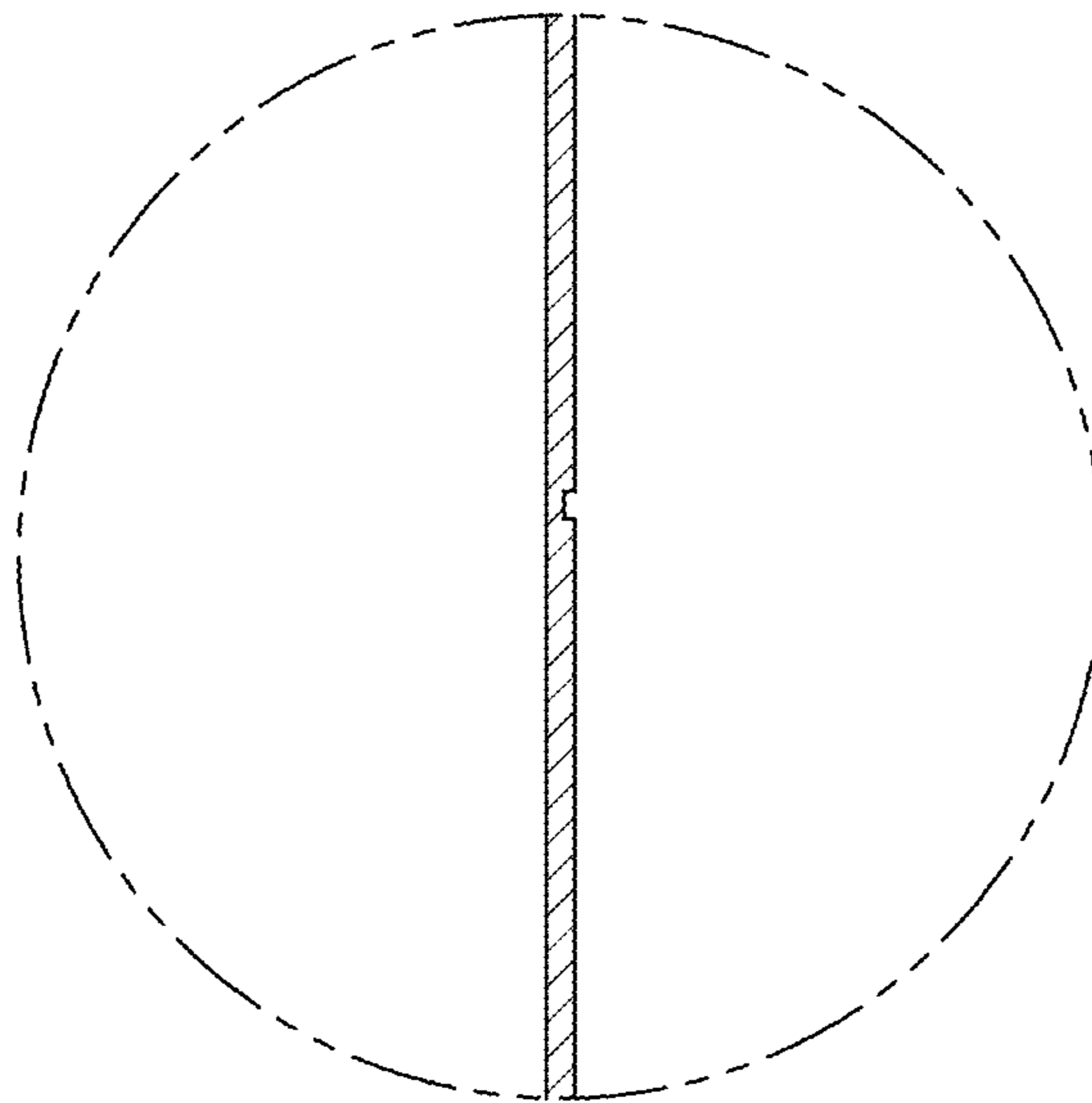

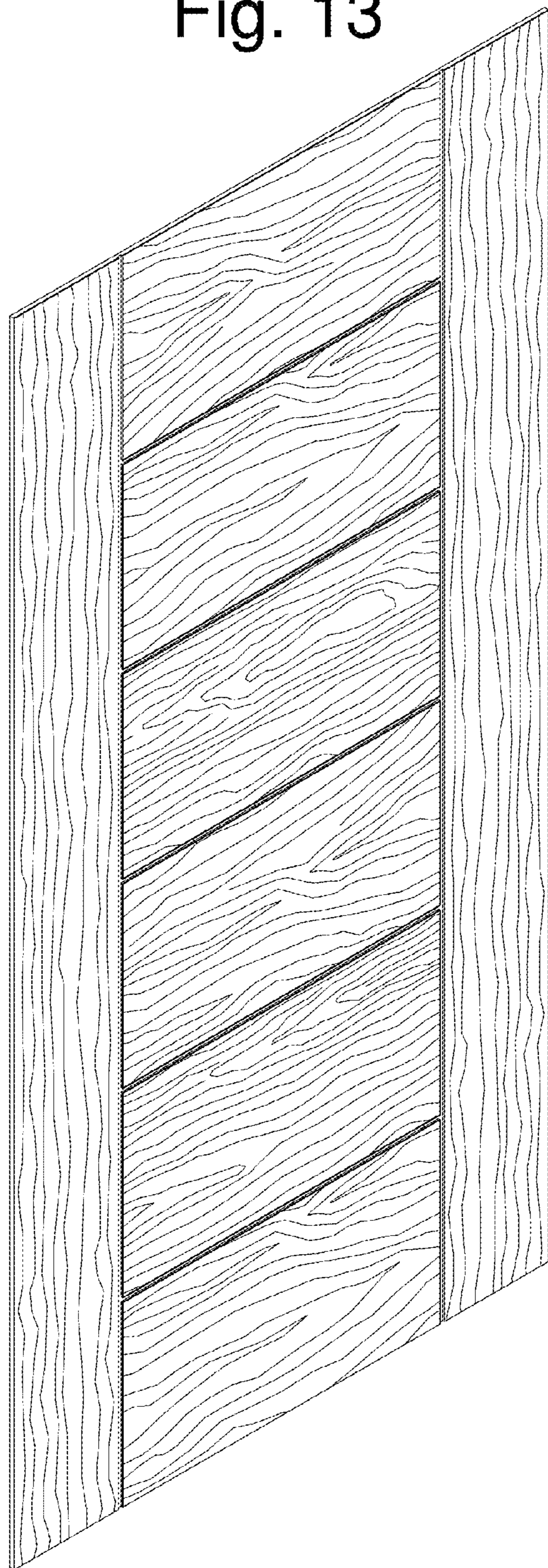

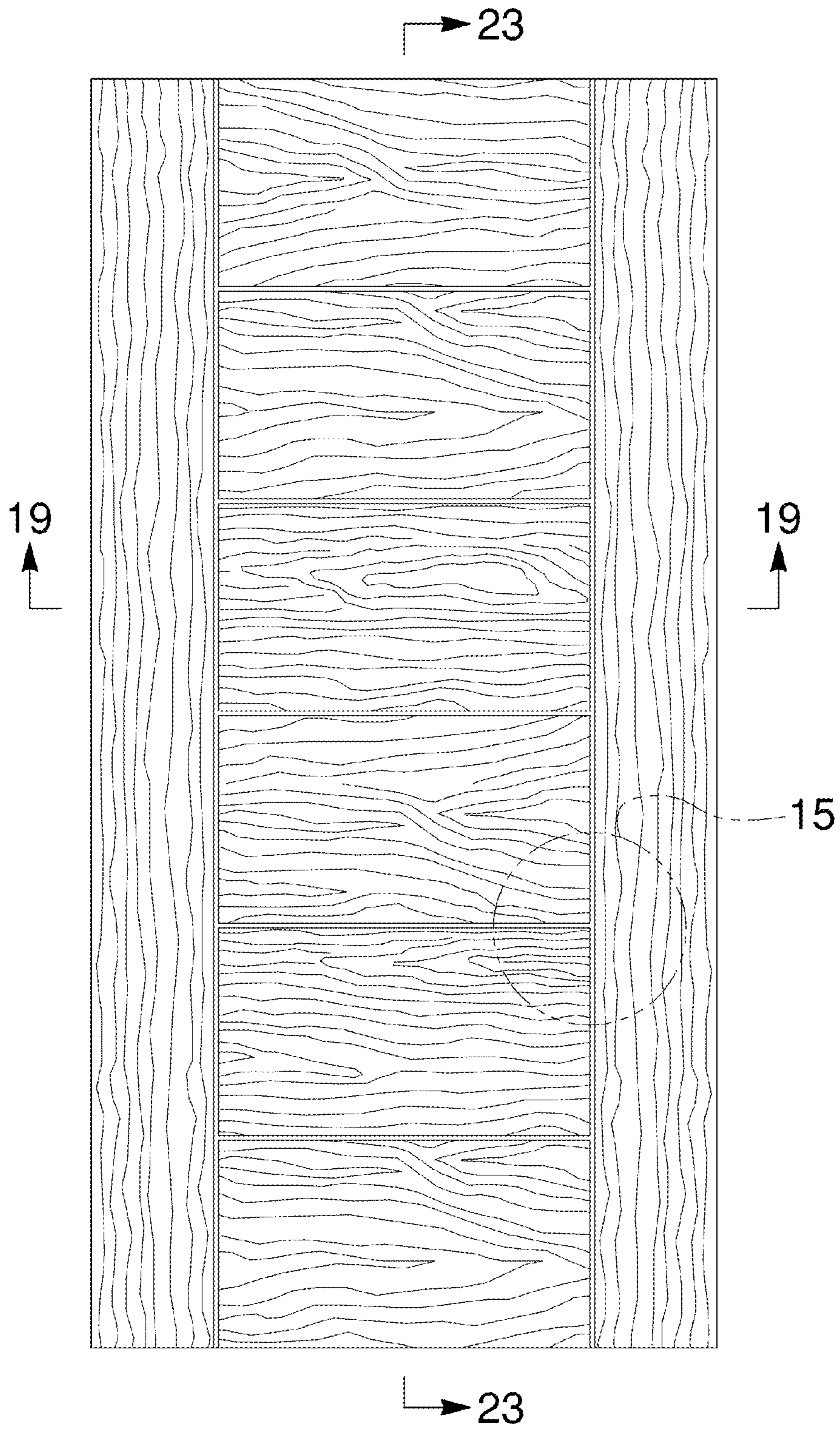

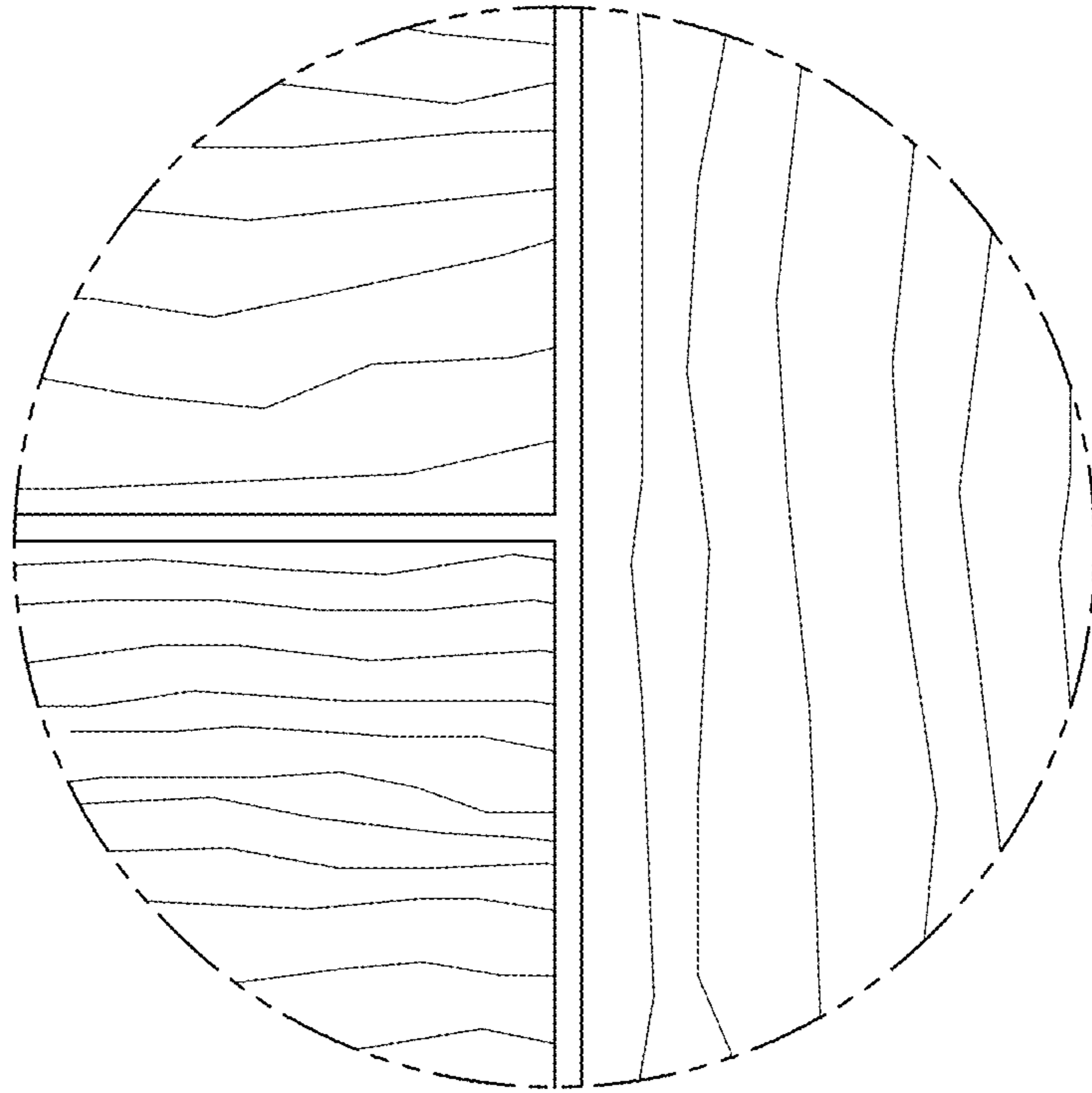

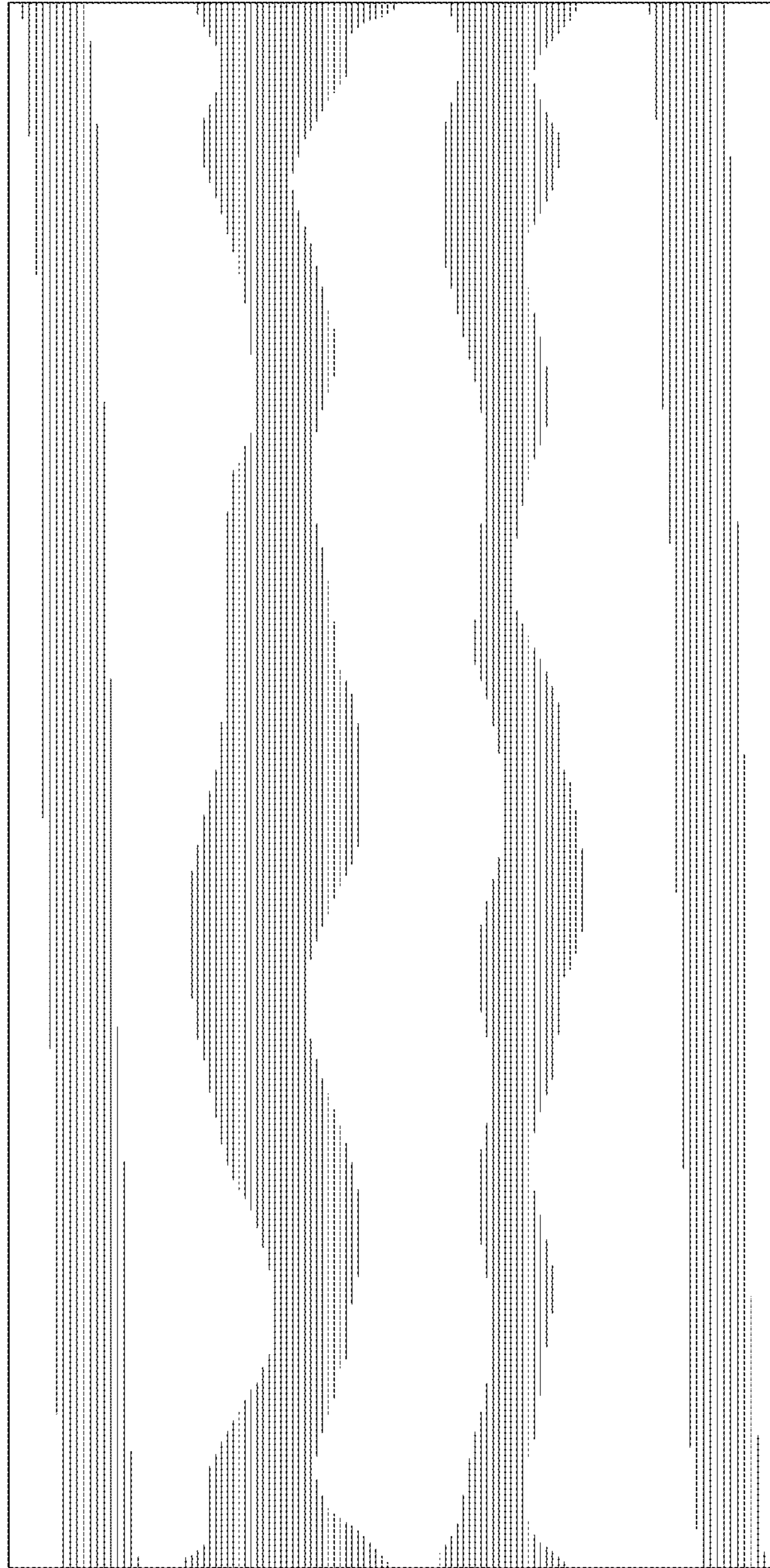

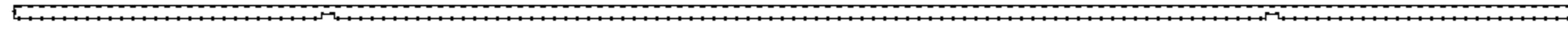

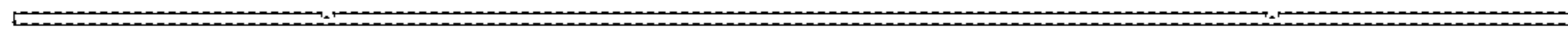

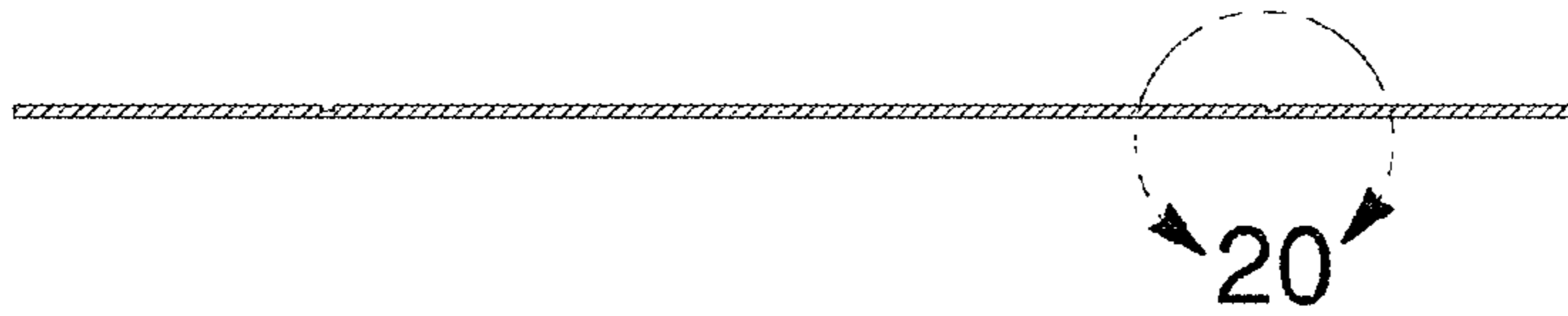

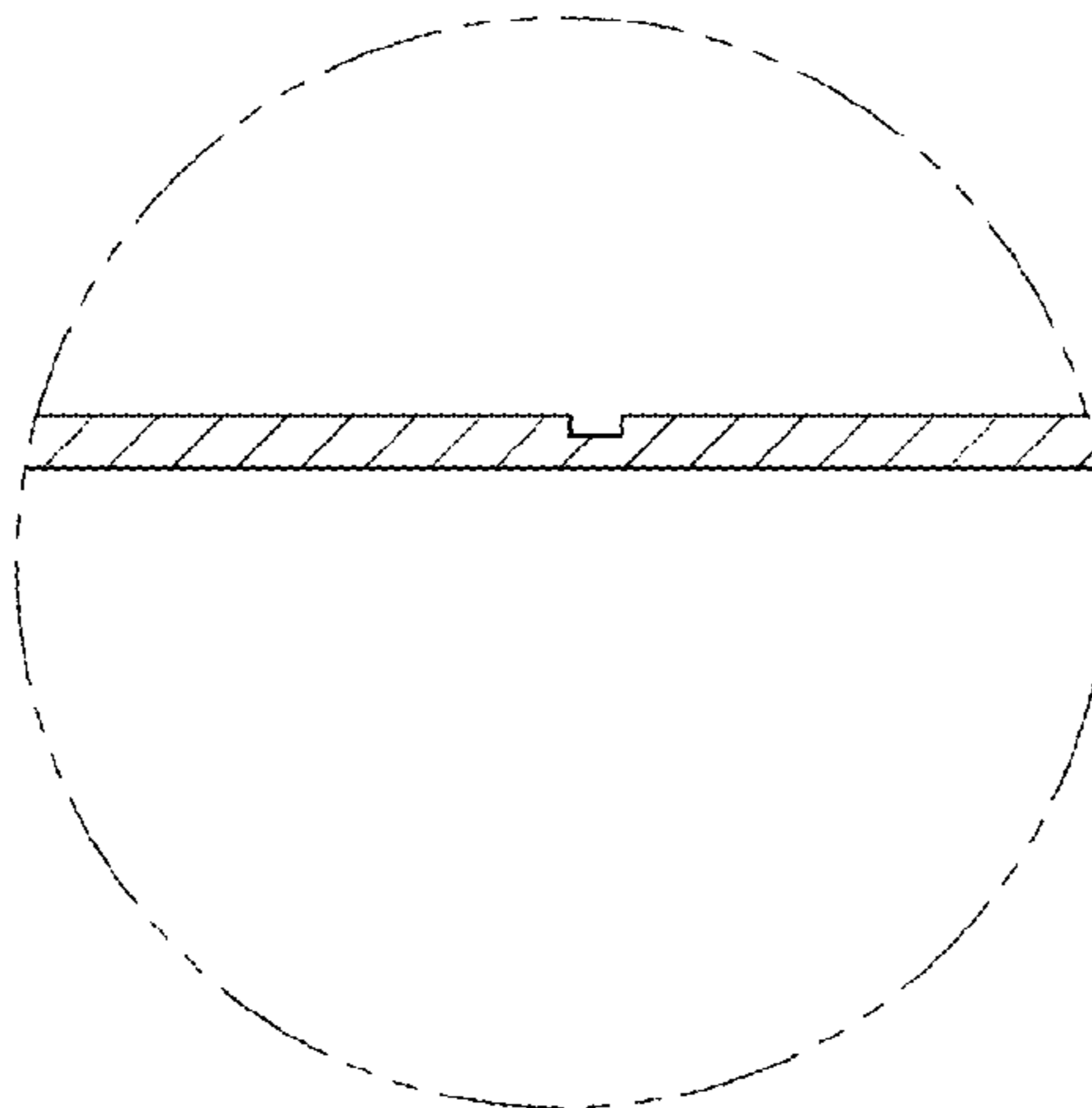

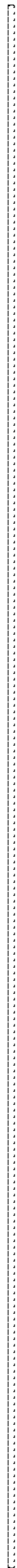

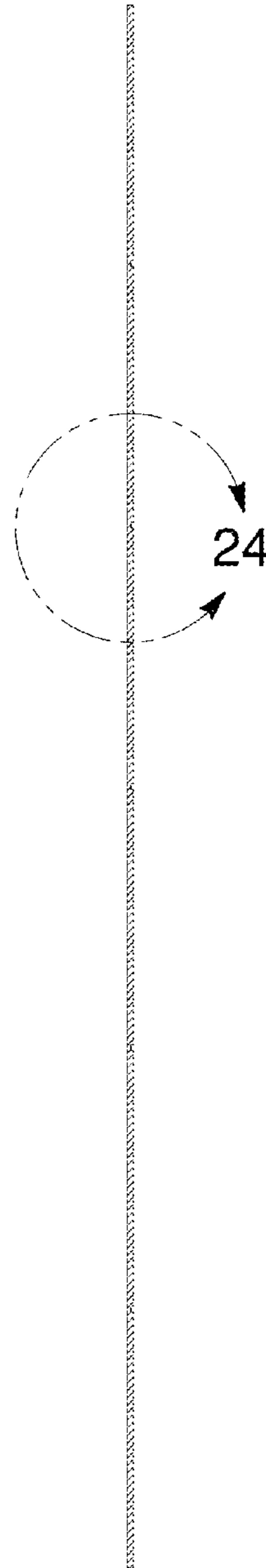
