**DESCRIPTION**

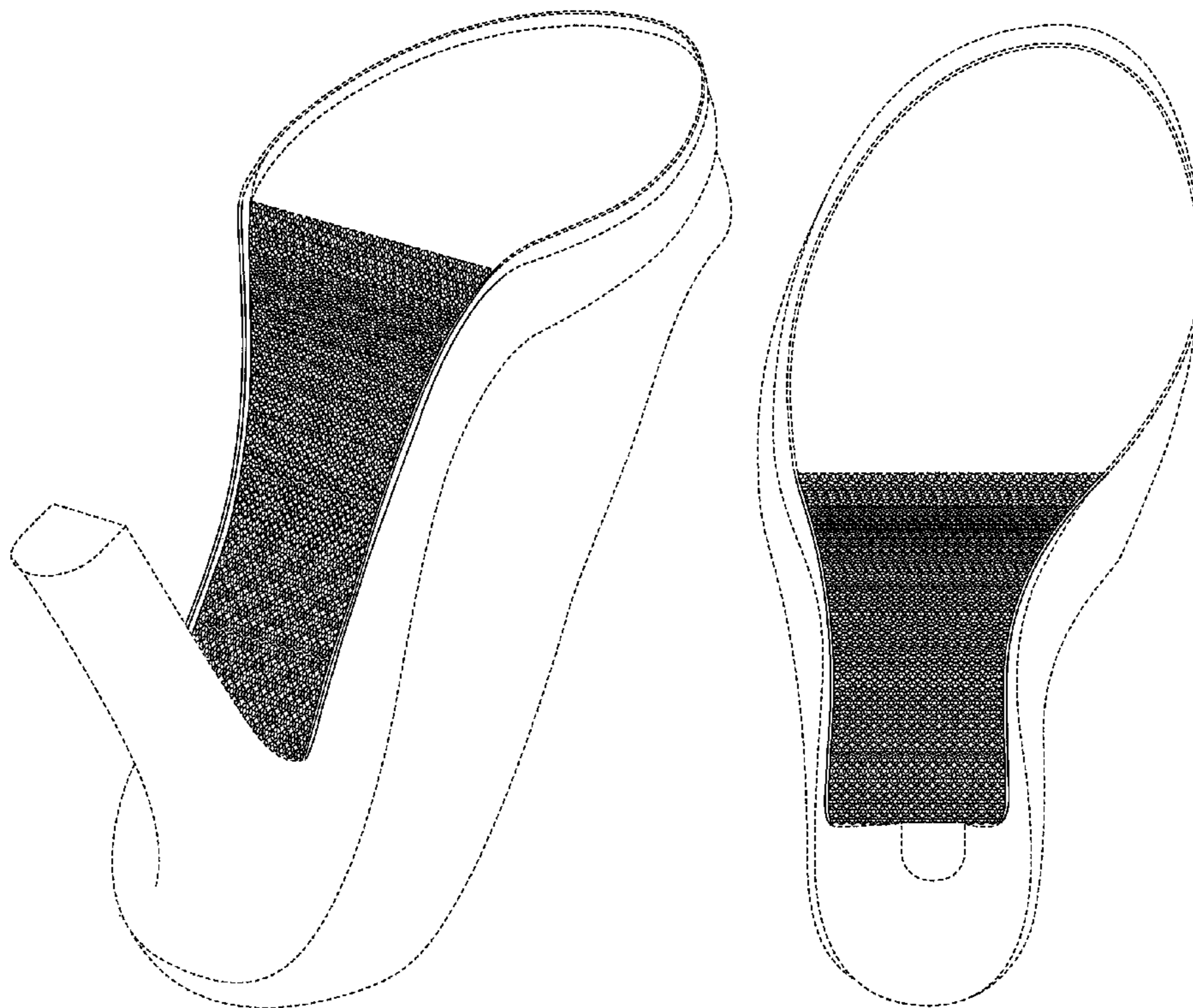
FIG. 1 is a bottom perspective view of the shoe with decorative sole of my new design;

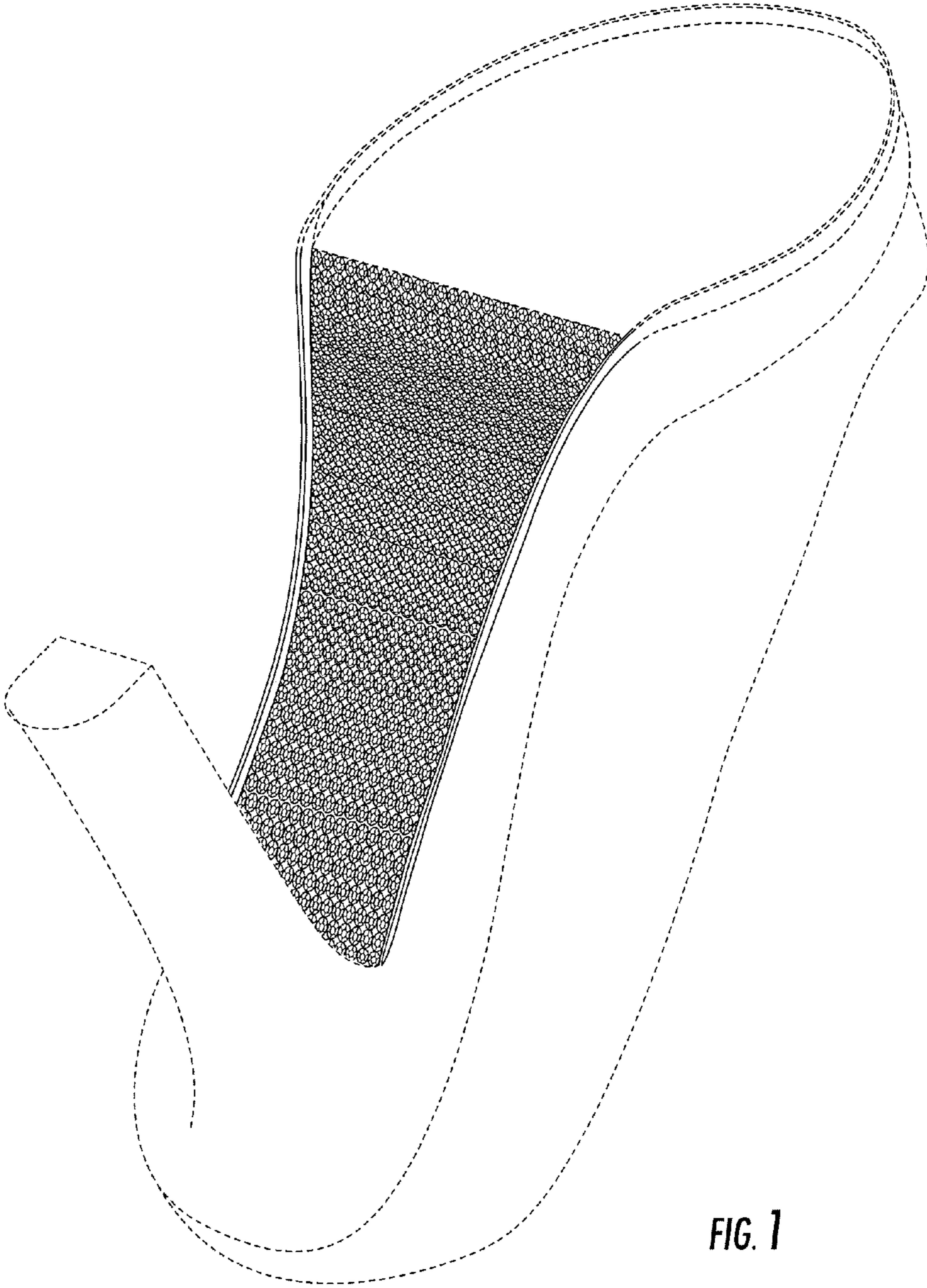

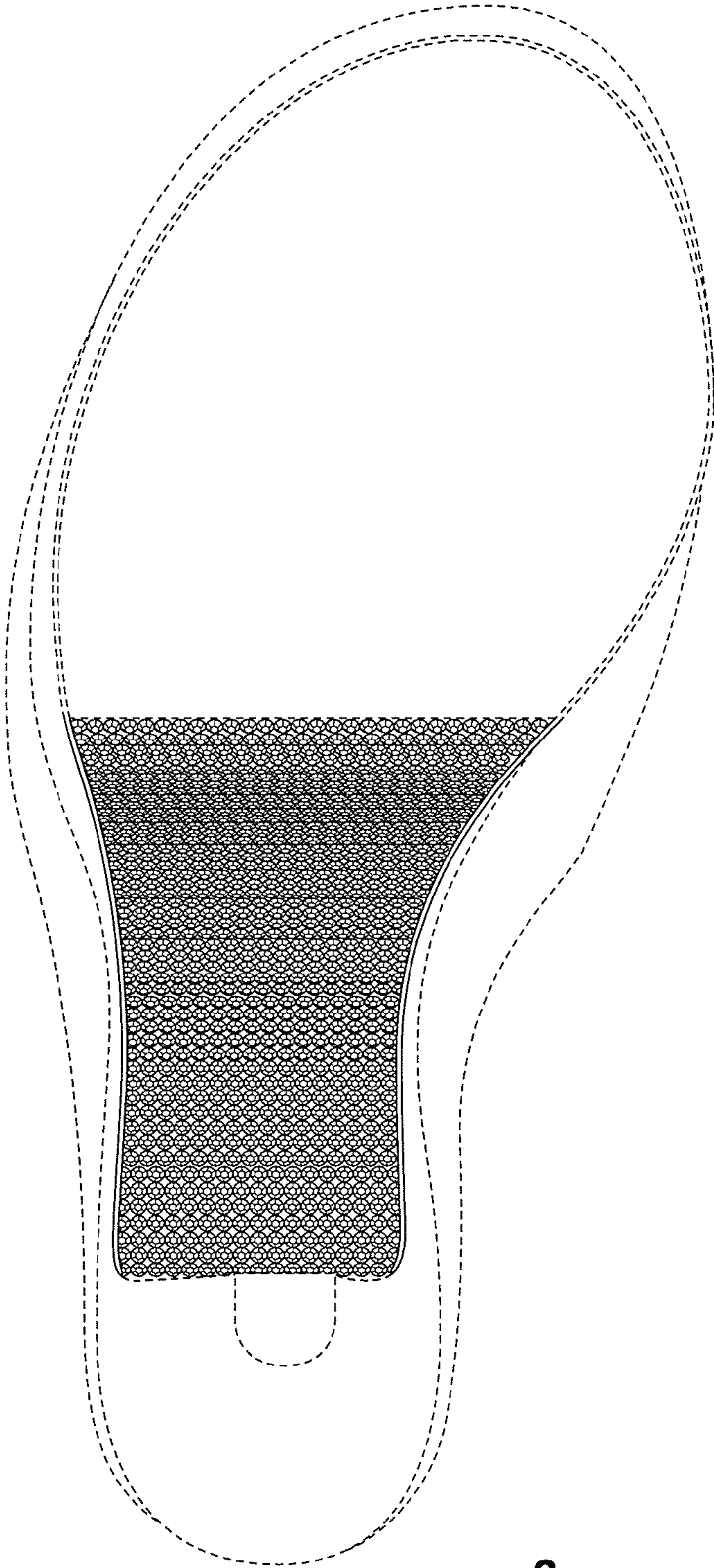
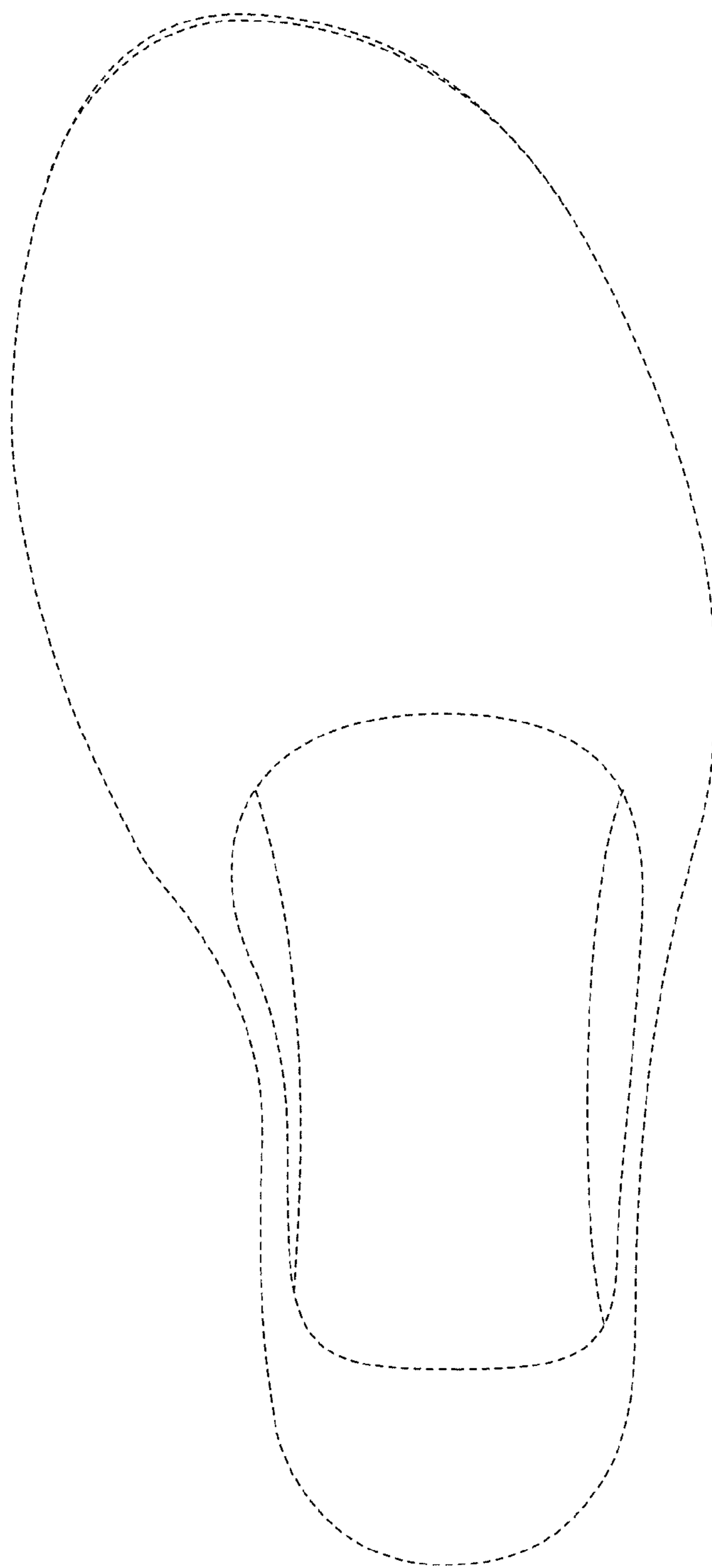

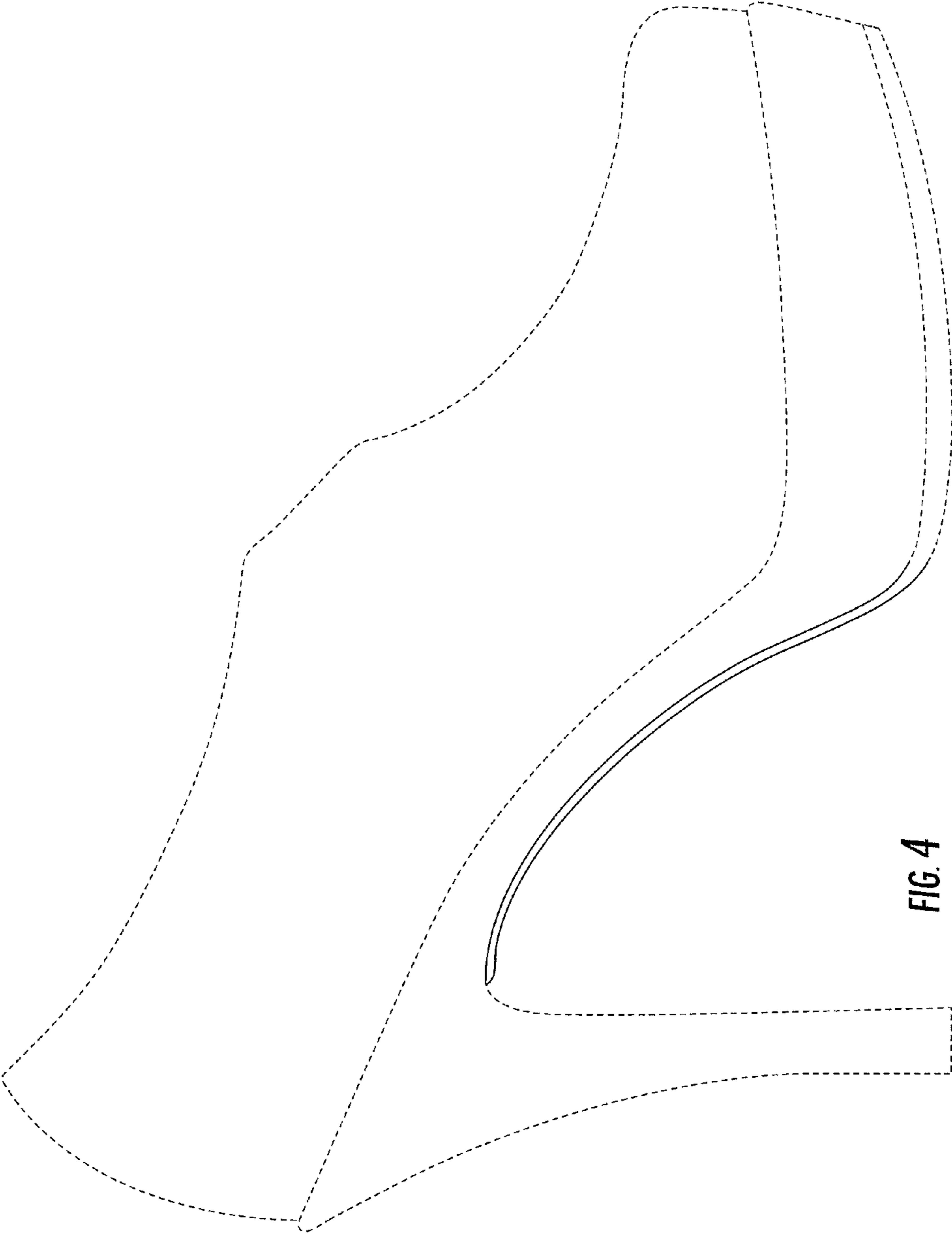

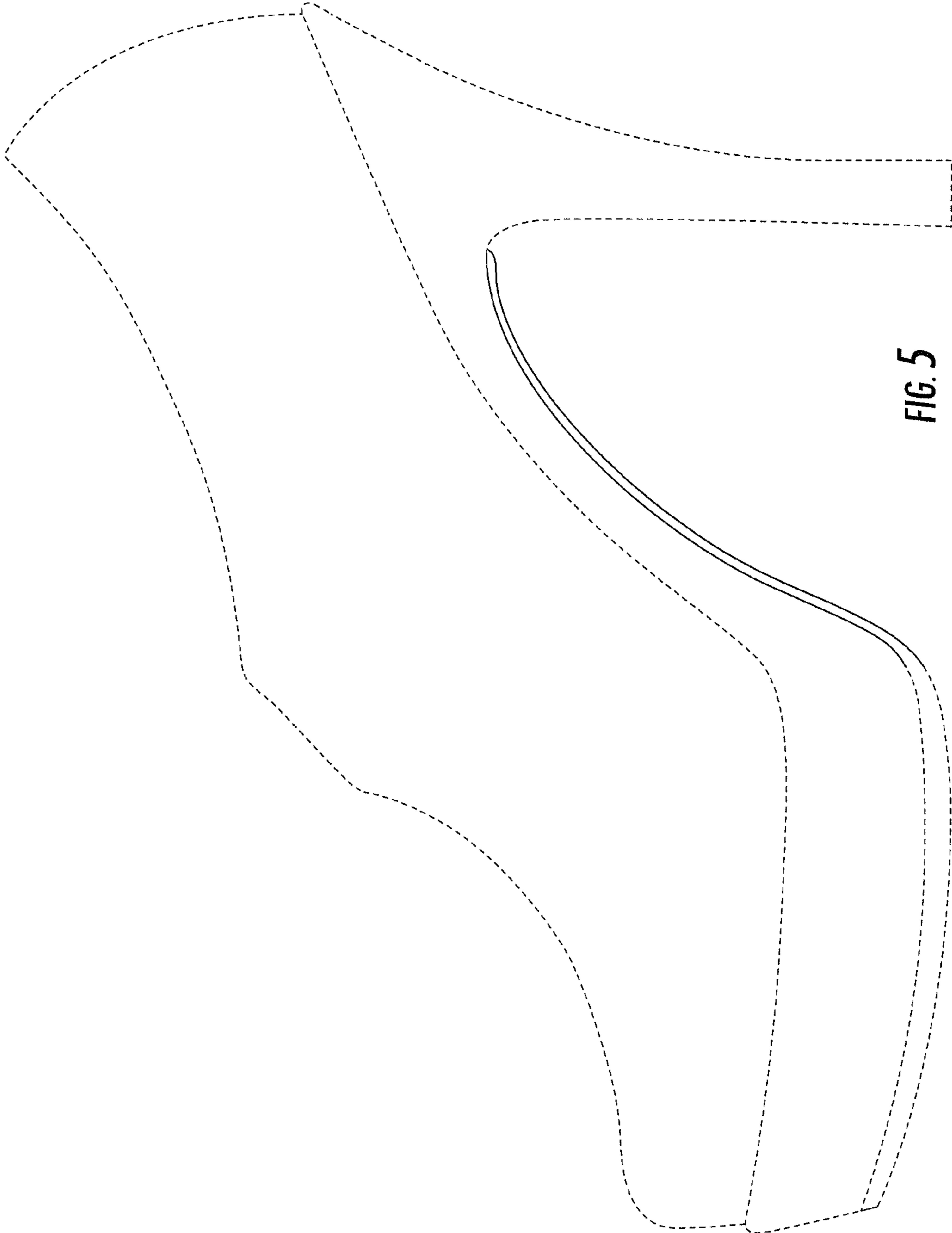

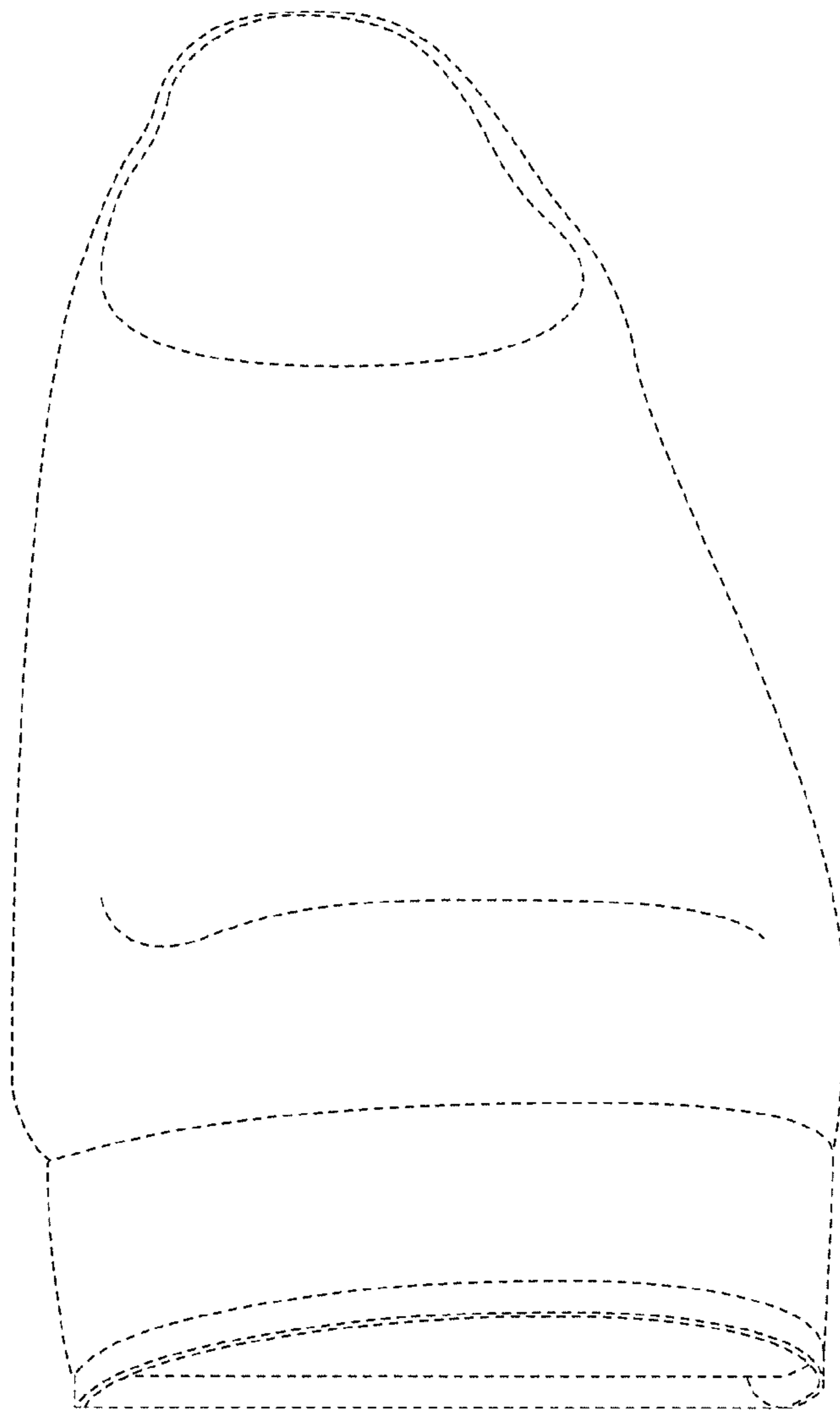

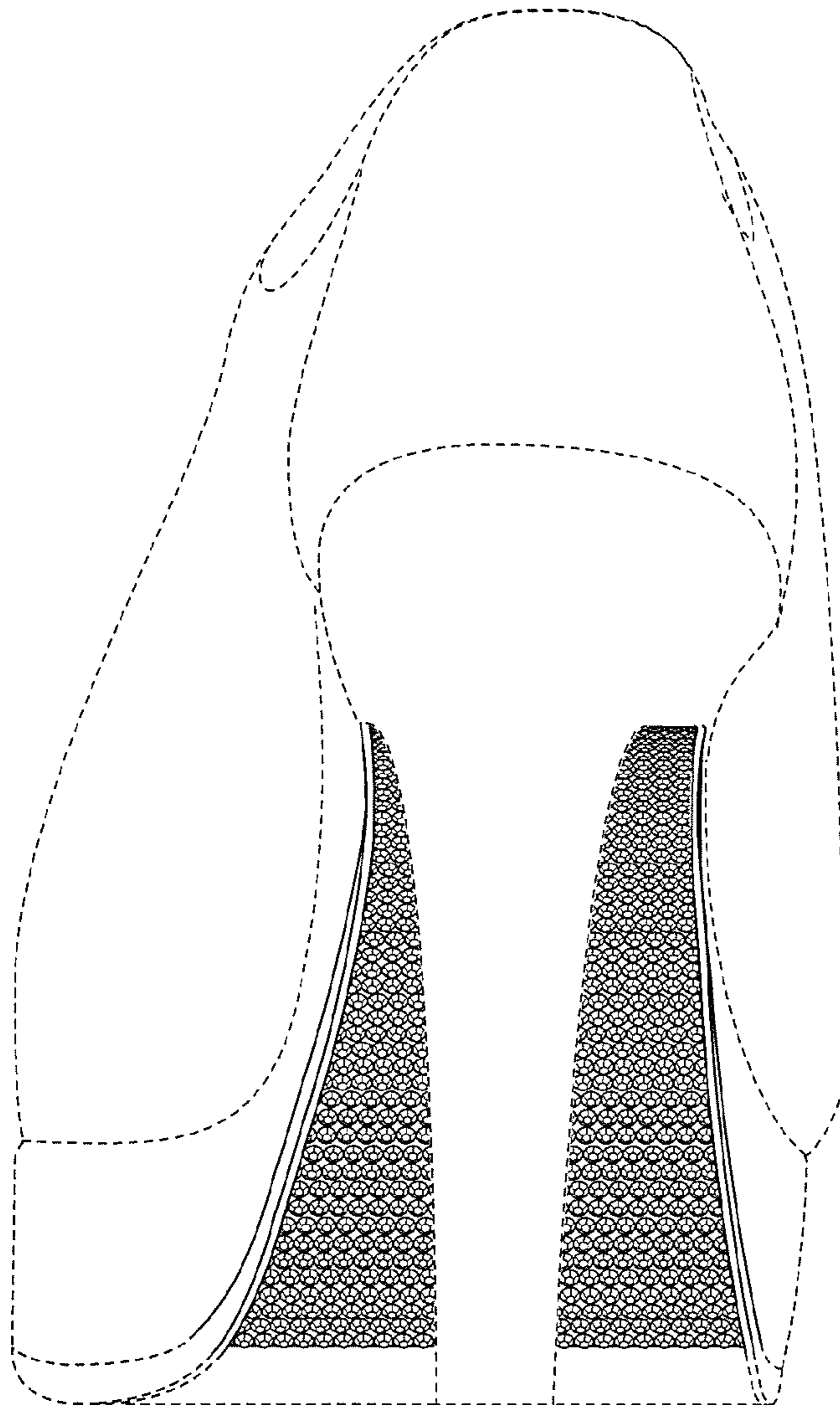
