DESCRIPTION

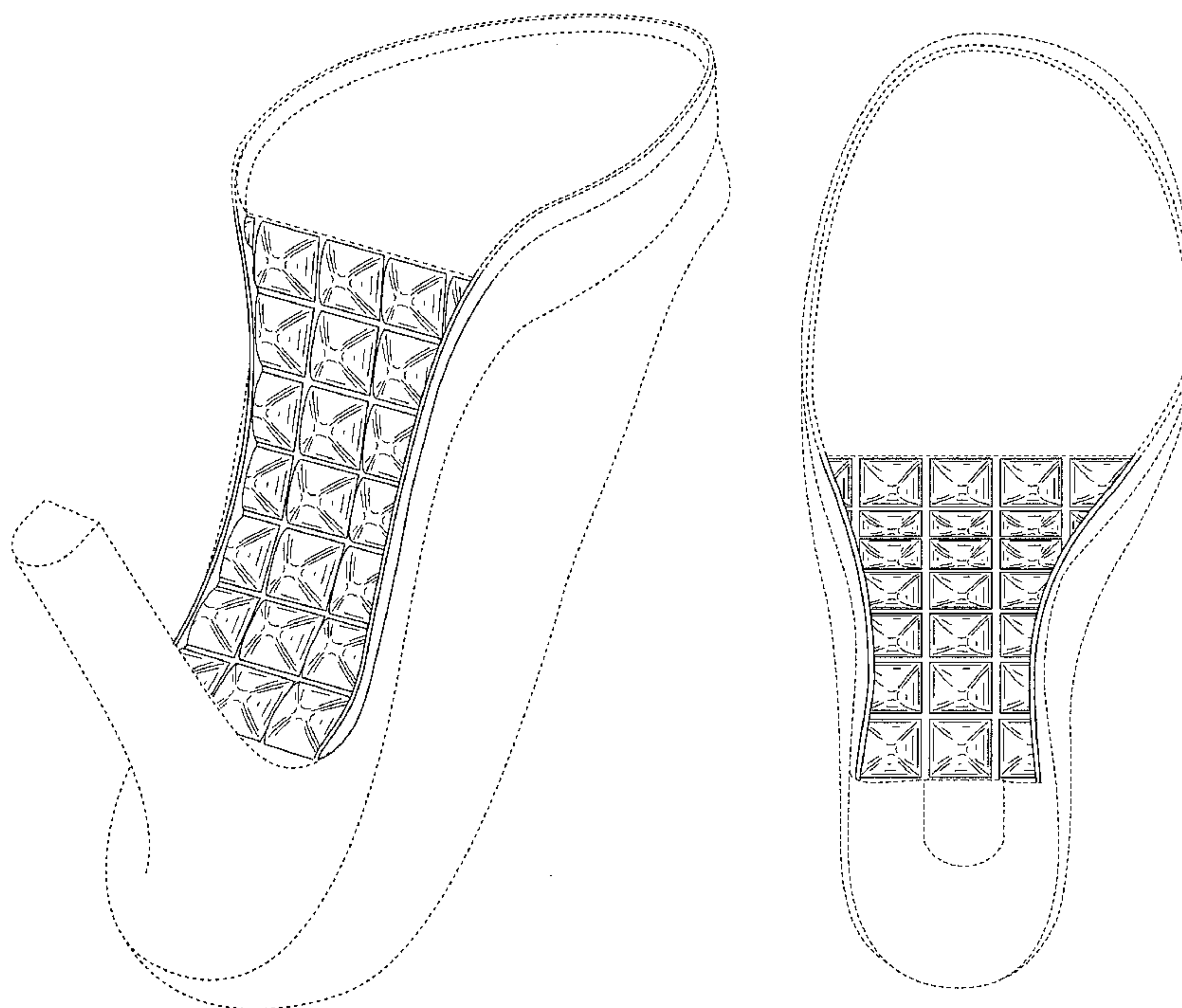
FIG. 1 is a bottom perspective view of the shoe with decorative sole in accordance with my new design;

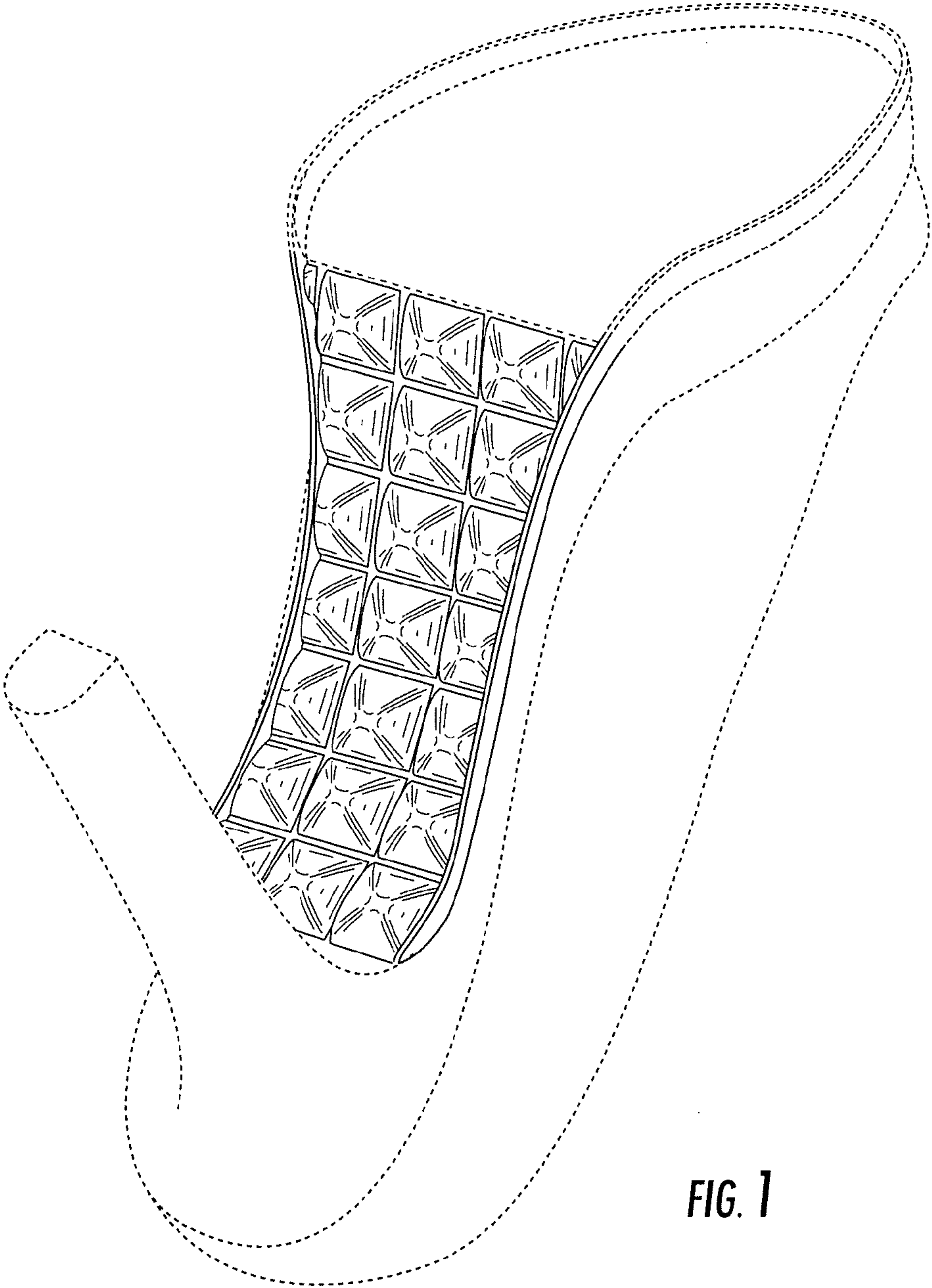

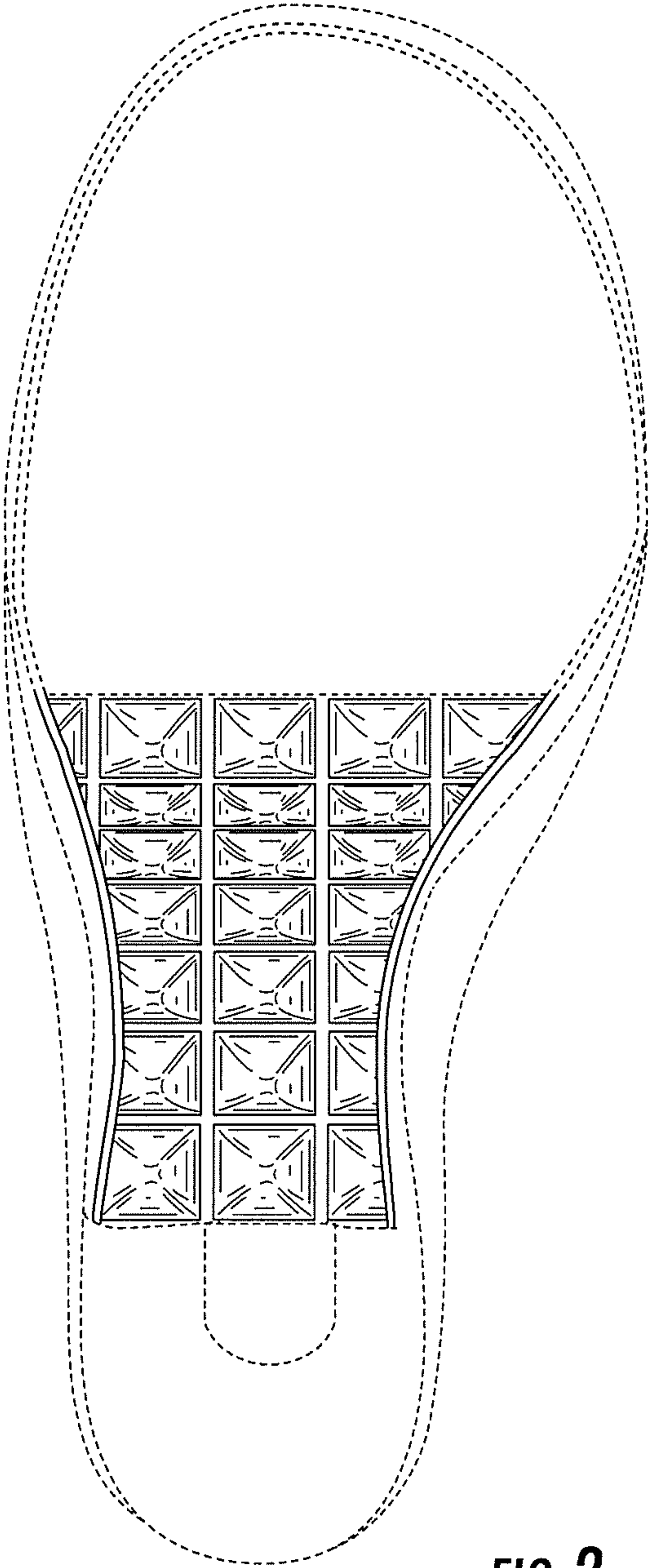

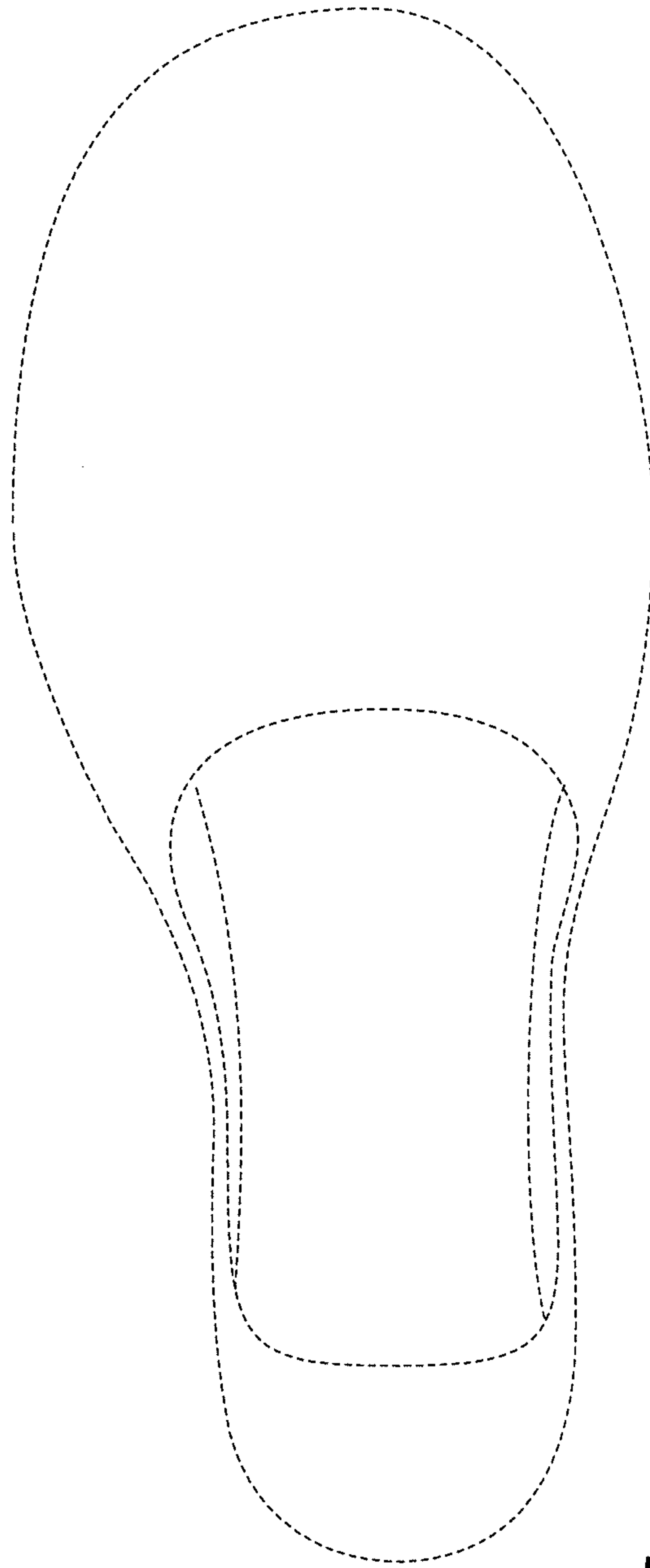

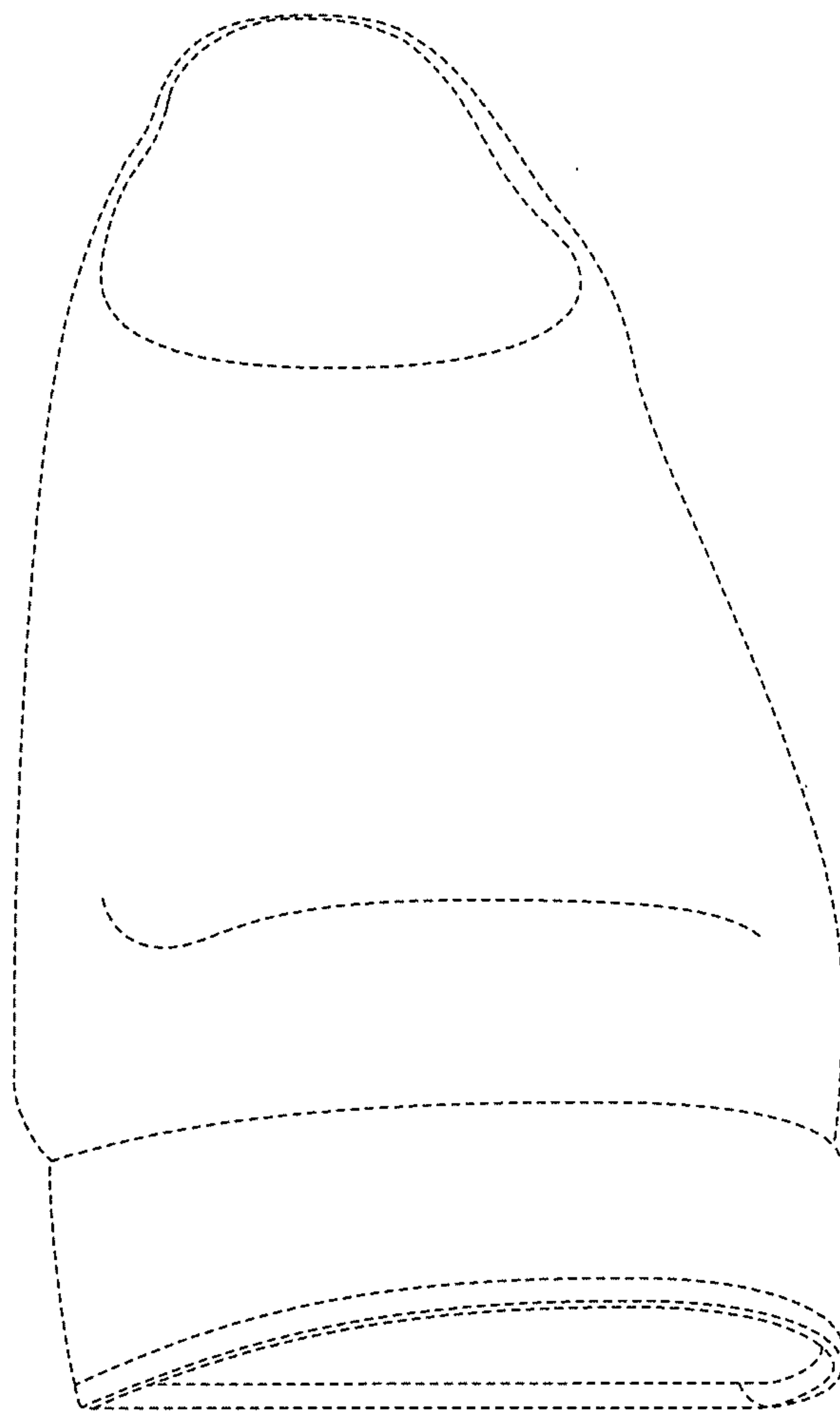

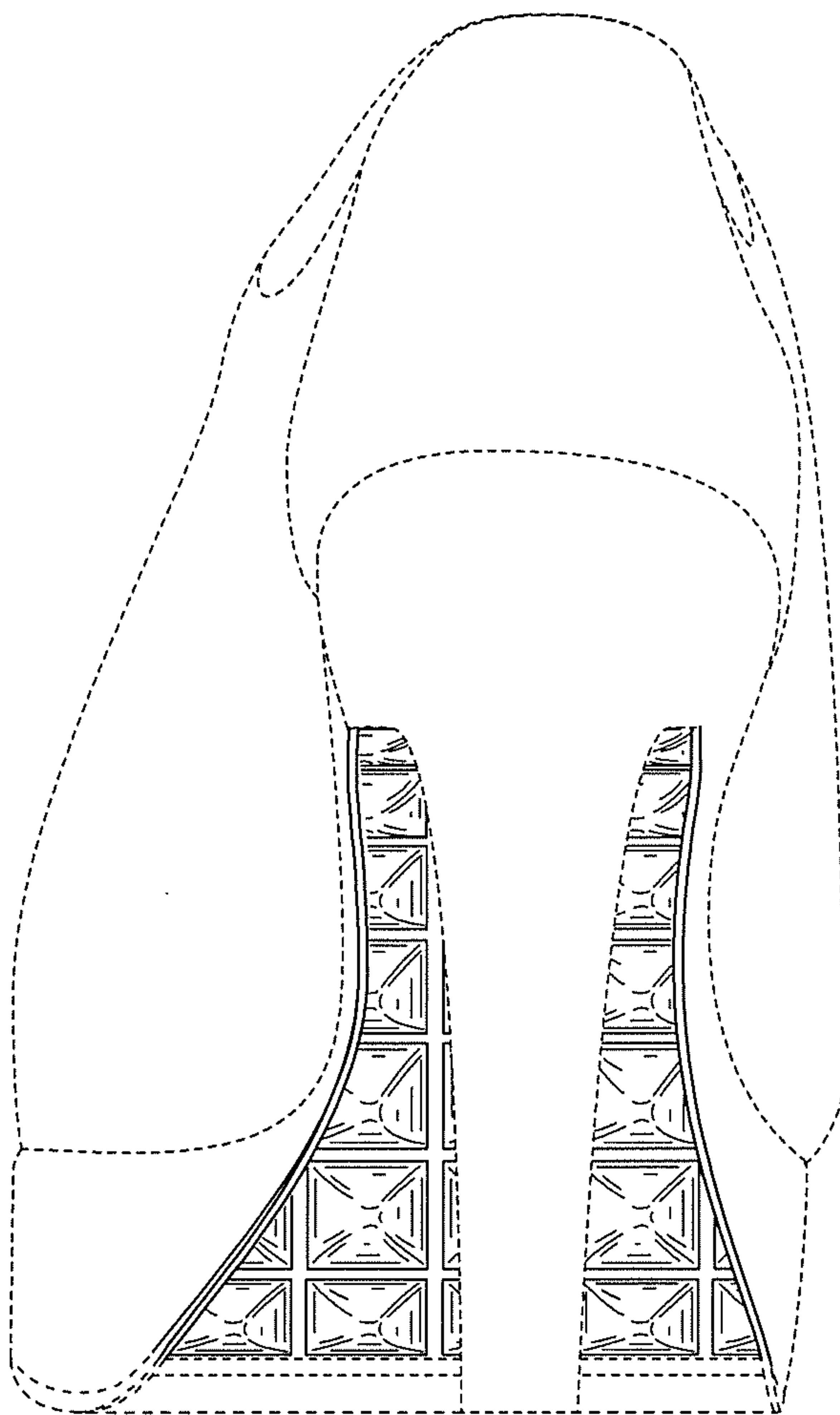
