The ornamental design for a sheet material with camouflage pattern, as shown and described.

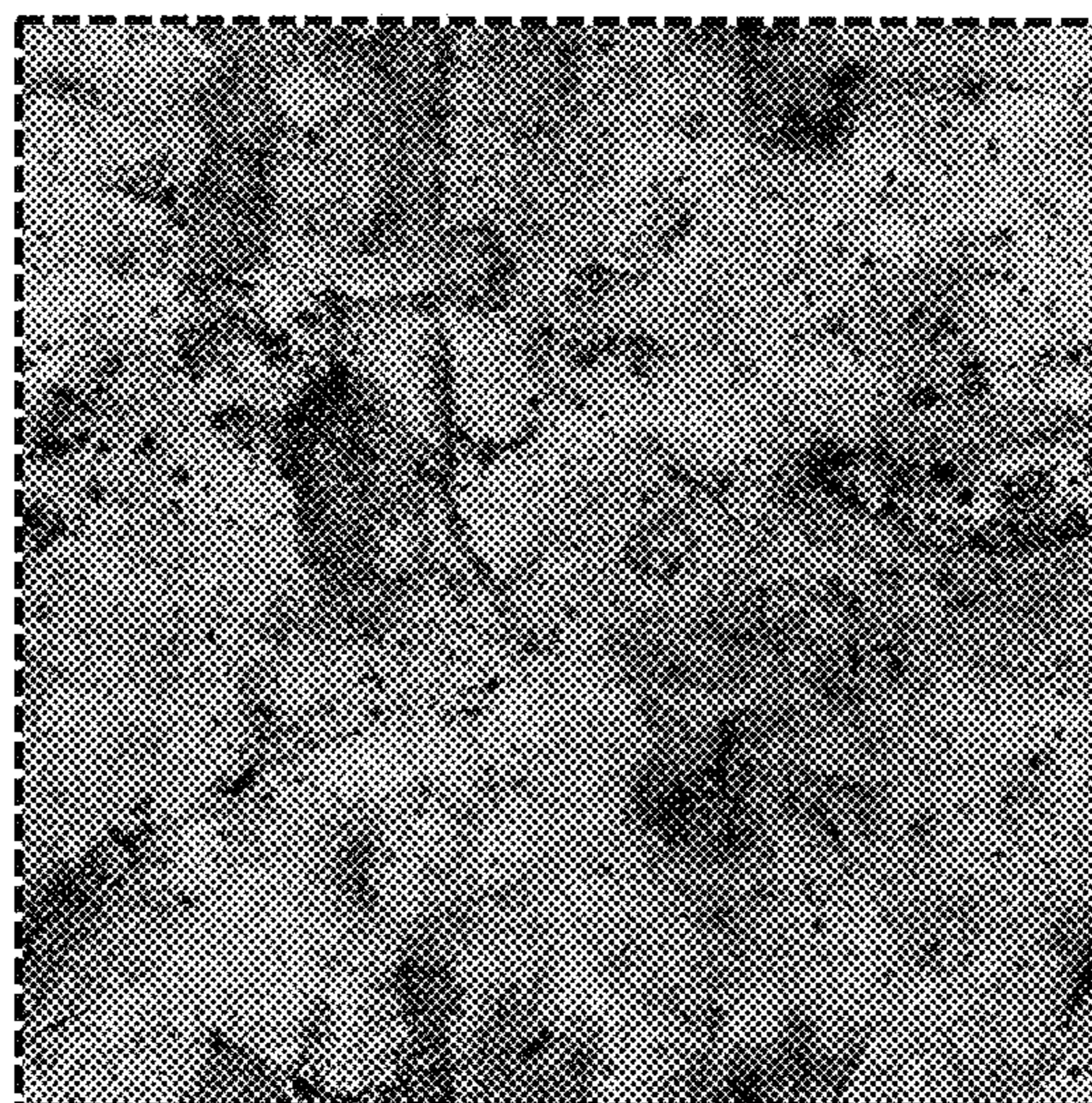
DESCRIPTION

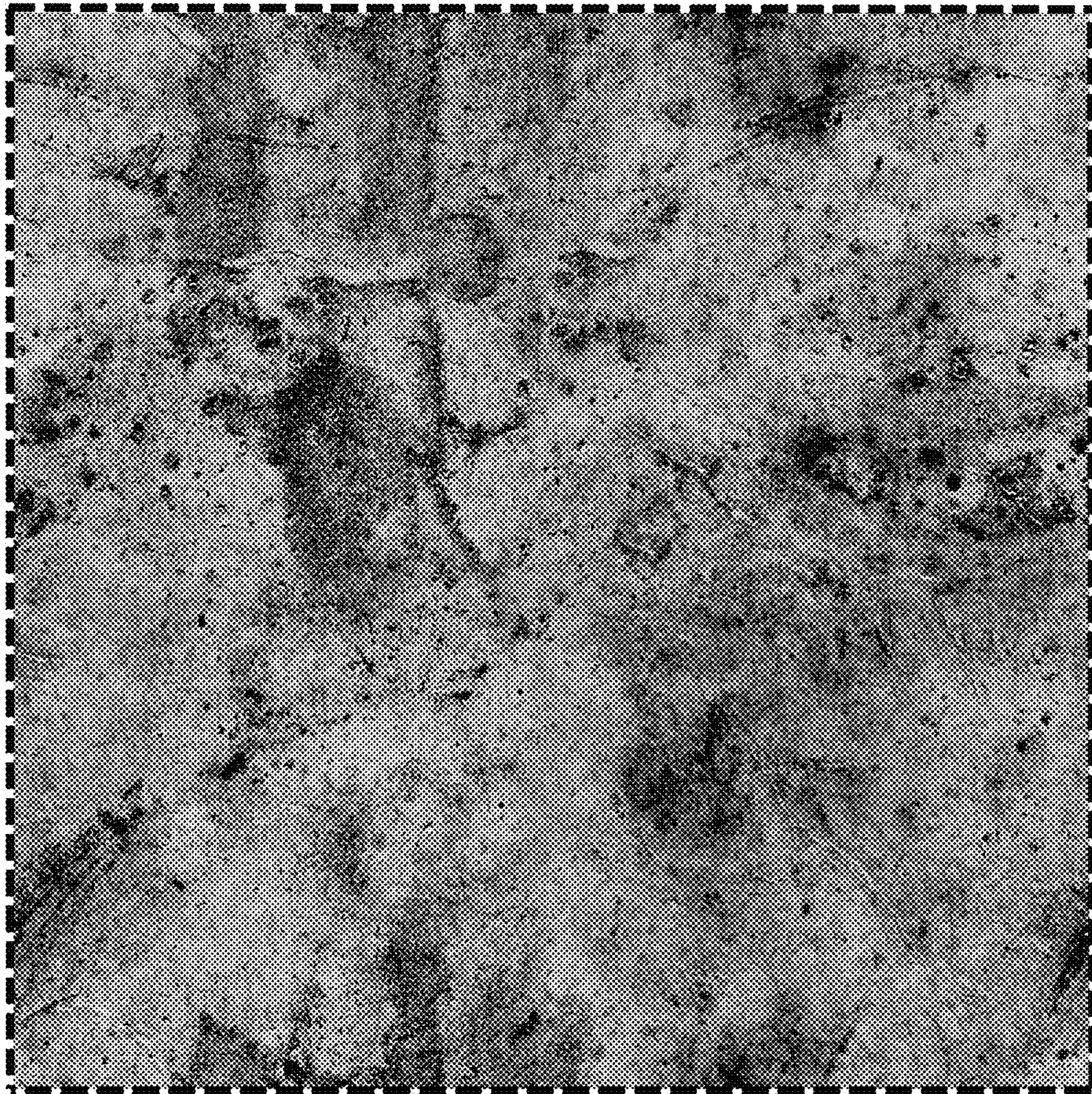

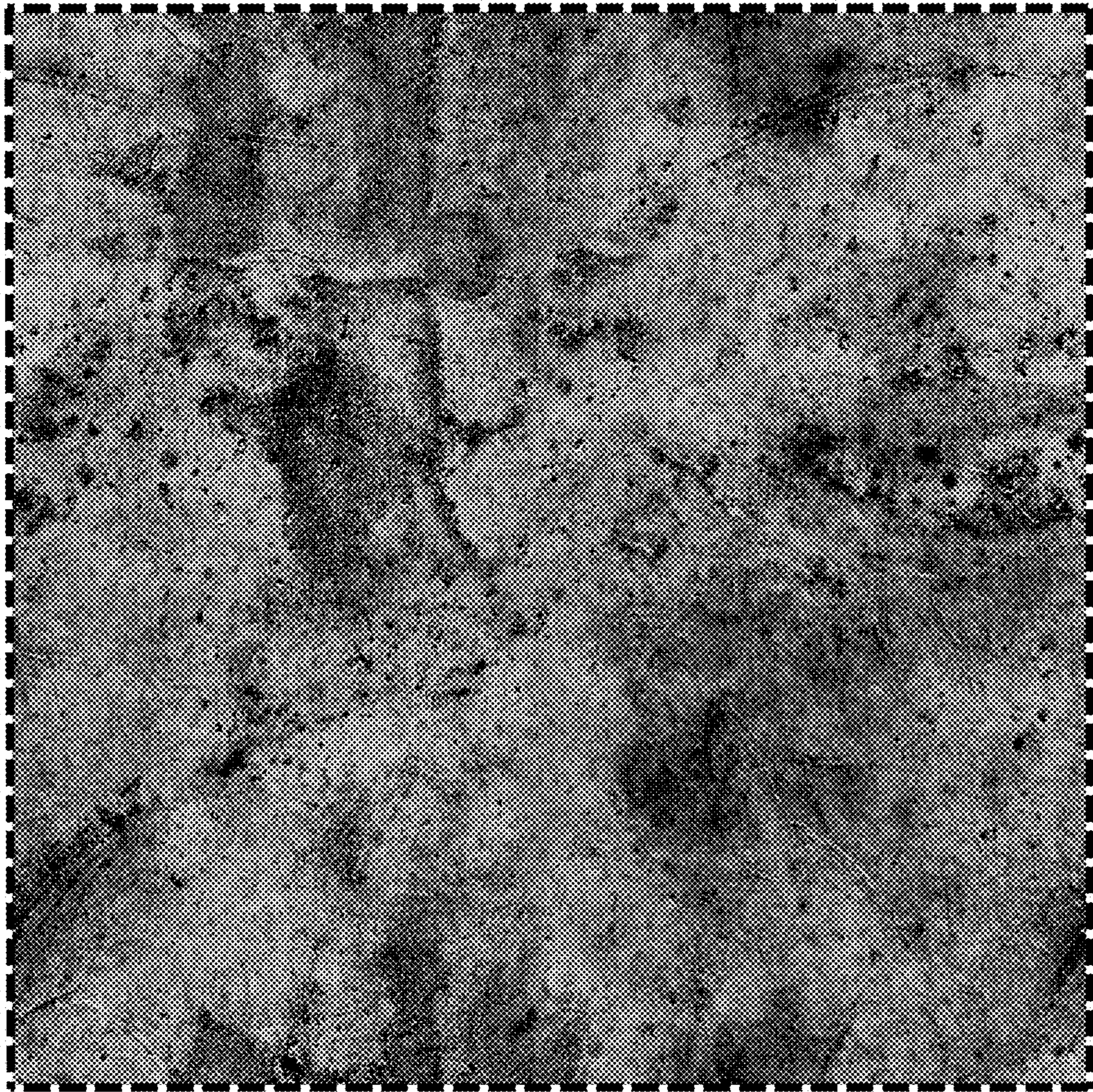
