(57) **CLAIM**

The ornamental design for a set of three seating modules, as shown and described.

DESCRIPTION

FIG. 1 is a reduced, top, front, right perspective view of the set of three seating modules of the claimed design;
 FIG. 2 is a front elevation view of the shortest seating module of the set of three seating modules shown in FIG. 1;
 FIG. 3 is a rear elevation view of the shortest seating module of the set of three seating modules shown in FIG. 1;
 FIG. 4 is a right side elevation view of the shortest seating module of the set of three seating modules shown in FIG. 1;
 FIG. 5 is a left side elevation view of the shortest seating module of the set of three seating modules shown in FIG. 1;

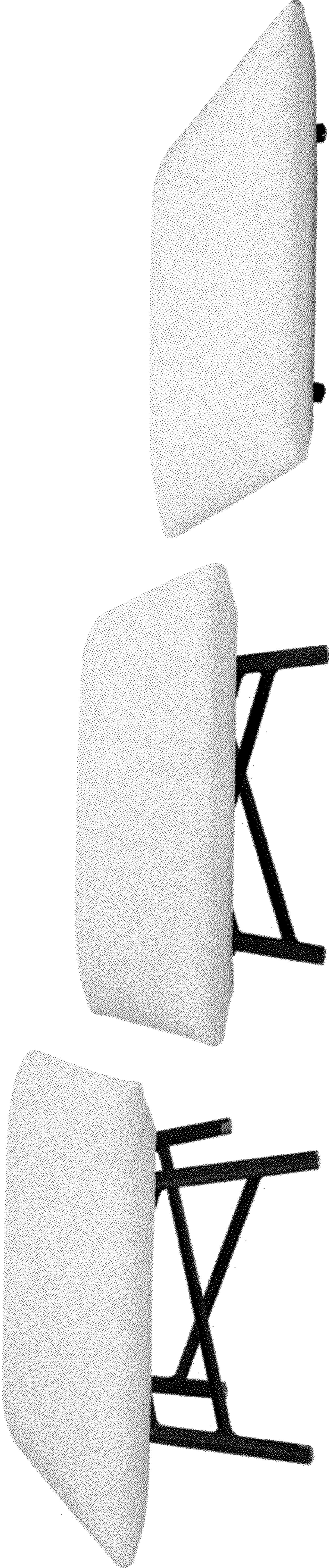

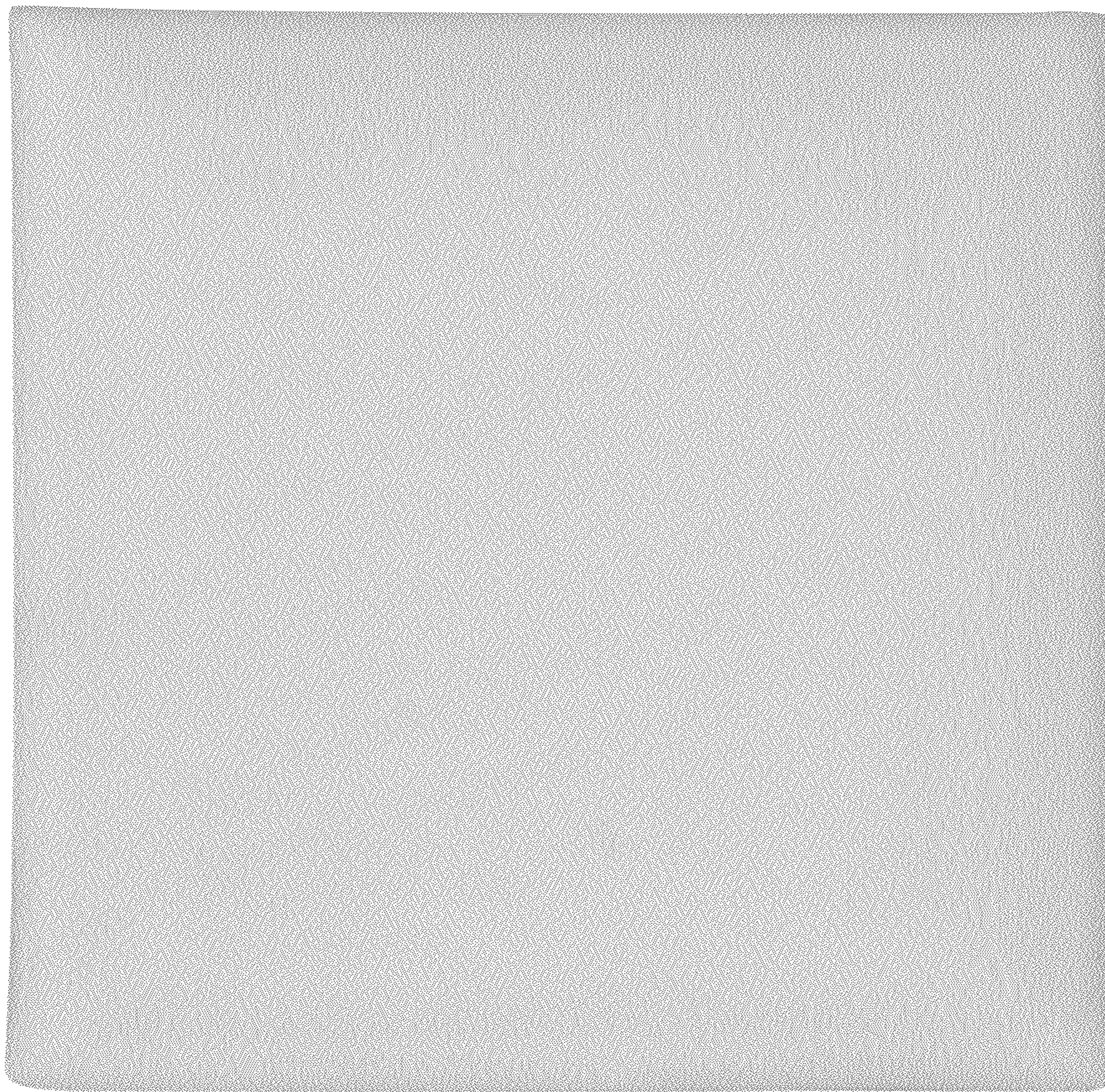

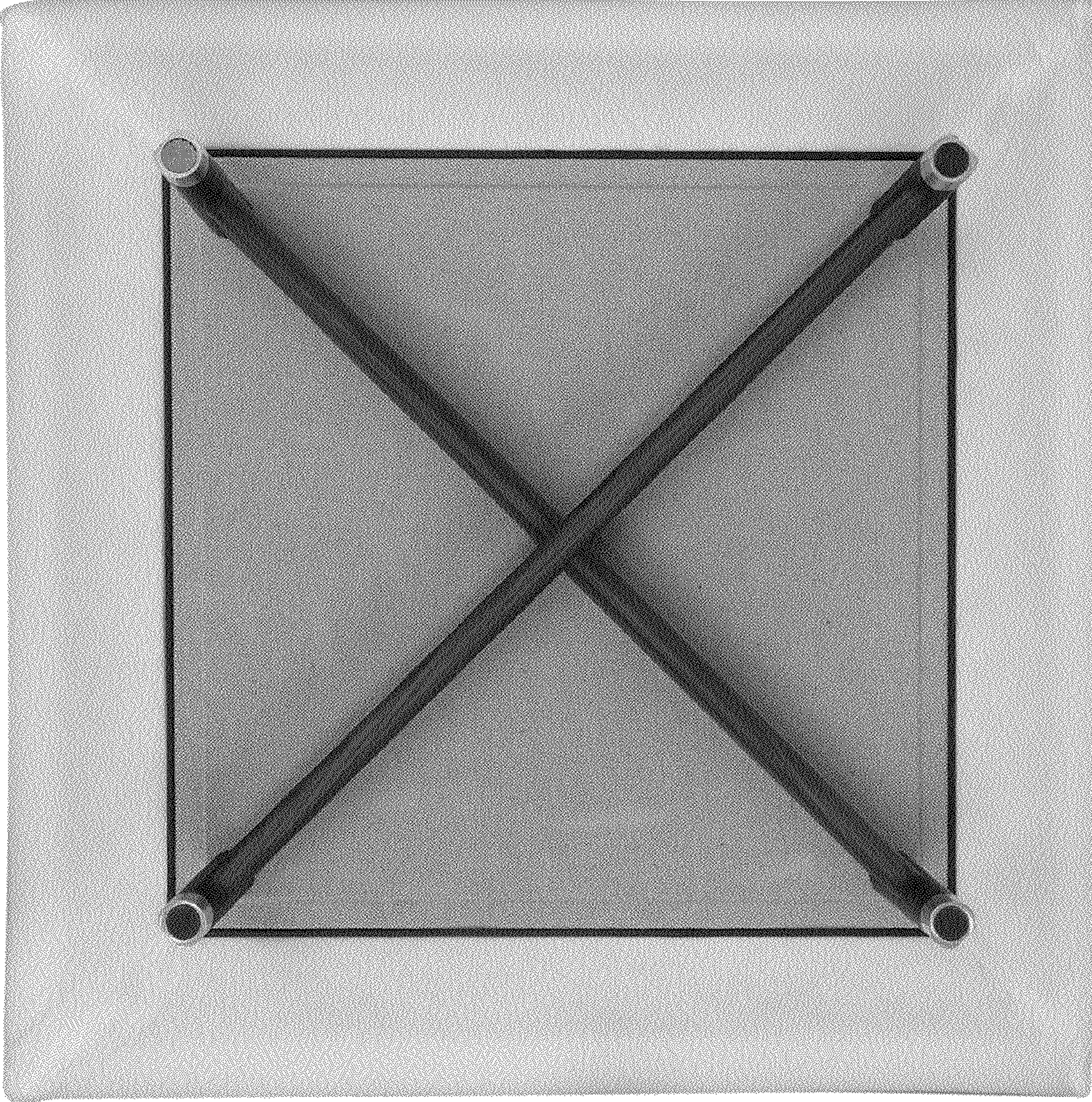

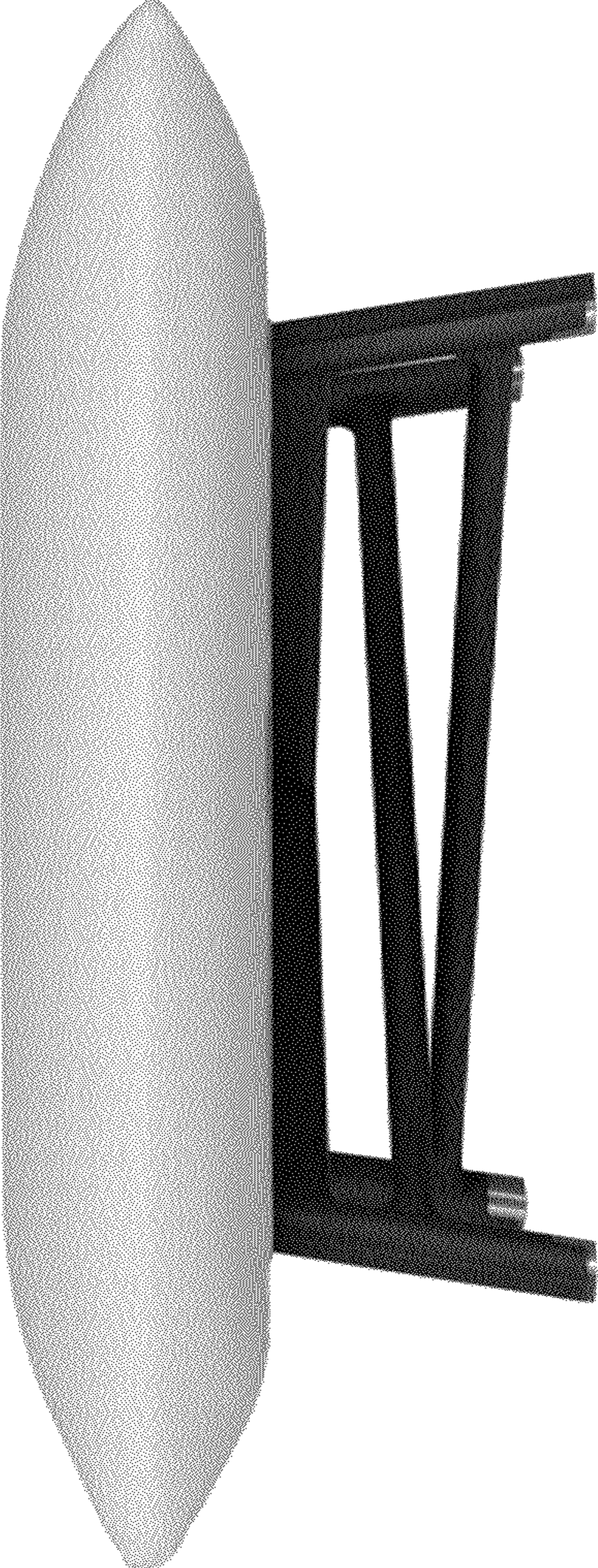

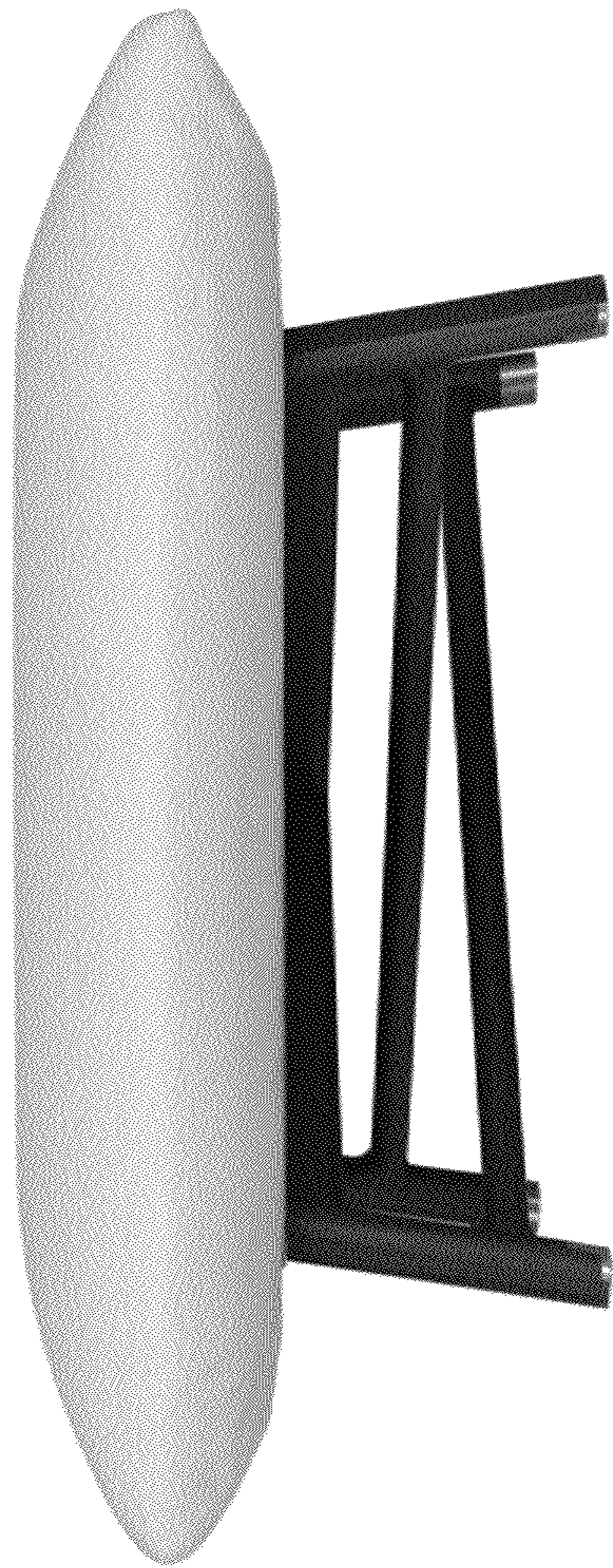

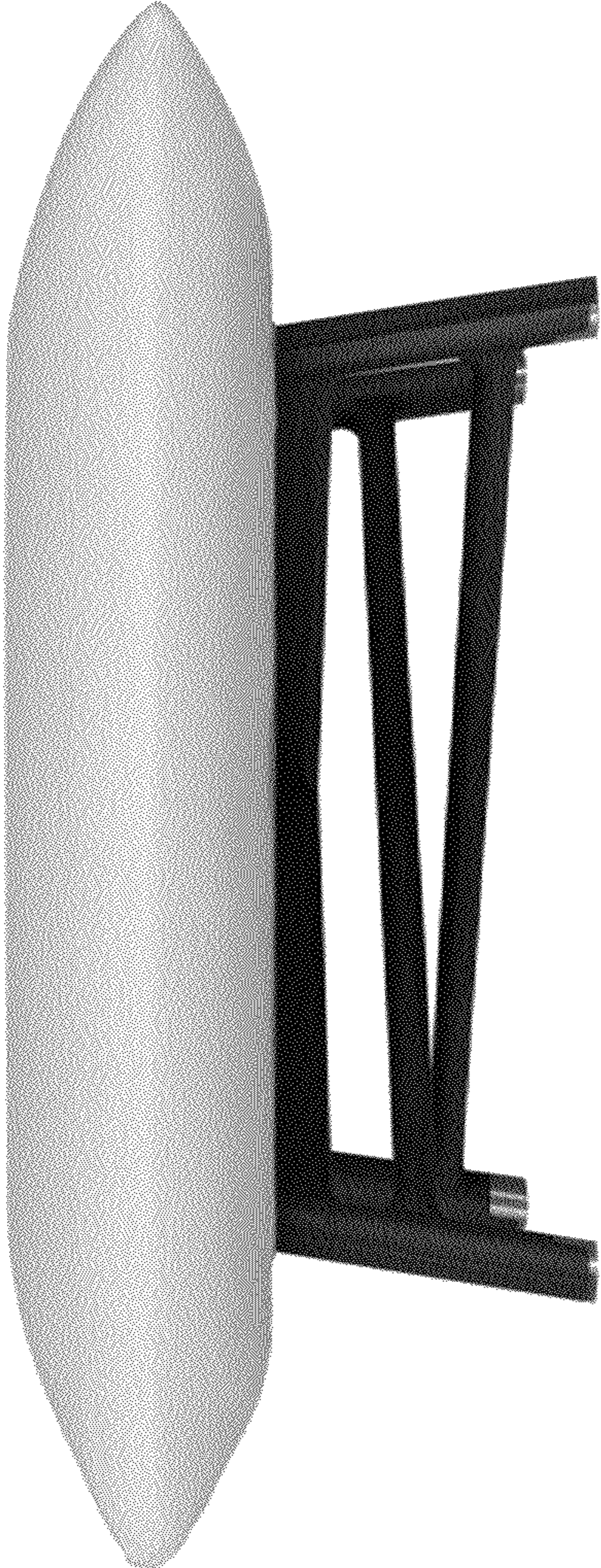

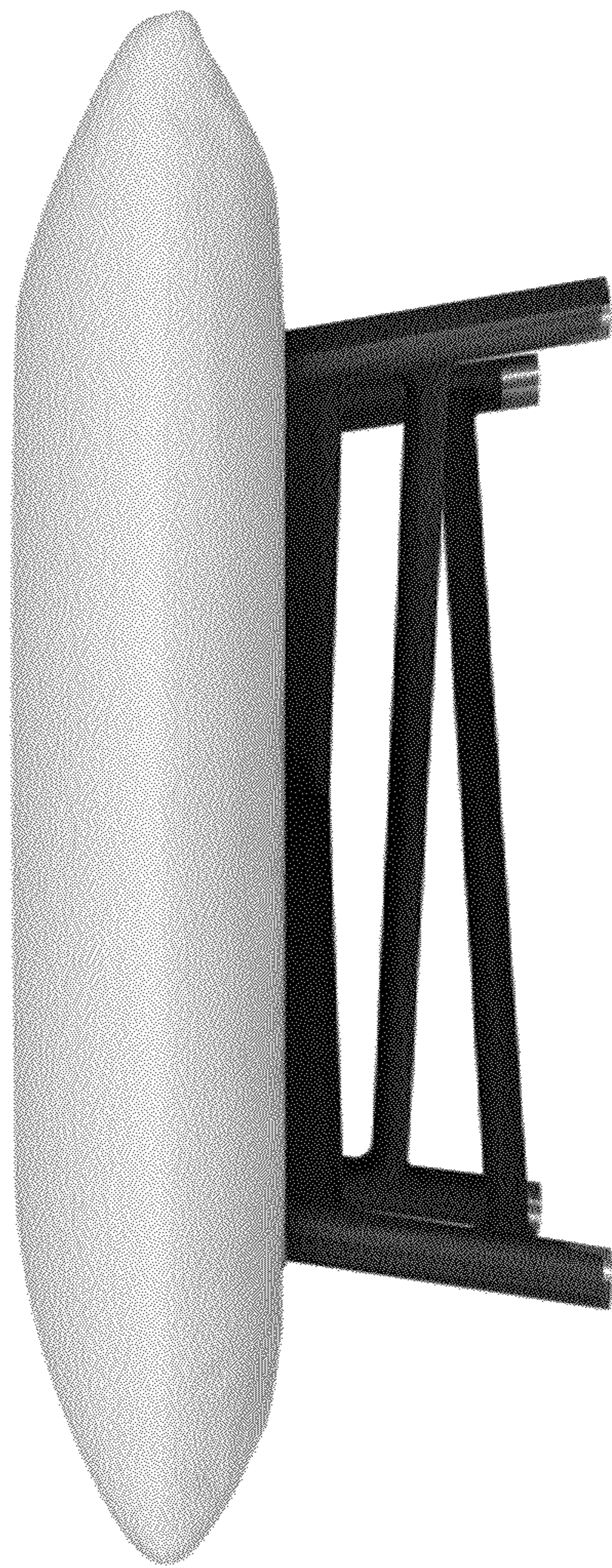

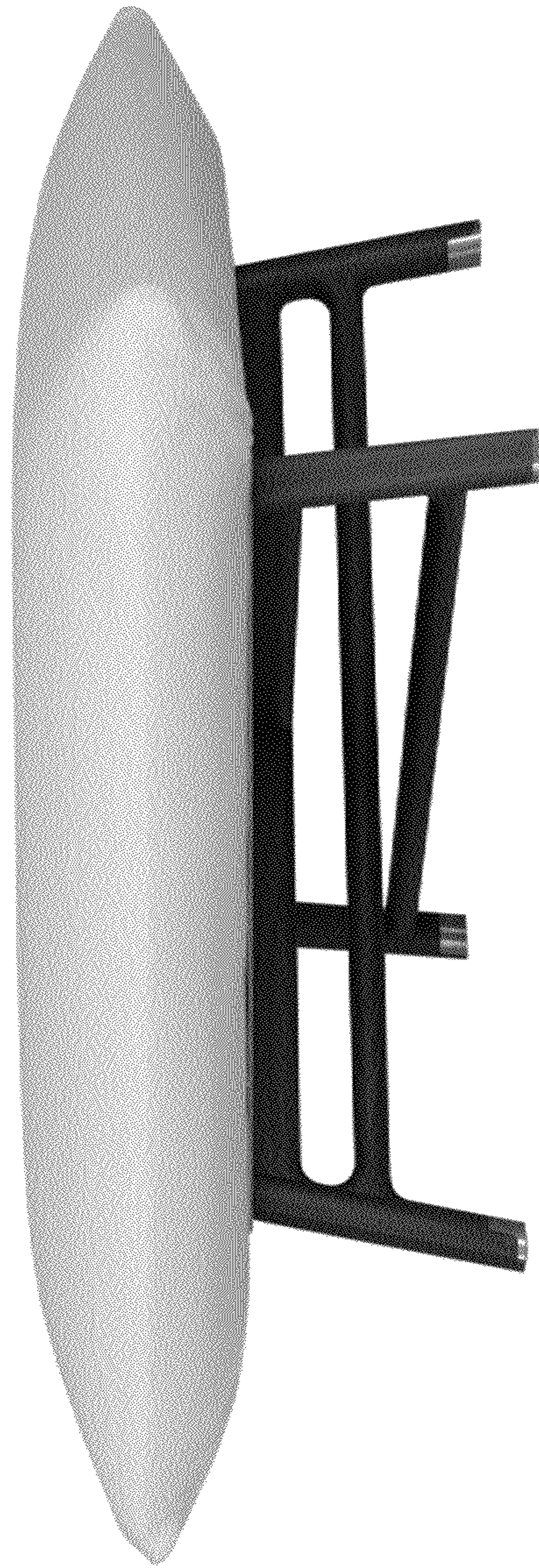

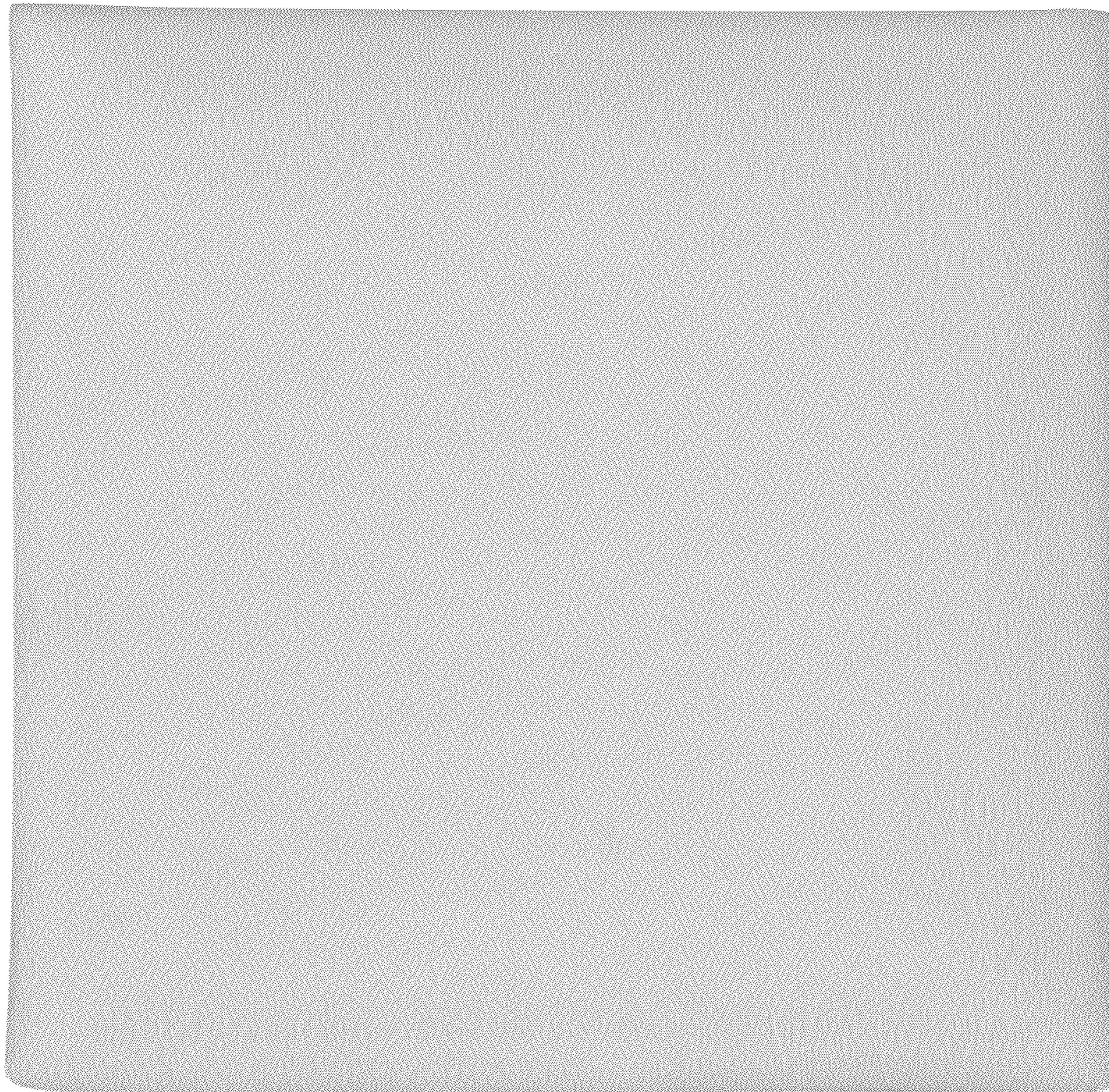

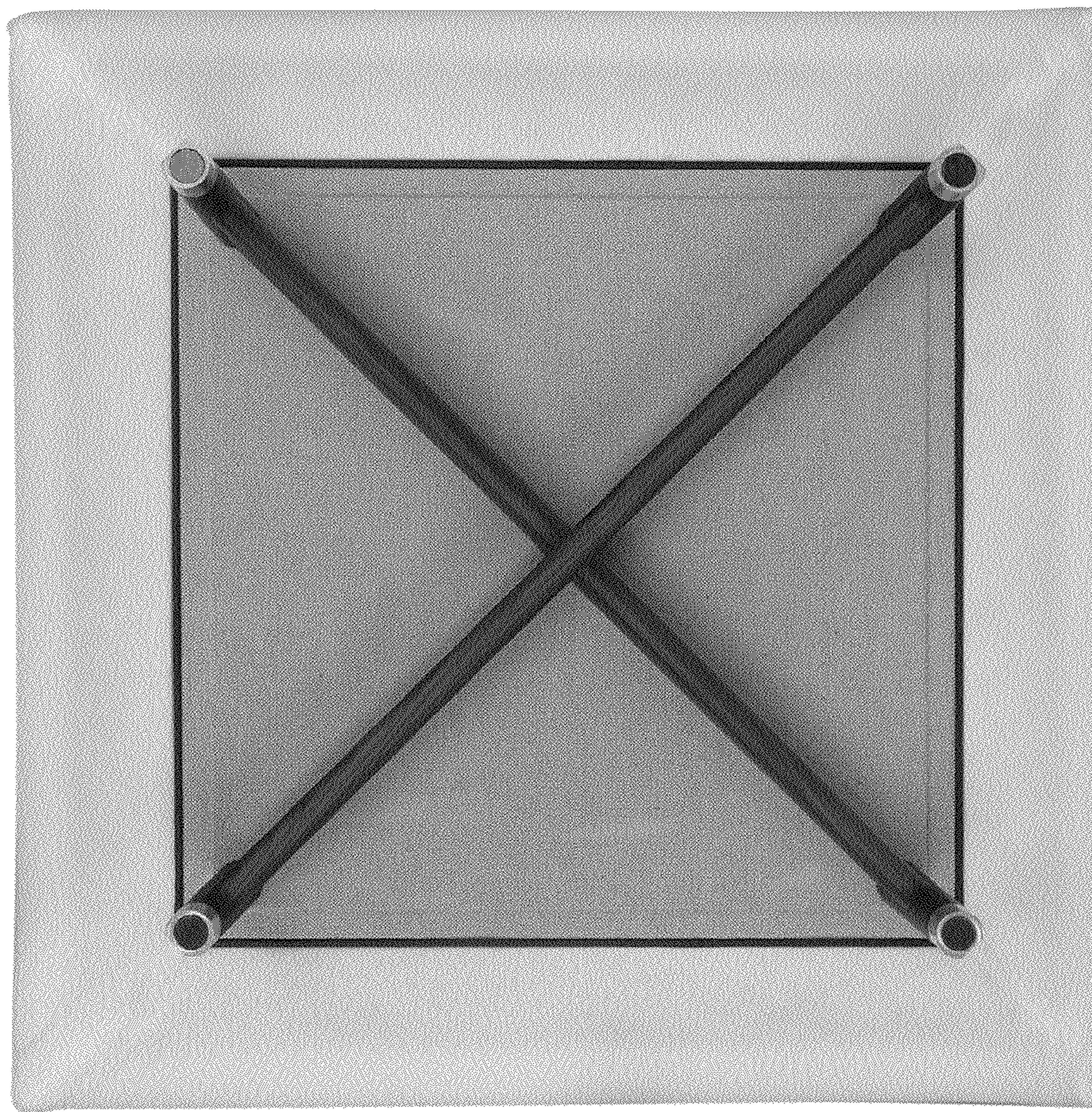

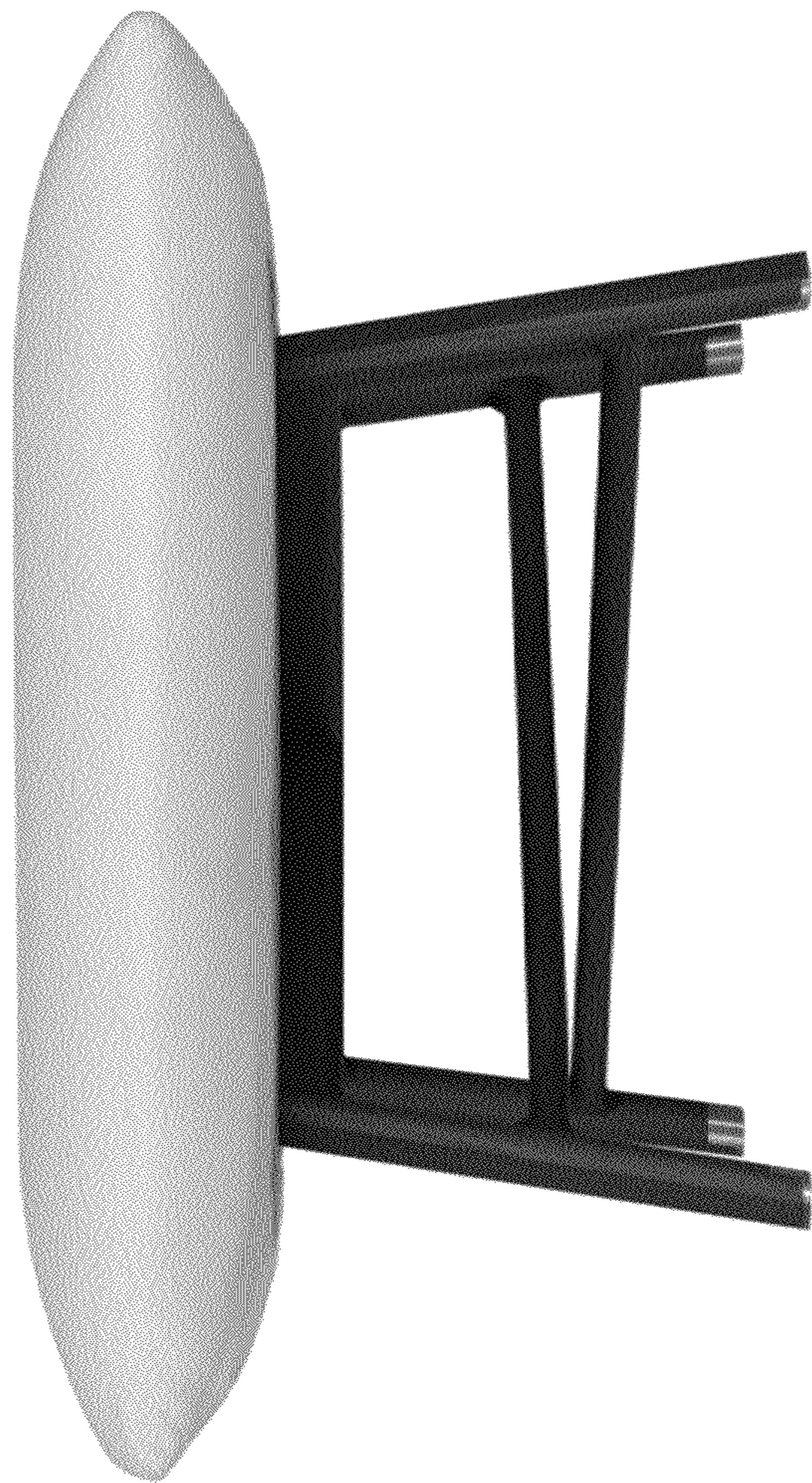

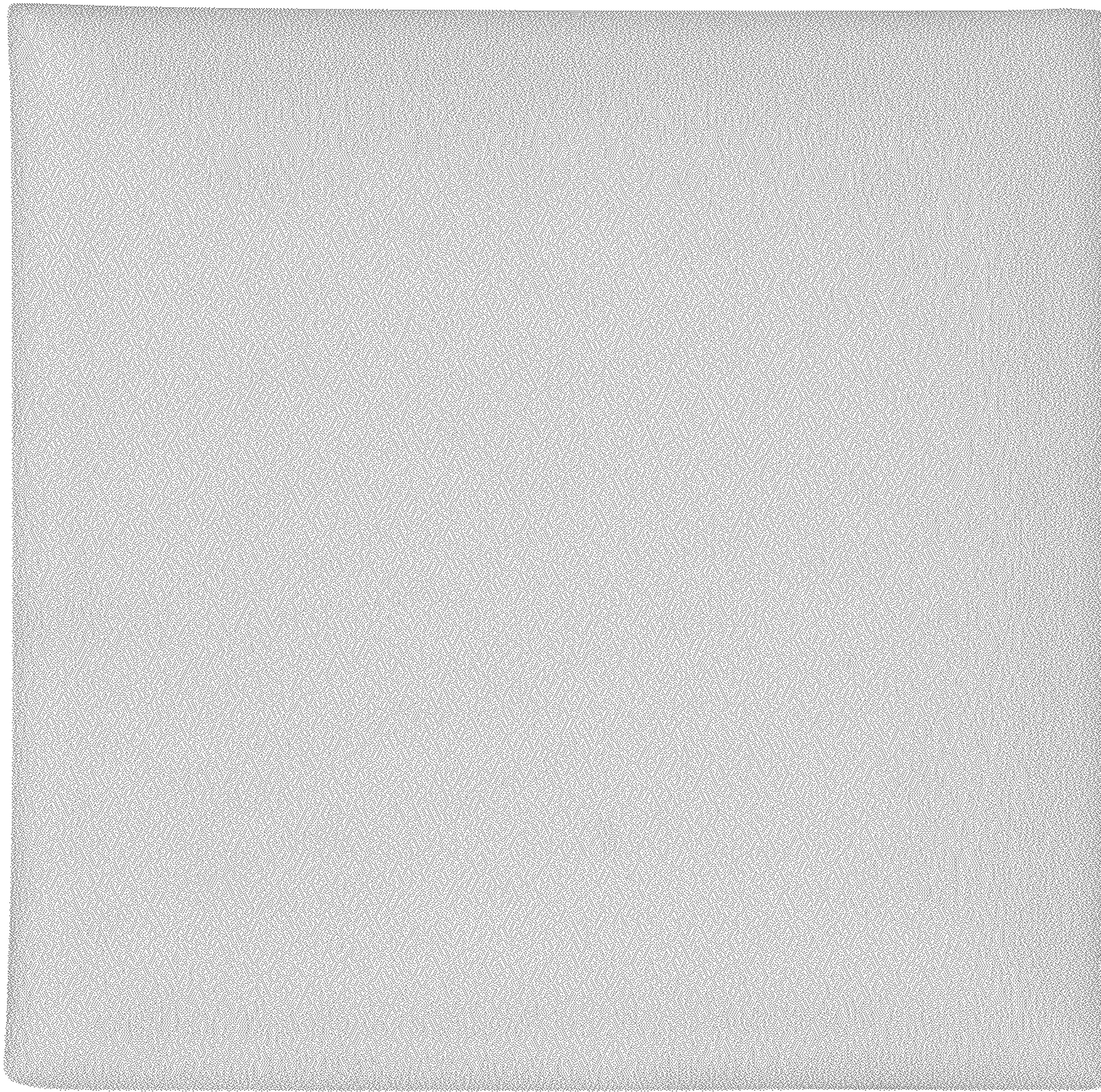

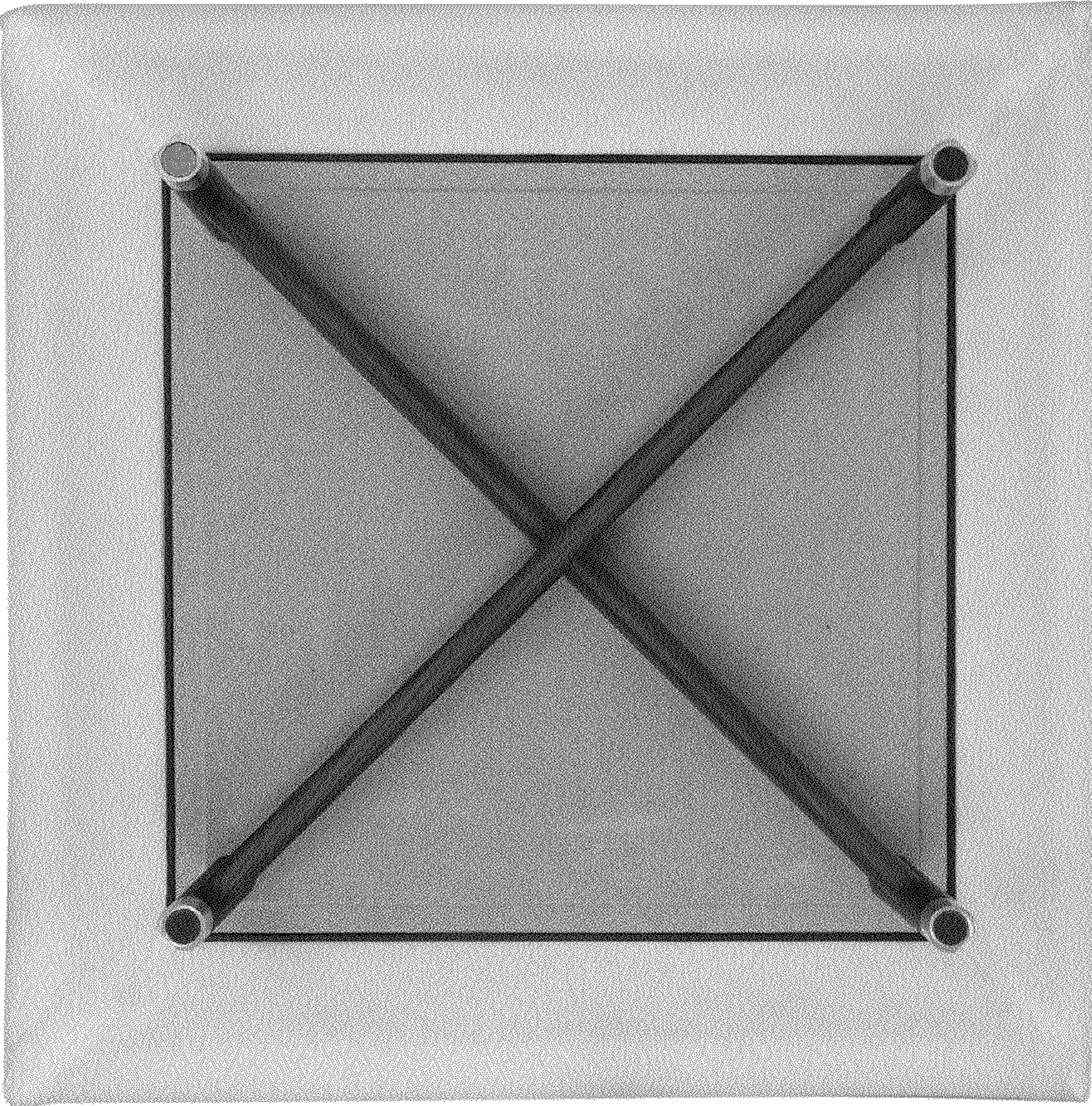

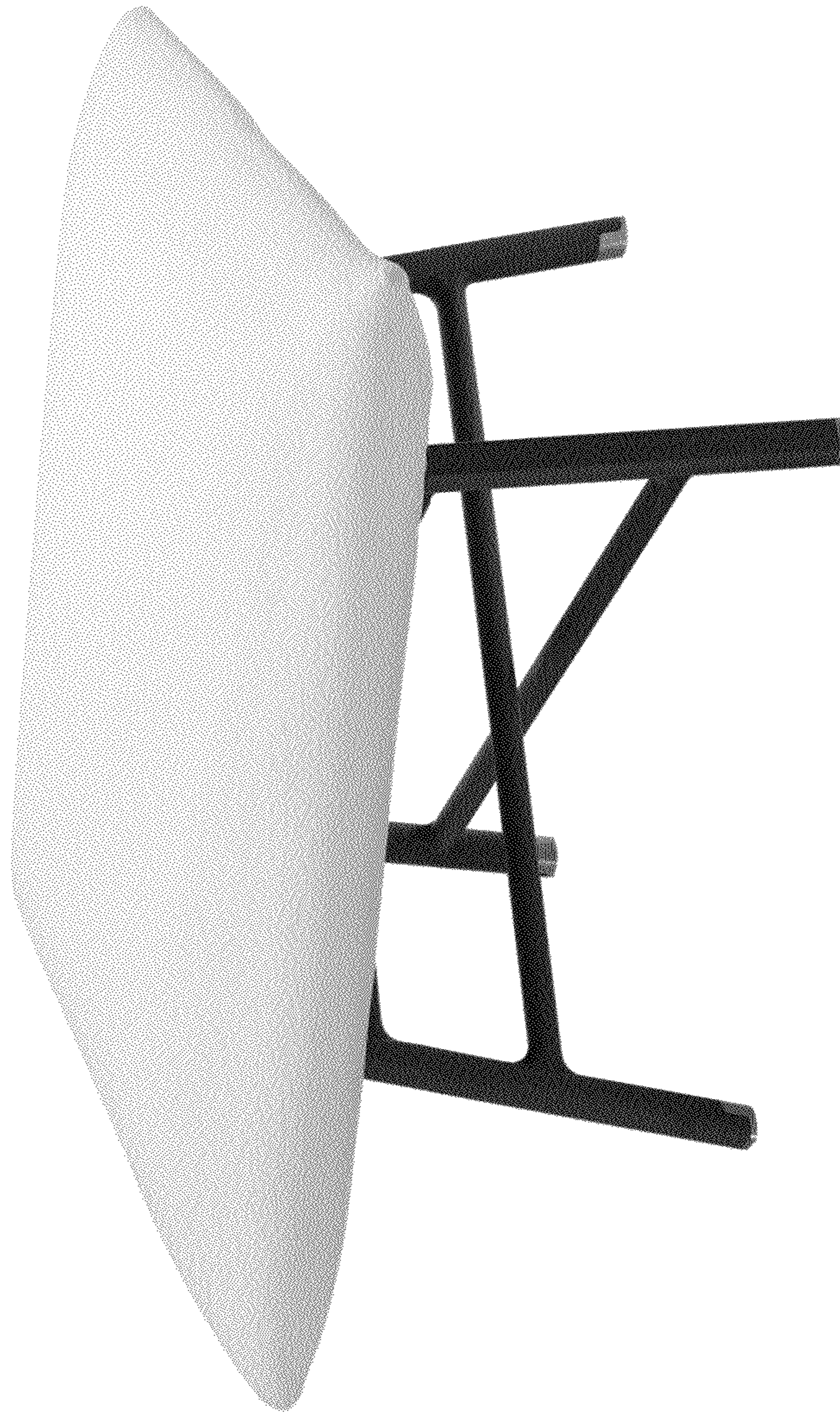
